The ornamental design for a buckle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a buckle from the front, plan, and right side showing my new design;

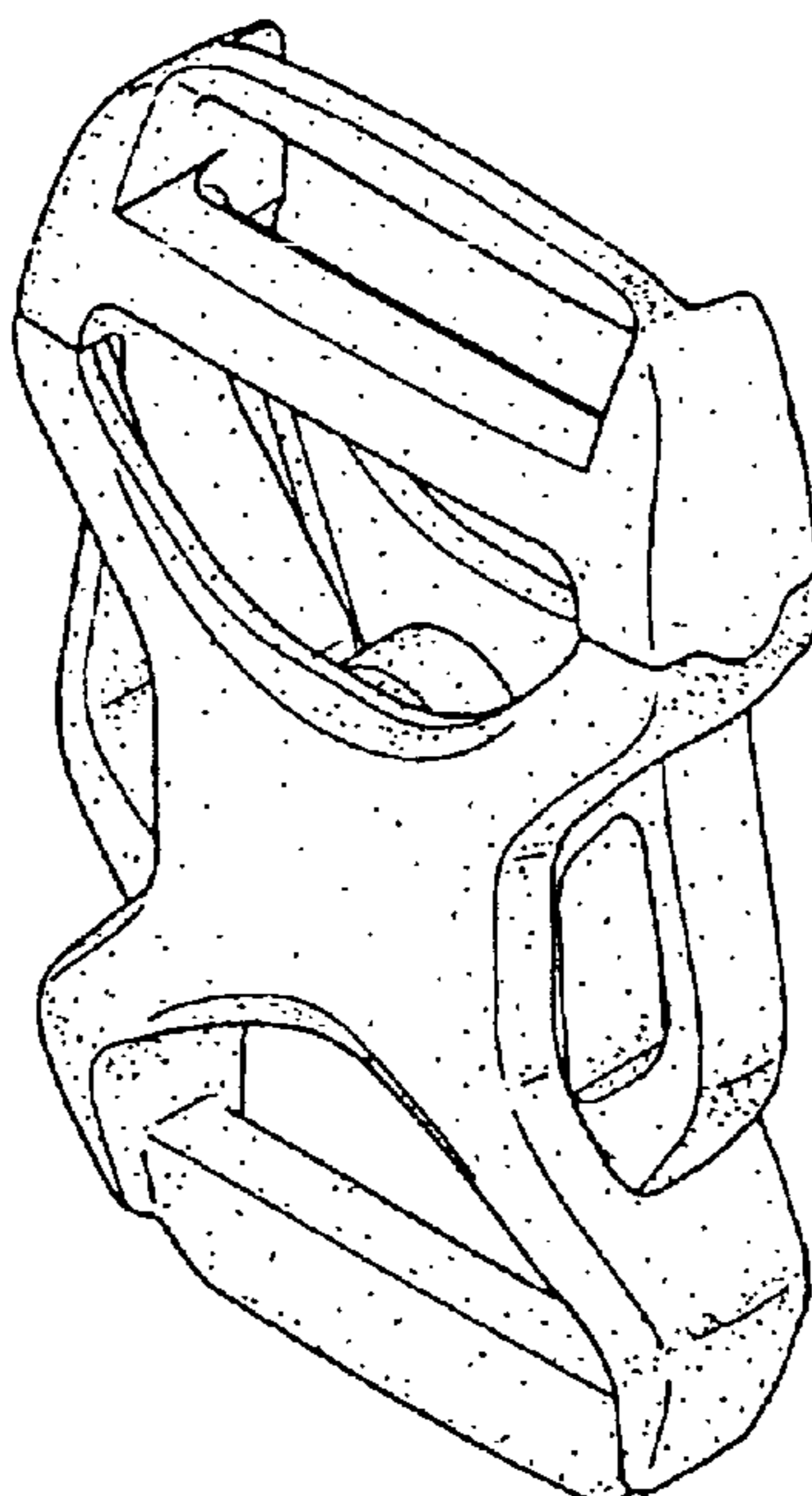

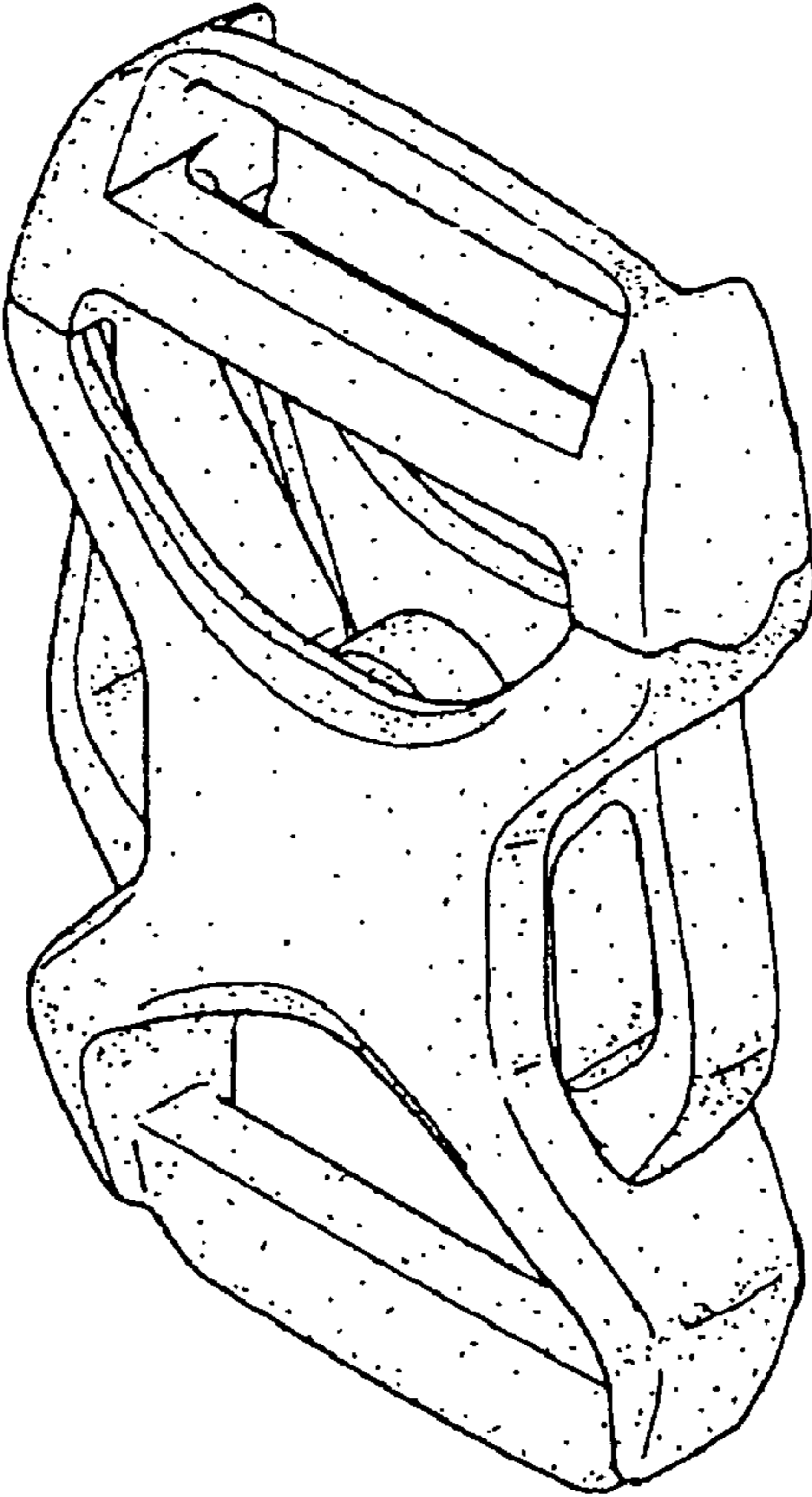

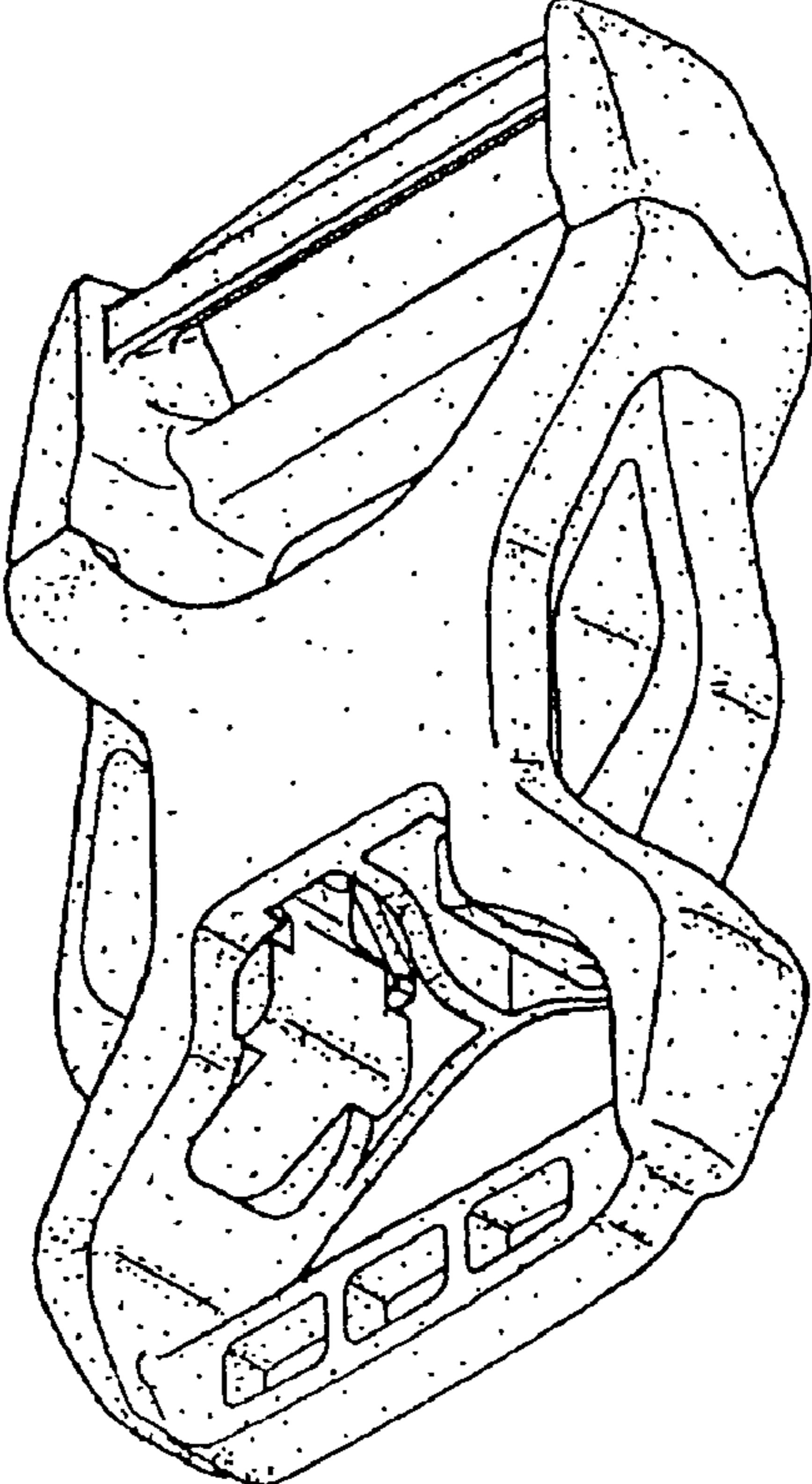

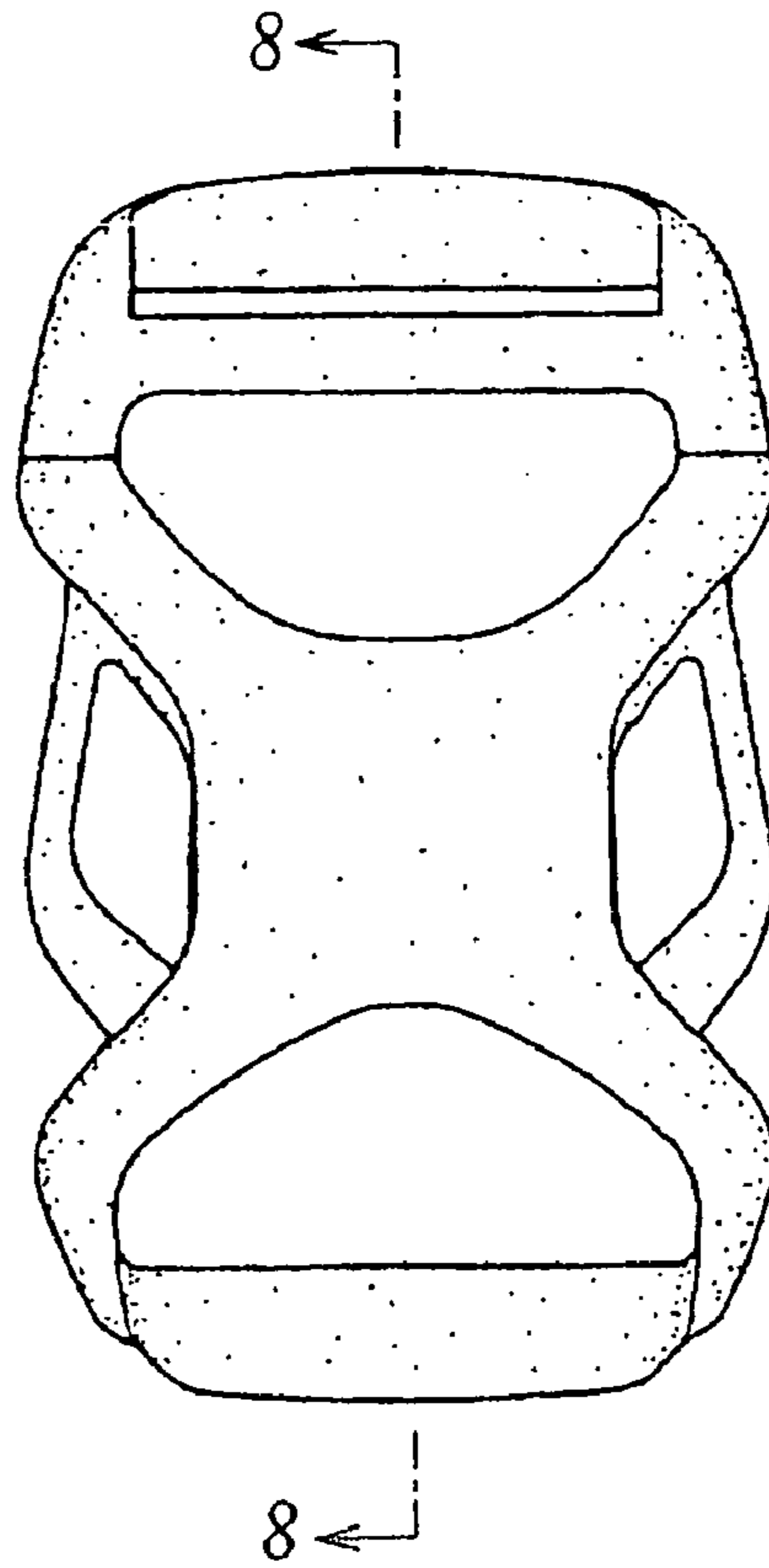

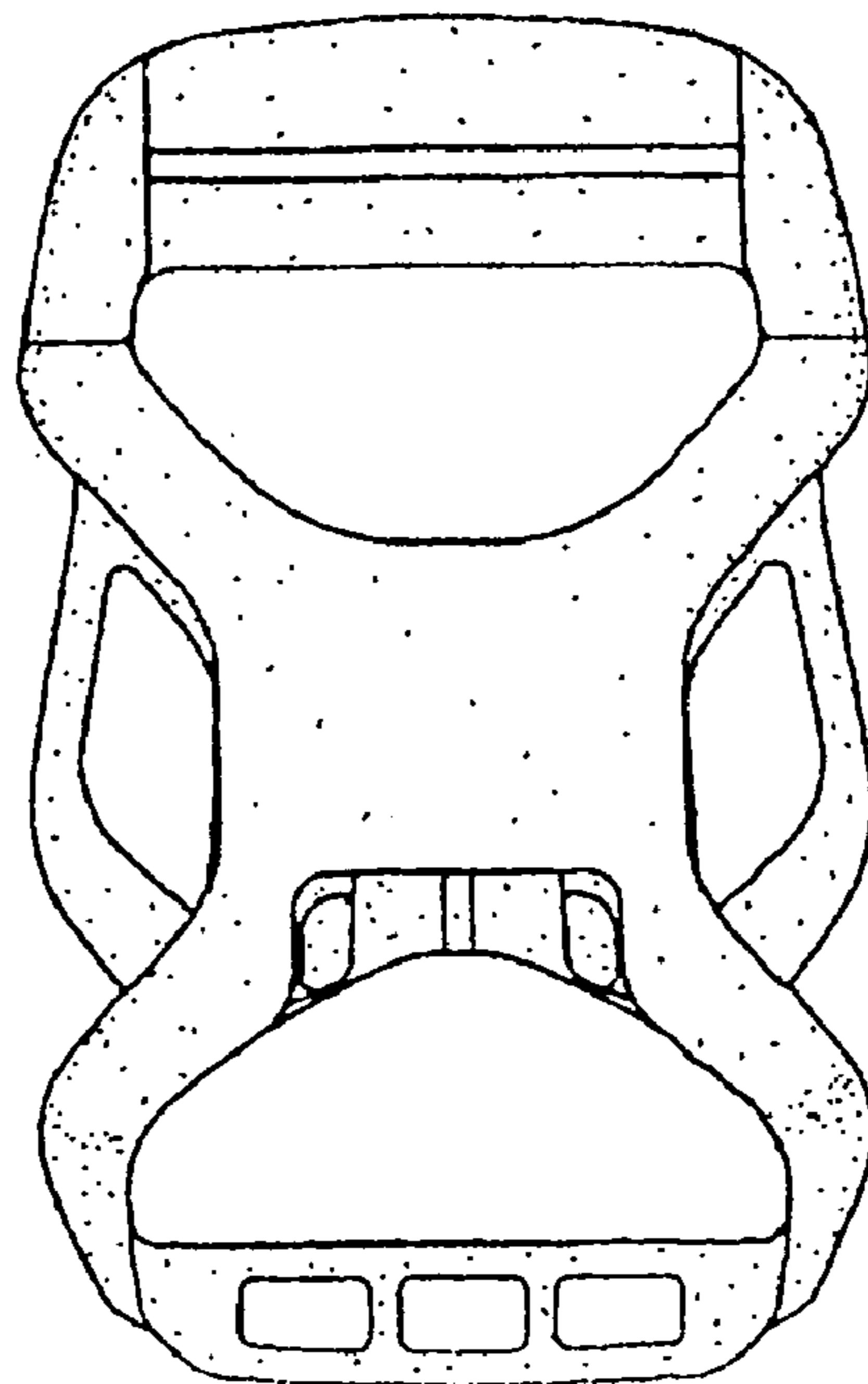

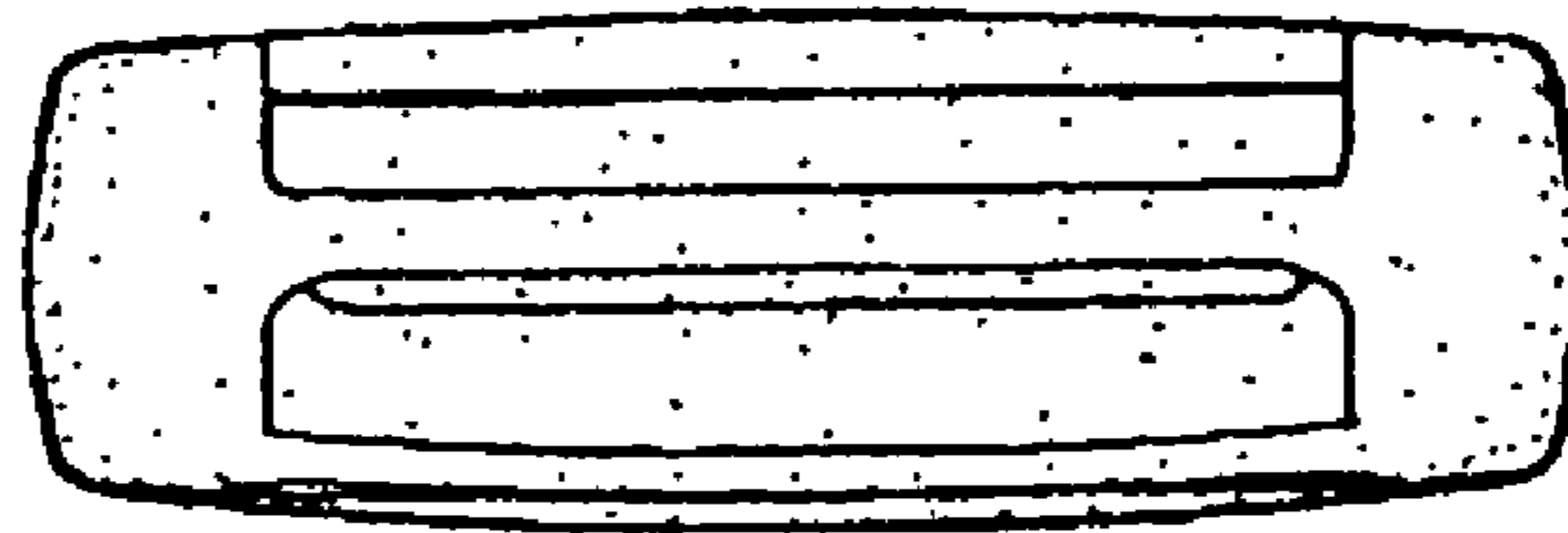

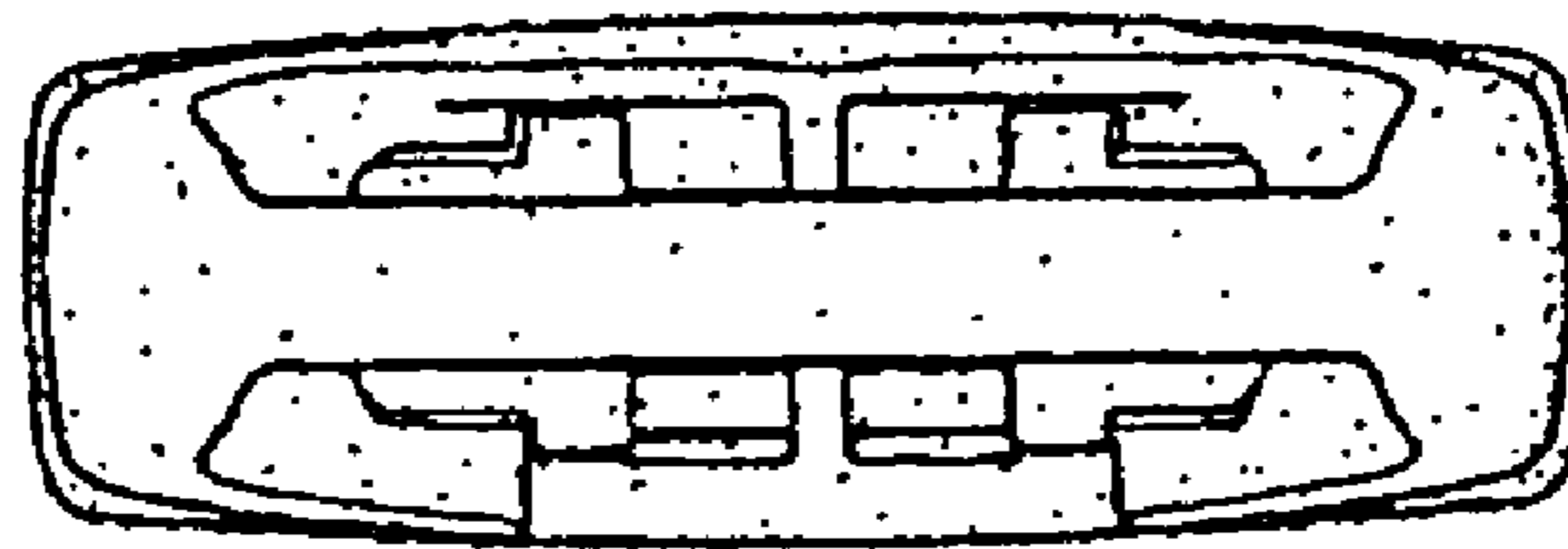

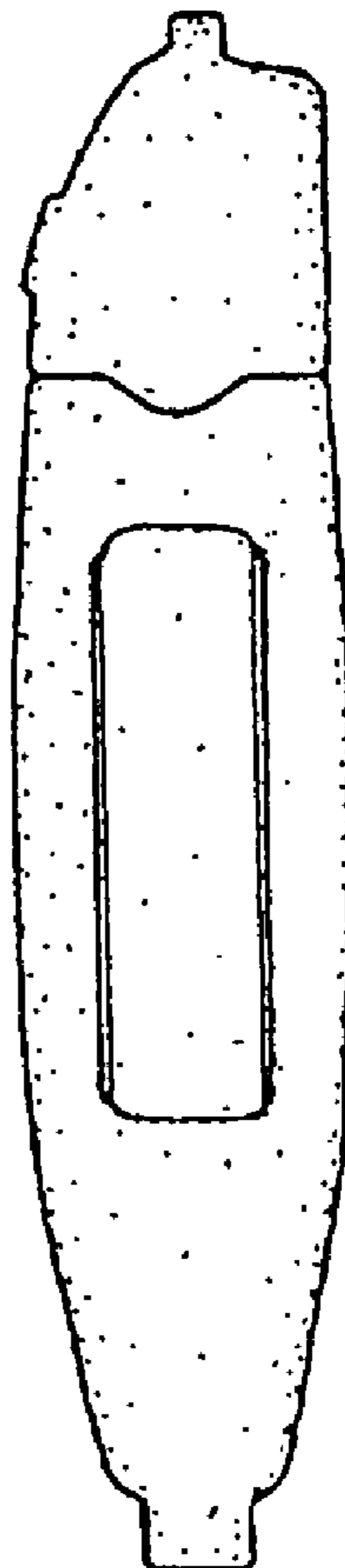

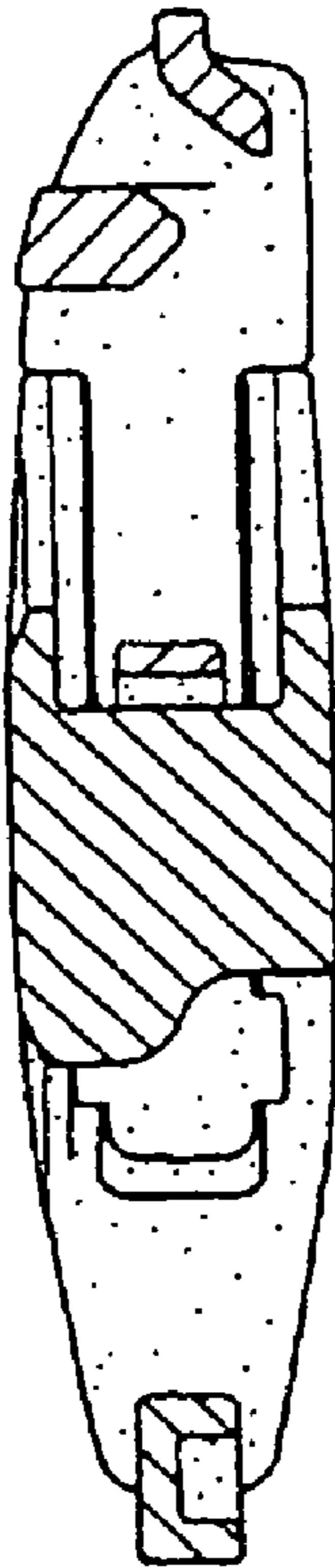

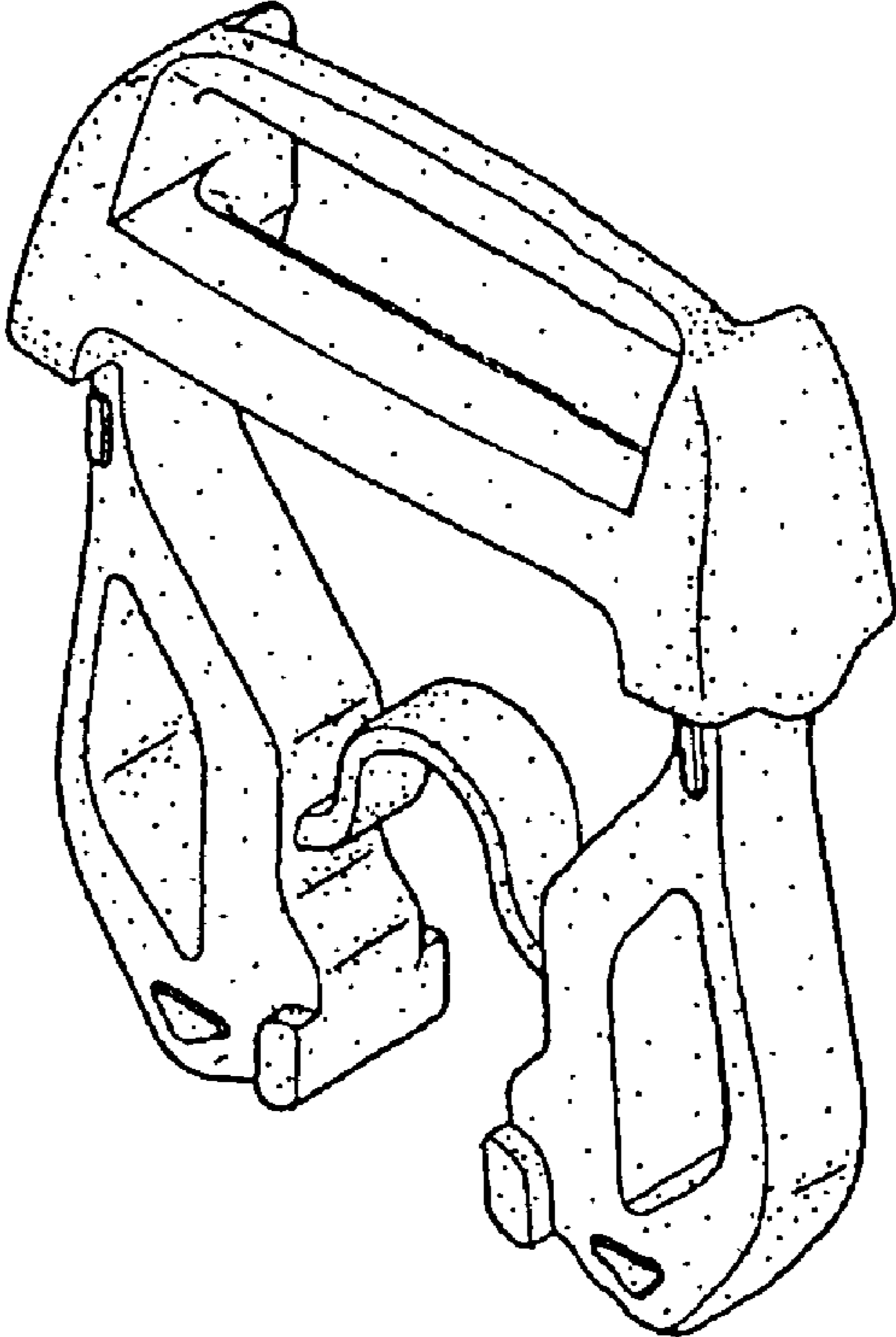

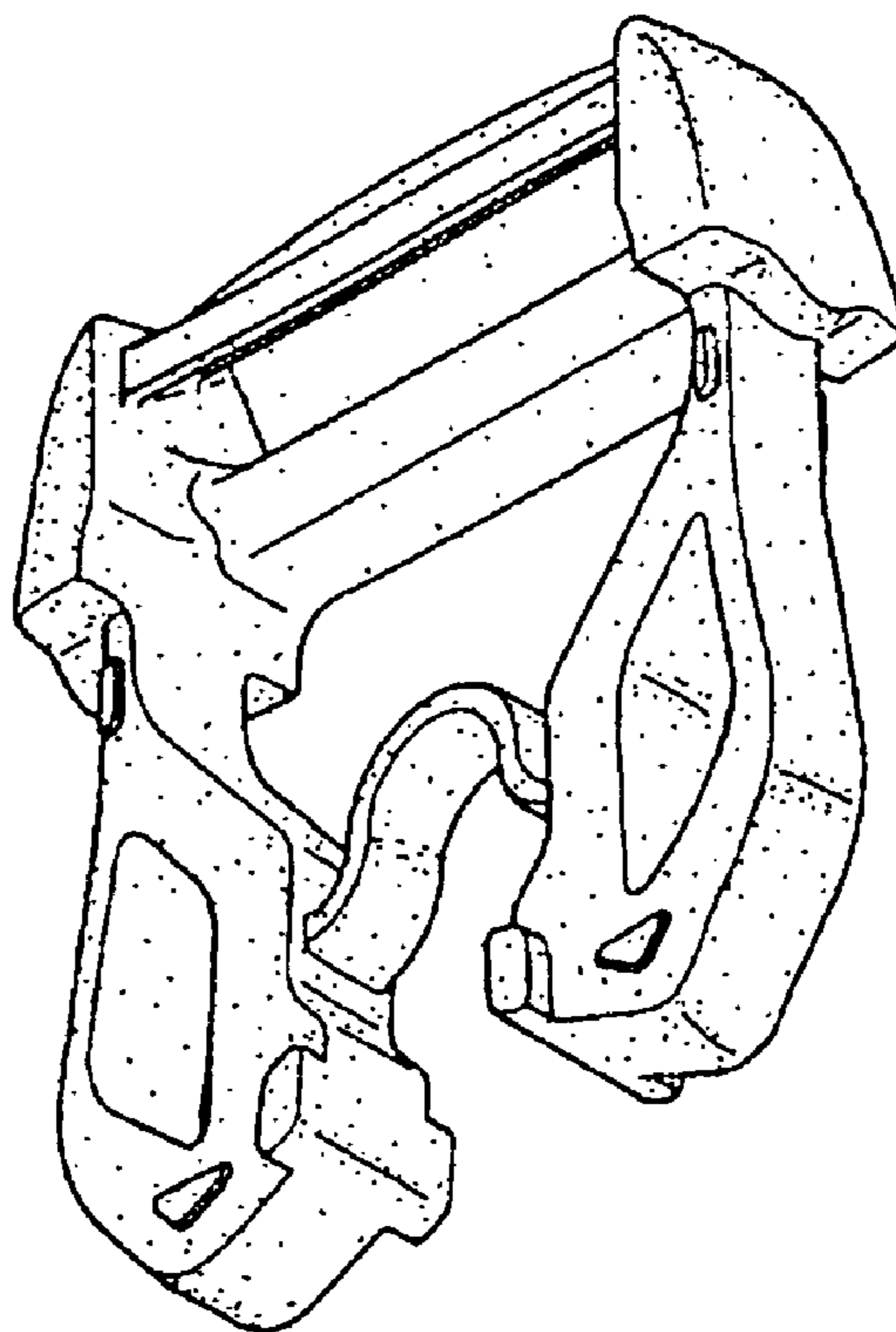

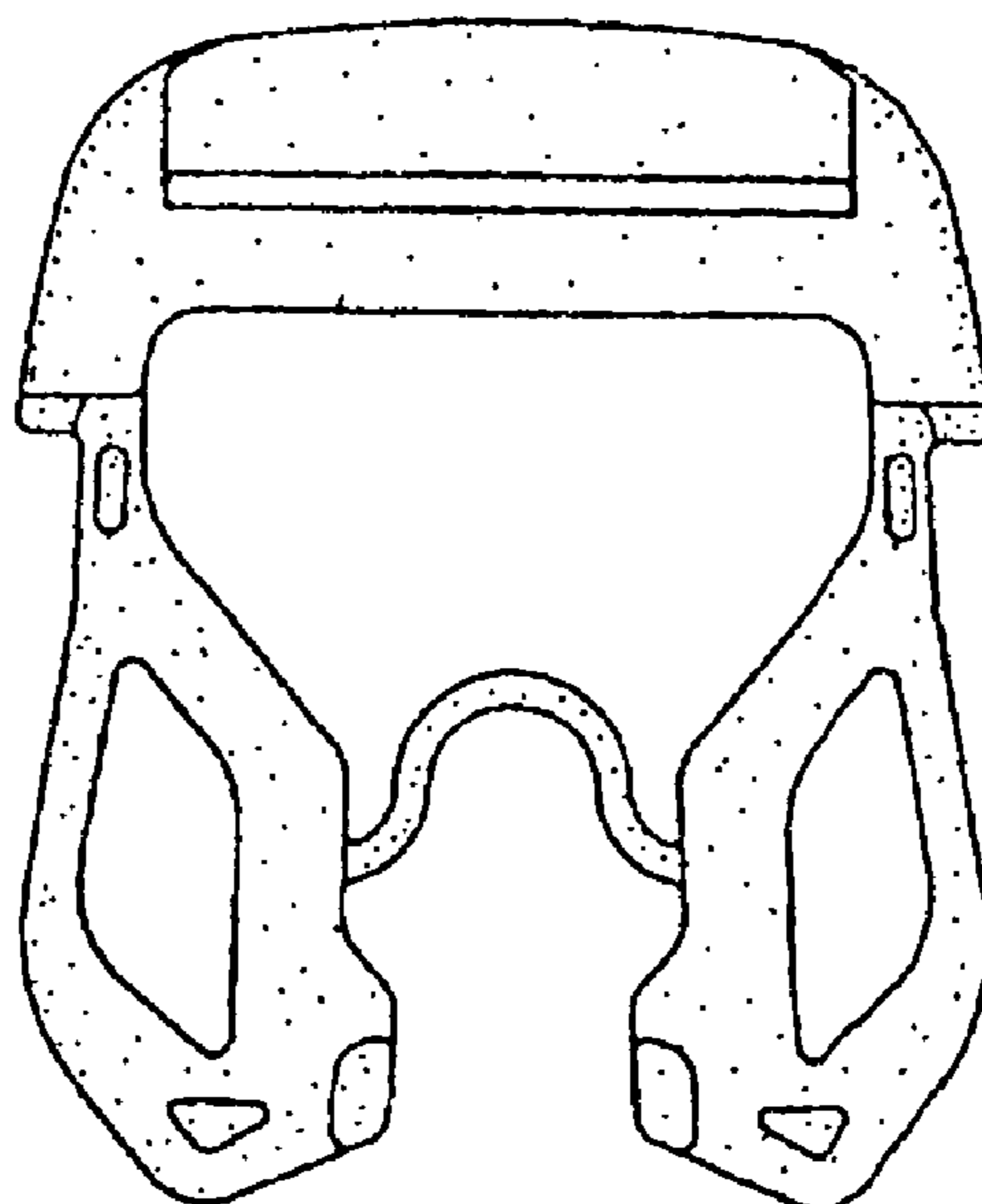

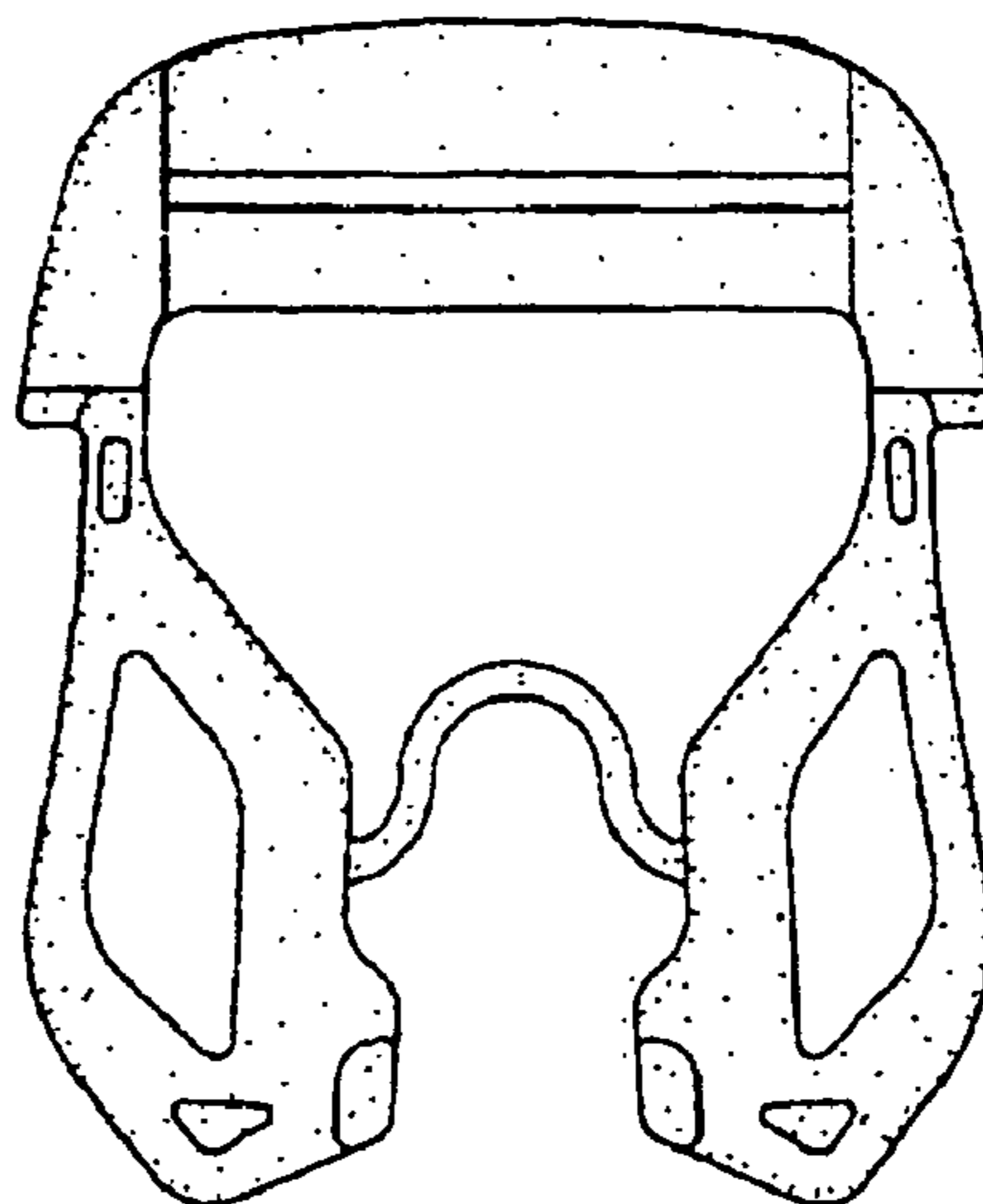

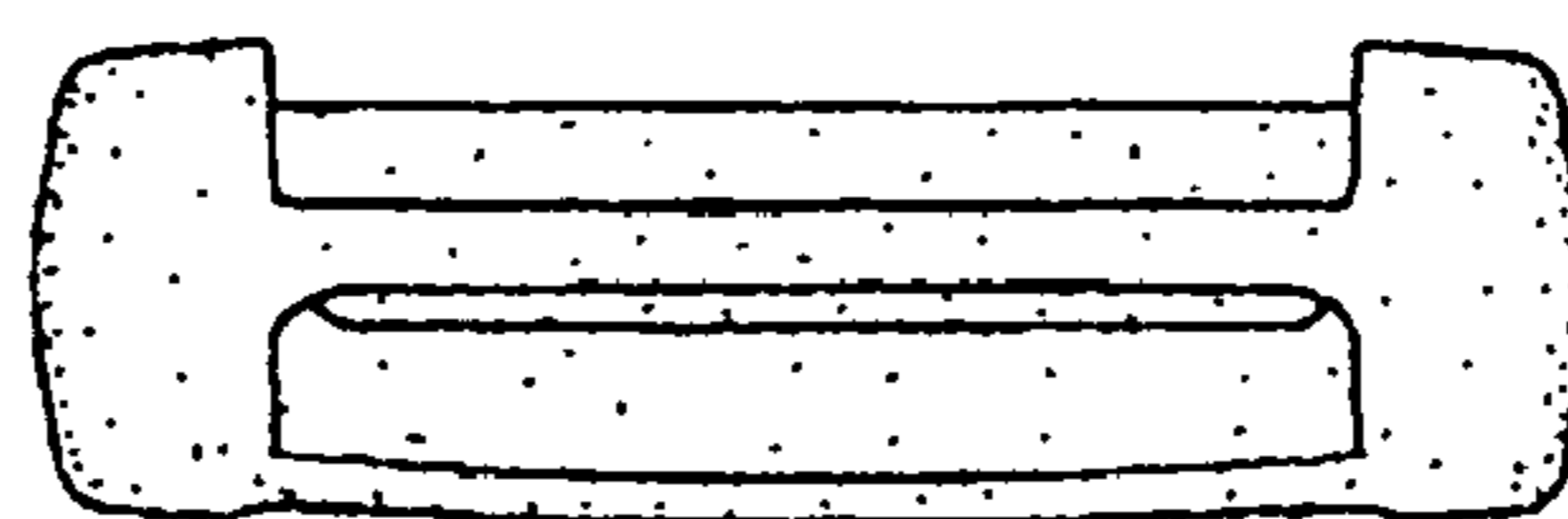

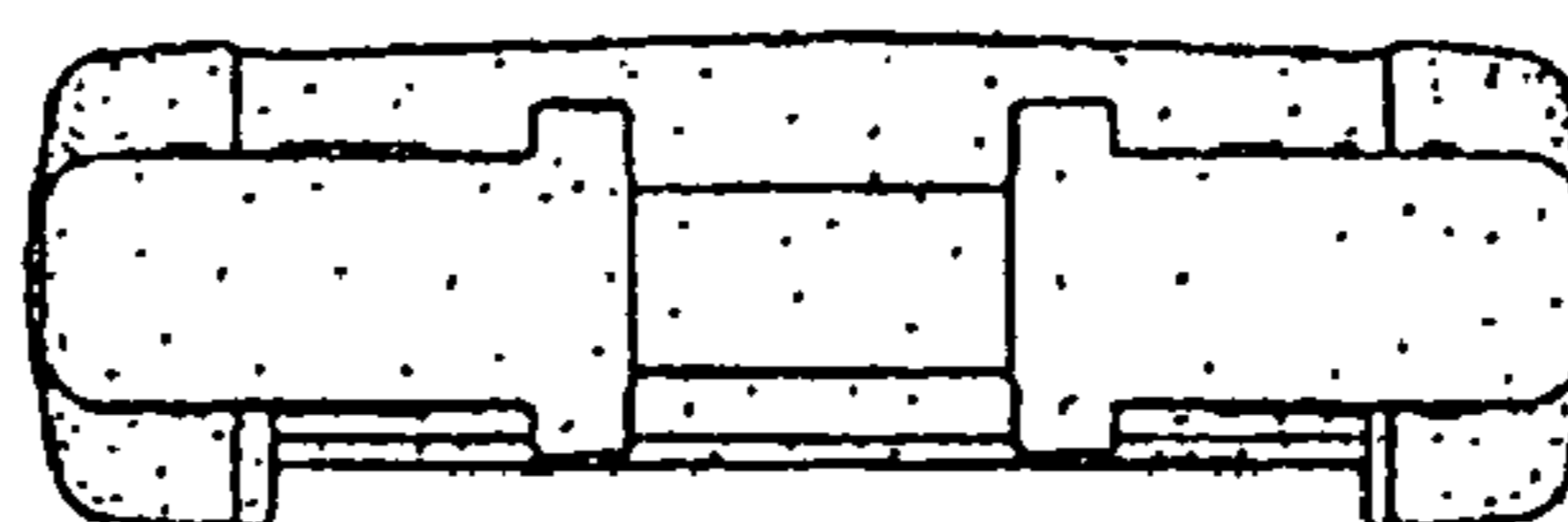

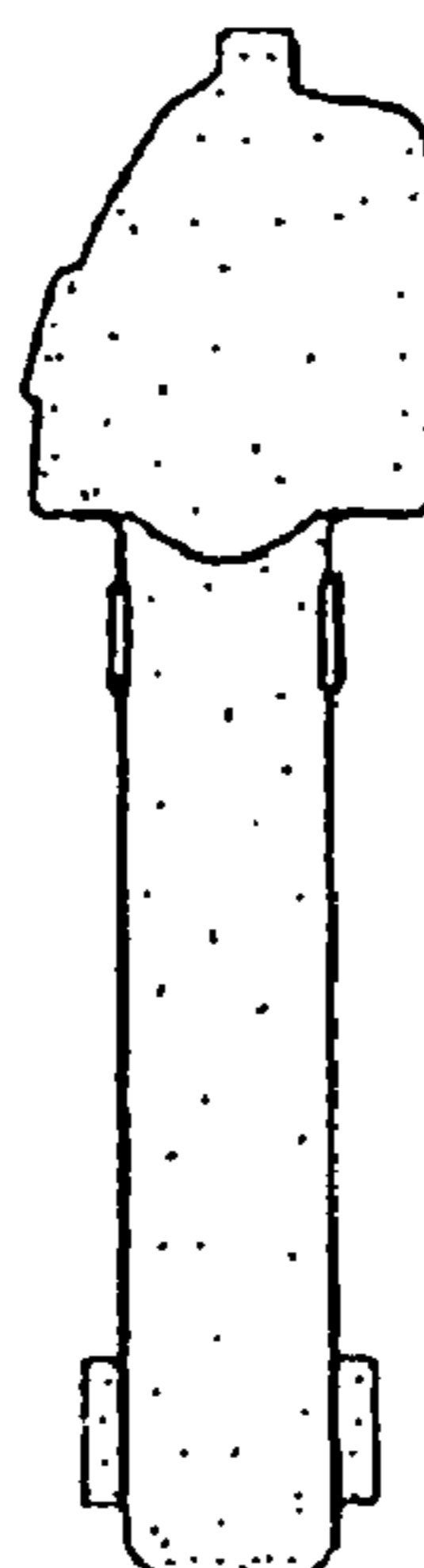

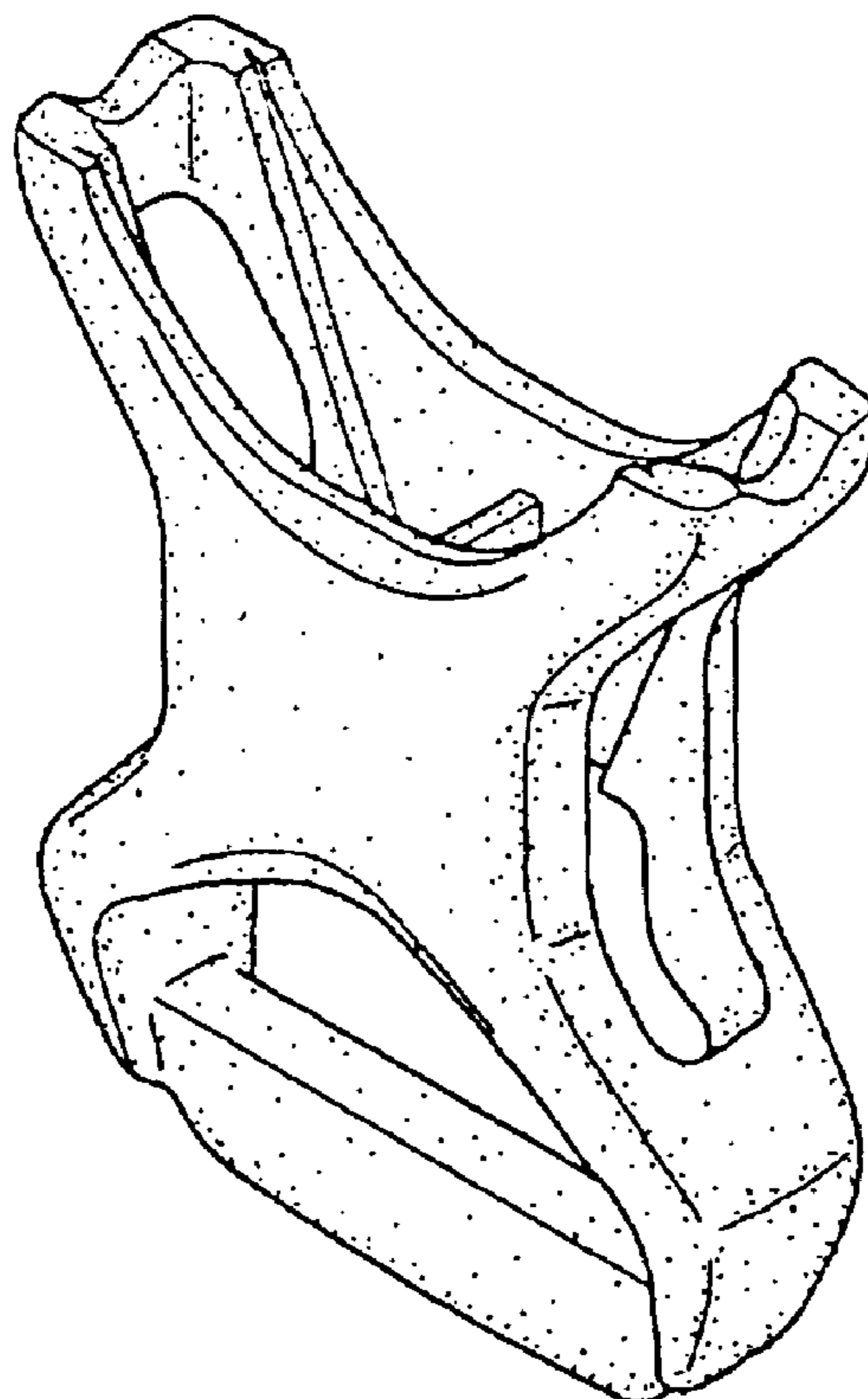

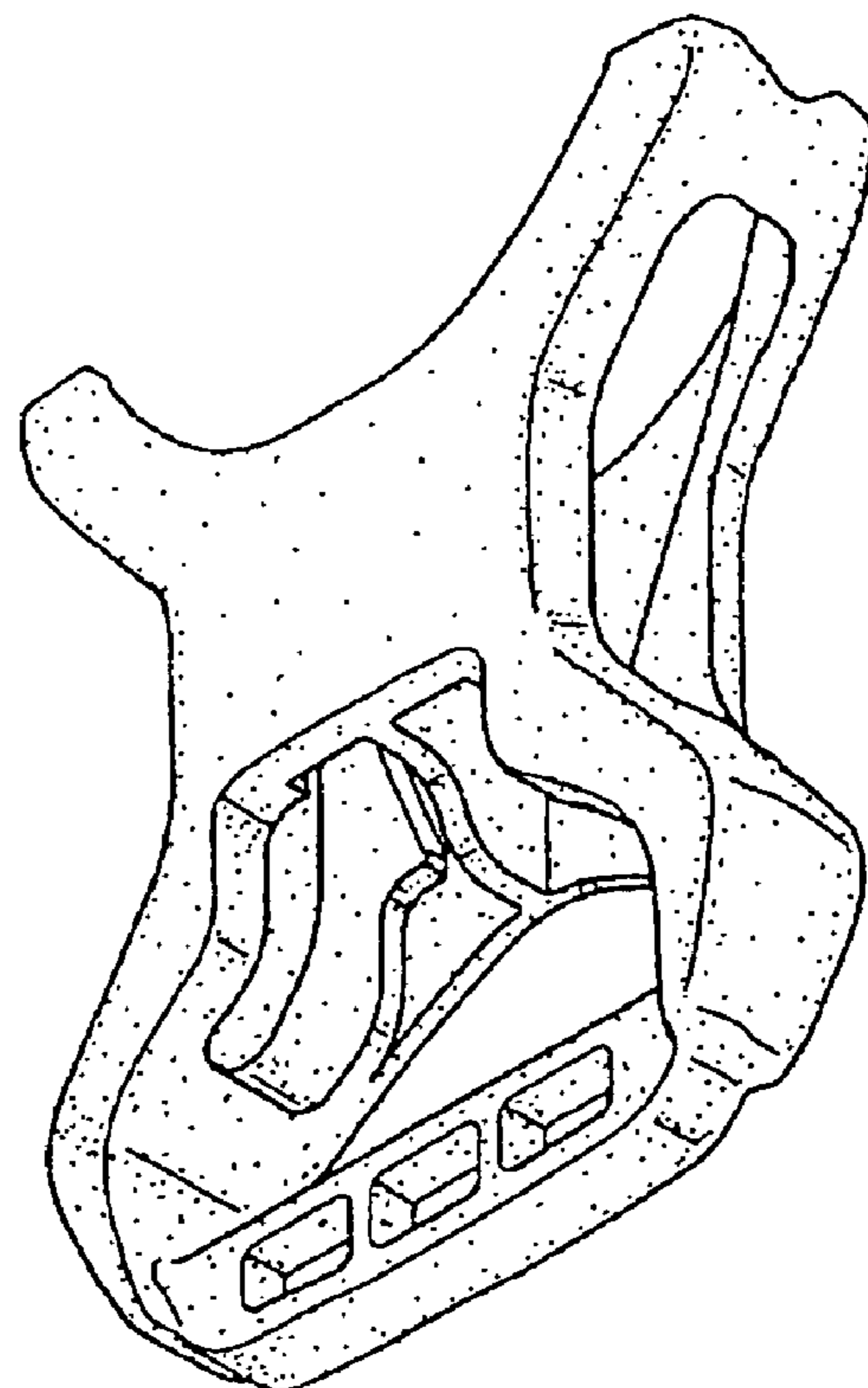

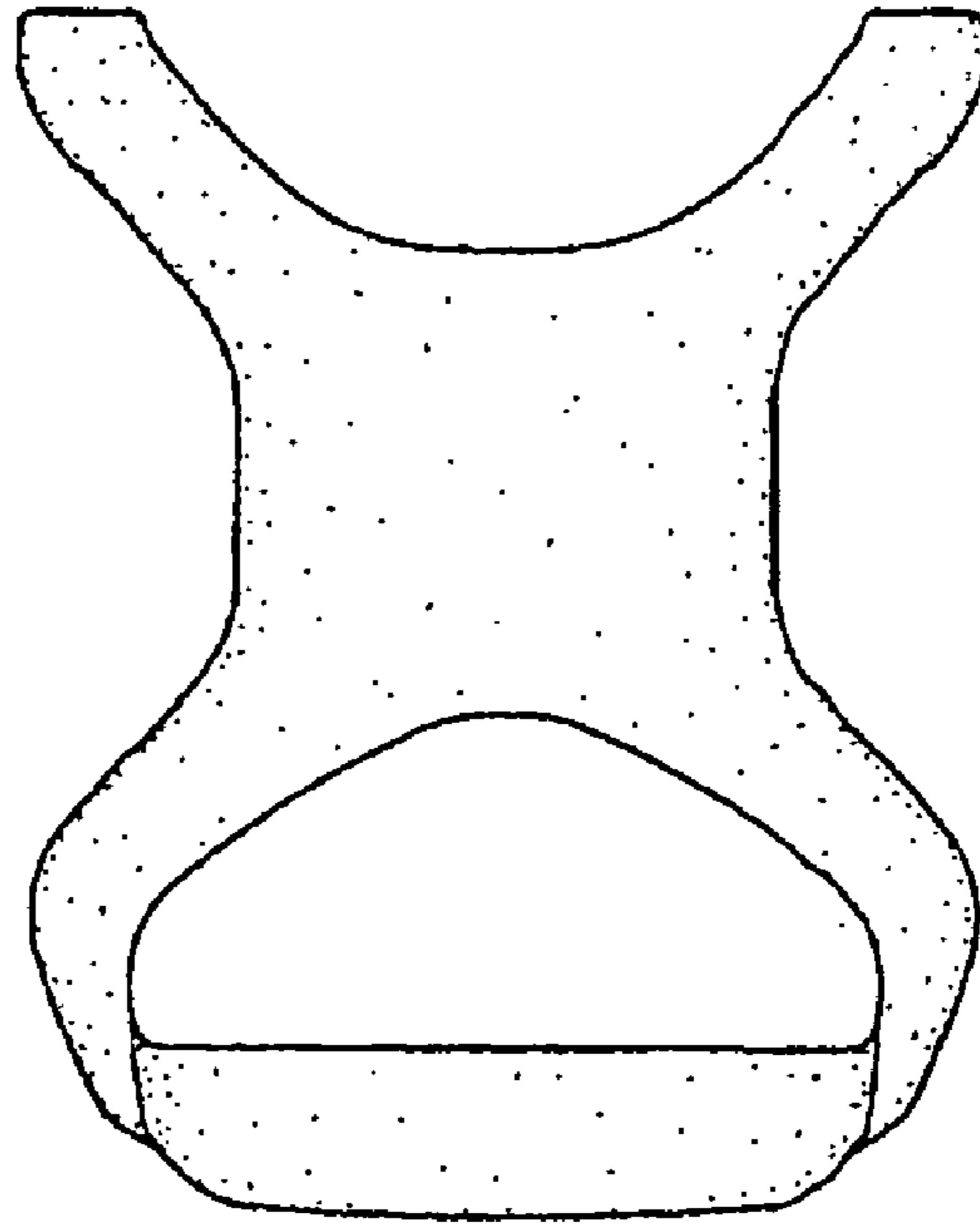

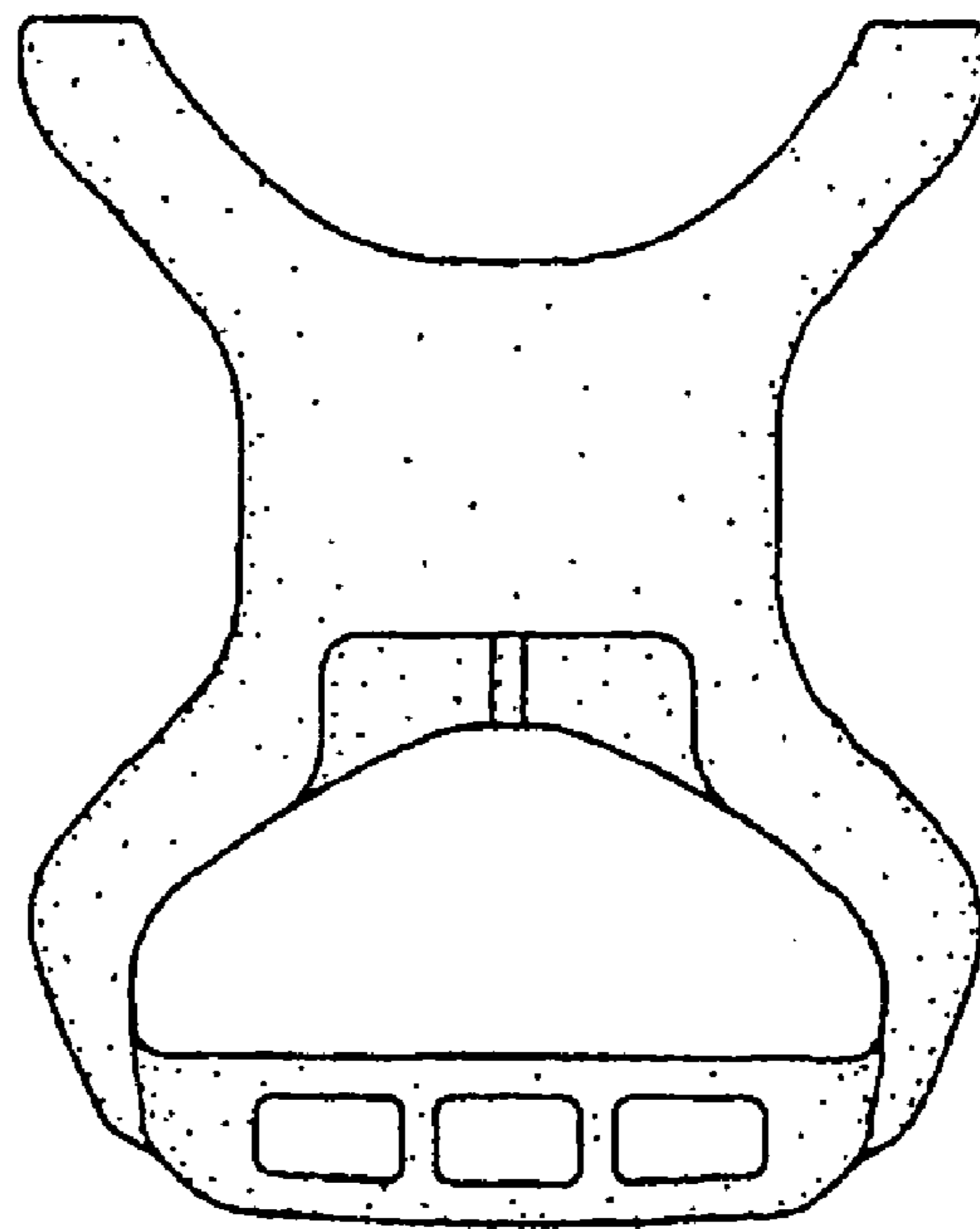

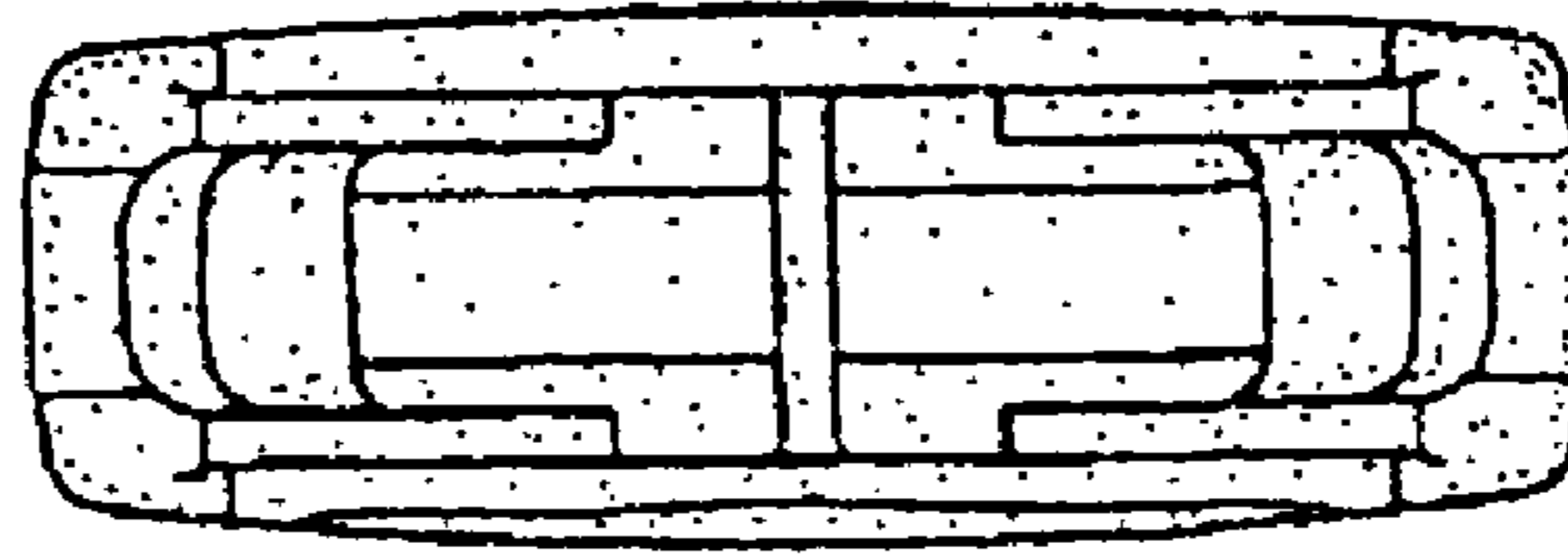

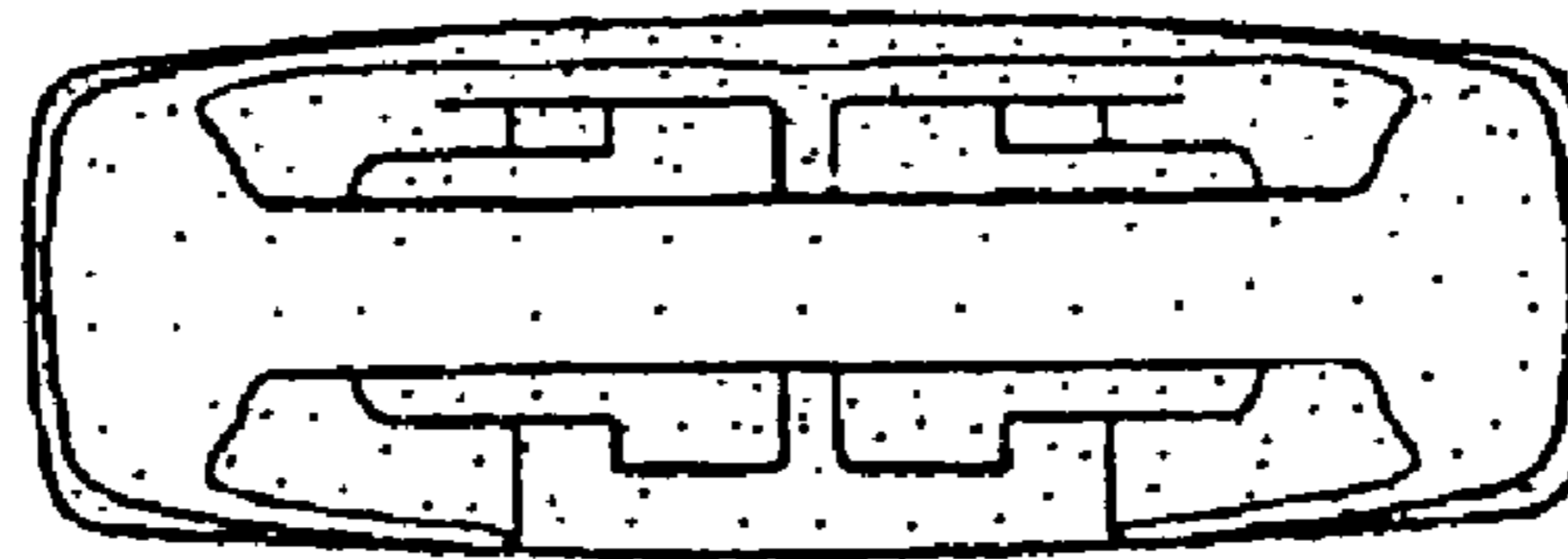
