(57) **CLAIM**

The ornamental design for a vehicular traction hook and forms, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side elevational view of a vehicular traction hook and forms showing our new design;  
 FIG. 2 is a left side elevational view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a front elevational view thereof;  
 FIG. 6 is a rear elevational view thereof;  
 FIG. 7 is a cross section thereof taken on section line VII-VII in FIG. 1;  
 FIG. 8 is a view of surrounding environmental matter while the design is in use;  
 FIG. 9 is a view of surrounding environmental matter while the design is in use; and,  
 FIG. 10 is an enlarged view thereof shown while in use.  
 The broken line showing of adjacent environmental matter shown throughout FIGS. 1-10 is included for the purpose of showing environmental portions of the vehicular traction hook and forms and a vehicle in use thereof and forms no part of the claimed design.

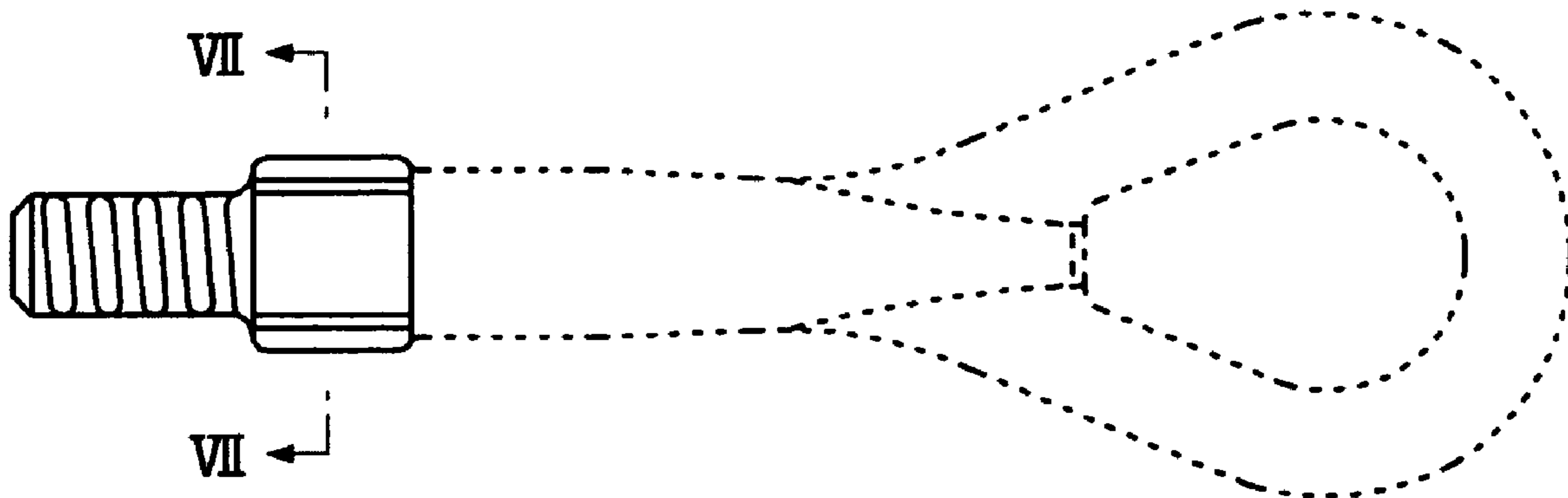

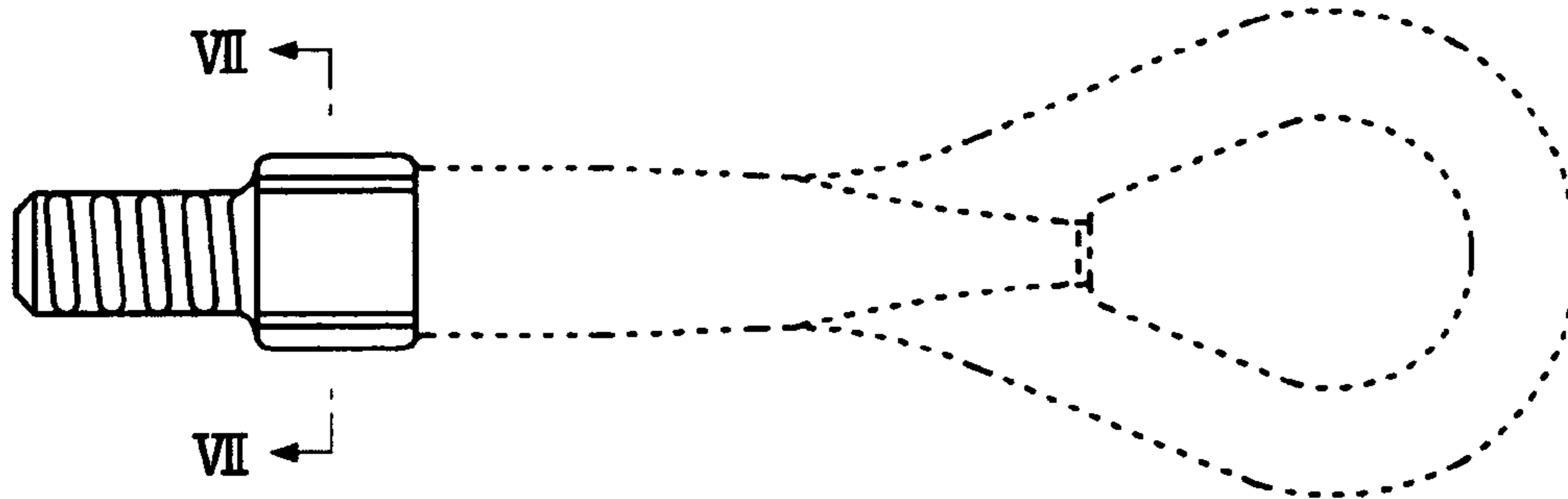

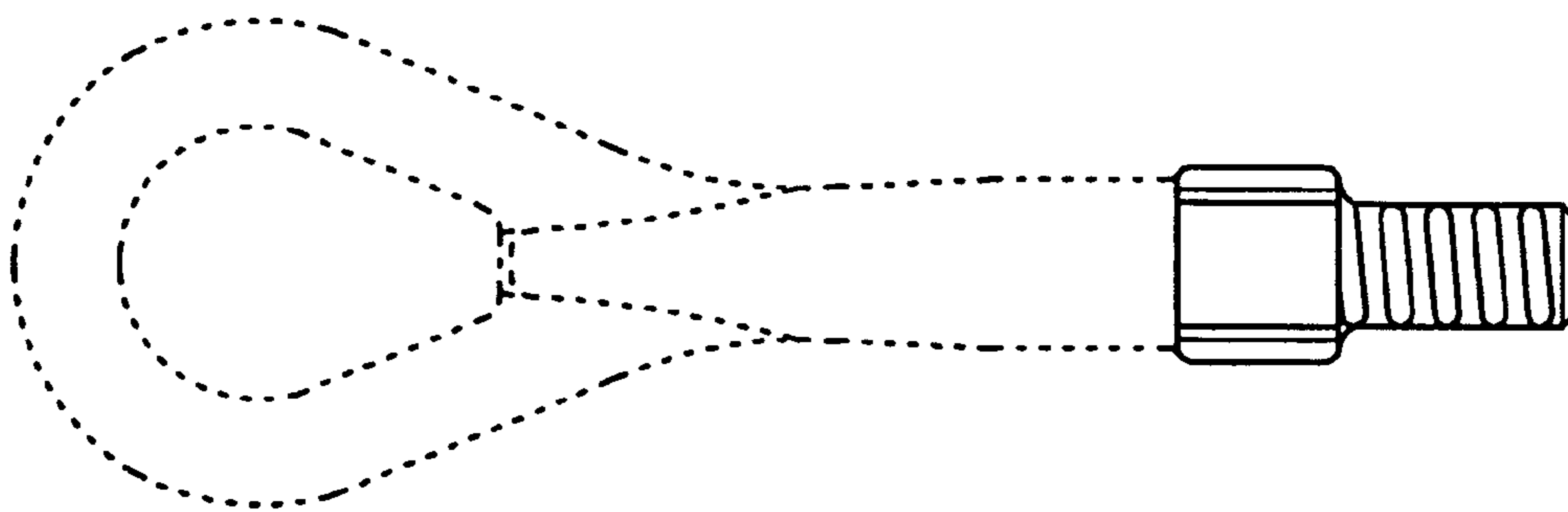

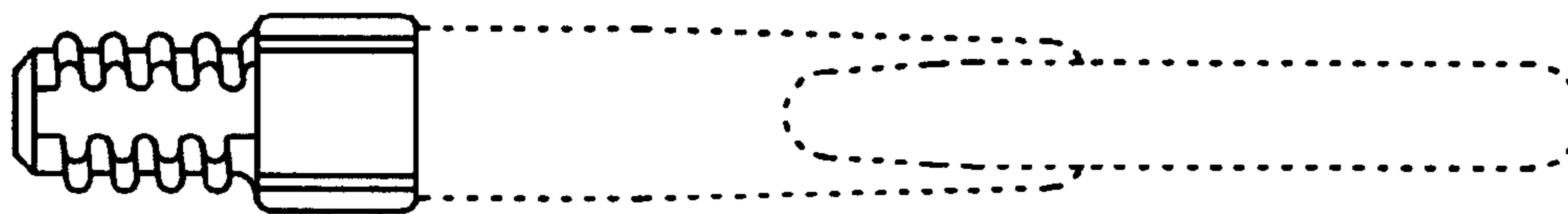
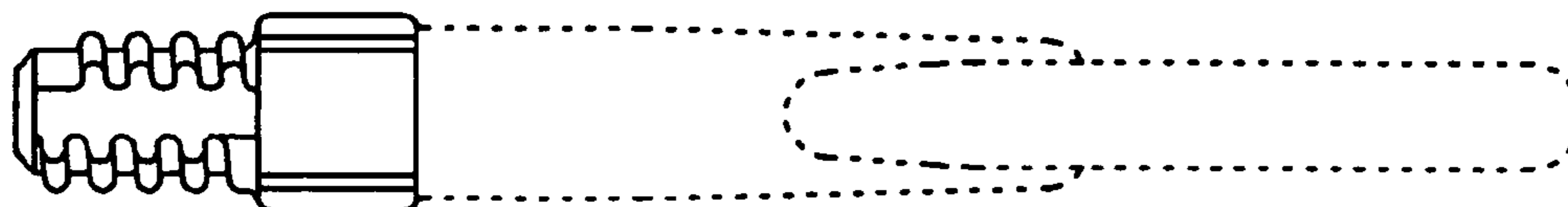
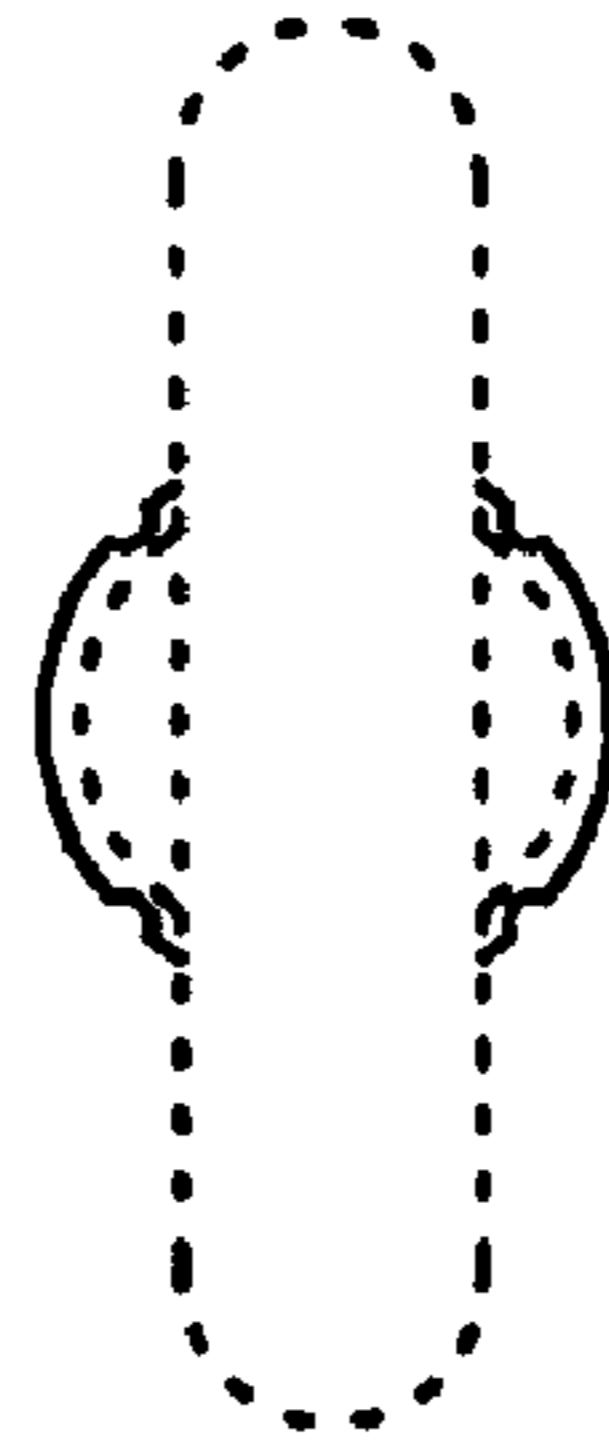


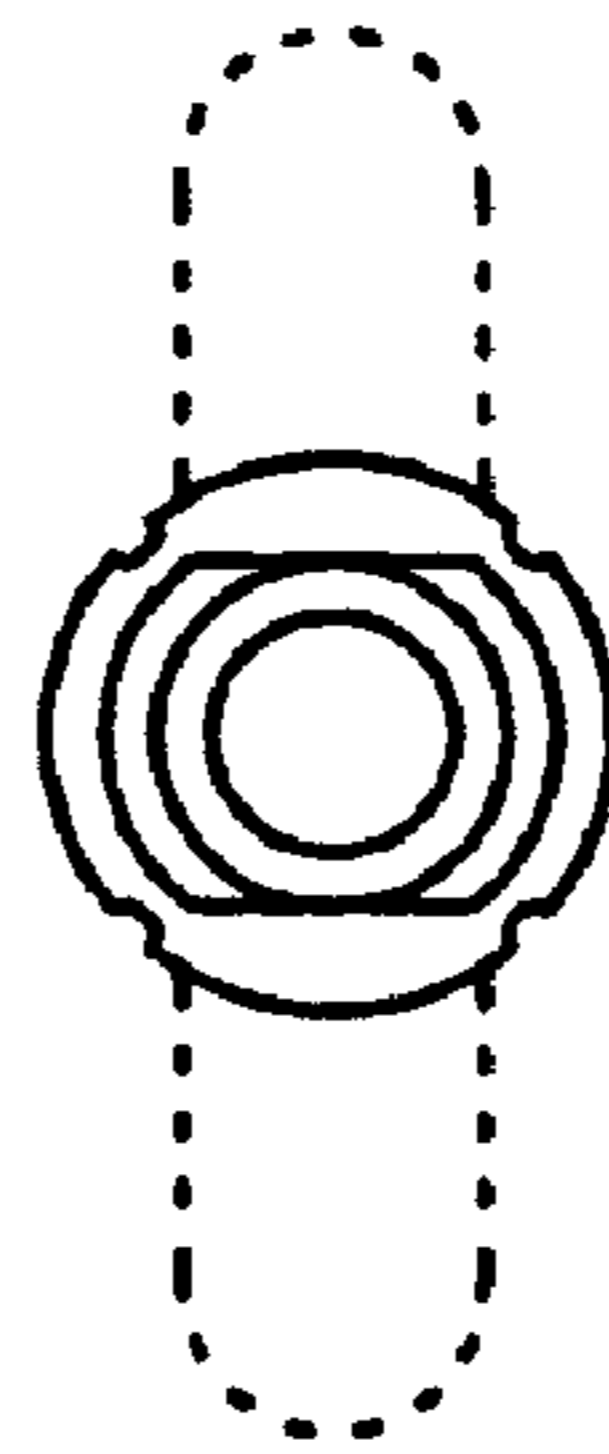

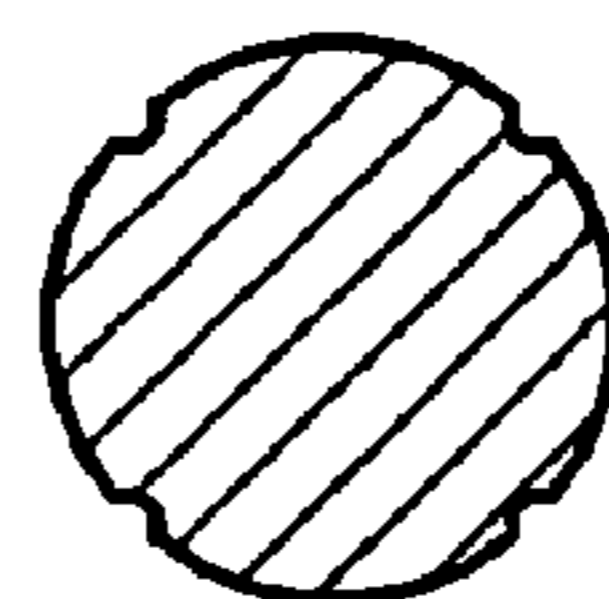

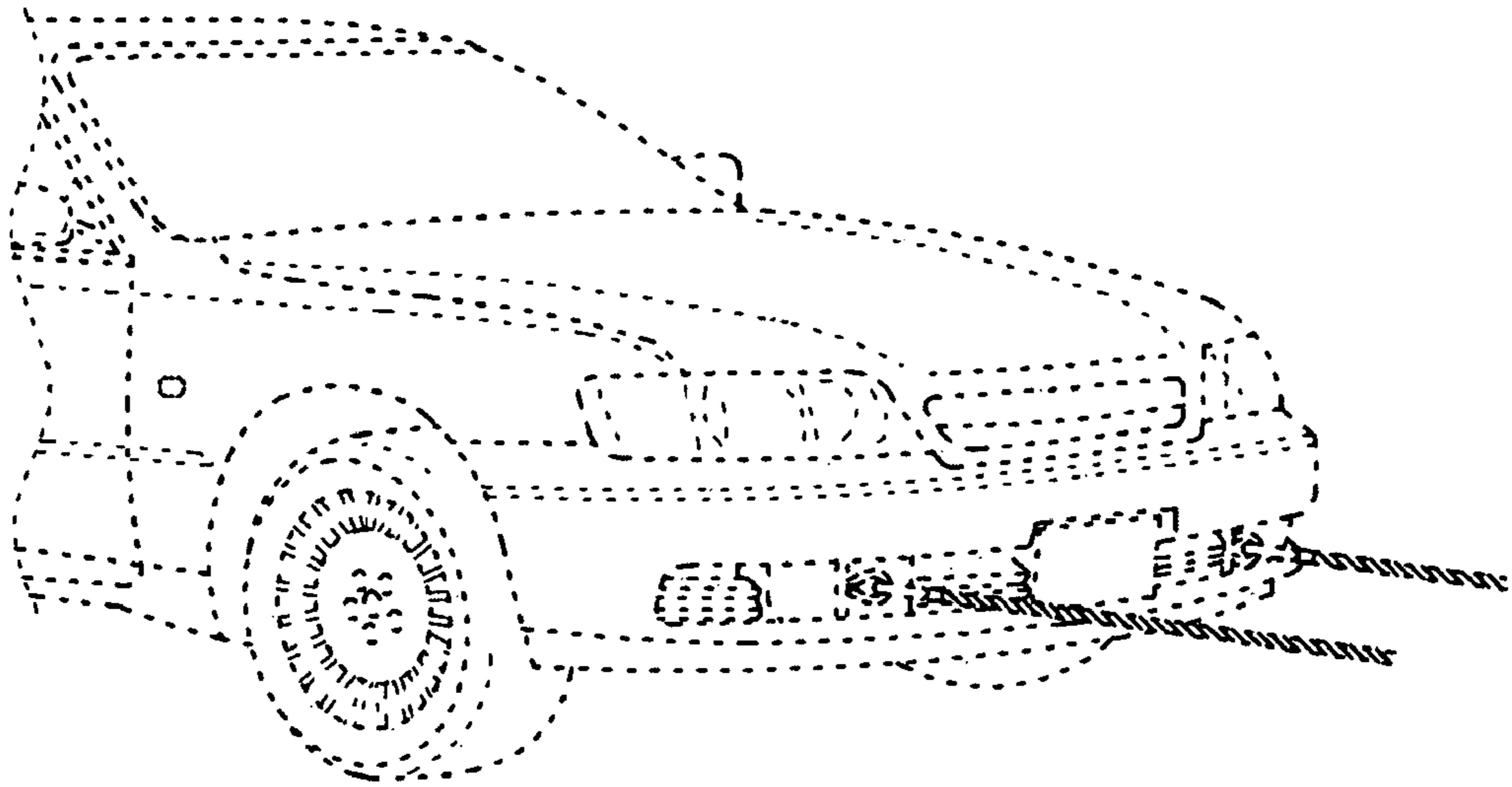

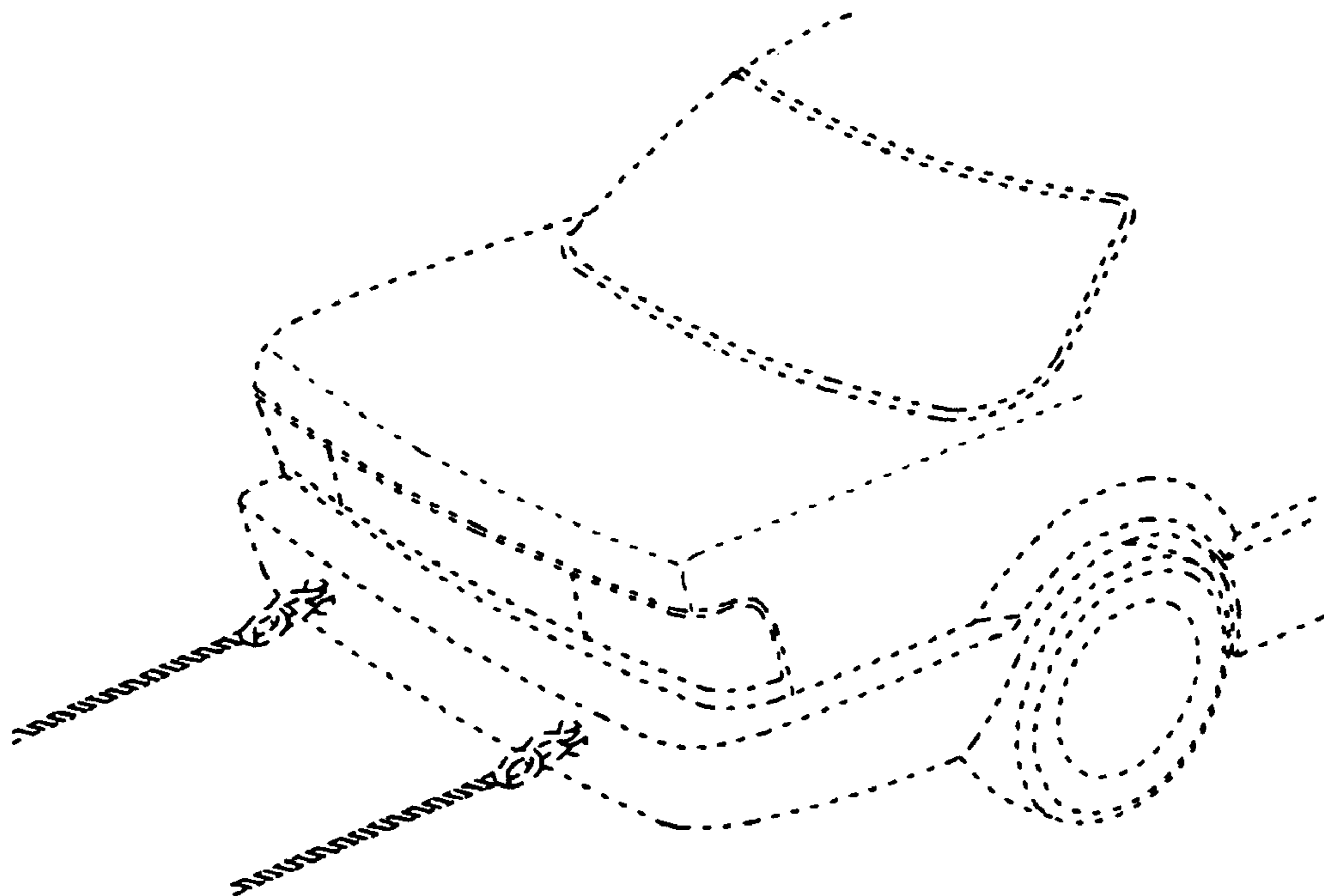
