FIG. 4 is an front elevational view thereof.

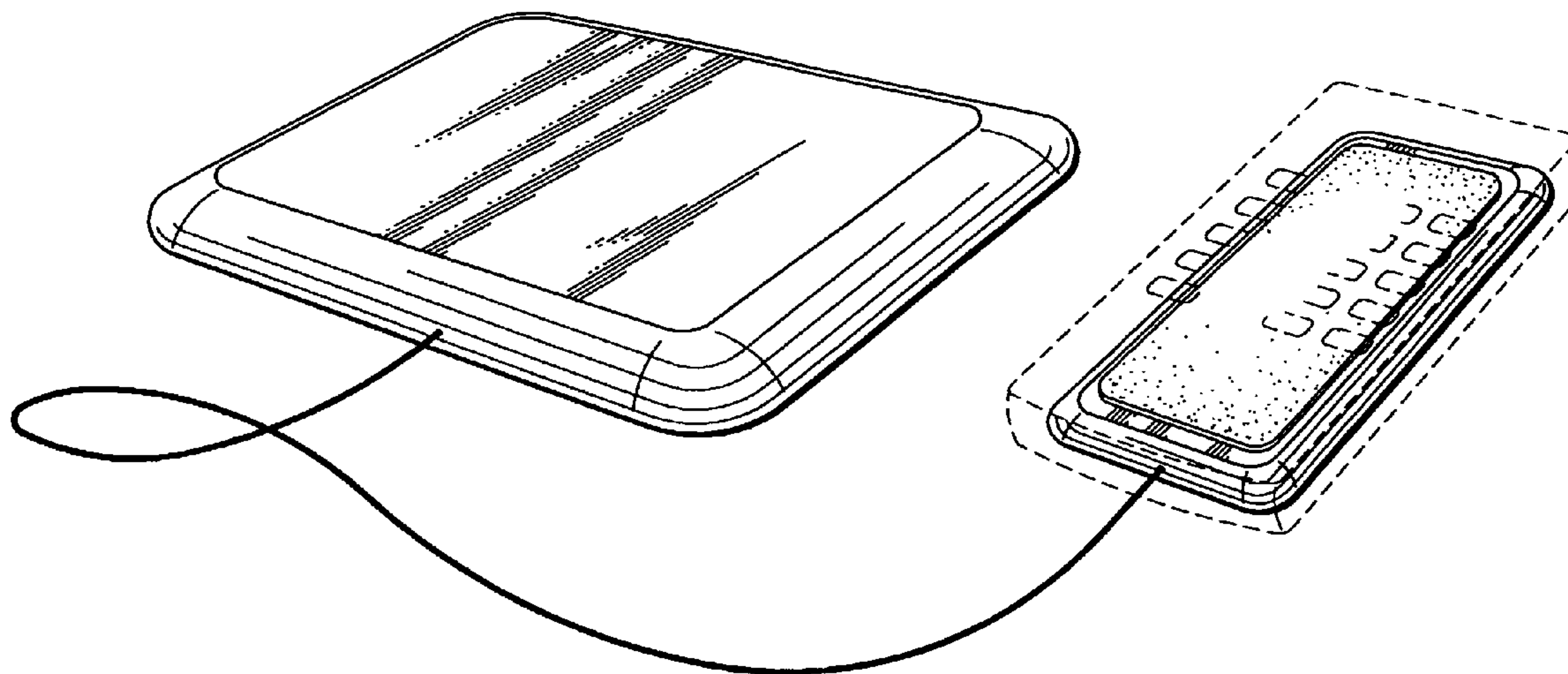
FIG. 5 is an elevational view of one side thereof.

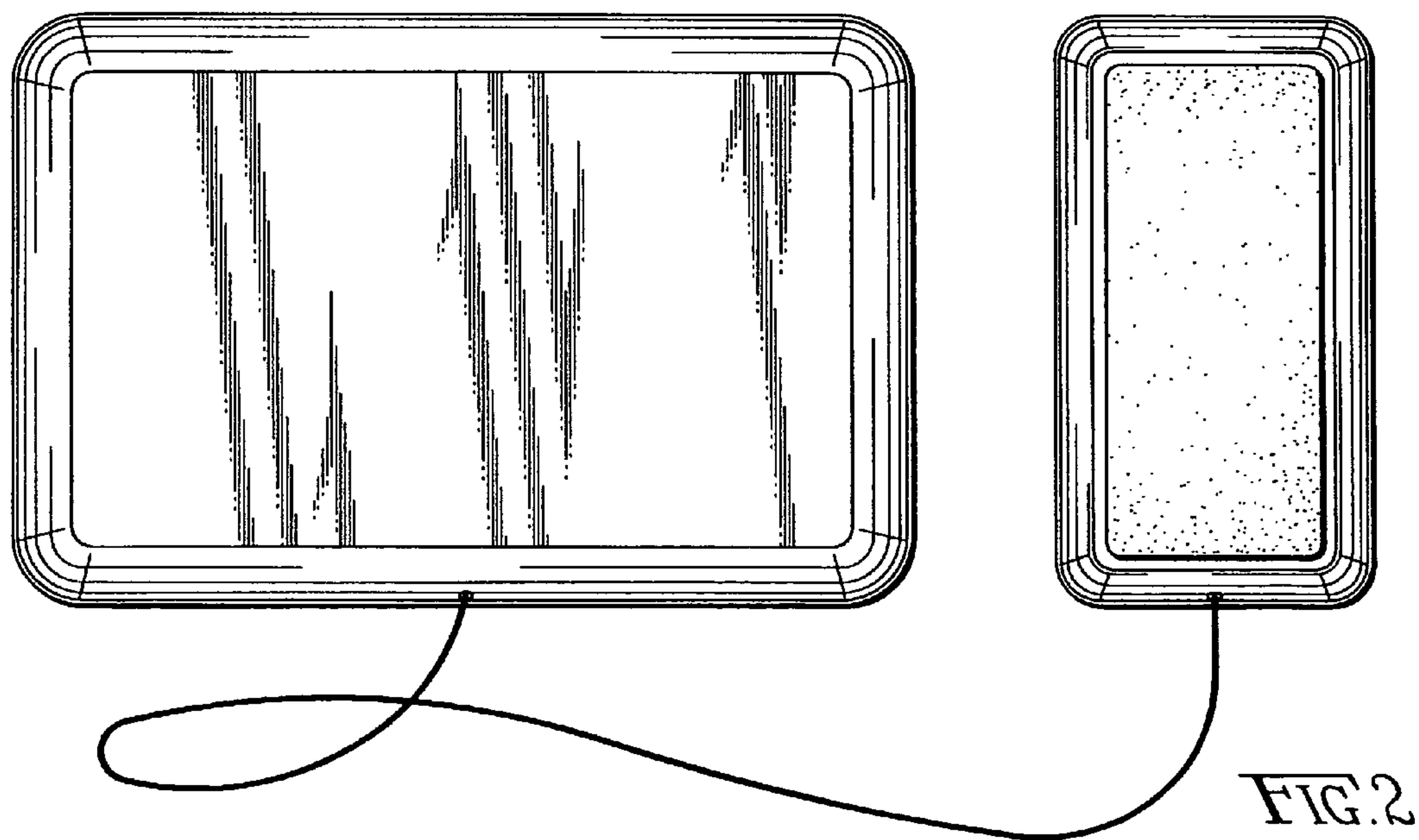
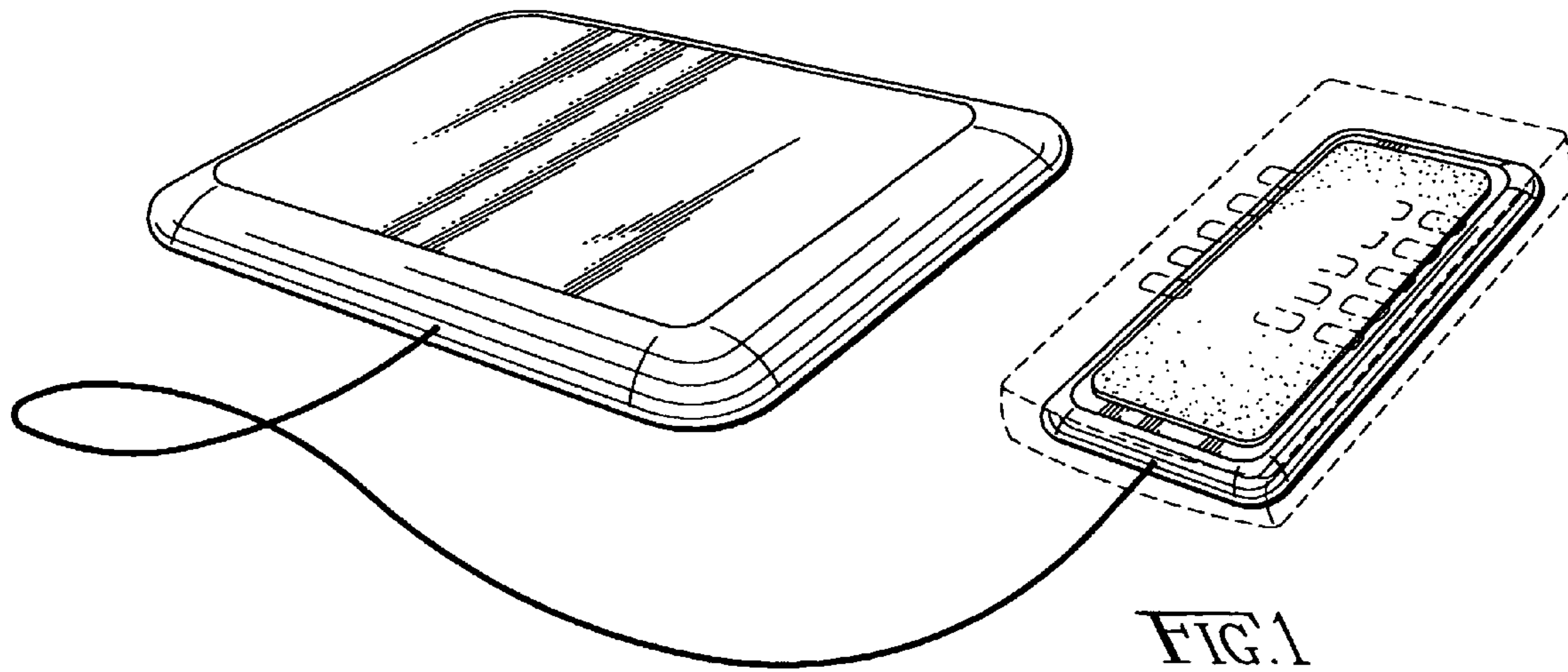
FIG. 6 is an elevational view of the opposite side thereof; and,

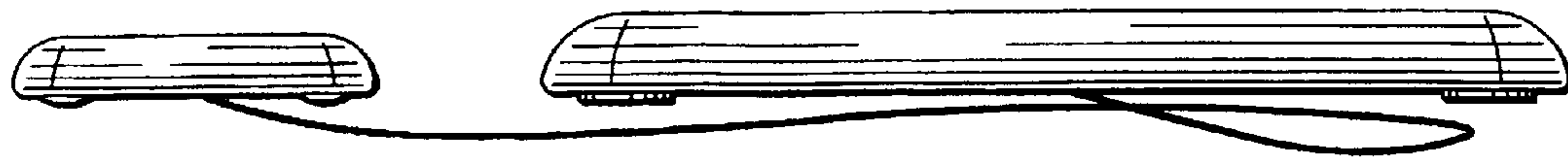

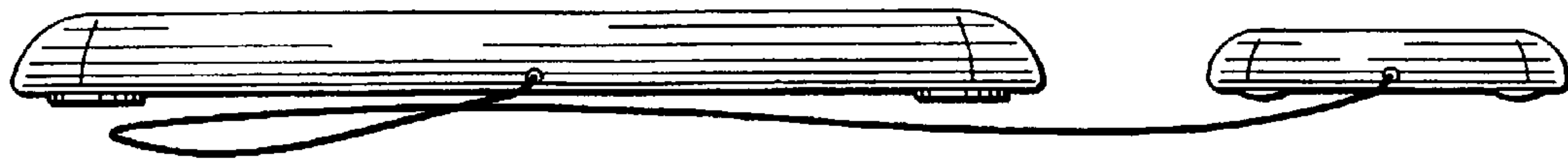

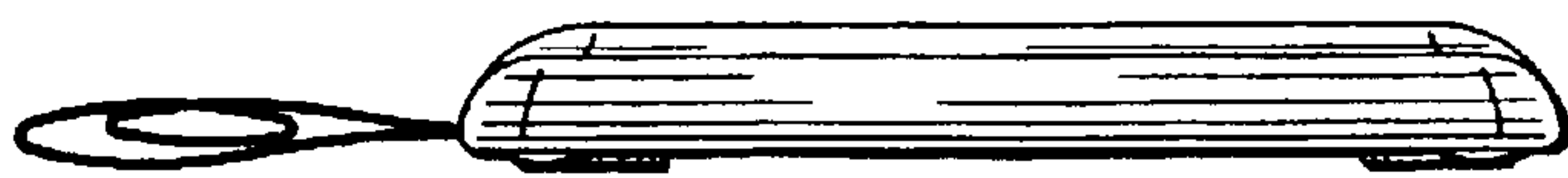

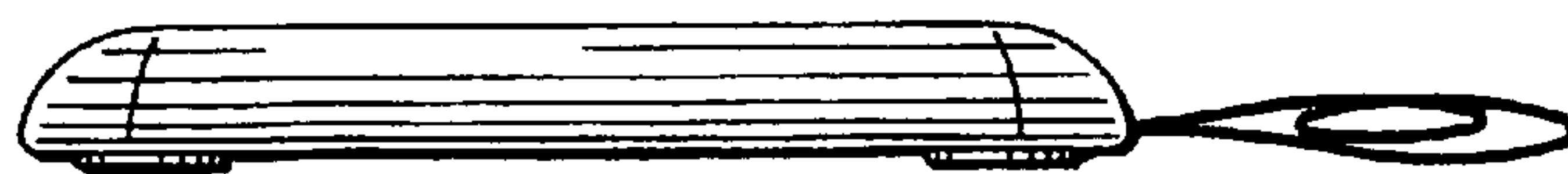

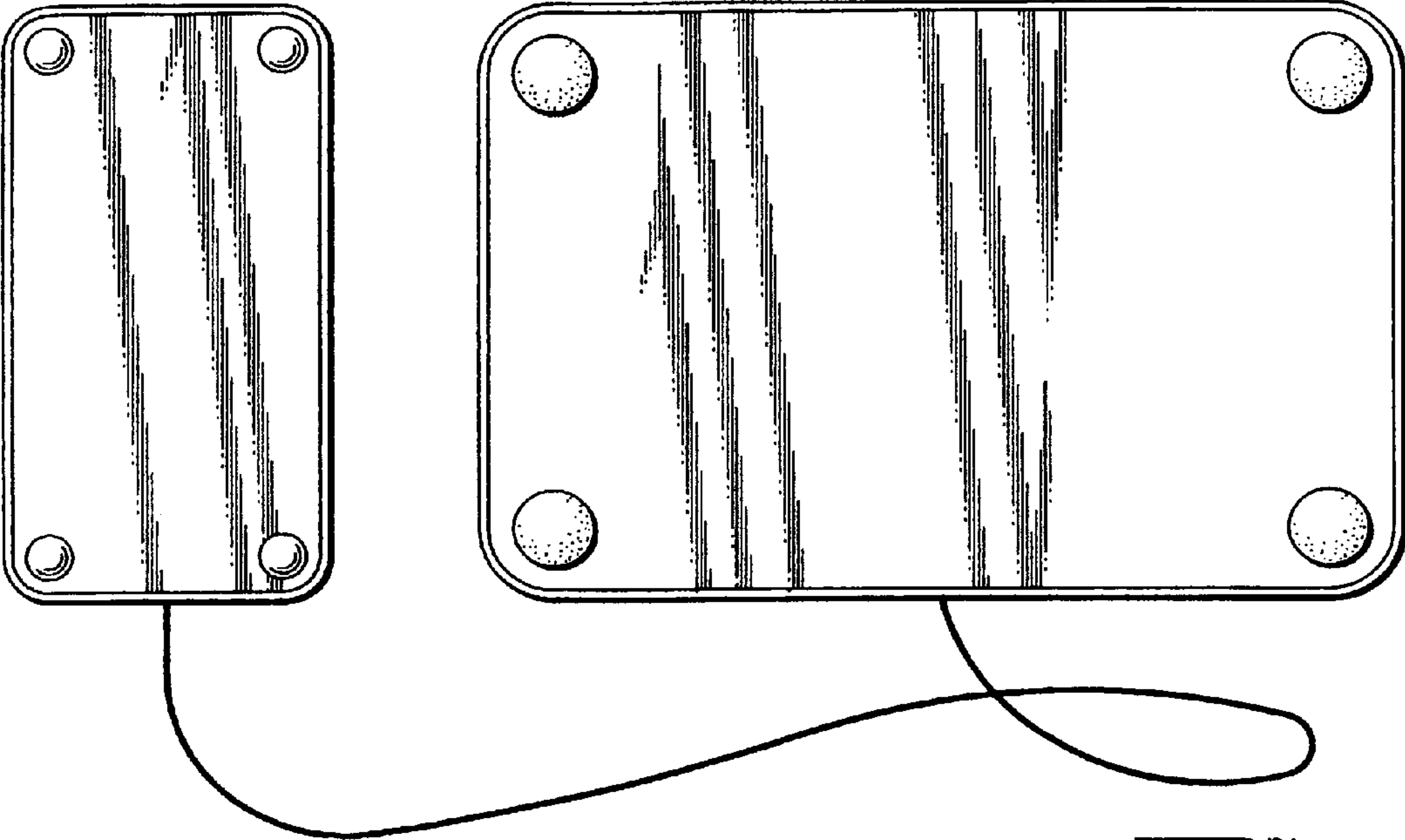
