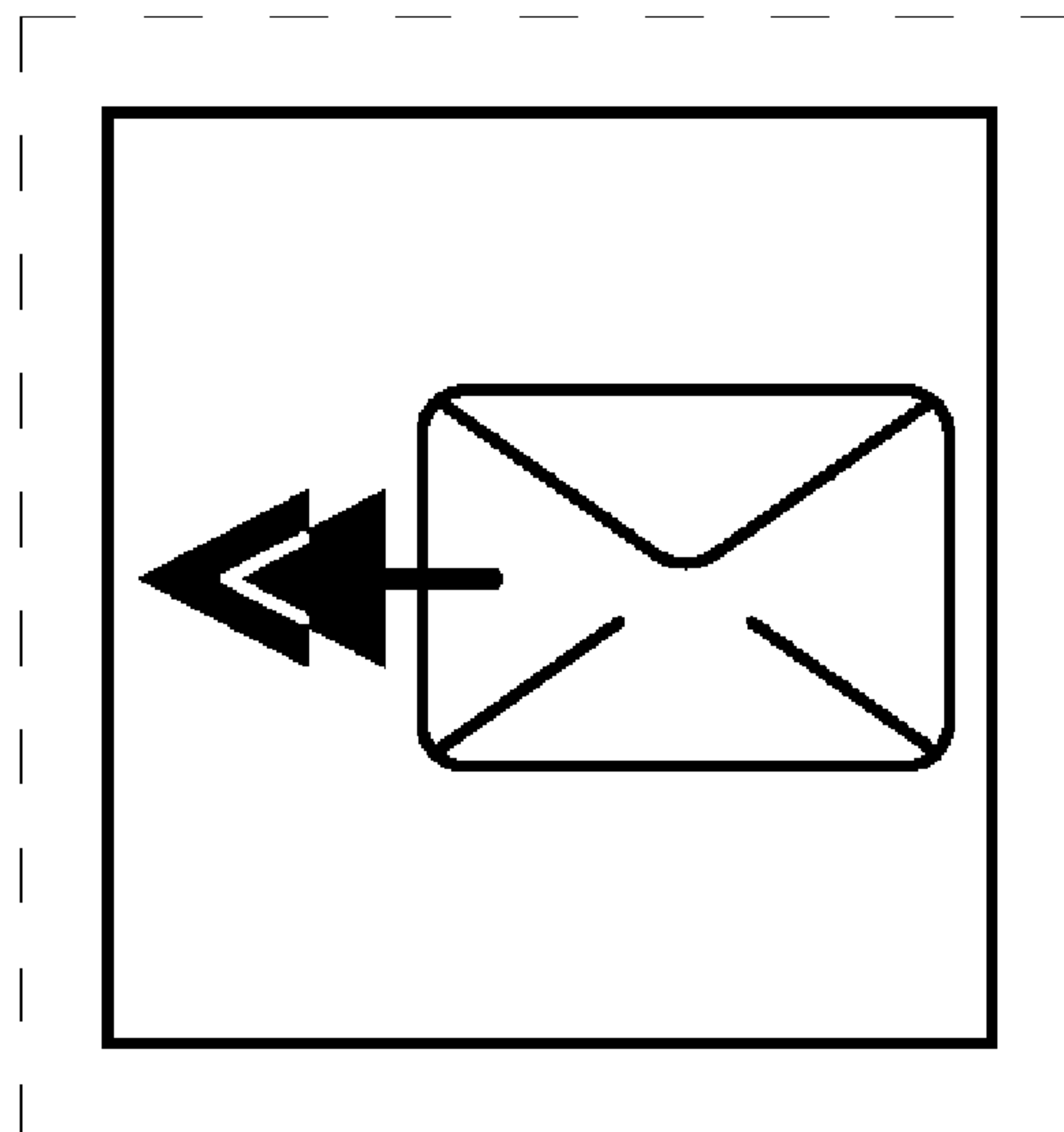
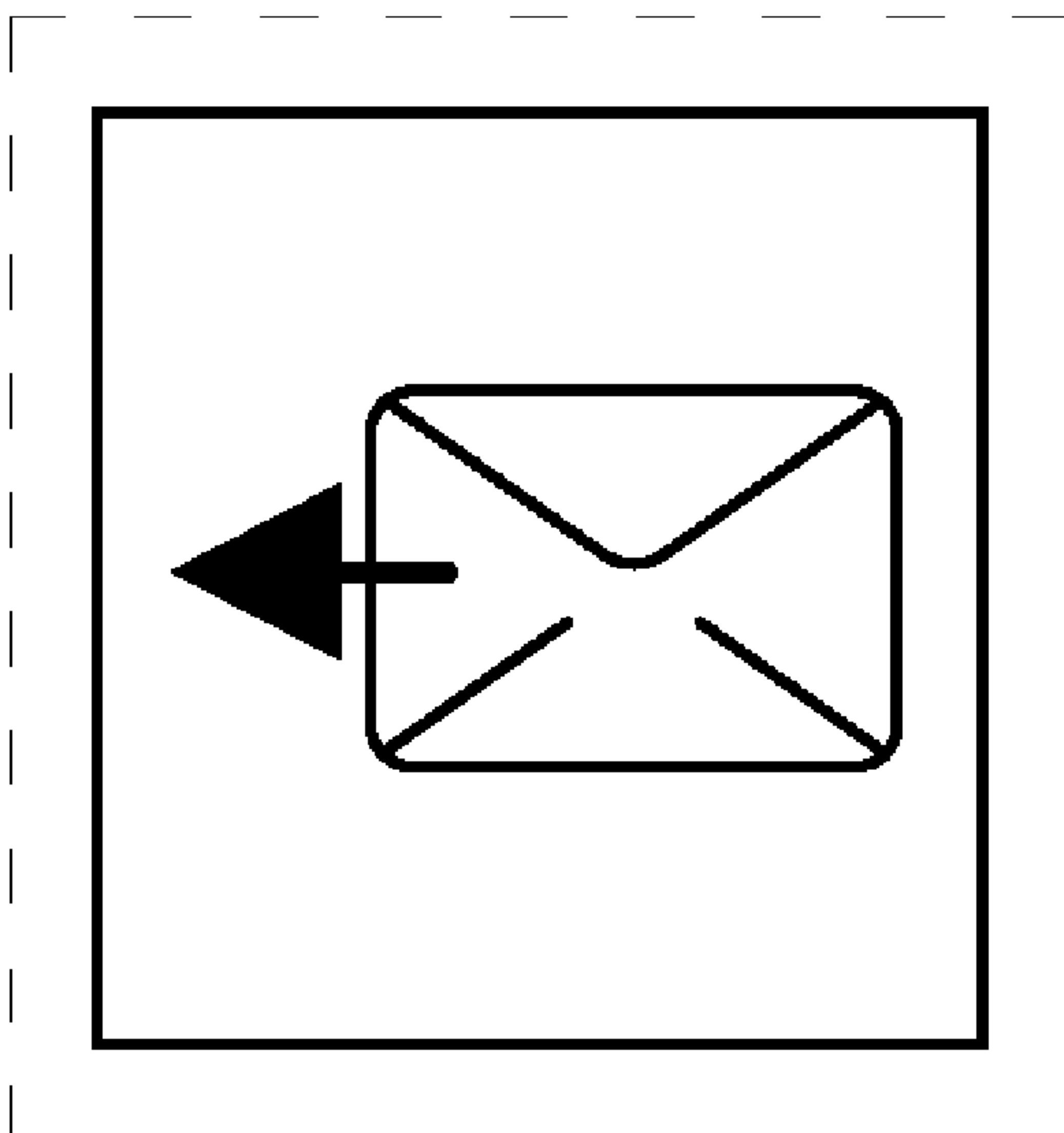
(57) **CLAIM**

We claim the ornamental design for display screen with an icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with an icon; FIG. 2 is a front view of a second embodiment thereof; and, FIG. 3 is a front view of a third embodiment thereof. The broken lines of the display screen in the drawings are for the purpose of illustrating environmental structure and form no part of the claimed design.

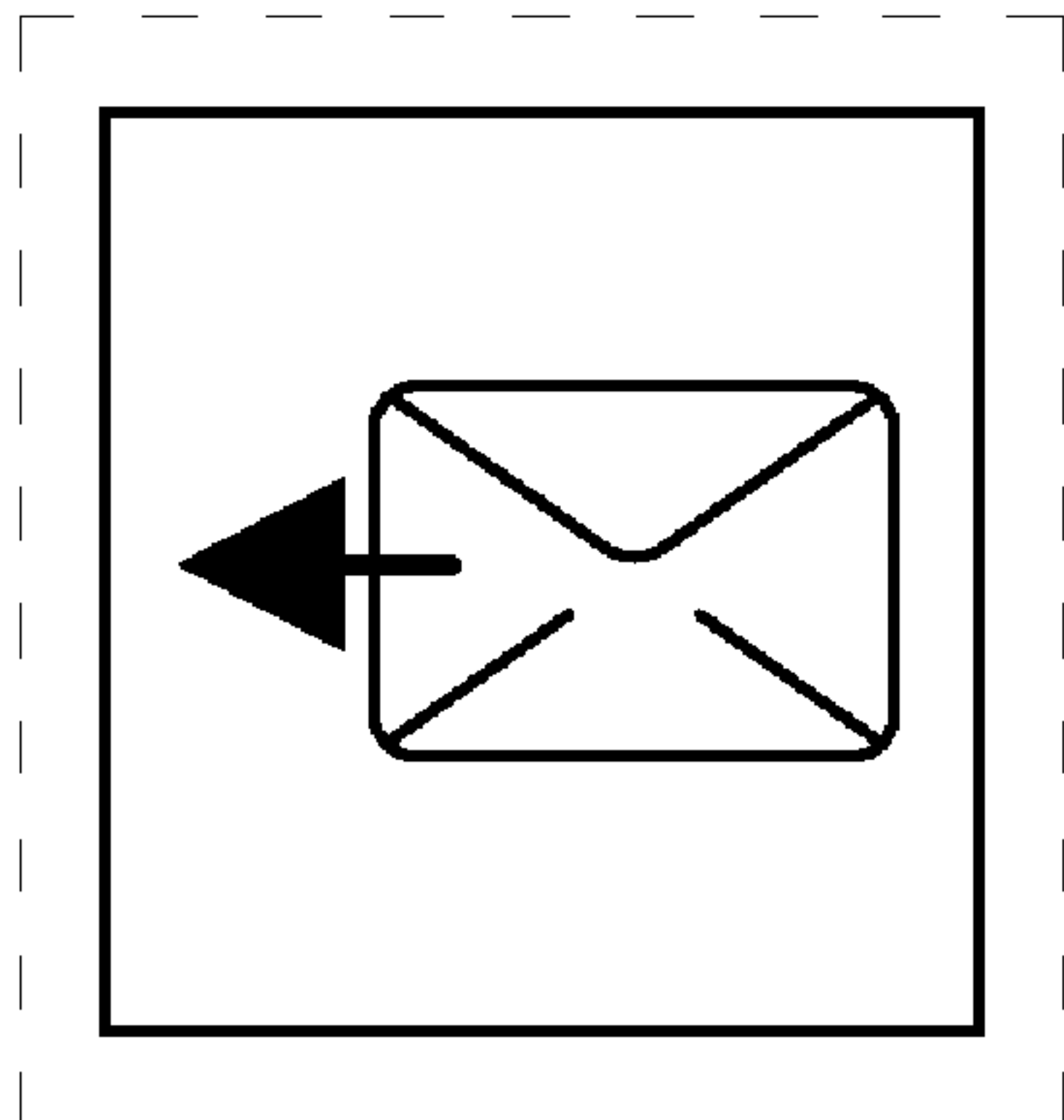

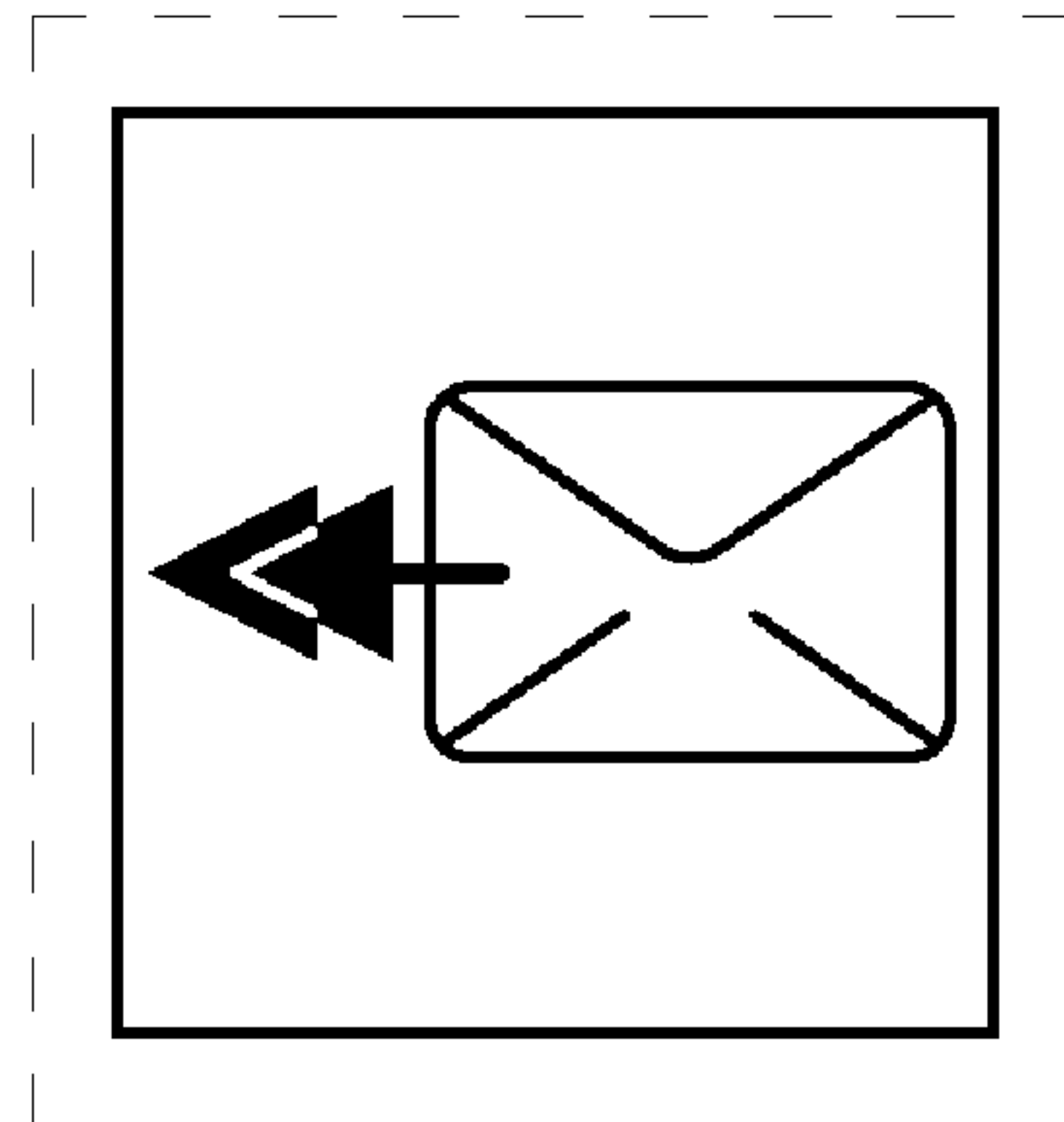

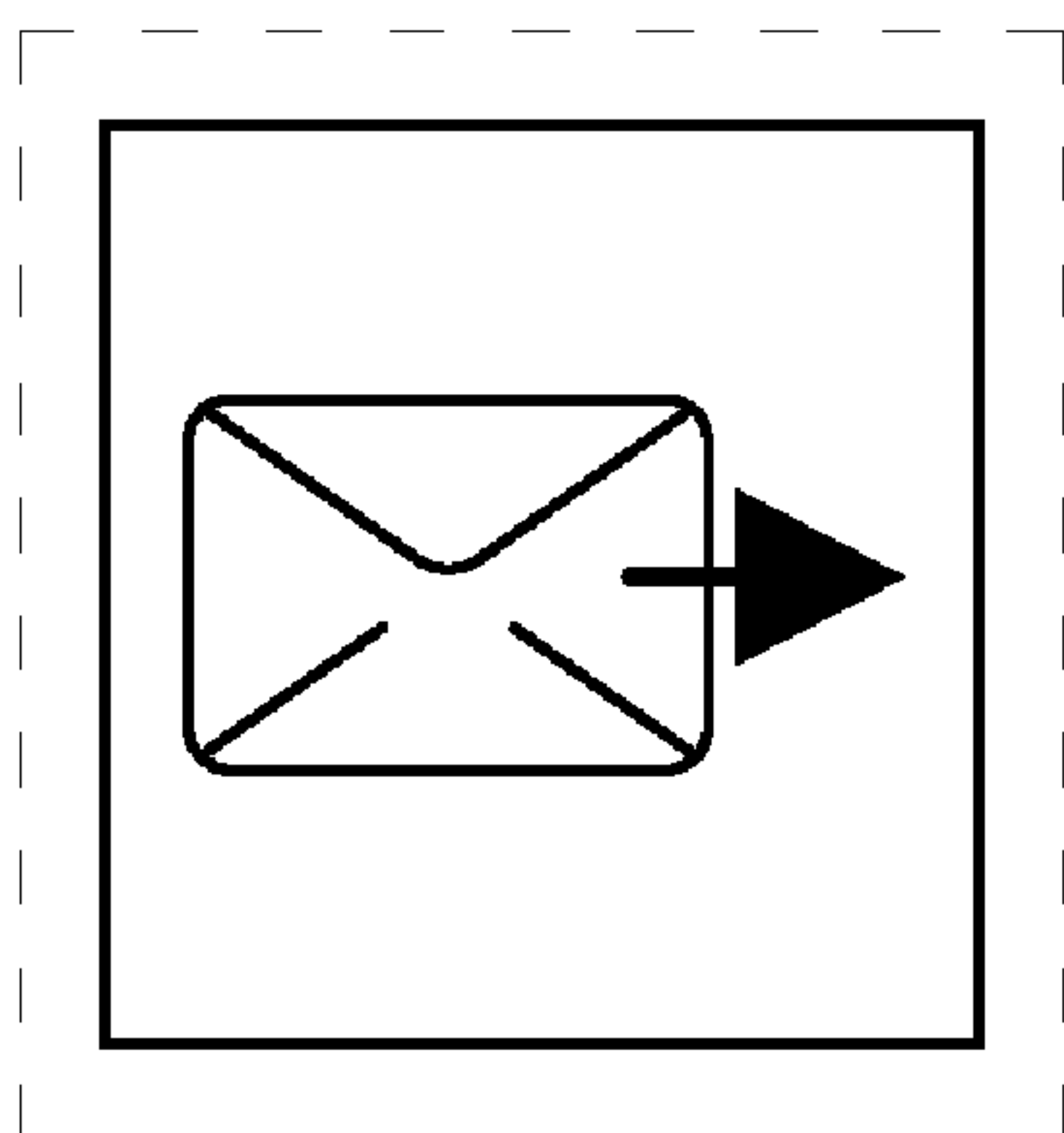
