The ornamental design for a hole cutter tip, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a hole cutter tip showing my new design;

FIG. 7 is a right side view thereof;

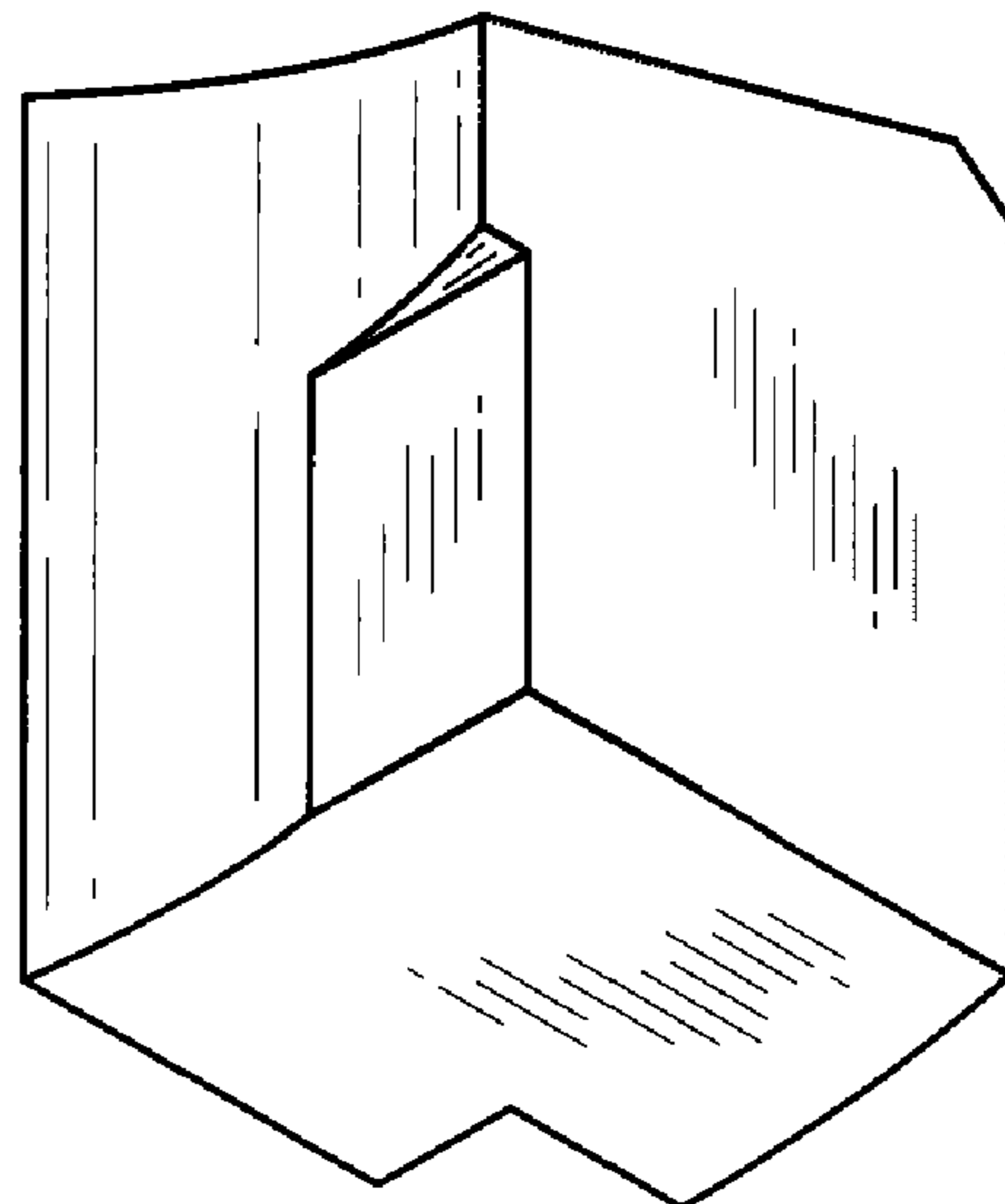
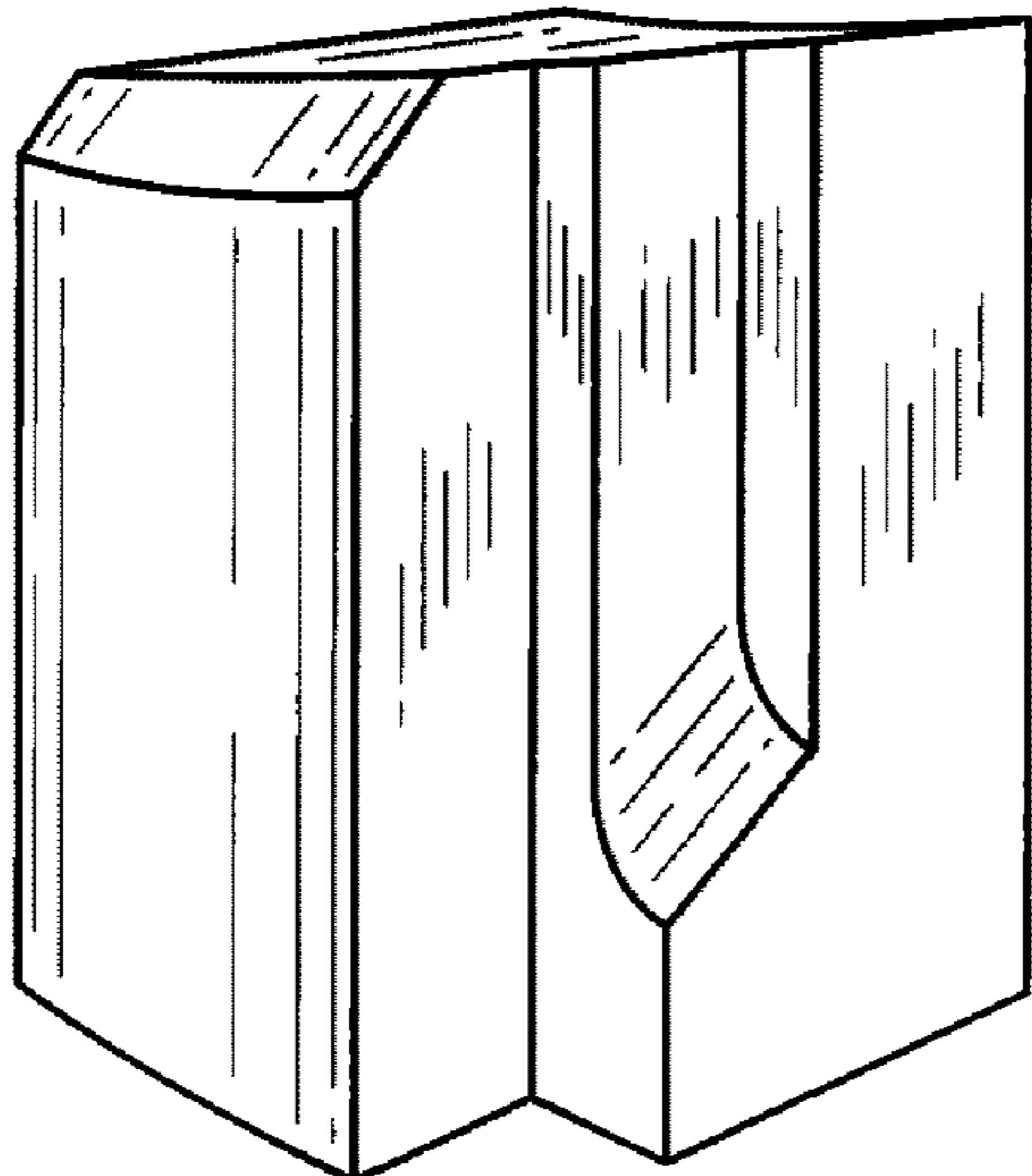
FIG. 8 is a left side view thereof;

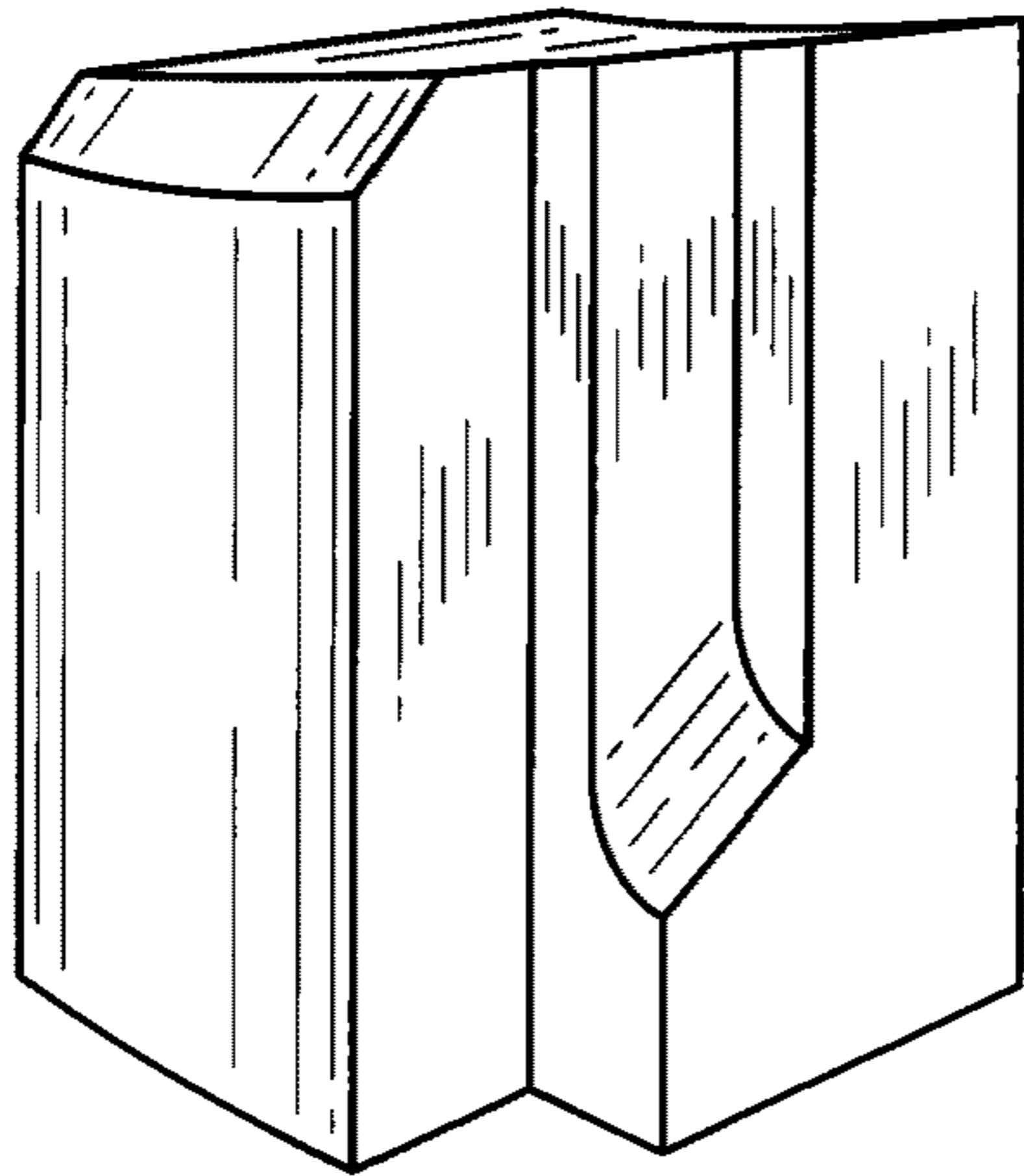

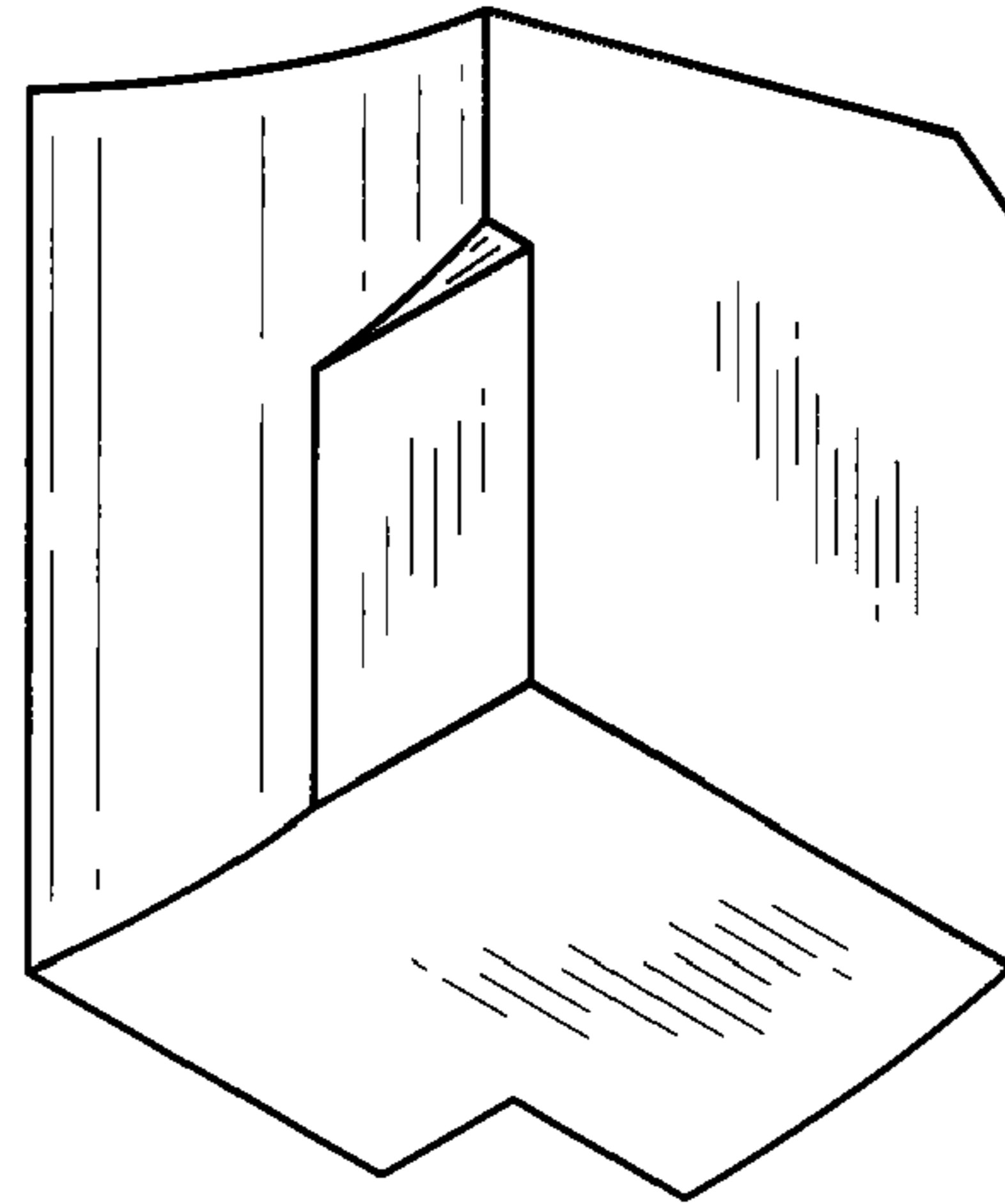

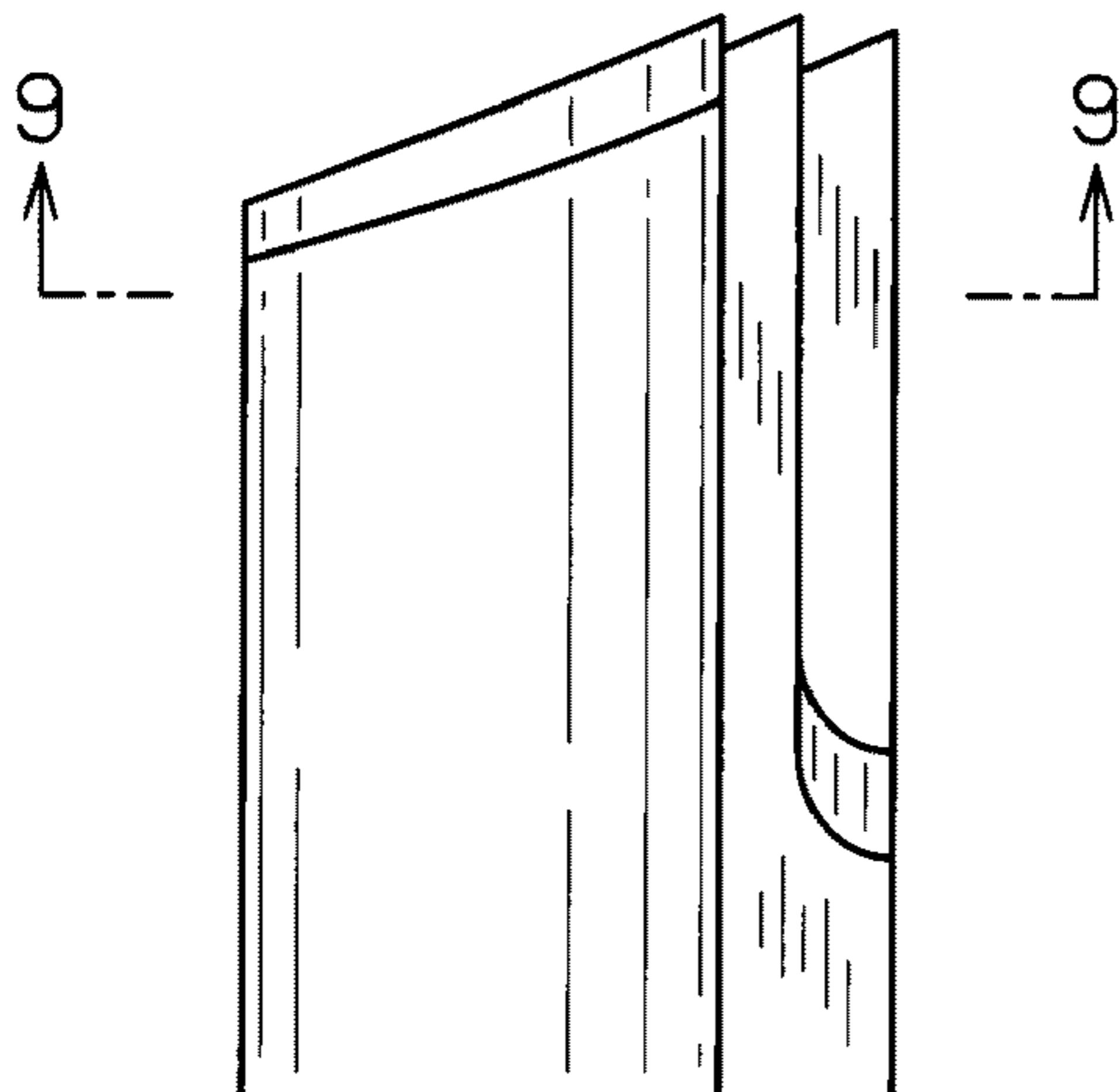

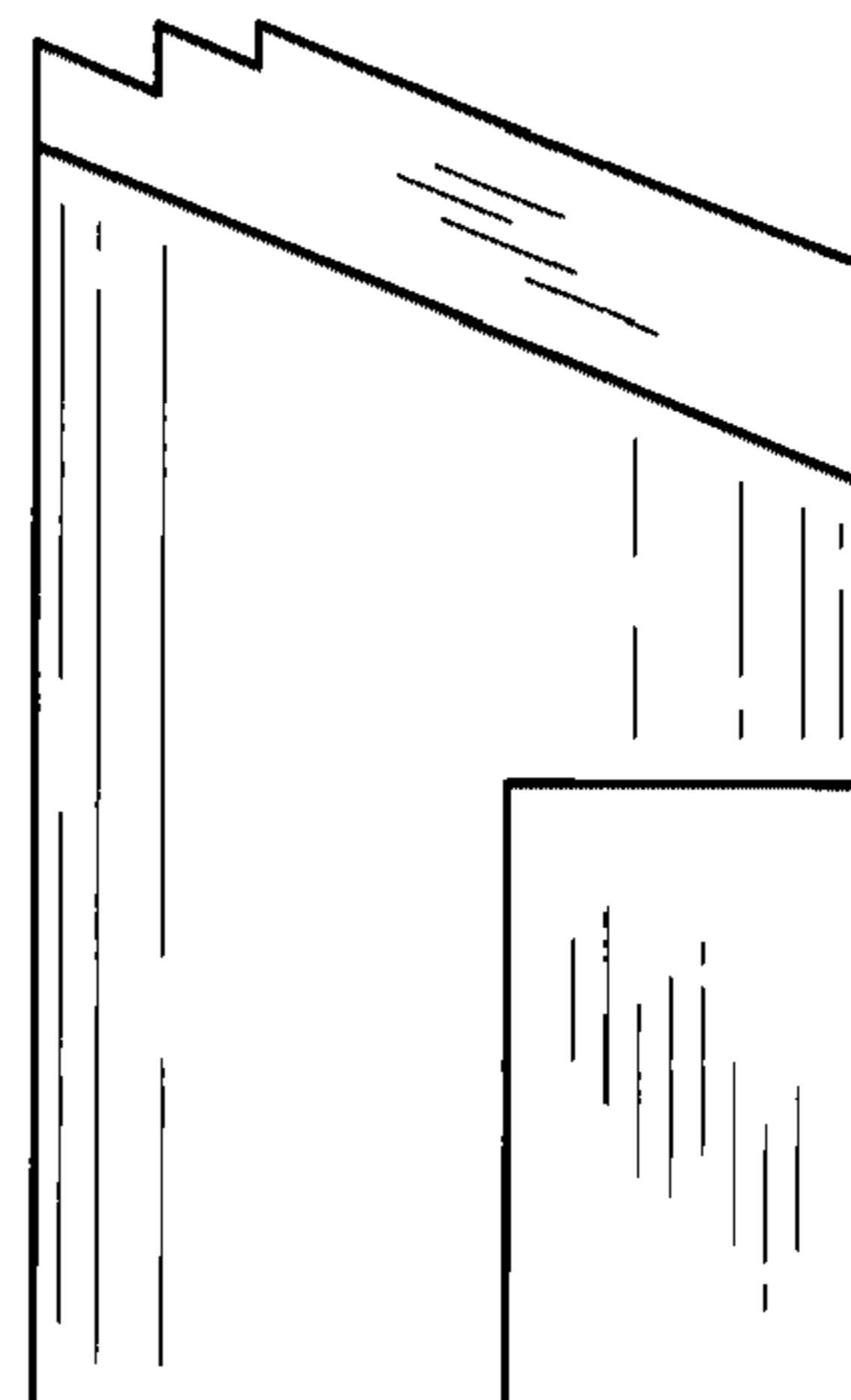

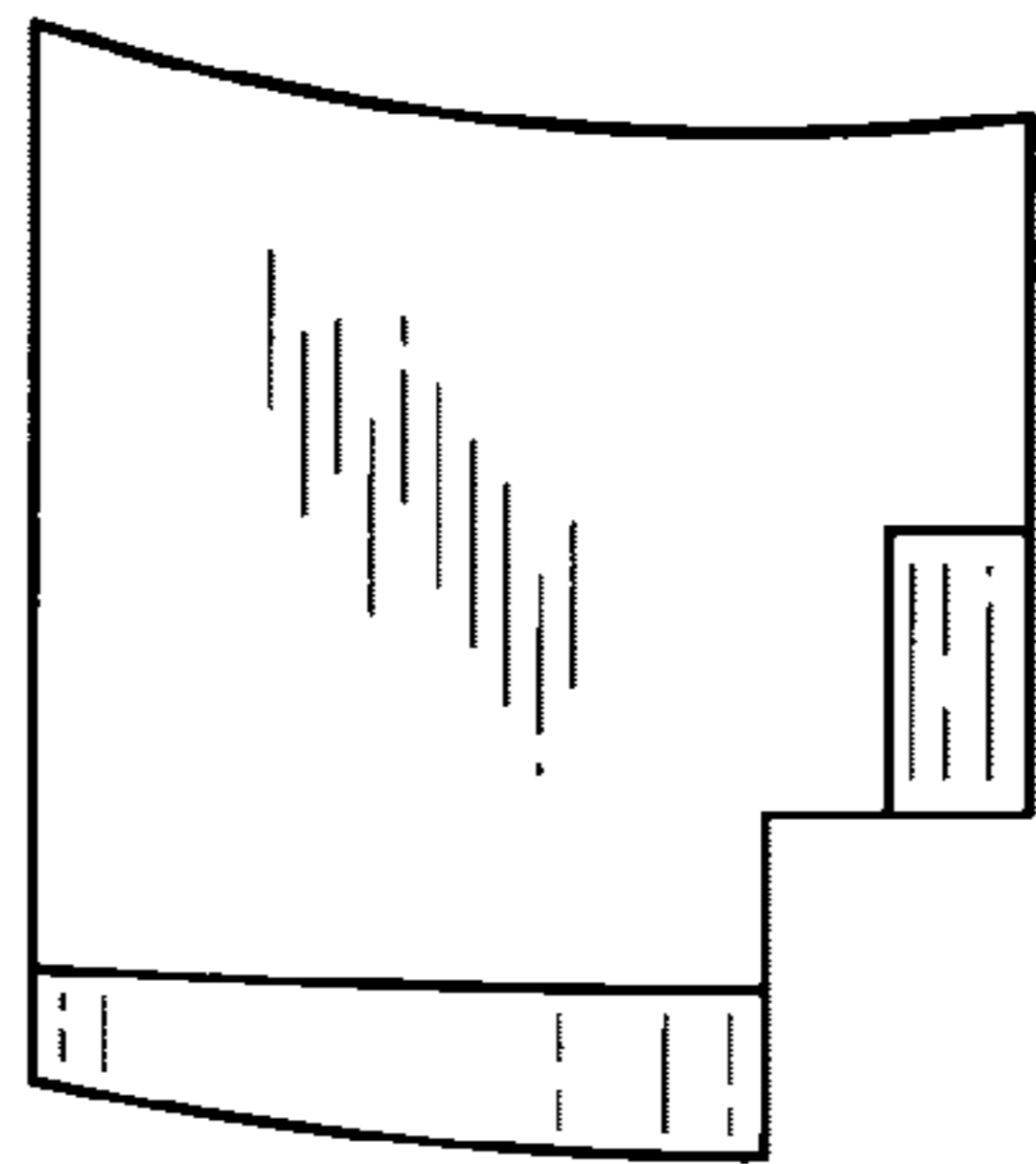

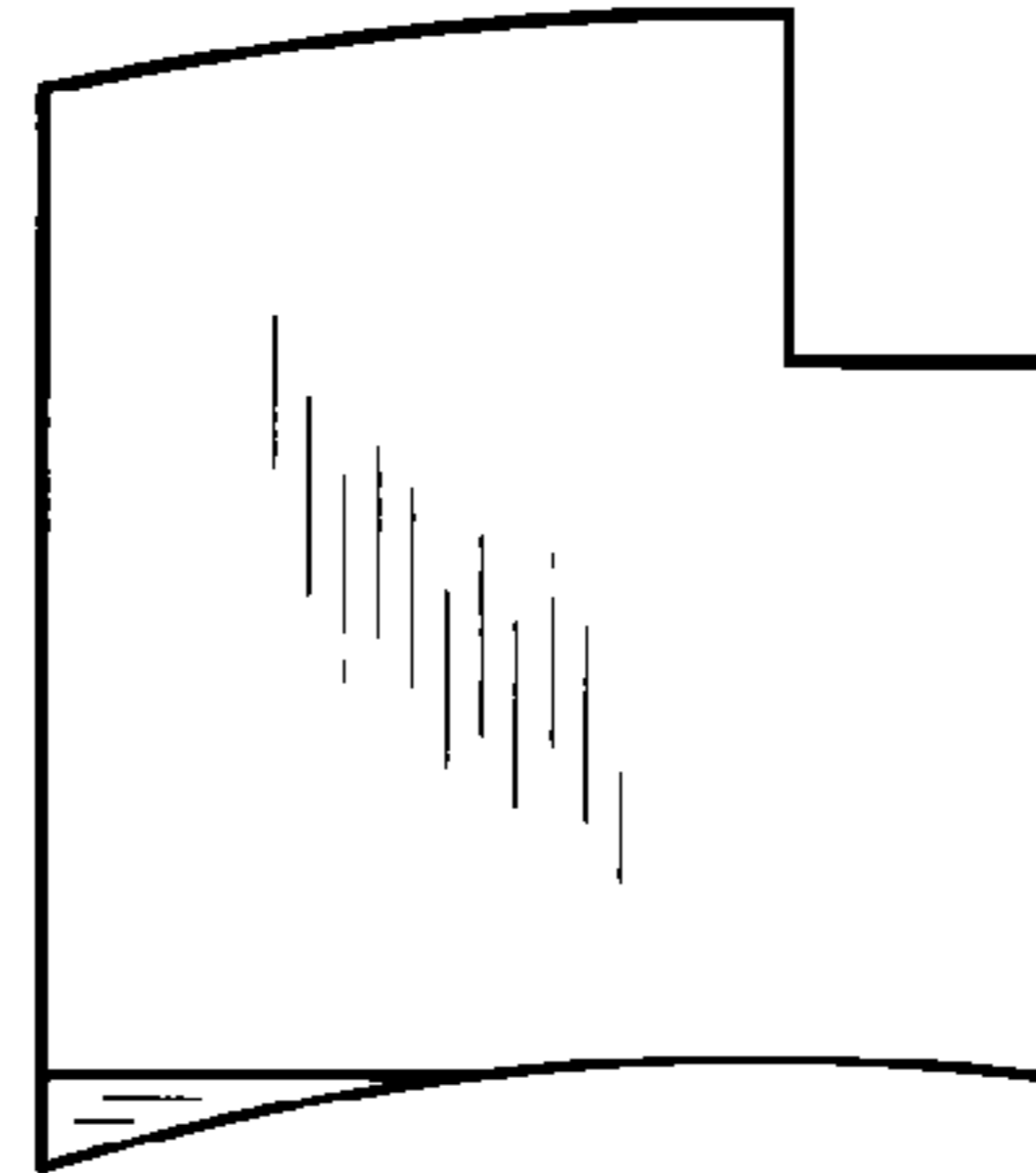

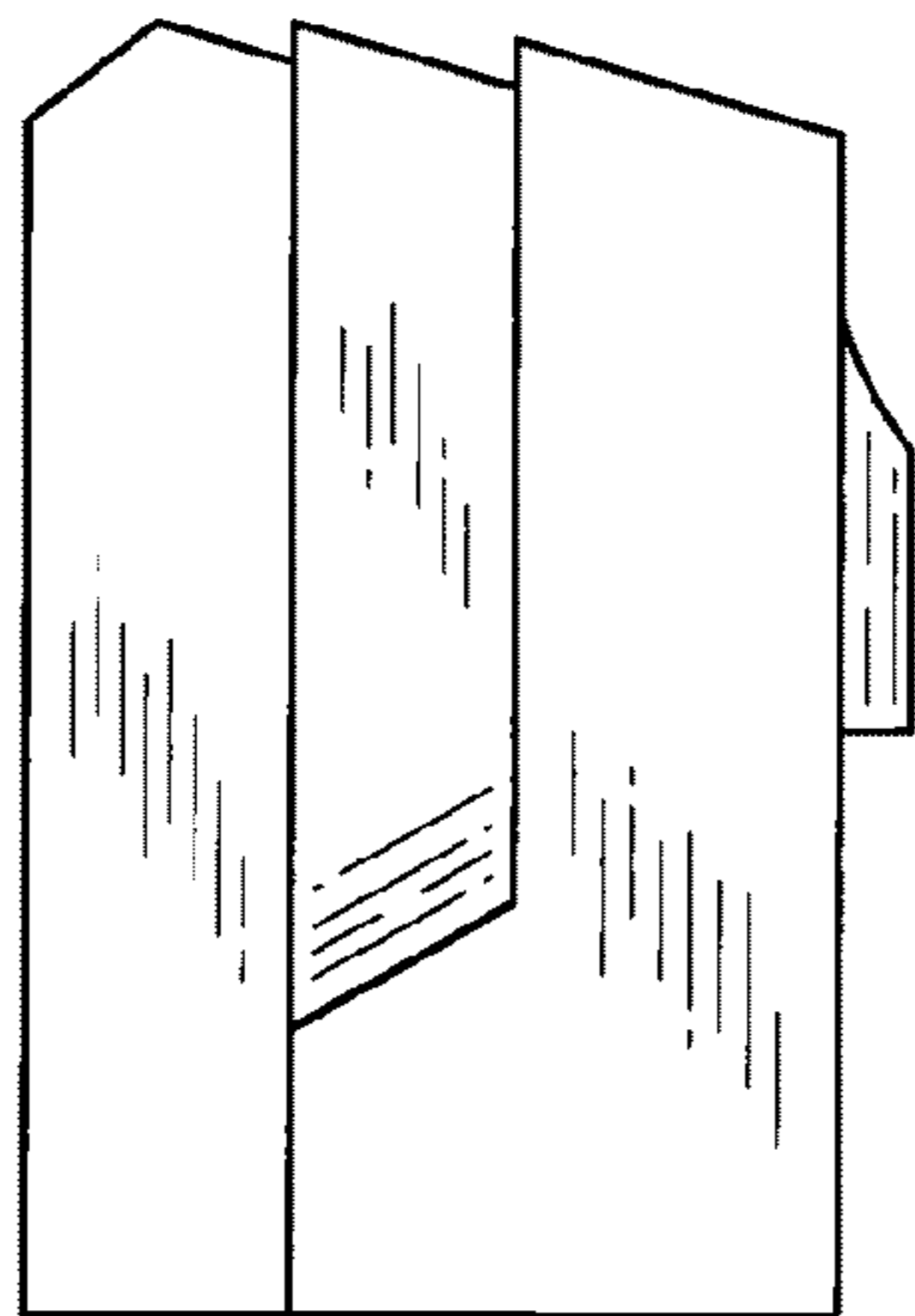

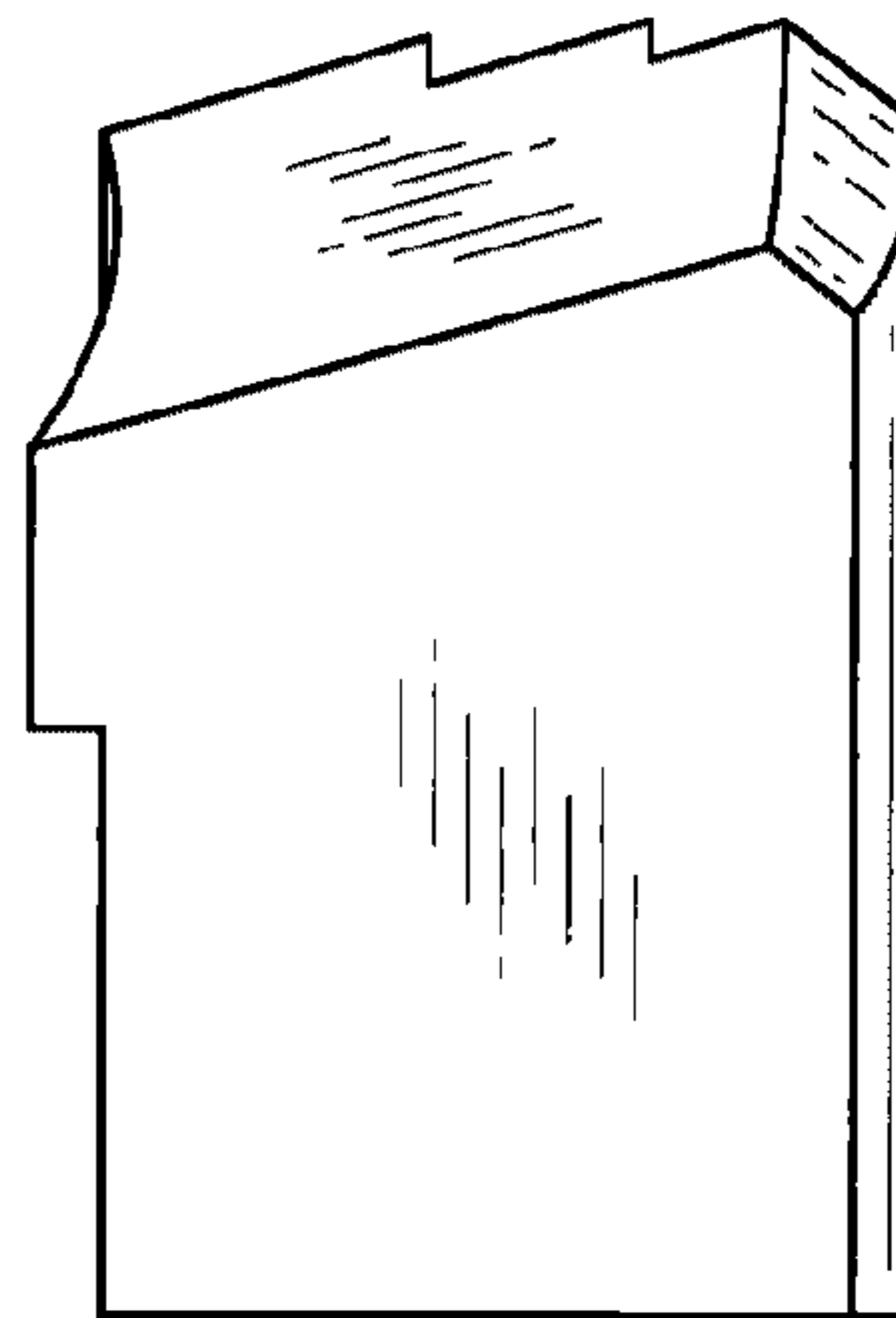

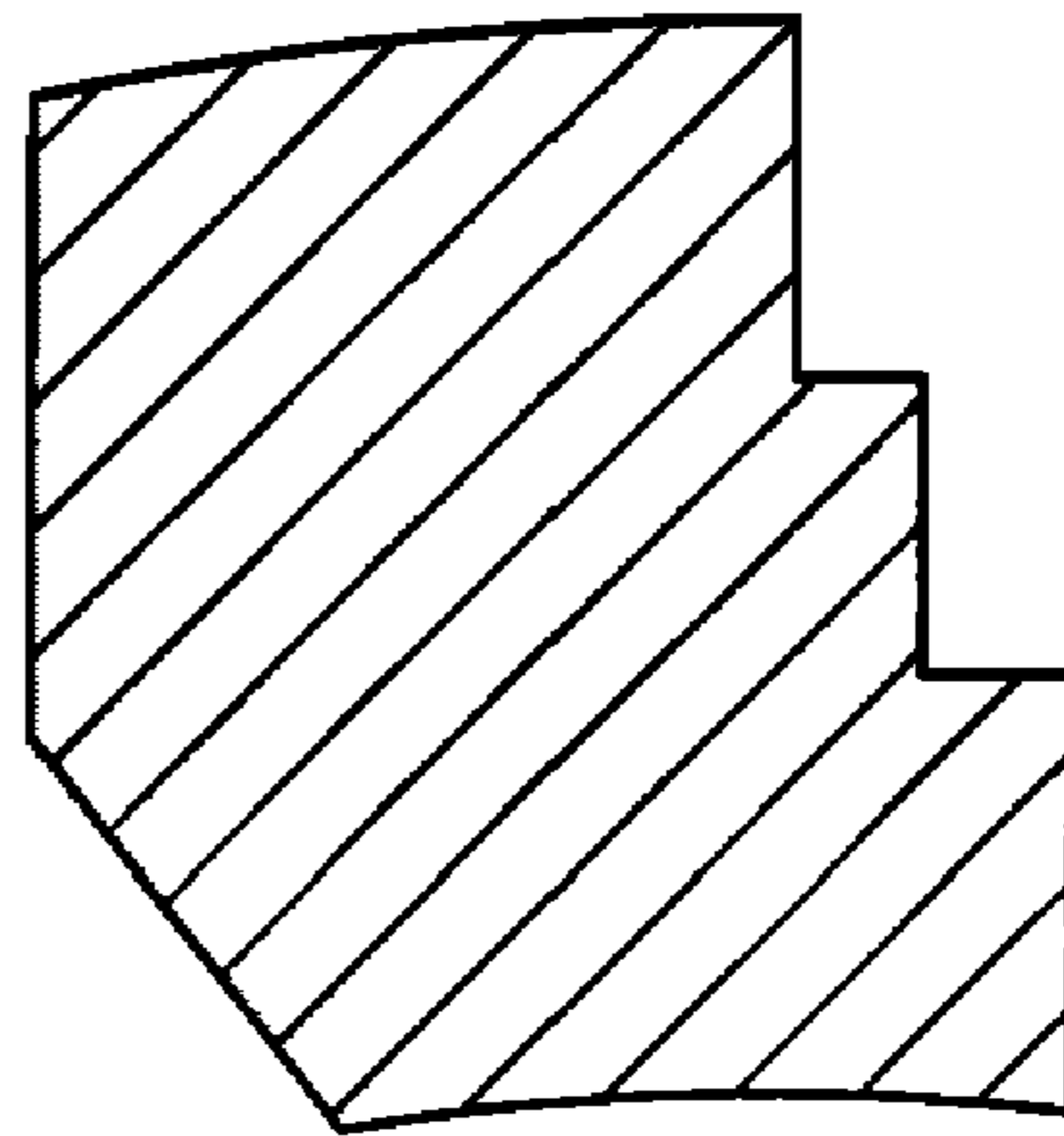
