FIG. 5 is a front view of the small game carrier of FIG. 2;

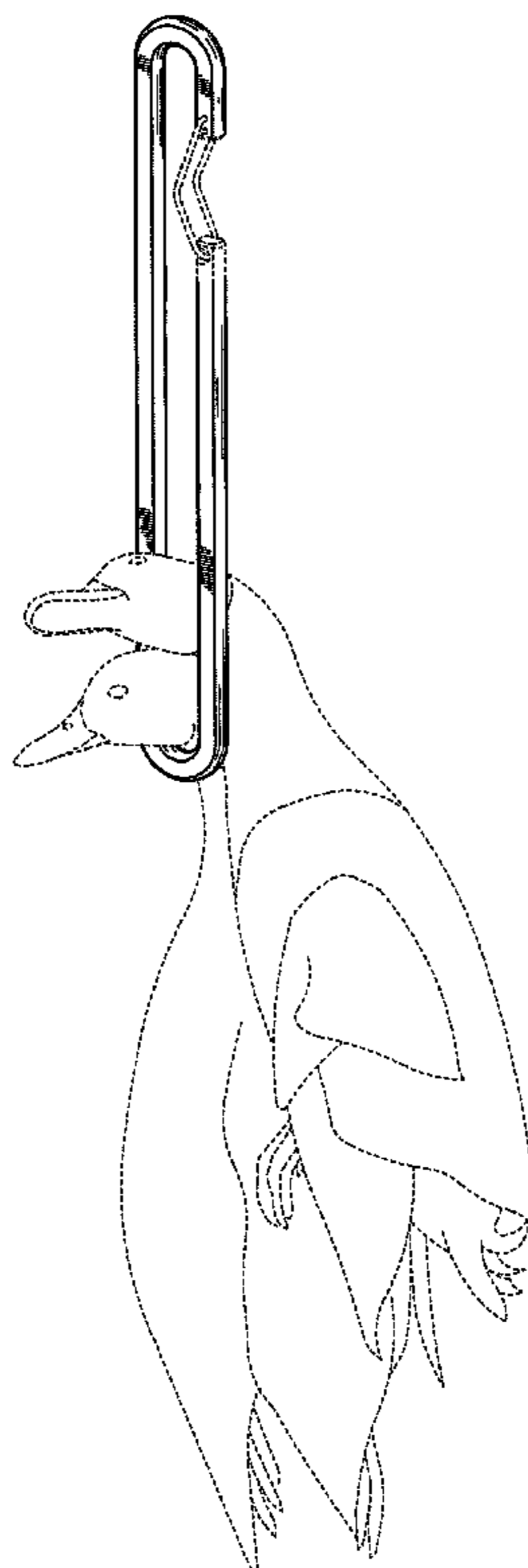
FIG. 6 is a rear view of the small game carrier of FIG. 2;

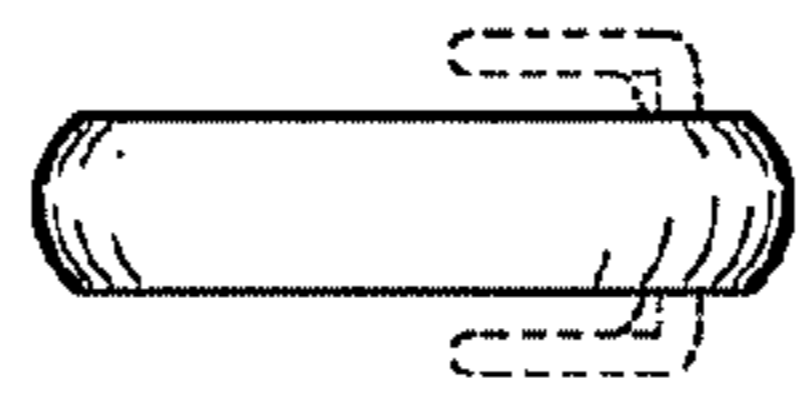
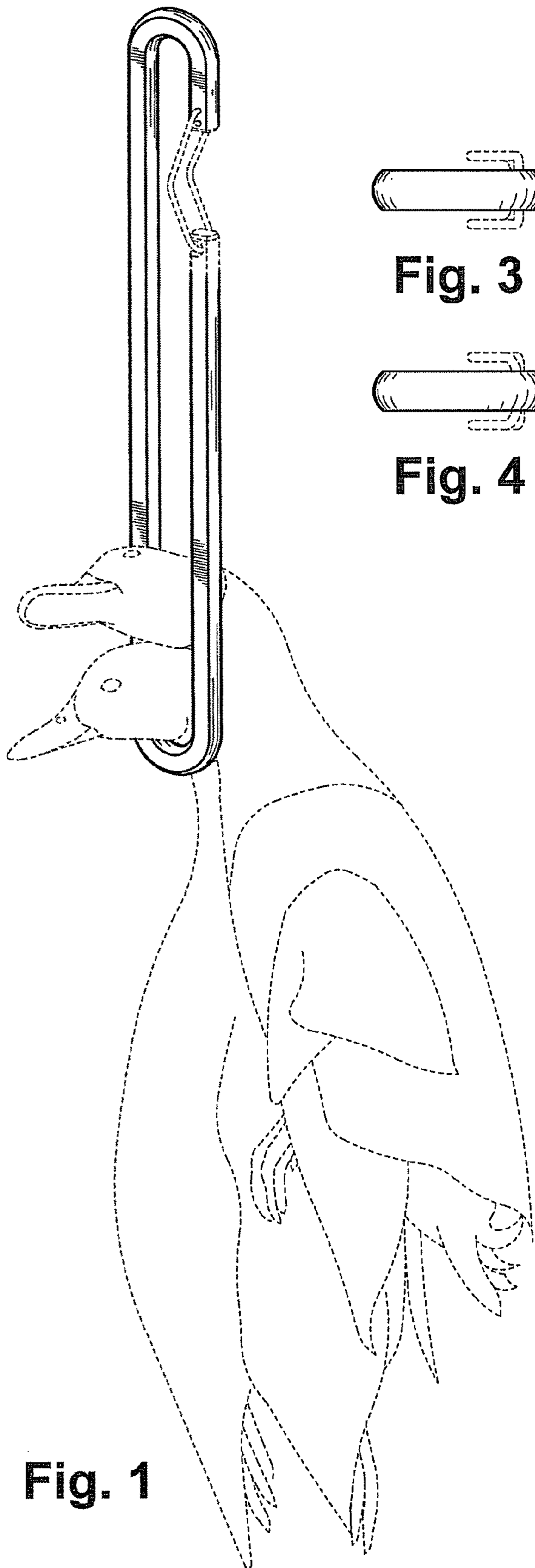
FIG. 7 is a left side view of the small game carrier of FIG. 2; and,

FIG. 8 is a right side view of the small game carrier of FIG. 2.

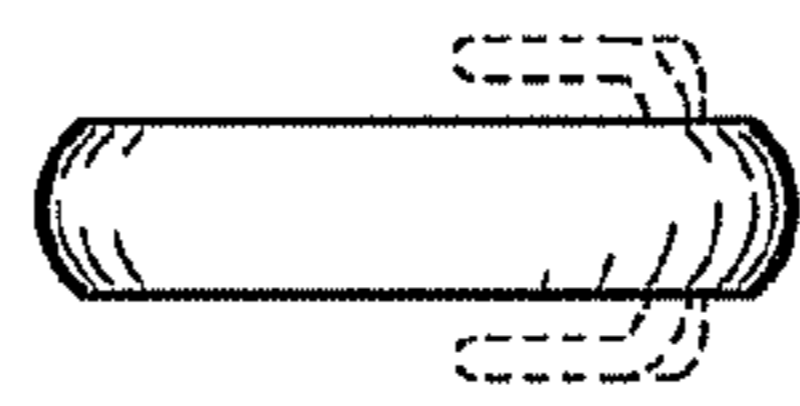

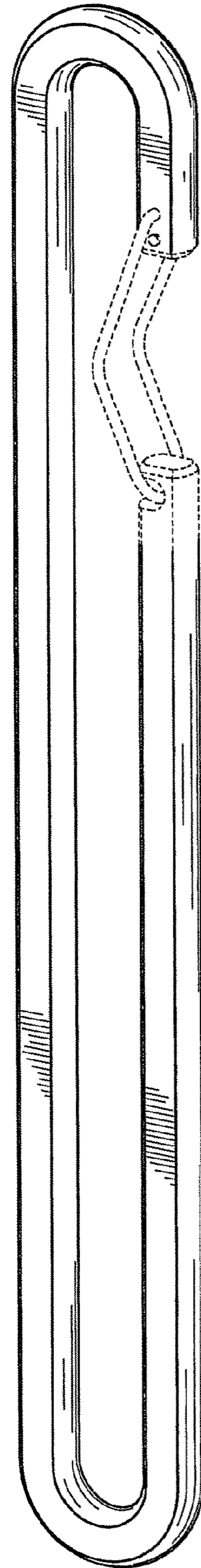




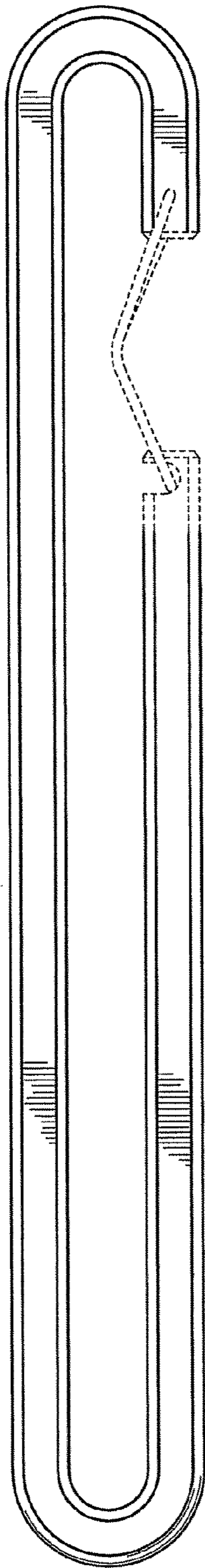

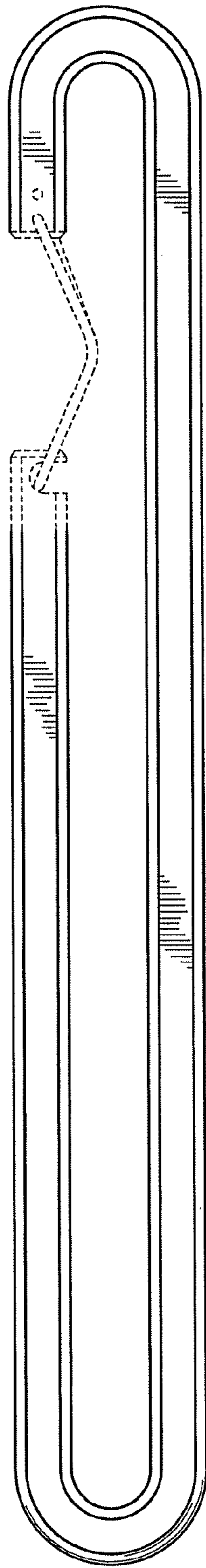

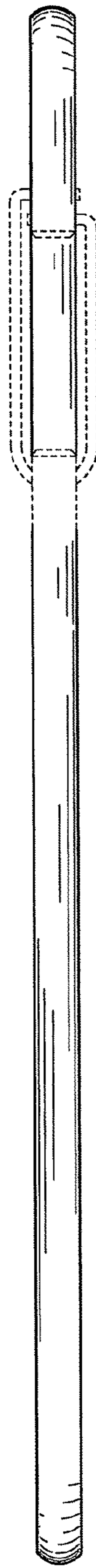

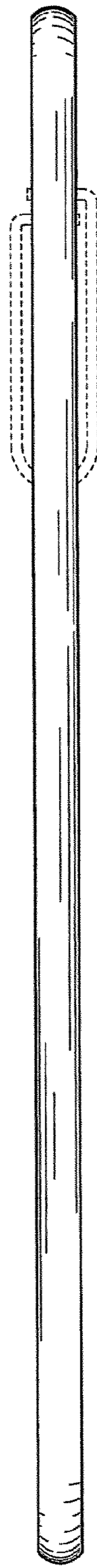
