(57) **CLAIM**

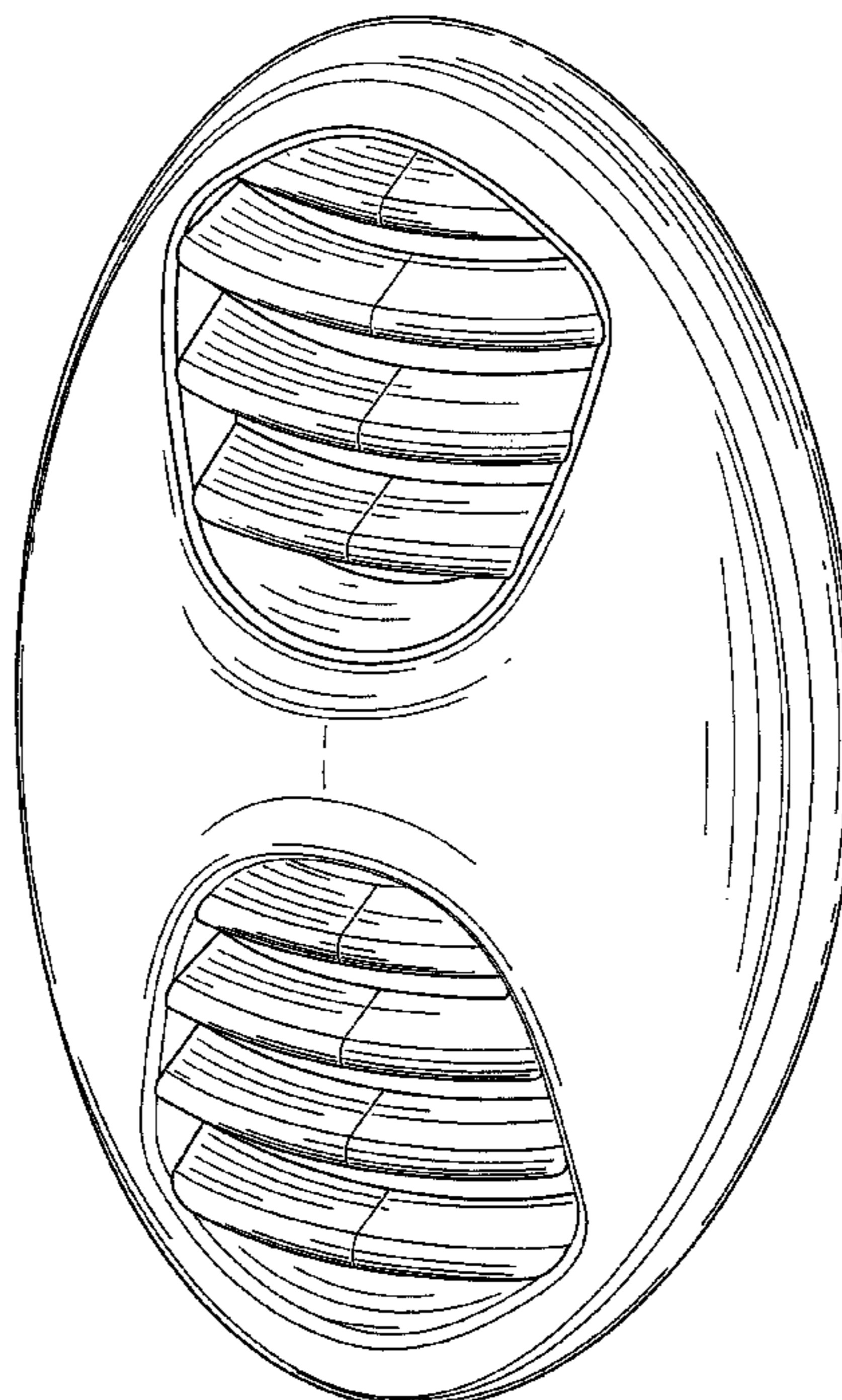
The ornamental design for a feature of an air treatment device, as shown and described.

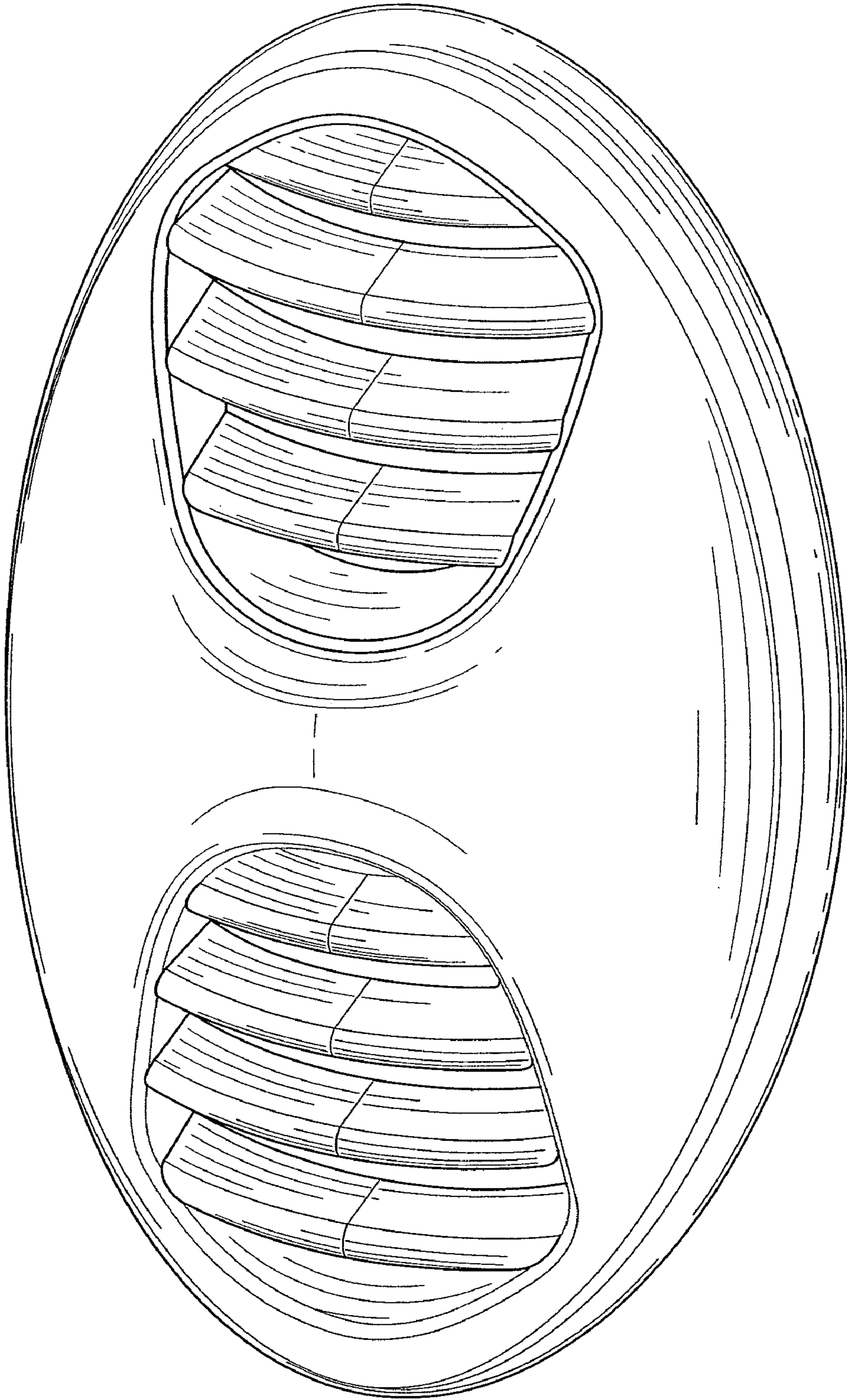
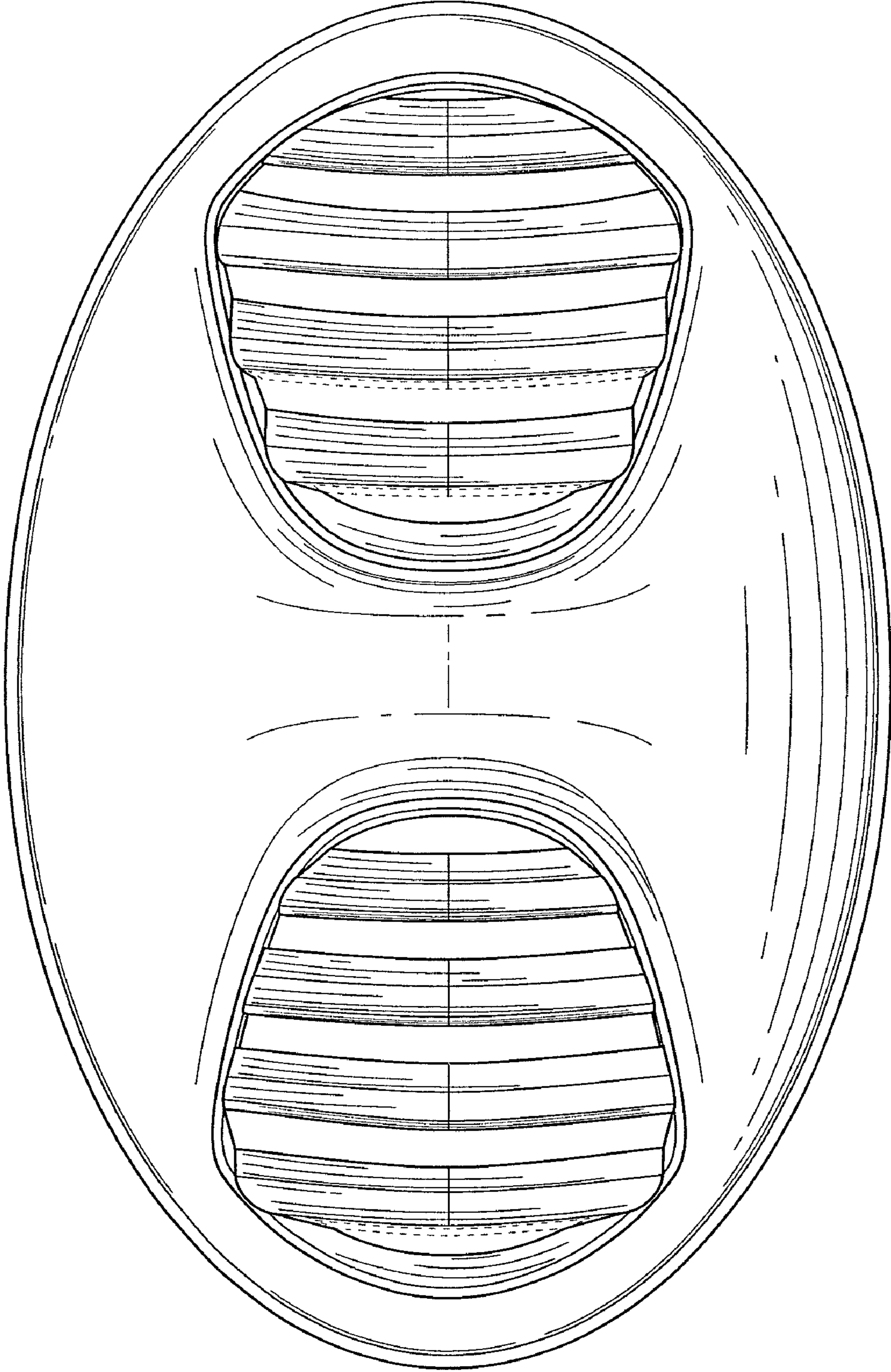
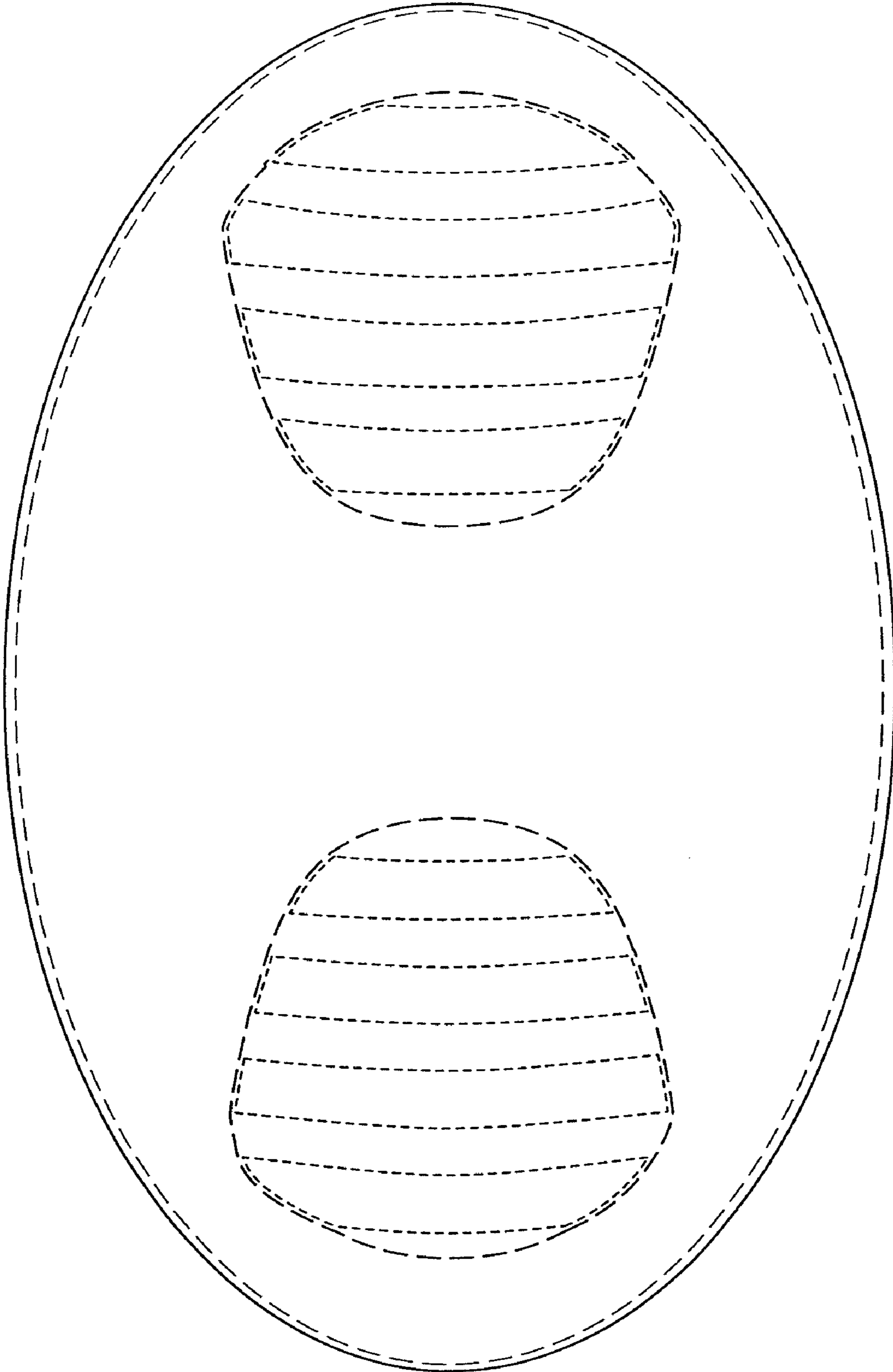


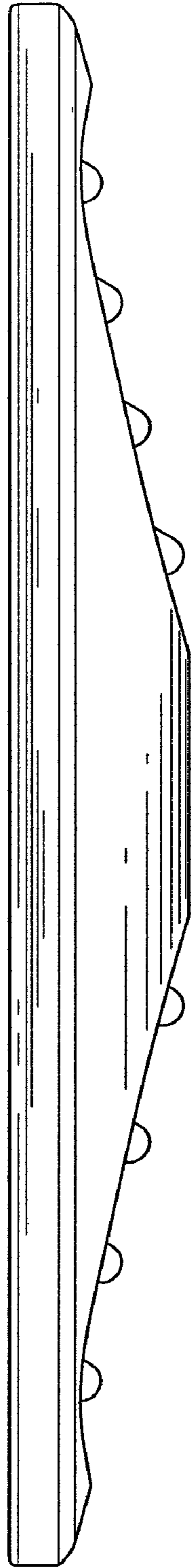

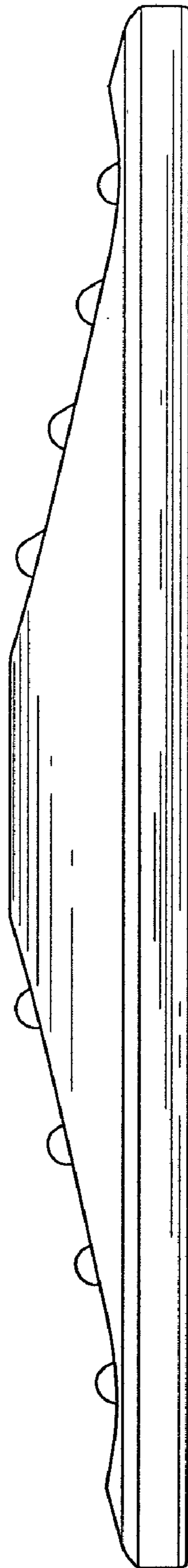

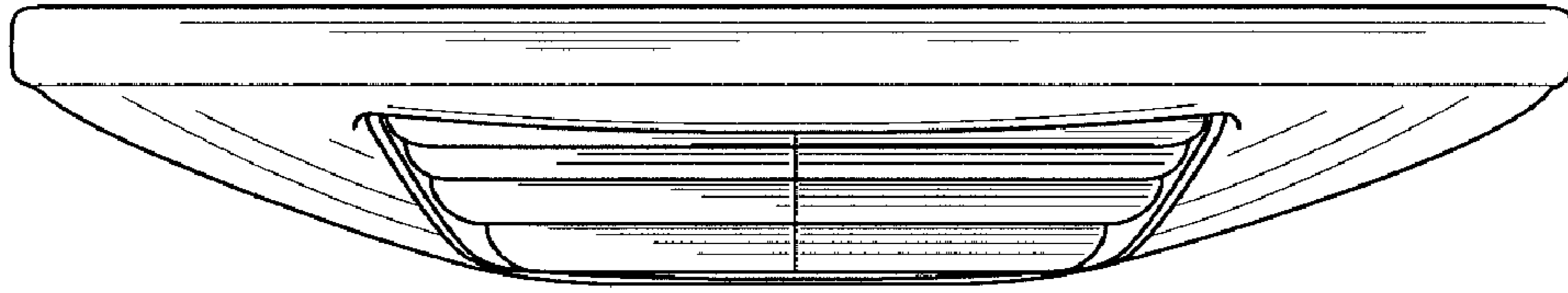

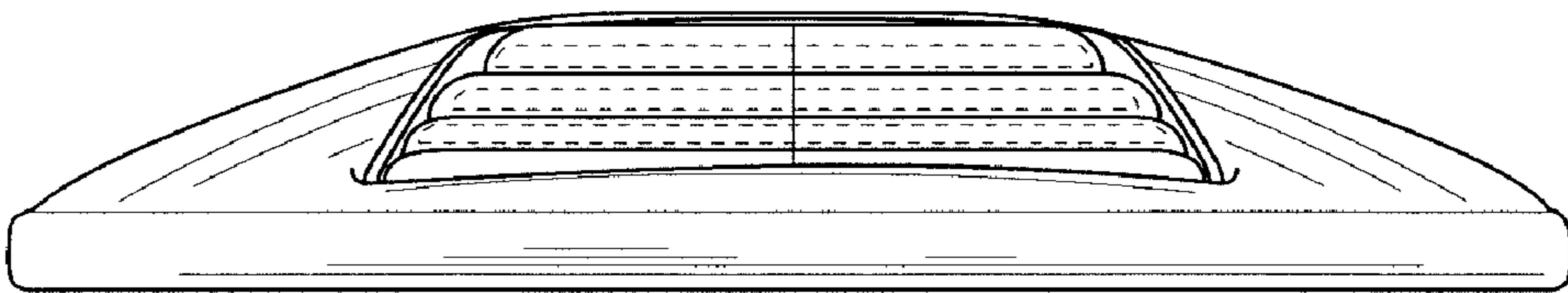
