DESCRIPTION

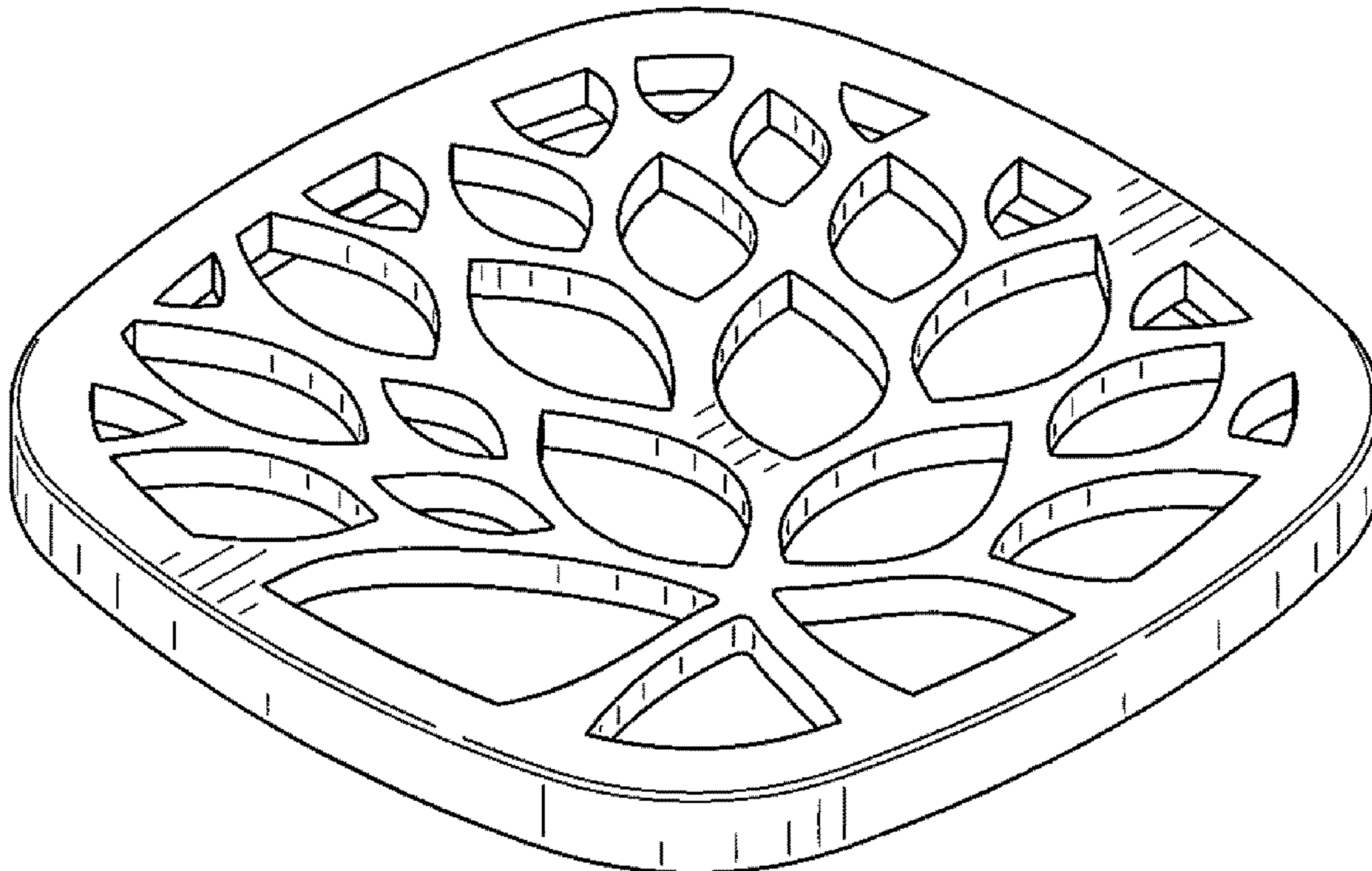
FIG. 1 is a top isometric view of a first embodiment of a lid of the present invention;

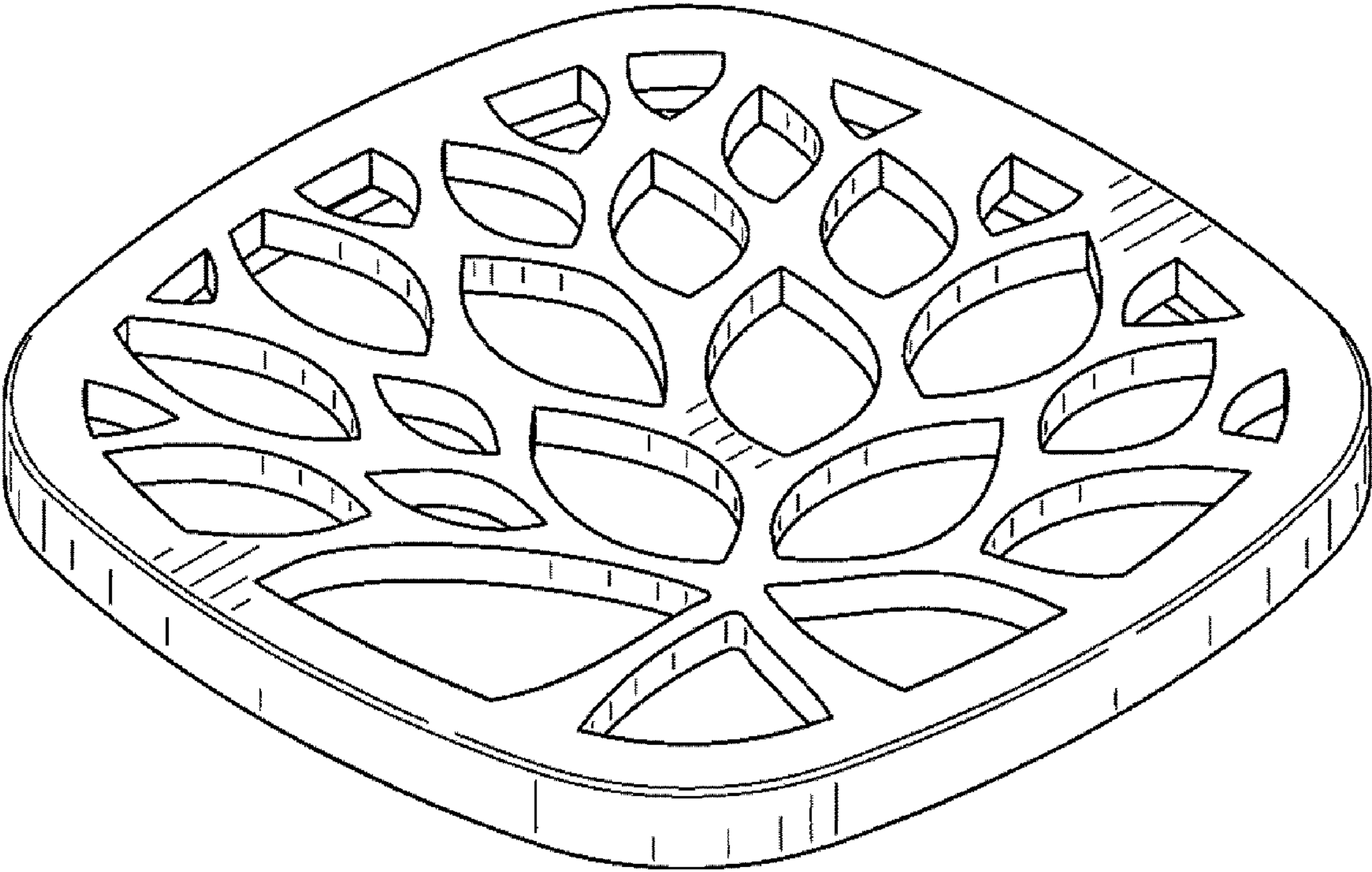

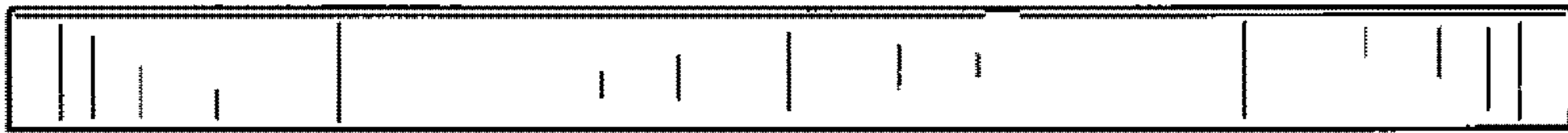

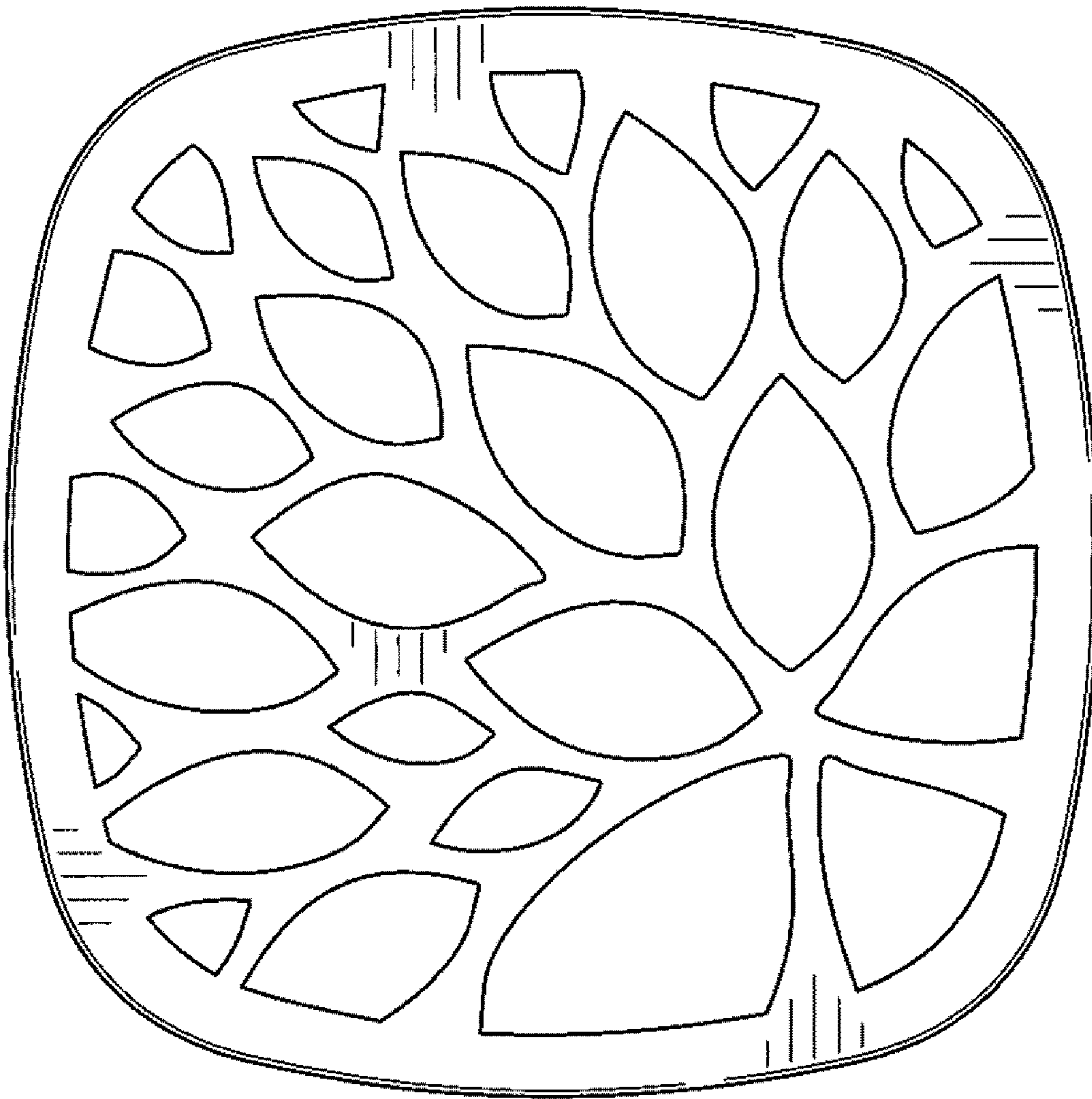
