**DESCRIPTION**

FIG. 5 is a rear elevation view thereof;

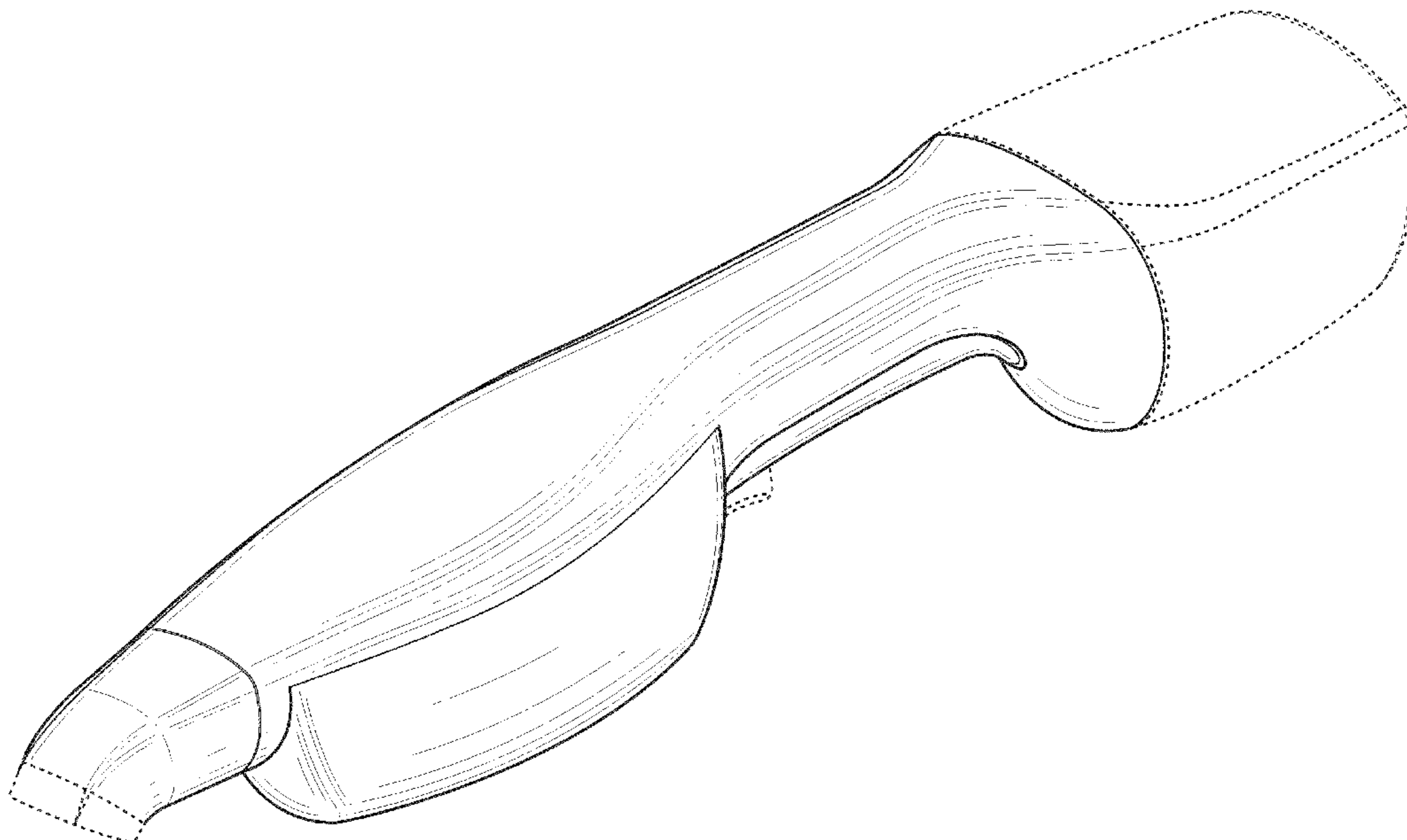
FIG. 6 is a front elevation view thereof;

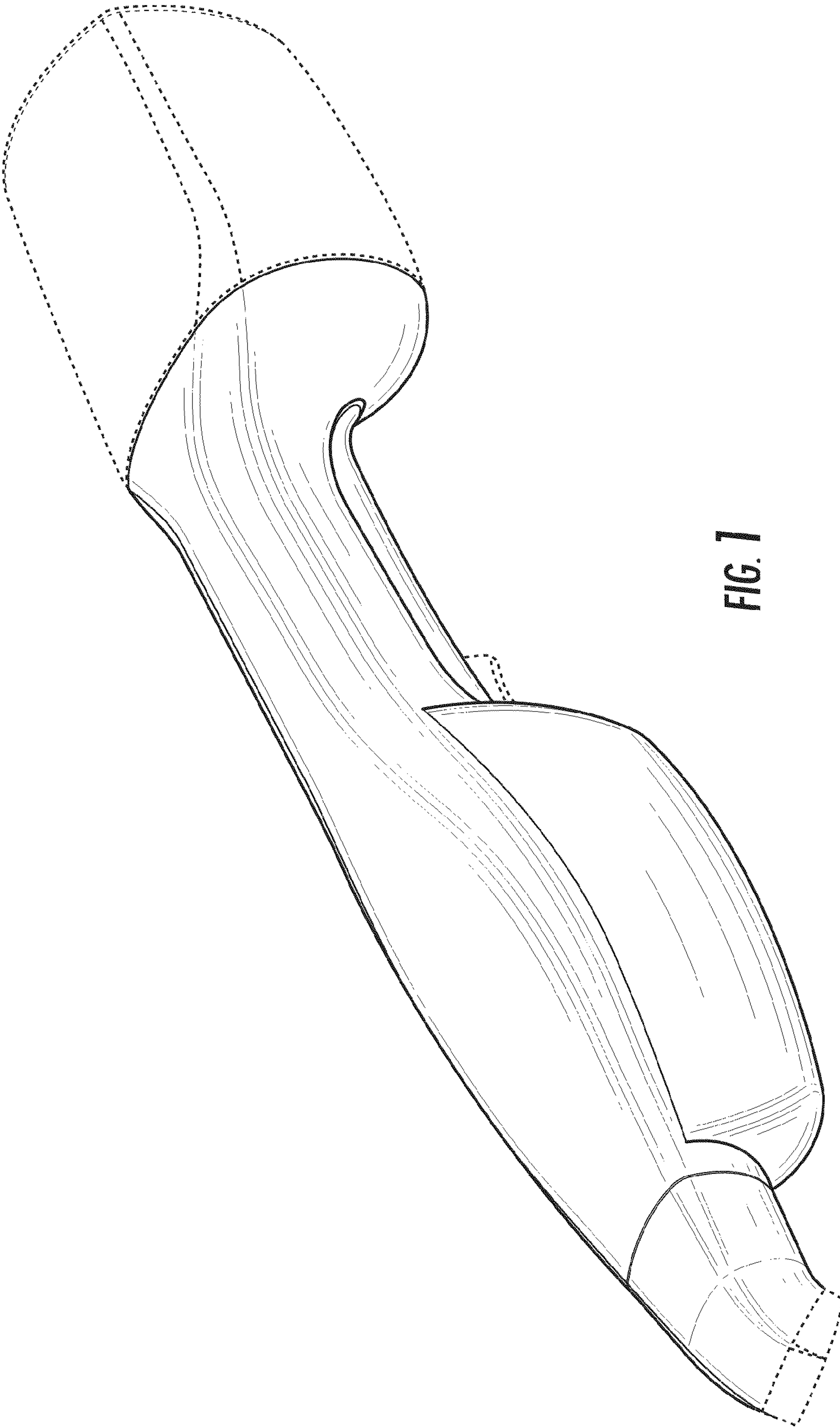

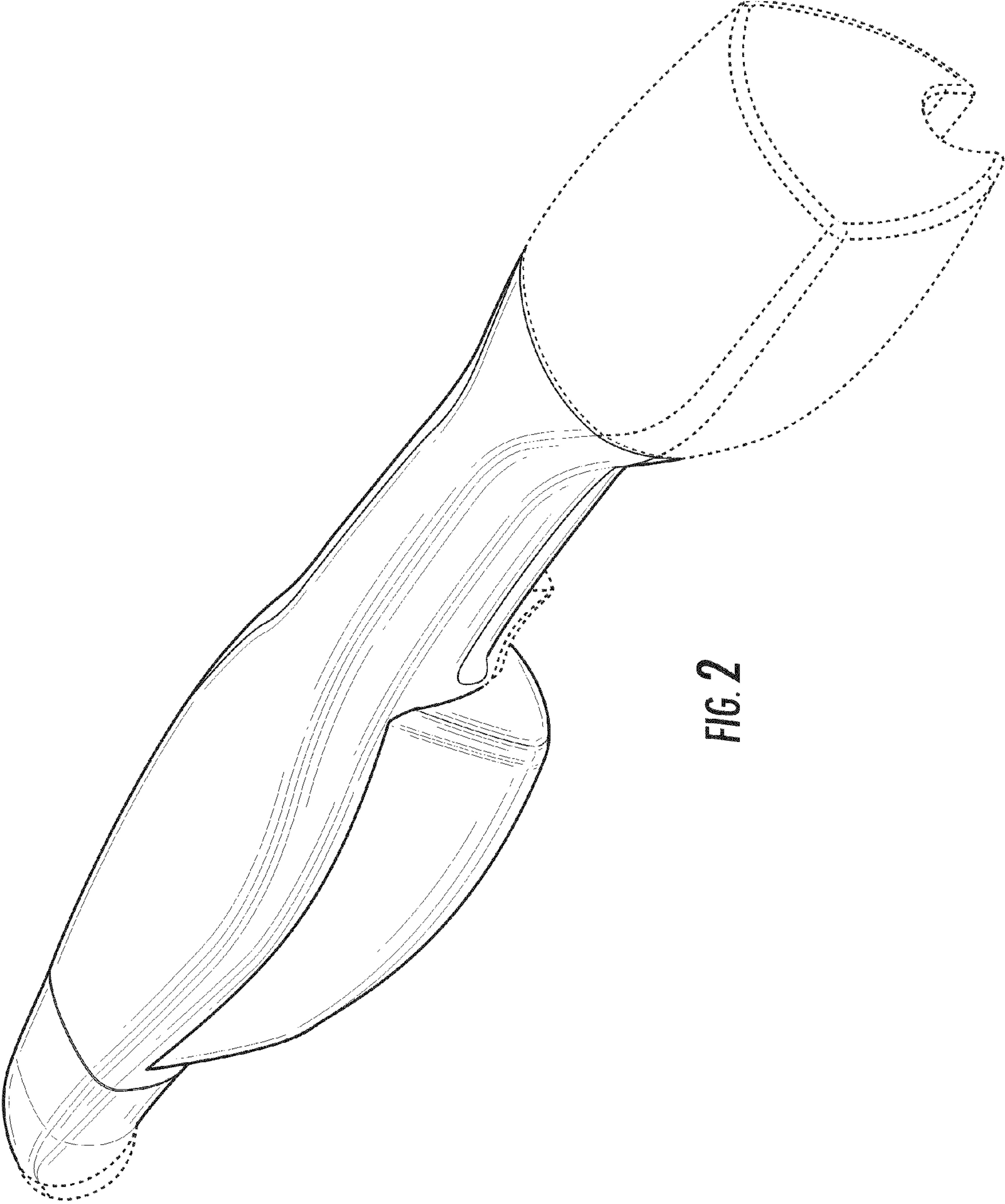

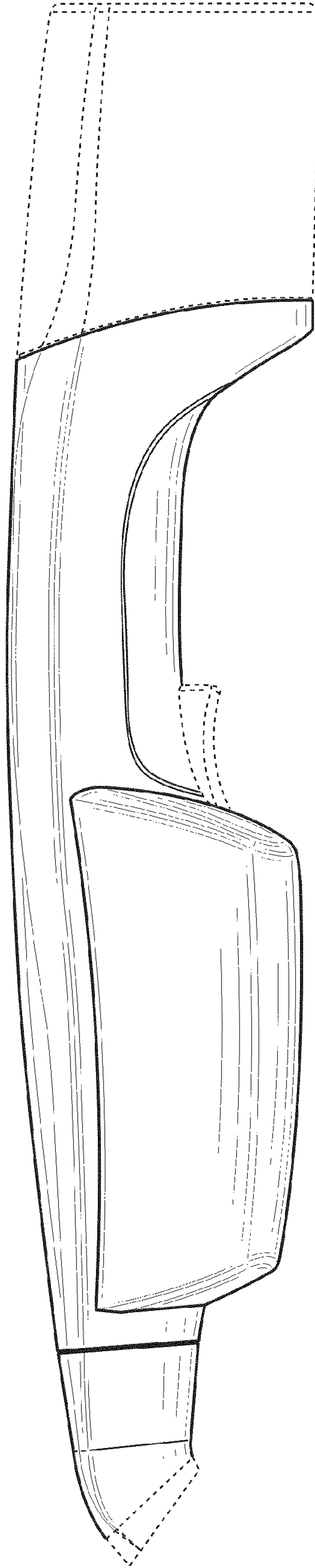

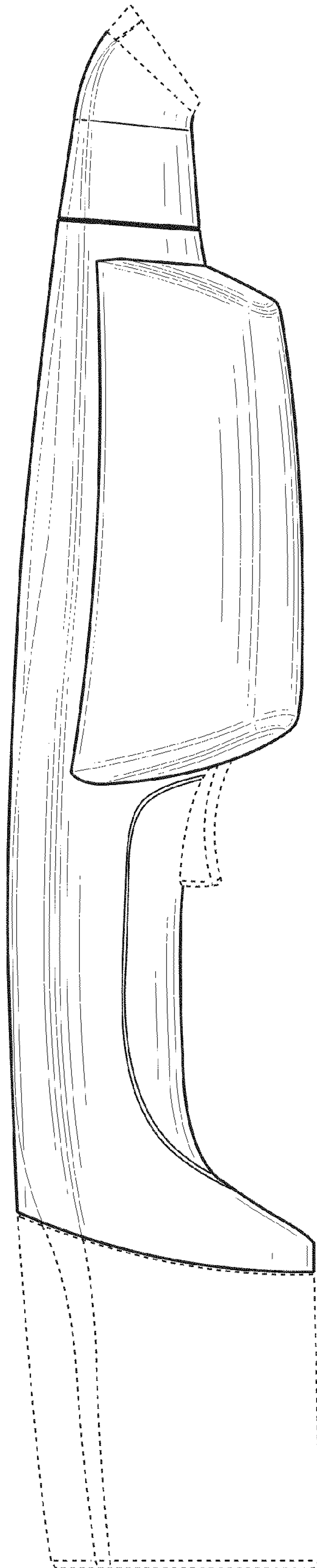

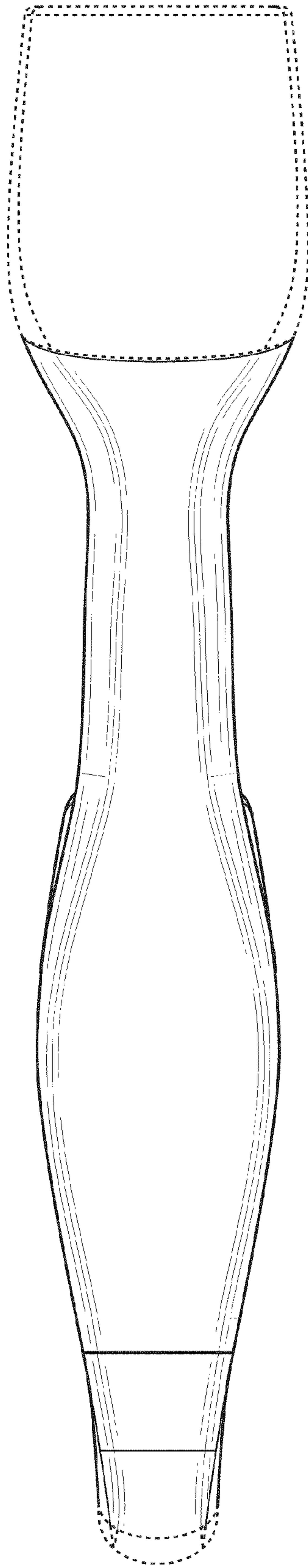

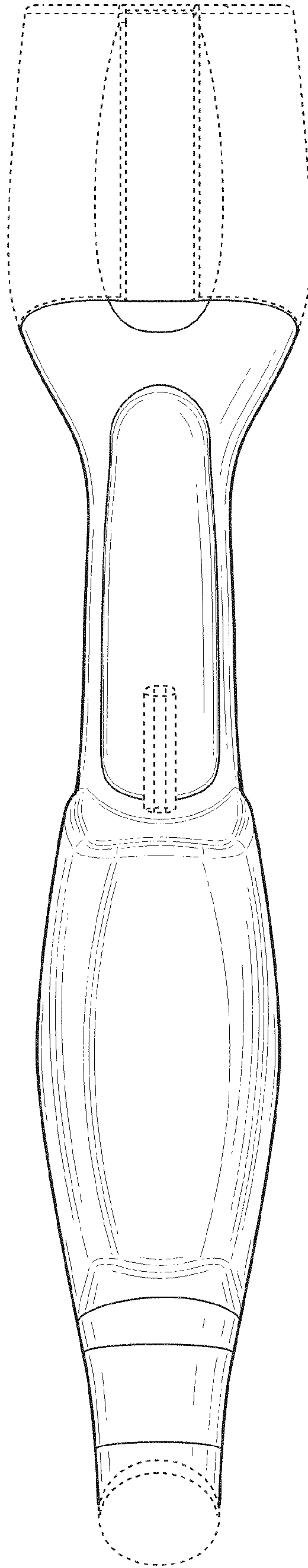

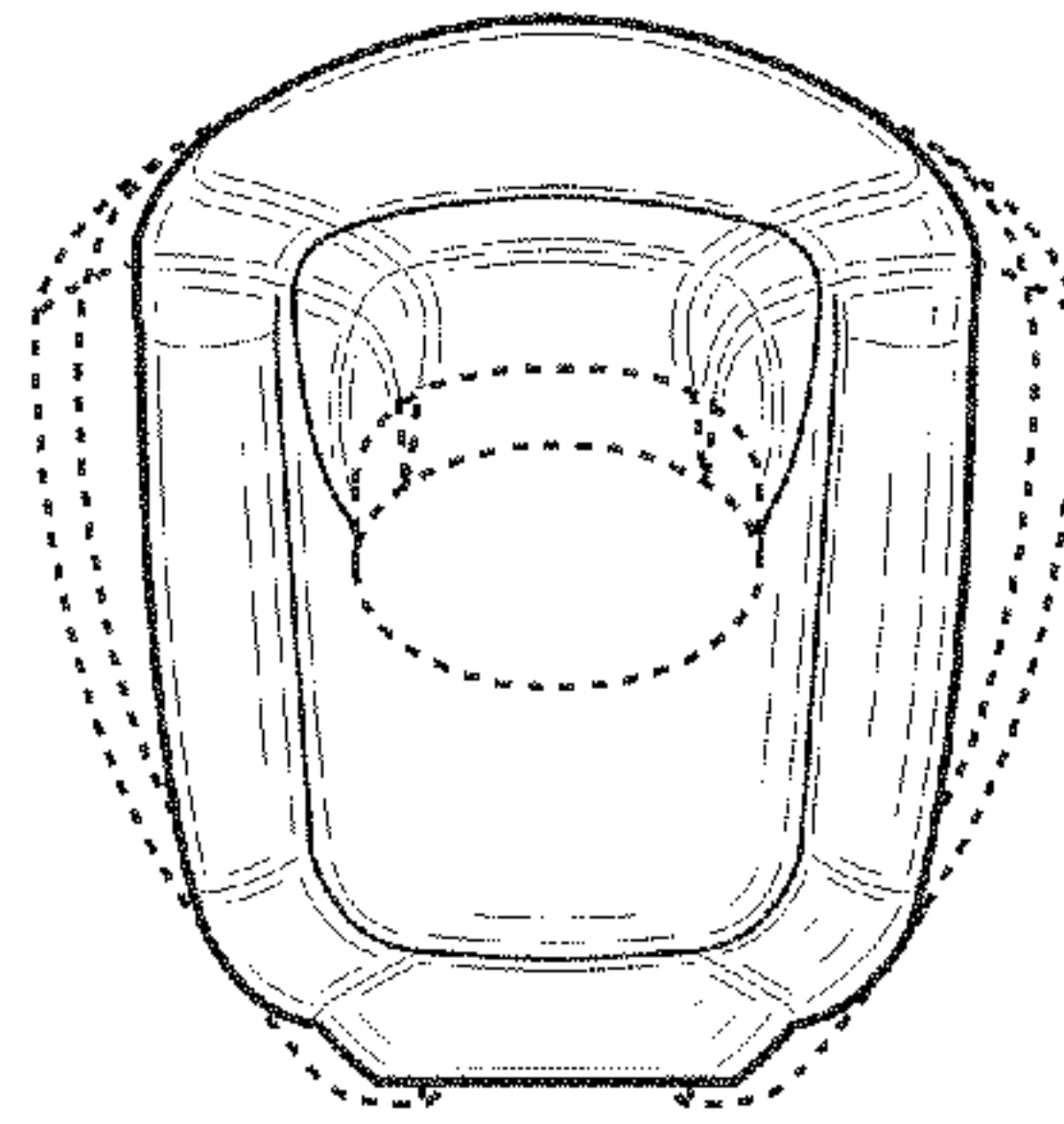
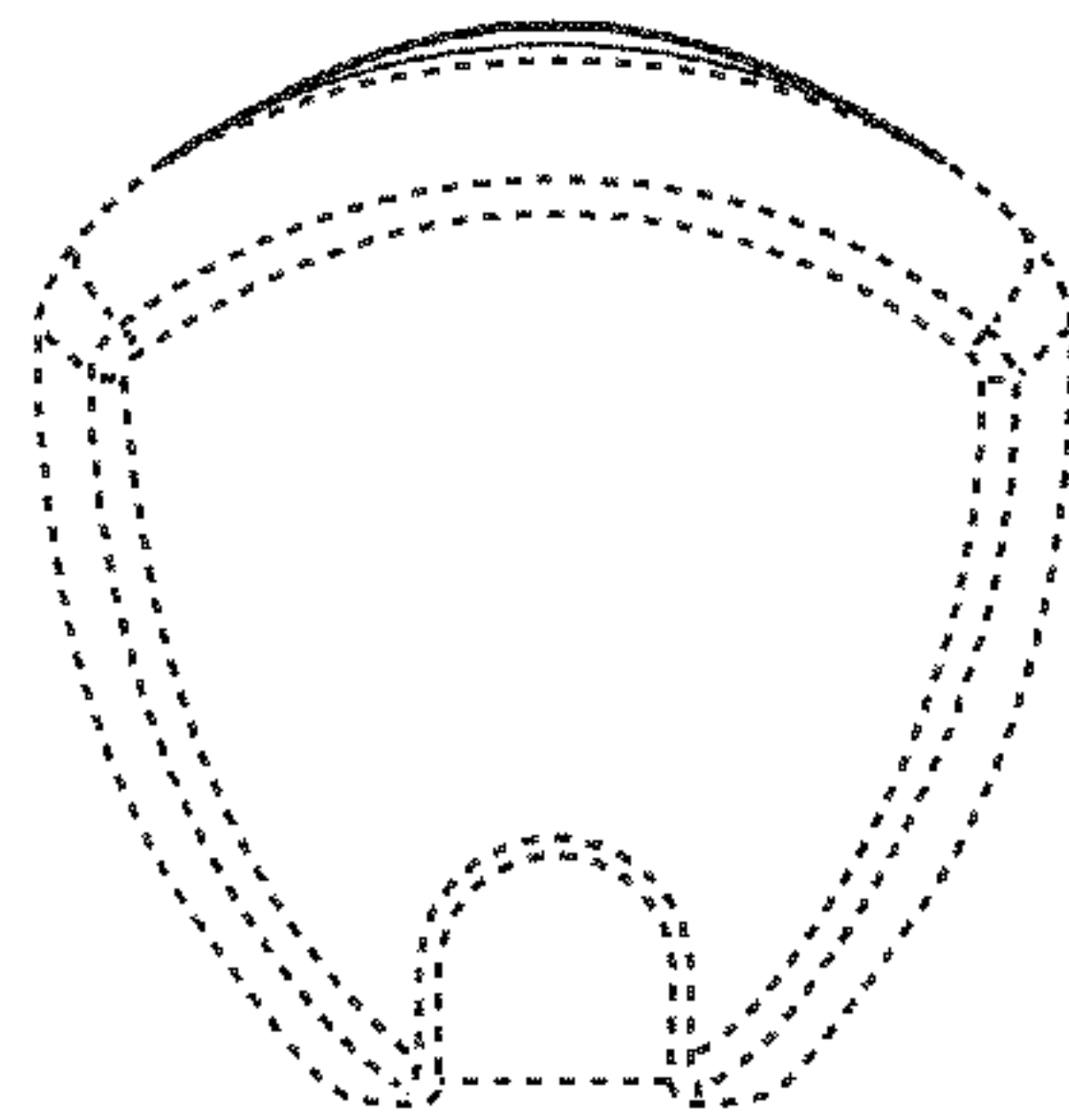
