(57) **CLAIM**

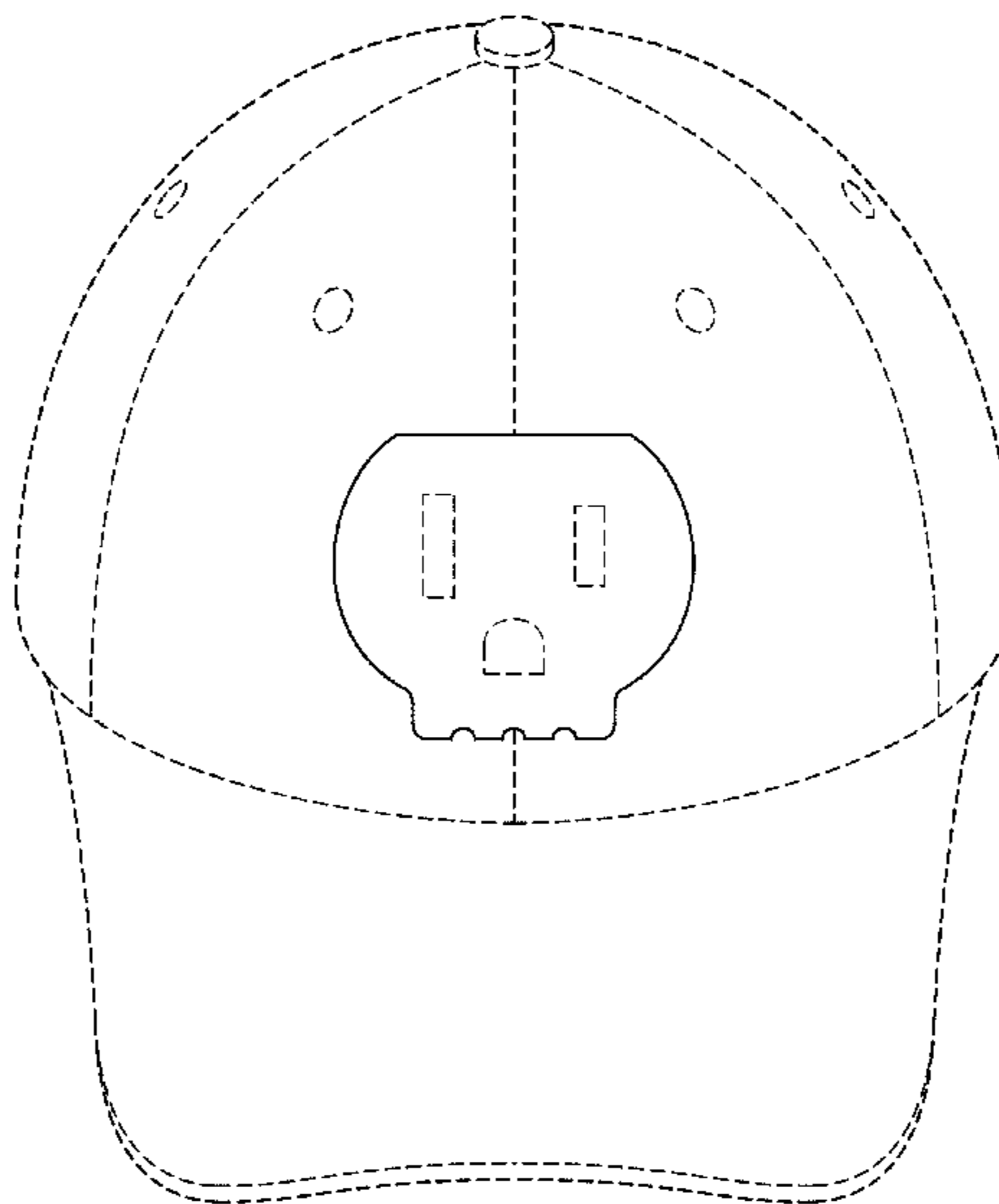
The ornamental design for a hat, as shown and described.
