FIG. 10 is another left view thereof.

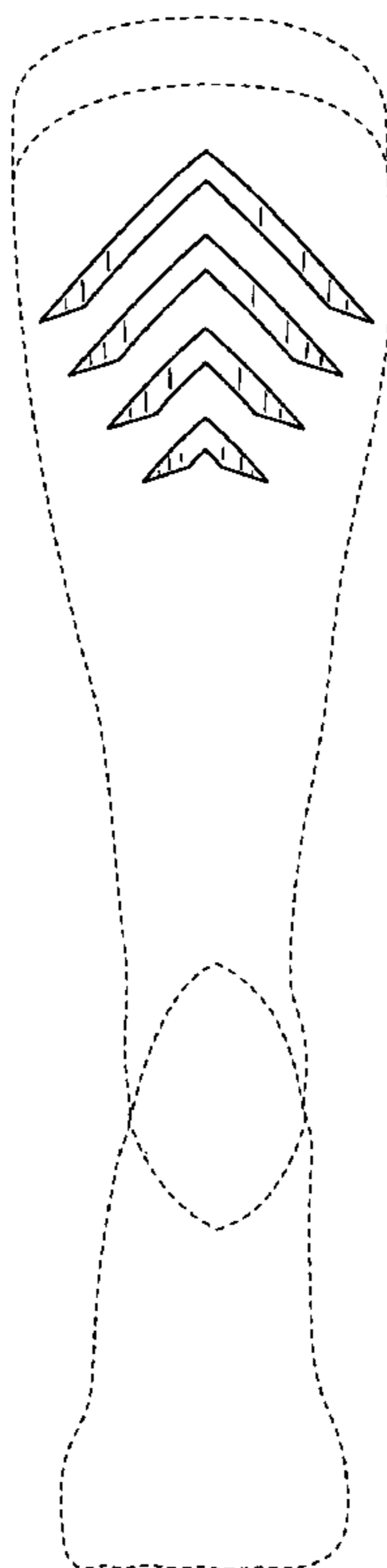
The broken line showing of the seams, stitching, and portions of the stocking is for illustrative purposes only and forms no part of the claimed design.

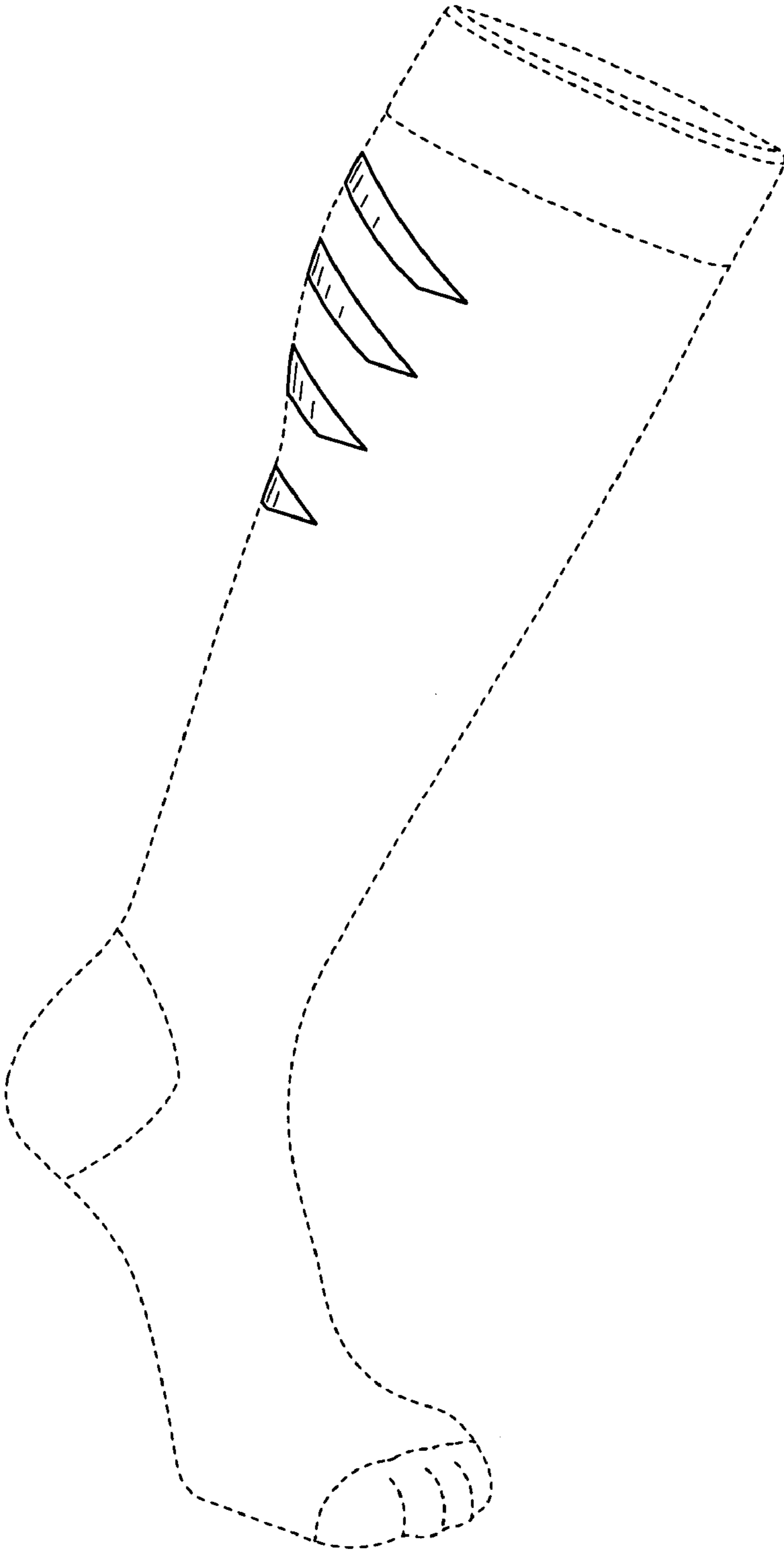

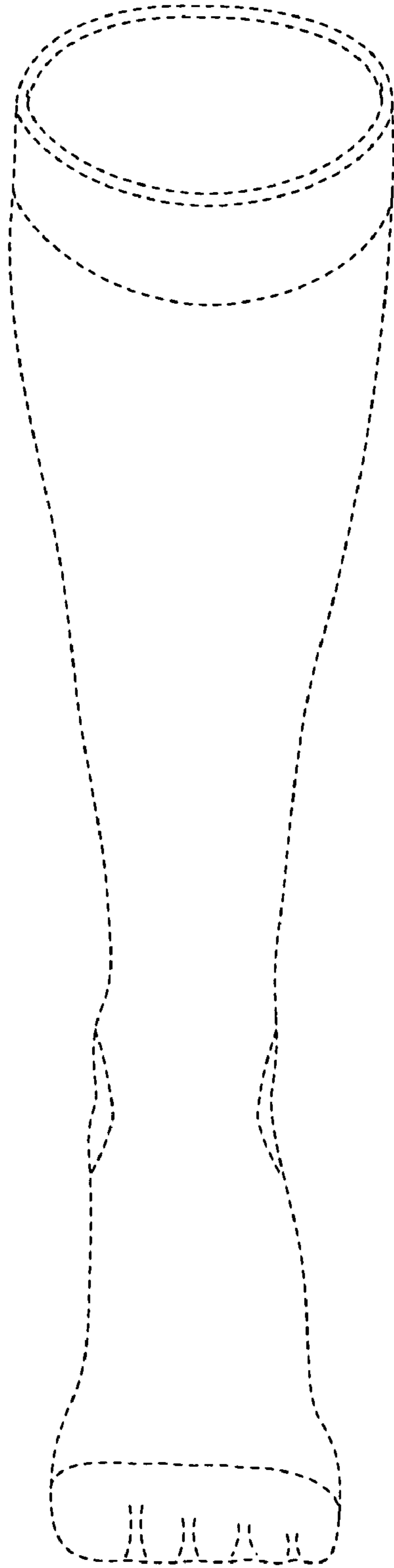

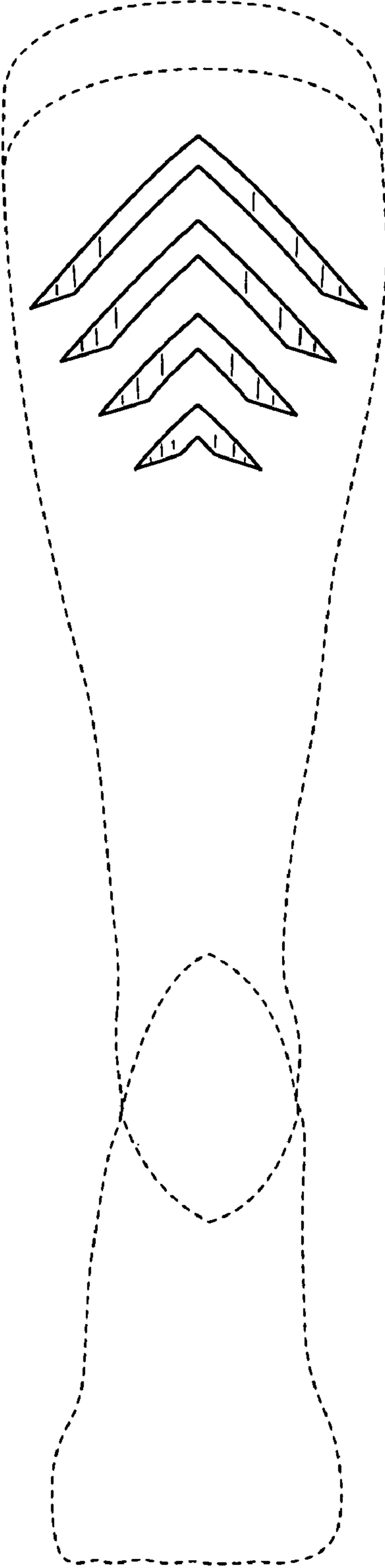

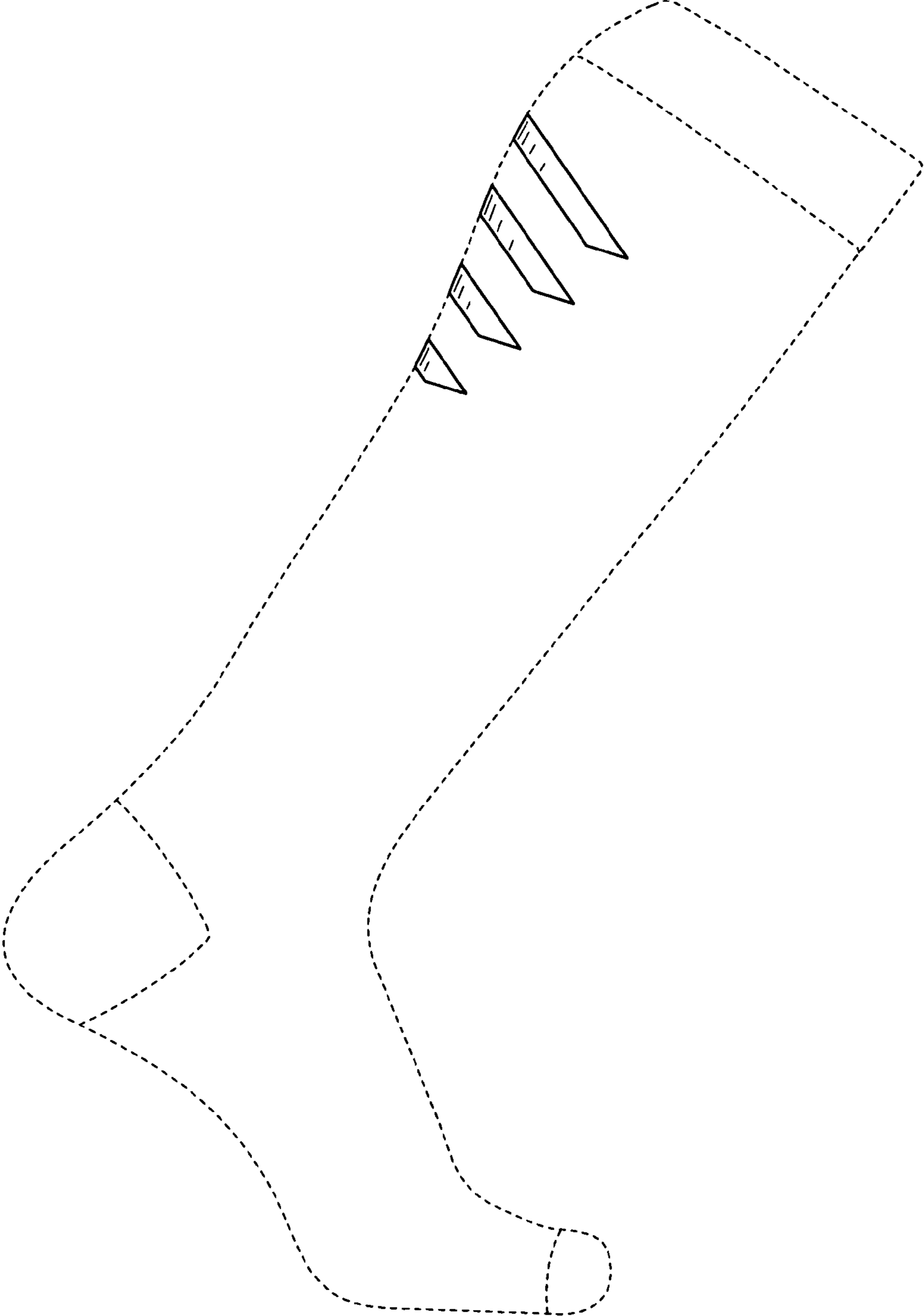

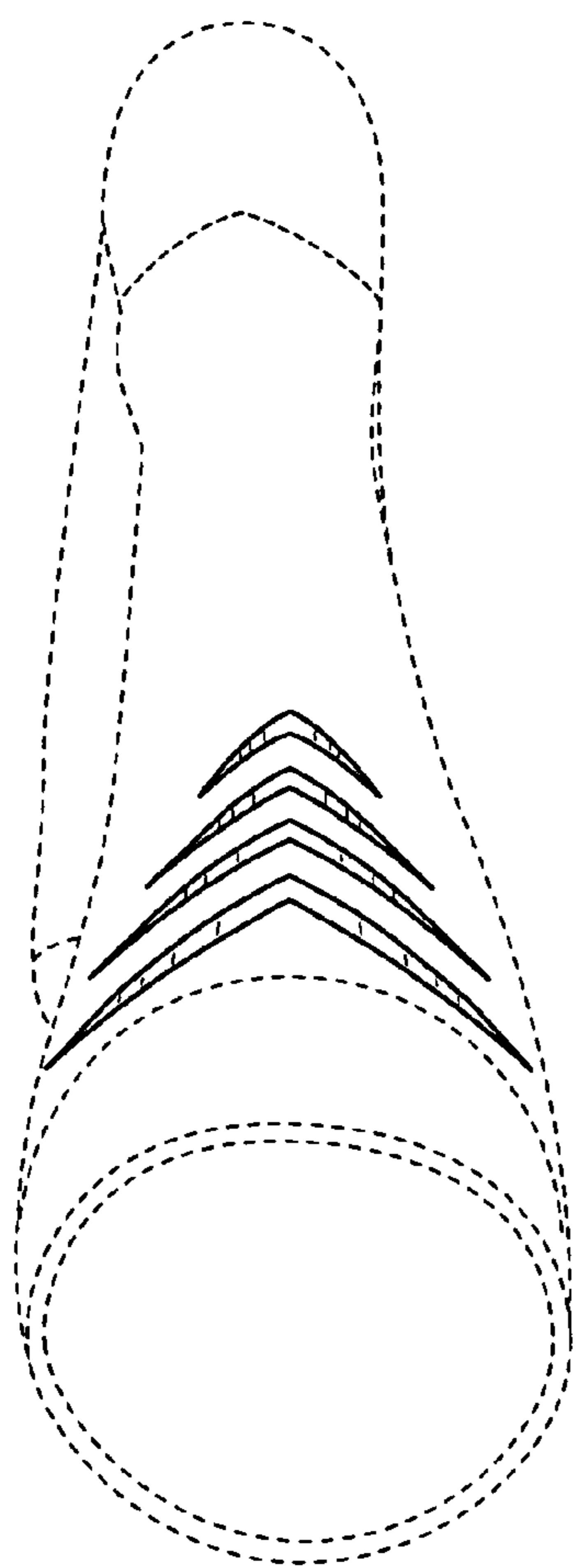

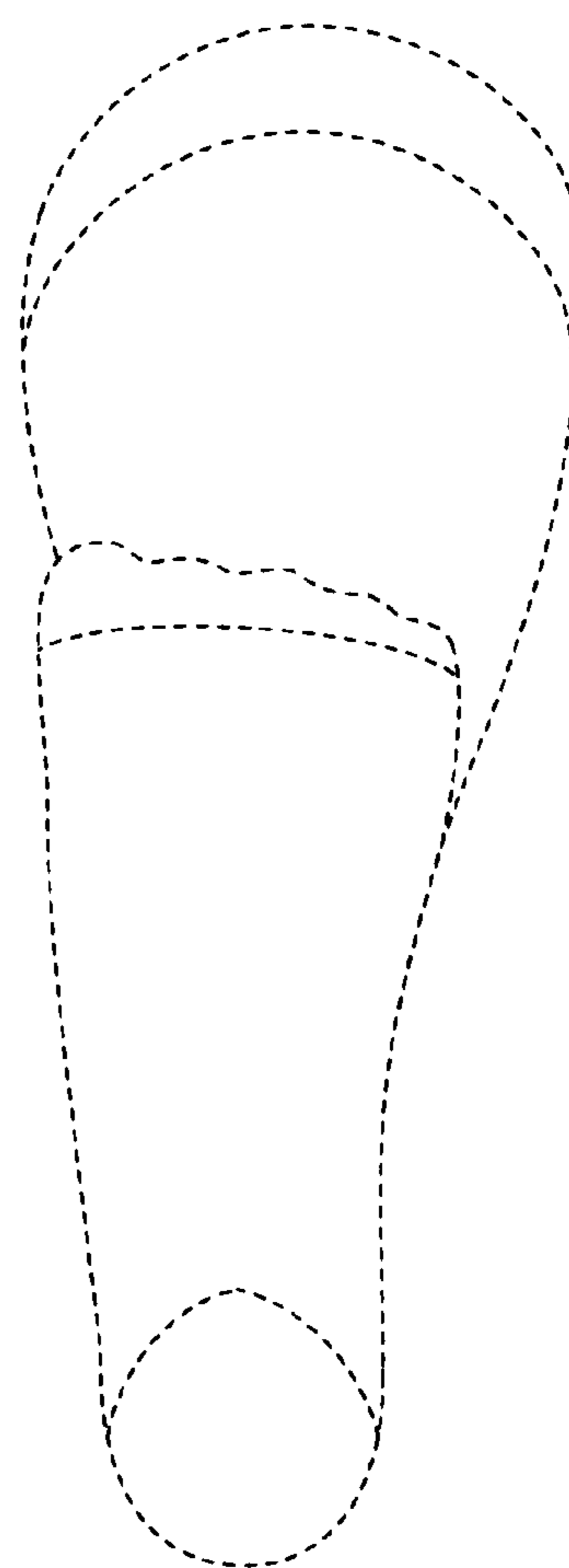

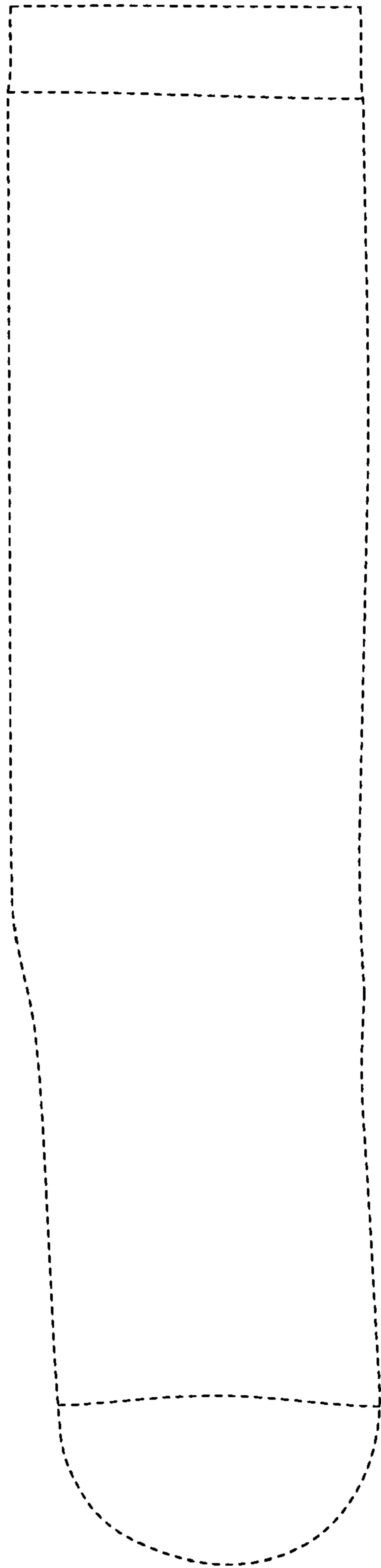

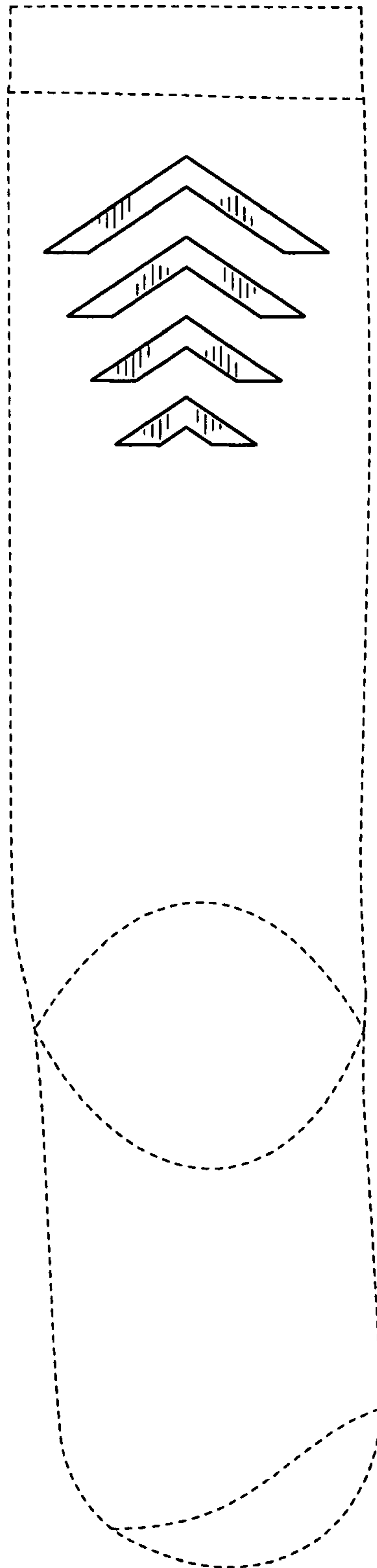

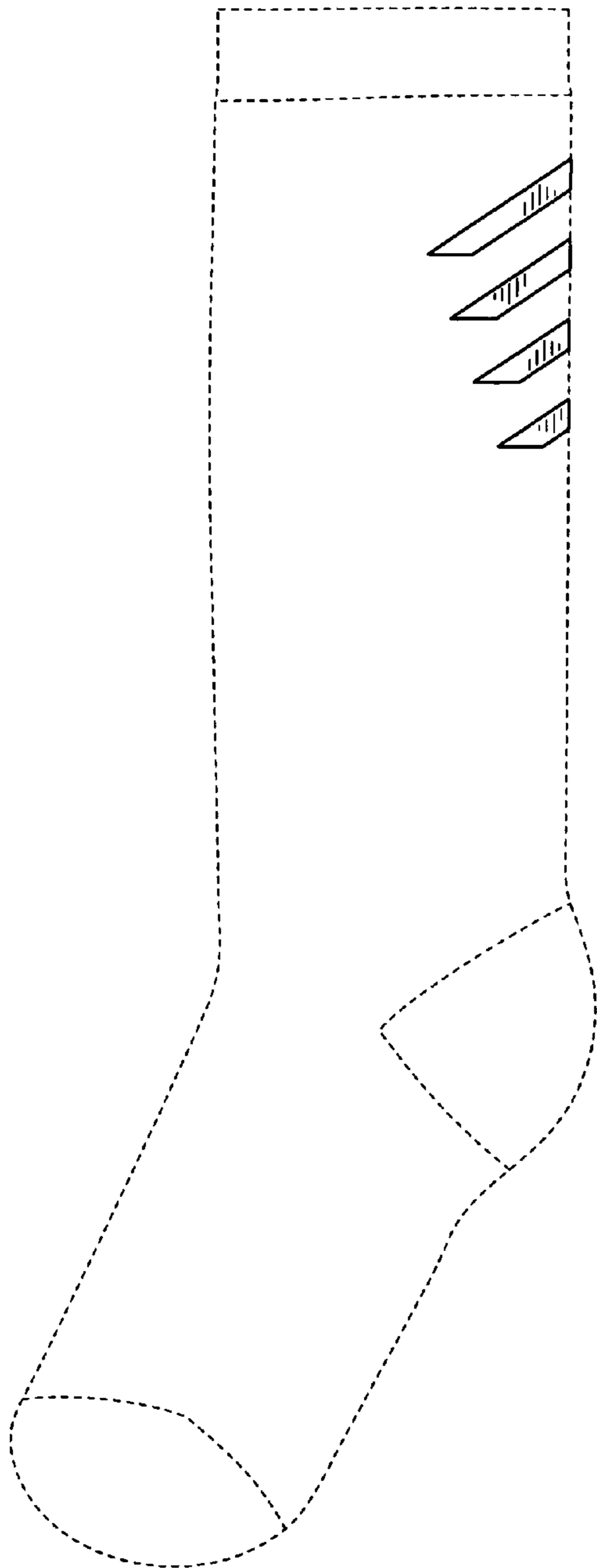

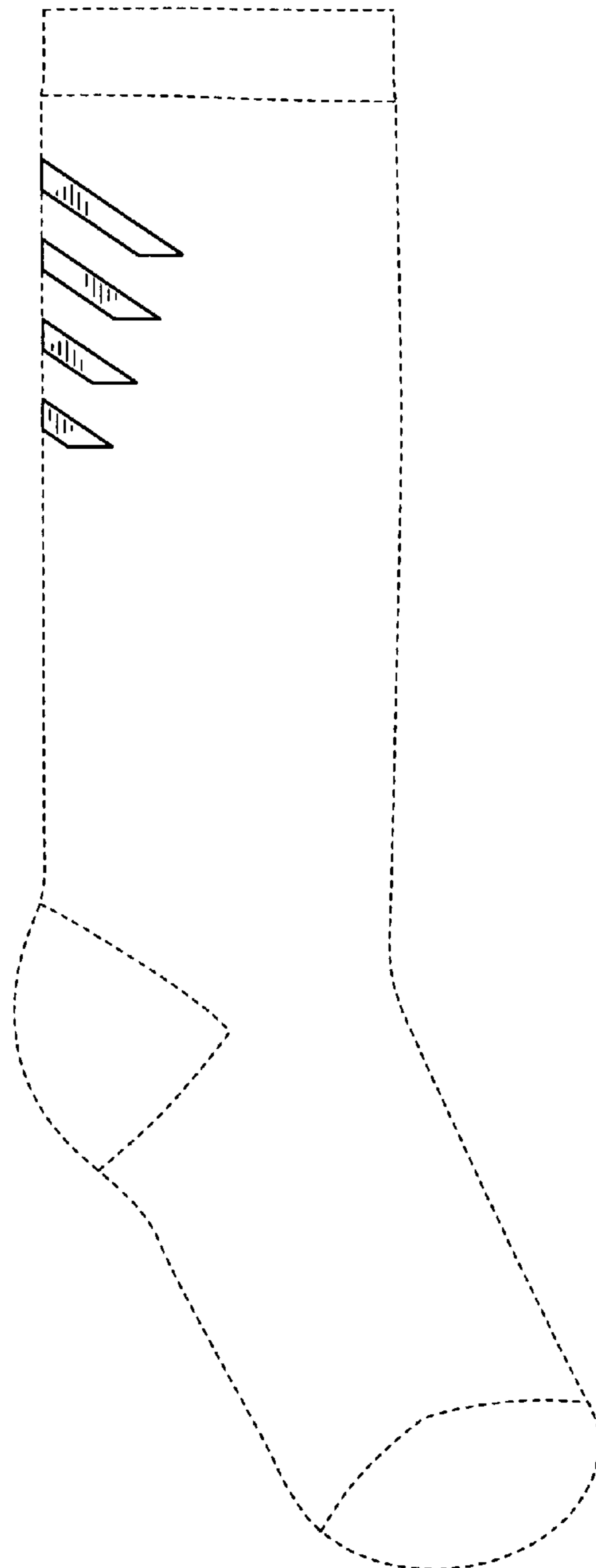
