FIG. 14 is a right side view of the insert with the clip folded.

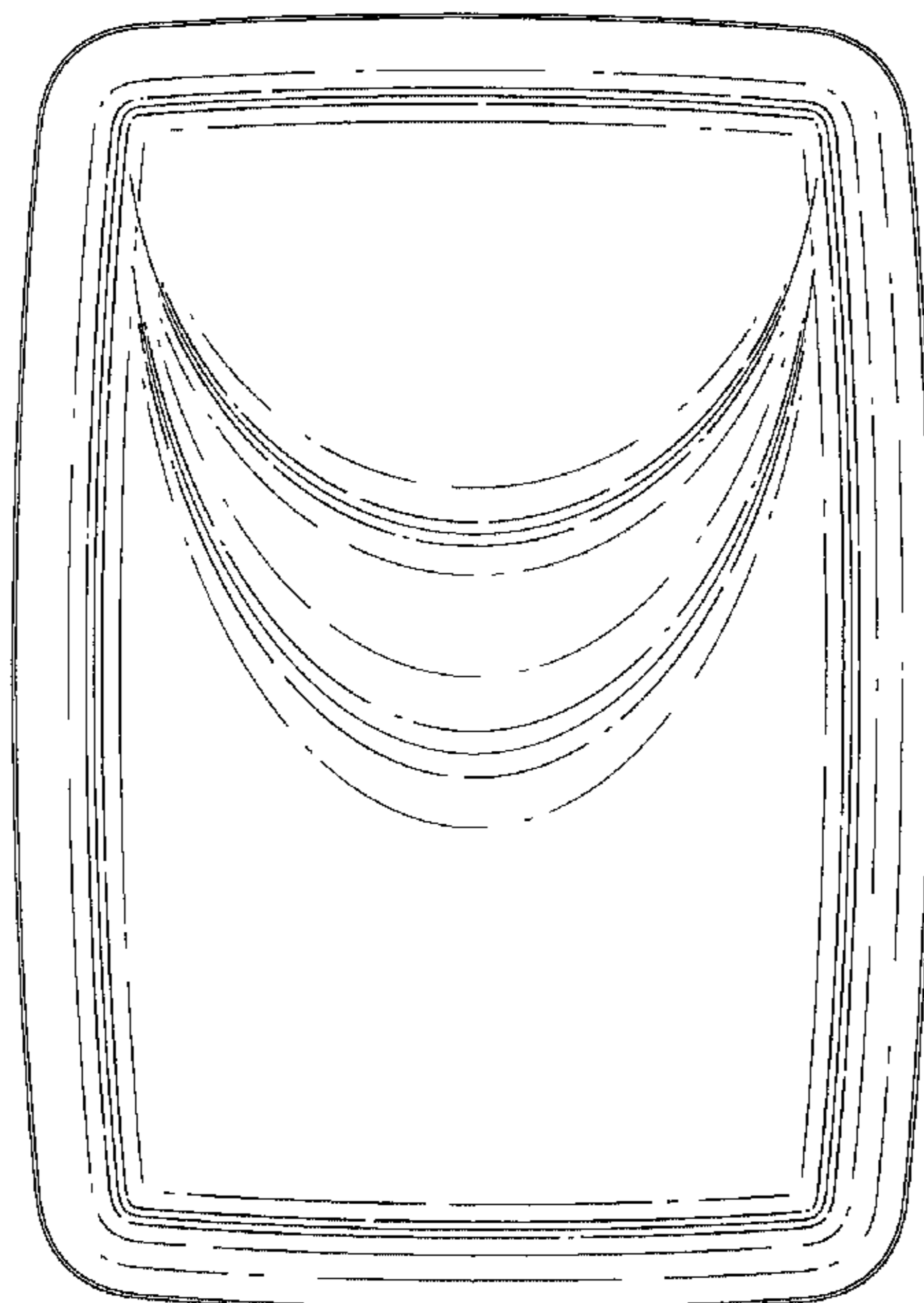
FIG. 15 is a top plan view of the insert with the clip folded; and,

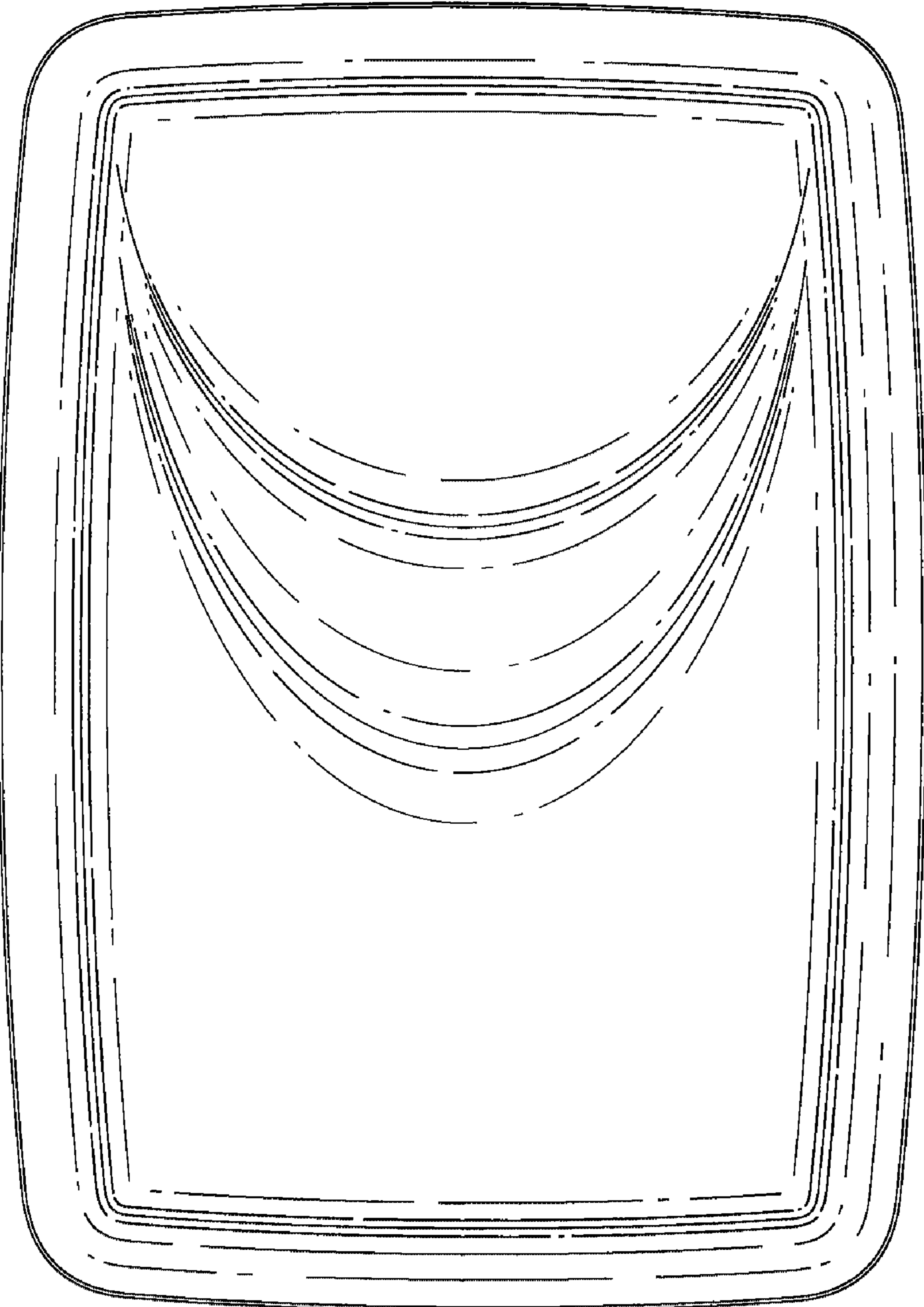

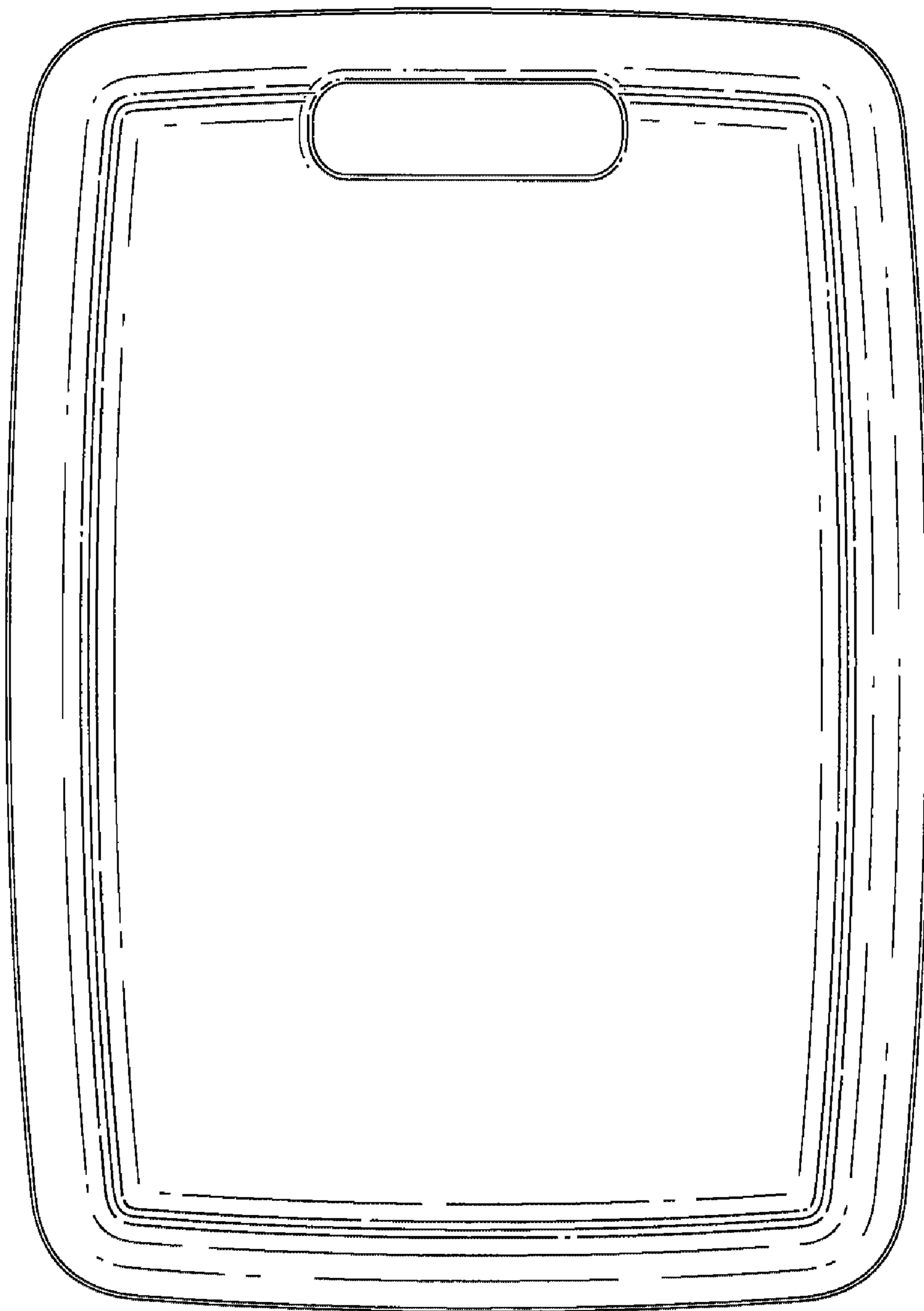

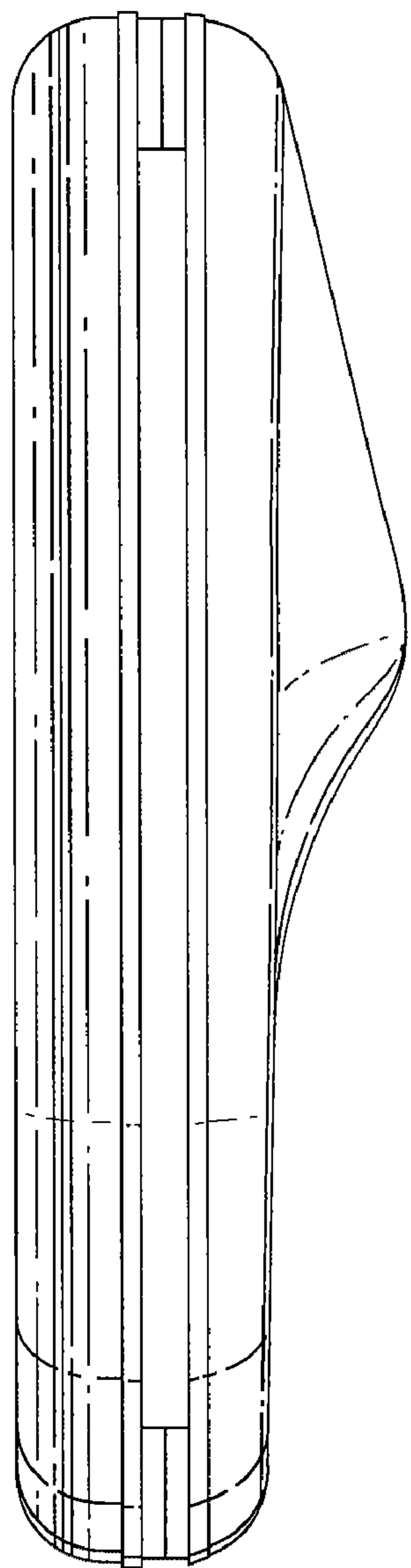

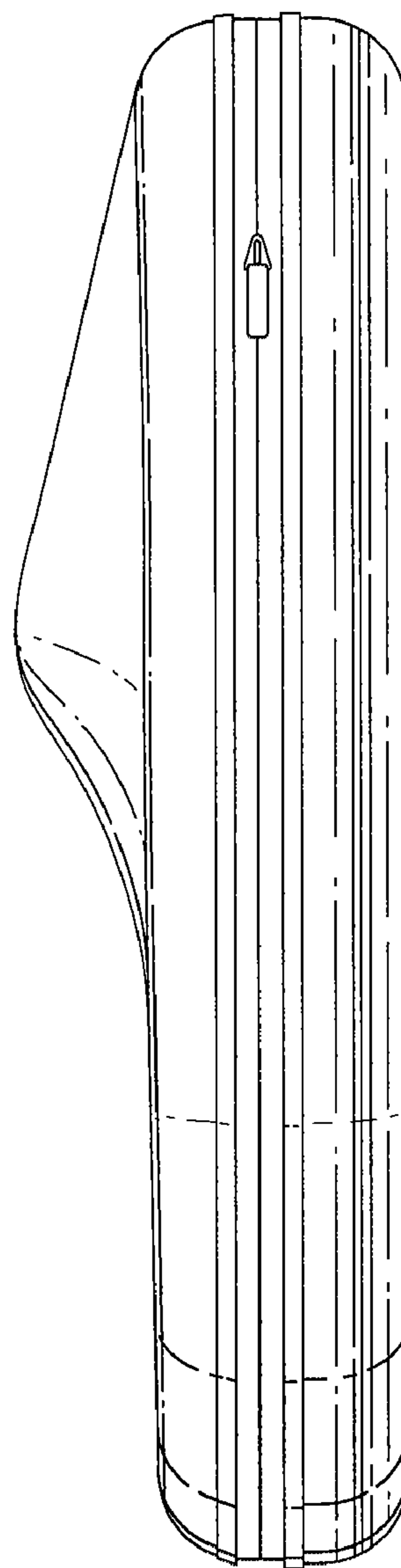

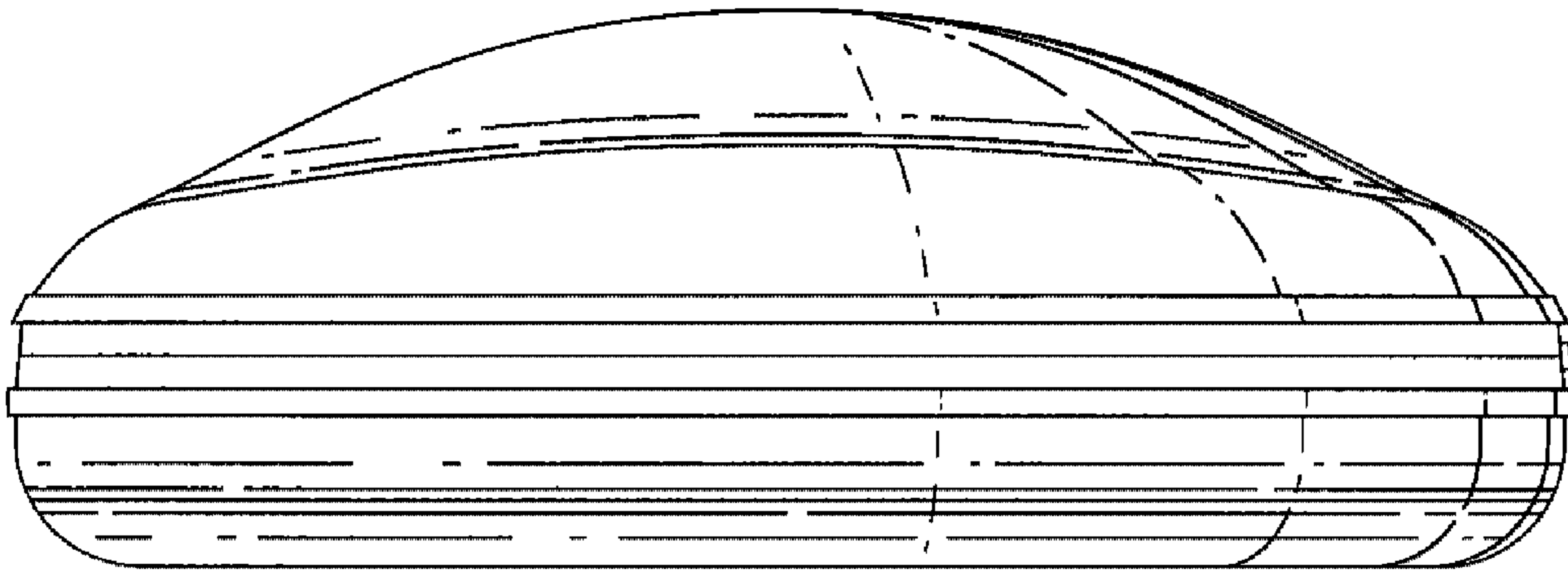

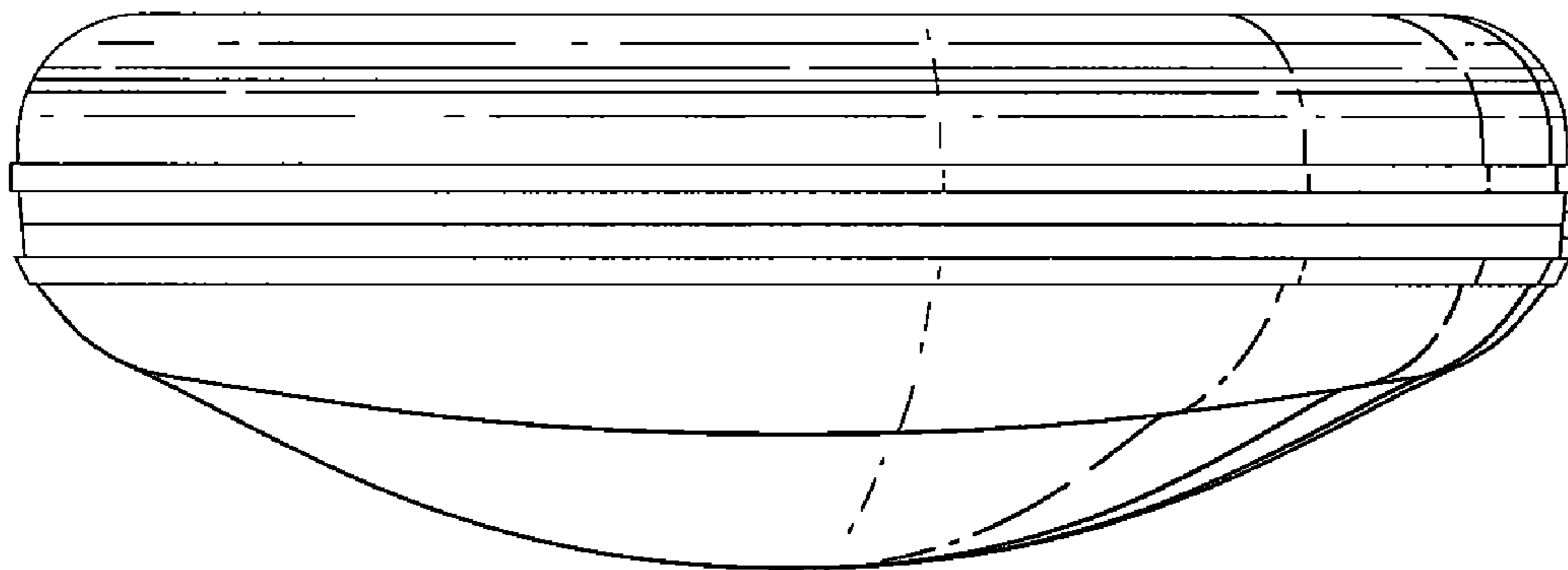

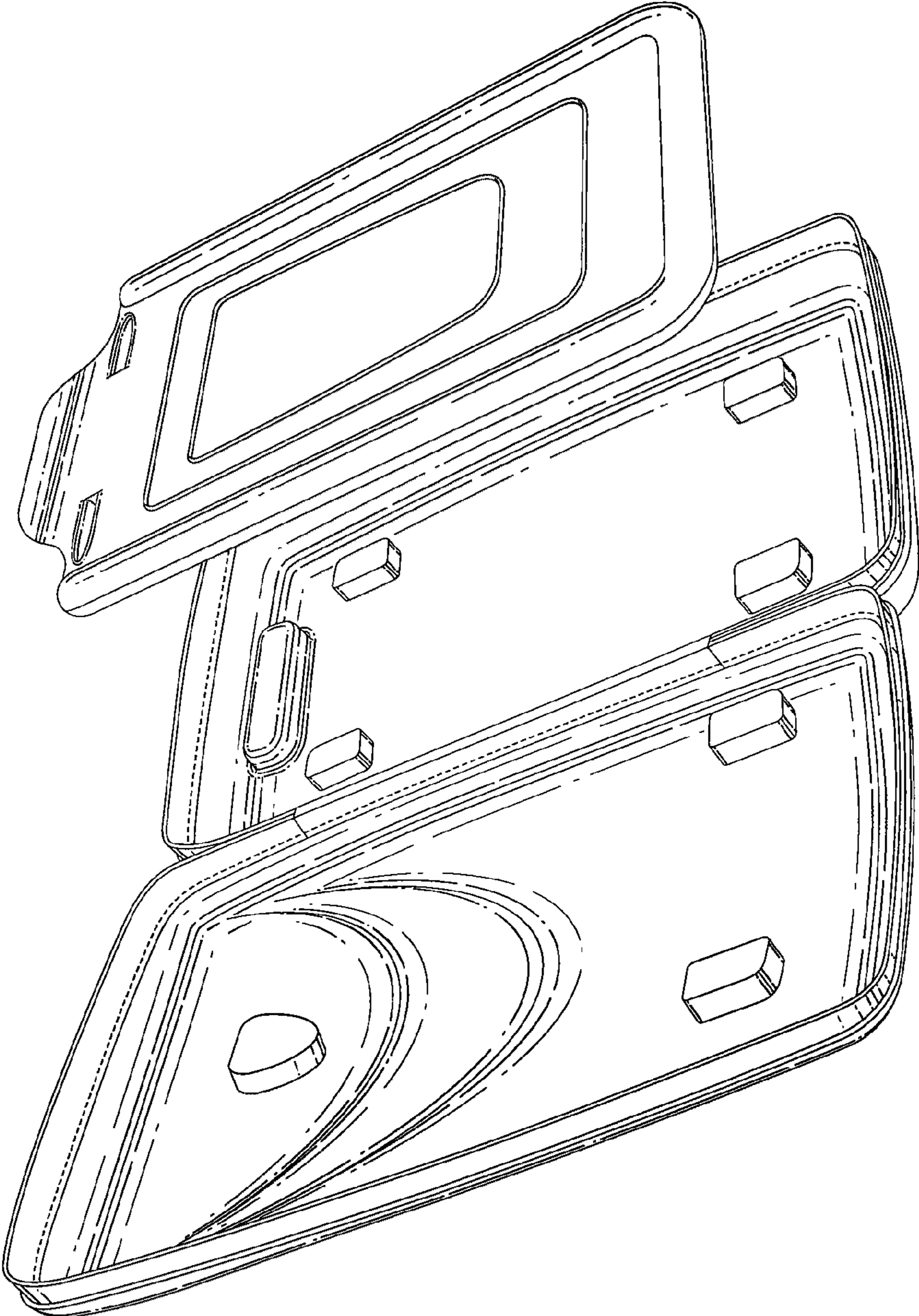

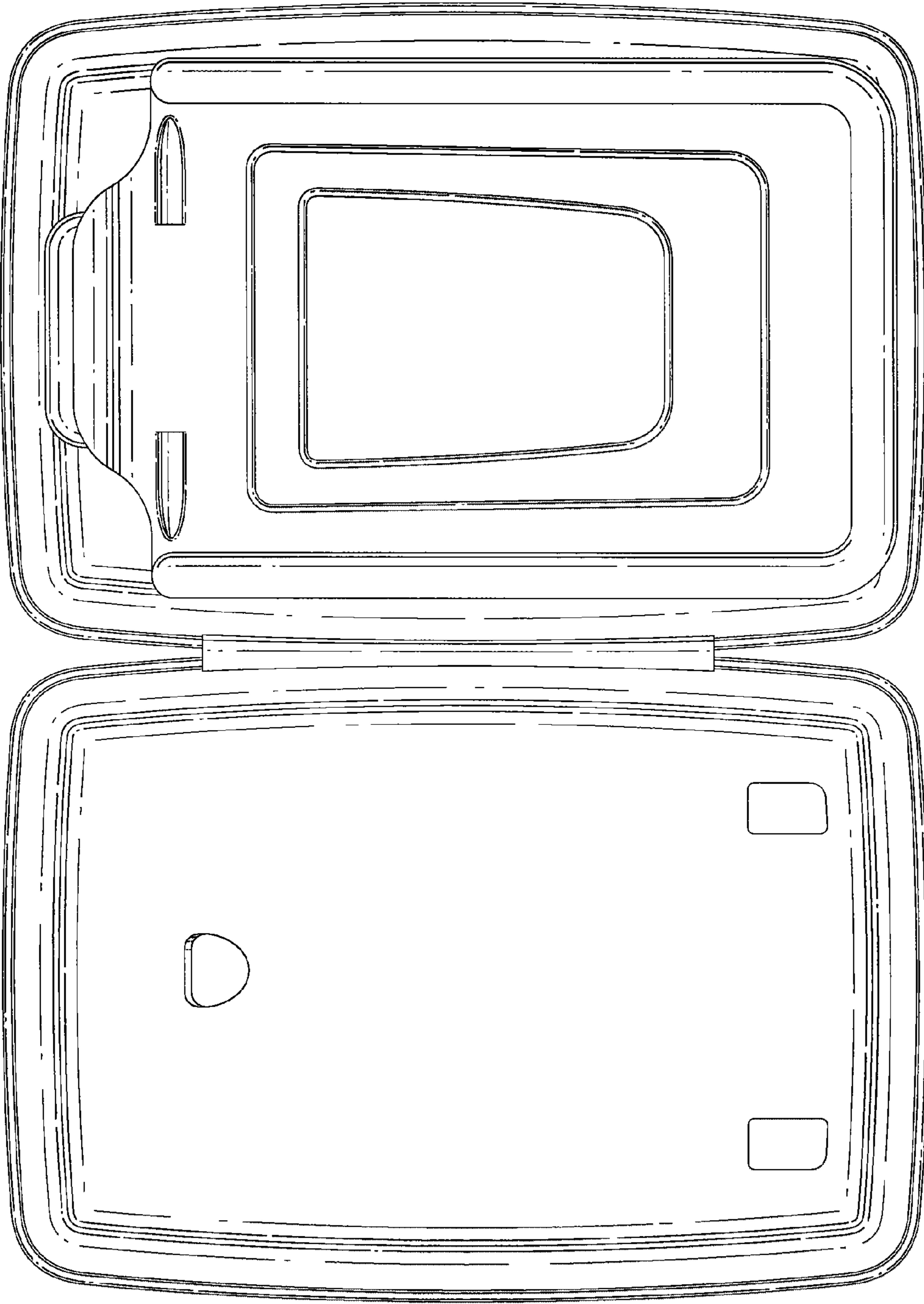

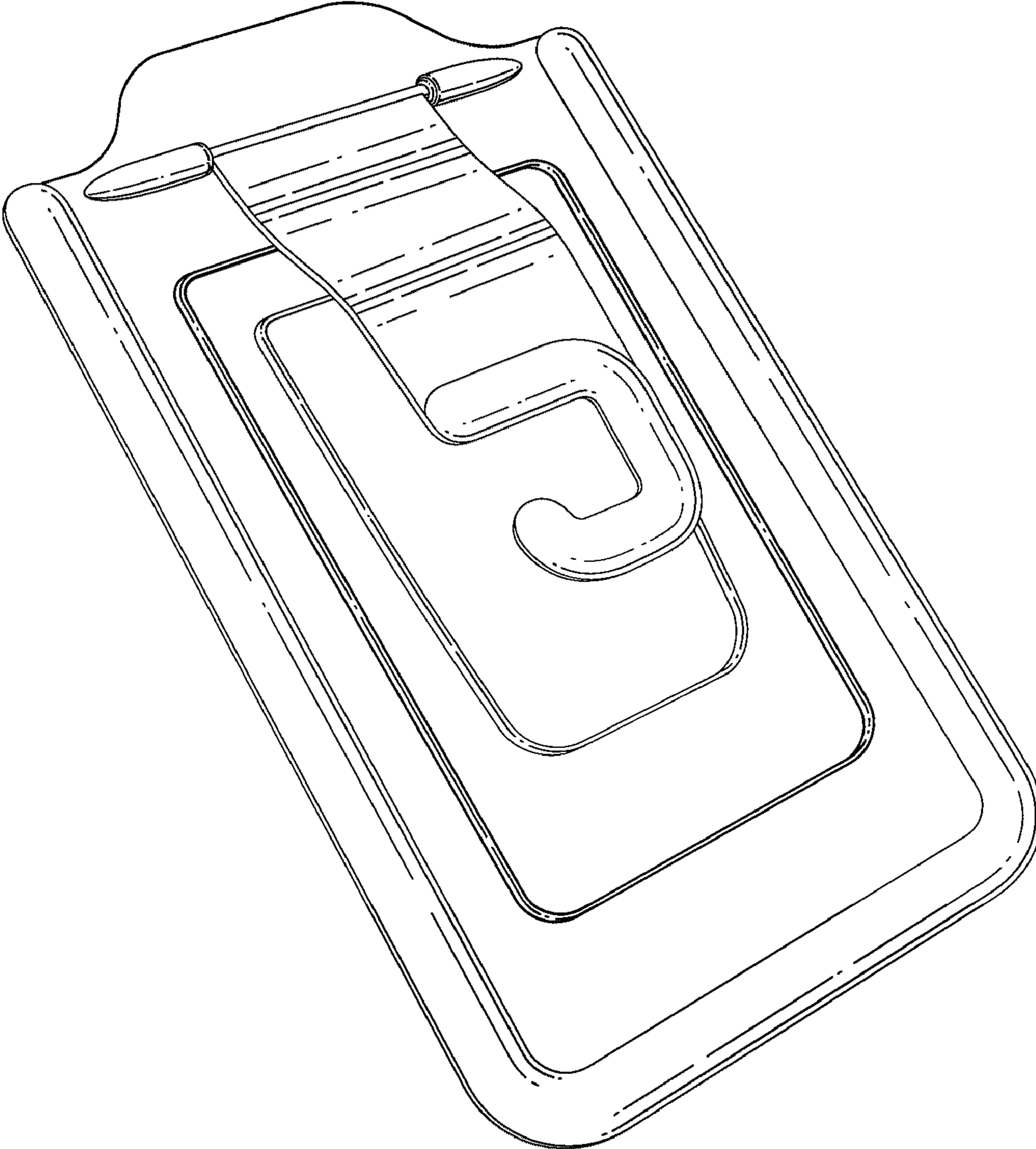

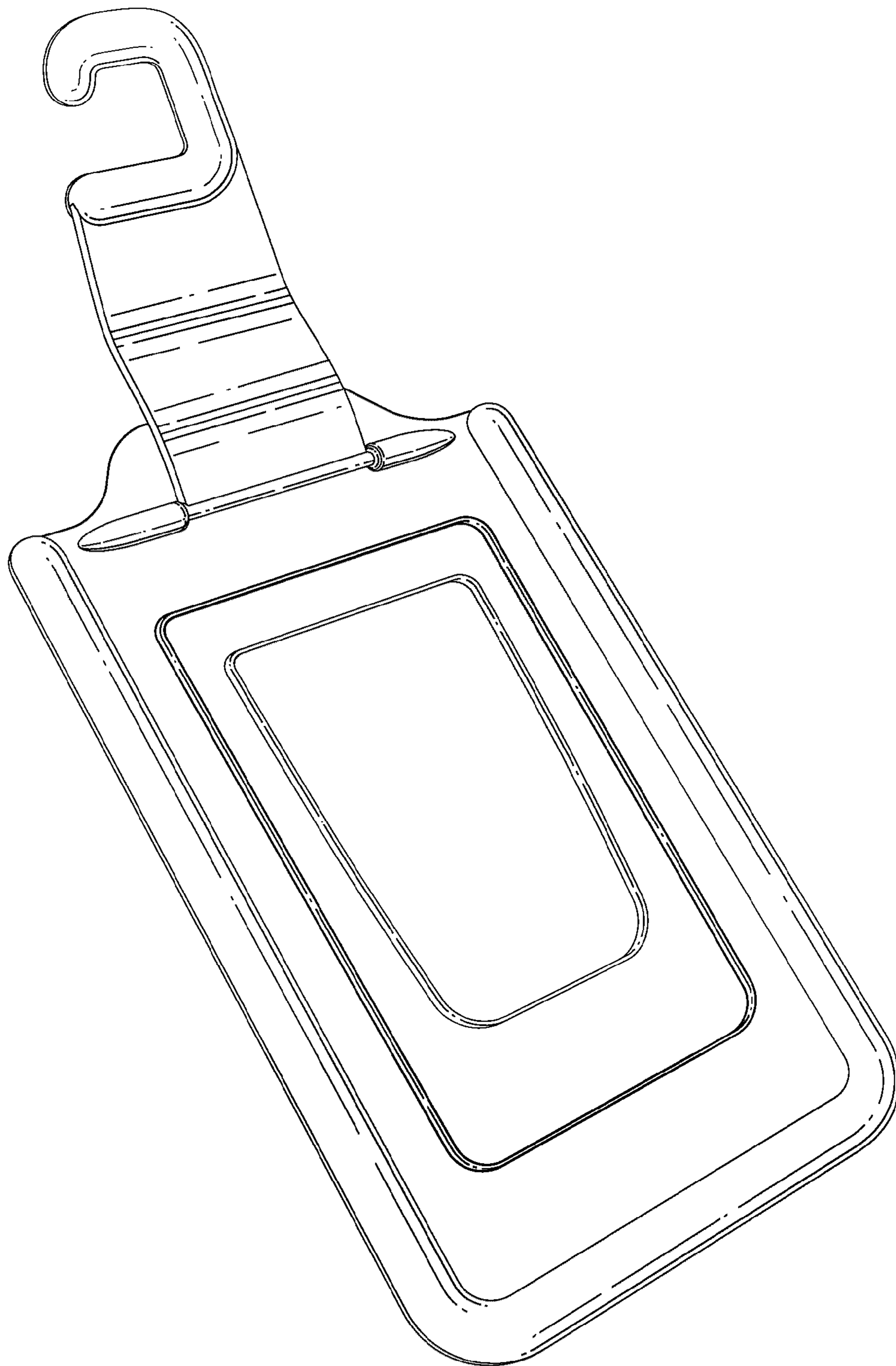

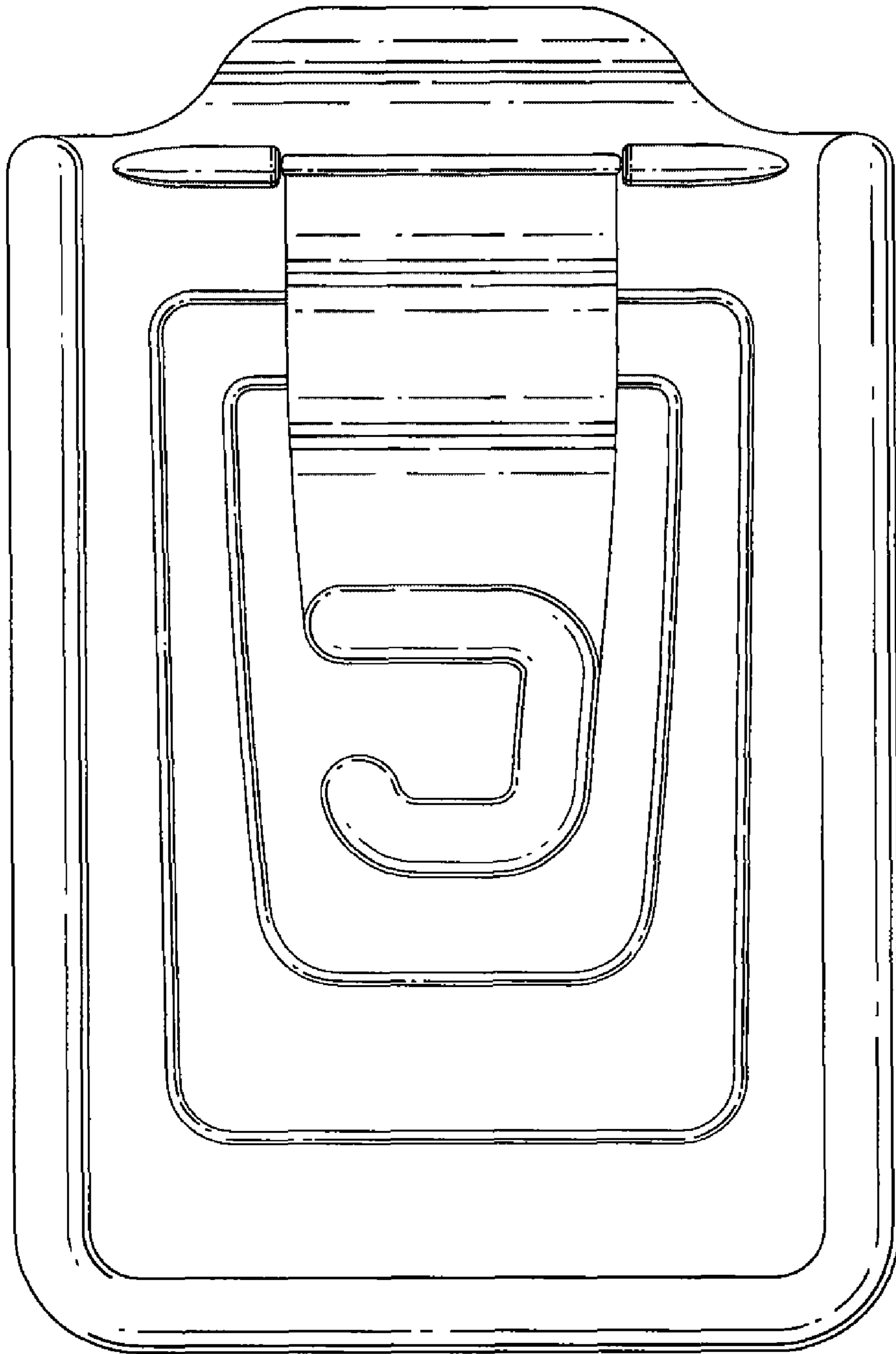

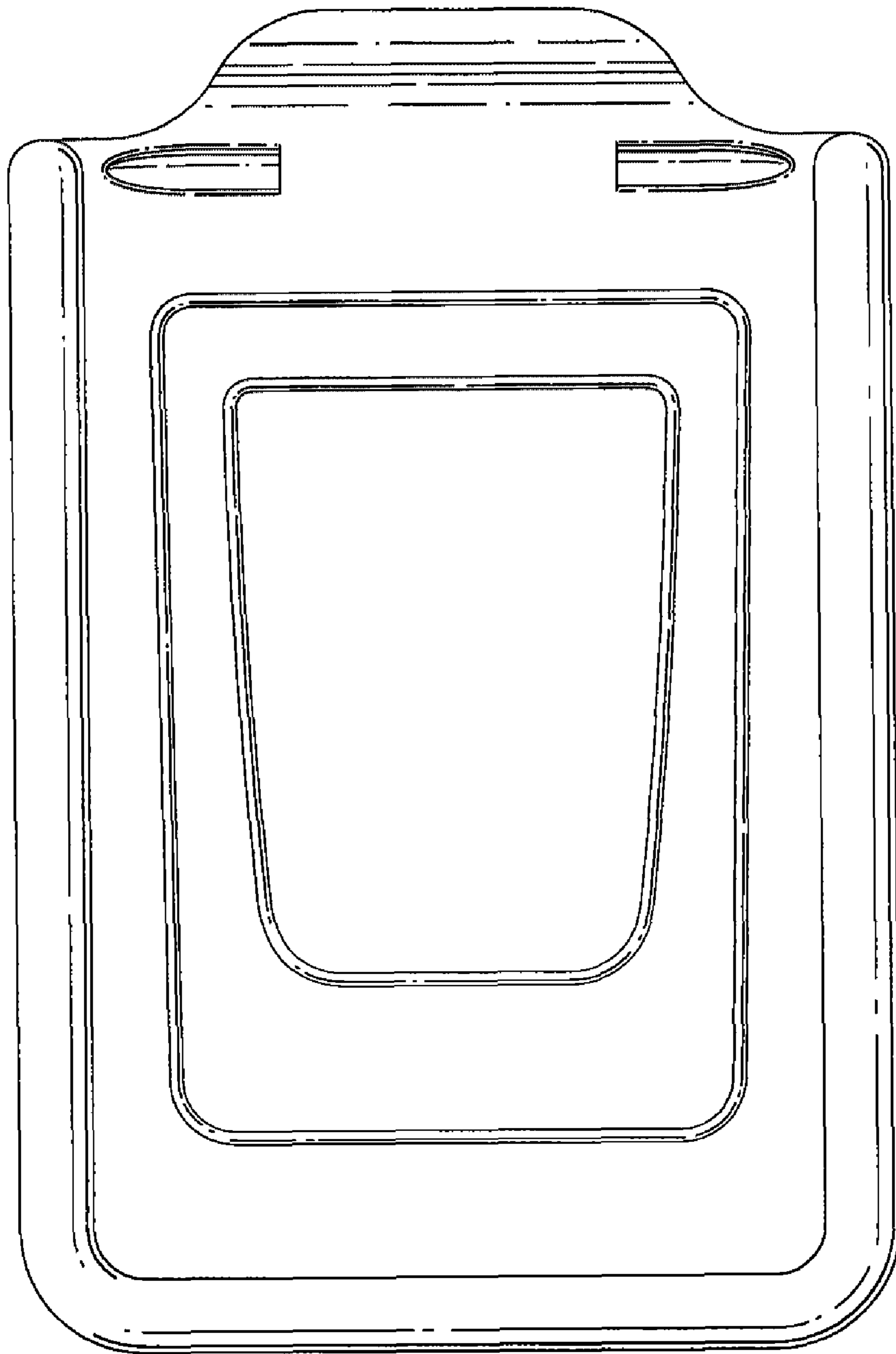

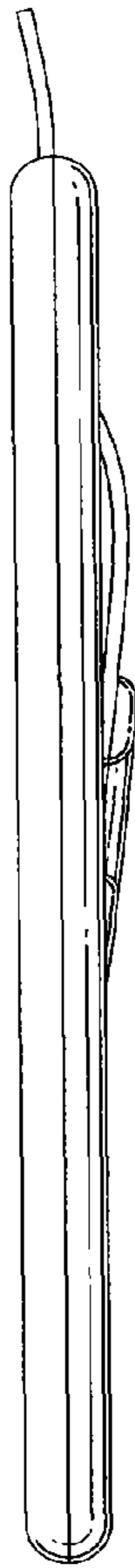

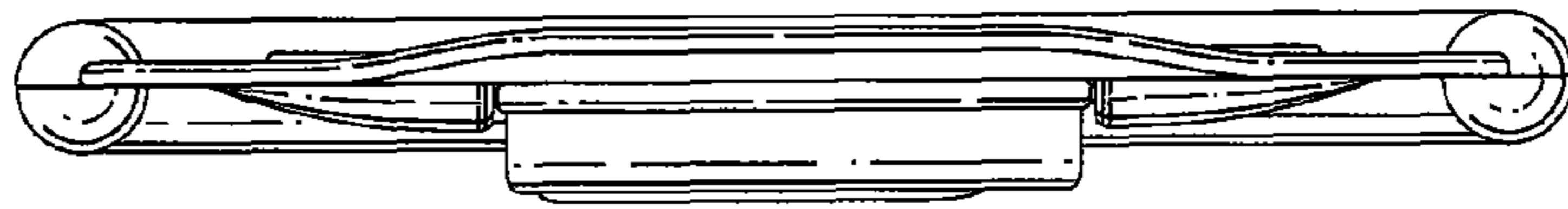

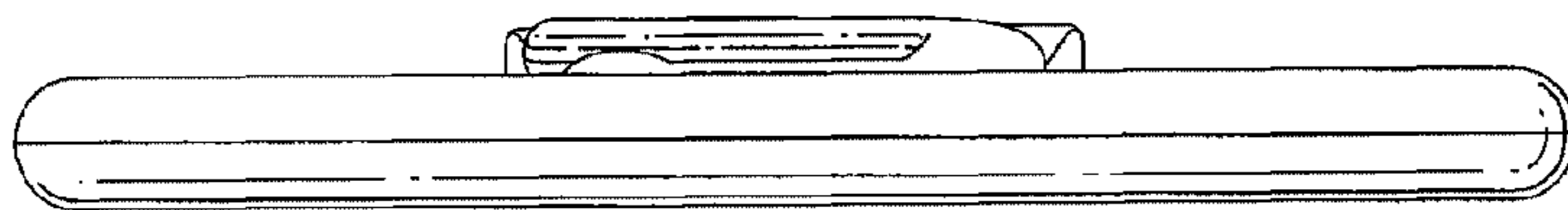
