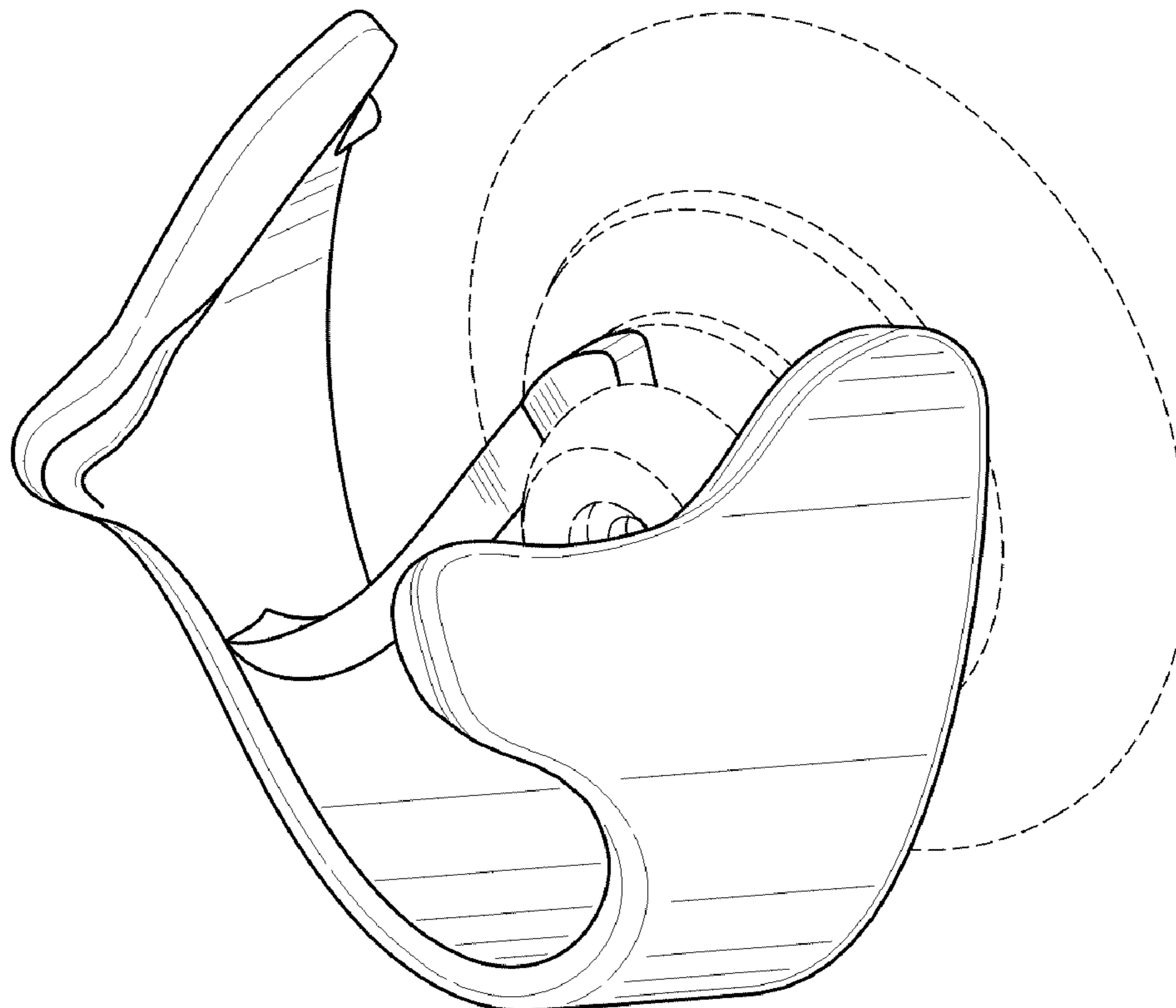
(57) **CLAIM**

I claim the ornamental design for the safety razor holder, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of the safety razor holder. FIG. 2 is a lower perspective view thereof. FIG. 3 is a front view thereof. FIG. 4 is a bottom view thereof. FIG. 5 is a top view thereof. FIG. 6 is a rear view thereof. FIG. 7 is a right side view of FIG. 3; and, FIG. 8 is a left side view of FIG. 3. 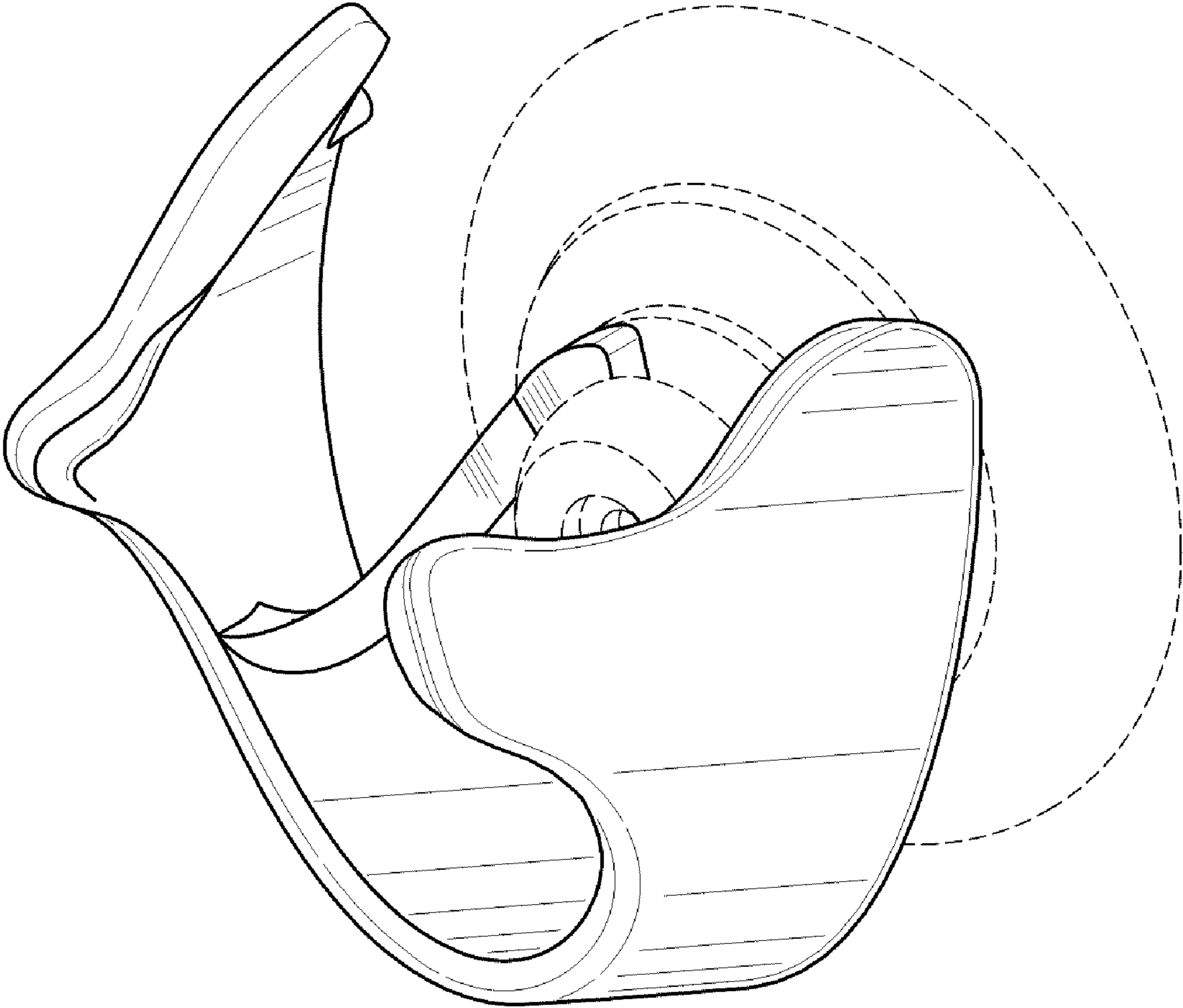

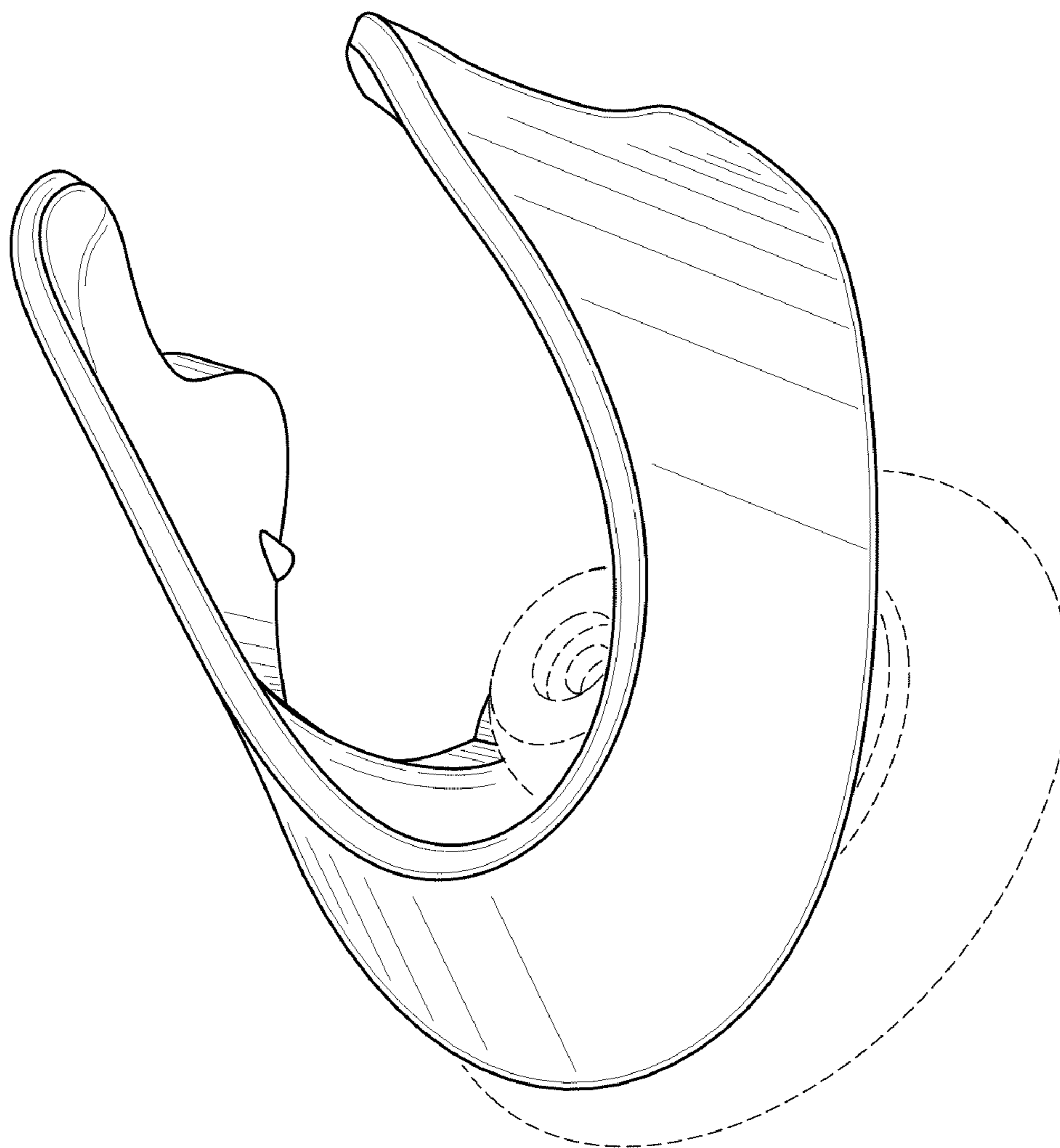

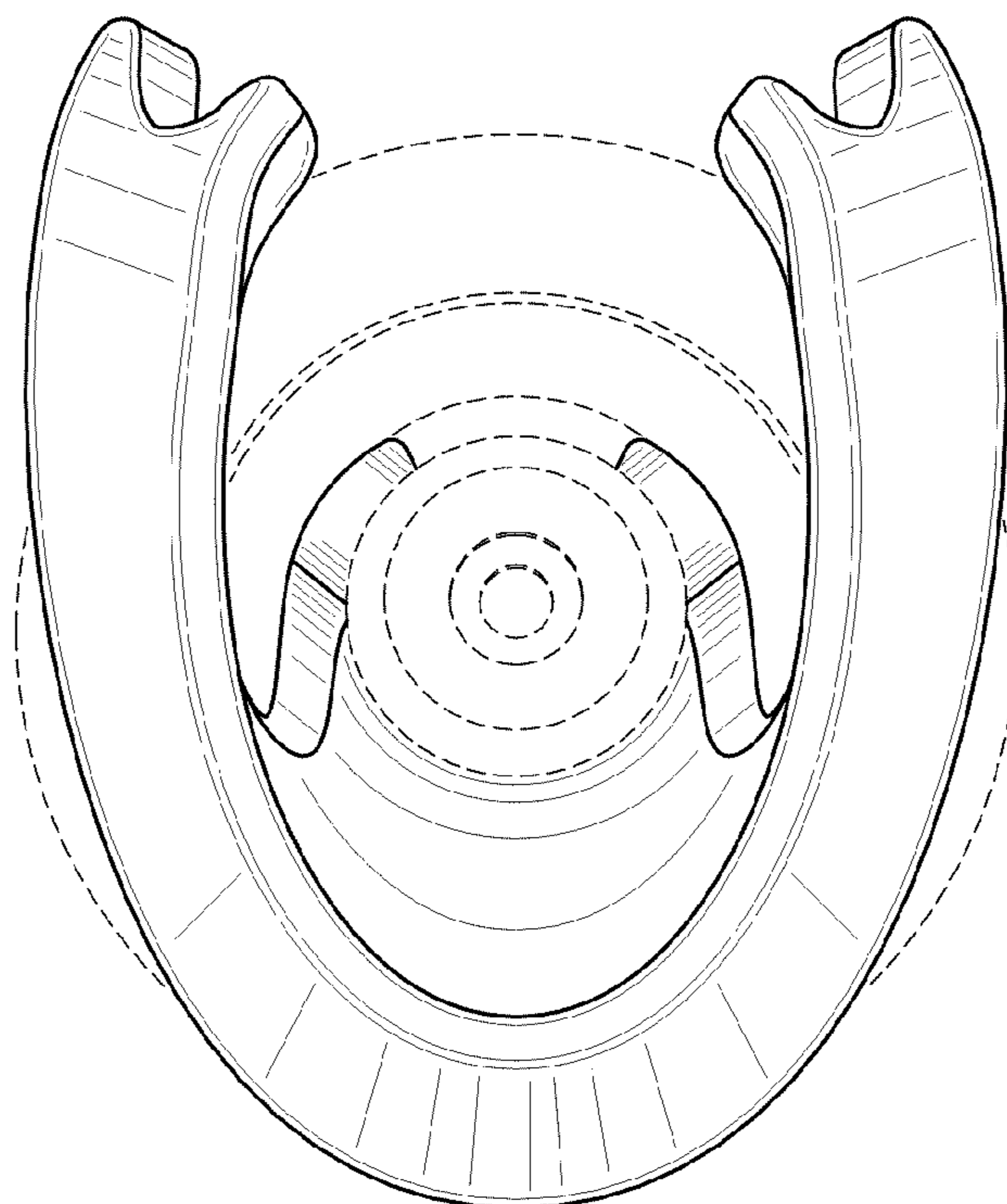

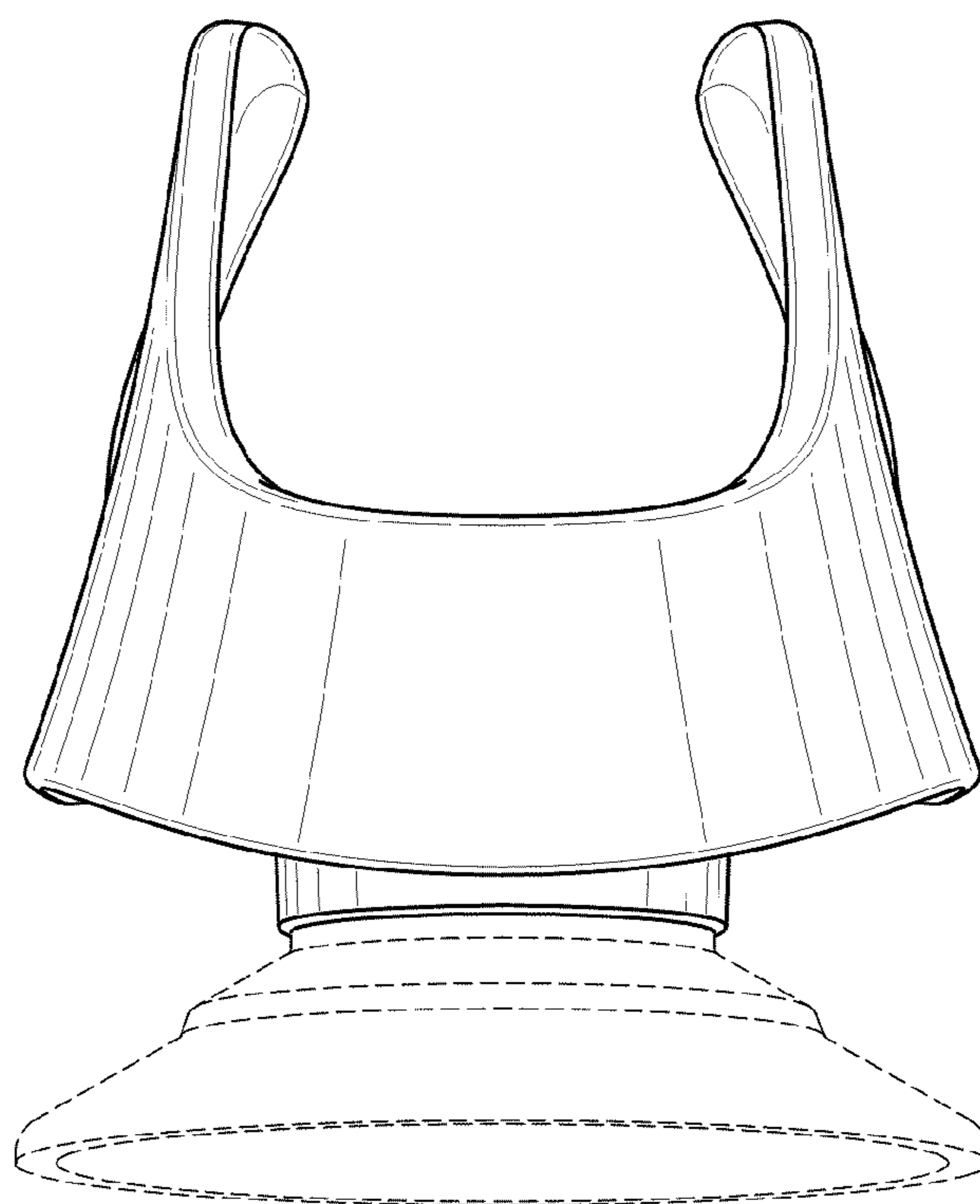

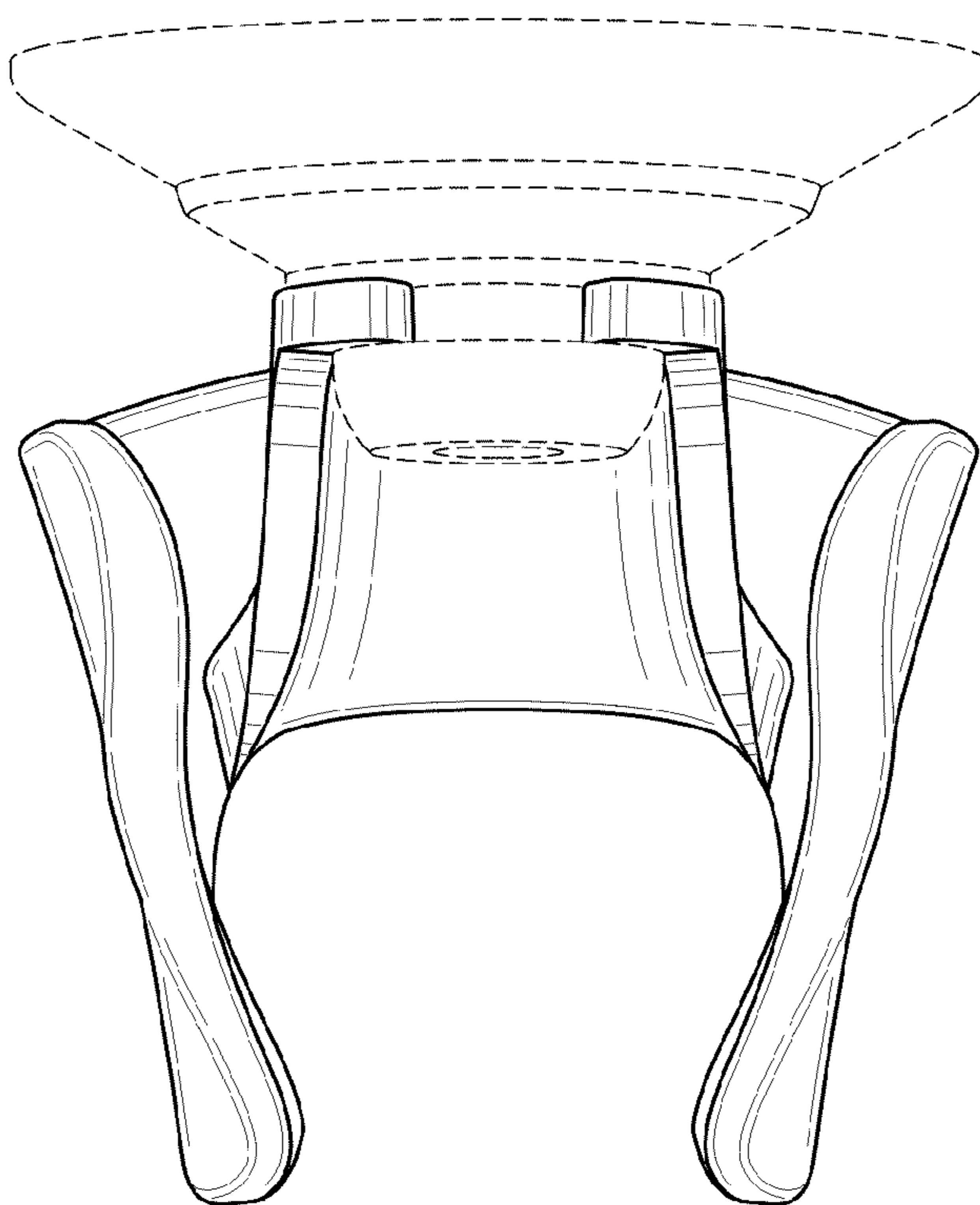

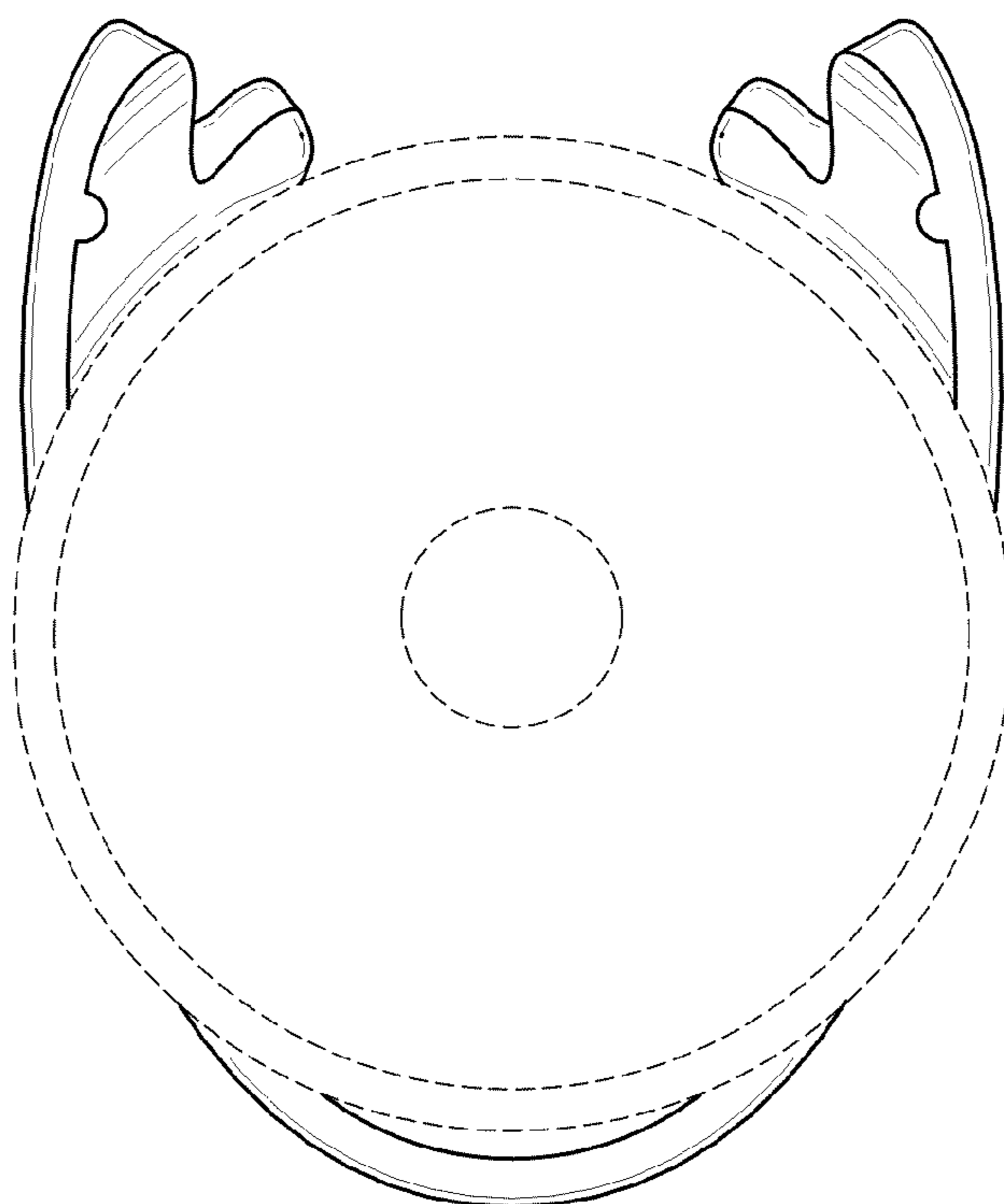

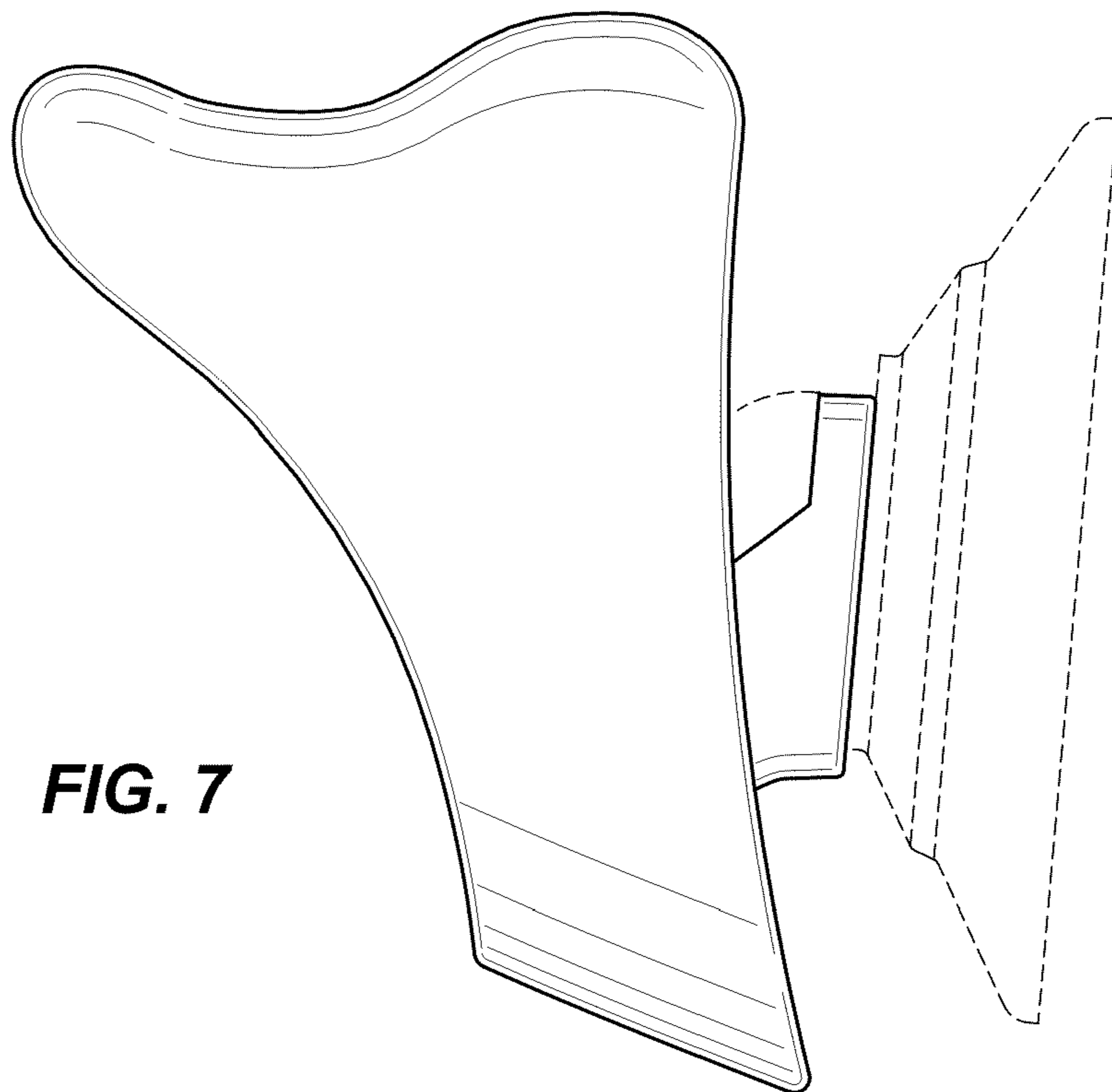

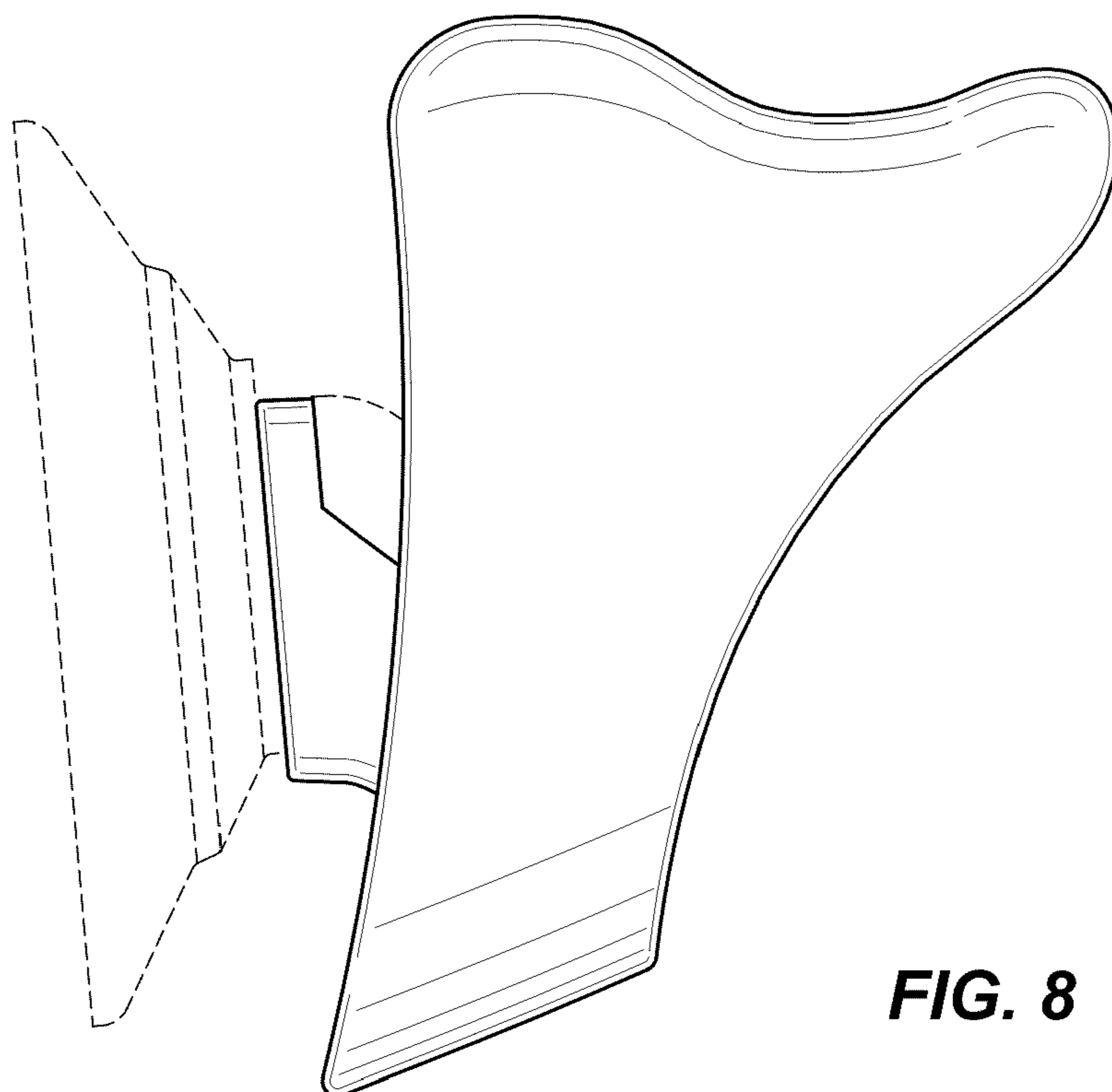
