(57) **CLAIM**

We claim the ornamental design for a cabinet and/or drawer  
pull, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cabinet and/or drawer pull  
showing our new design, the opposite perspective view is a  
mirror image;

FIG. 2 is a side elevation view of the cabinet and/or drawer  
pull shown in FIG. 1, the other side elevation view being  
identical thereto;

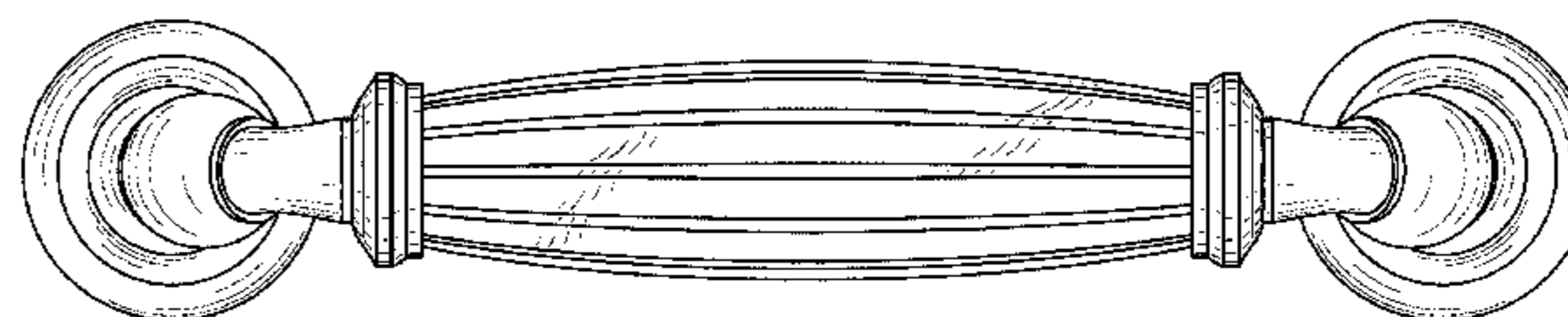
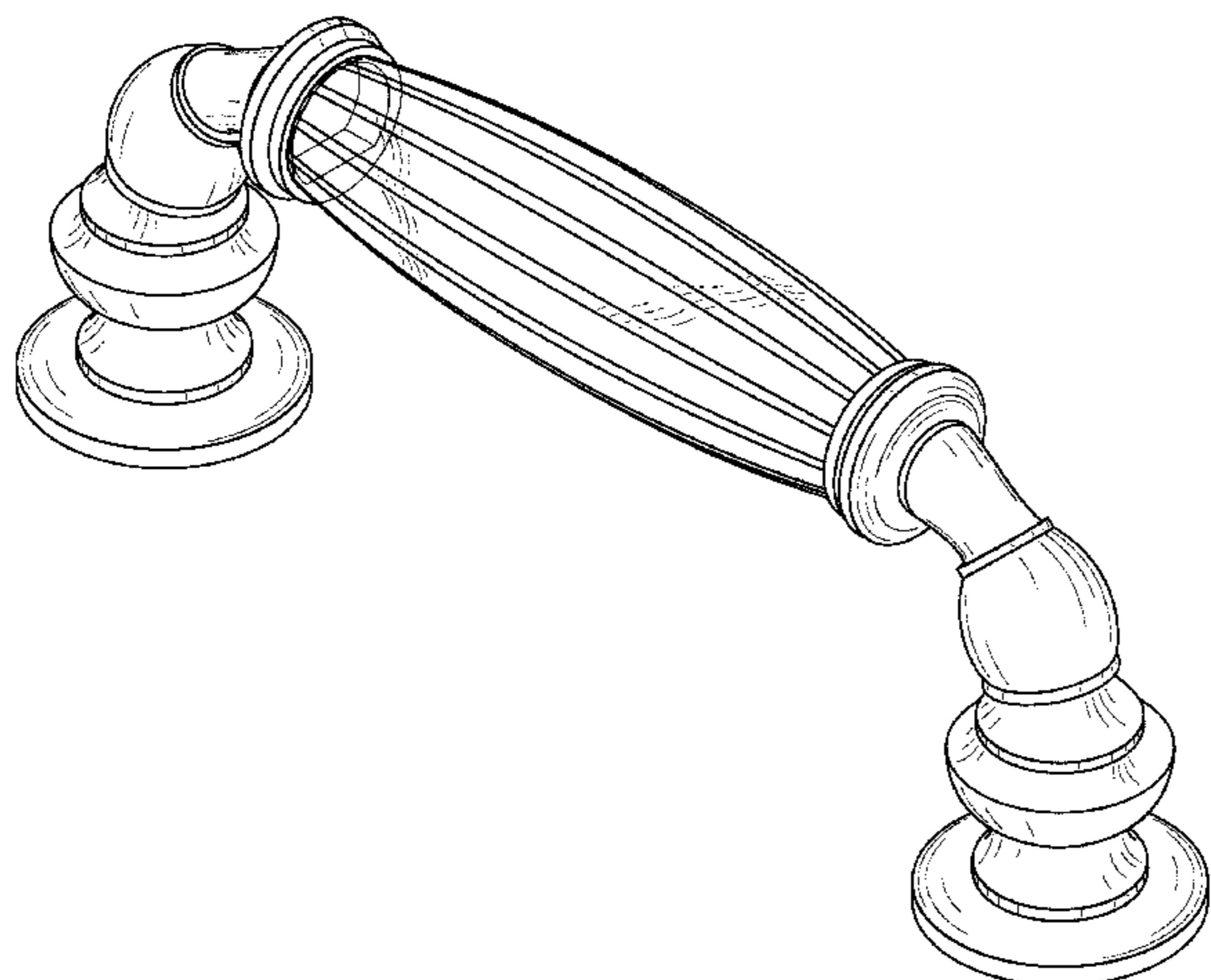
FIG. 3 is an end elevation view of the cabinet and/or drawer  
pull shown in FIG. 1, the other end elevation view being

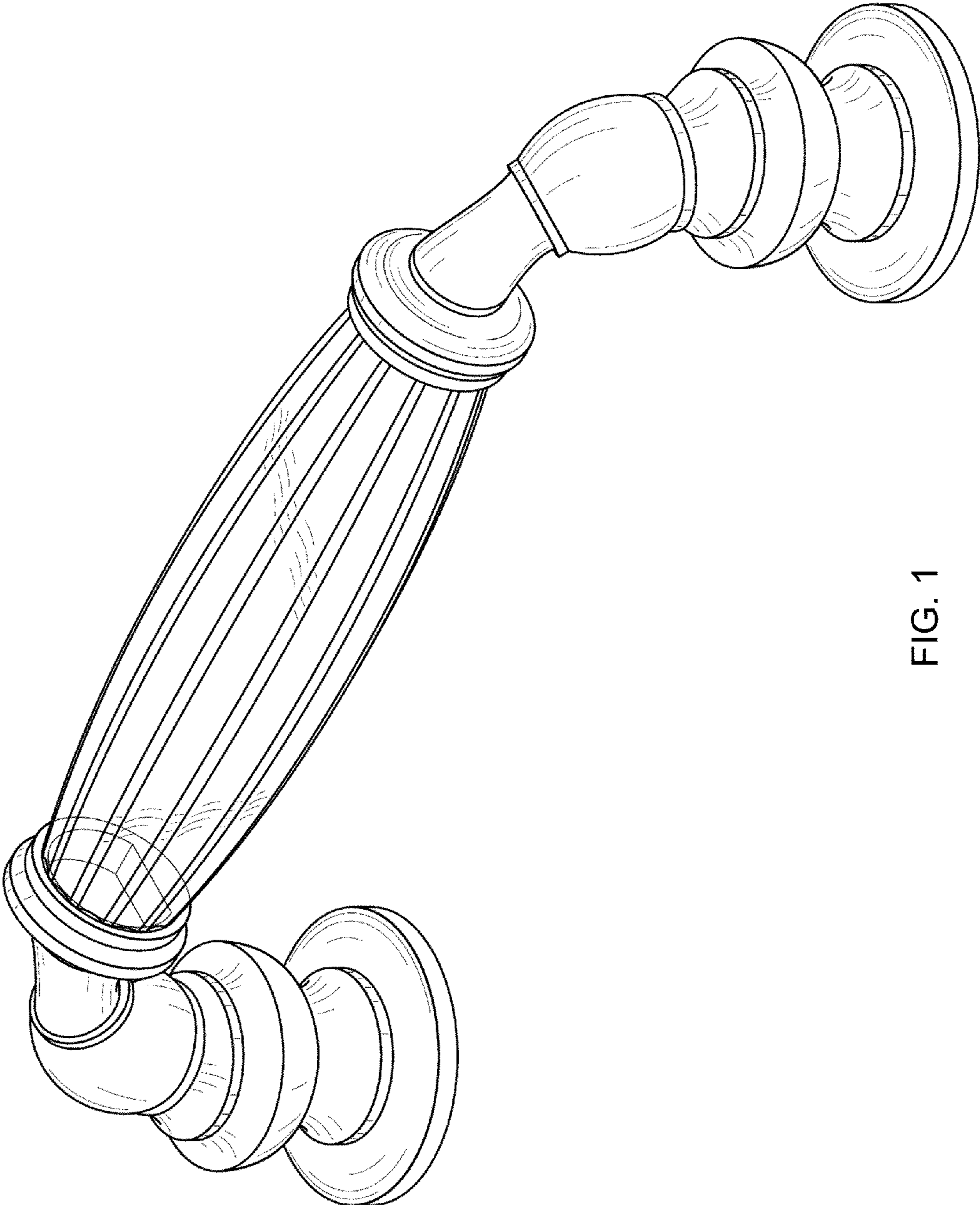

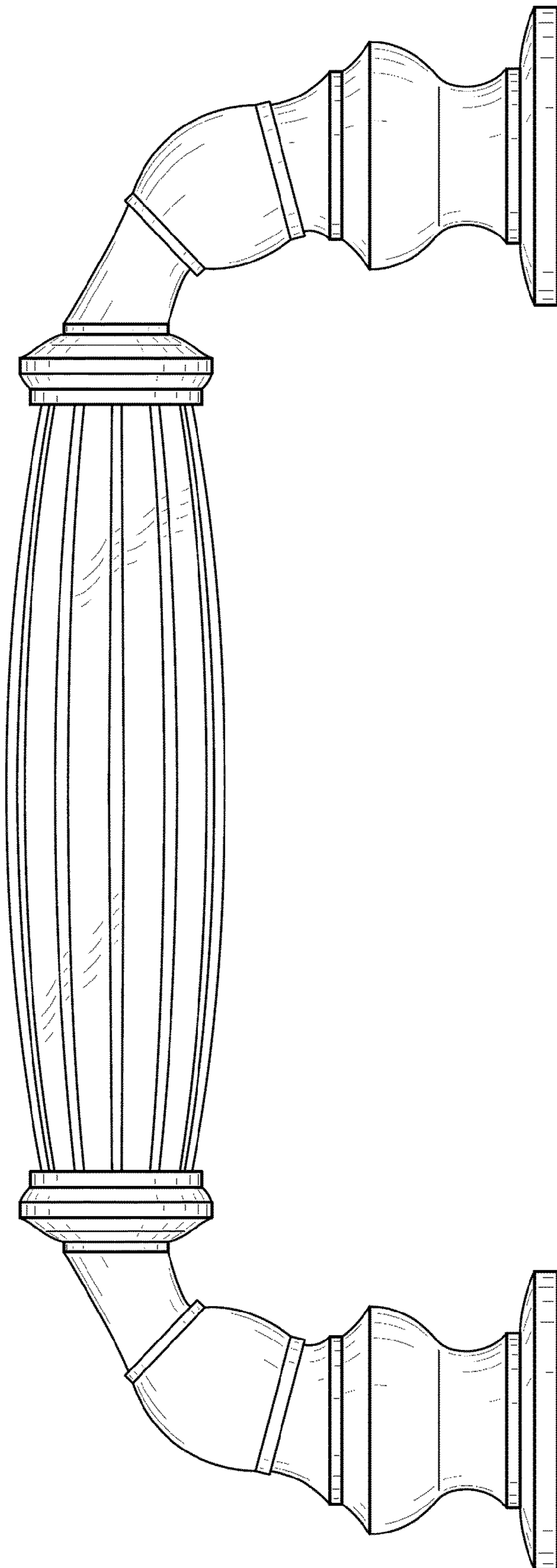

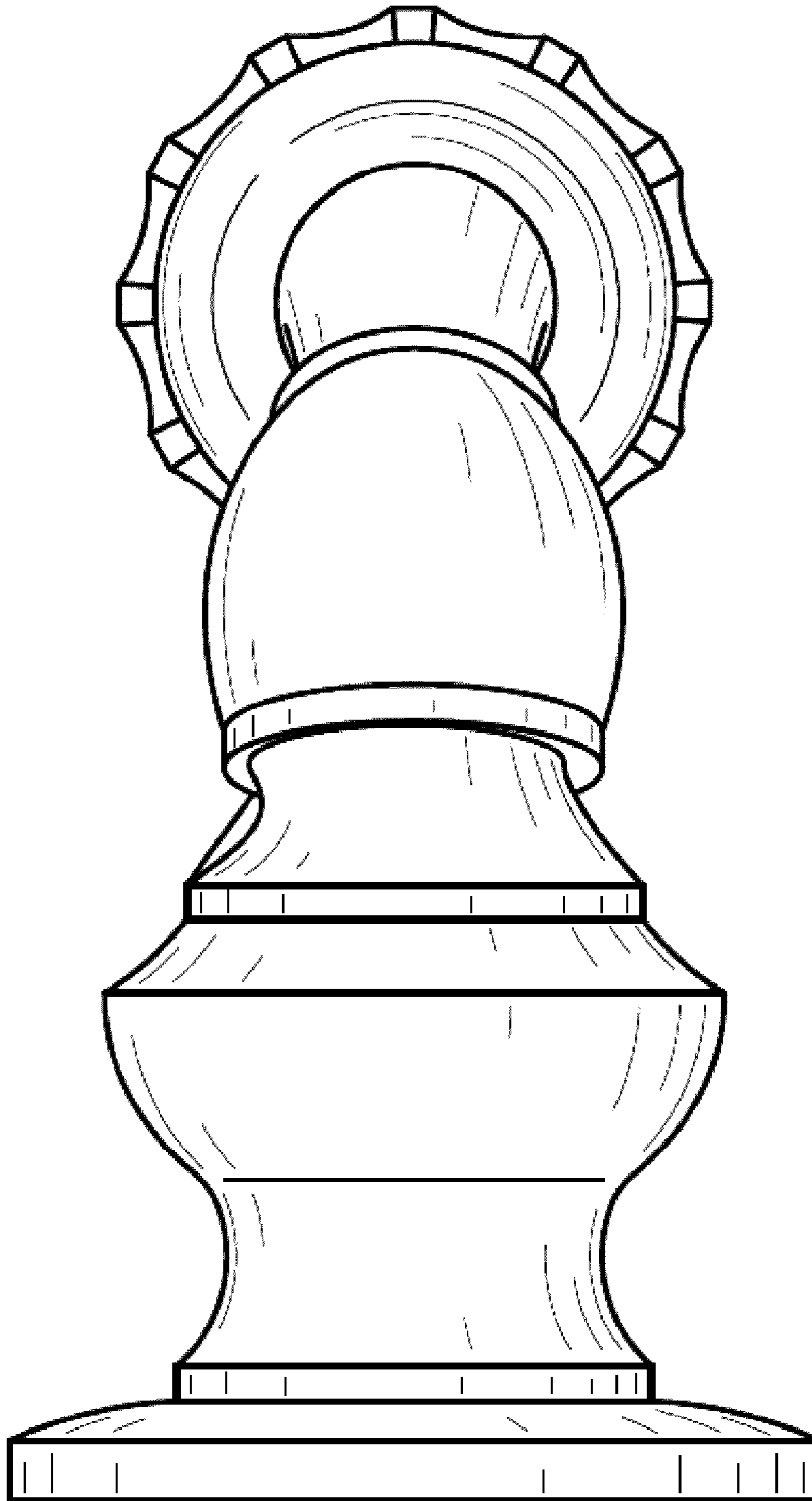

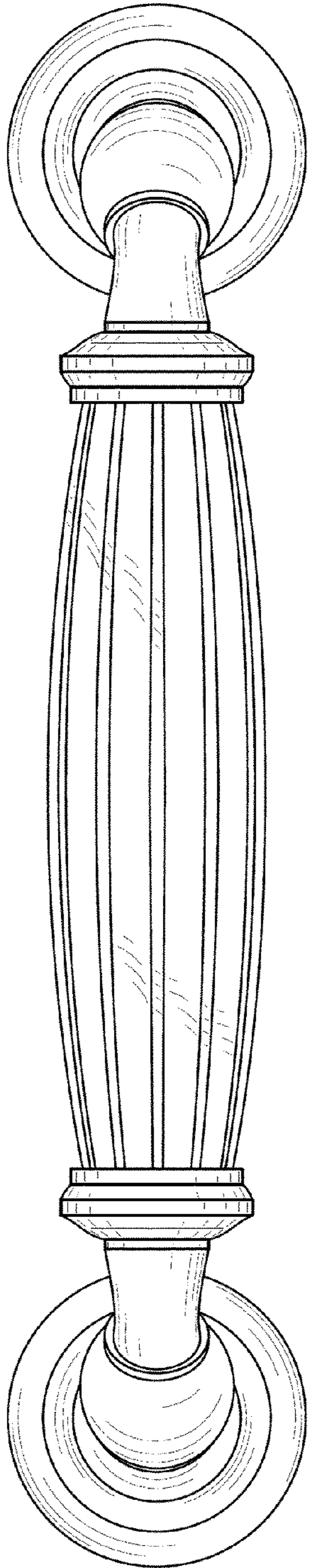

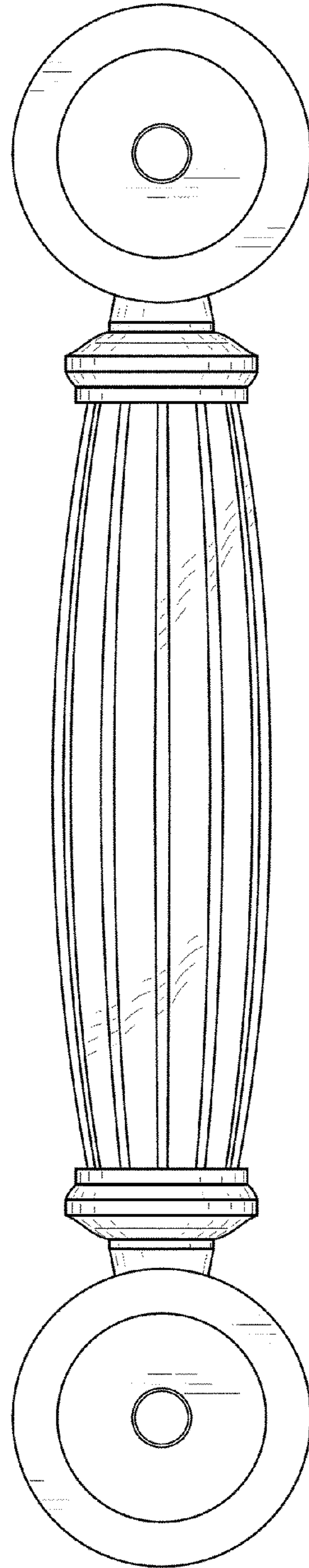
