FIG. 9 is a cross-sectional view taken along line 9-9 of FIG. 1; and,

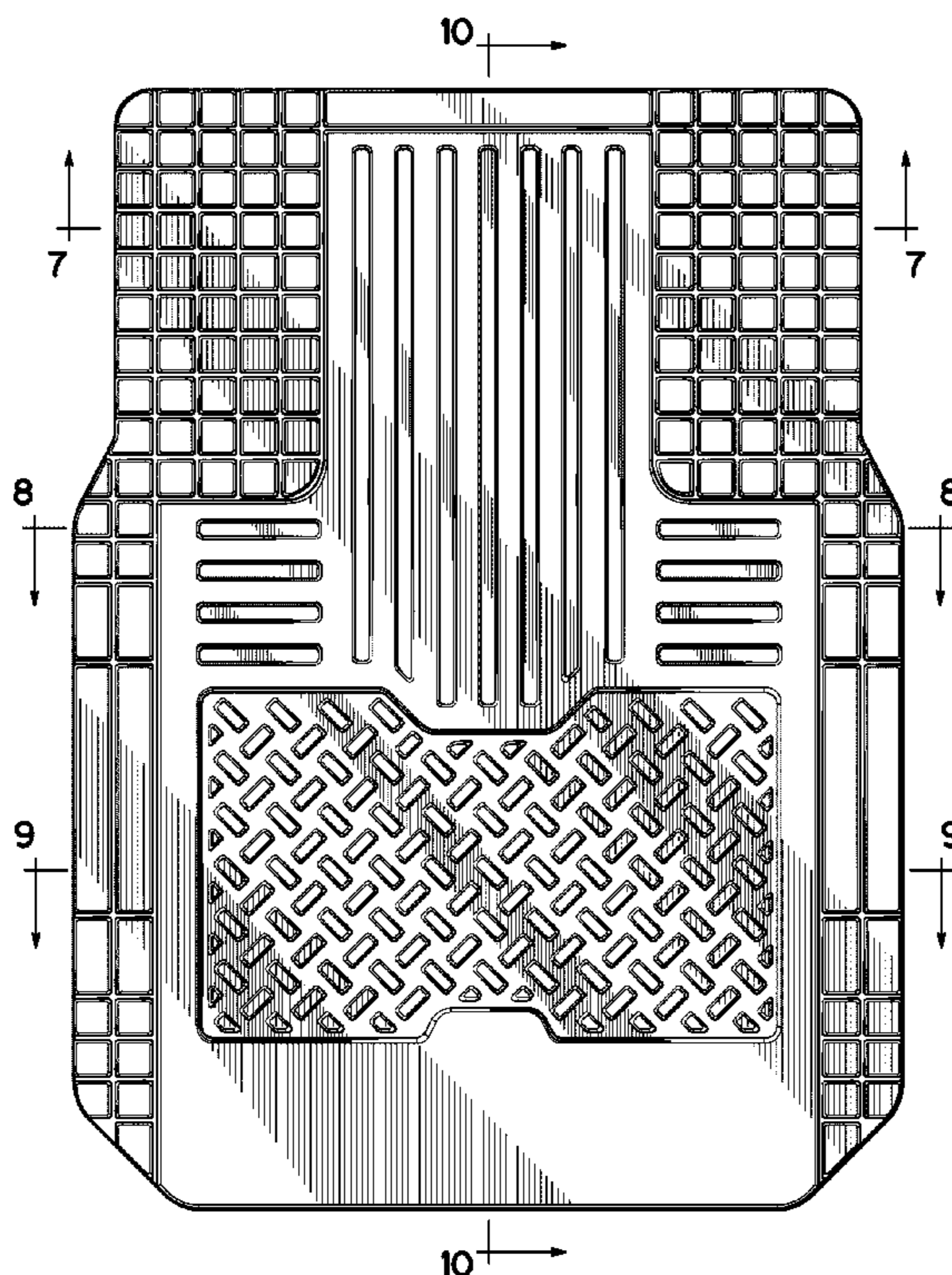
FIG. 10 is a cross-sectional view taken along line 10-10 of FIG. 1.

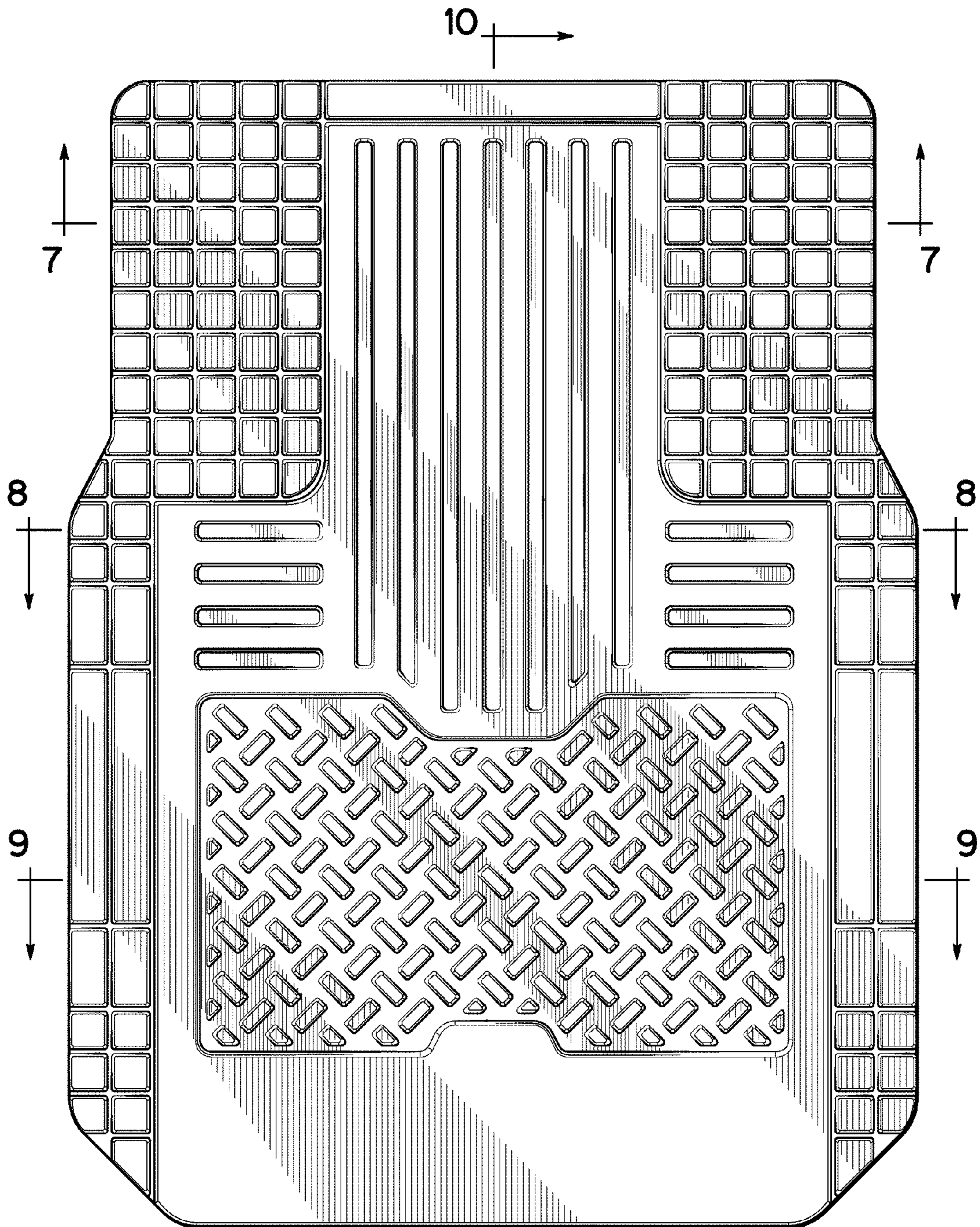

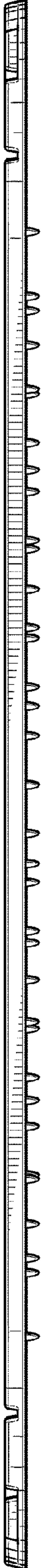

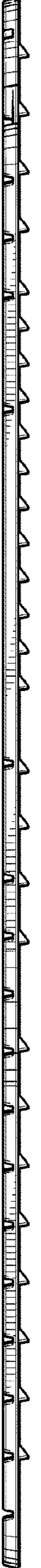

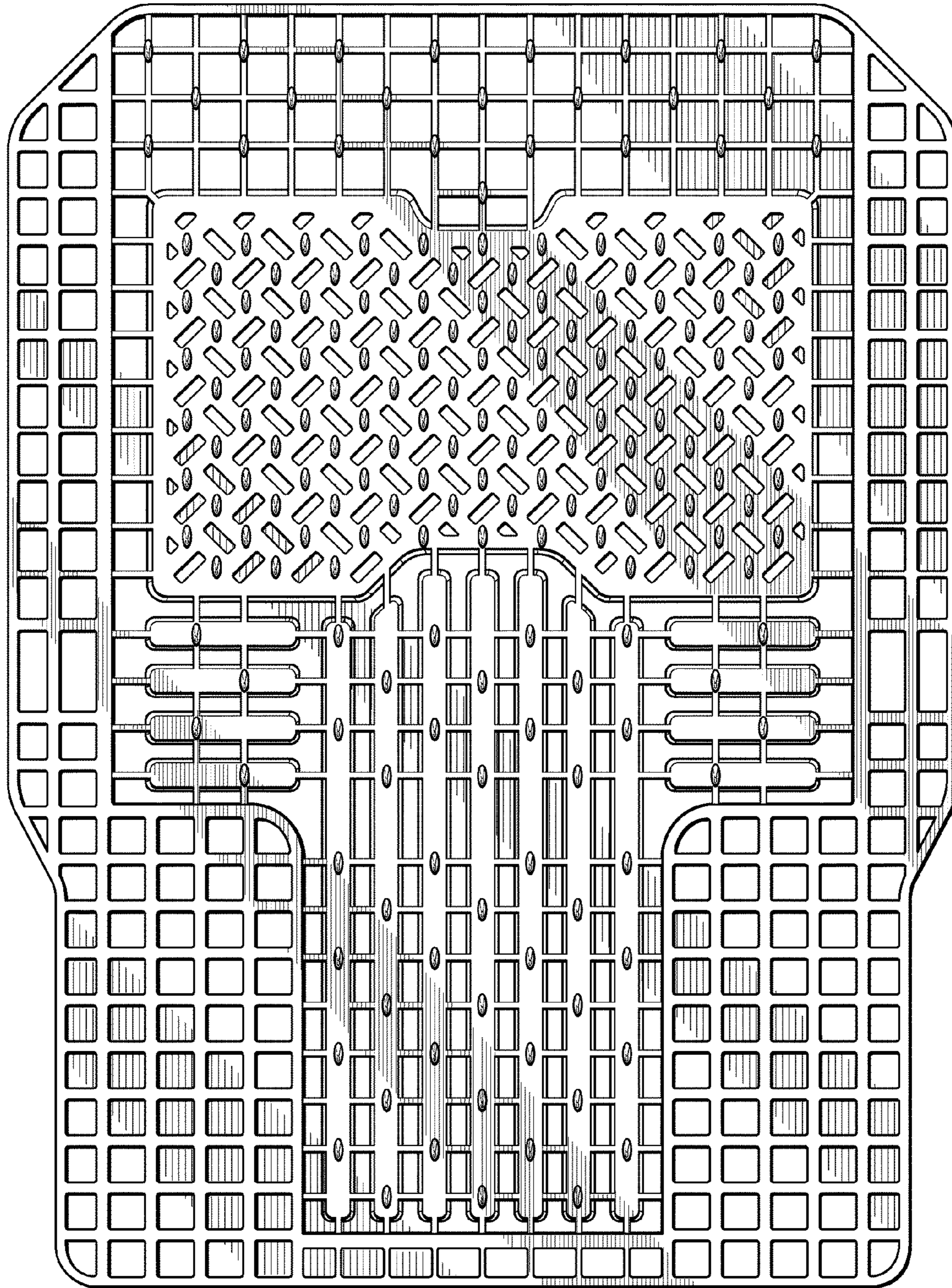
