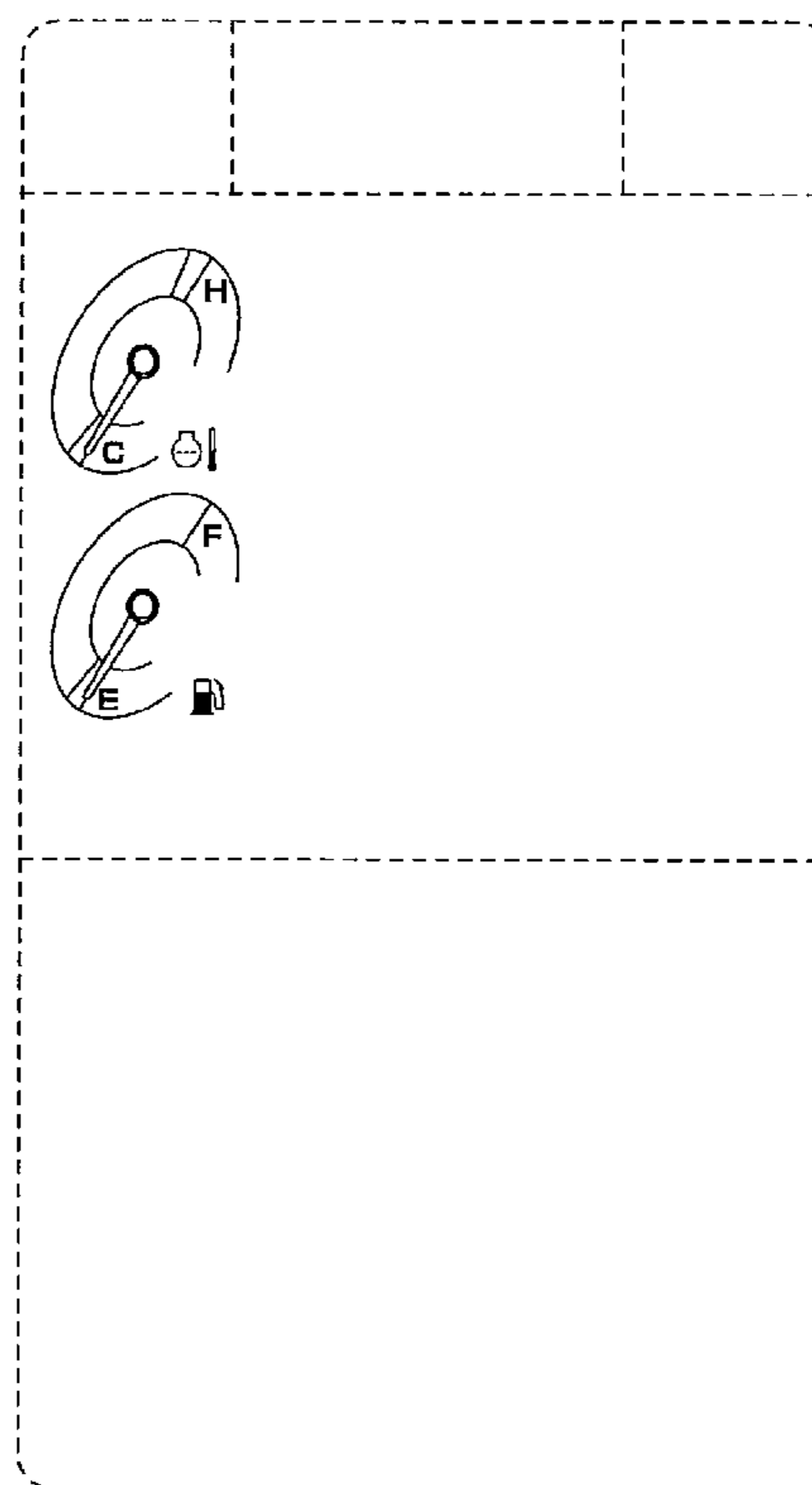
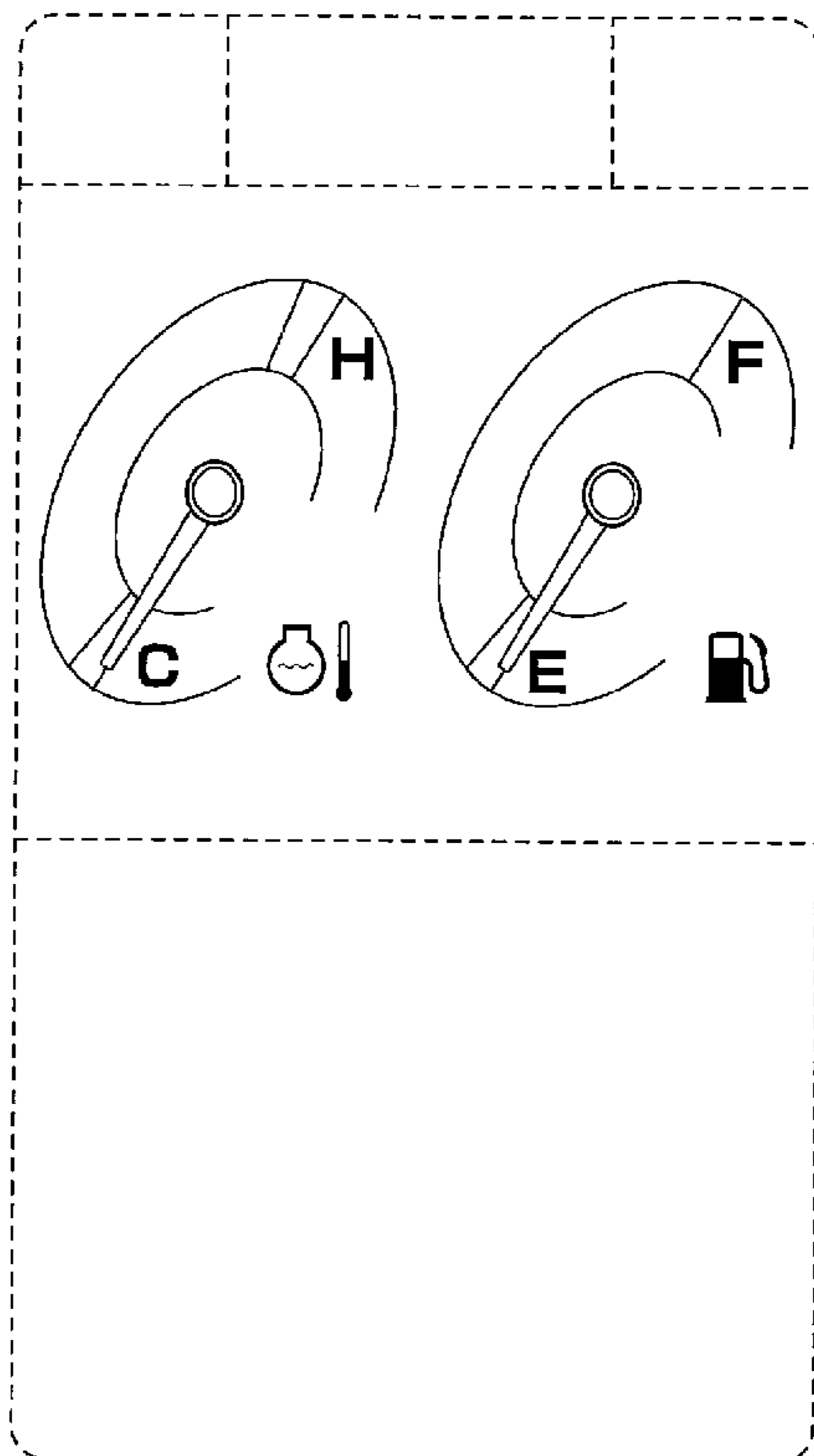
The ornamental design for a screen display for a construction machine, as shown and described.

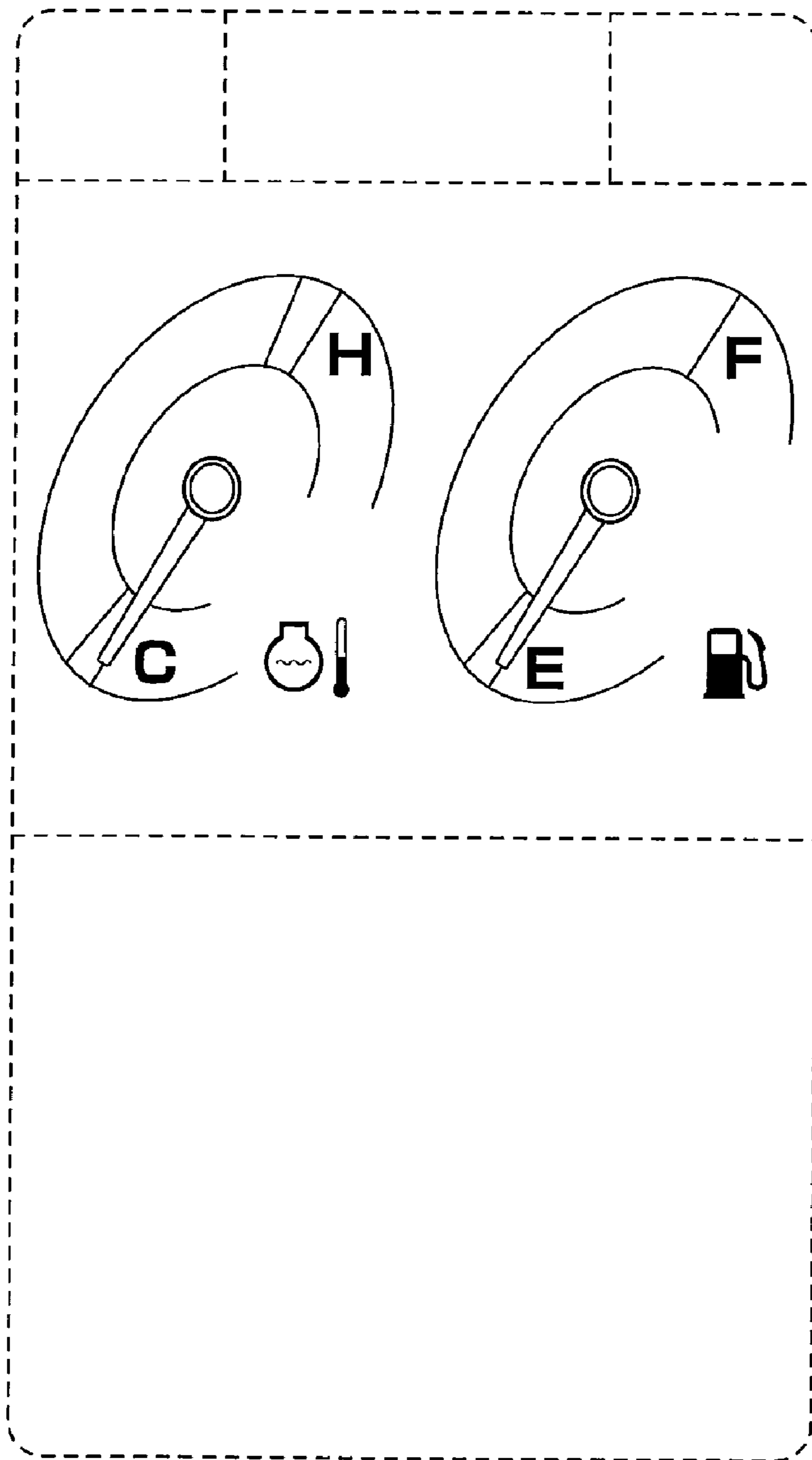

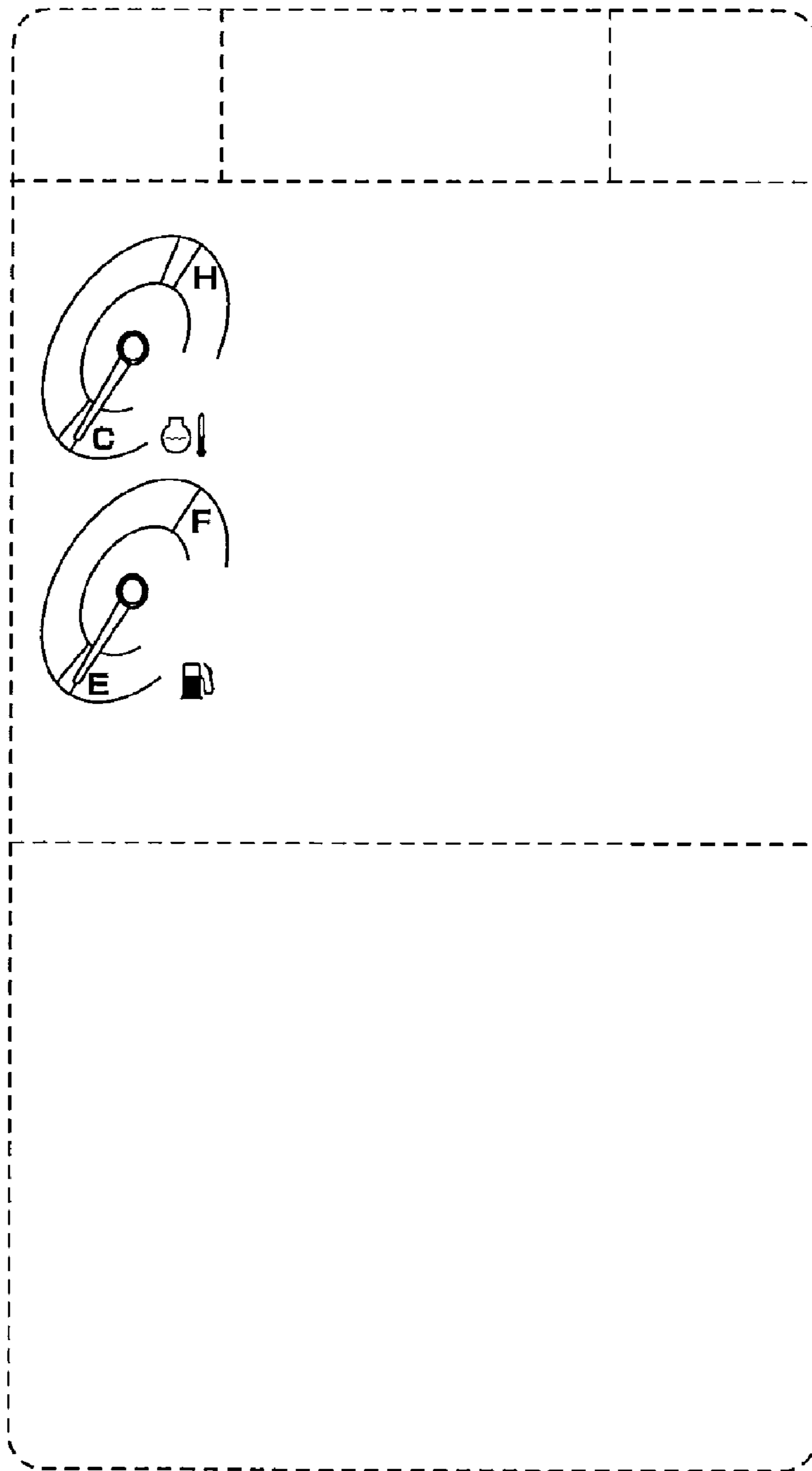
