(57) **CLAIM**

The ornamental design for a rocket pen, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the rocket pen showing my design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a left side elevational view thereof;

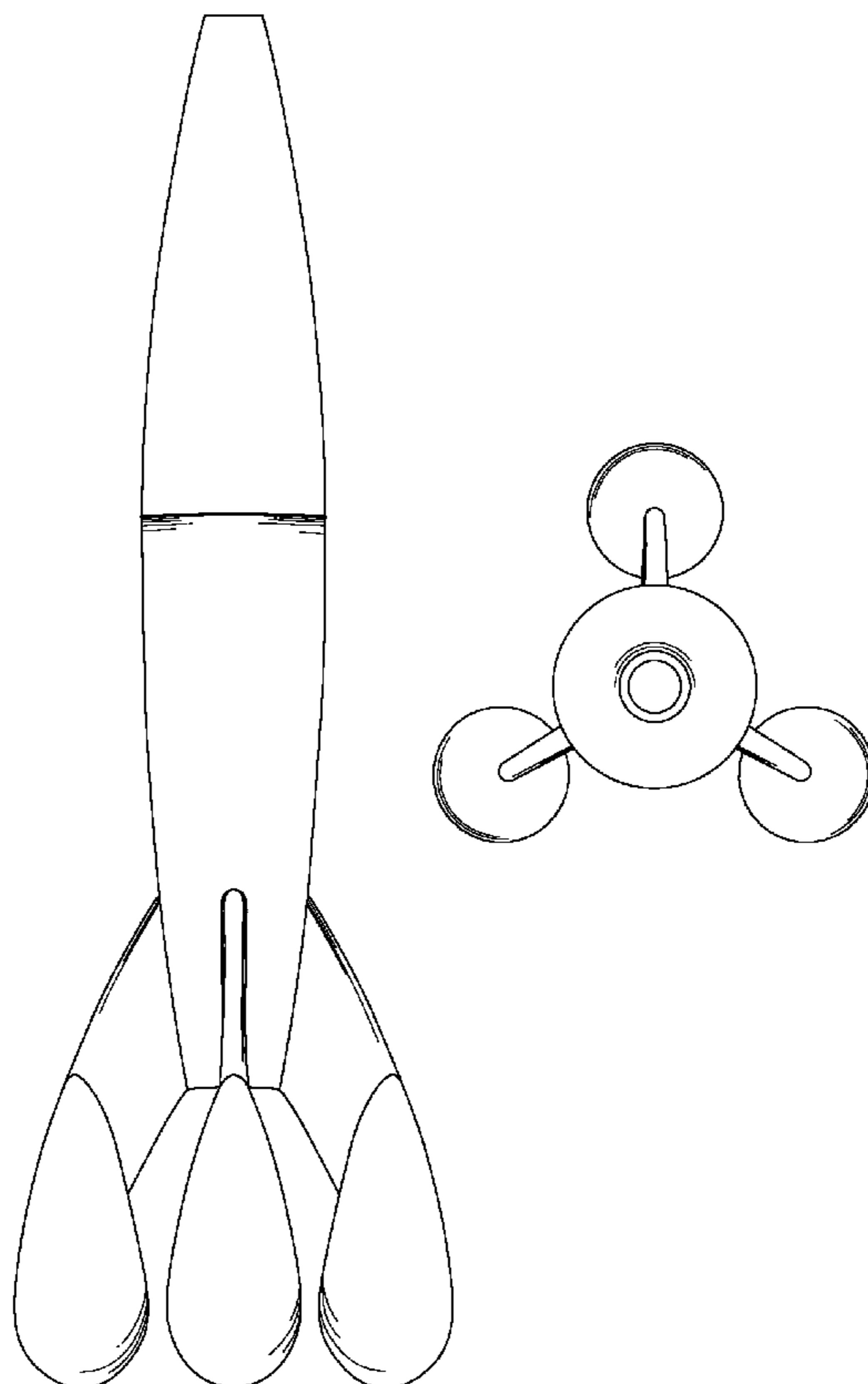
FIG. 6 is a right side elevational view thereof;

FIG. 8 is a front perspective view thereof with the writing tip shown in an extended position.

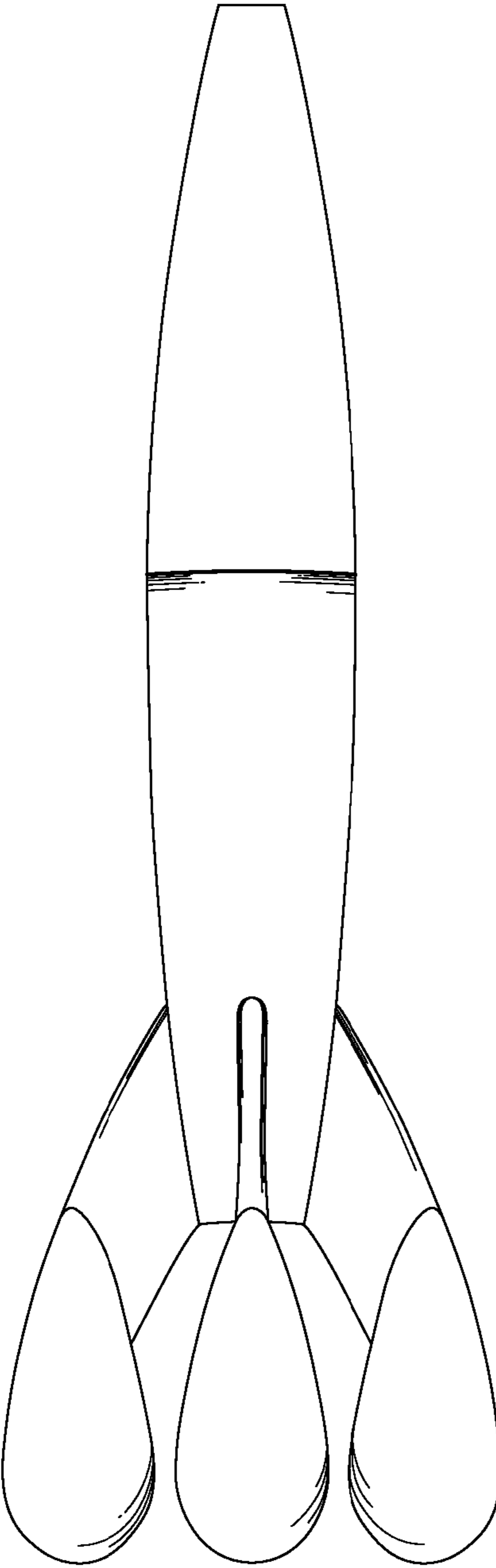

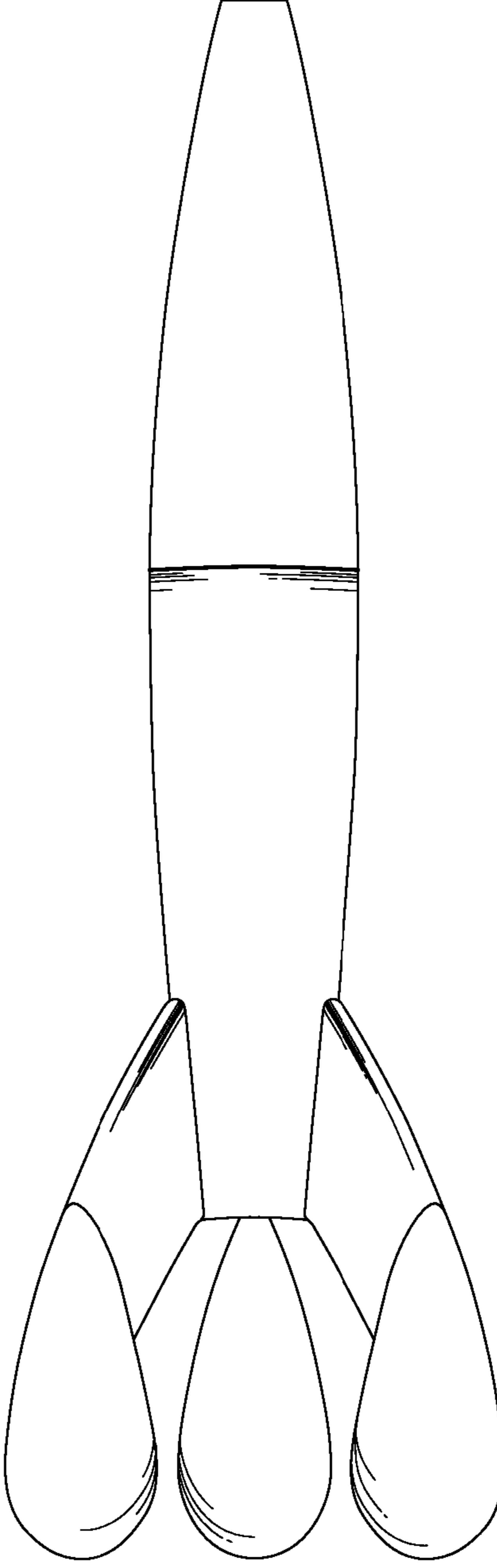

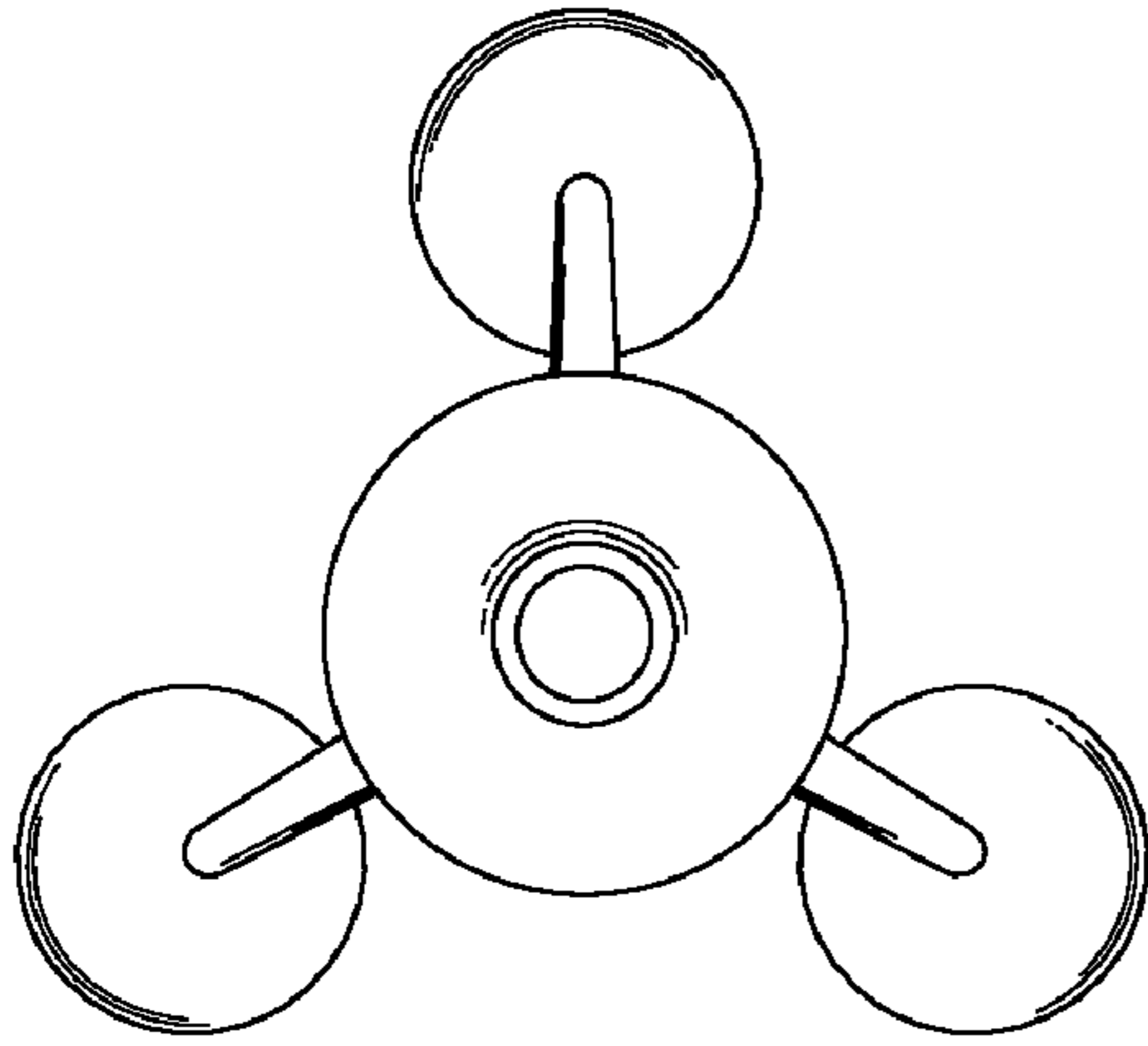

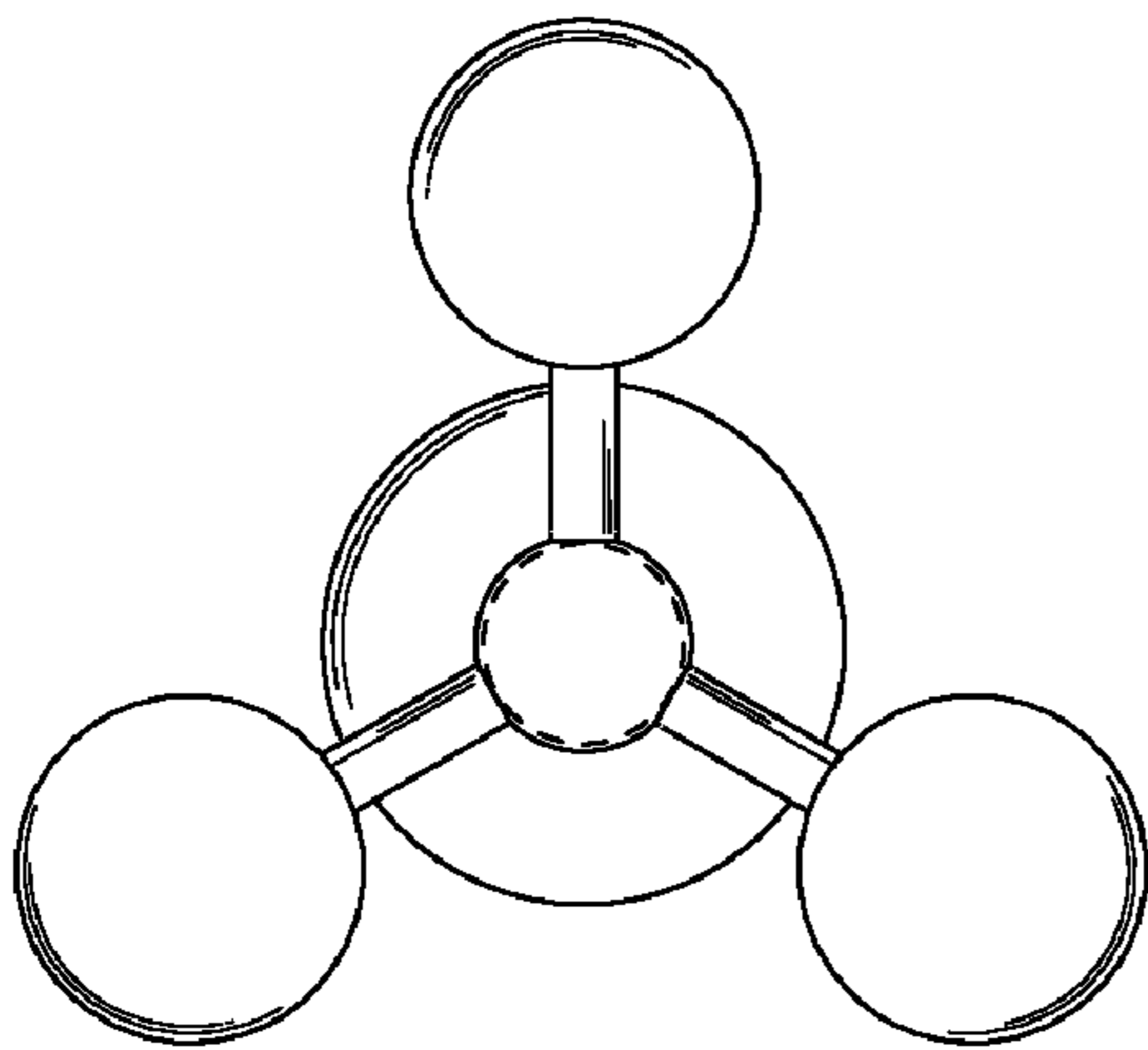

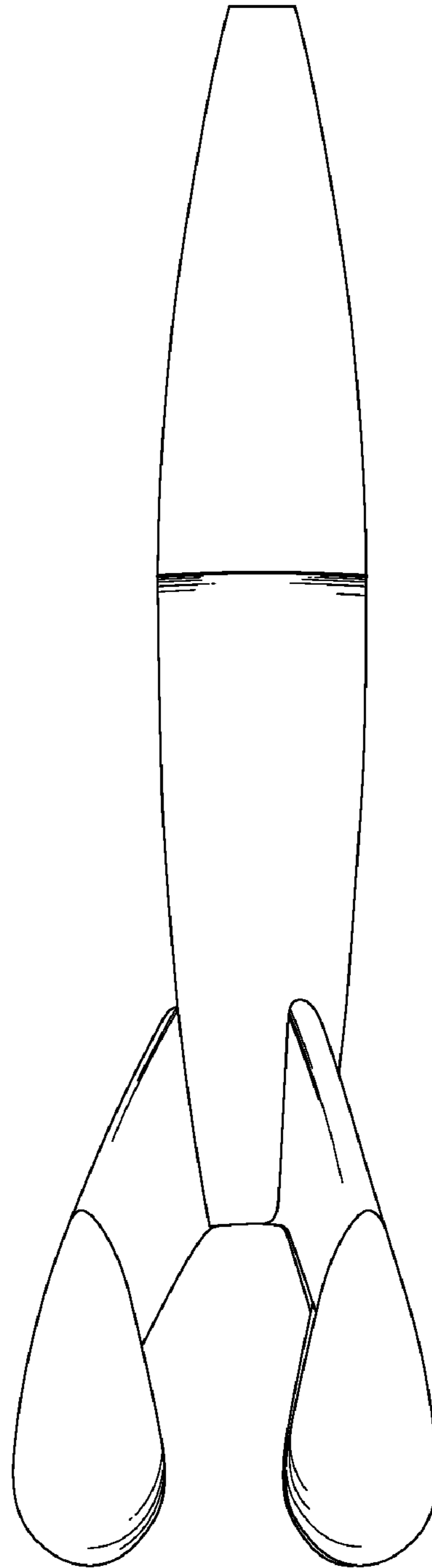

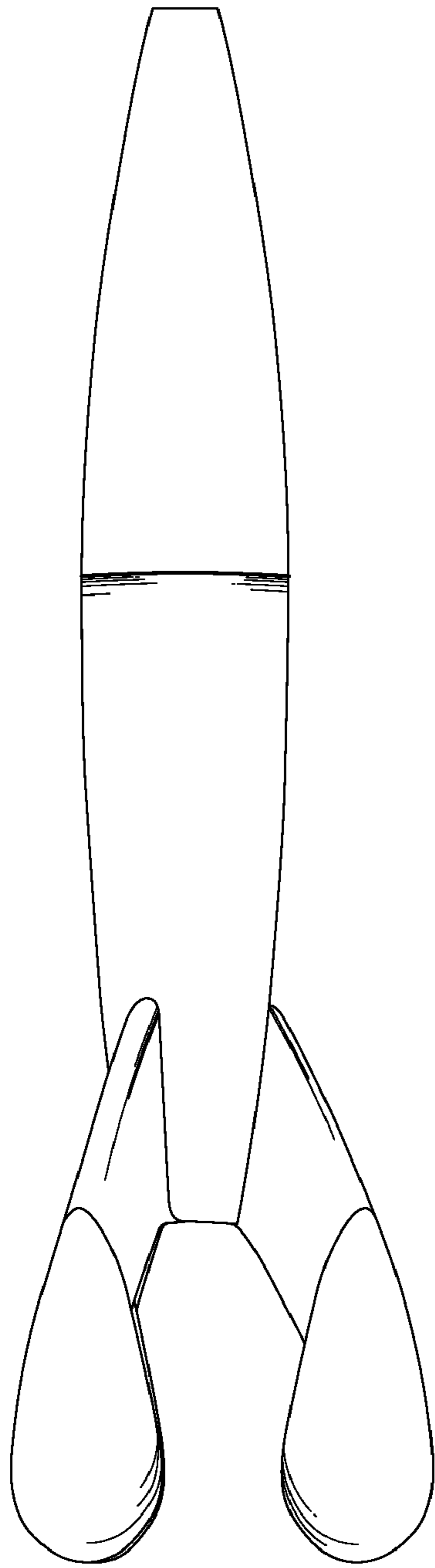

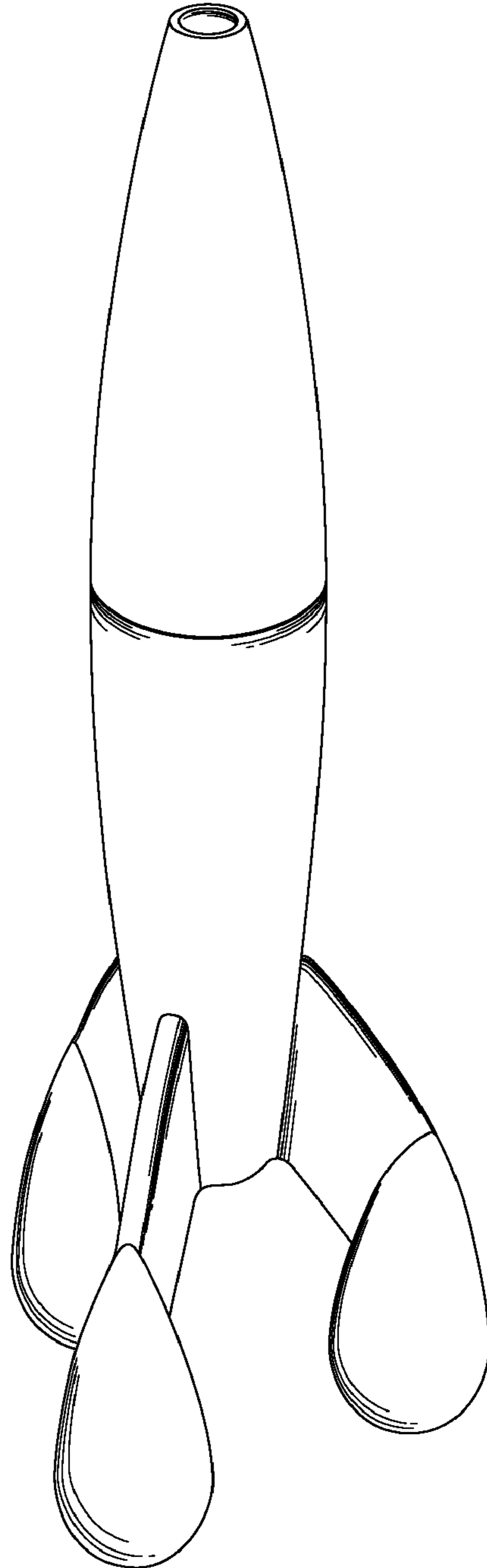

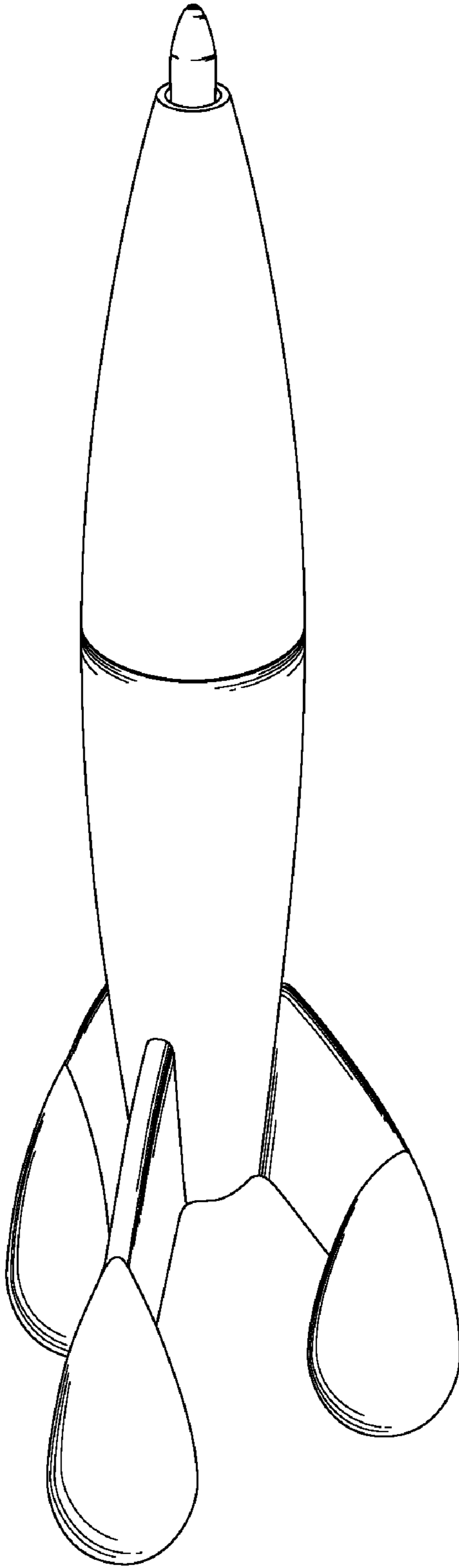
