The ornamental design for a sports jersey pencil cap, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the sports jersey pencil cap showing my new design;

FIG. 2 is a rear view of FIG. 1;

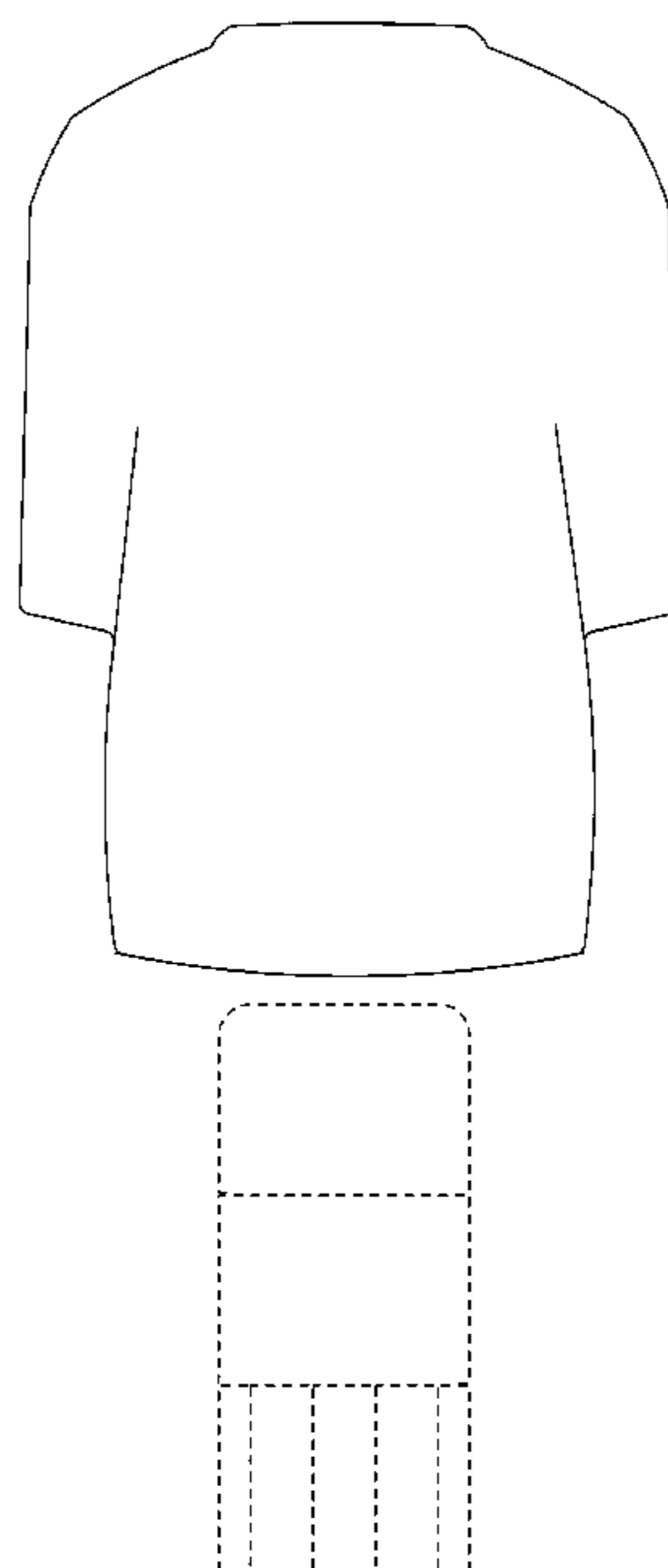
FIG. 3 is a side view of FIG. 1;

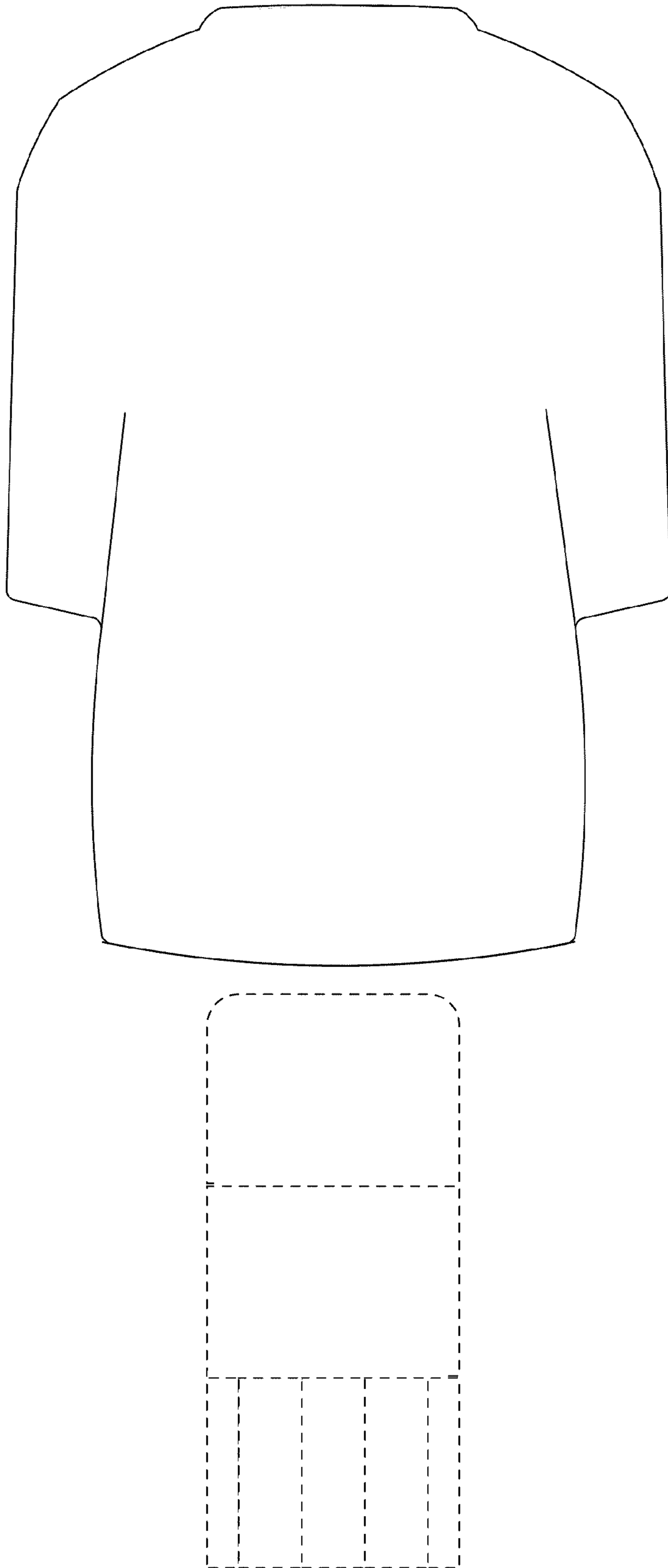

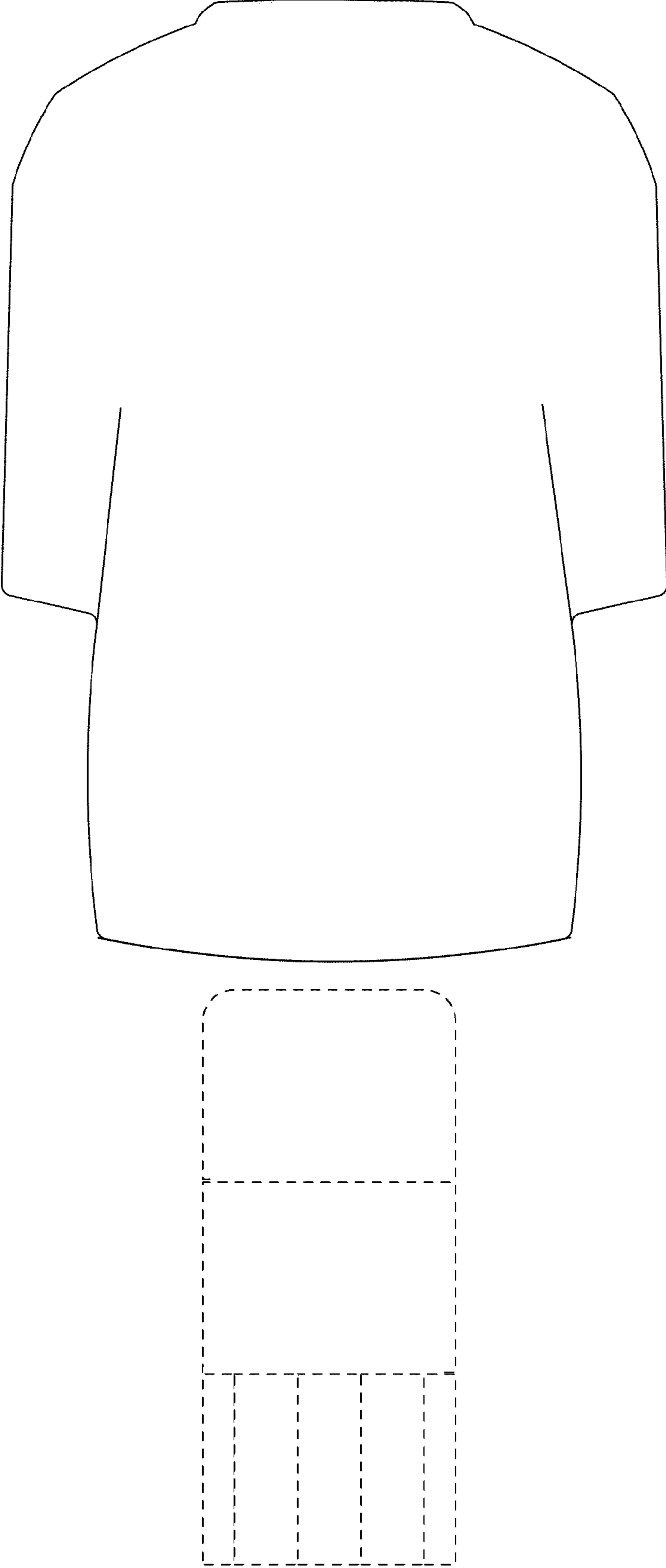

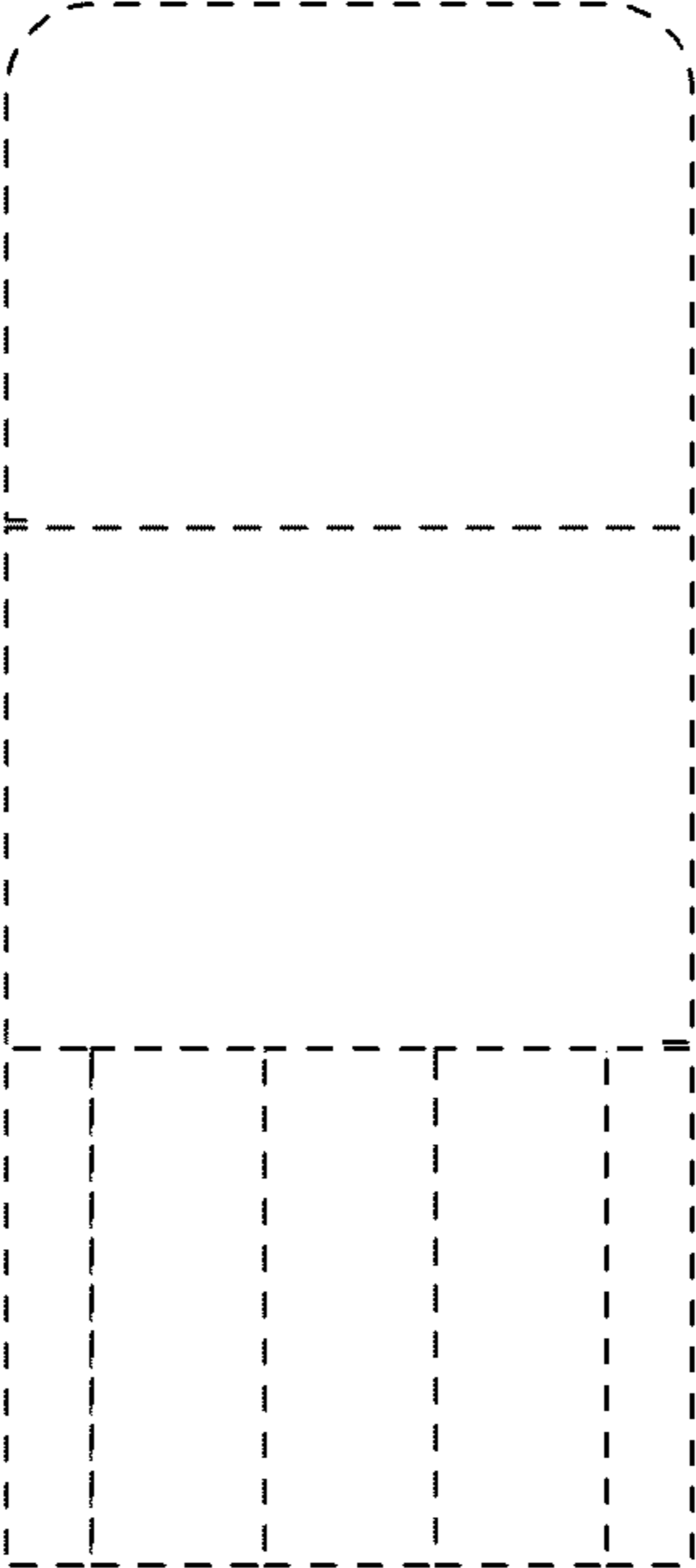
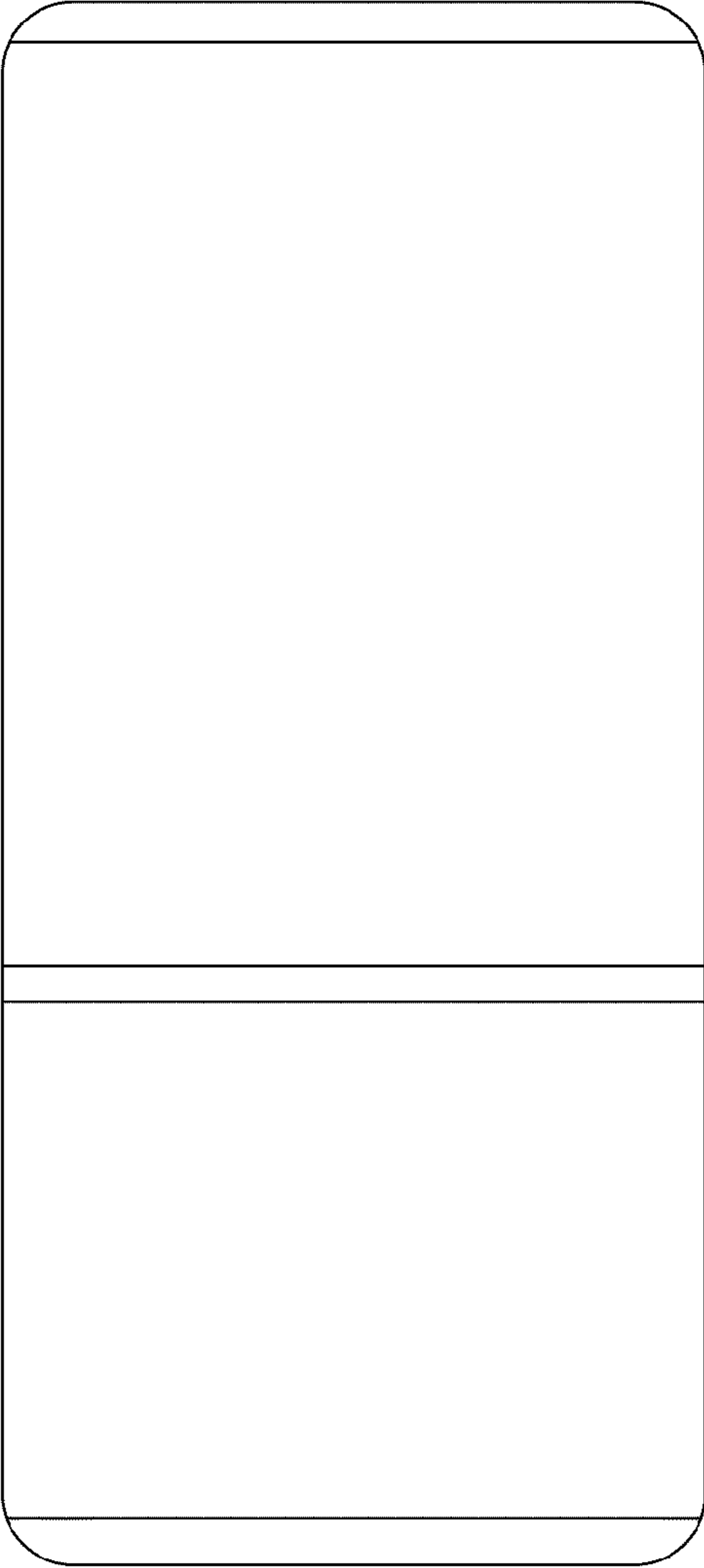

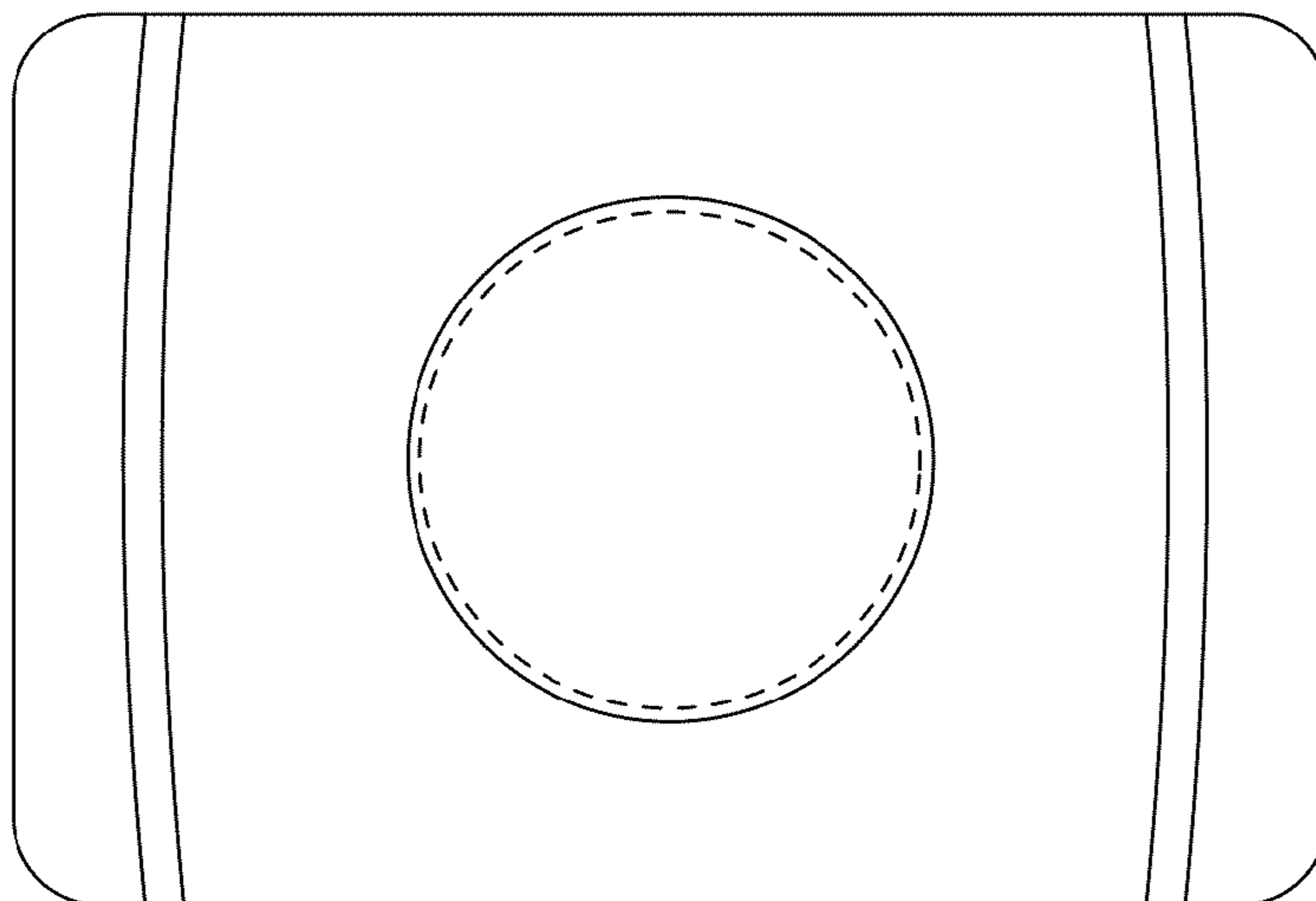

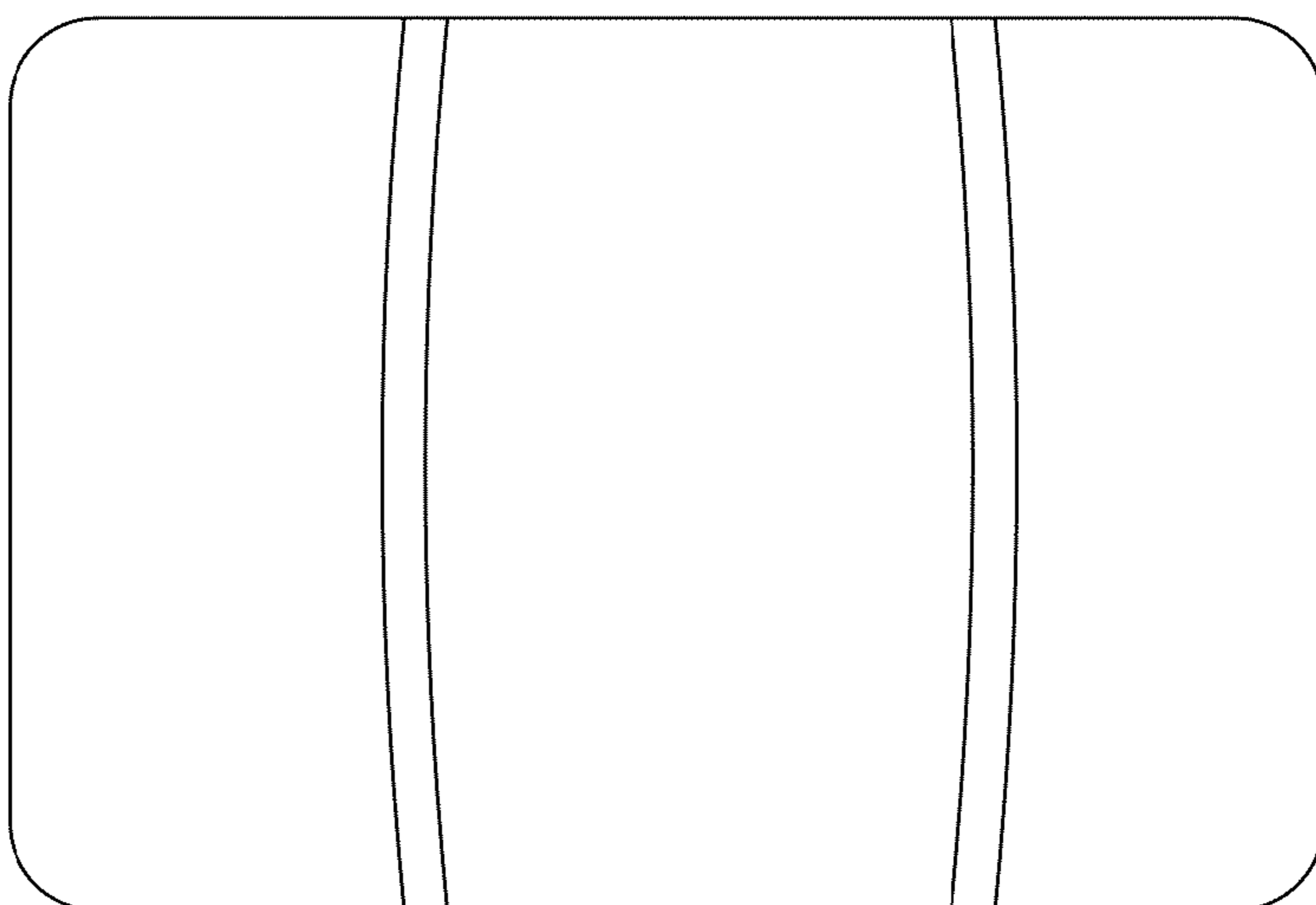
