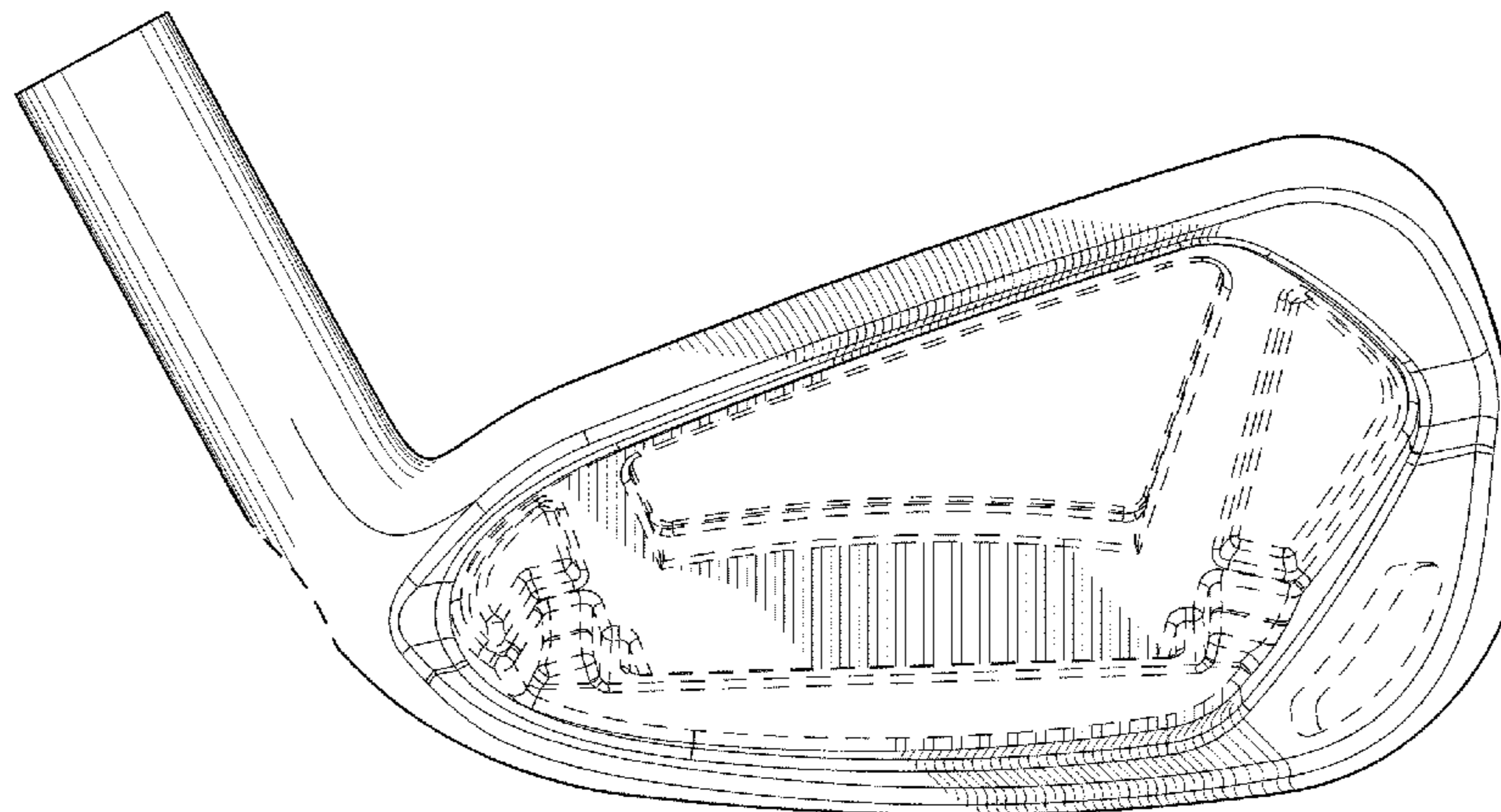
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a golf club head; FIG. 2 is a bottom perspective view of the golf club head of FIG. 1; FIG. 3 is a front elevational view of the golf club head of FIG. 1; FIG. 4 is a rear elevational view of the golf club head of FIG. 1; FIG. 5 is a top view of the golf club head of FIG. 1; FIG. 6 is a bottom view of the golf club head of FIG. 1; FIG. 7 is a left side view of the golf club head of FIG. 1; and, FIG. 8 is a right side view of the golf club head of FIG. 1. The broken lines shown in one or more of the figures are for illustrative purposes only and form no part of the claimed design.

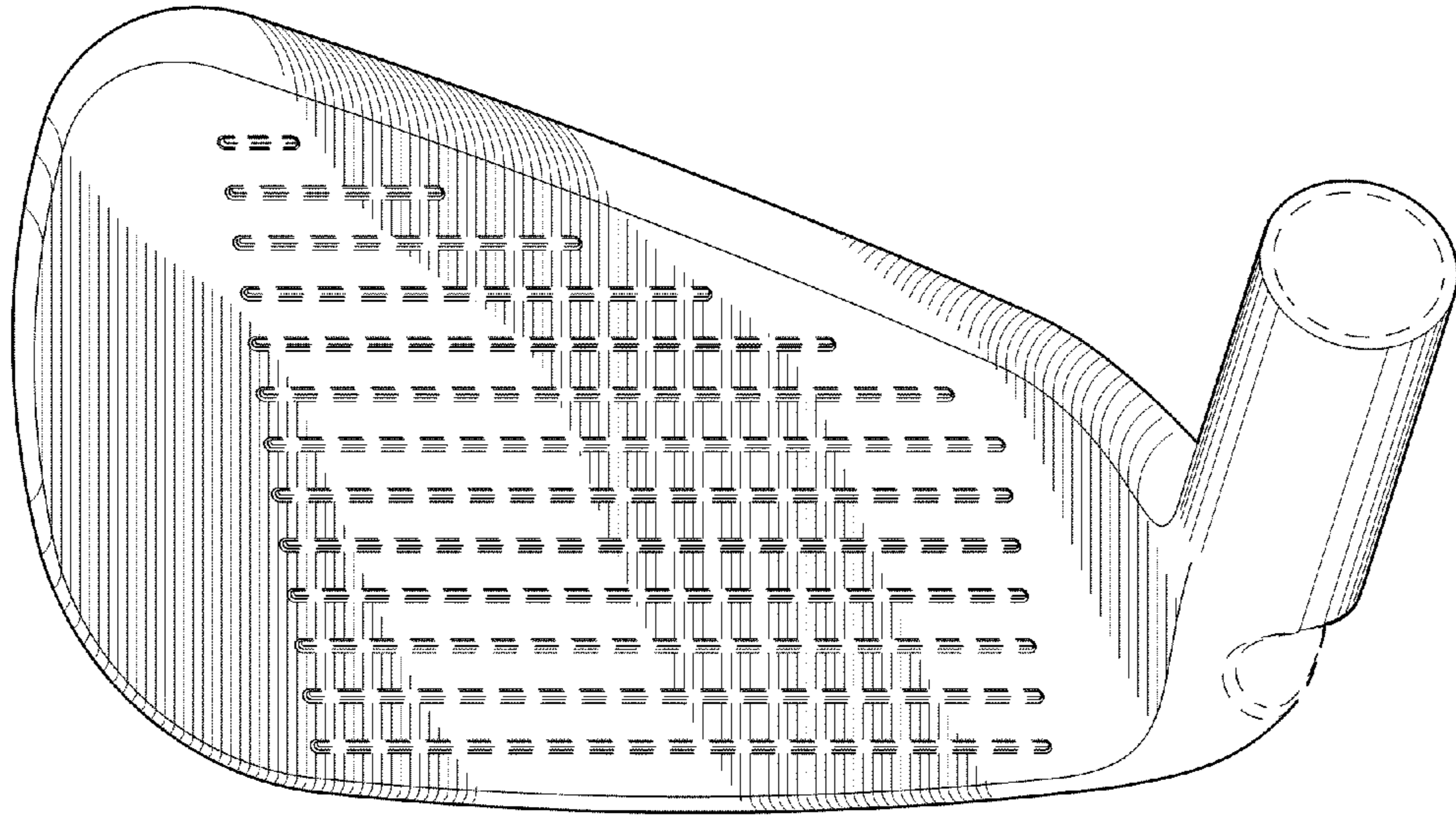

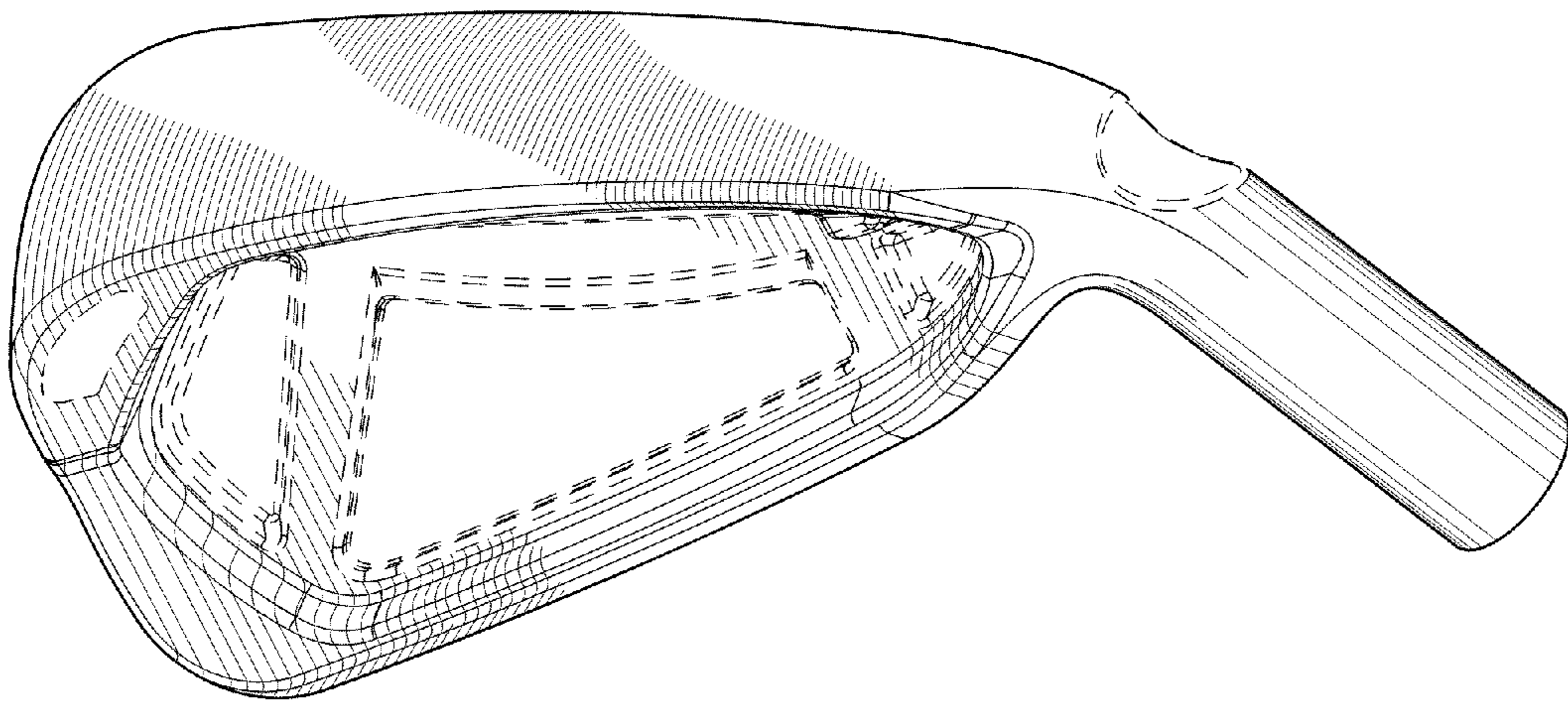

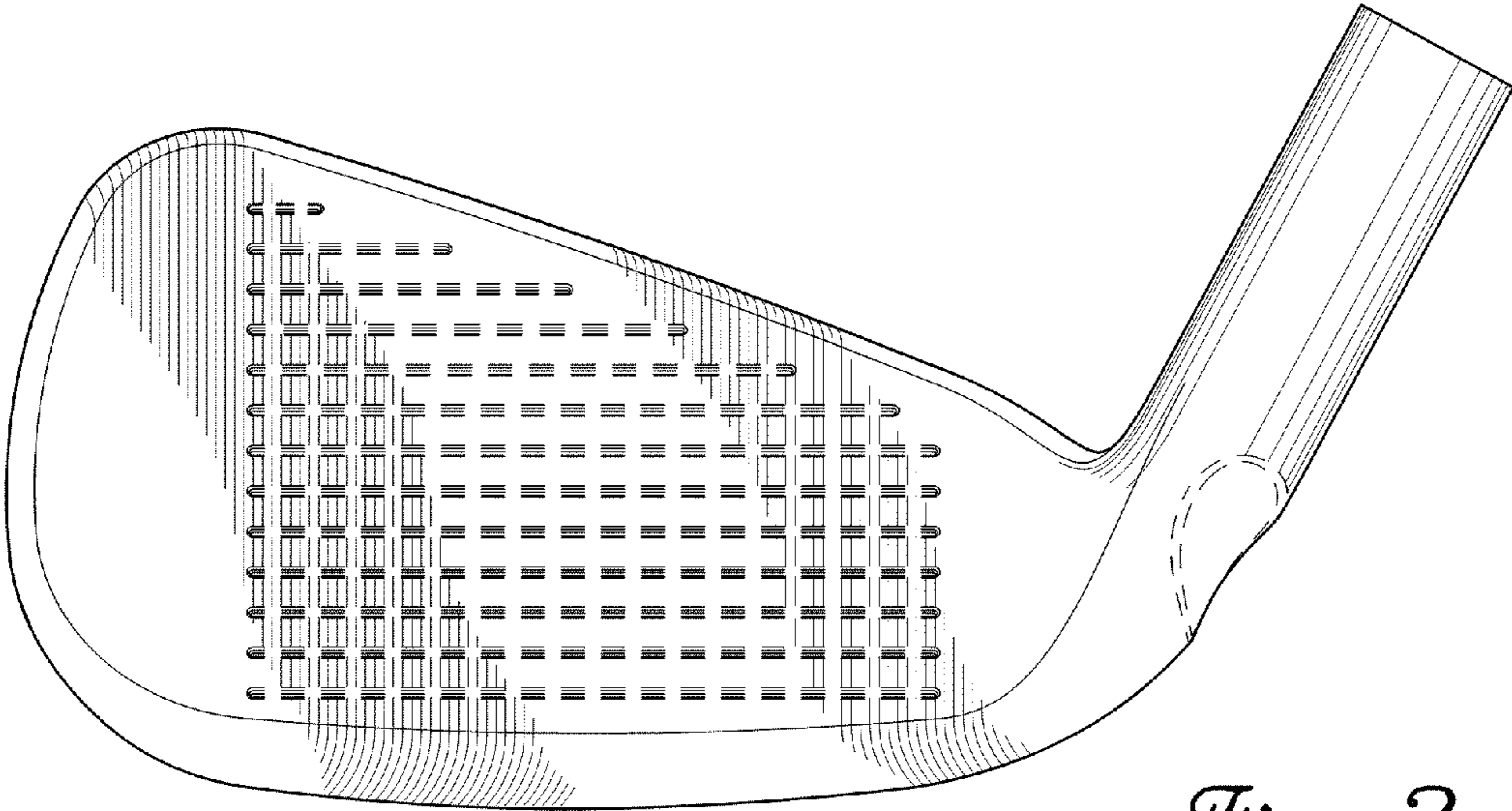

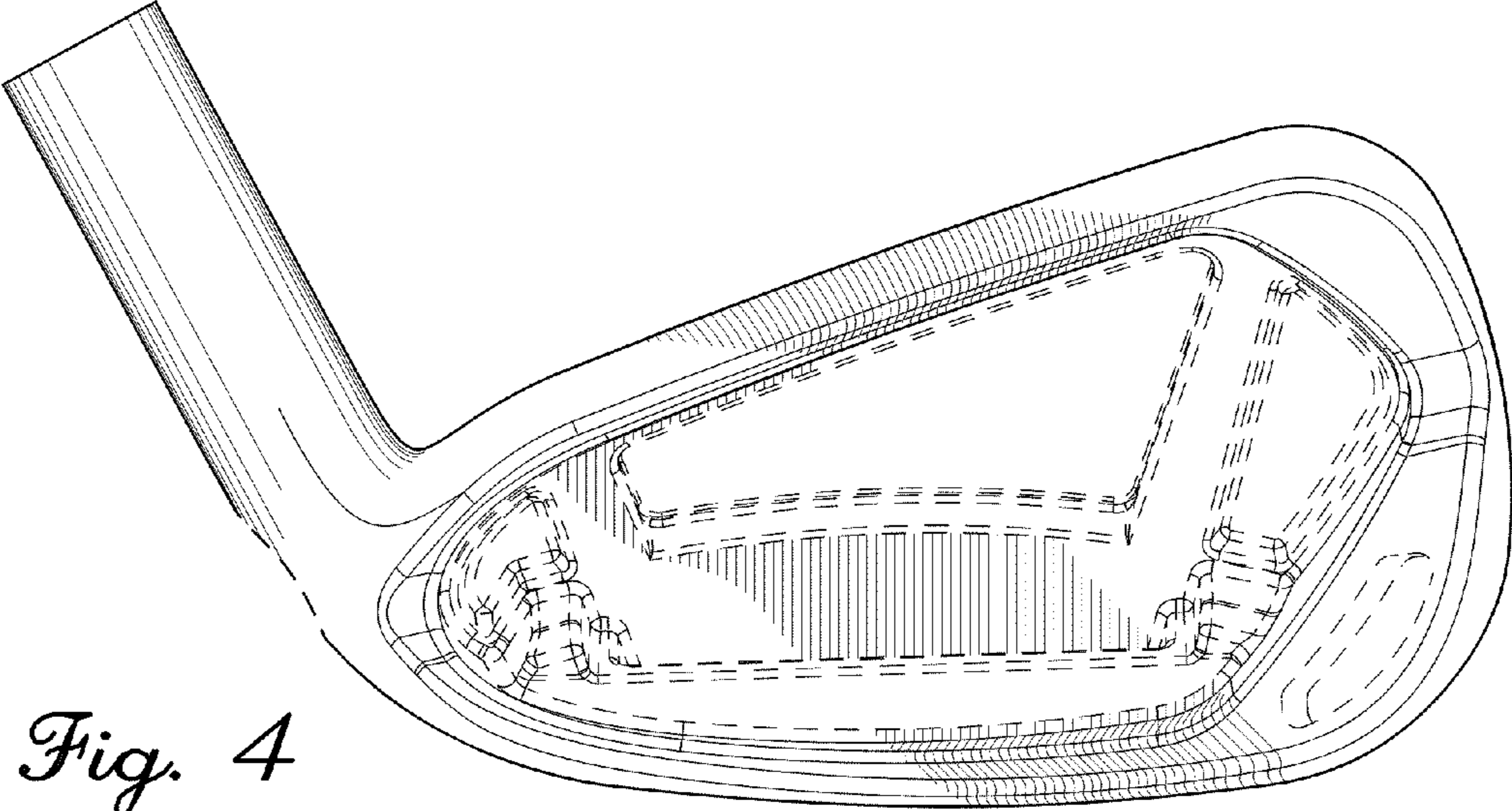

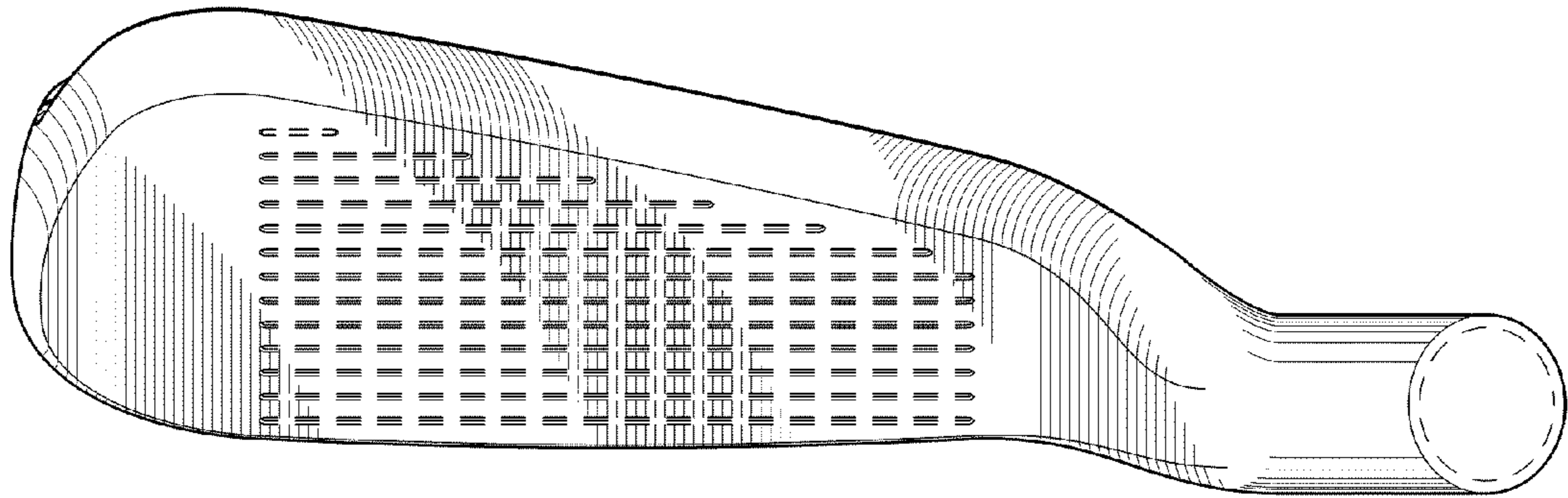

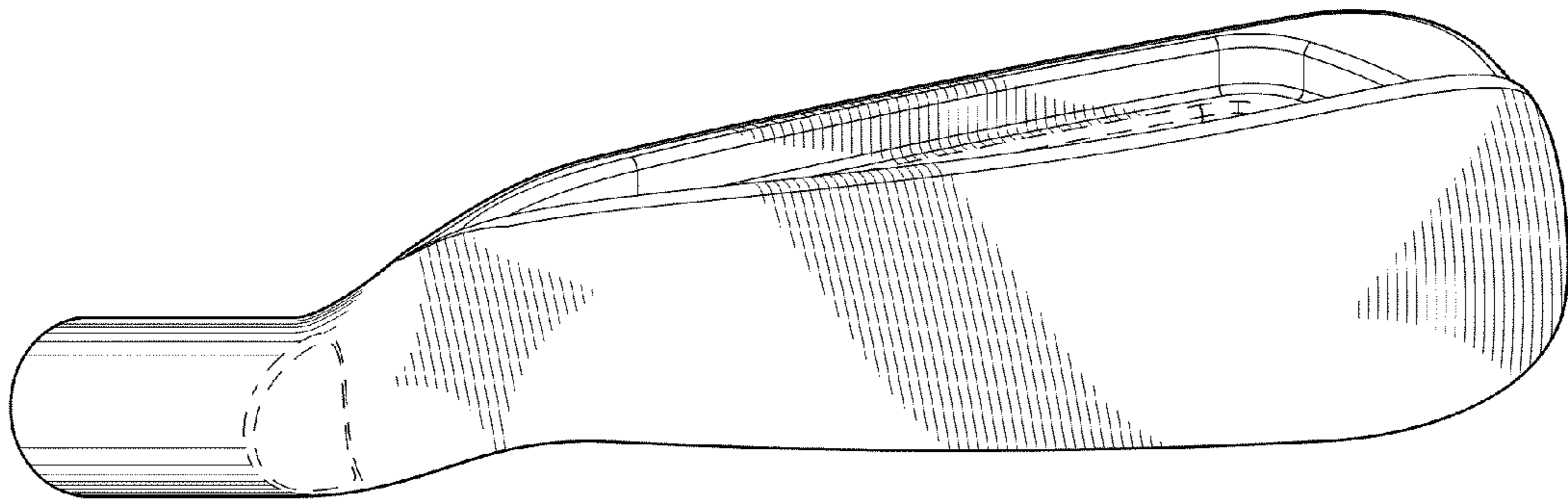

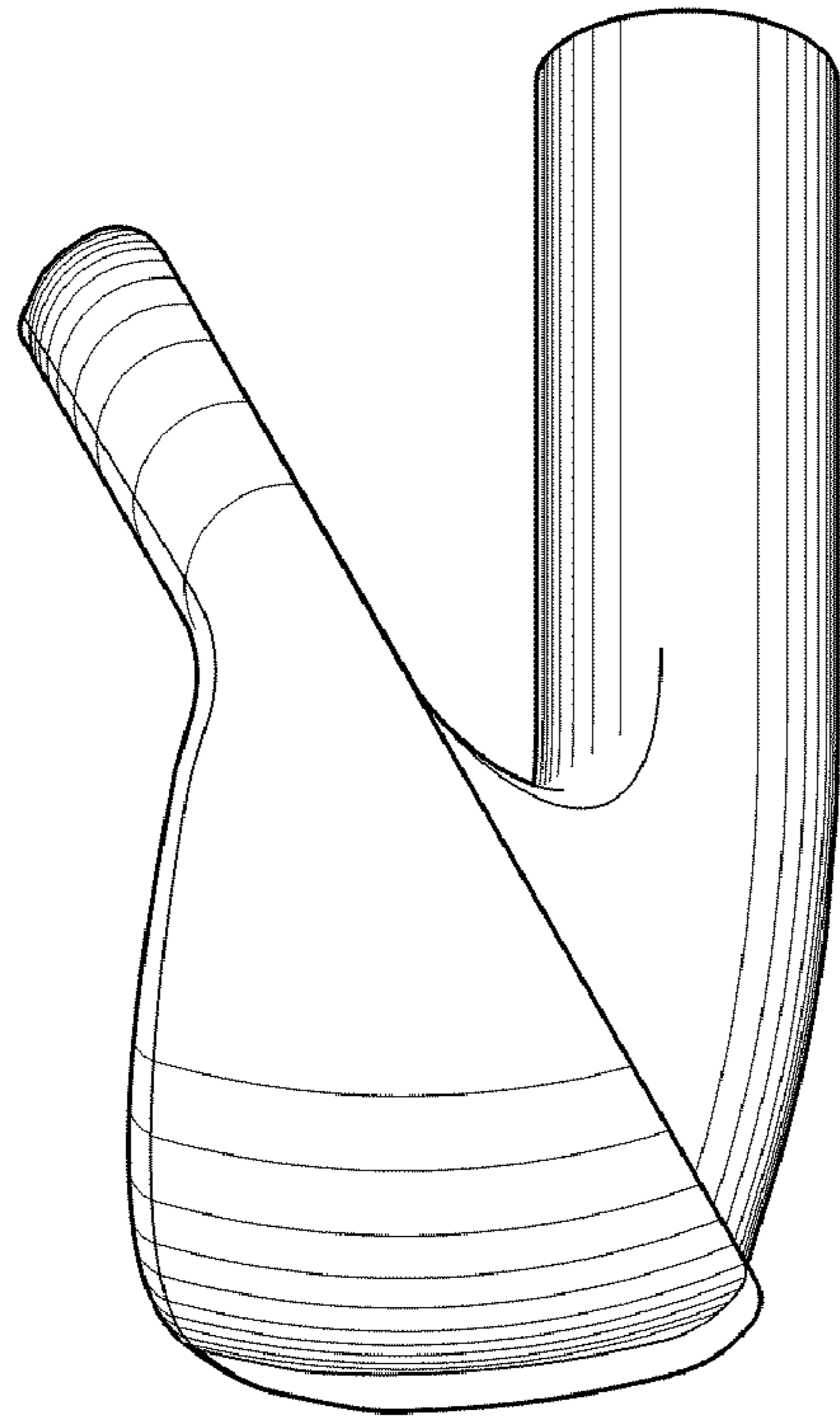

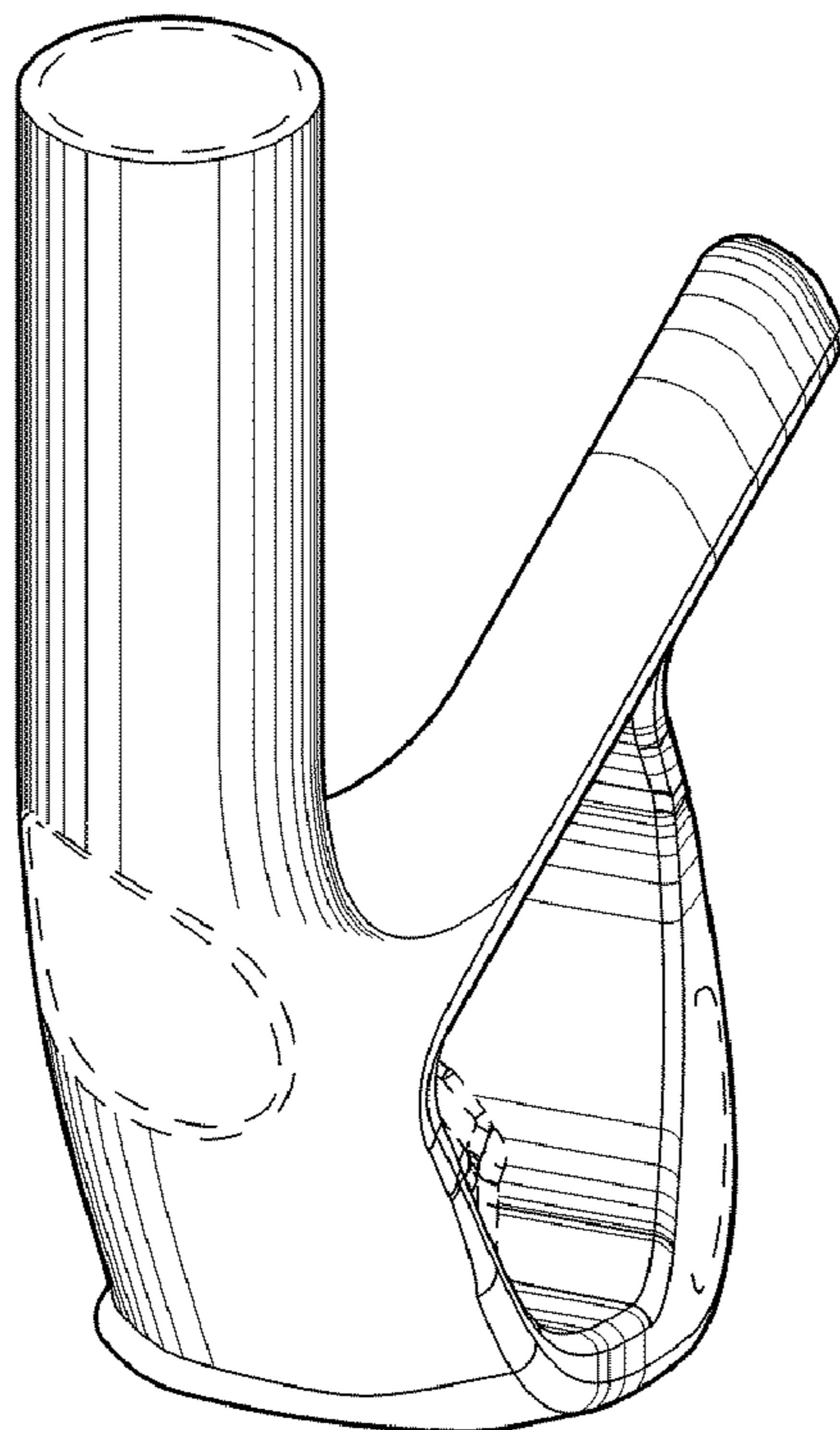
