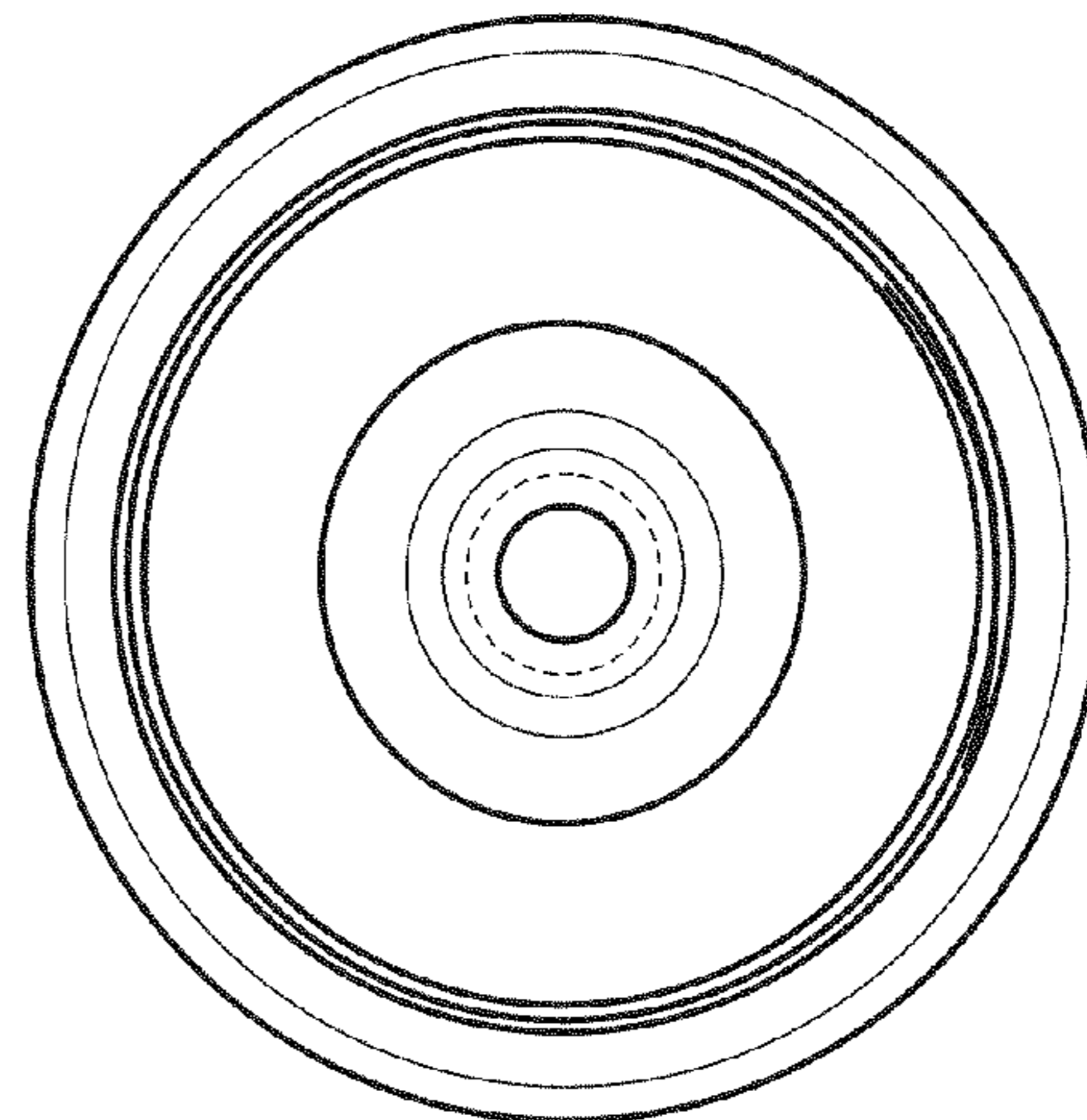
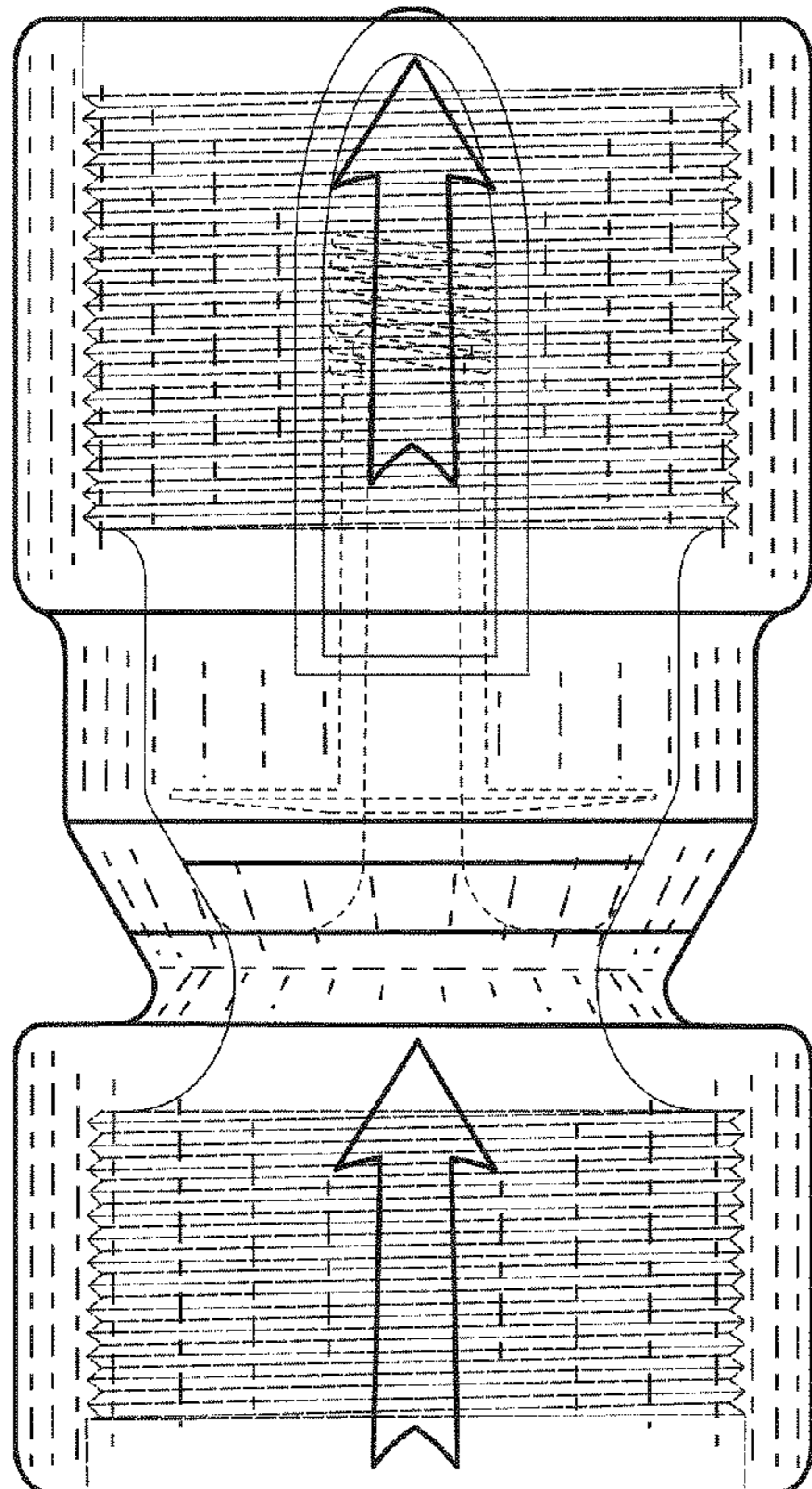
(57) **CLAIM**

I claim the ornamental design for a check valve with contoured body, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a check valve with contoured body, showing my new design;  
FIG. 2 is a right side elevational view thereof, the left side elevational view being the same;  
FIG. 3 is a bottom plan view thereof; and,  
FIG. 4 is a top plan view thereof.  
The broken line showing of unclaimed portions of the check valve with contoured body form no part of the claimed design.

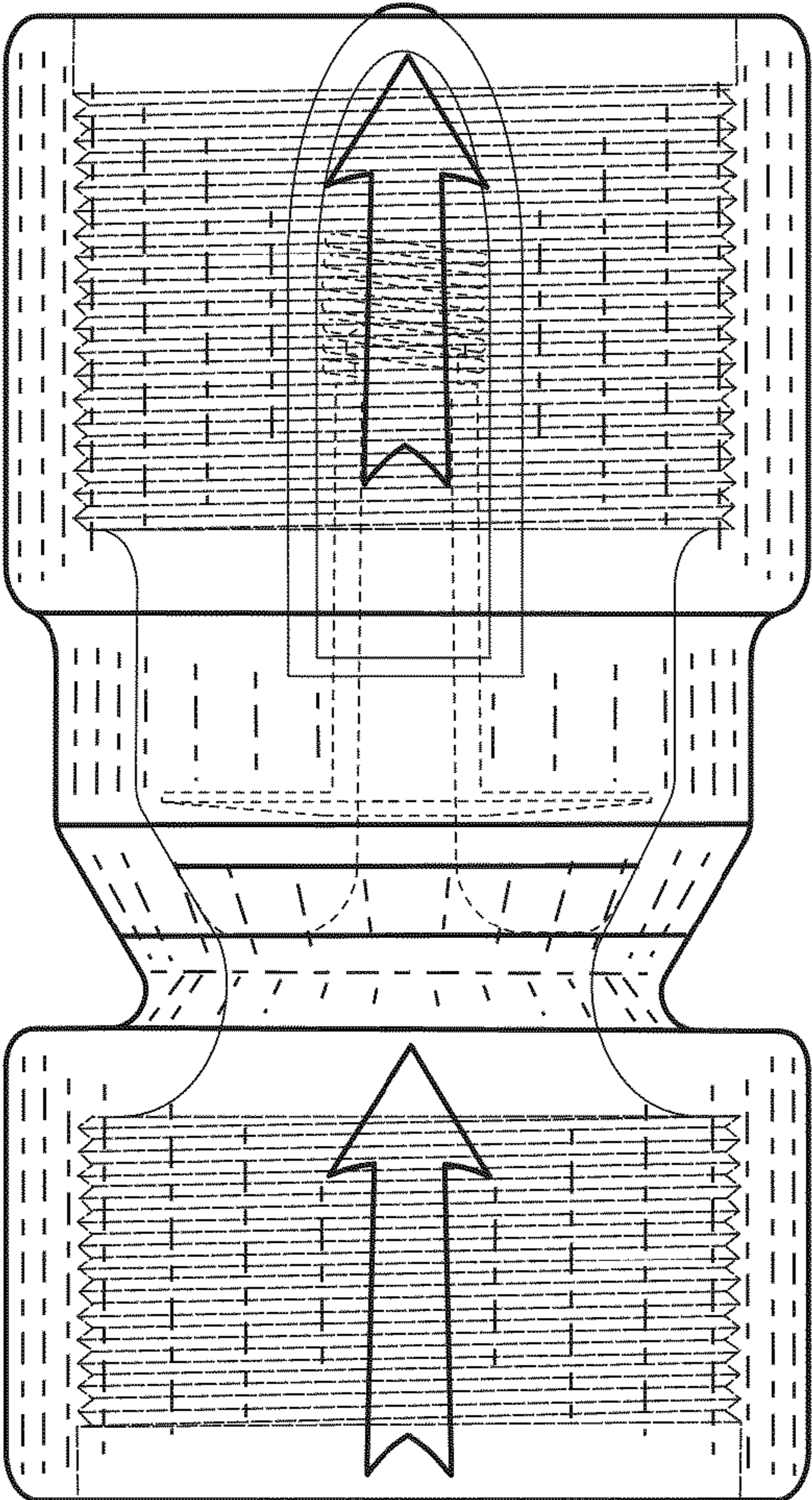

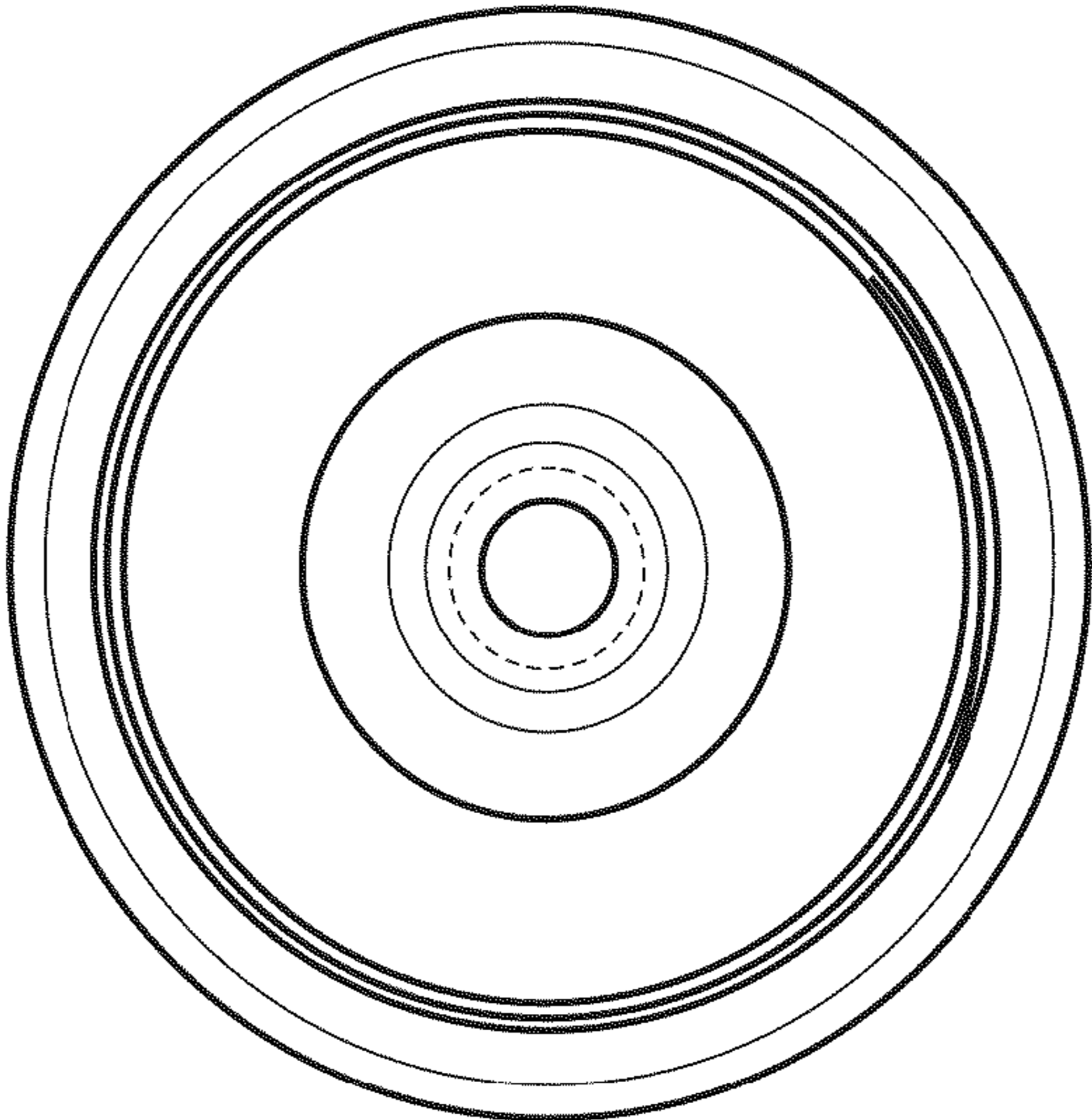

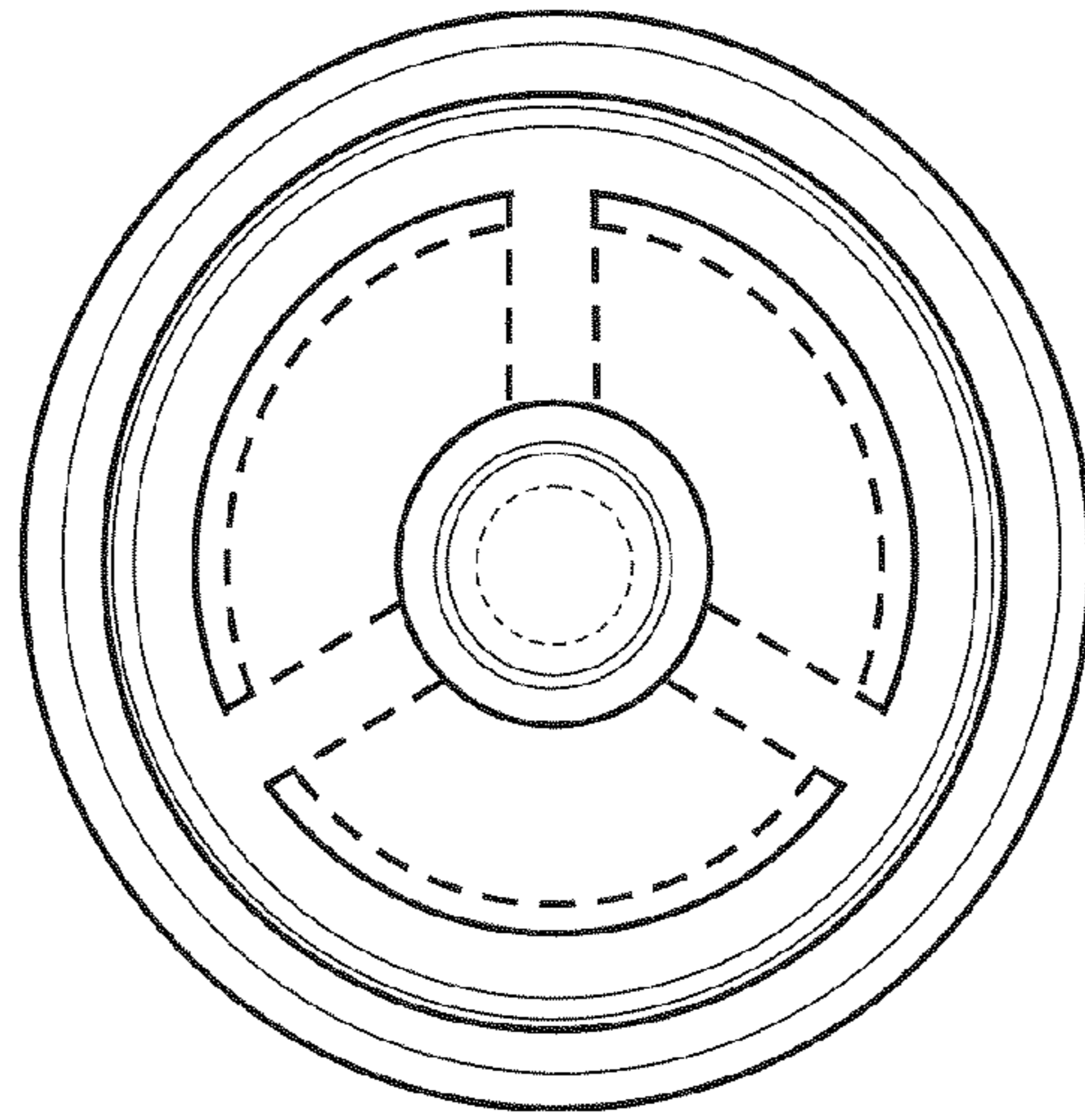

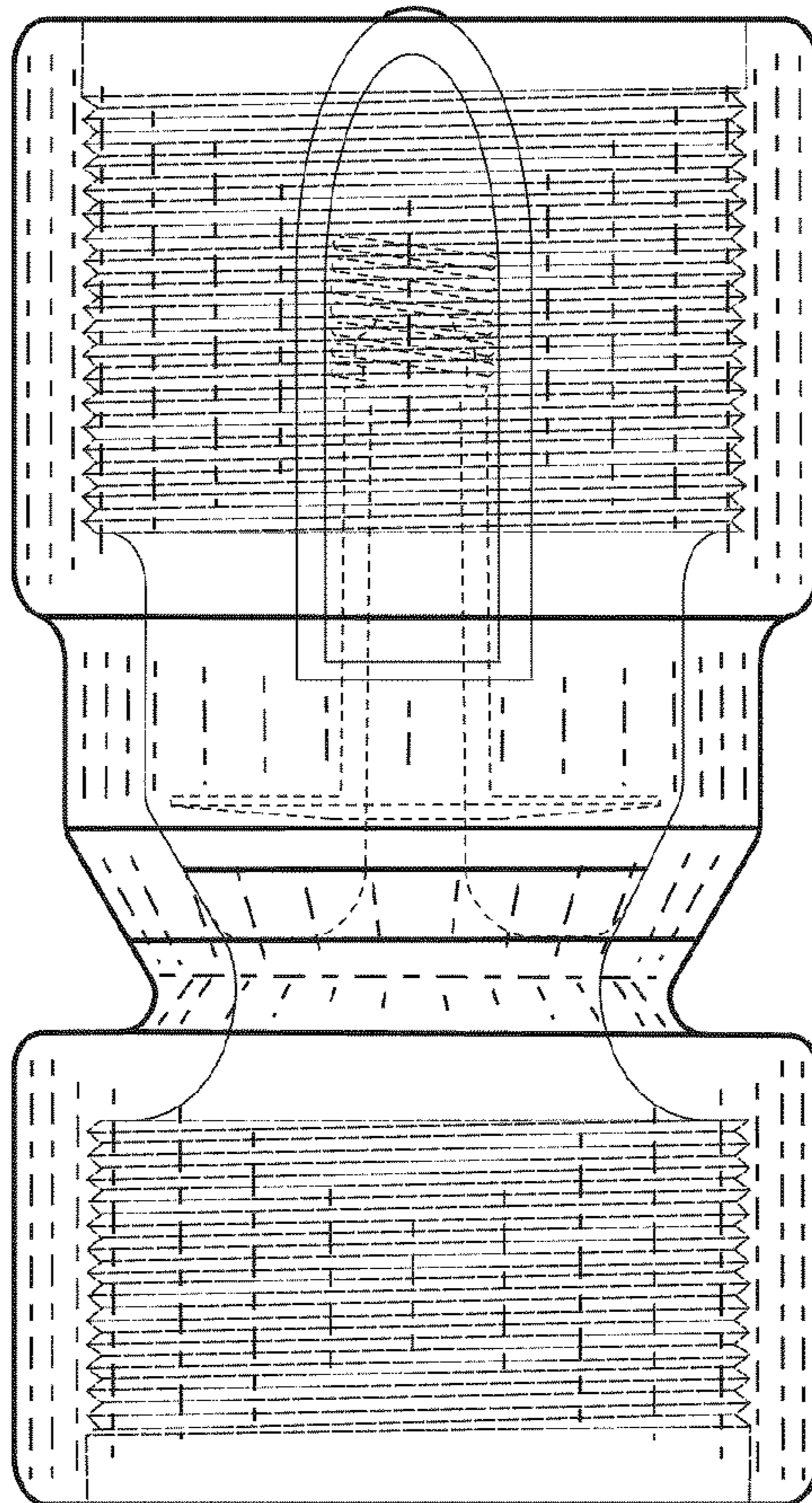
