(57) **CLAIM**

The ornamental design for a rear combination lamp for a motorcycle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a rear combination lamp for a motorcycle showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a right side elevation view thereof; and, FIG. 6 is a left side elevation view thereof.

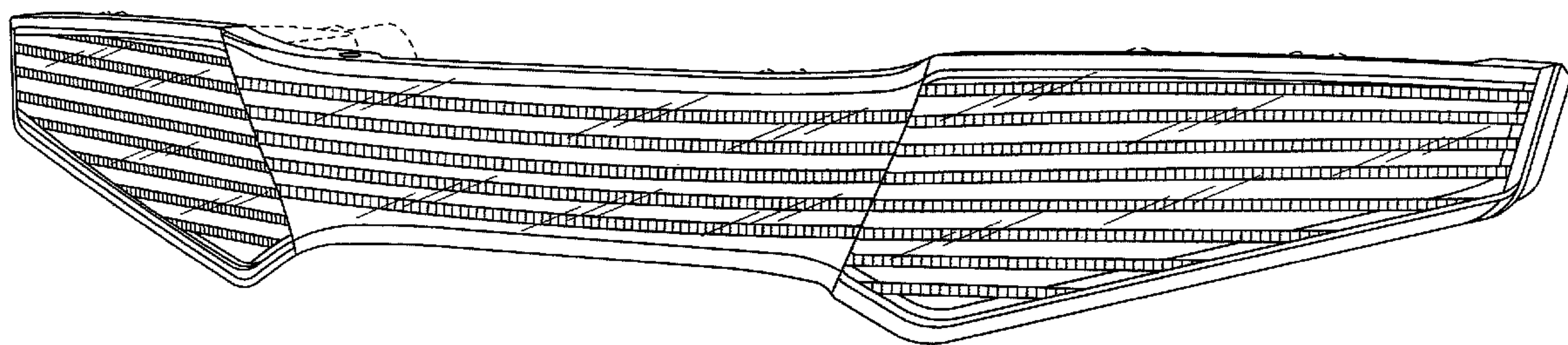

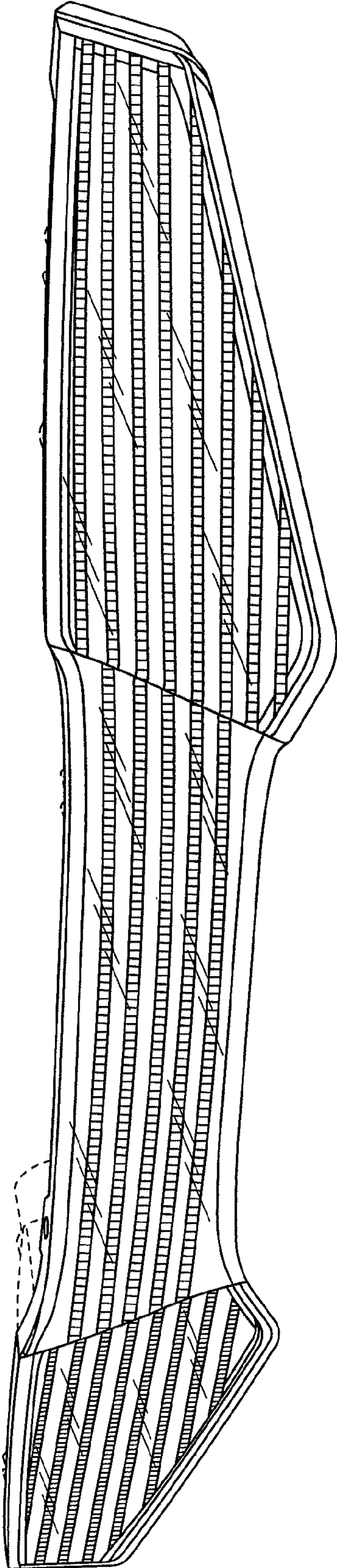
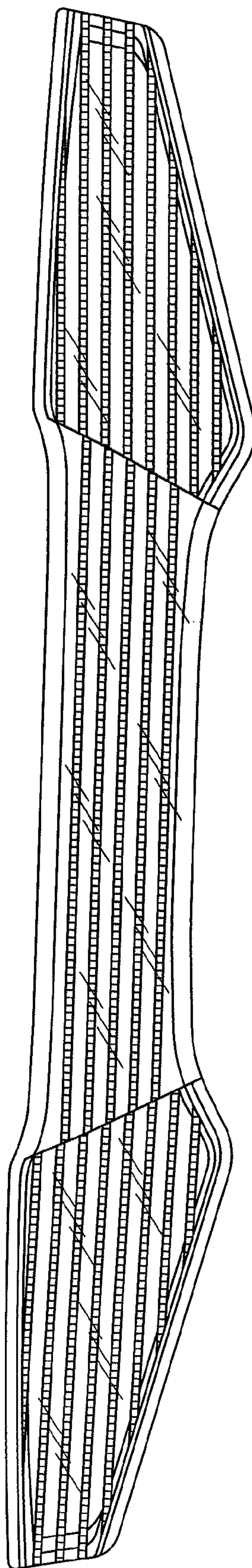

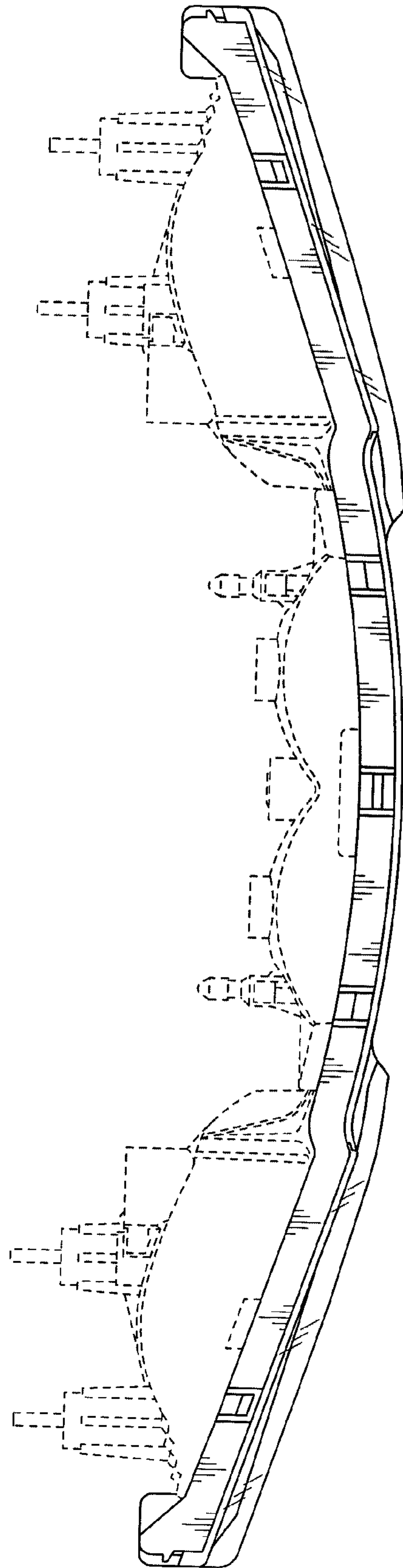

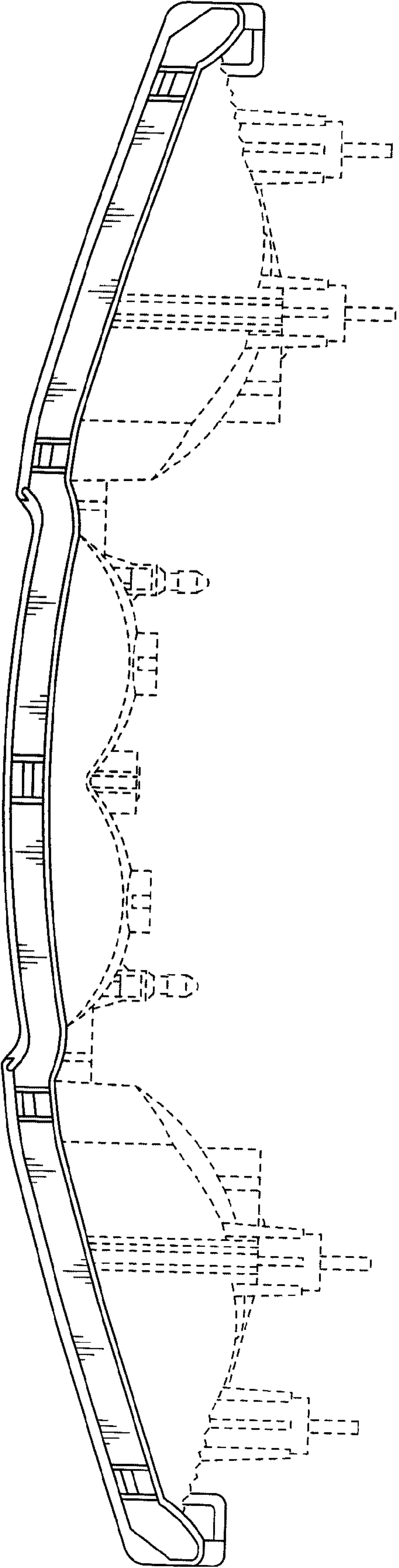

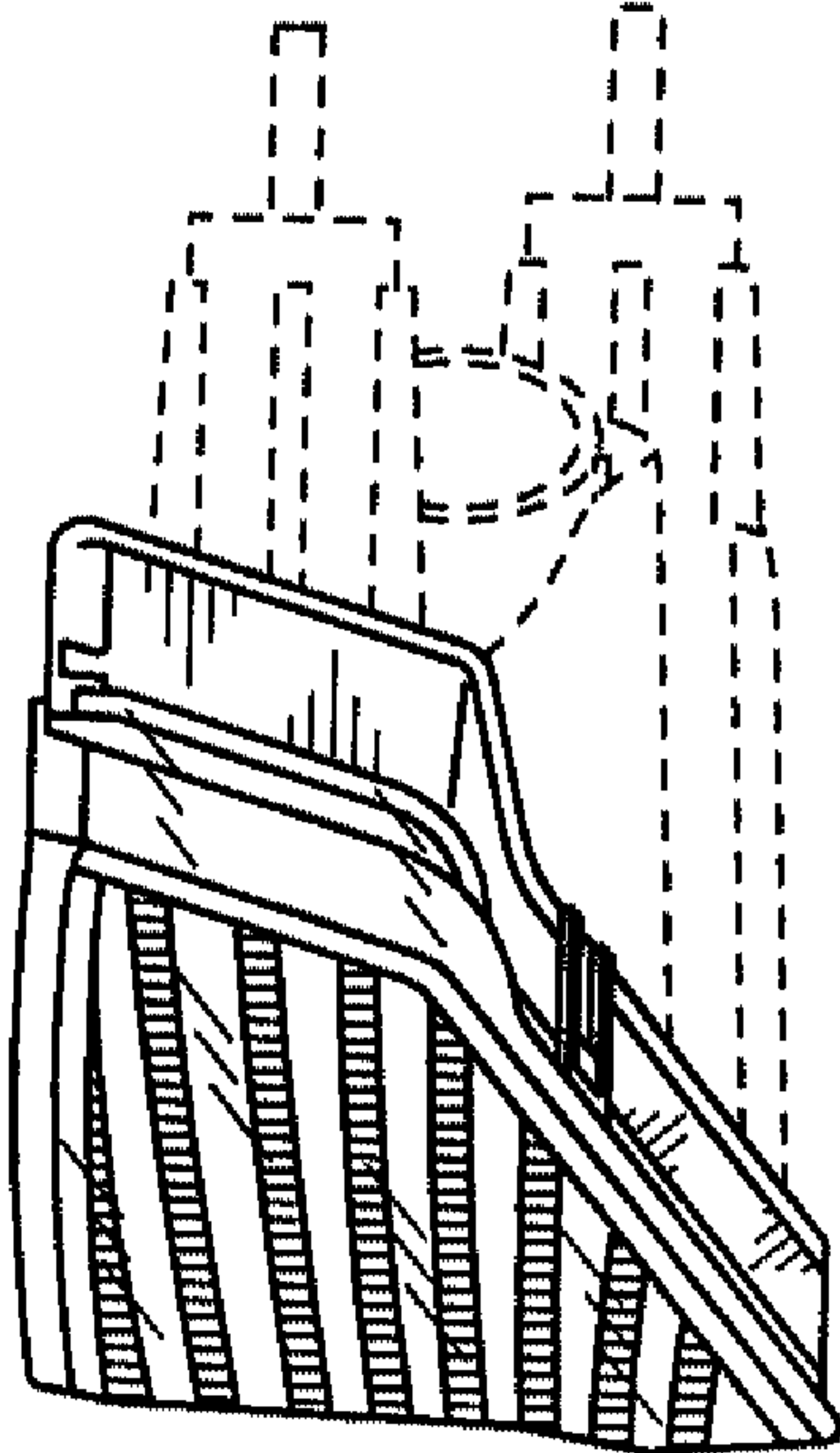
