(57) **CLAIM**

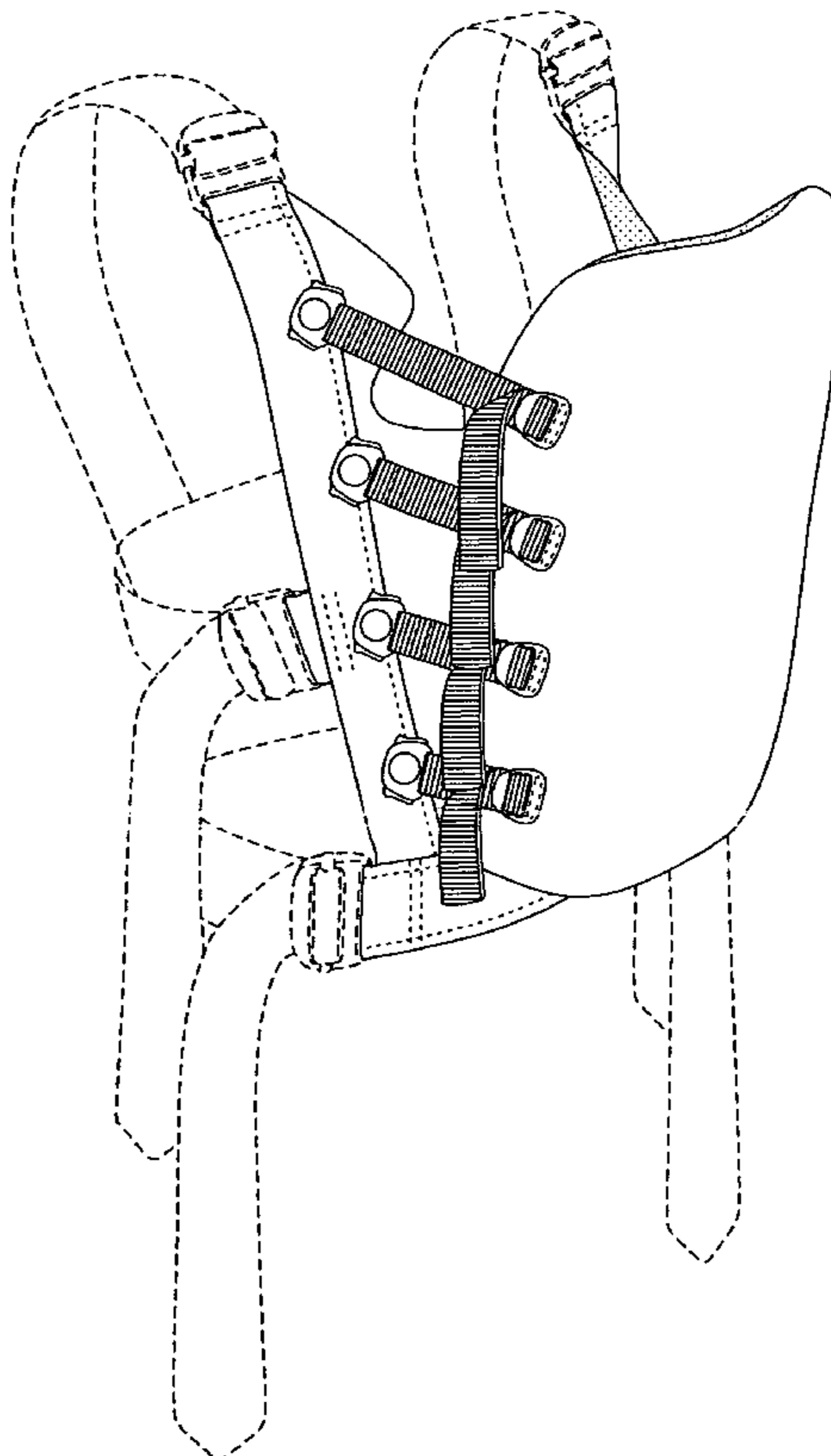
The ornamental design for a carrier for prematurely born baby, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view showing our new design for a carrier for prematurely born baby, FIG. 2 is a rear perspective view thereof, FIG. 3 is a front view thereof, FIG. 4 is a rear view thereof, FIG. 5 is a top view thereof, FIG. 6 is a bottom view thereof; and, FIG. 7 is a right side view thereof, the left side being a mirror image thereof.

The portions shown in dotted lines are for illustrative purposes only, forming no part of the claimed design. The broken line showing of surfaces of the Belt Carrier represents stitching and forms a part of the claimed design.

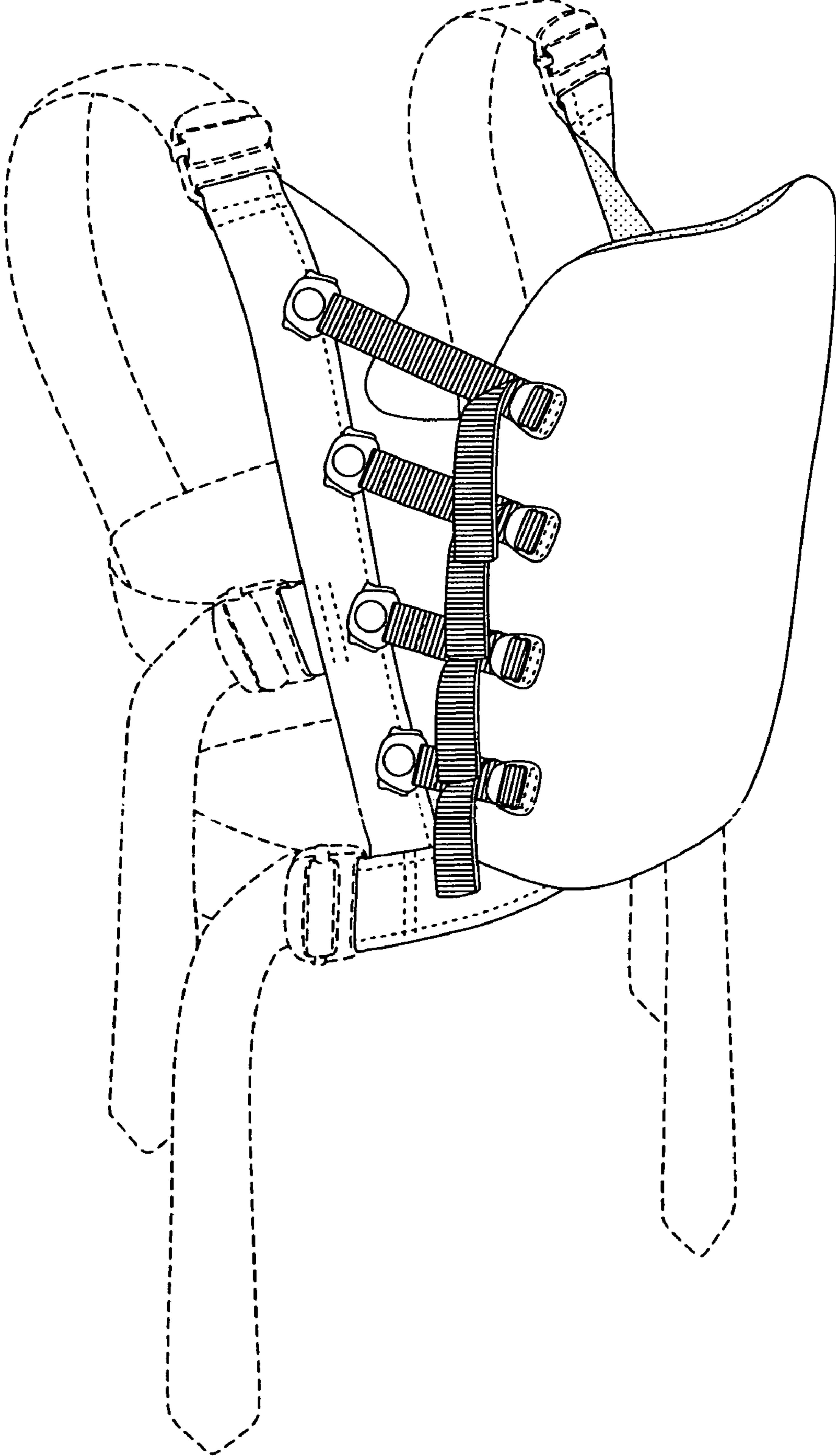

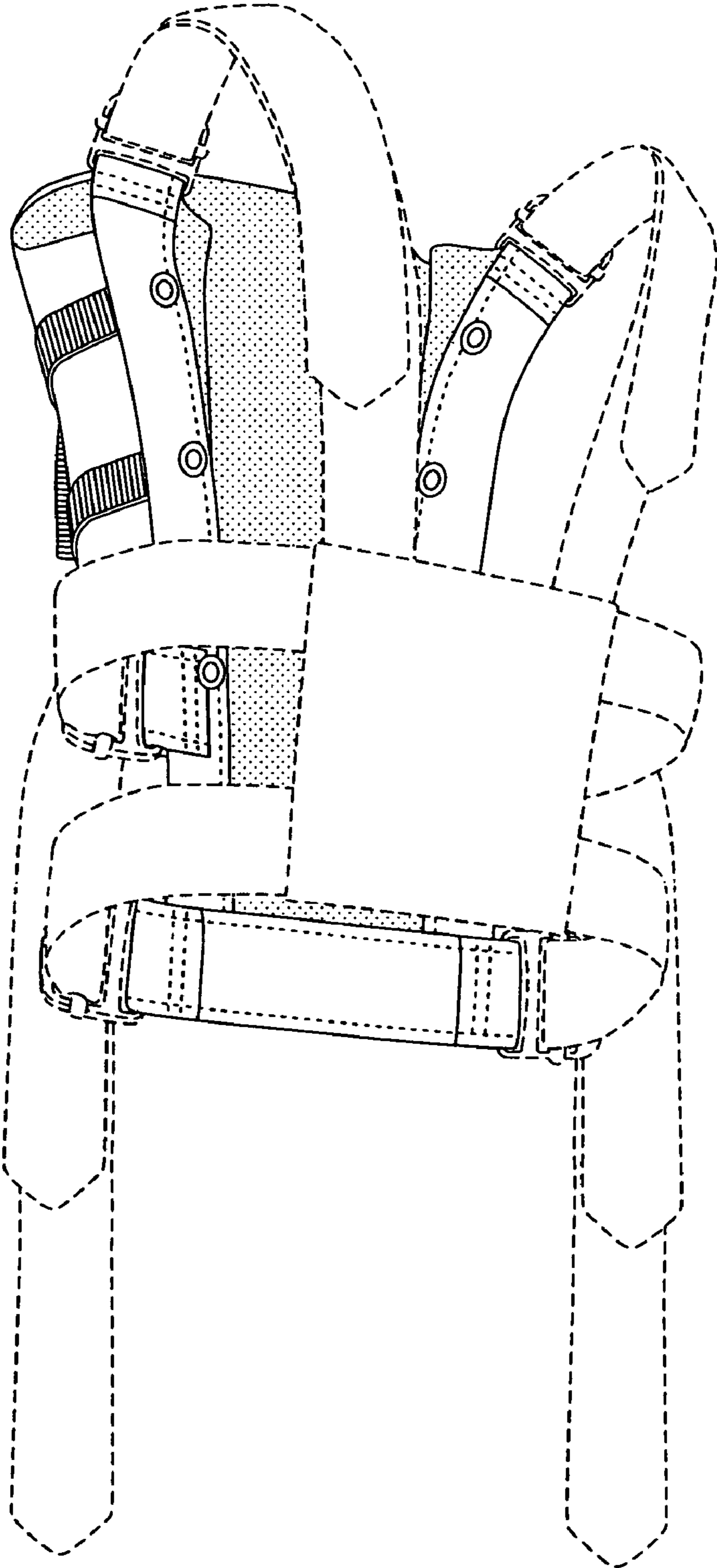

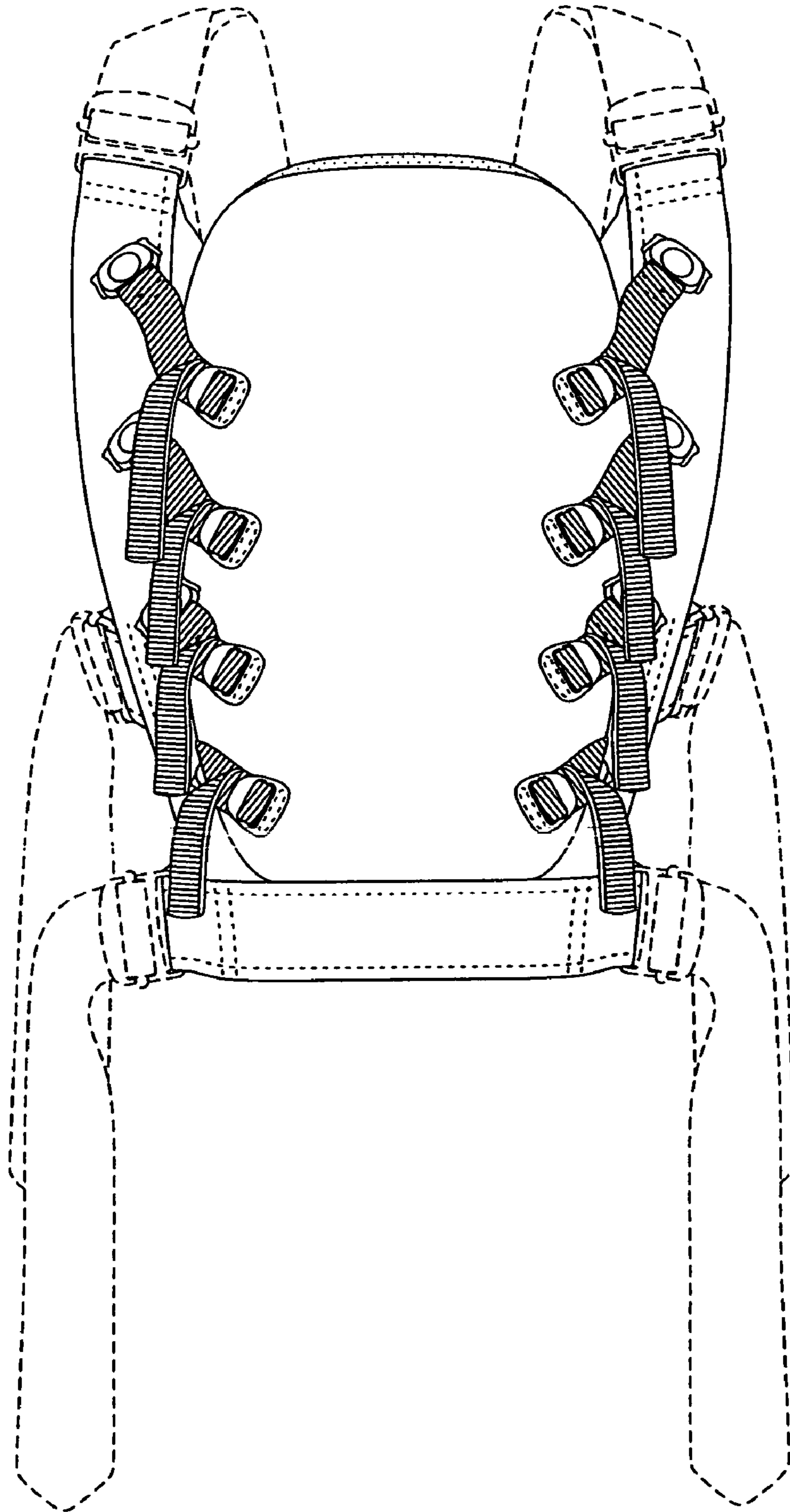

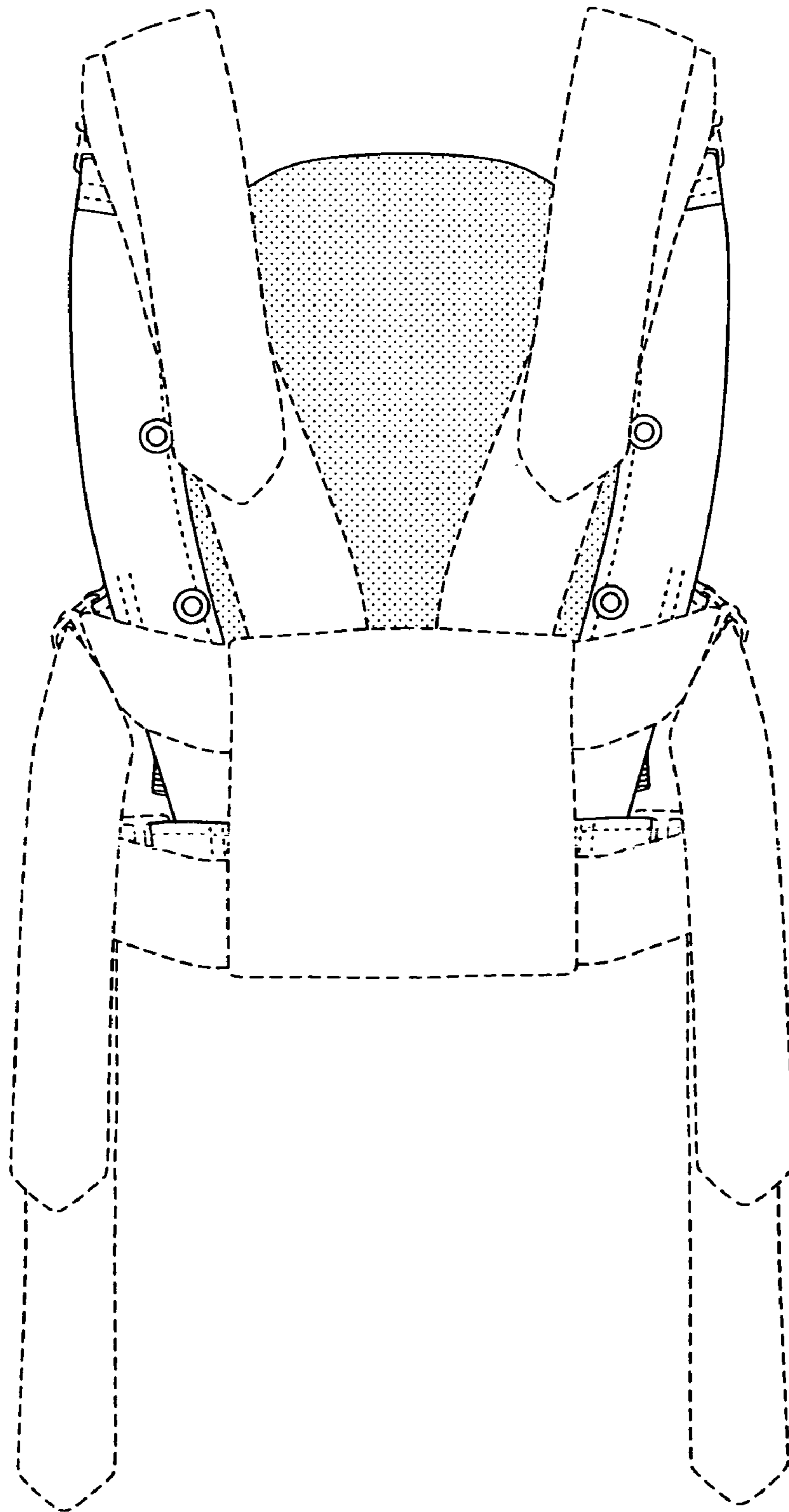

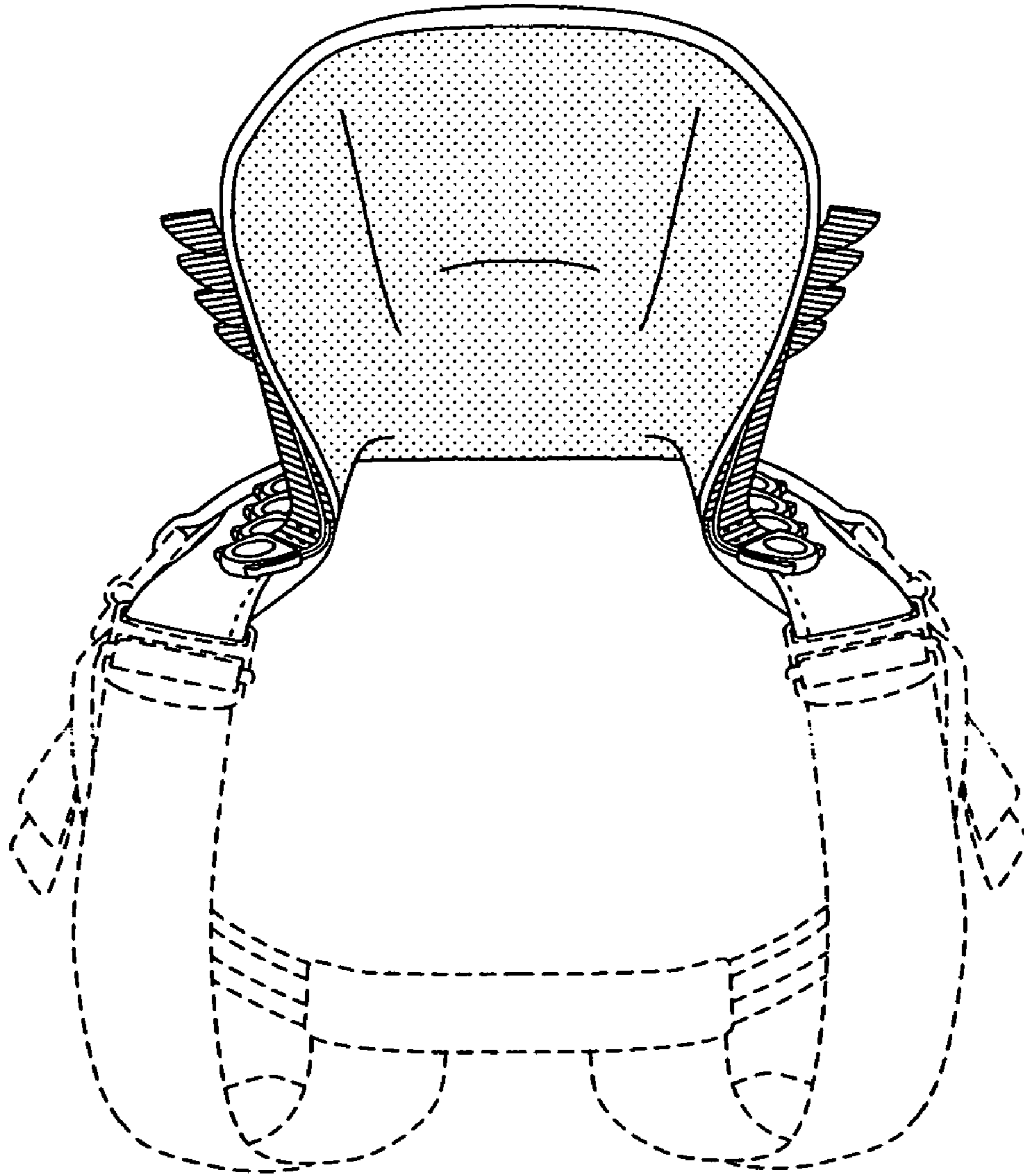

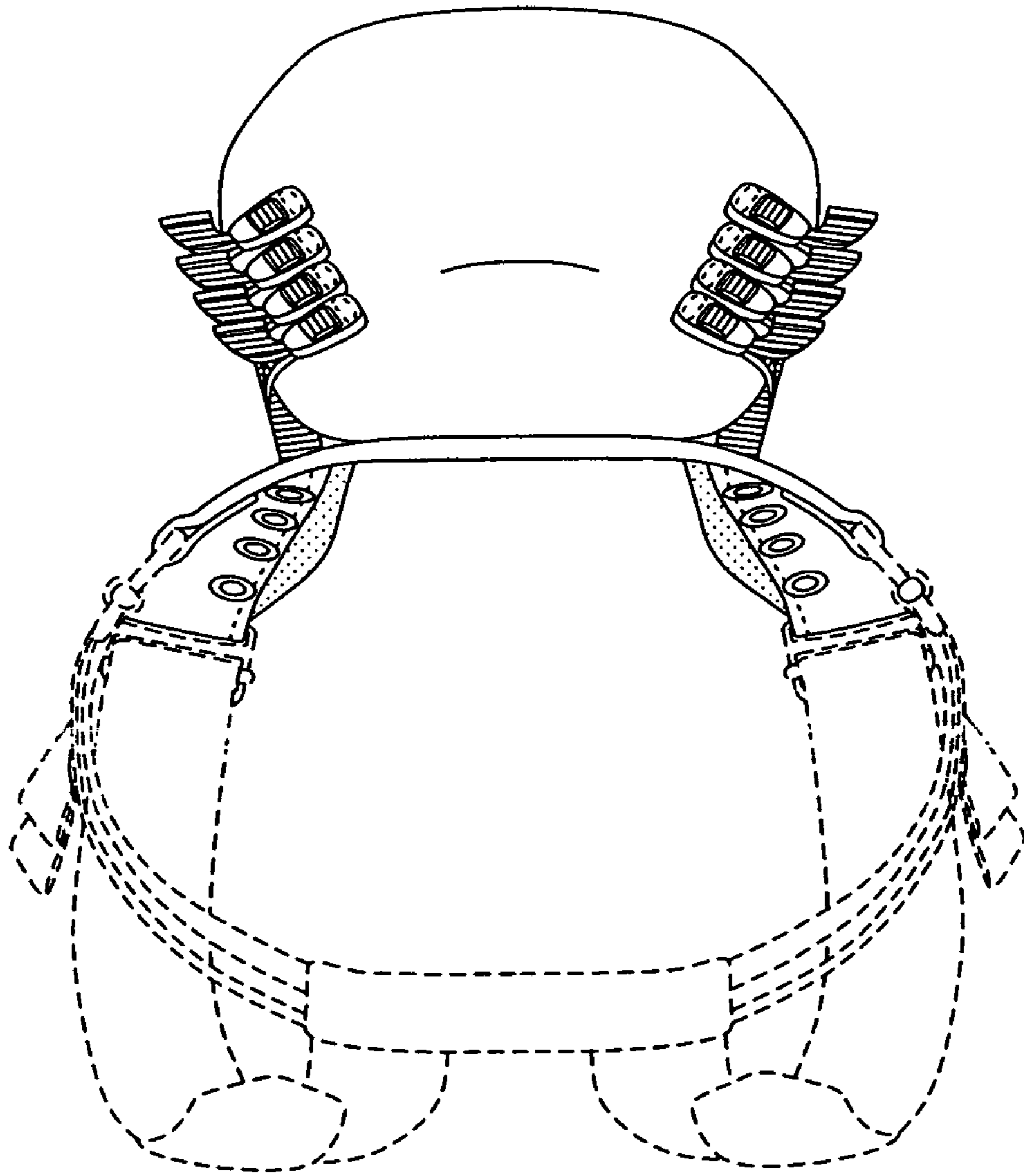

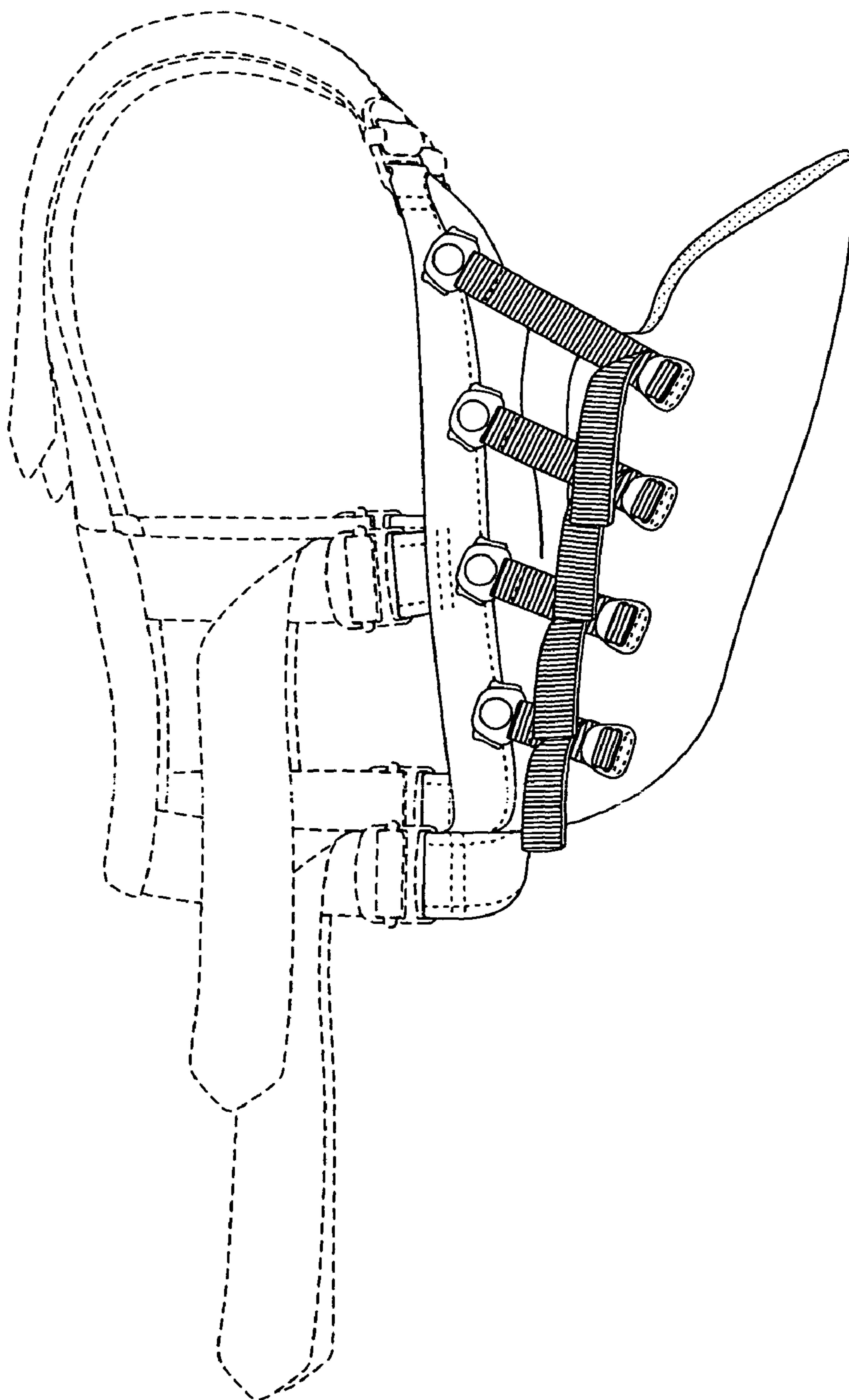
