The ornamental design for a fabric with ornamentation, as shown and described.

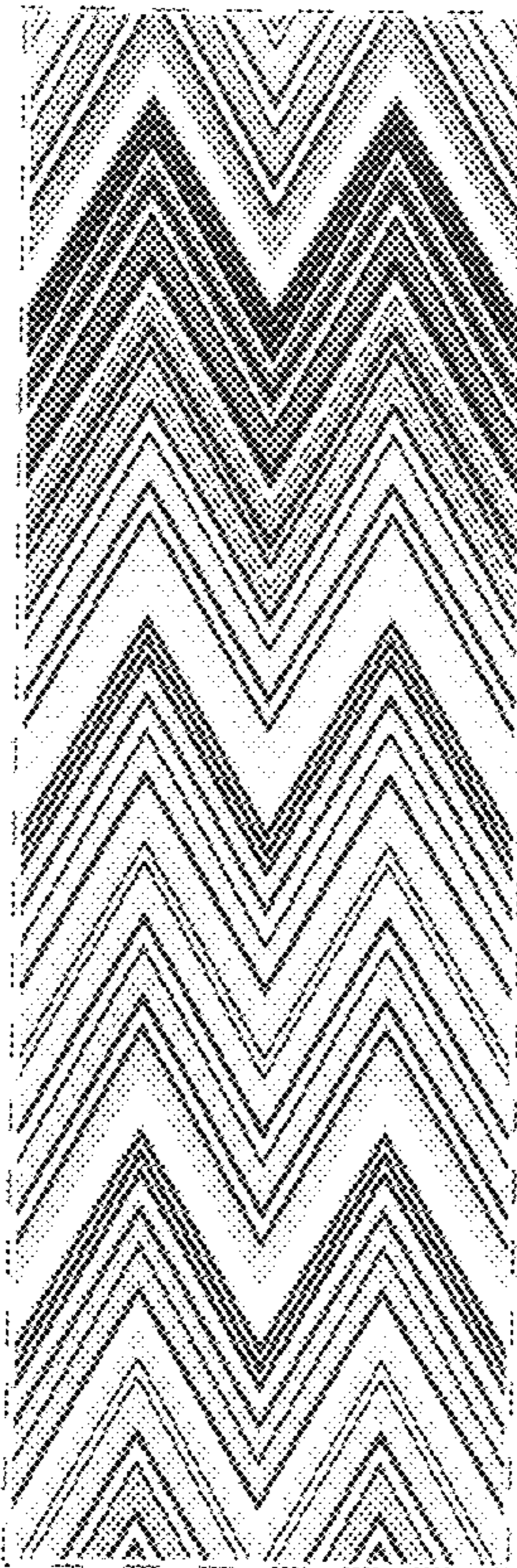
DESCRIPTION

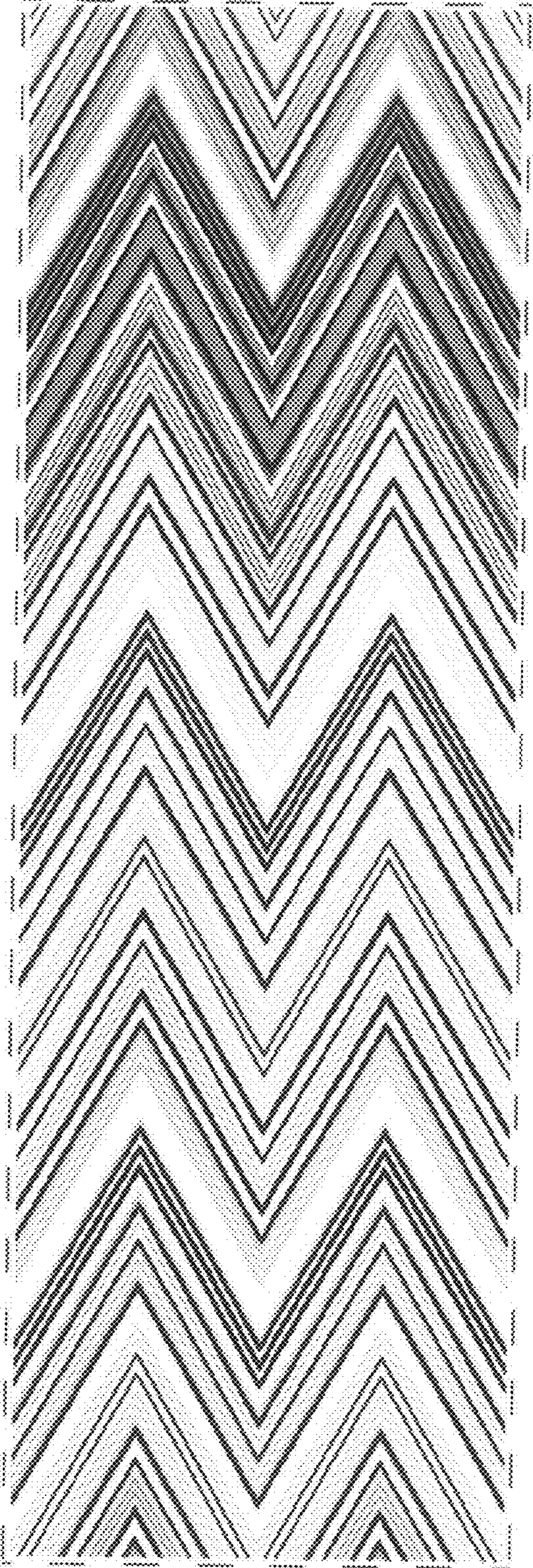

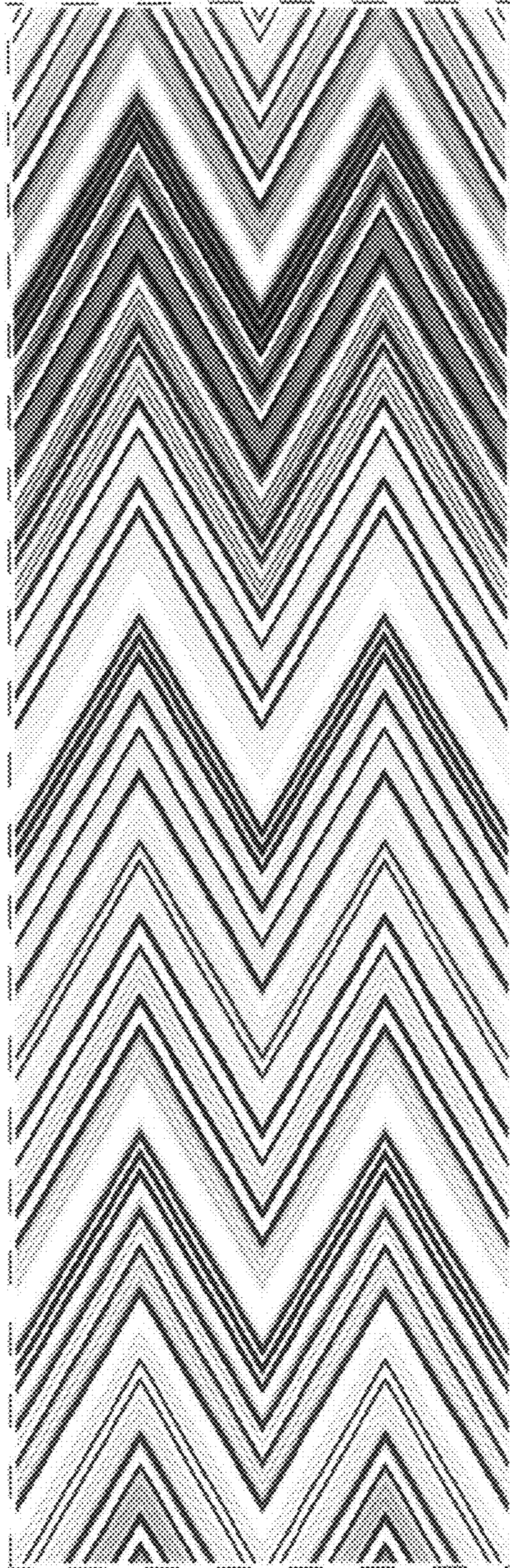
