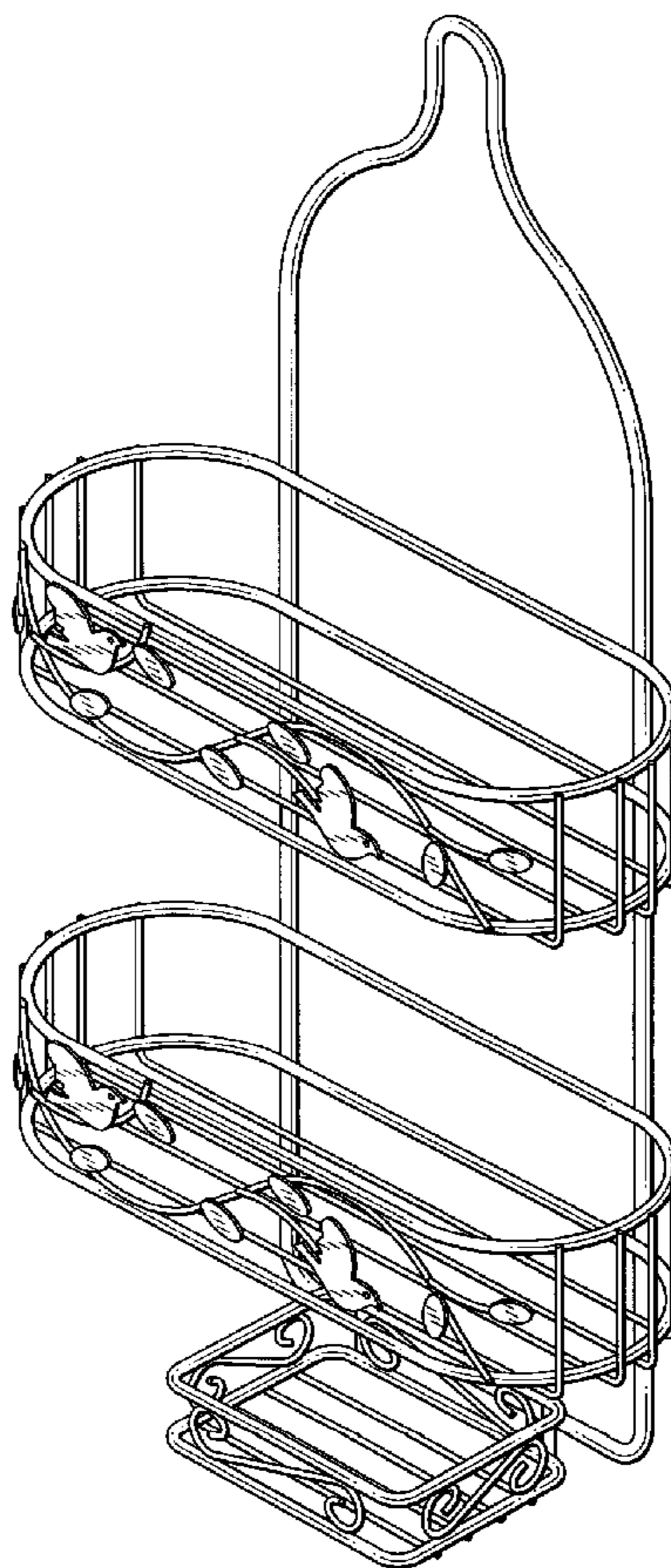
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front, and right perspective view of a bathroom caddy showing my new design;

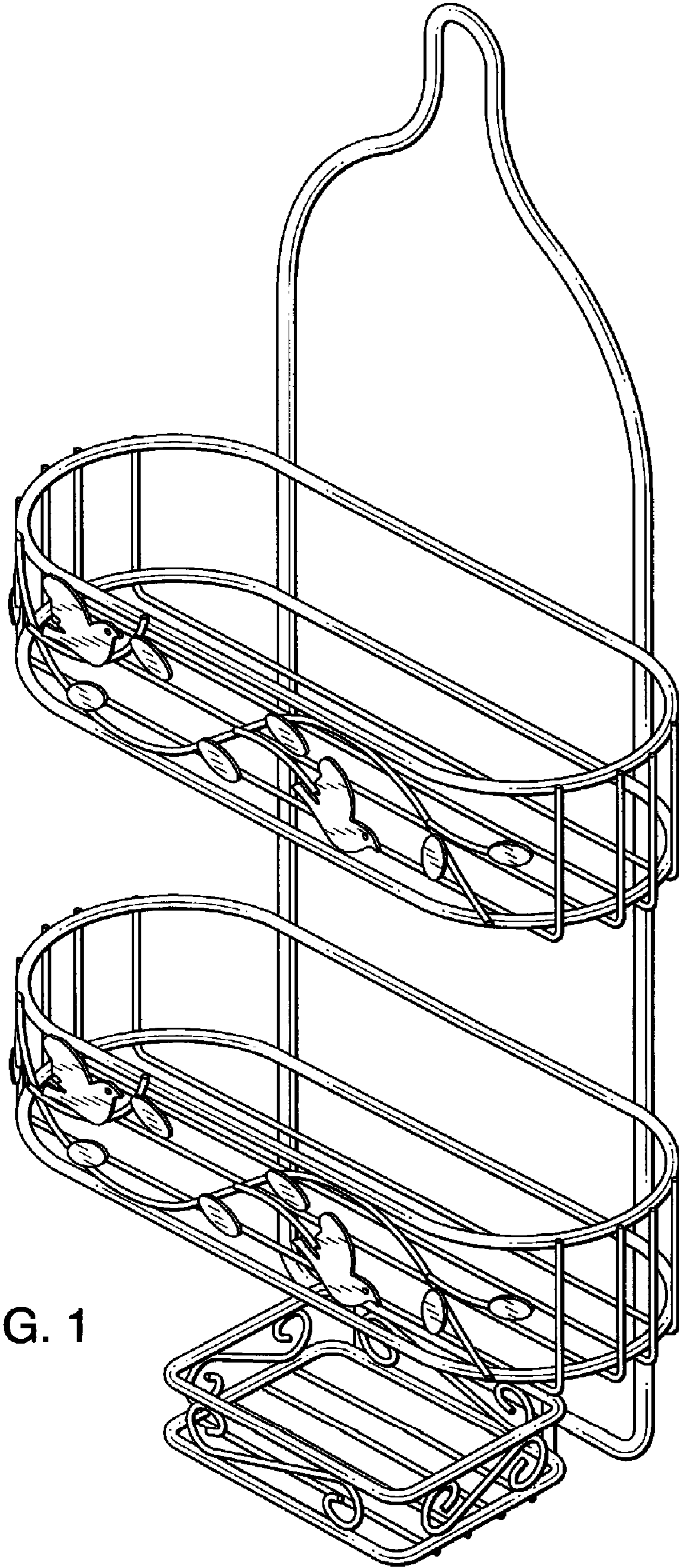

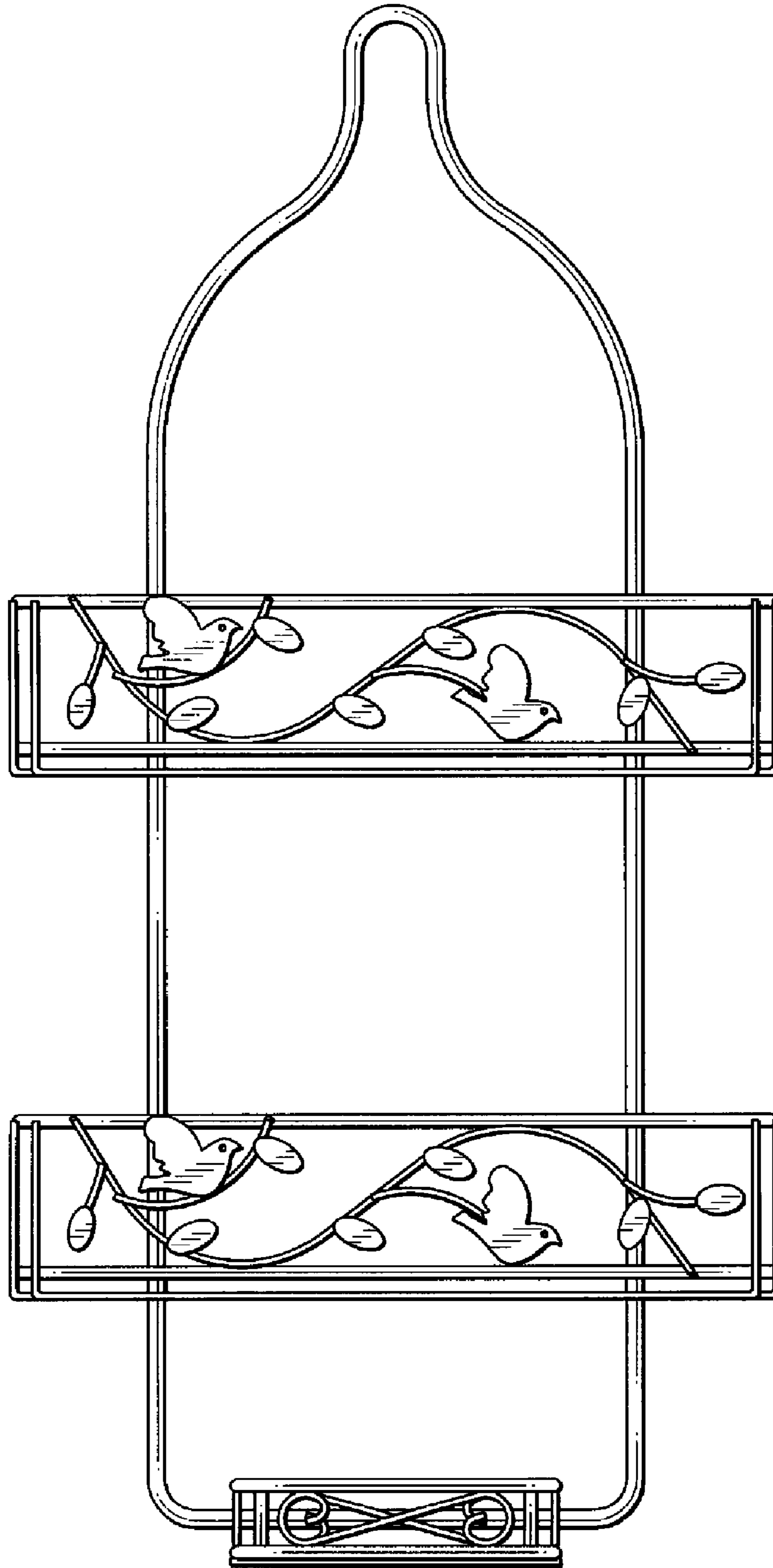

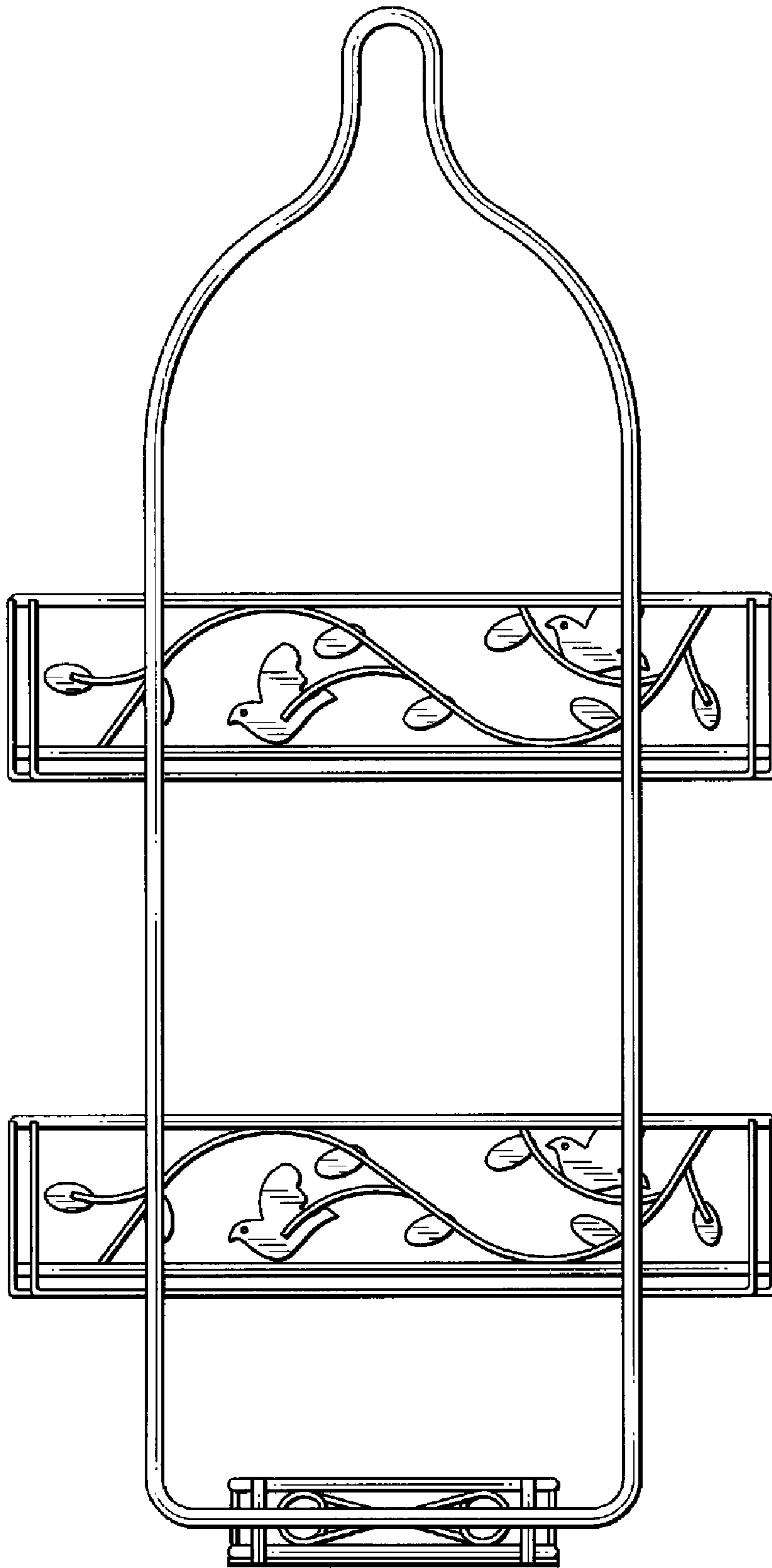

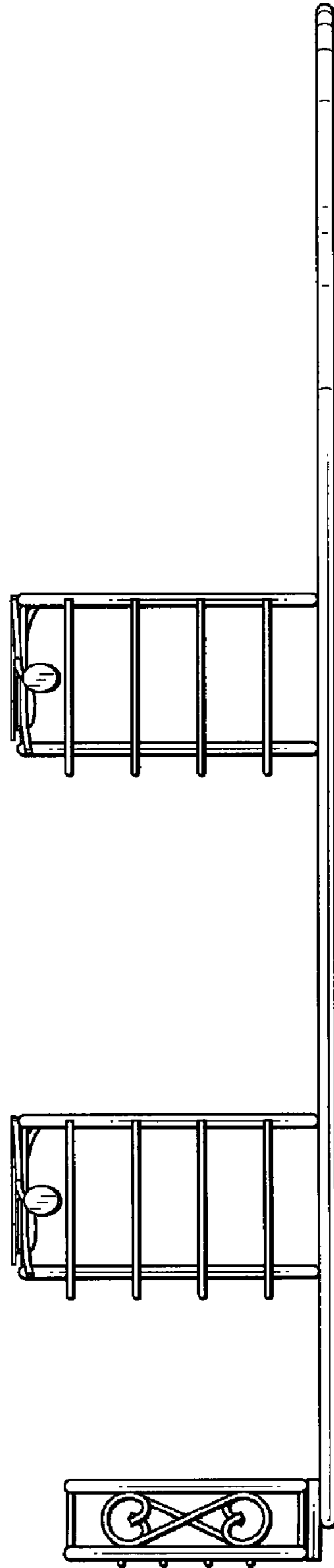

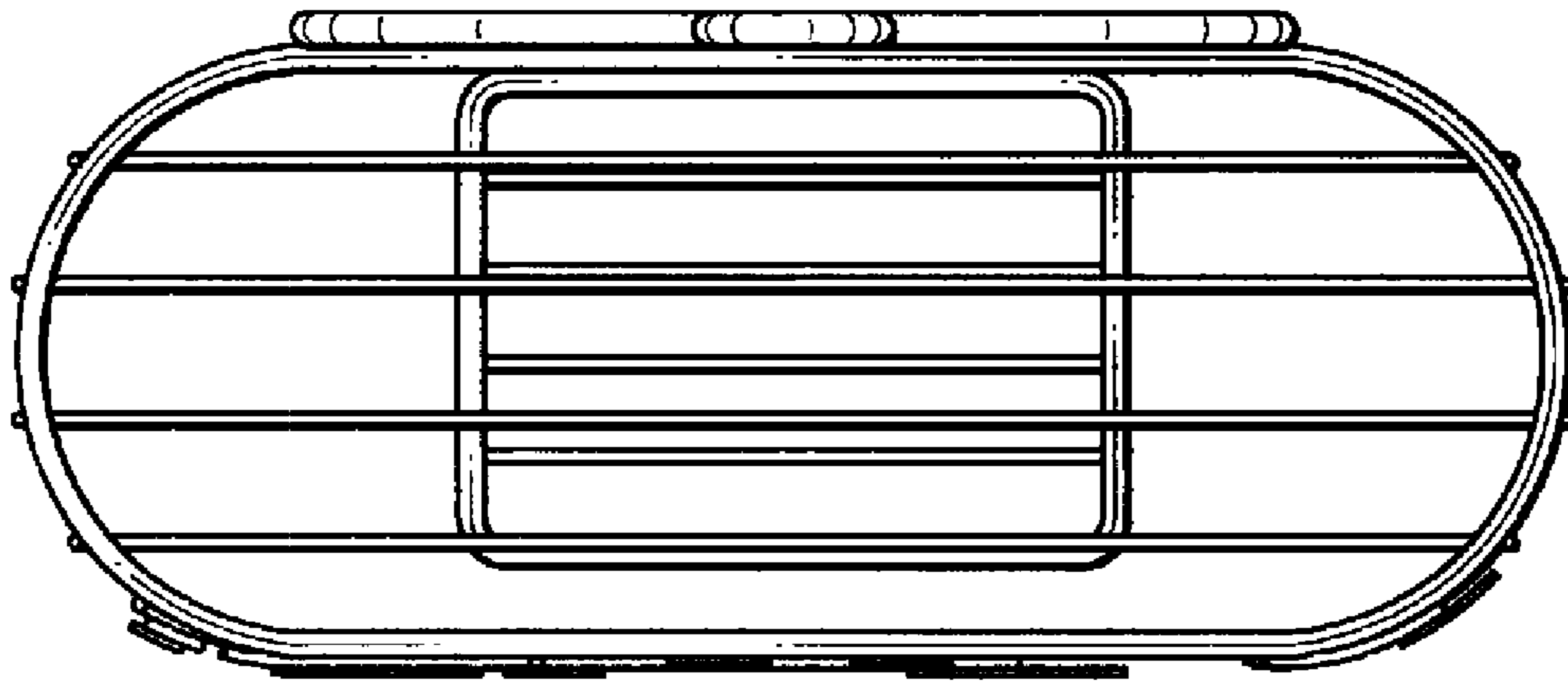

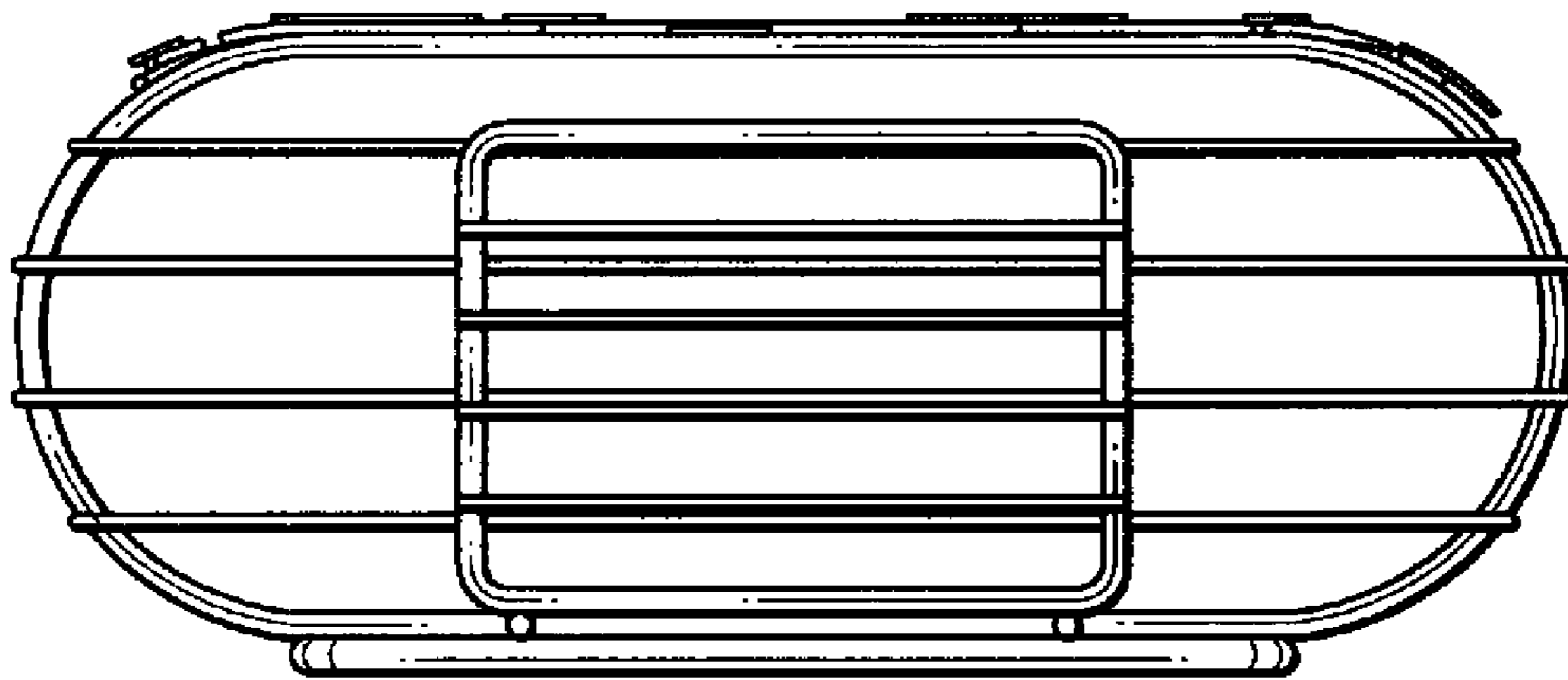
