DESCRIPTION

FIG. 8 is a top view of FIG. 7;

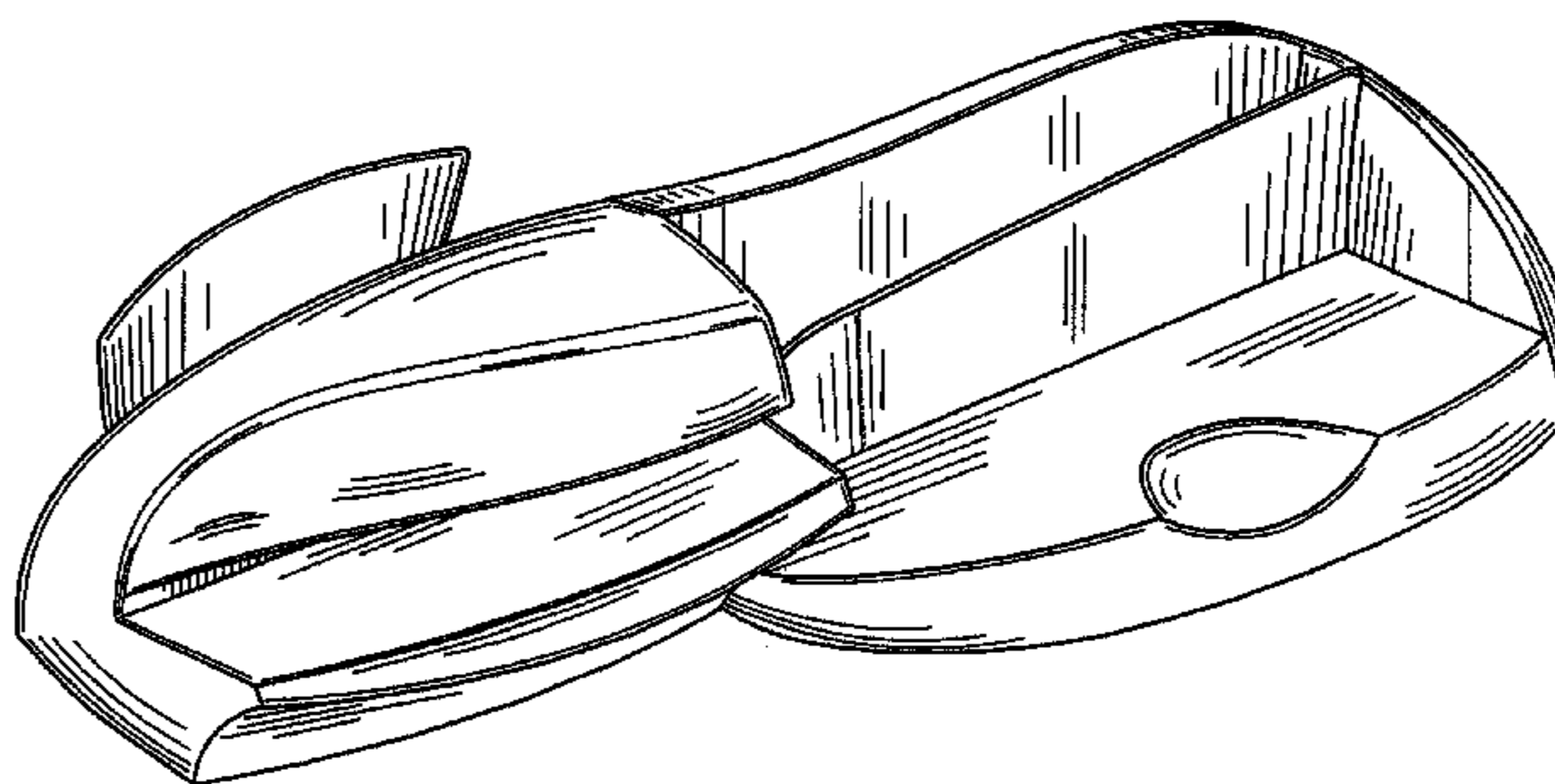
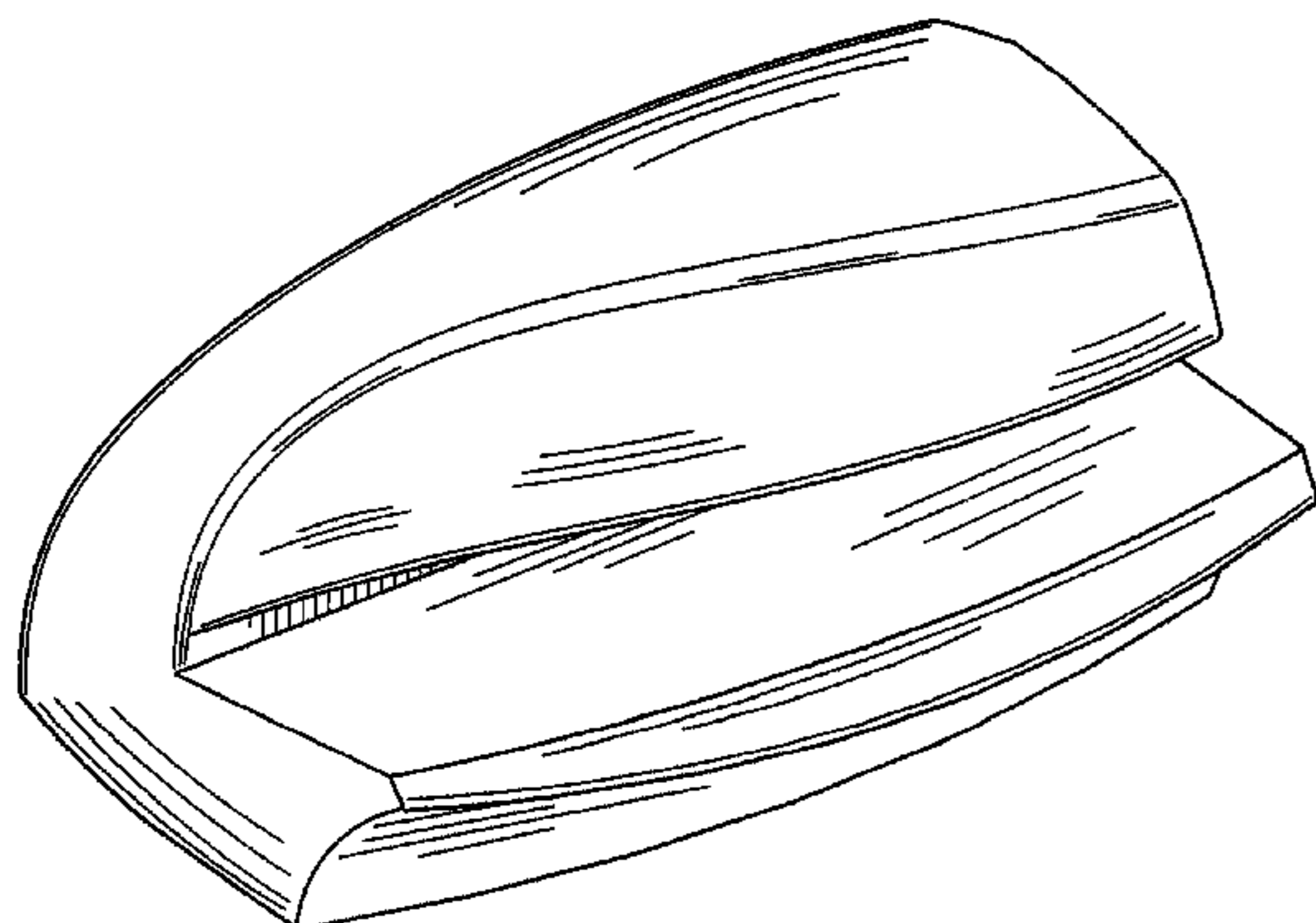
FIG. 9 is a front view of FIG. 7;

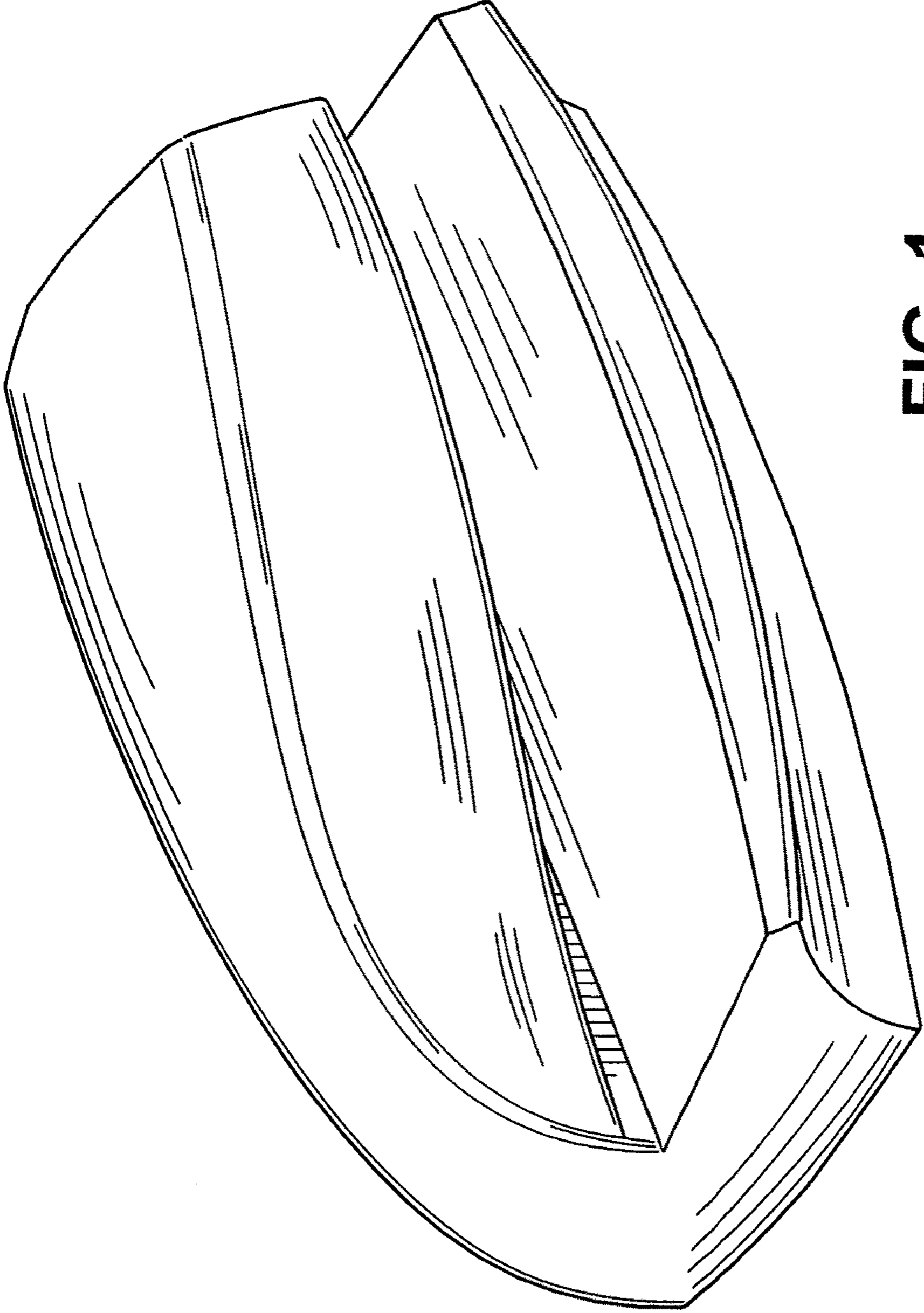

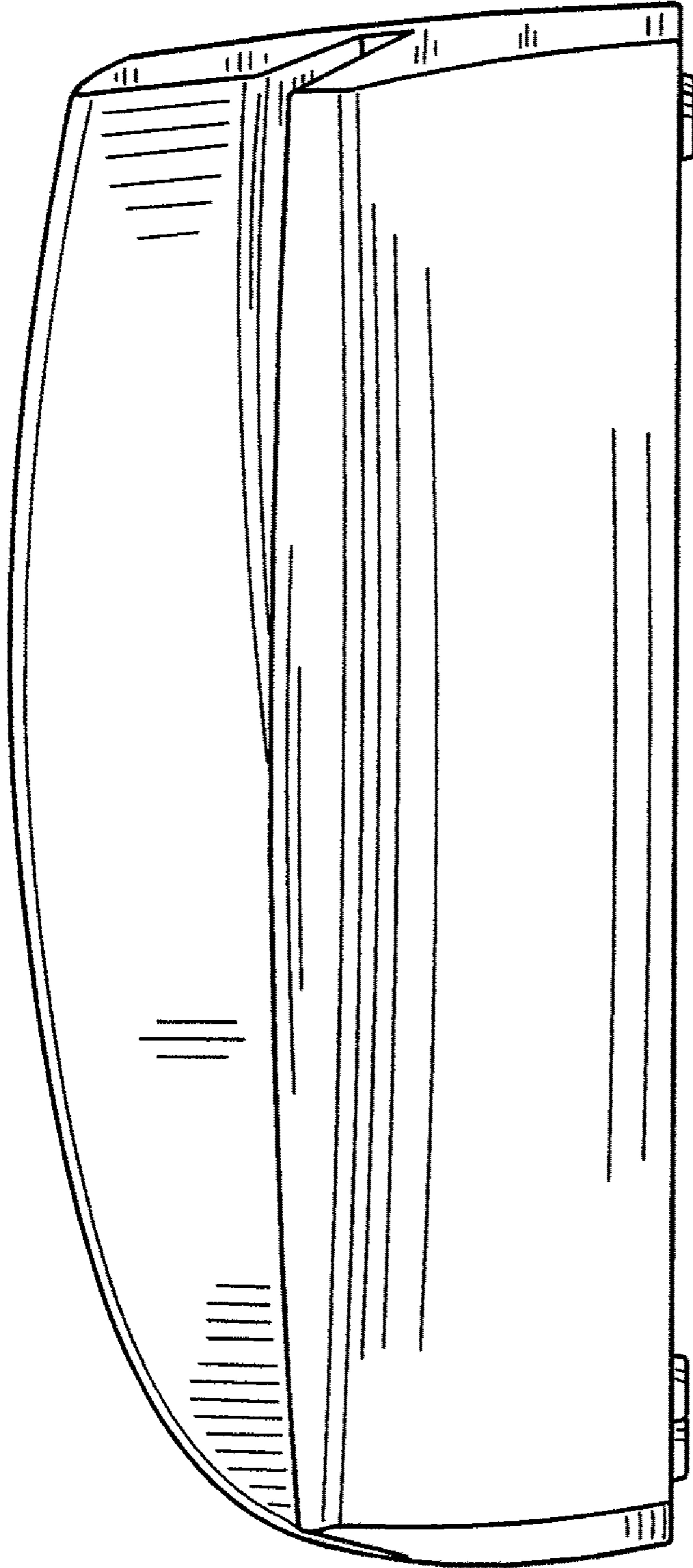

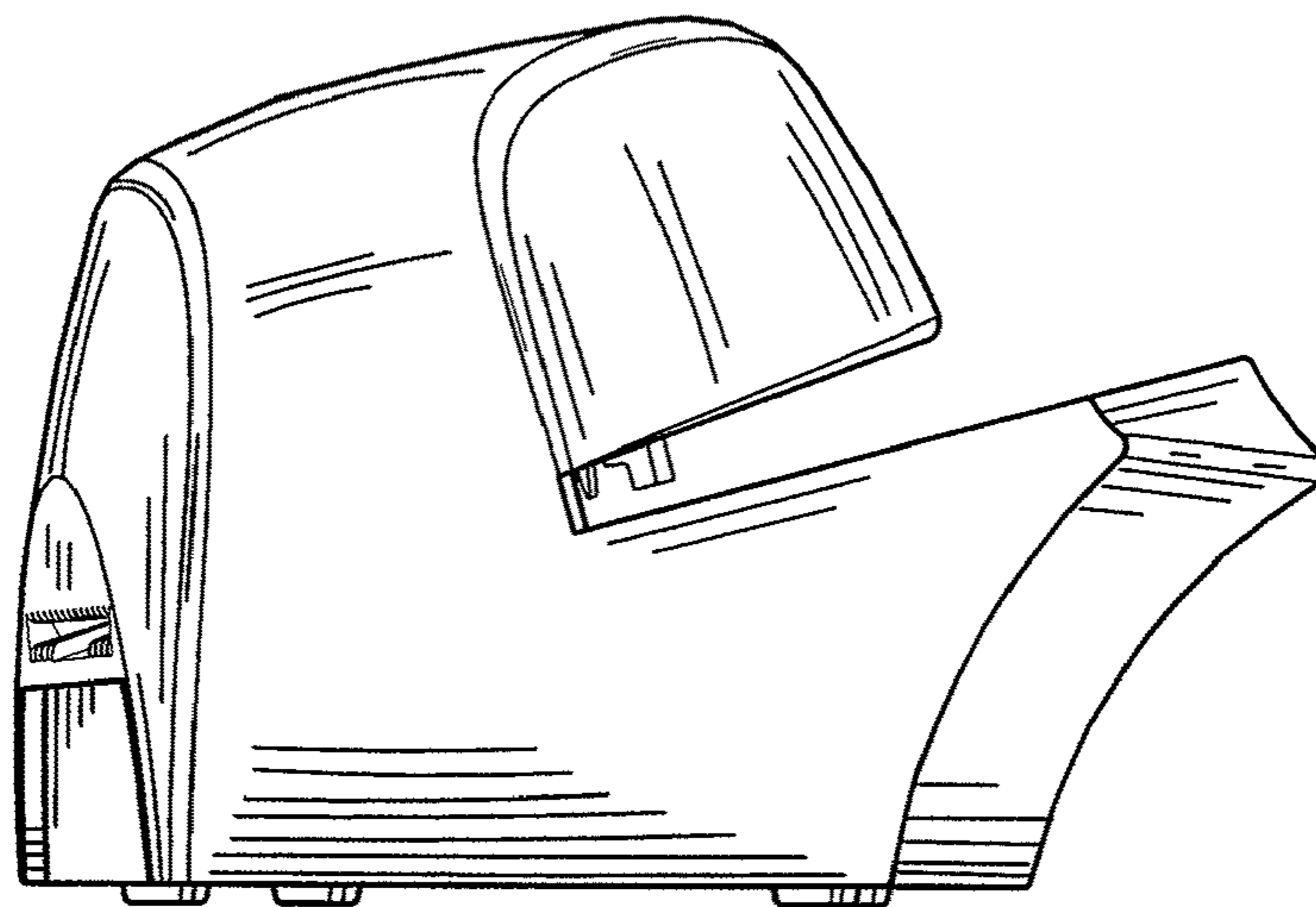

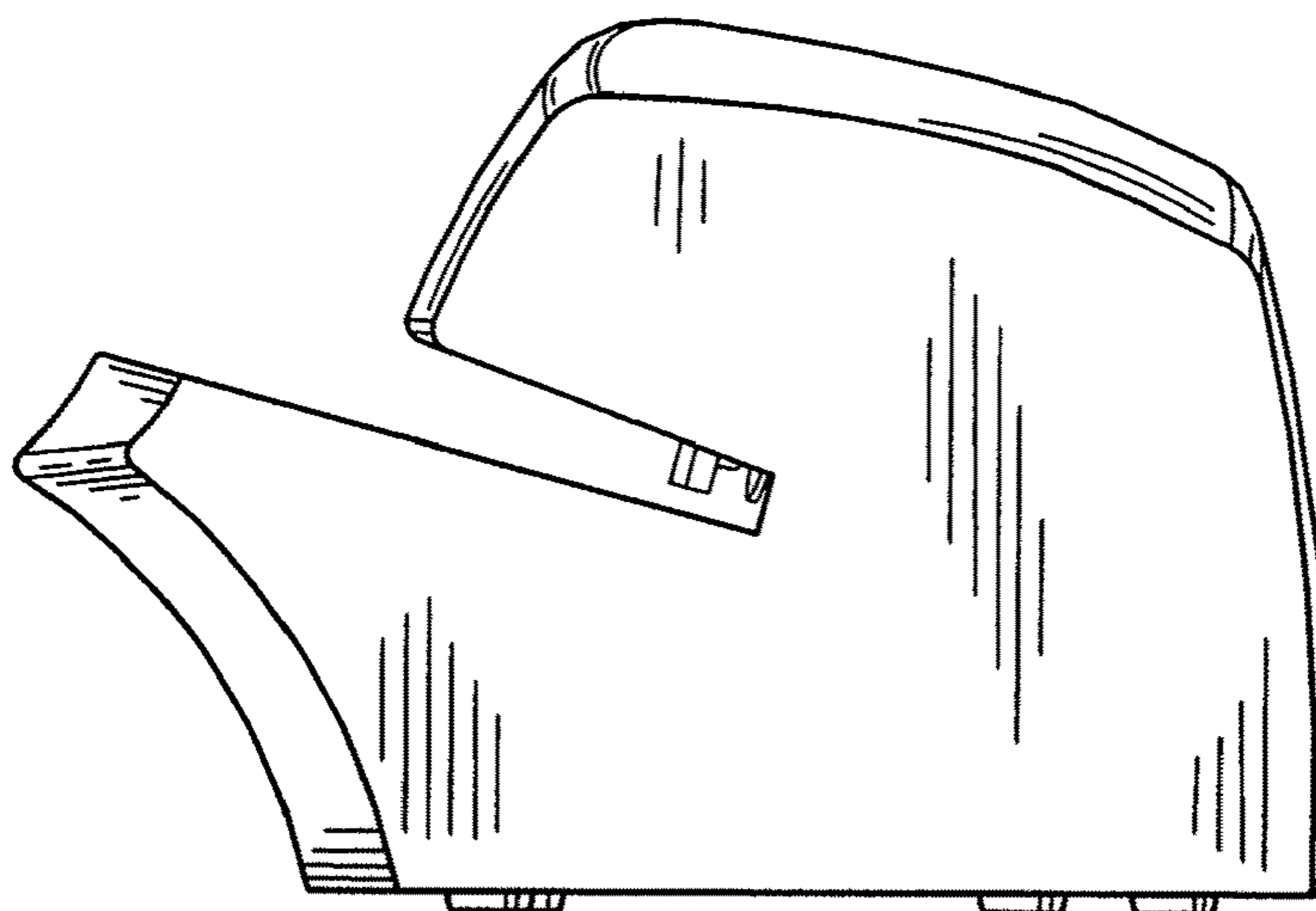

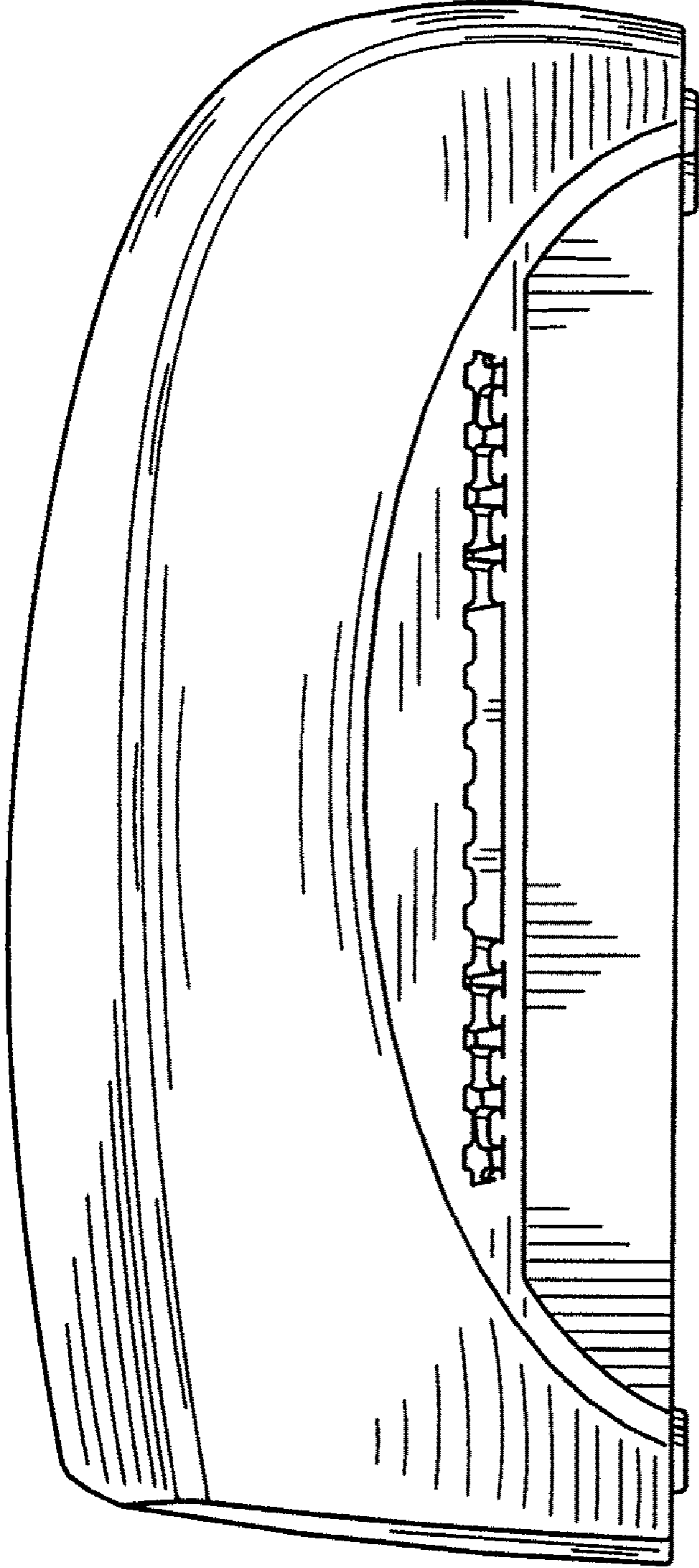

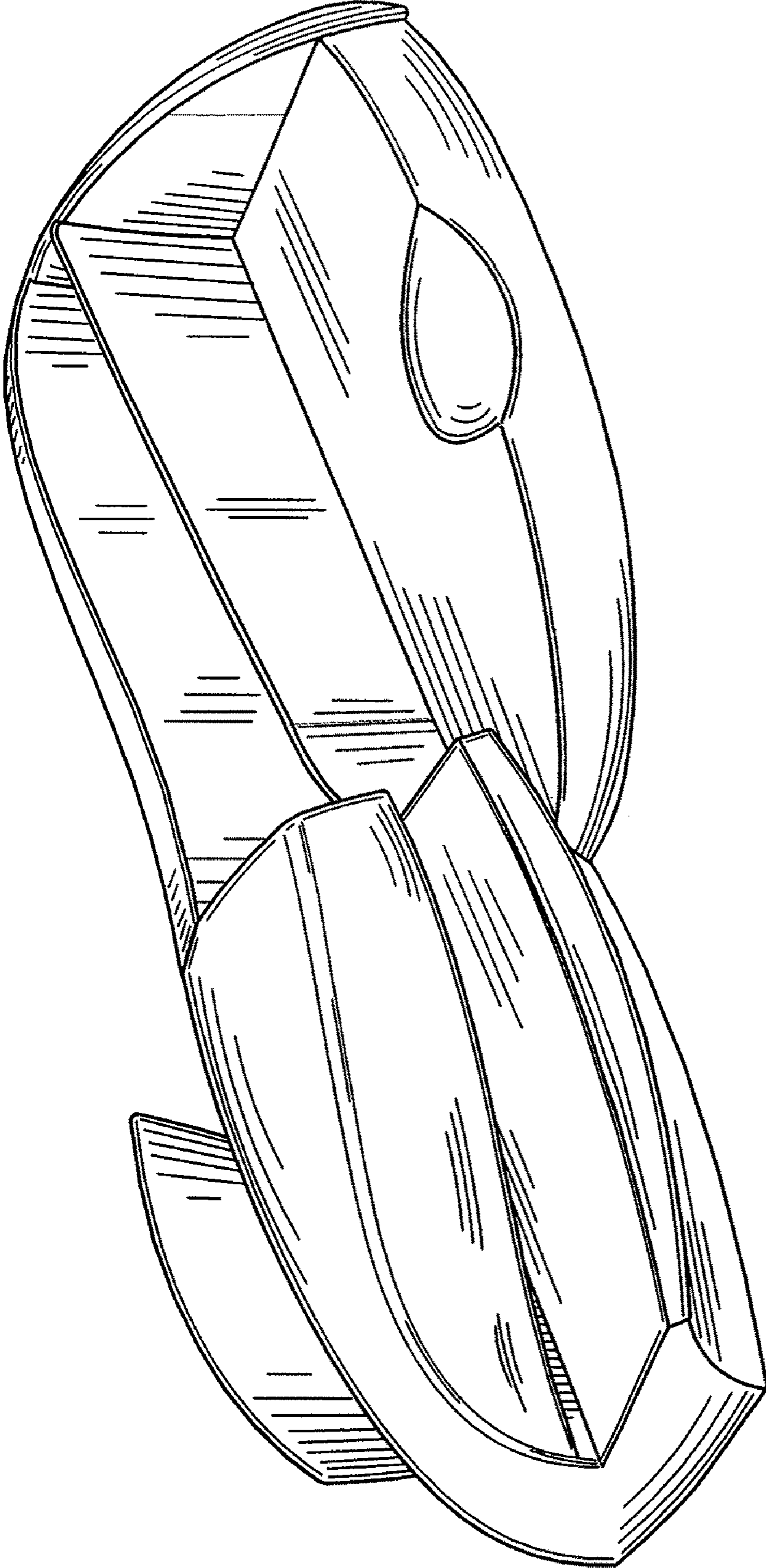

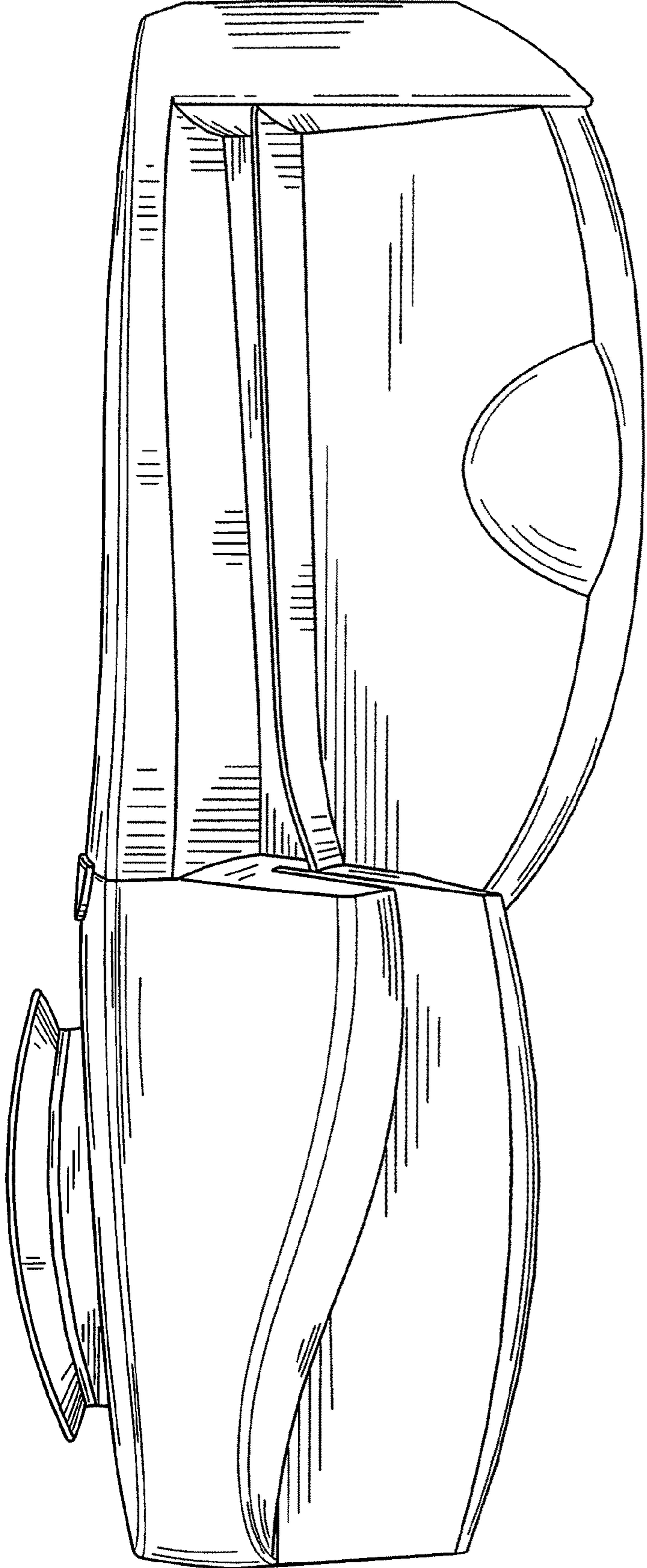

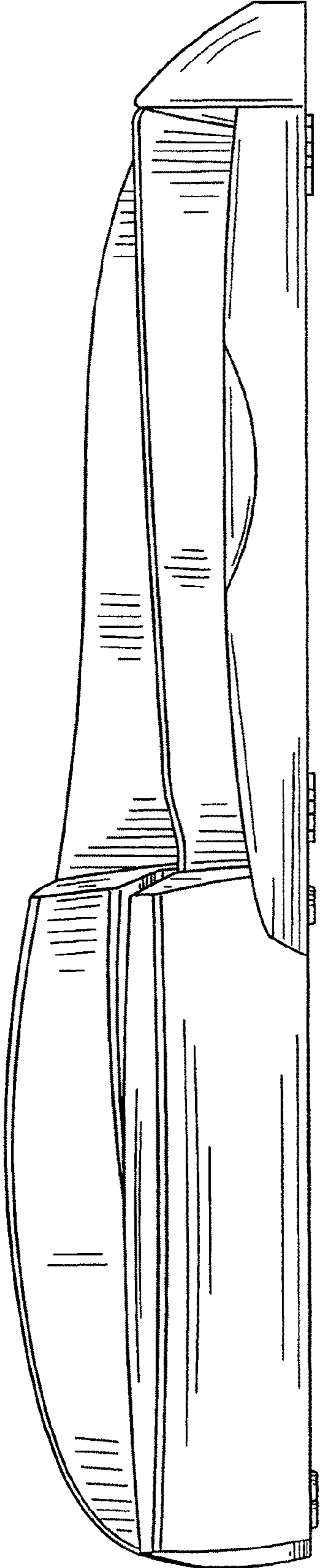

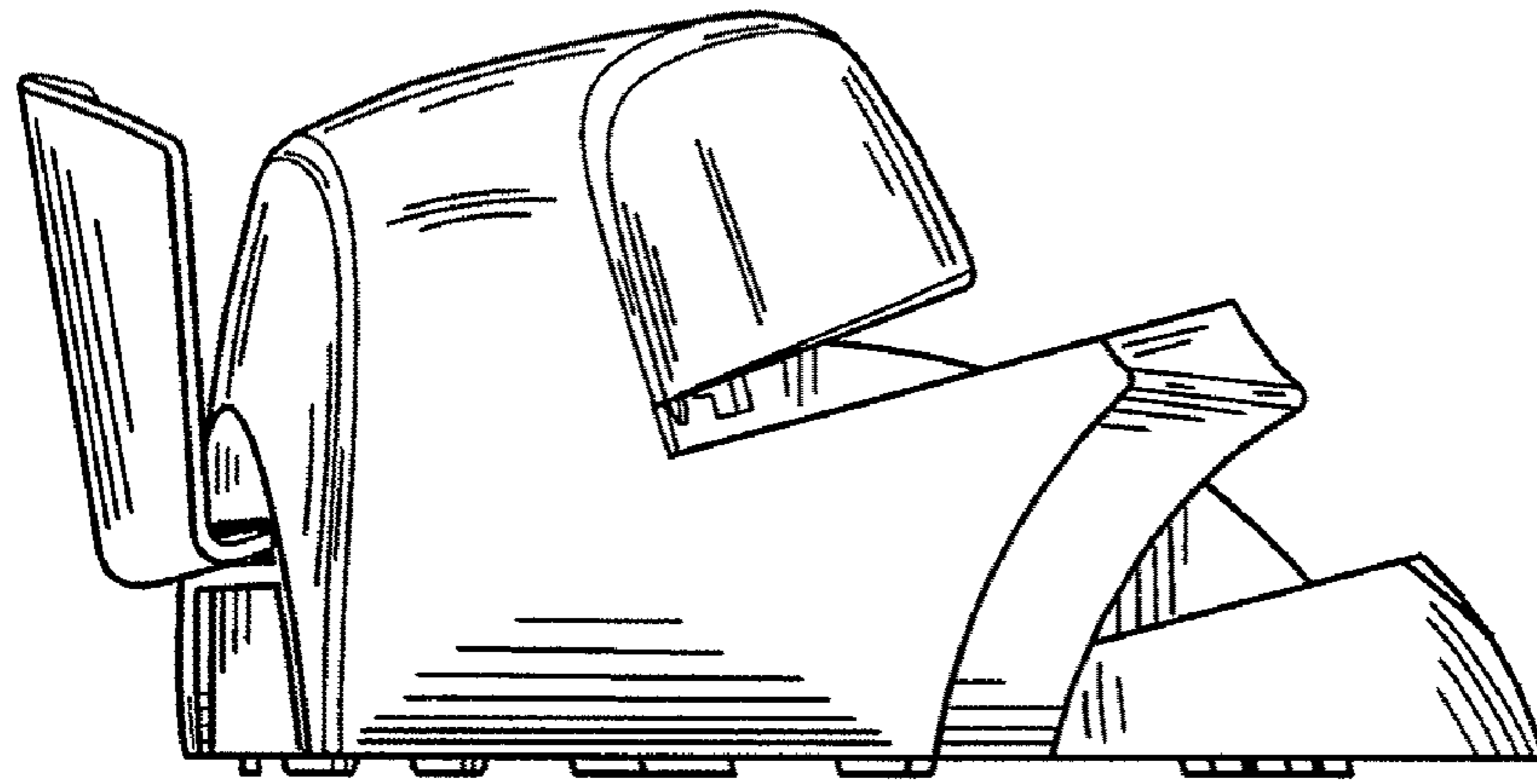

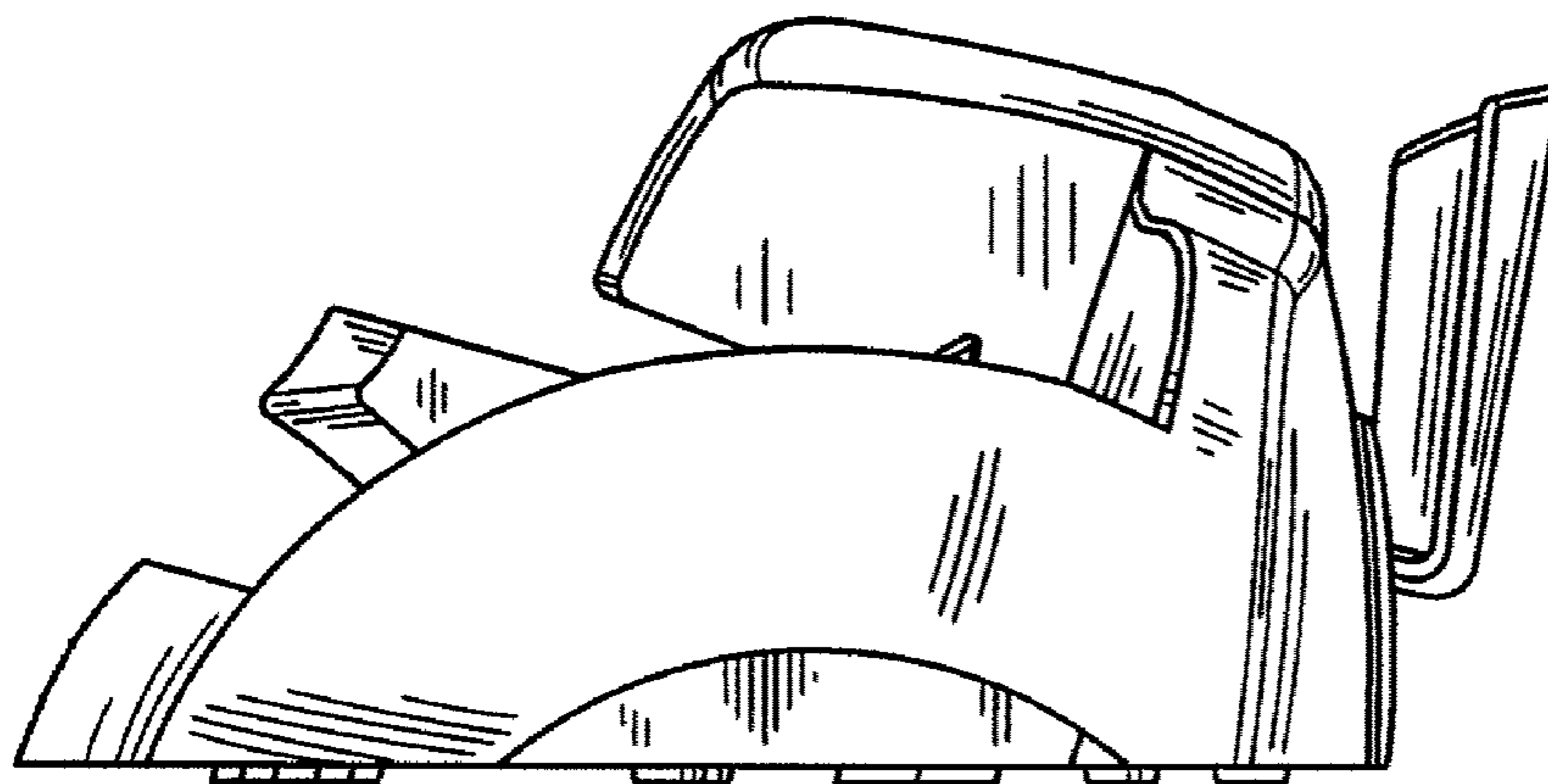

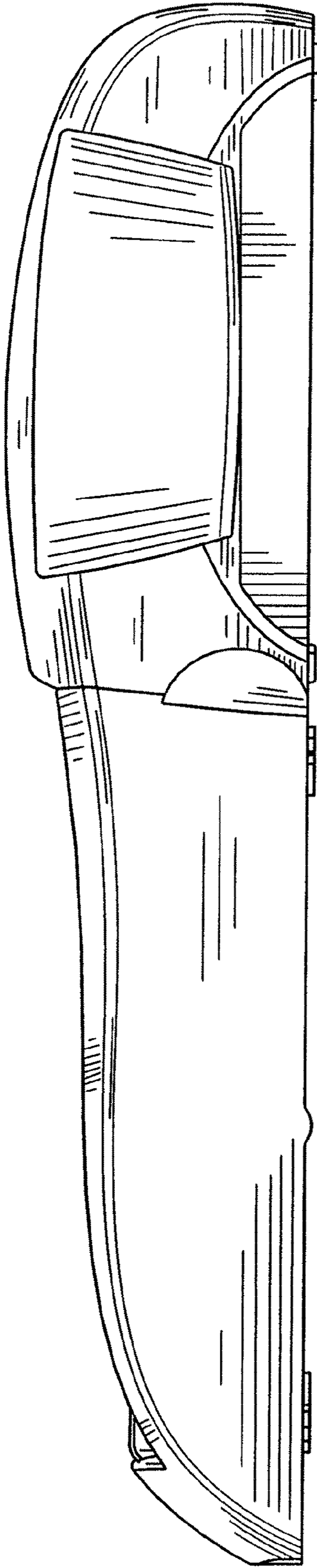
