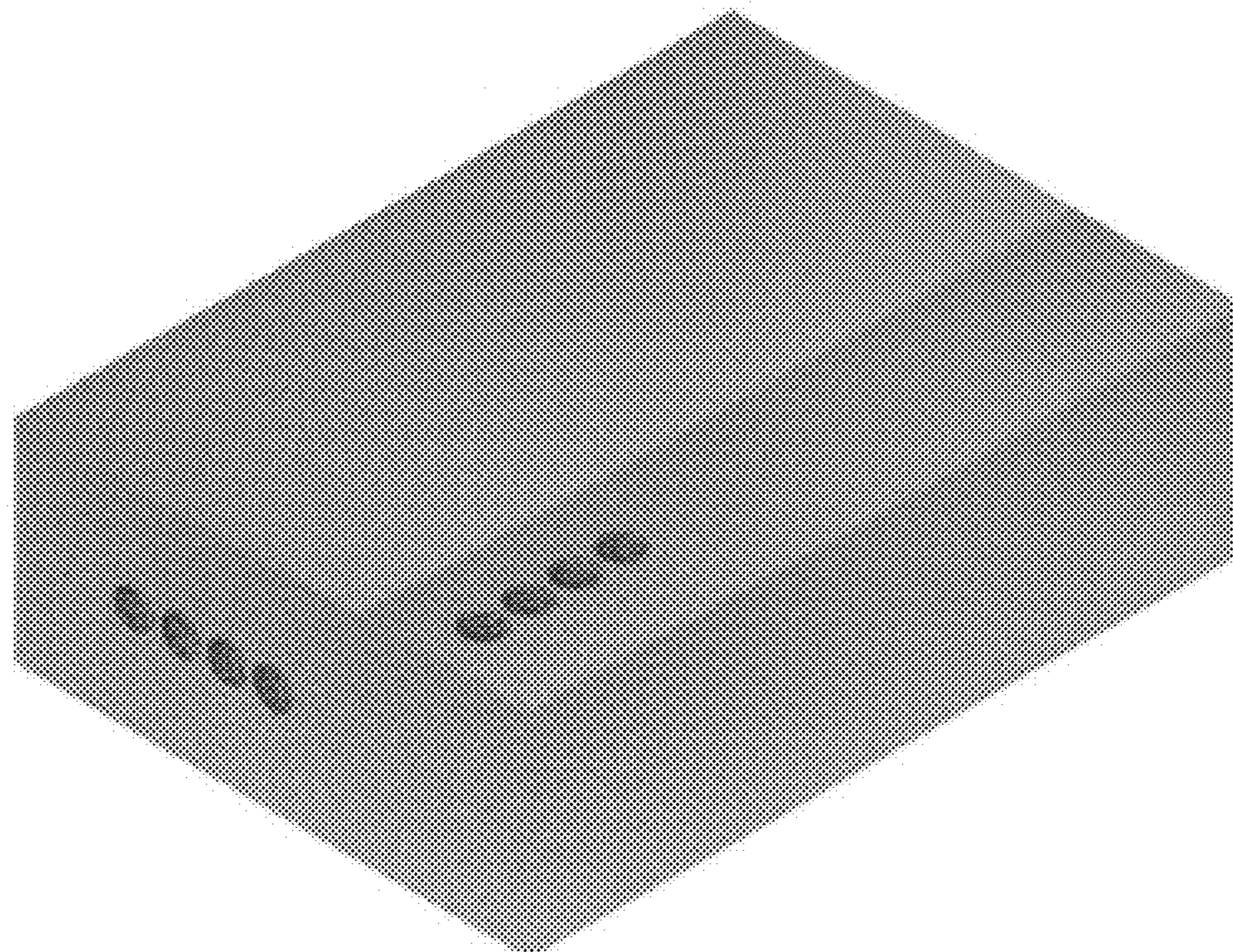
FIG. 3 is a top view of the design for a packaging box shown in FIG. 1;

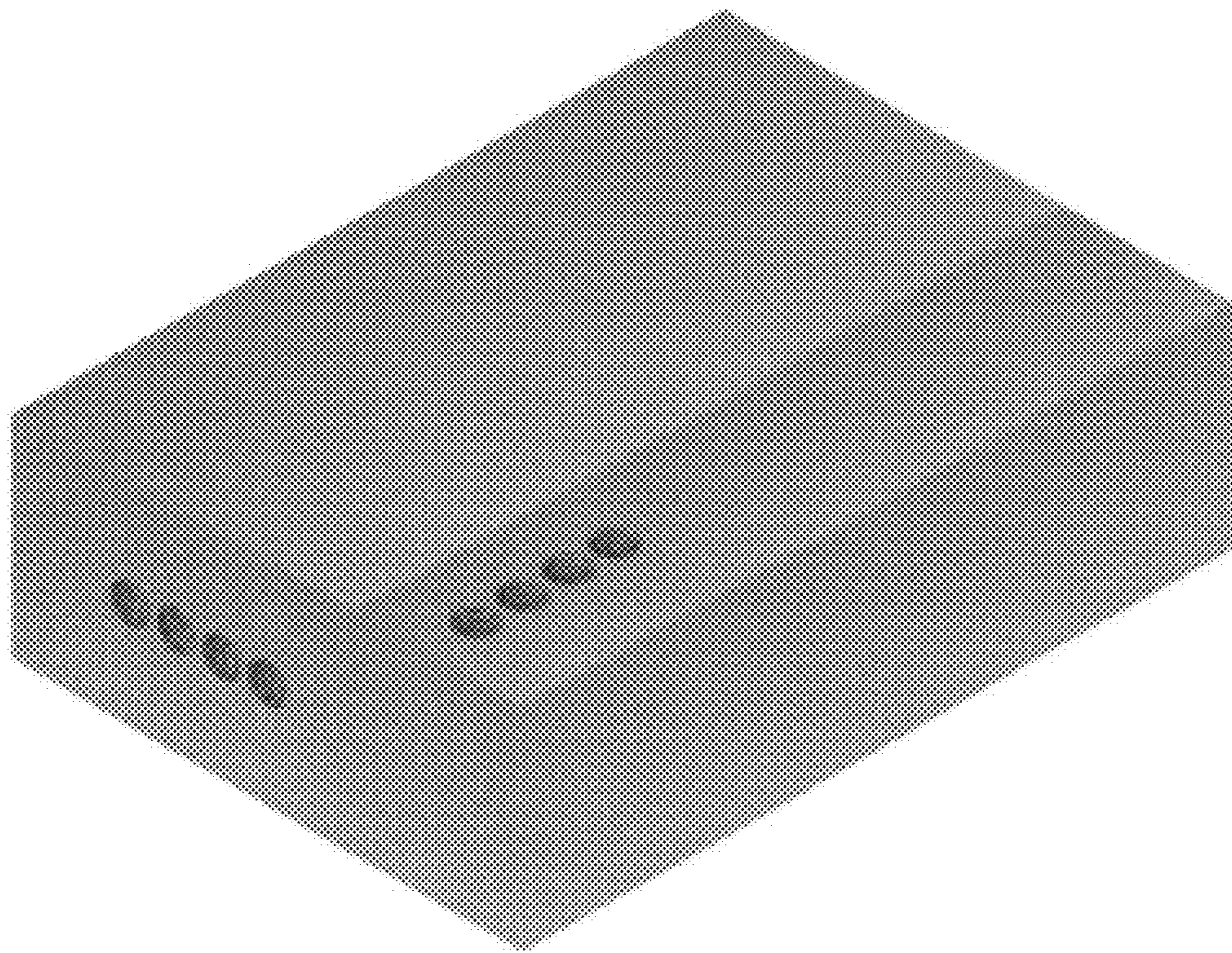

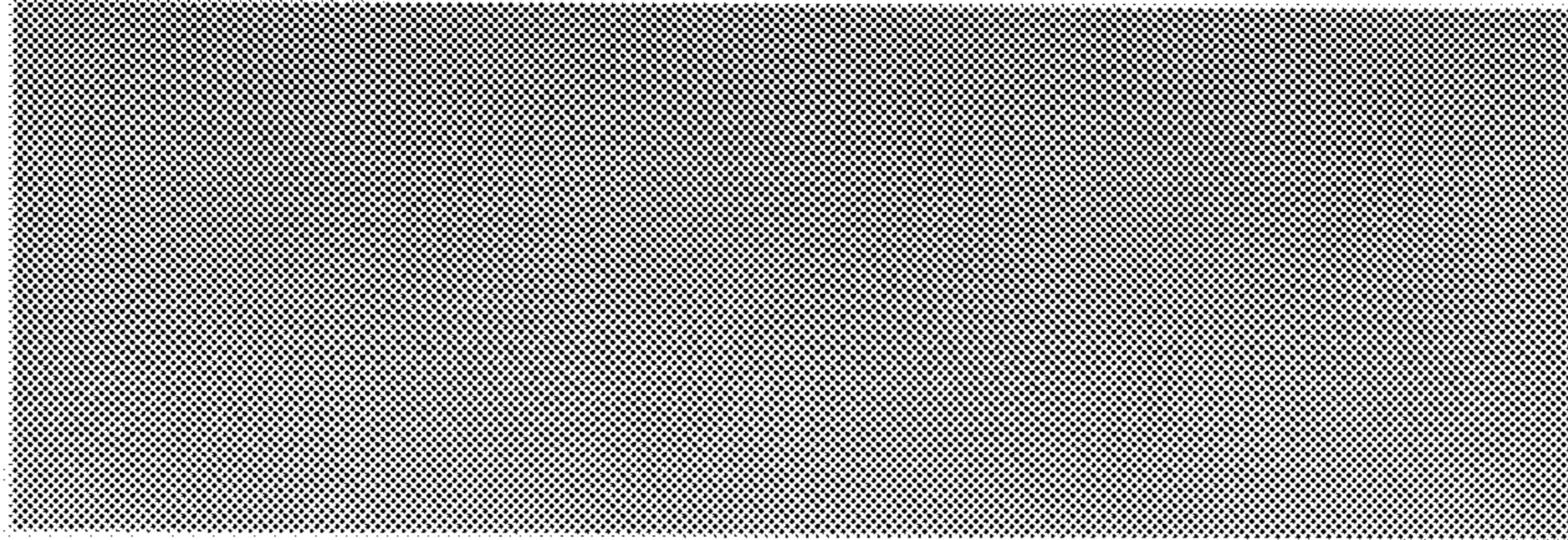

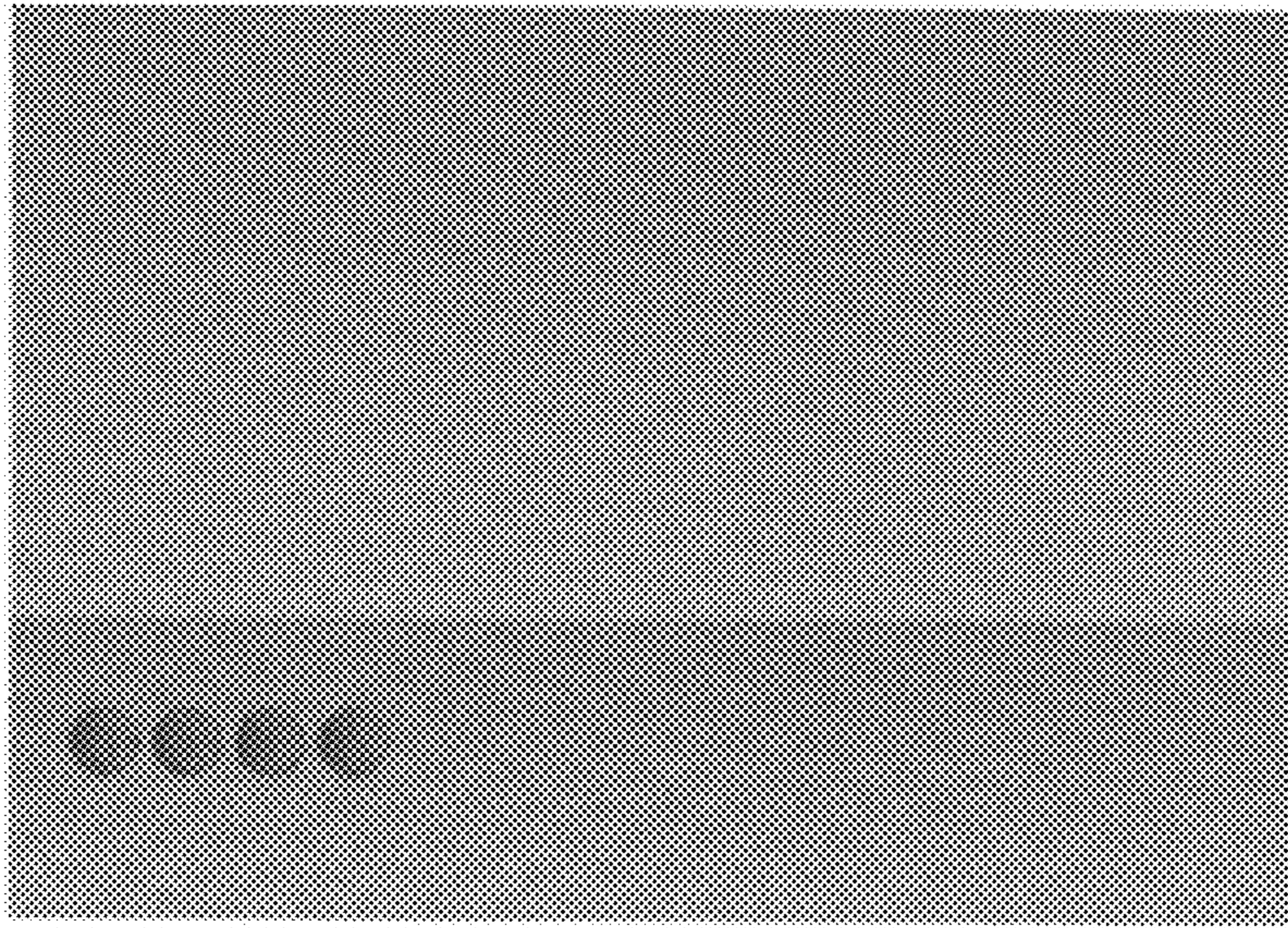

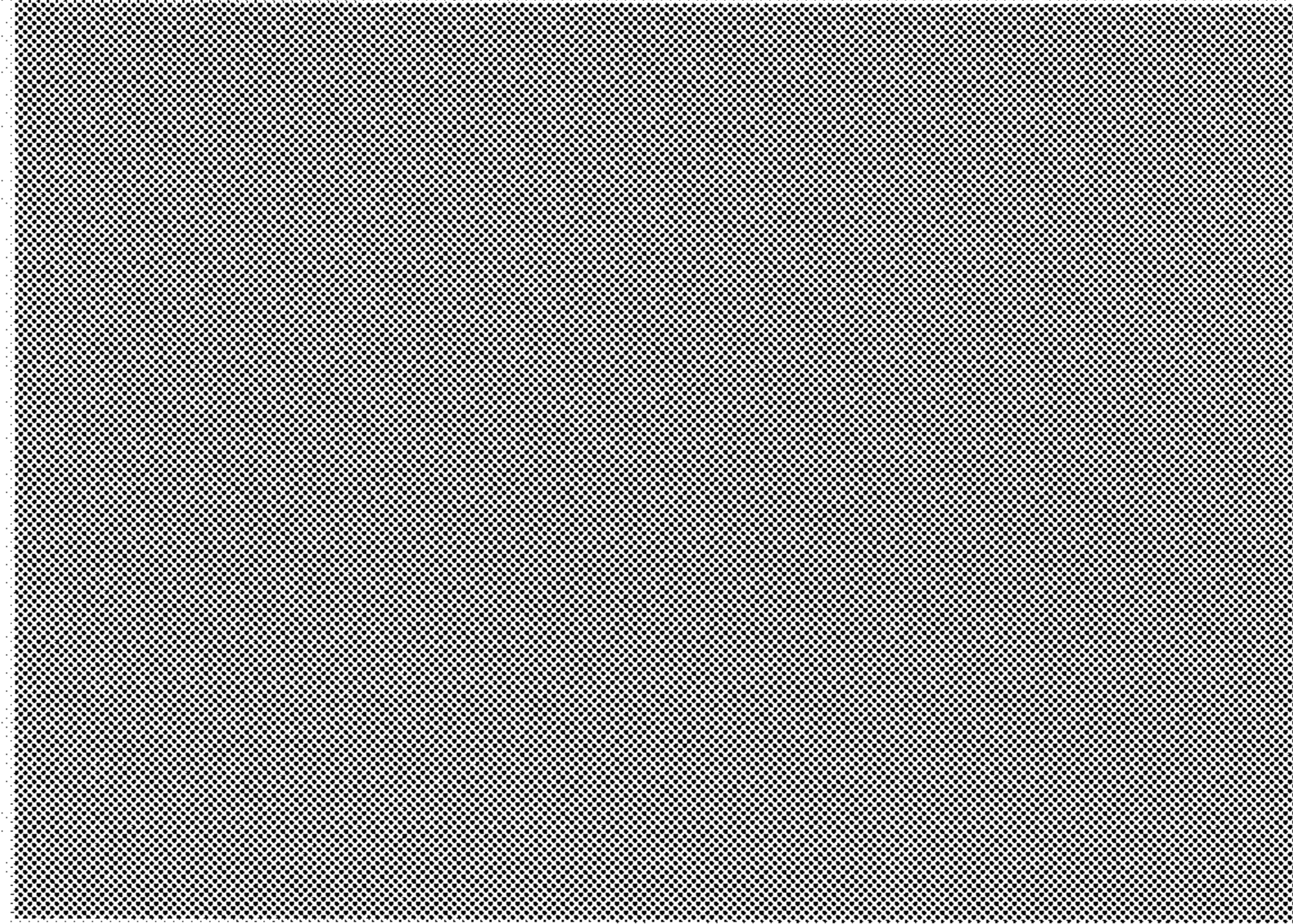

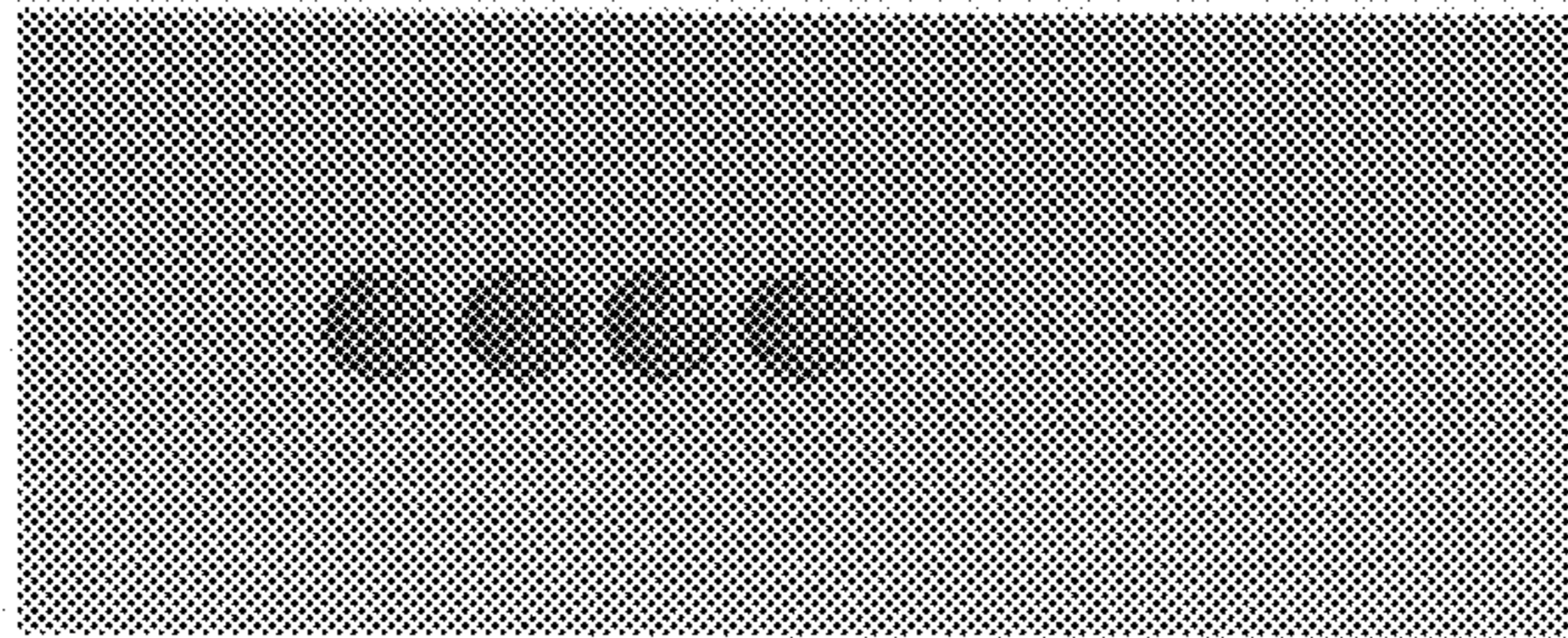

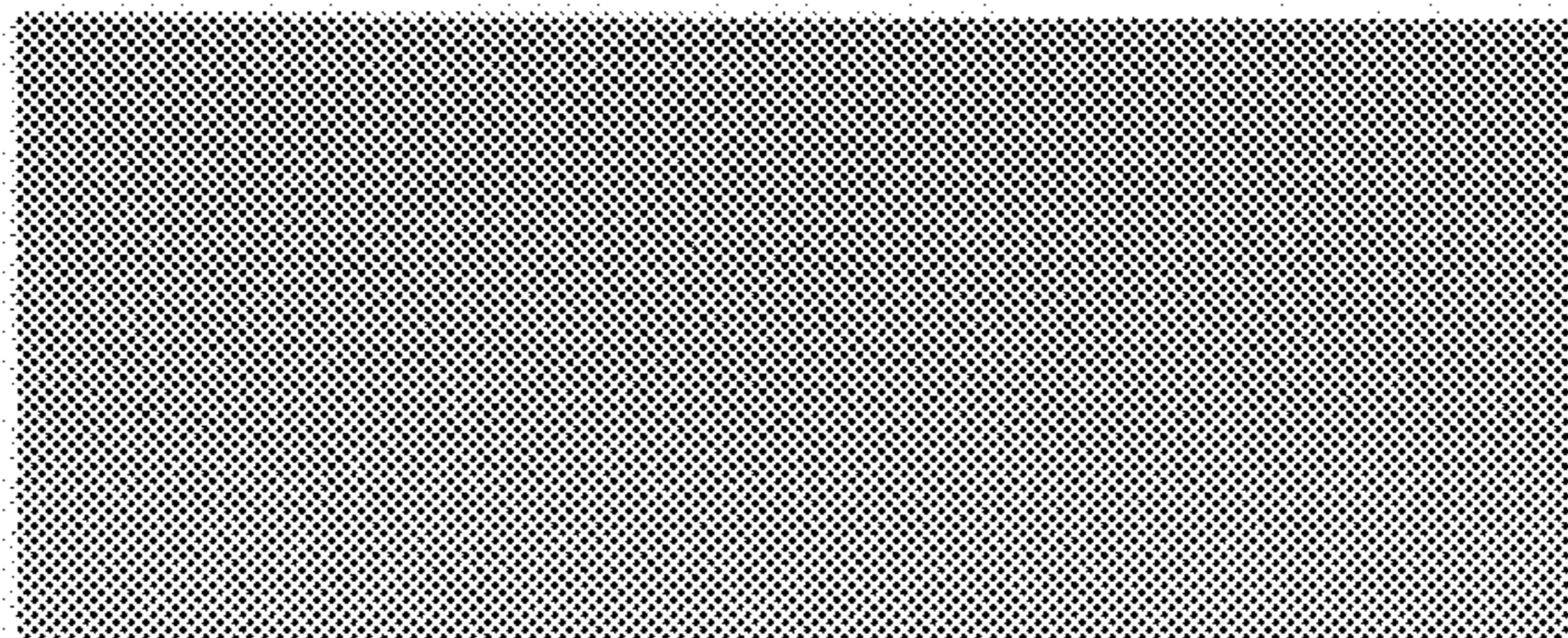
