The ornamental design for a pouring spout, as shown and described.

DESCRIPTION

FIG. 1 is a left side view of a pouring spout, in accordance the present design;

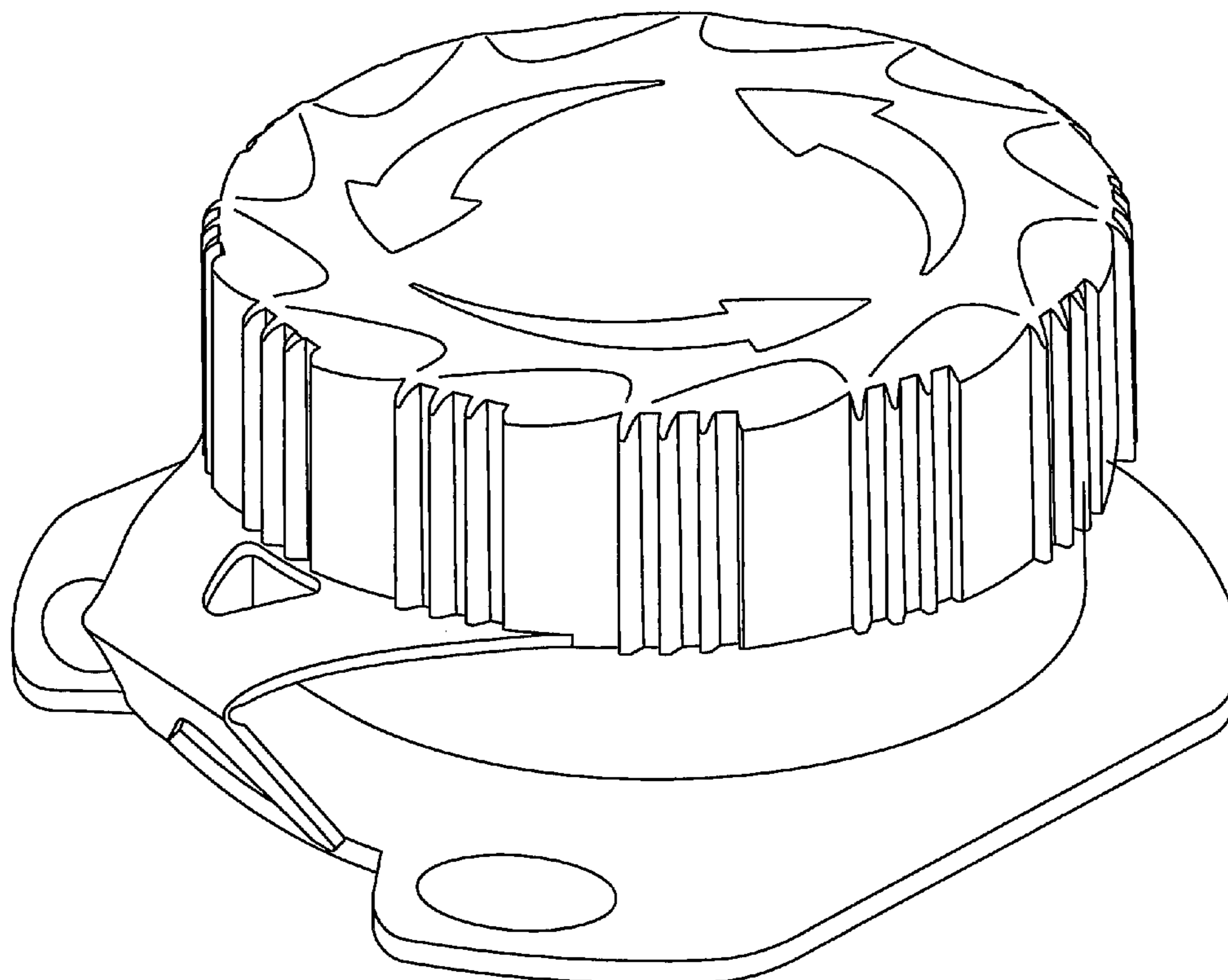
FIG. 2 is a front view of the pouring spout shown in FIG. 1; FIG. 3 is a perspective view of the pouring spout shown in FIG. 1;

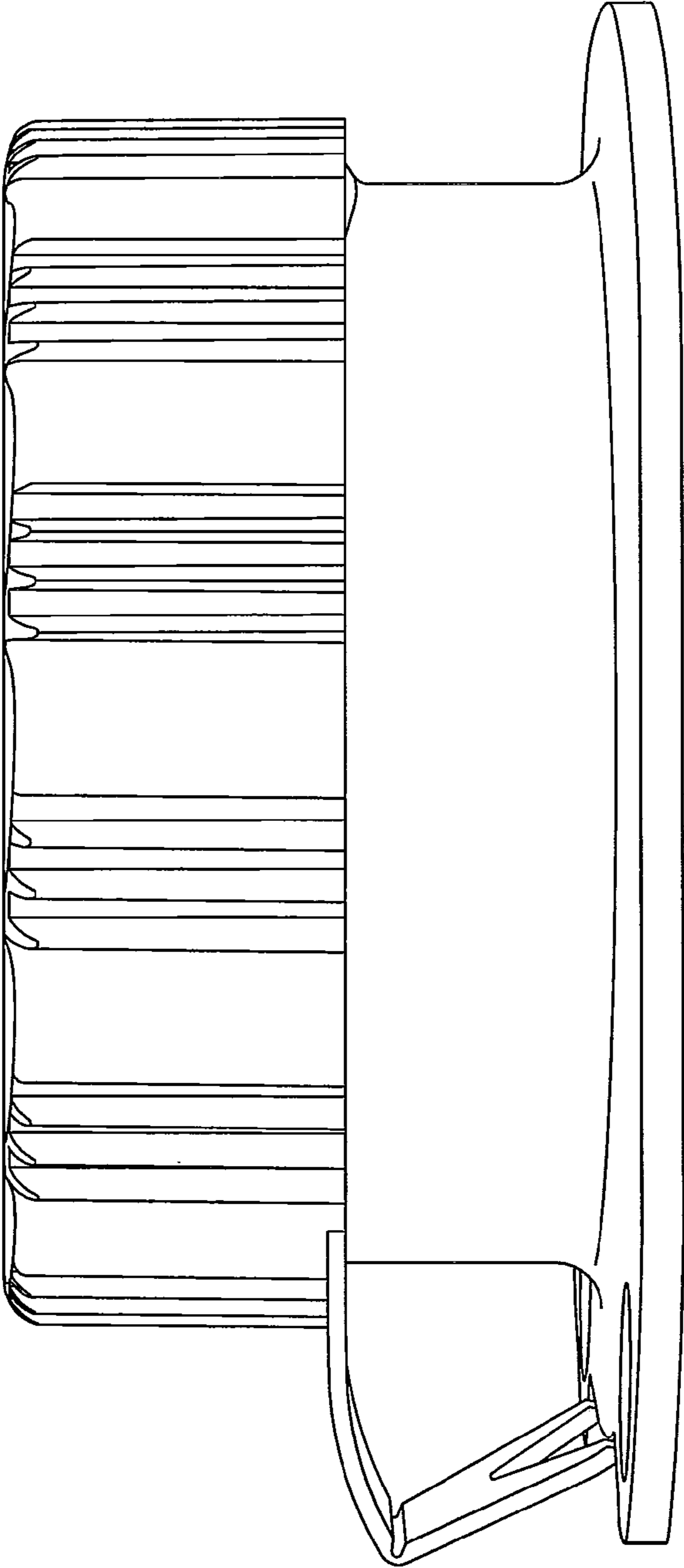

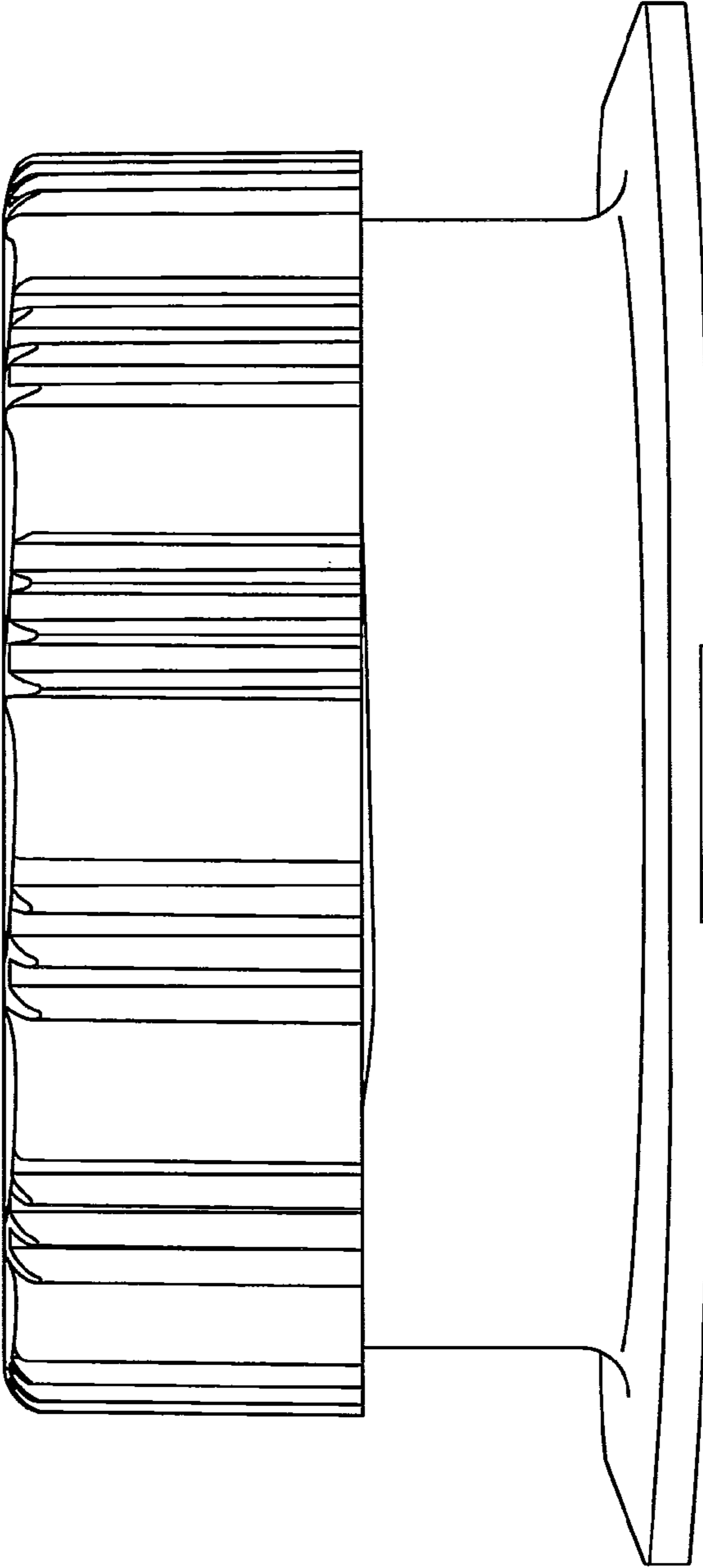

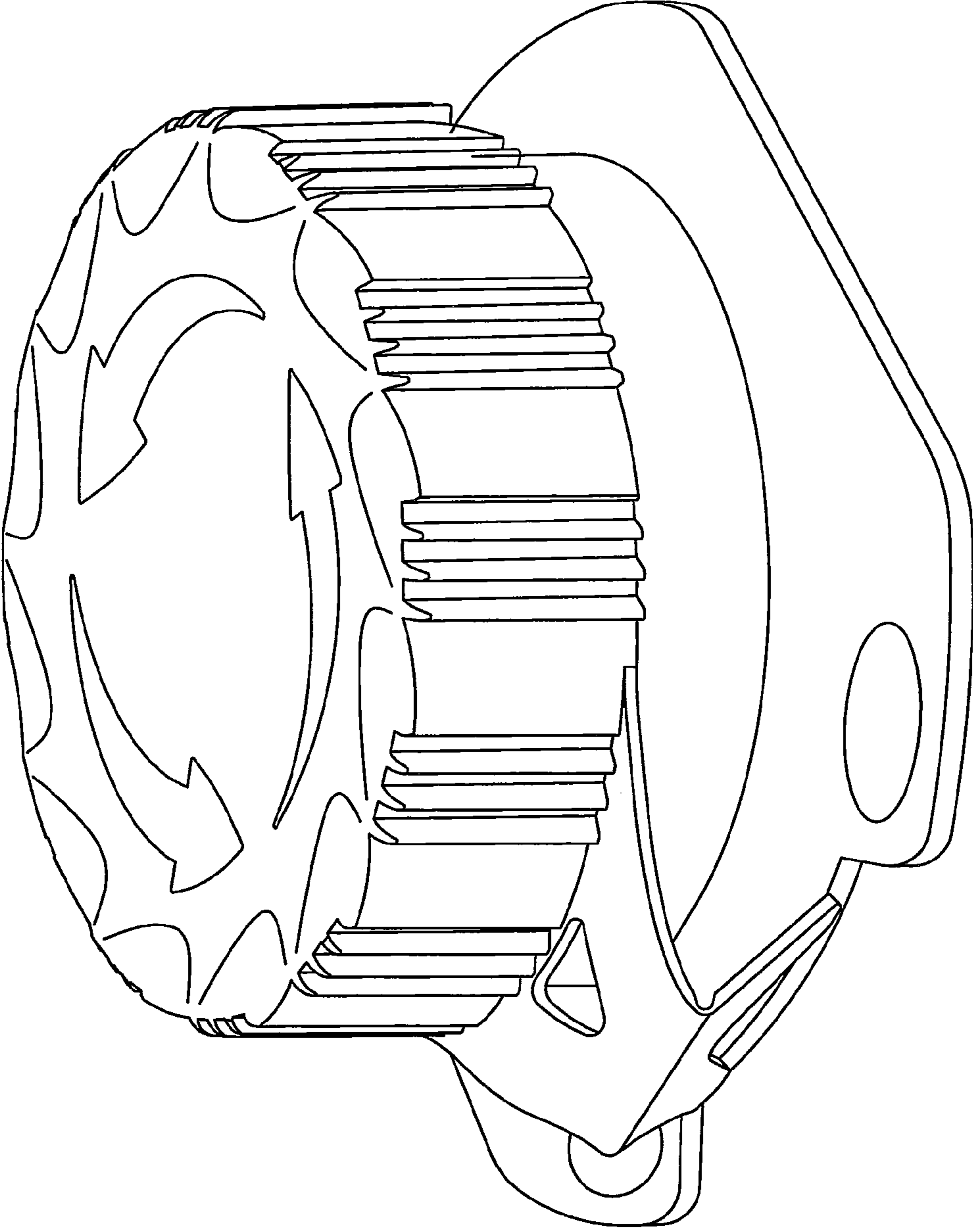

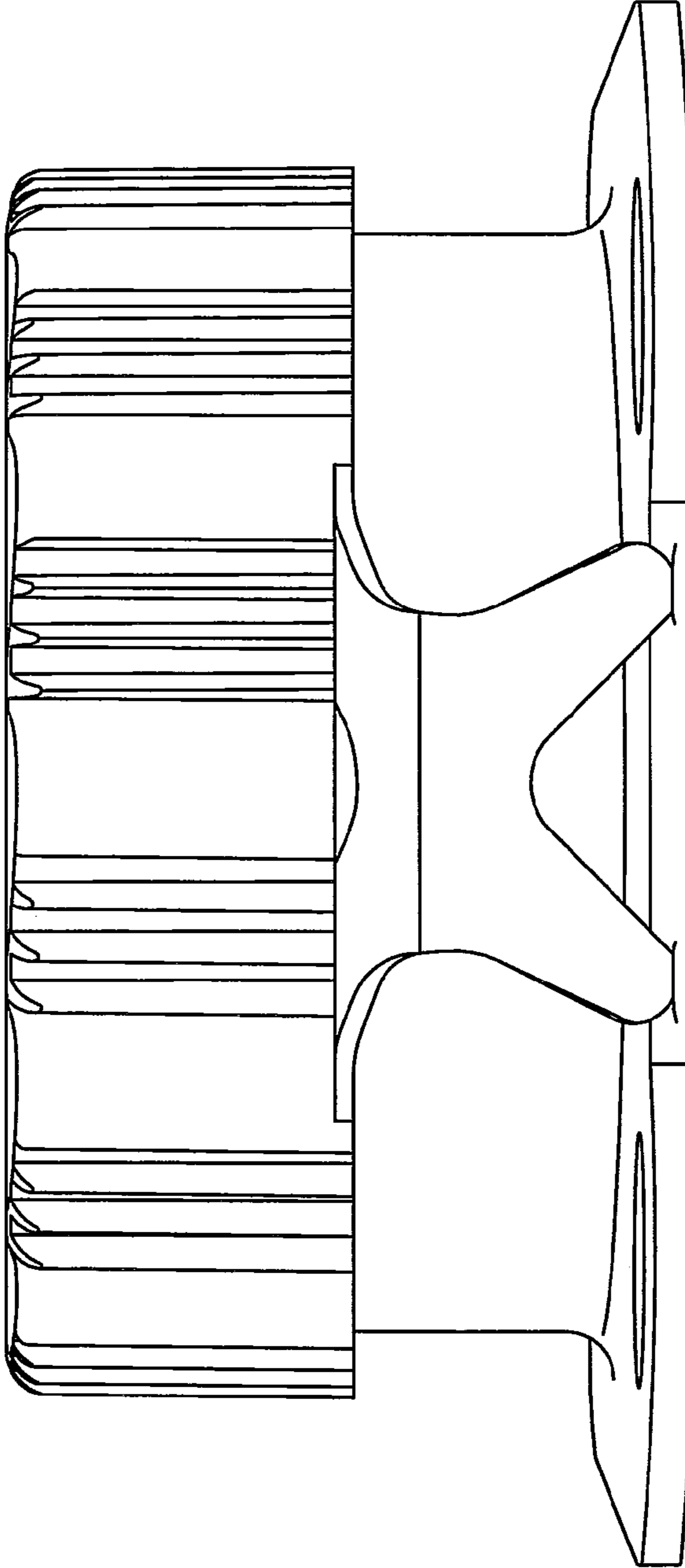

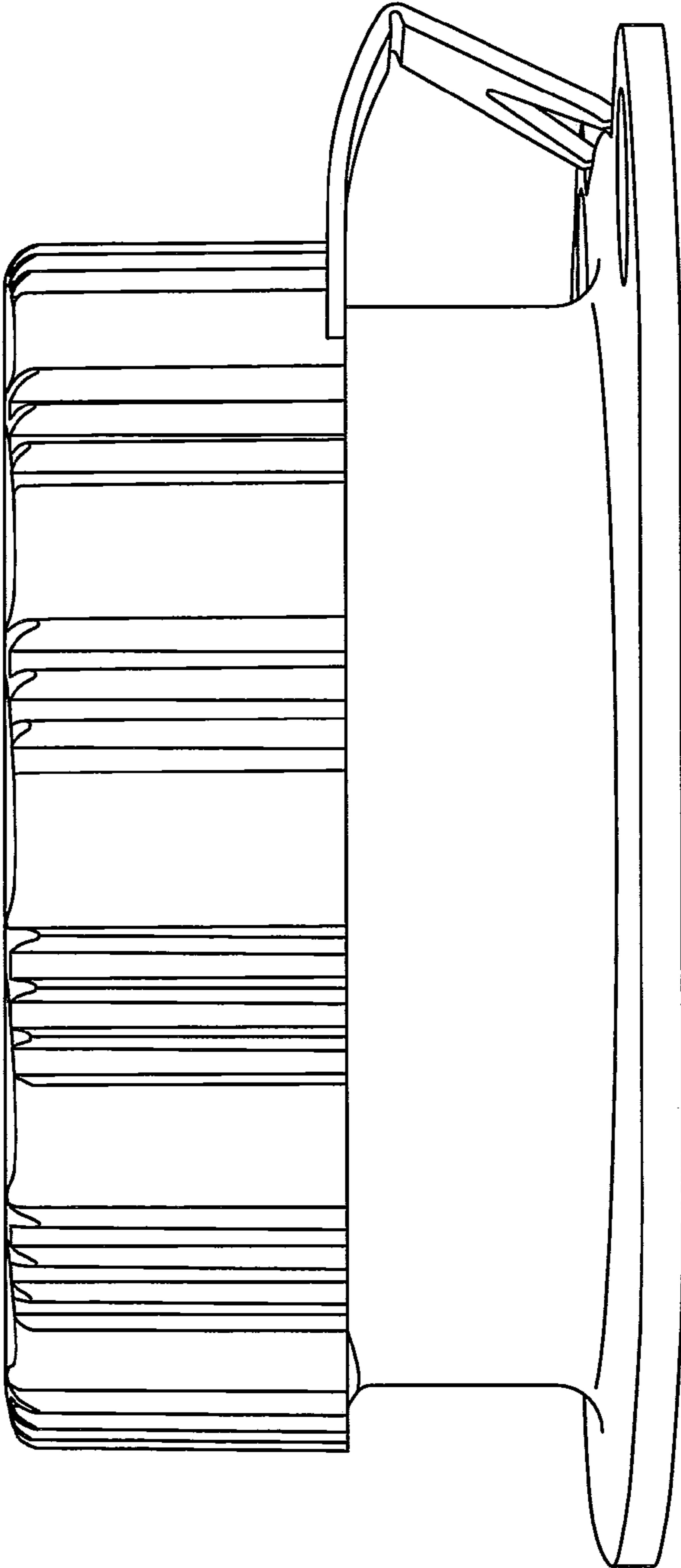

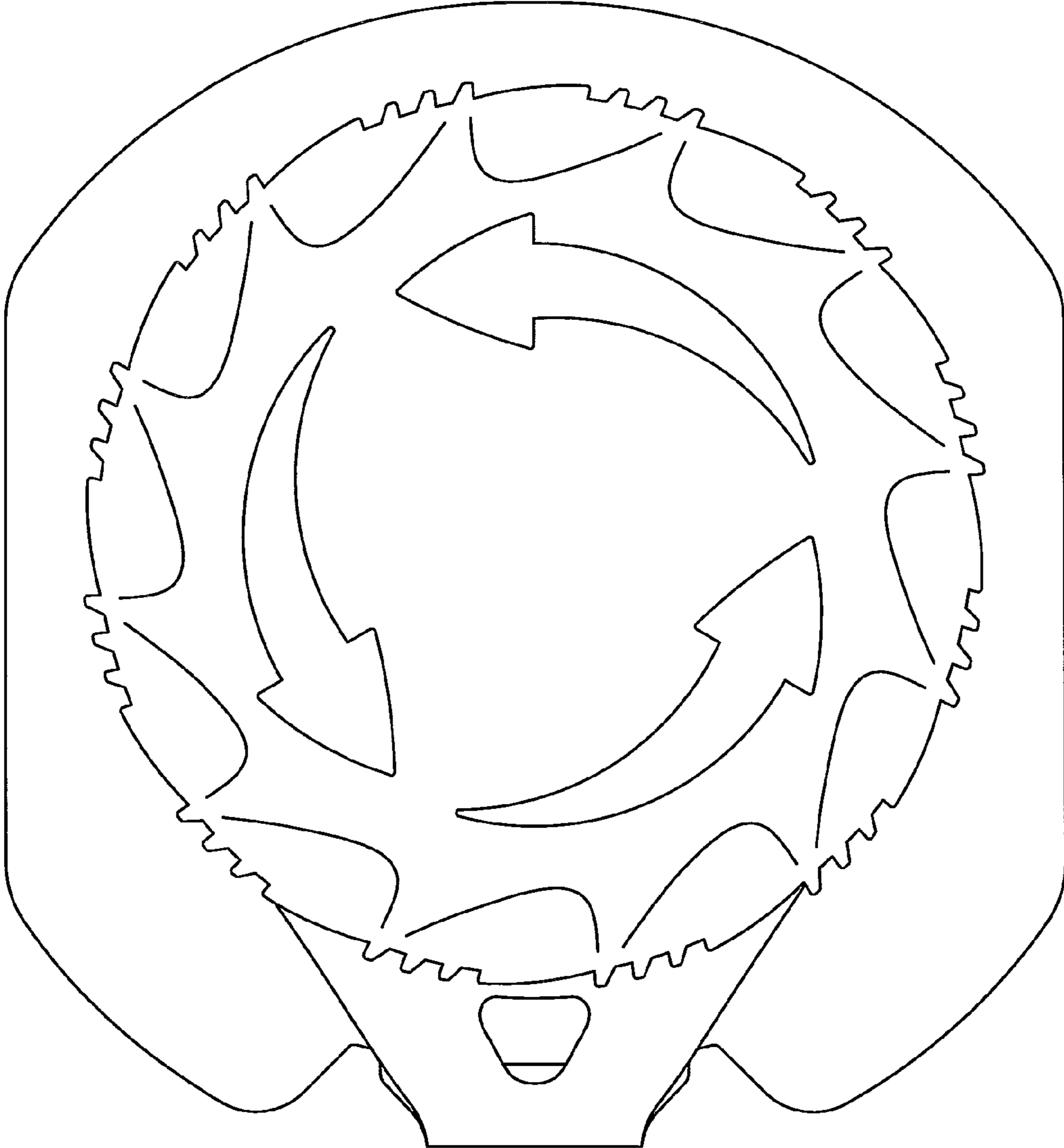
