(57) **CLAIM**

The ornamental design for a projector, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right-side perspective view of a projector showing my new design;
FIG. 2 is a rear, top, left-side perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;

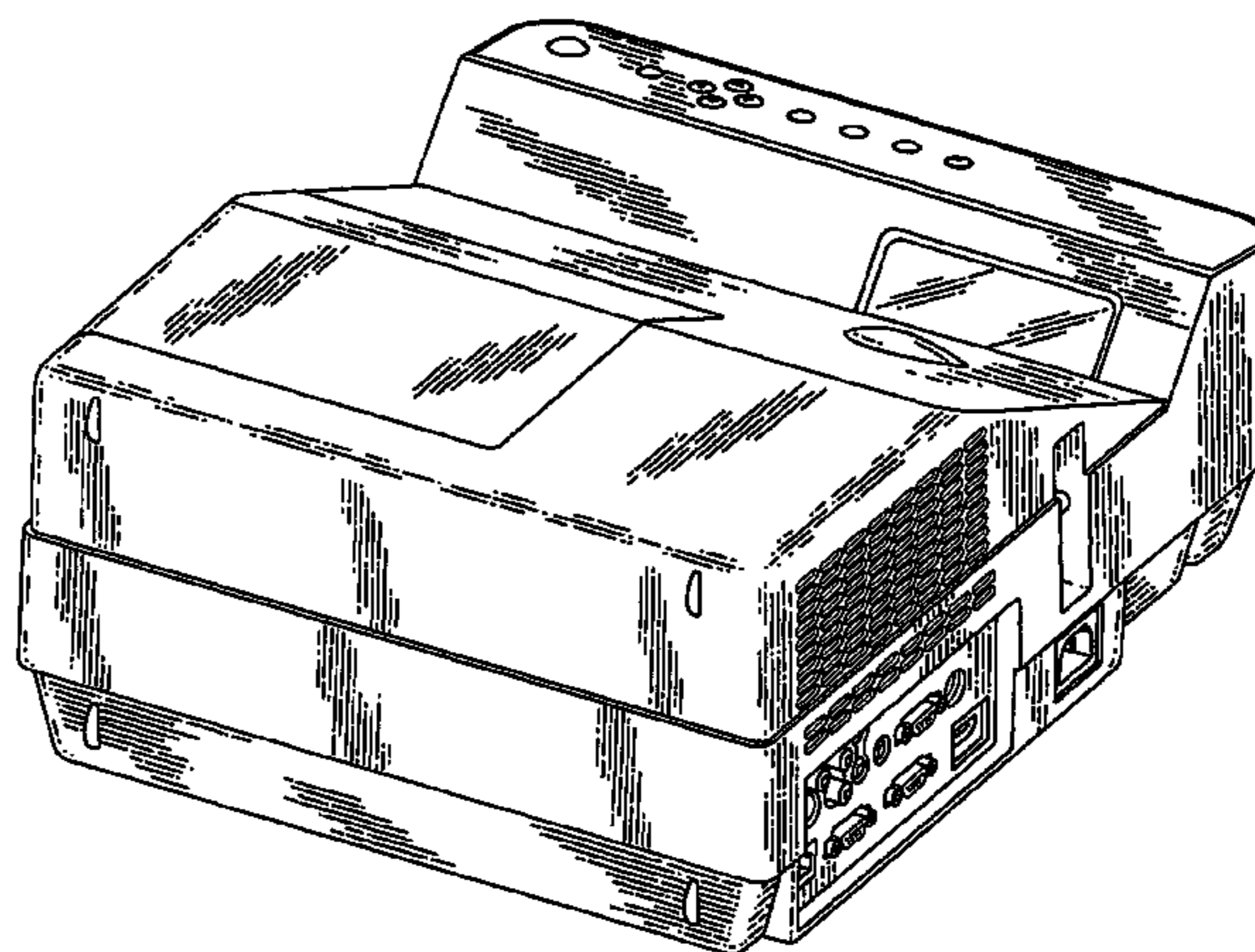
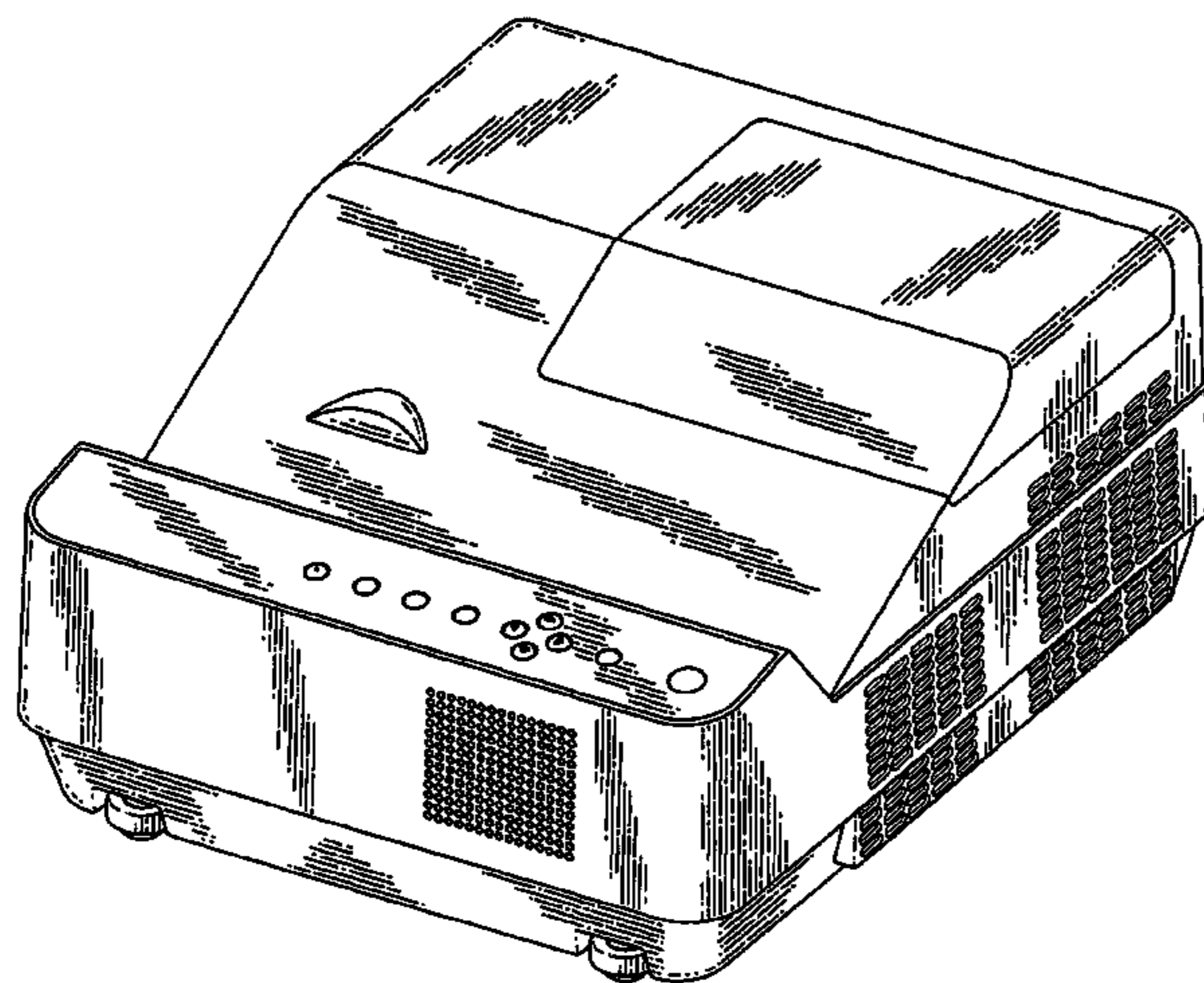

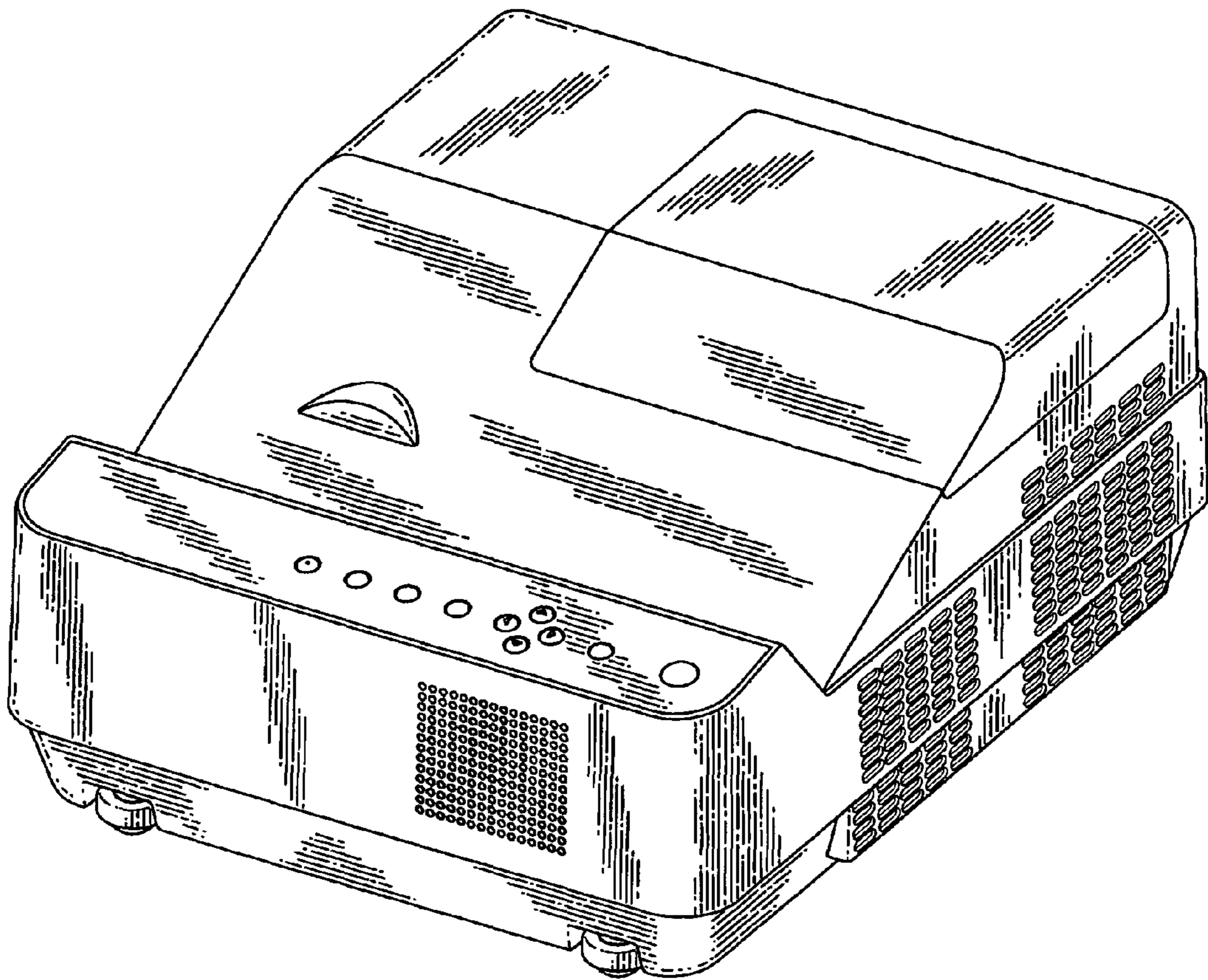

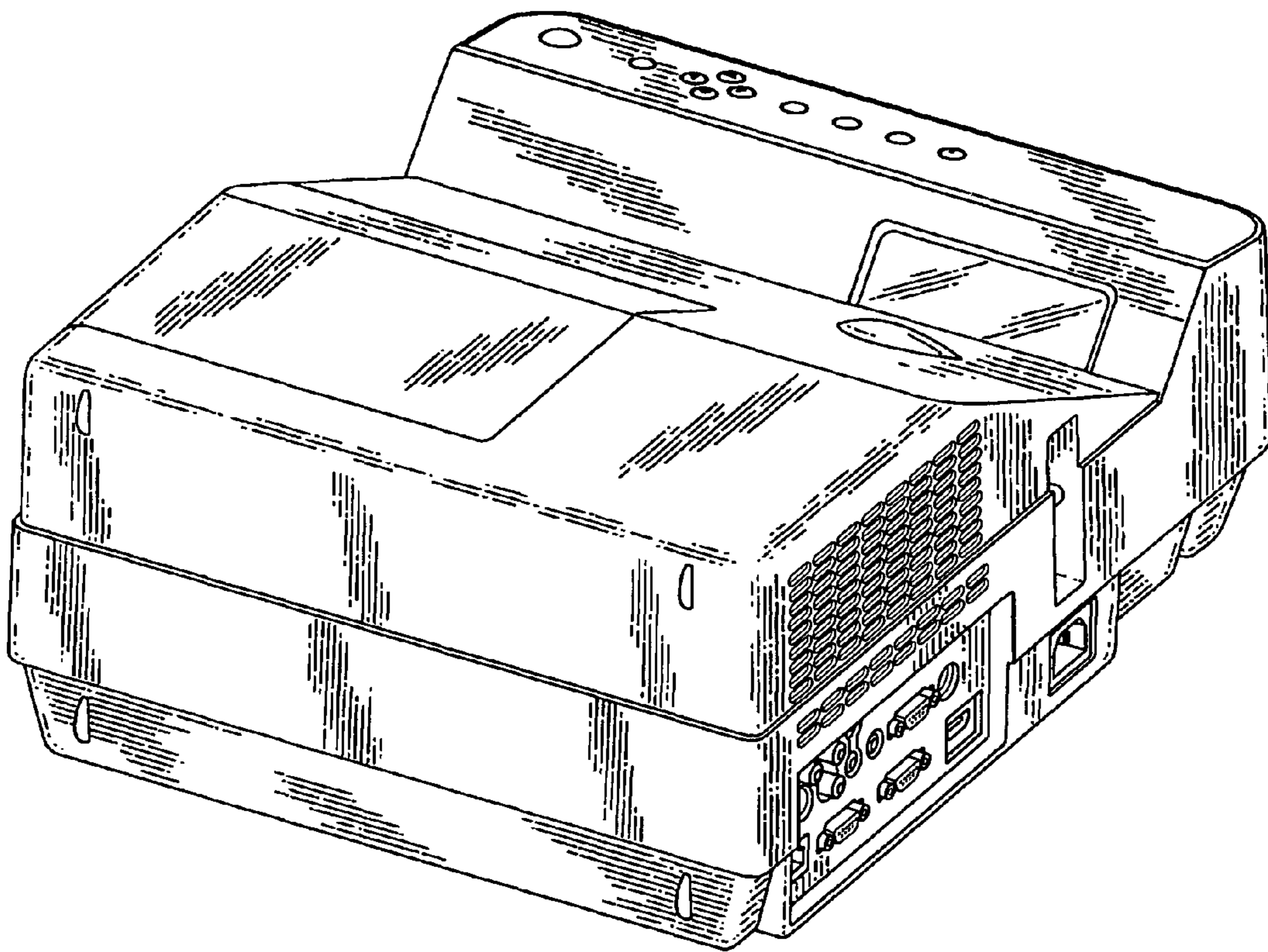

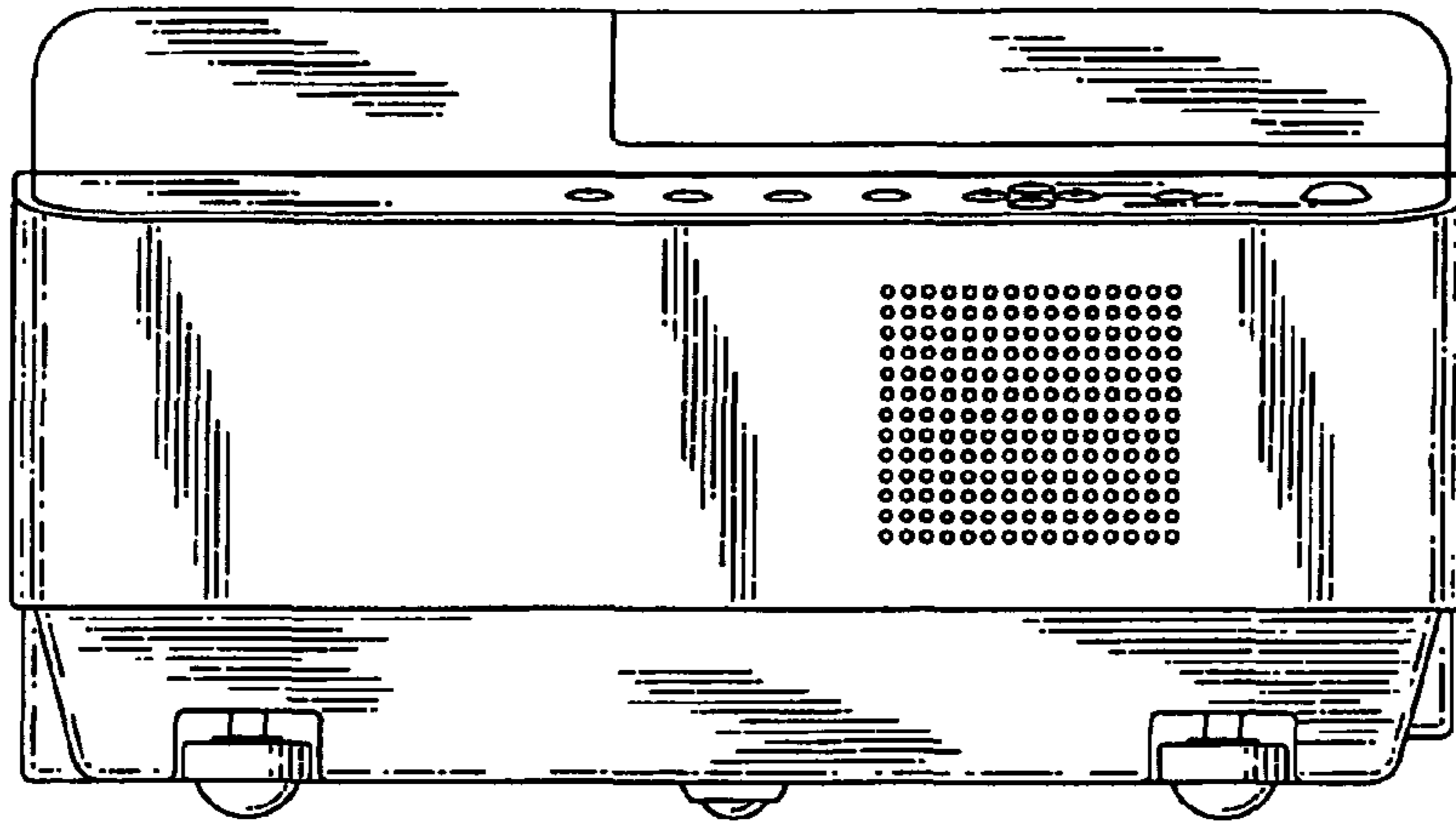

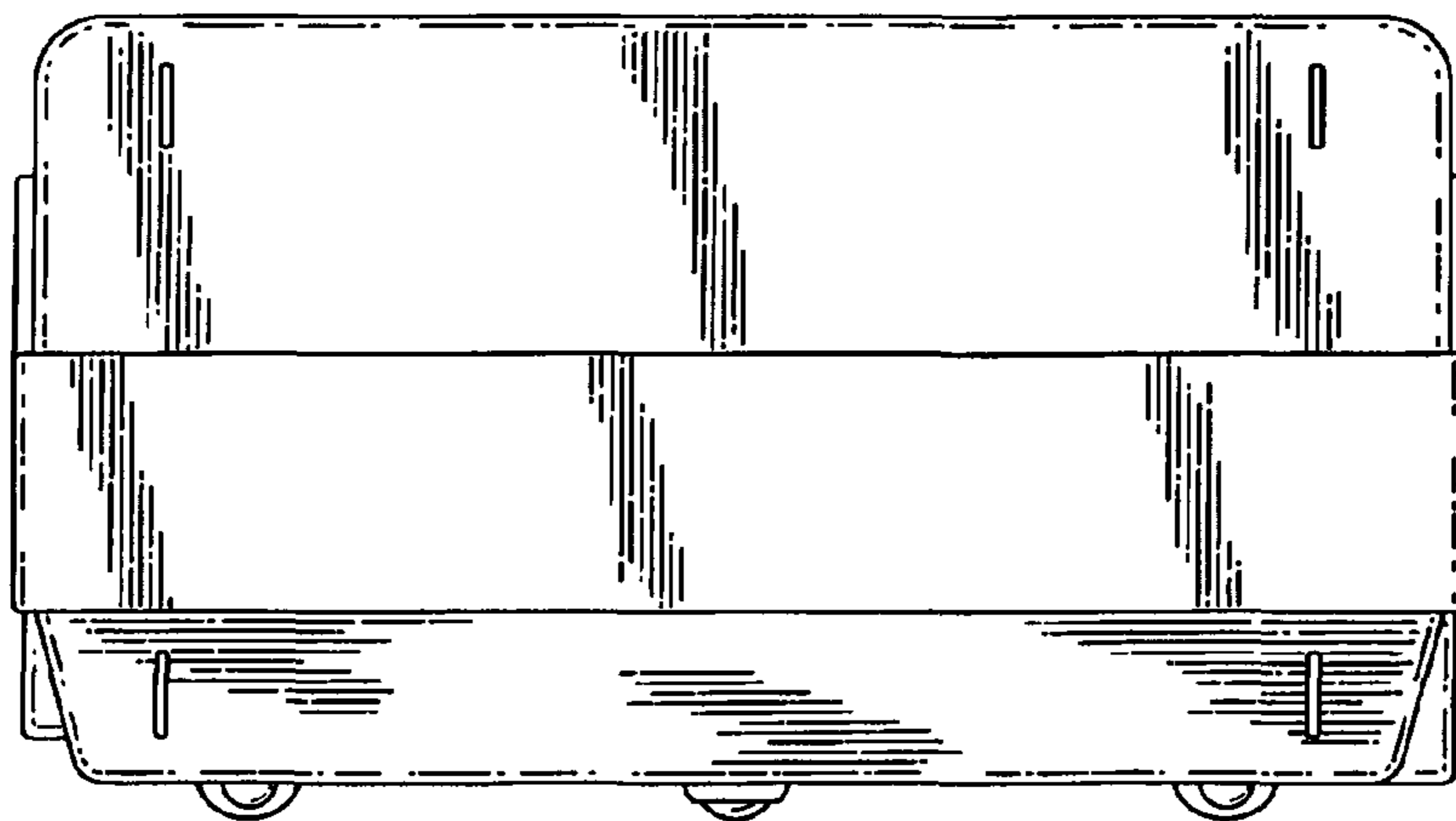

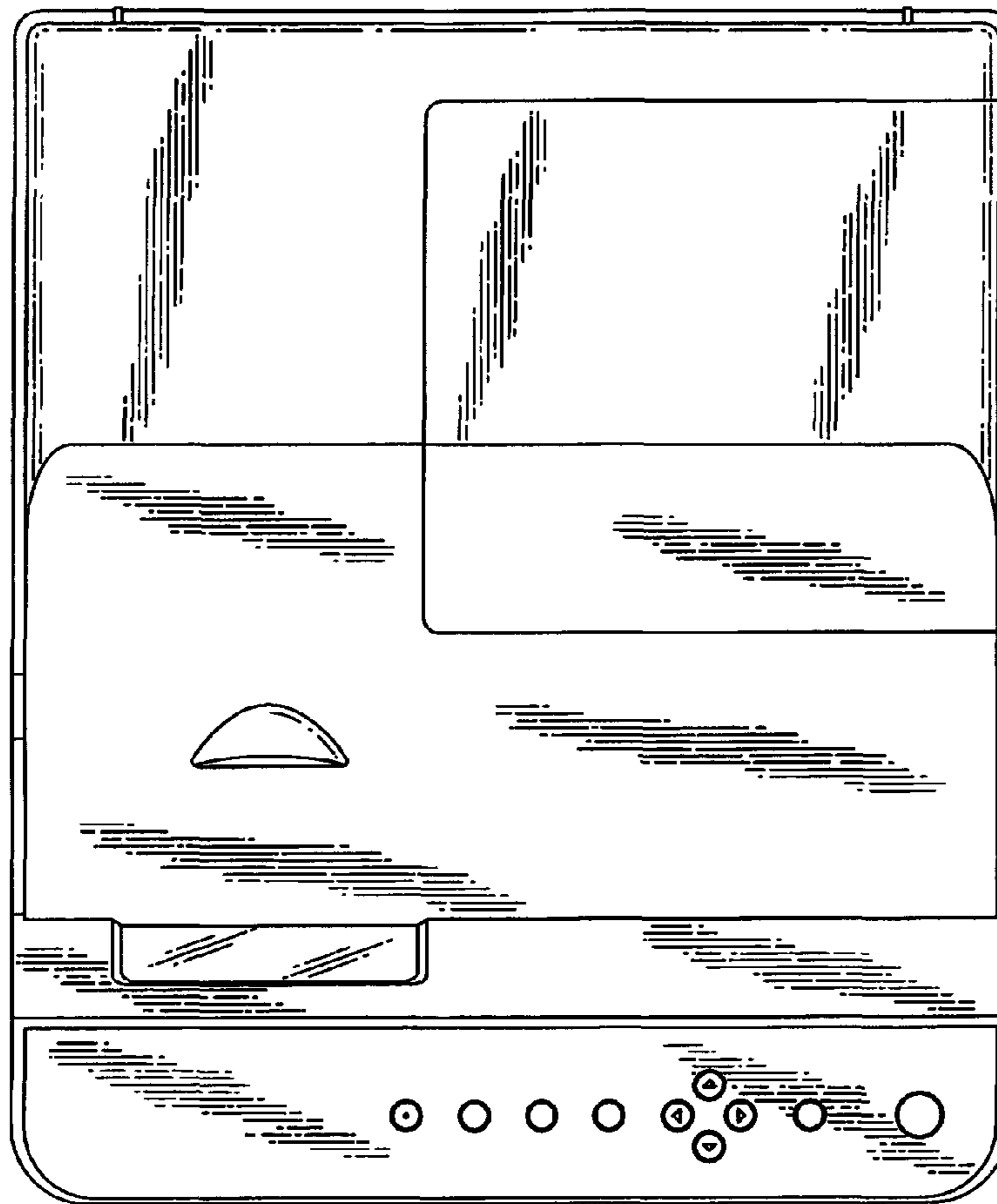

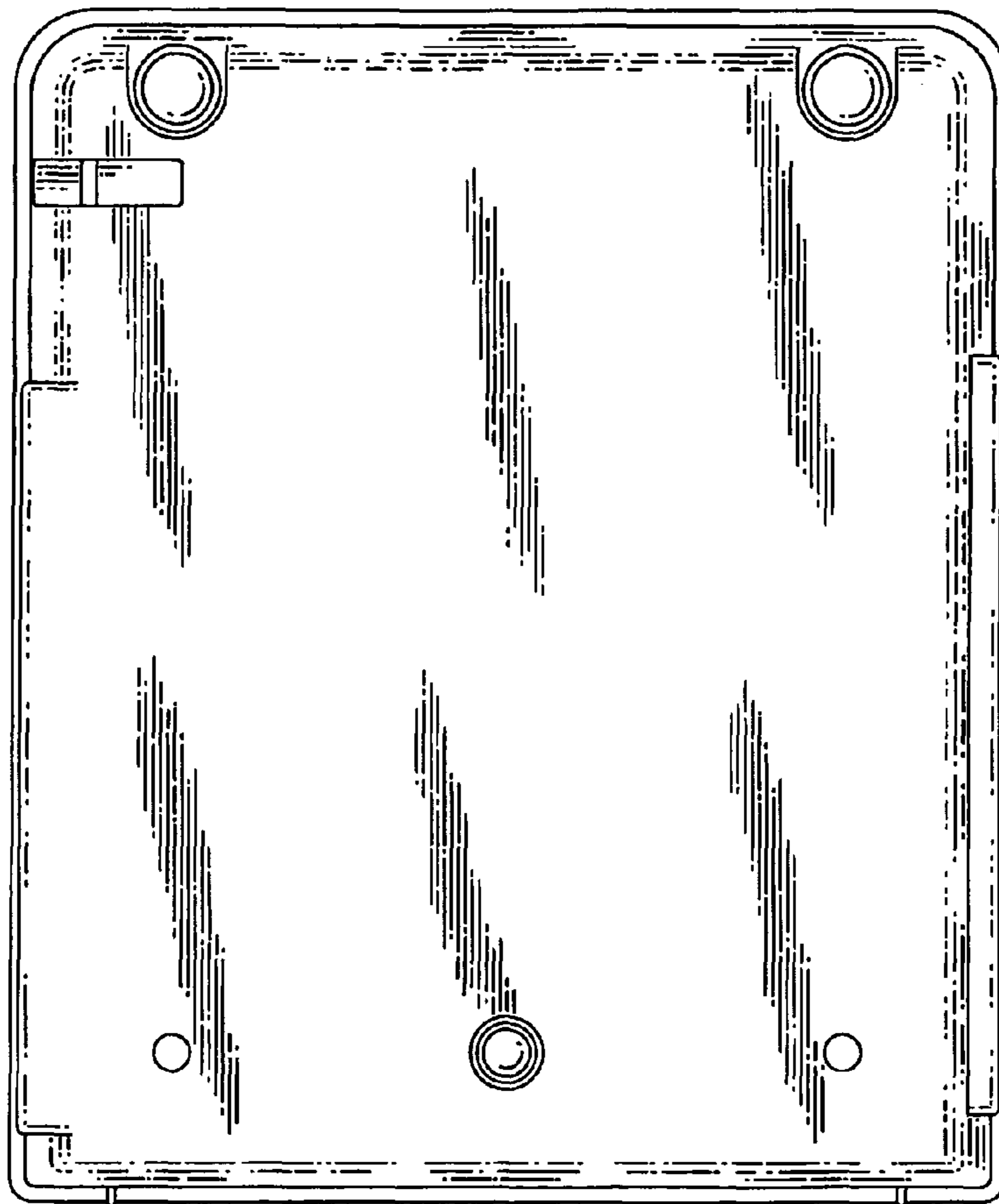

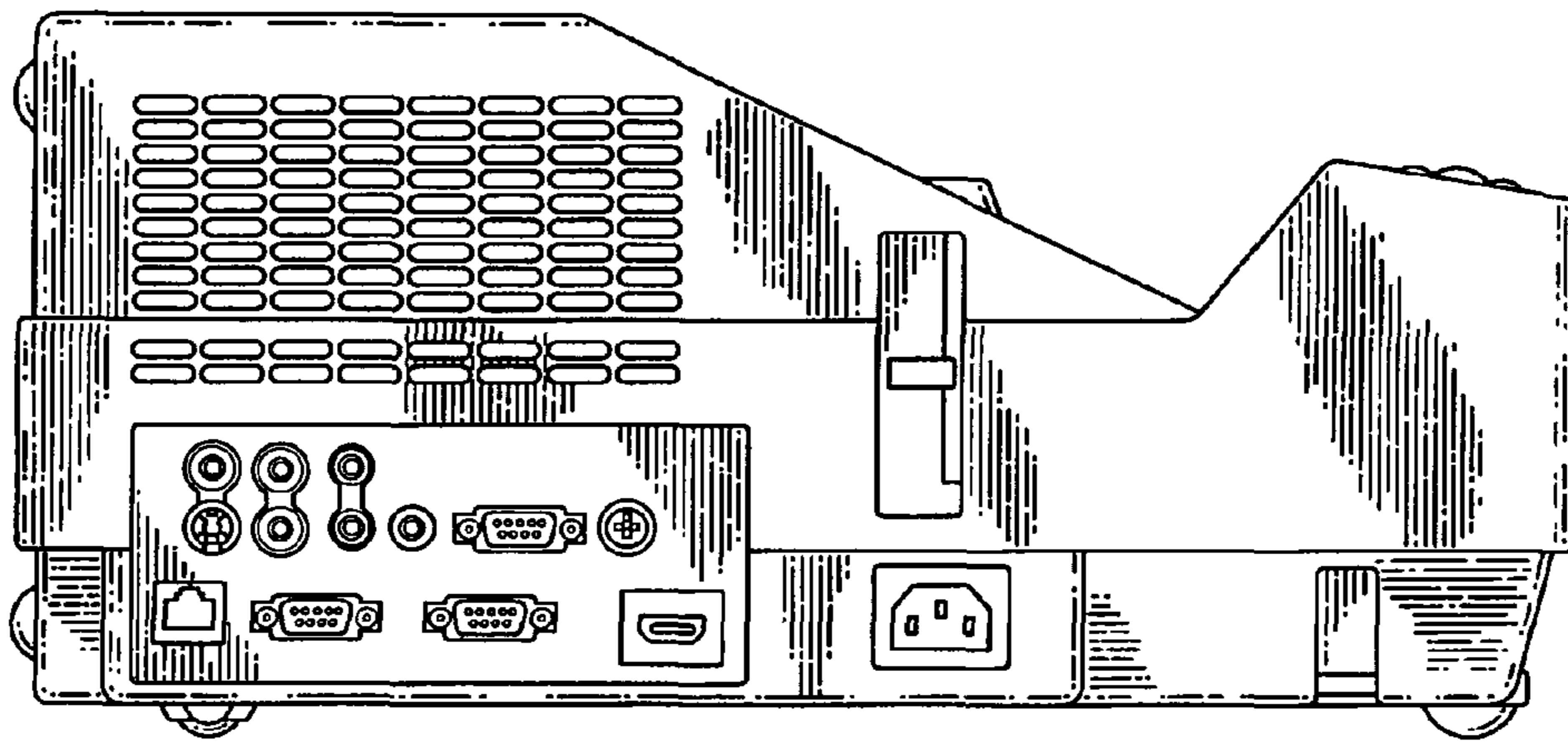
