FIG. 1 is a perspective view of a shredder according to a first embodiment of our new design;

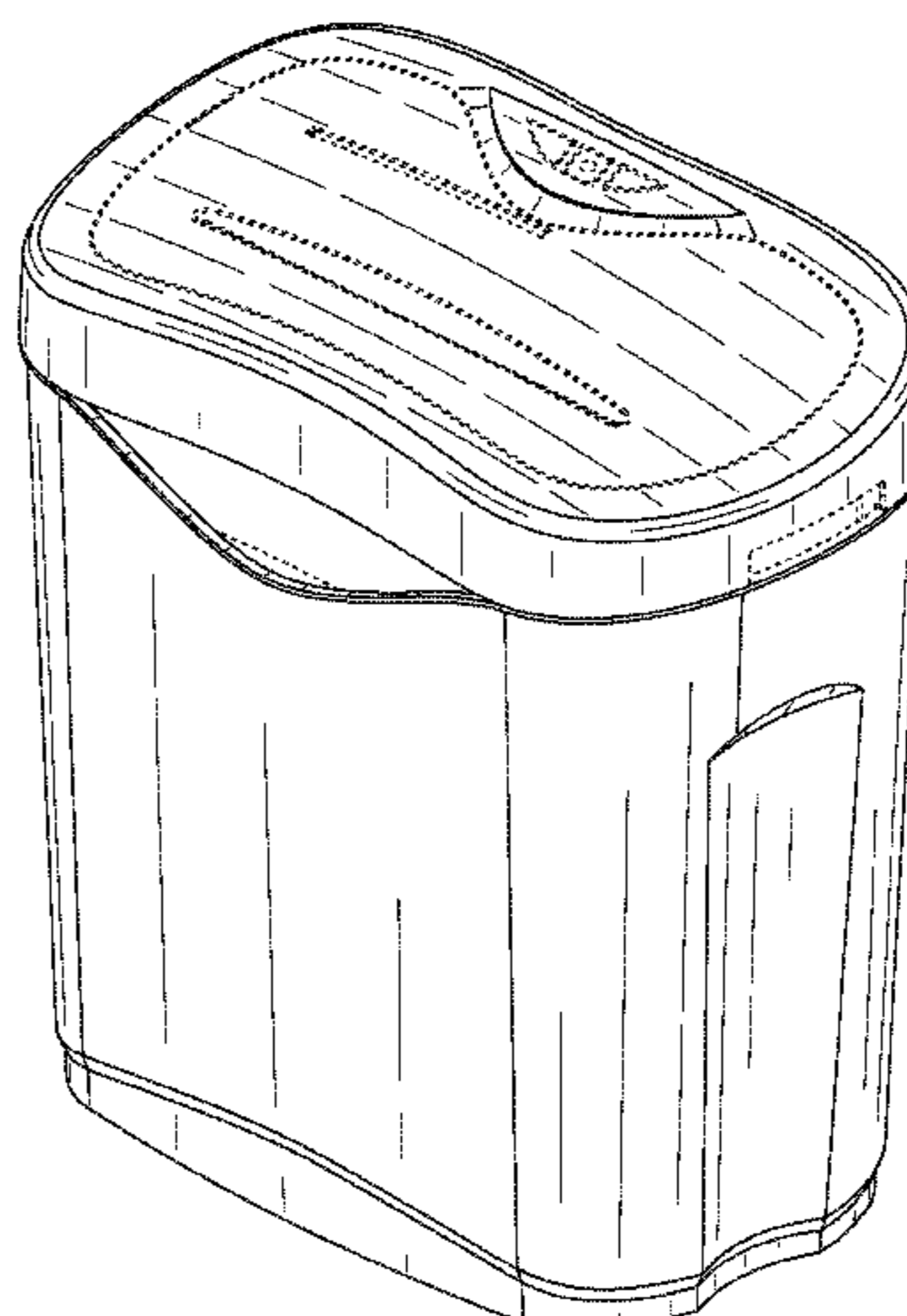
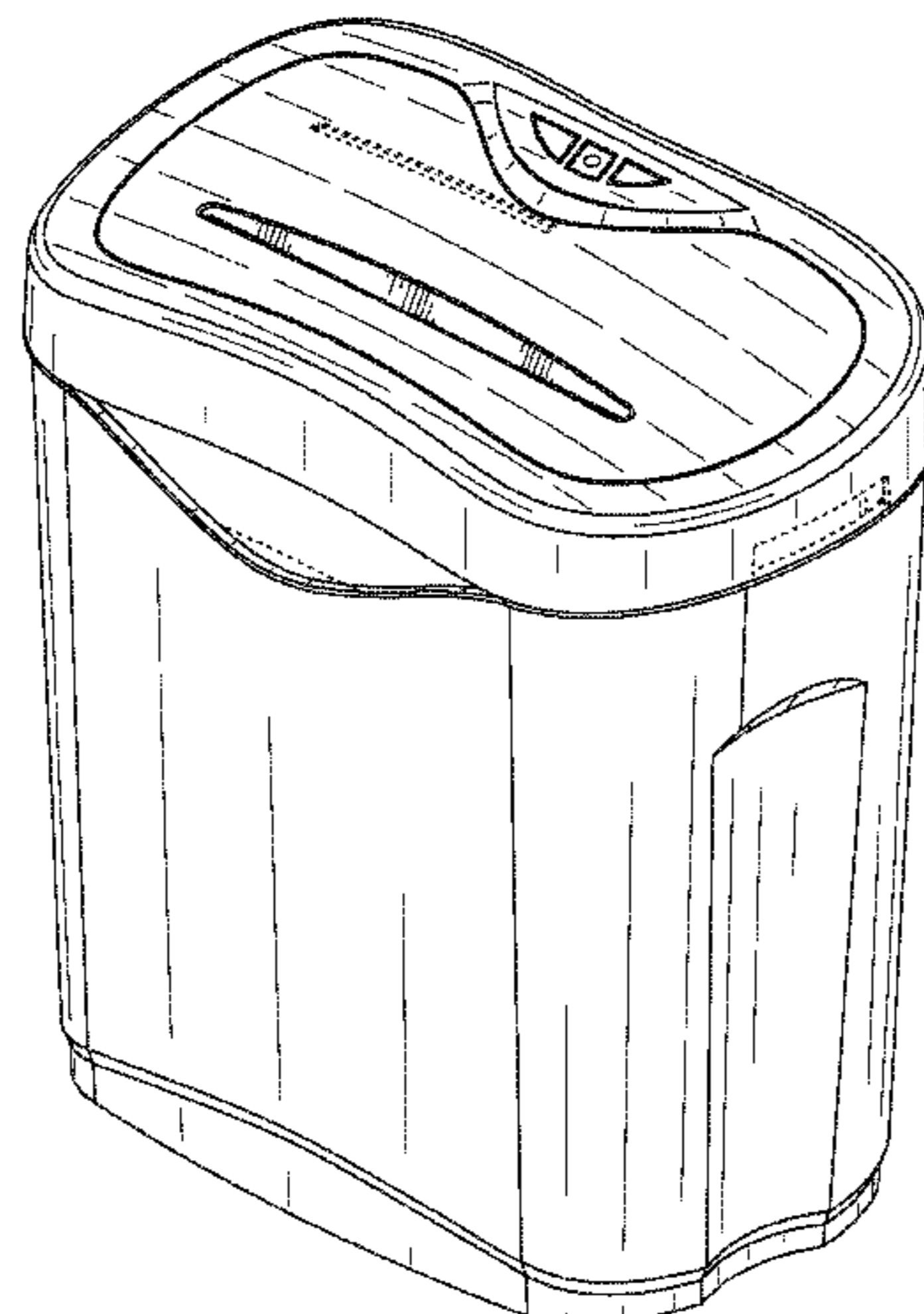
FIG. 2 is a top plan view of the shredder of FIG. 1;

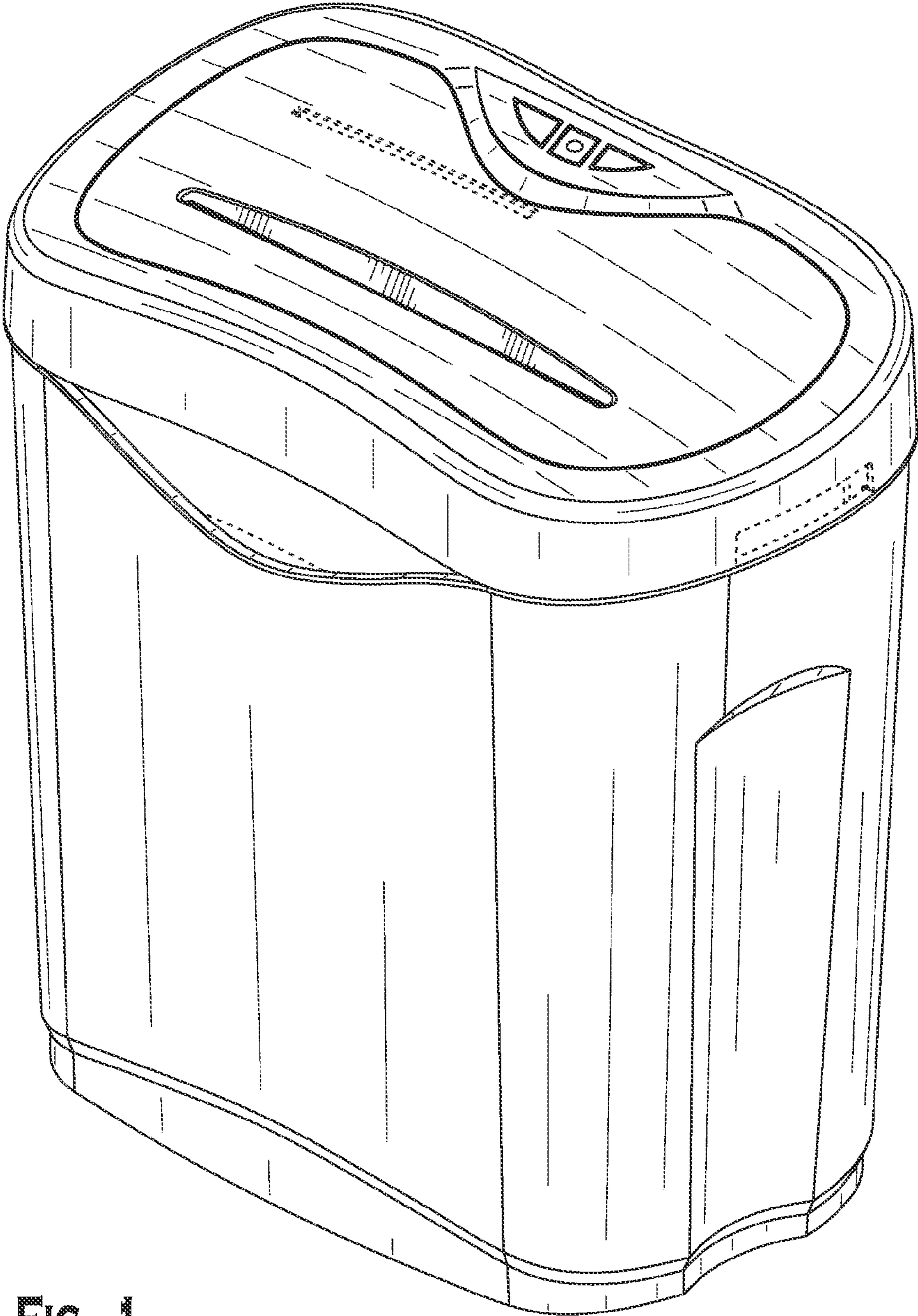

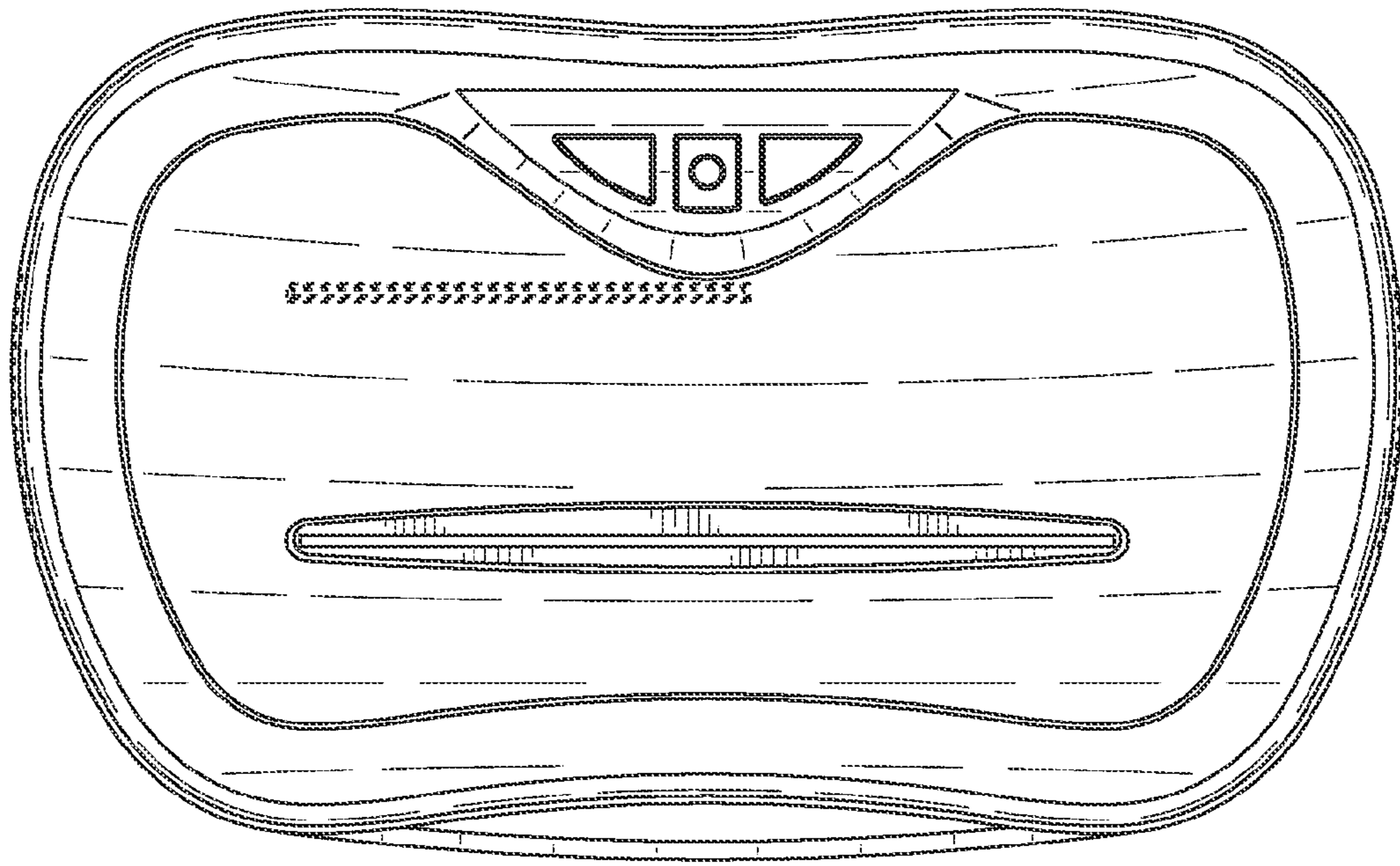

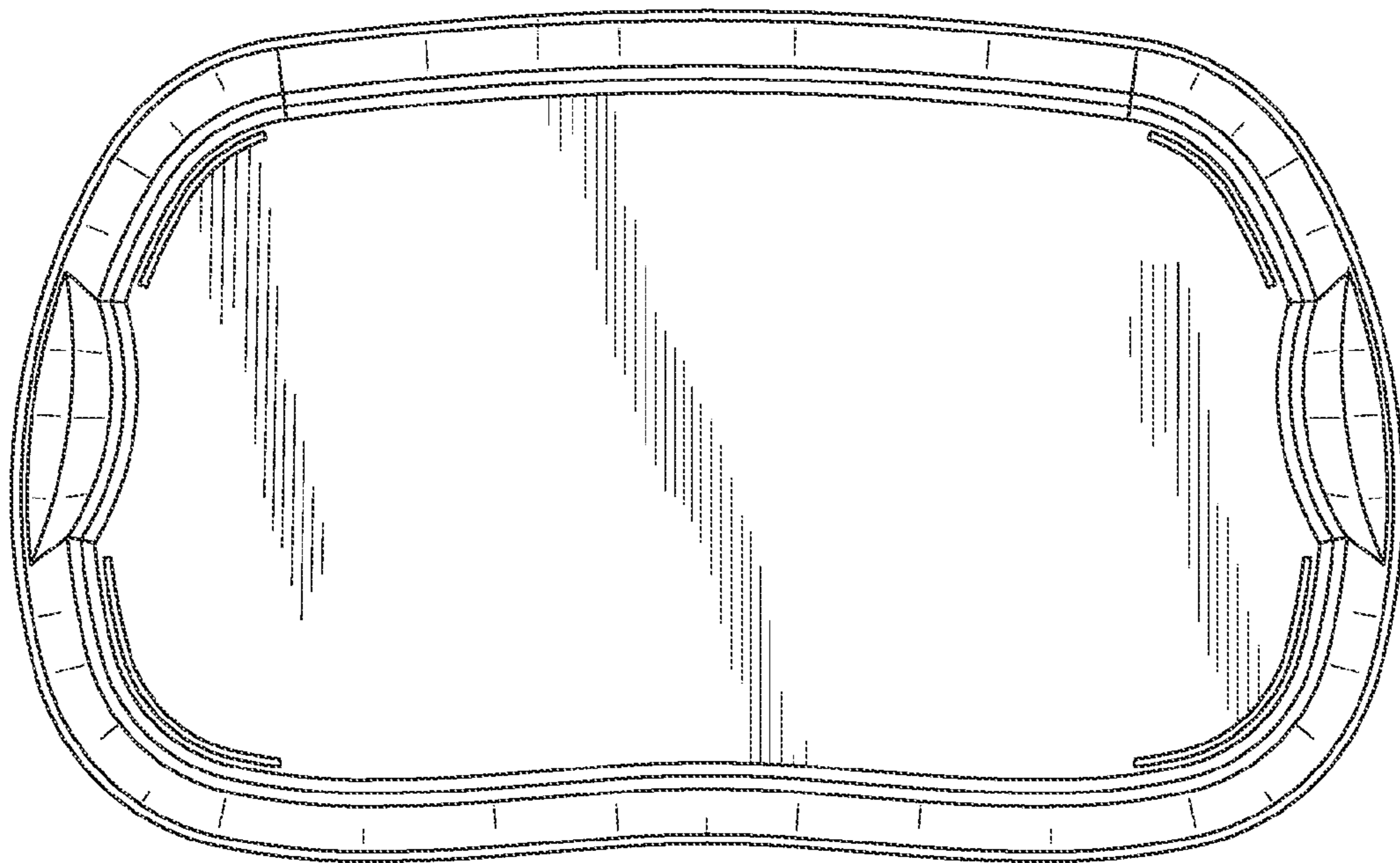

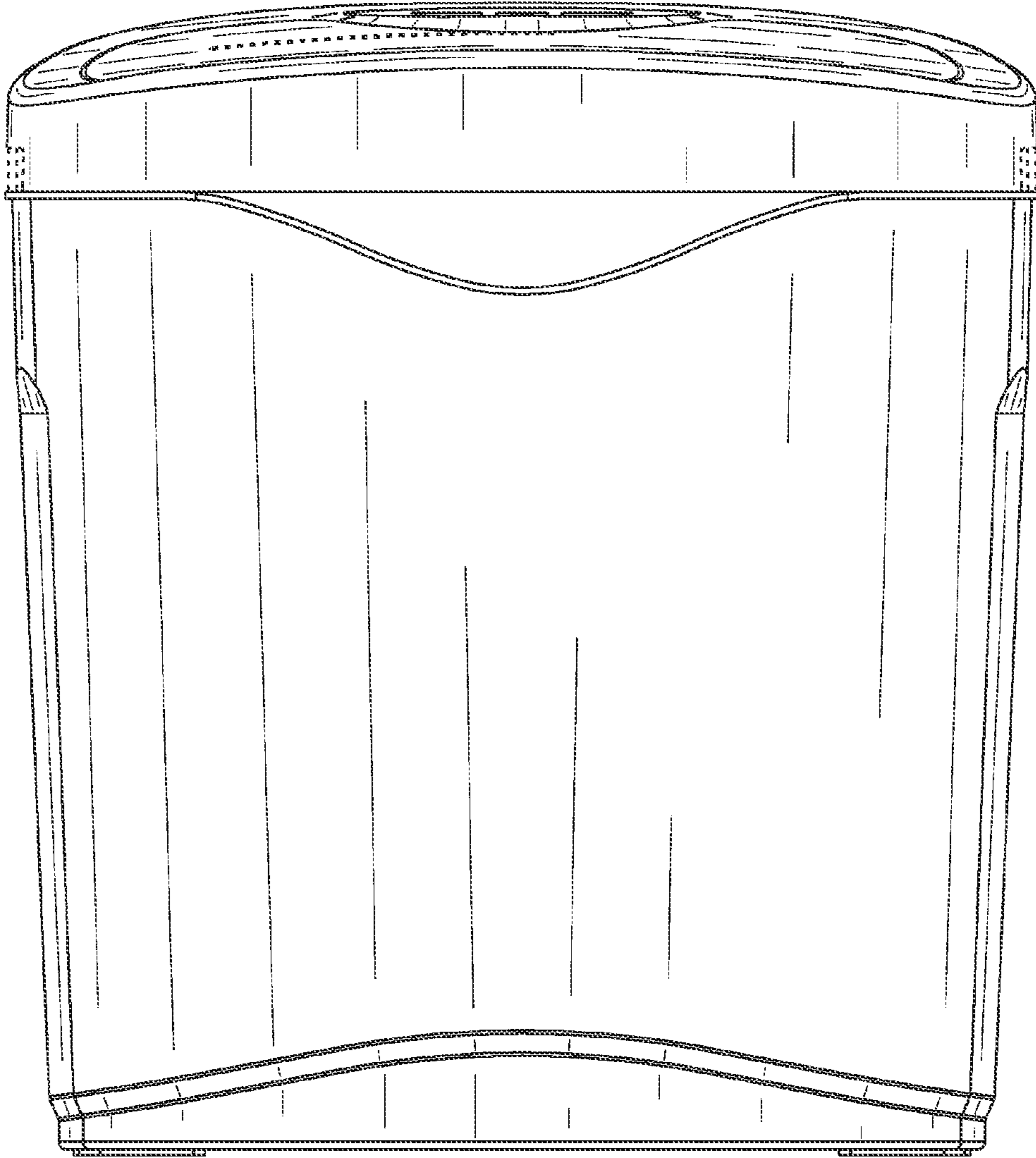

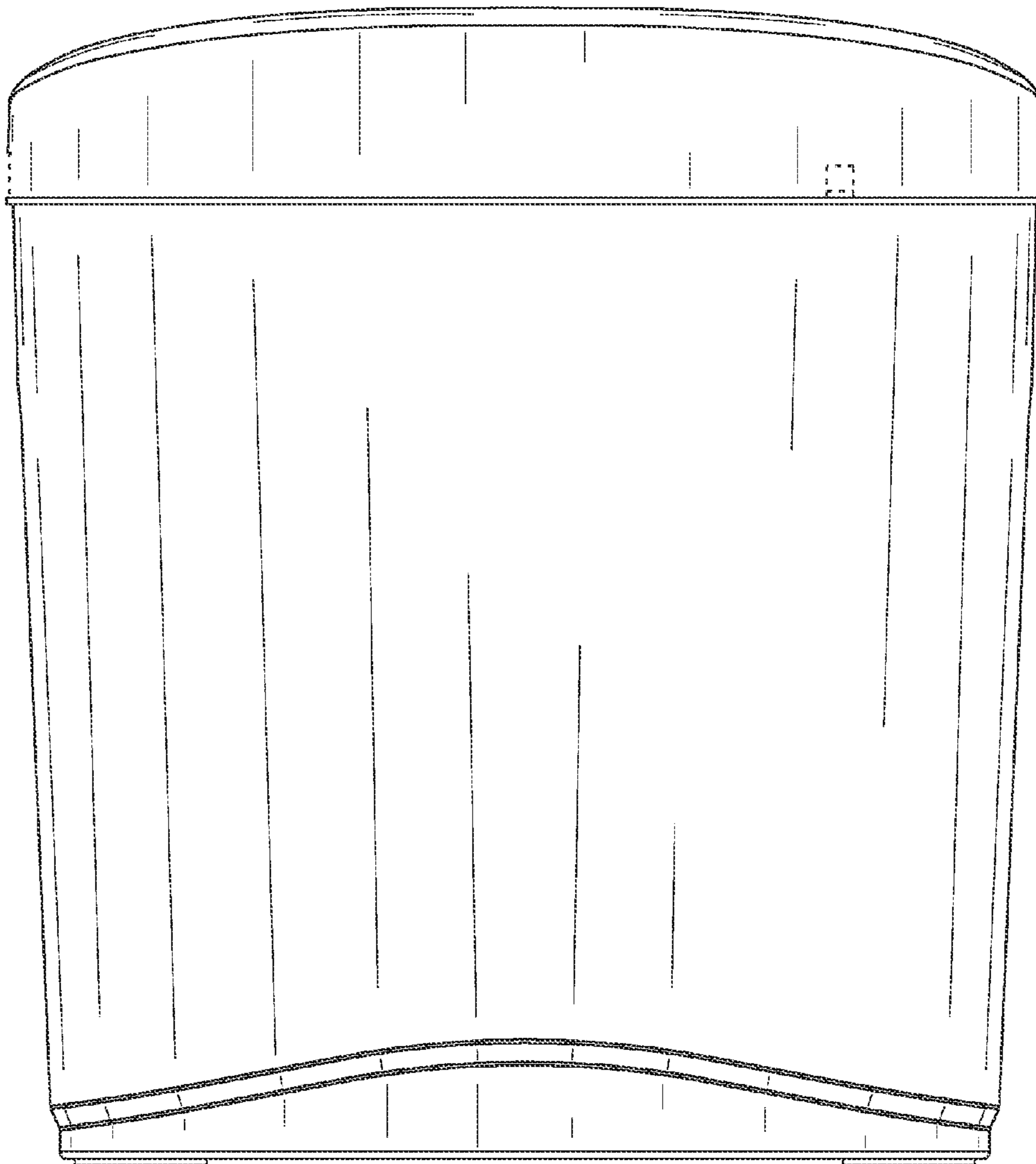

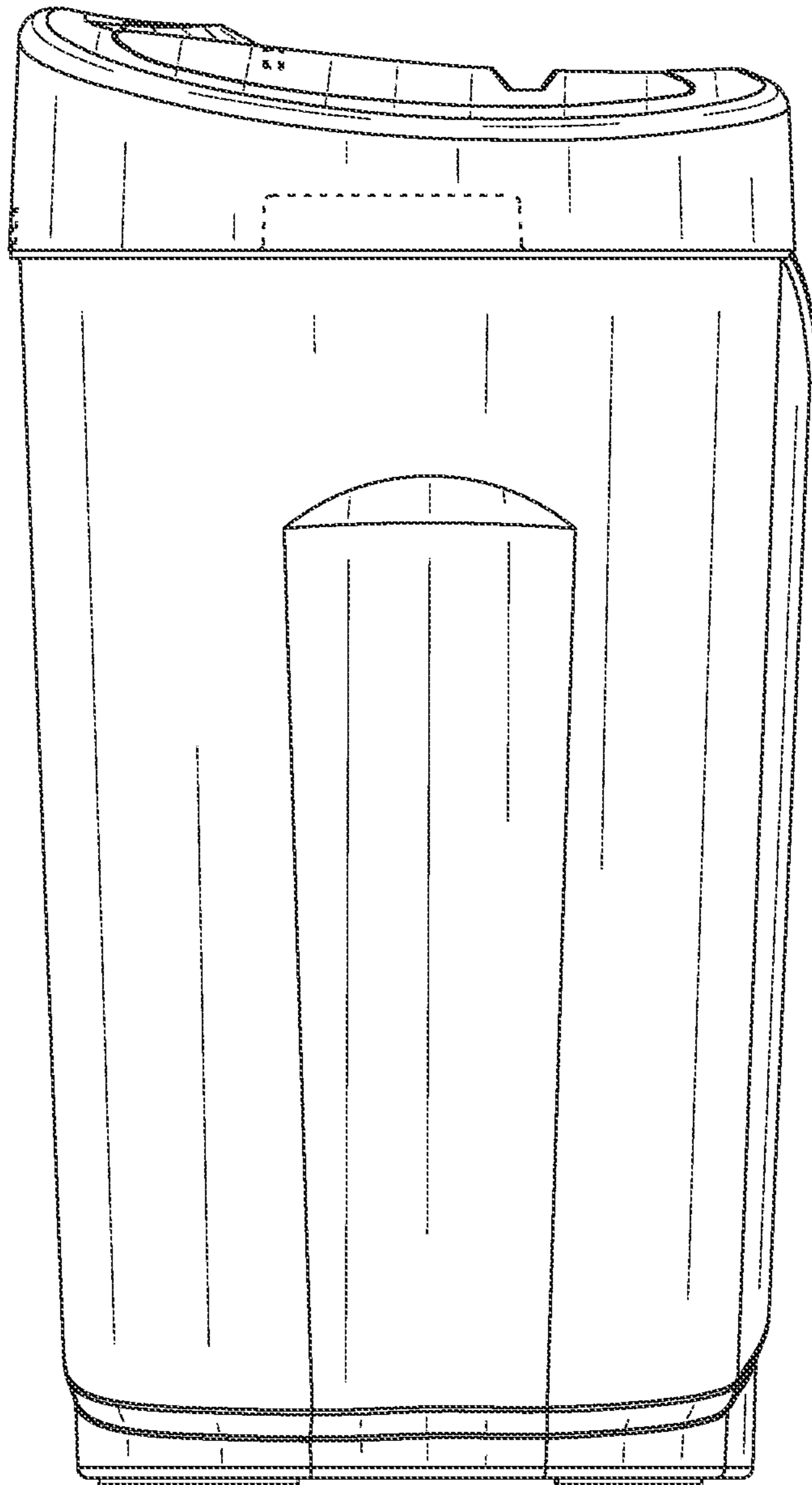

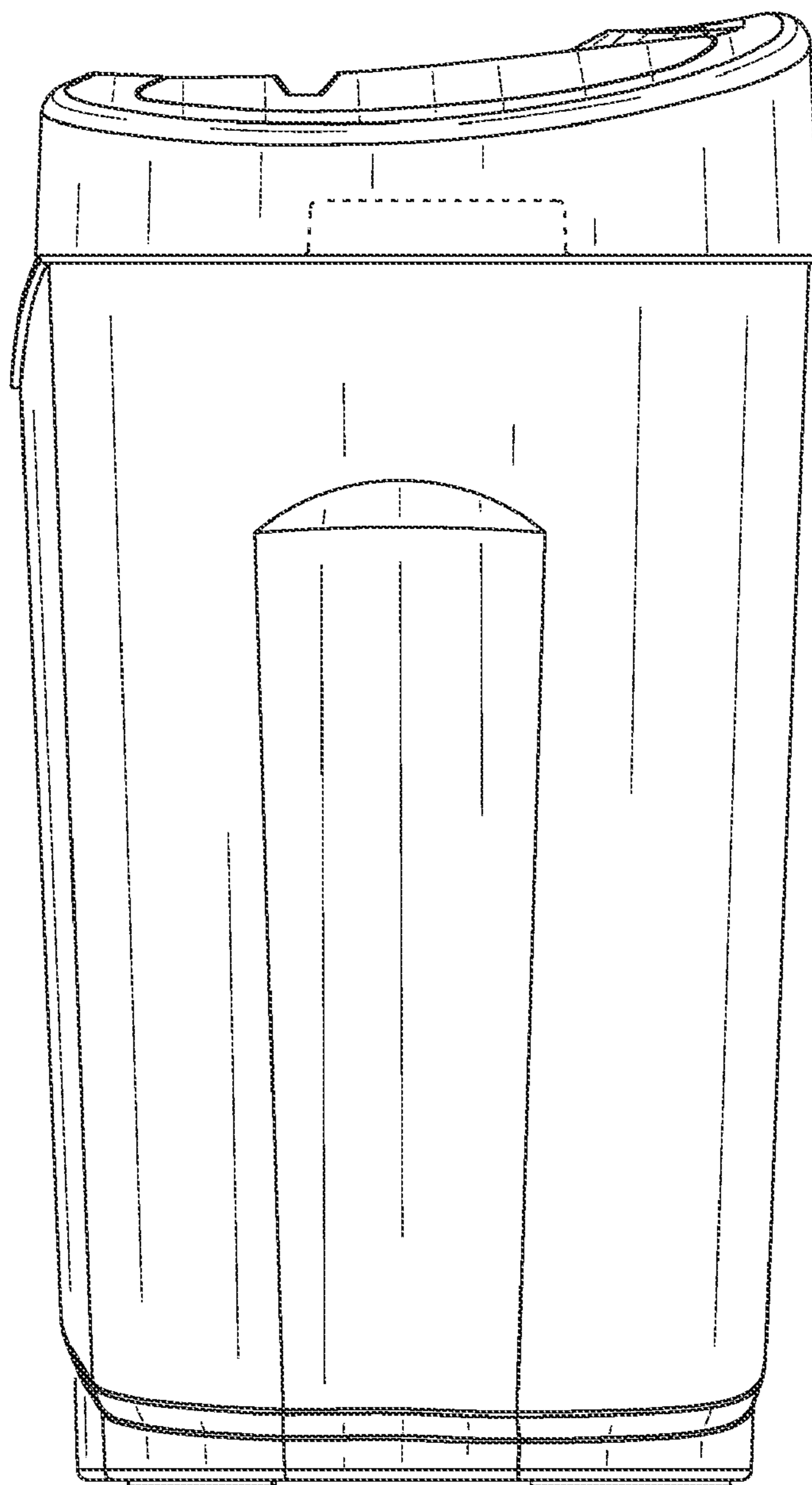

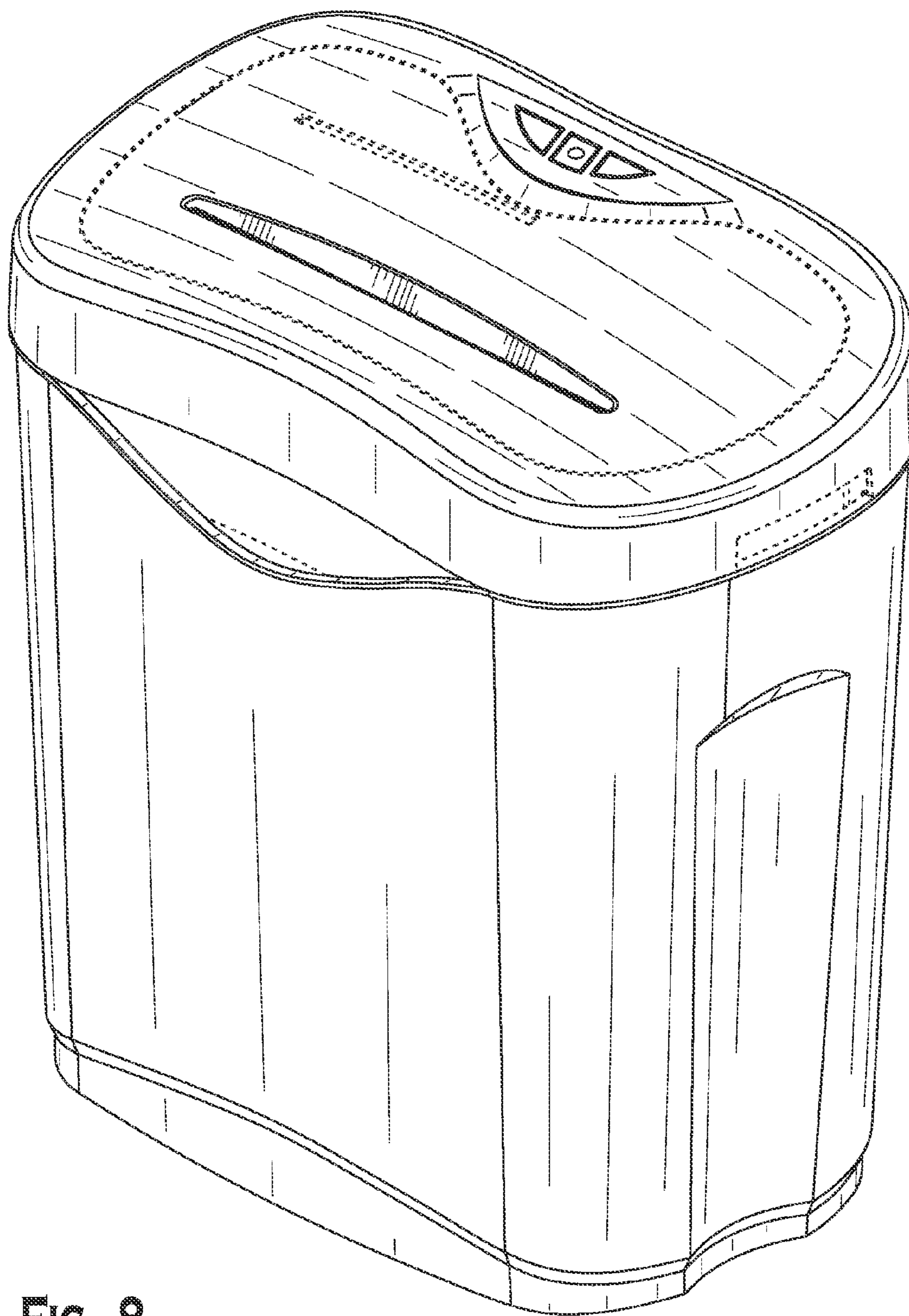

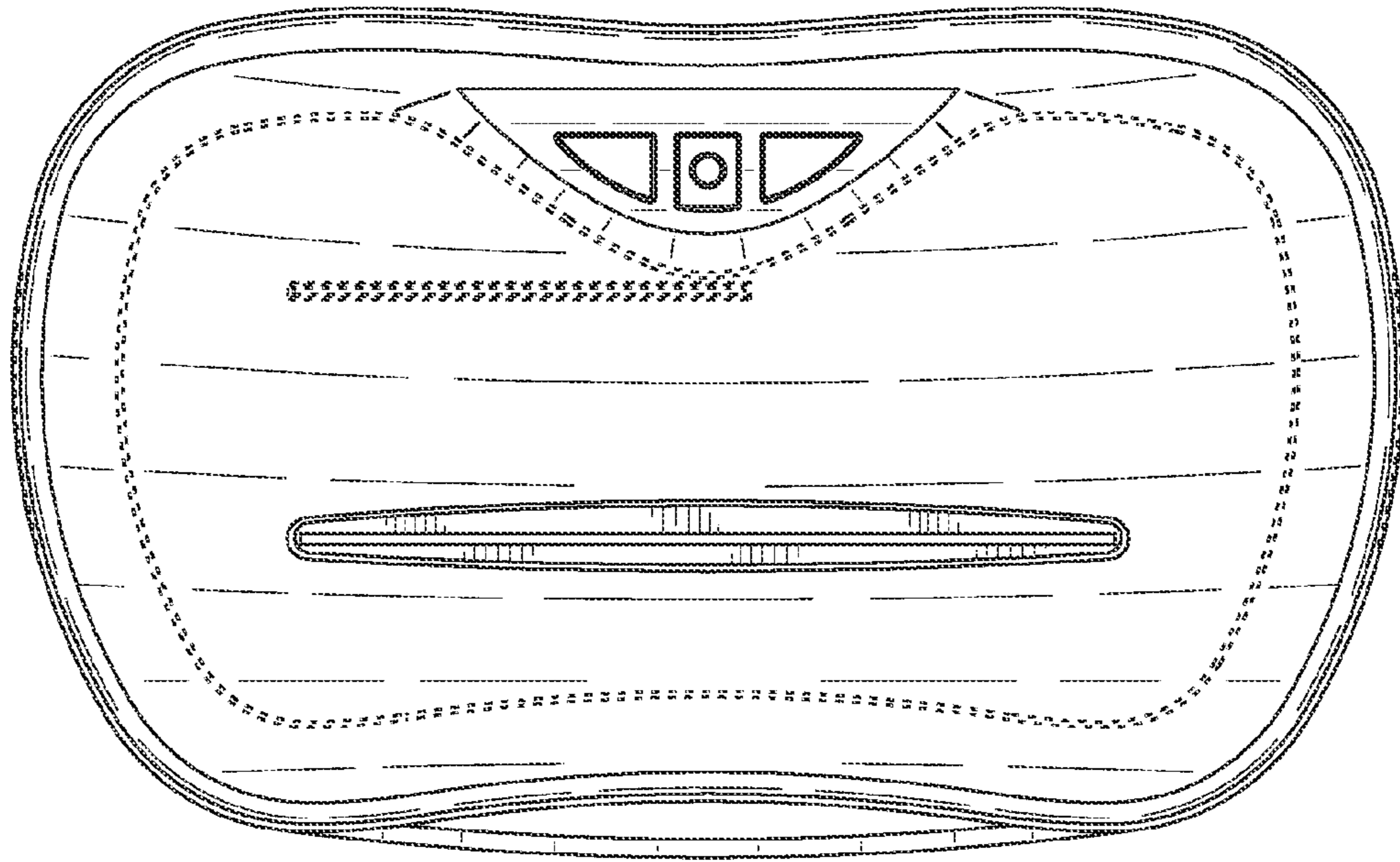

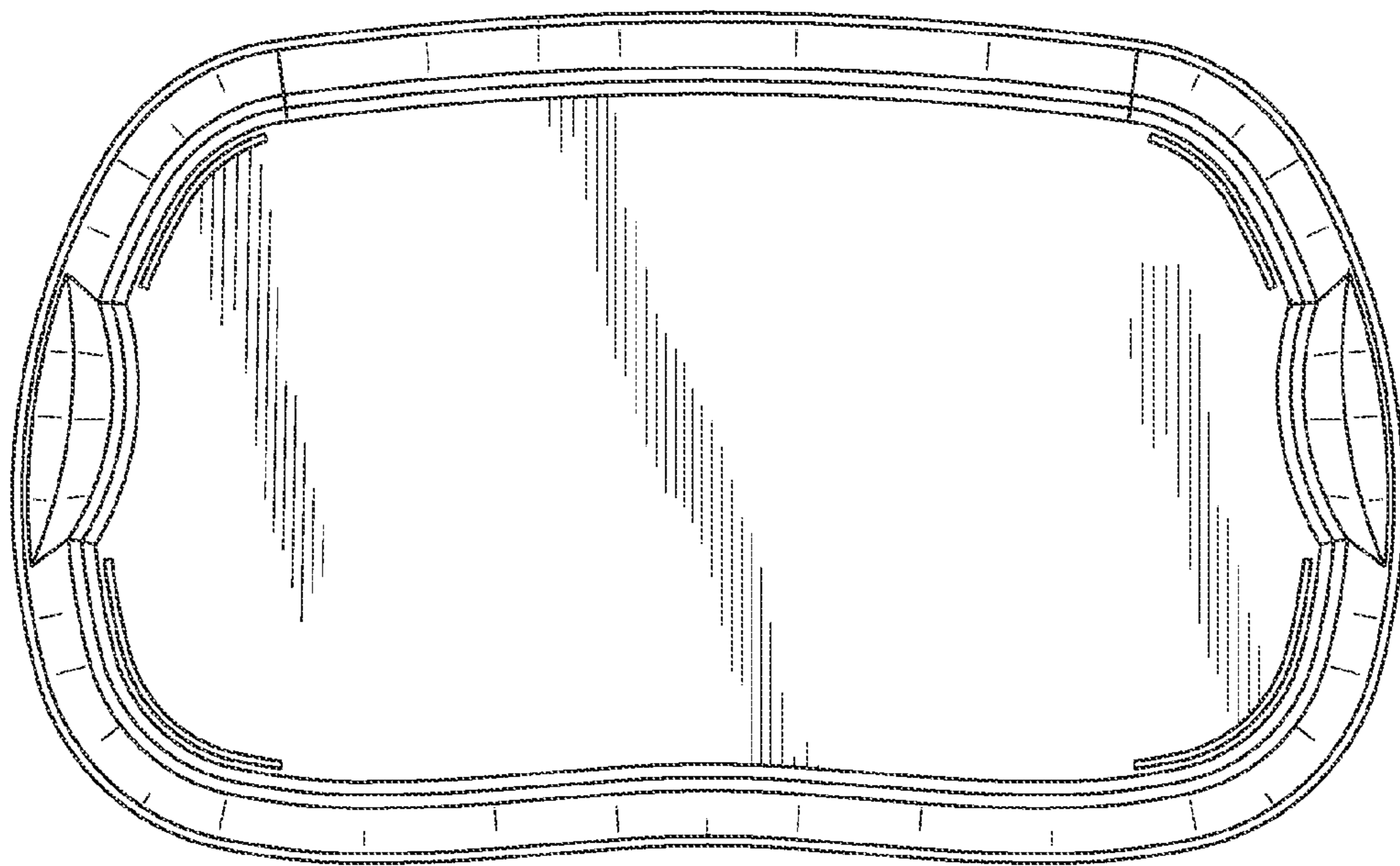

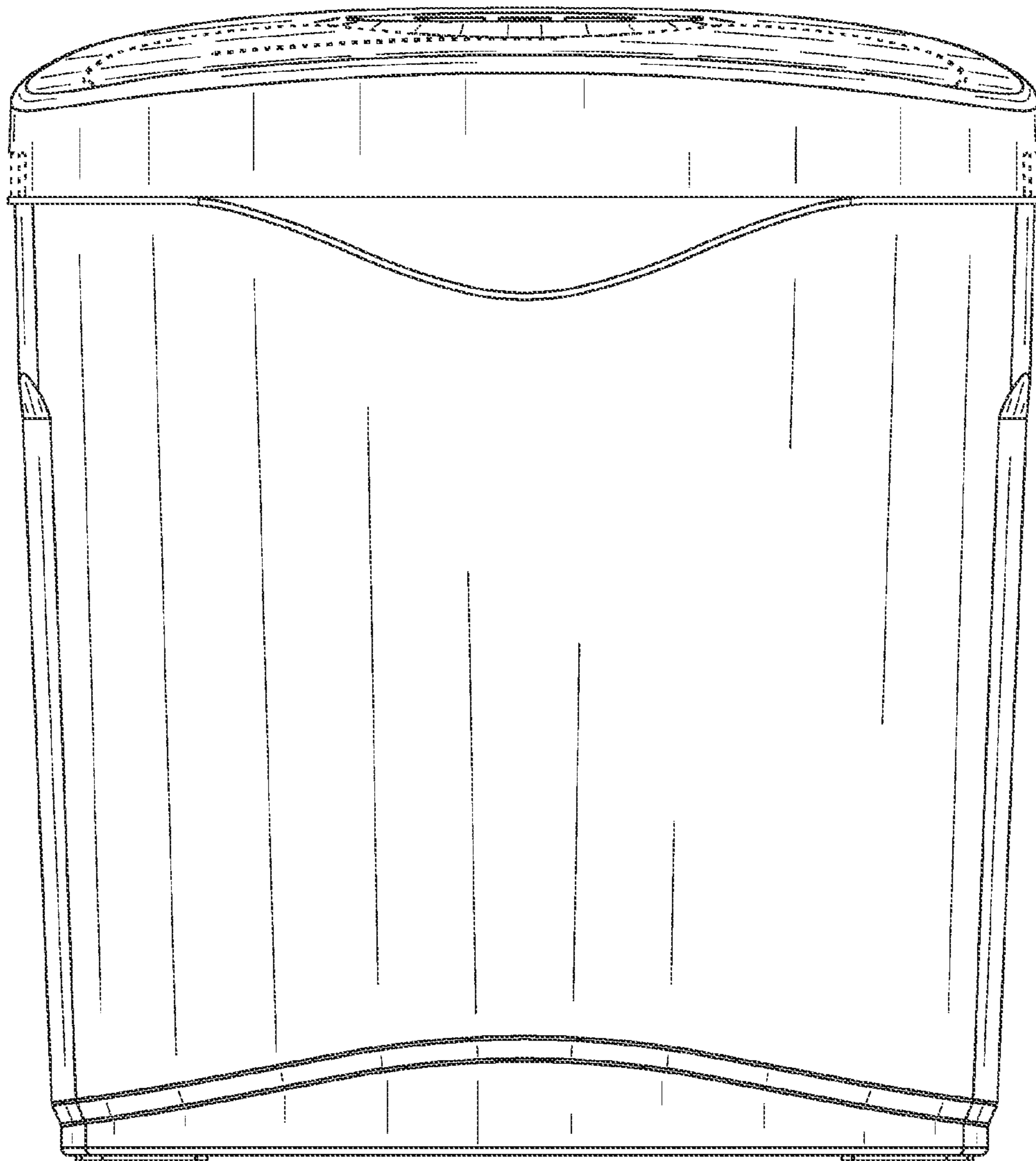

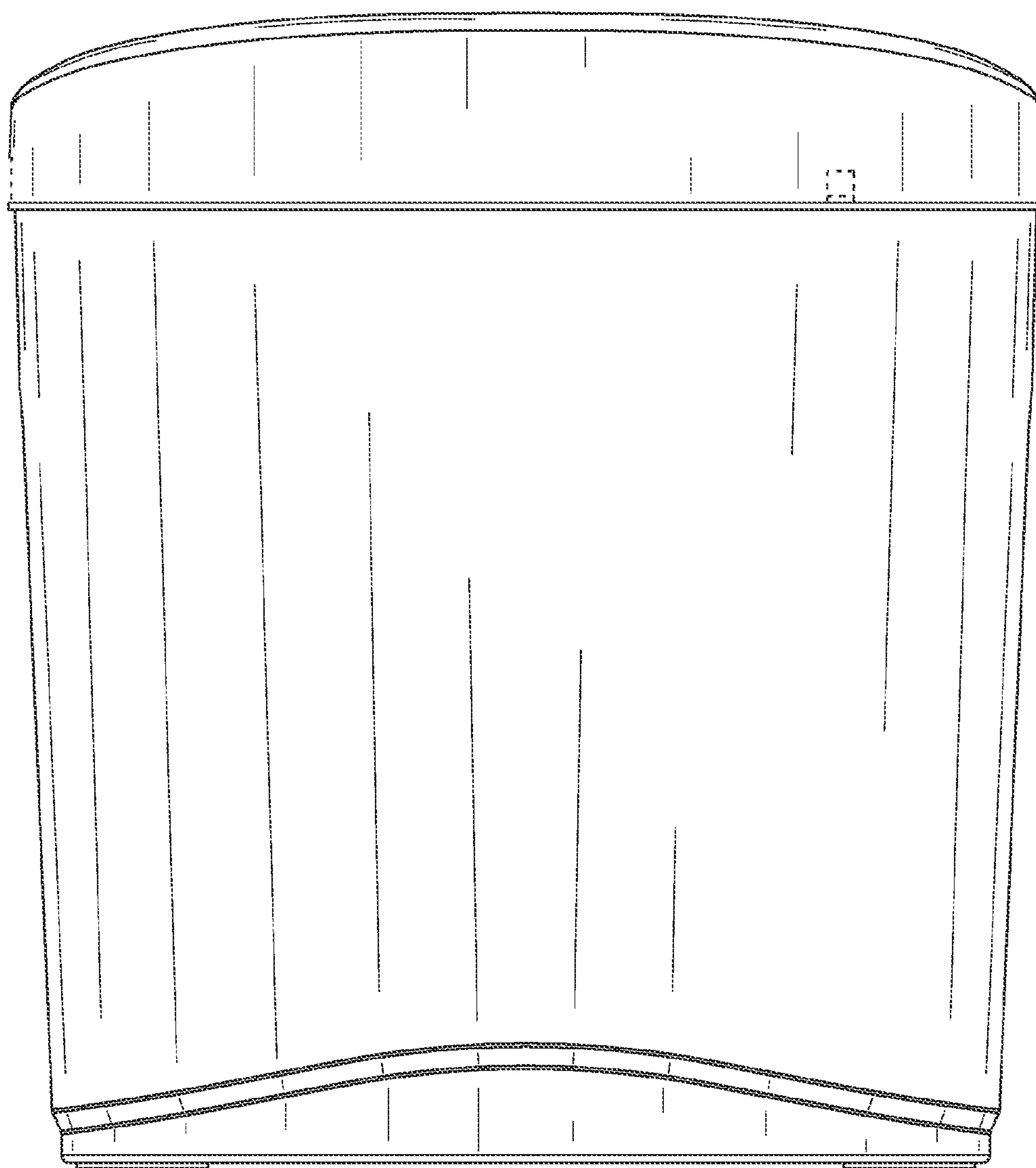

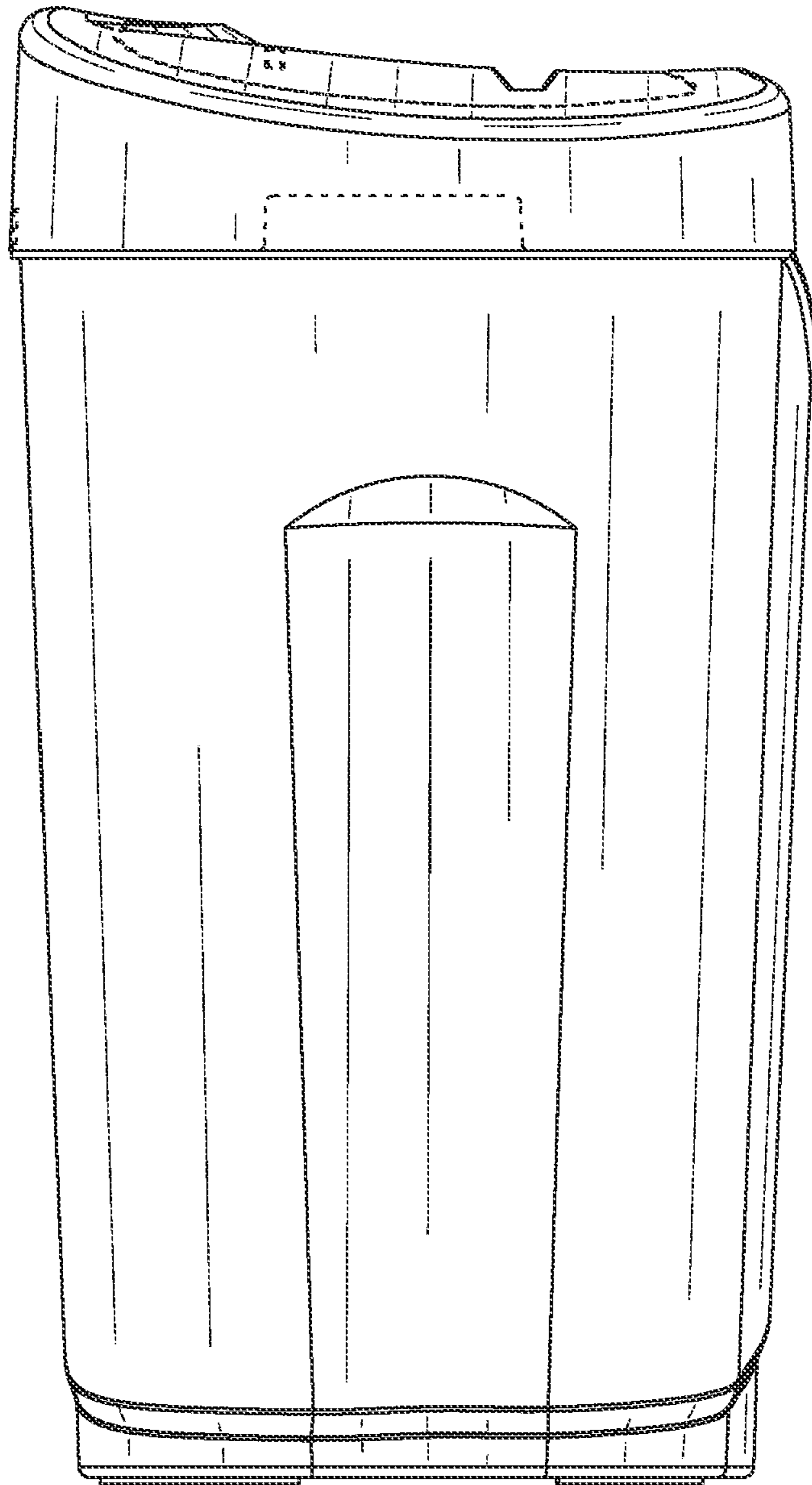

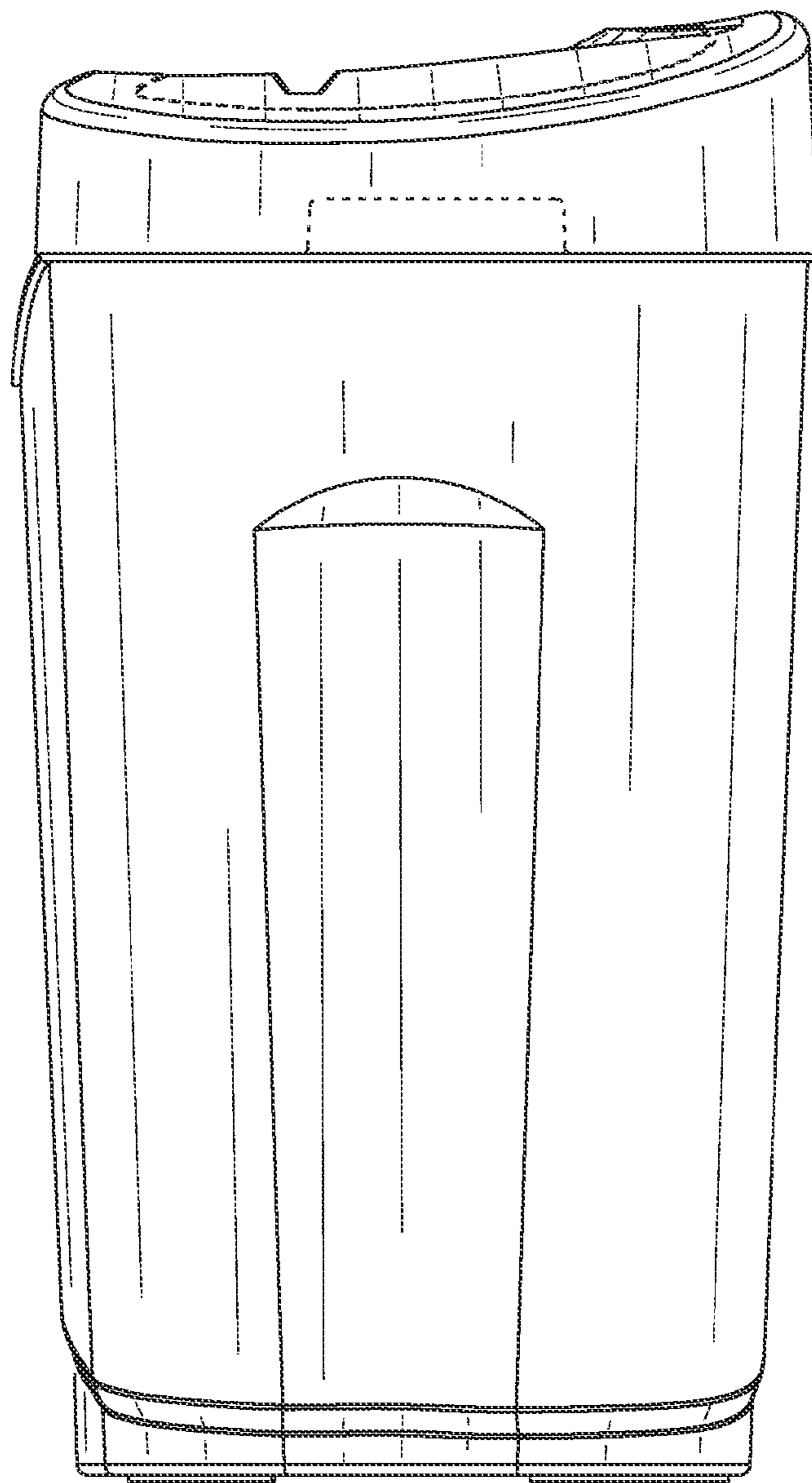

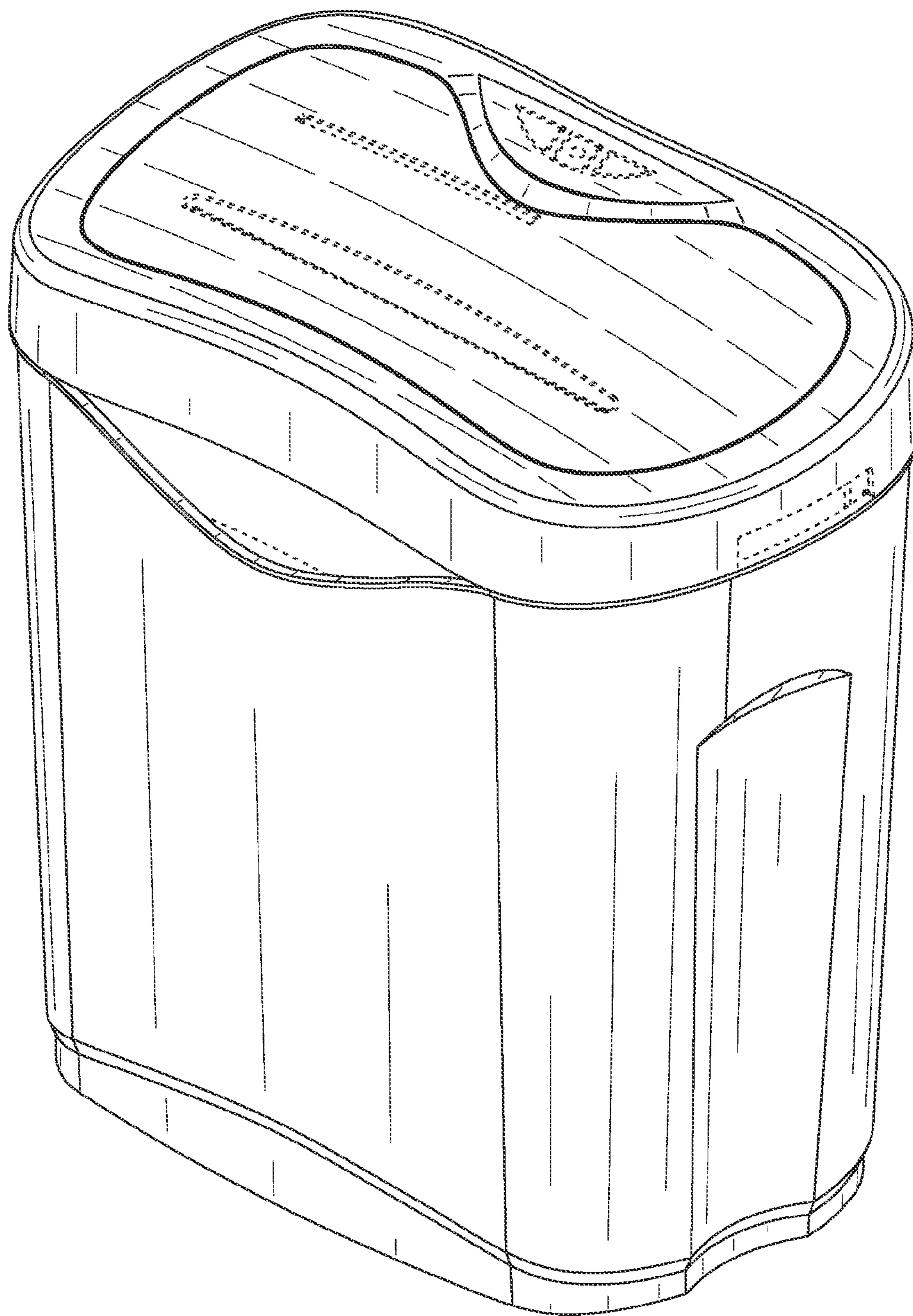

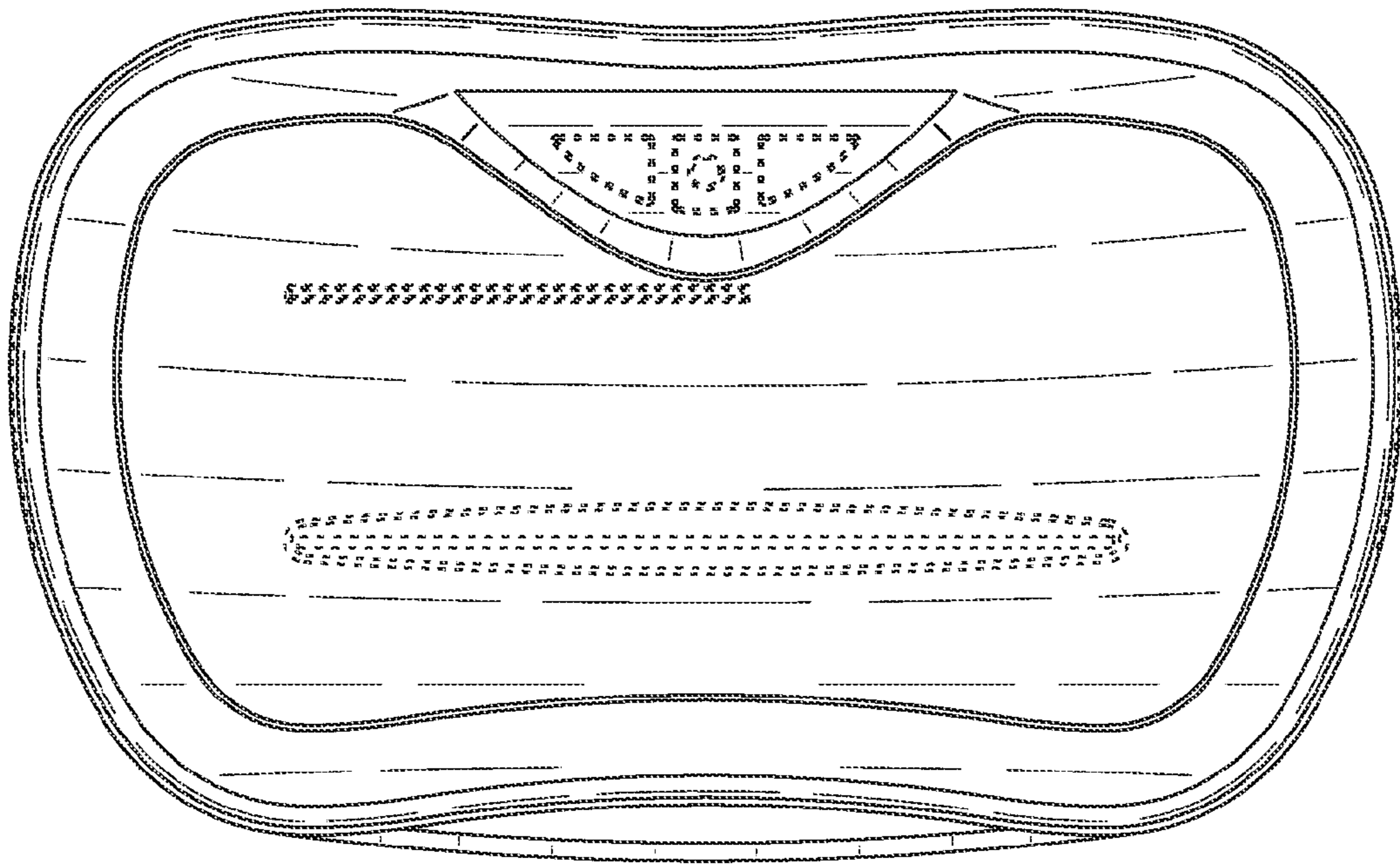

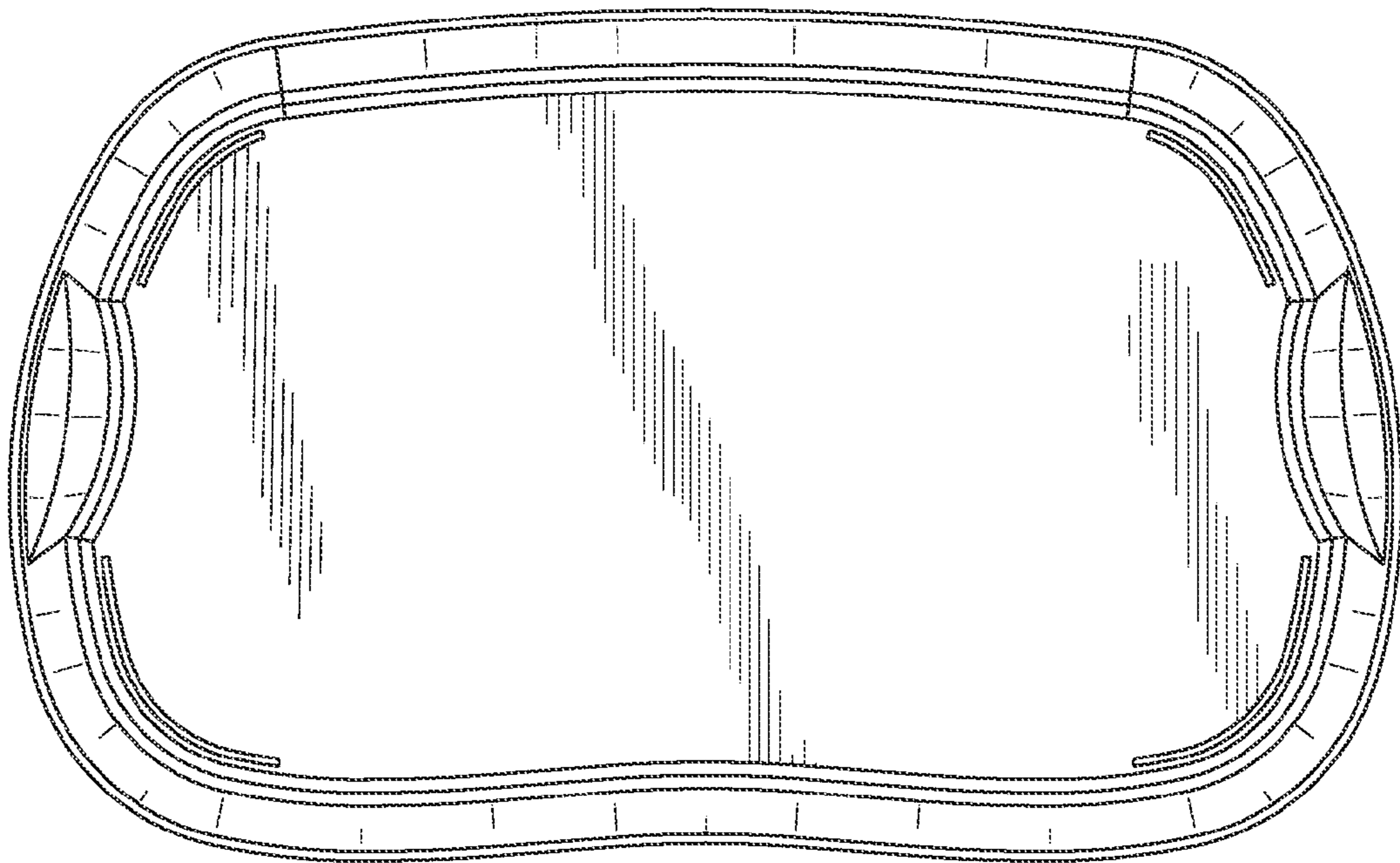

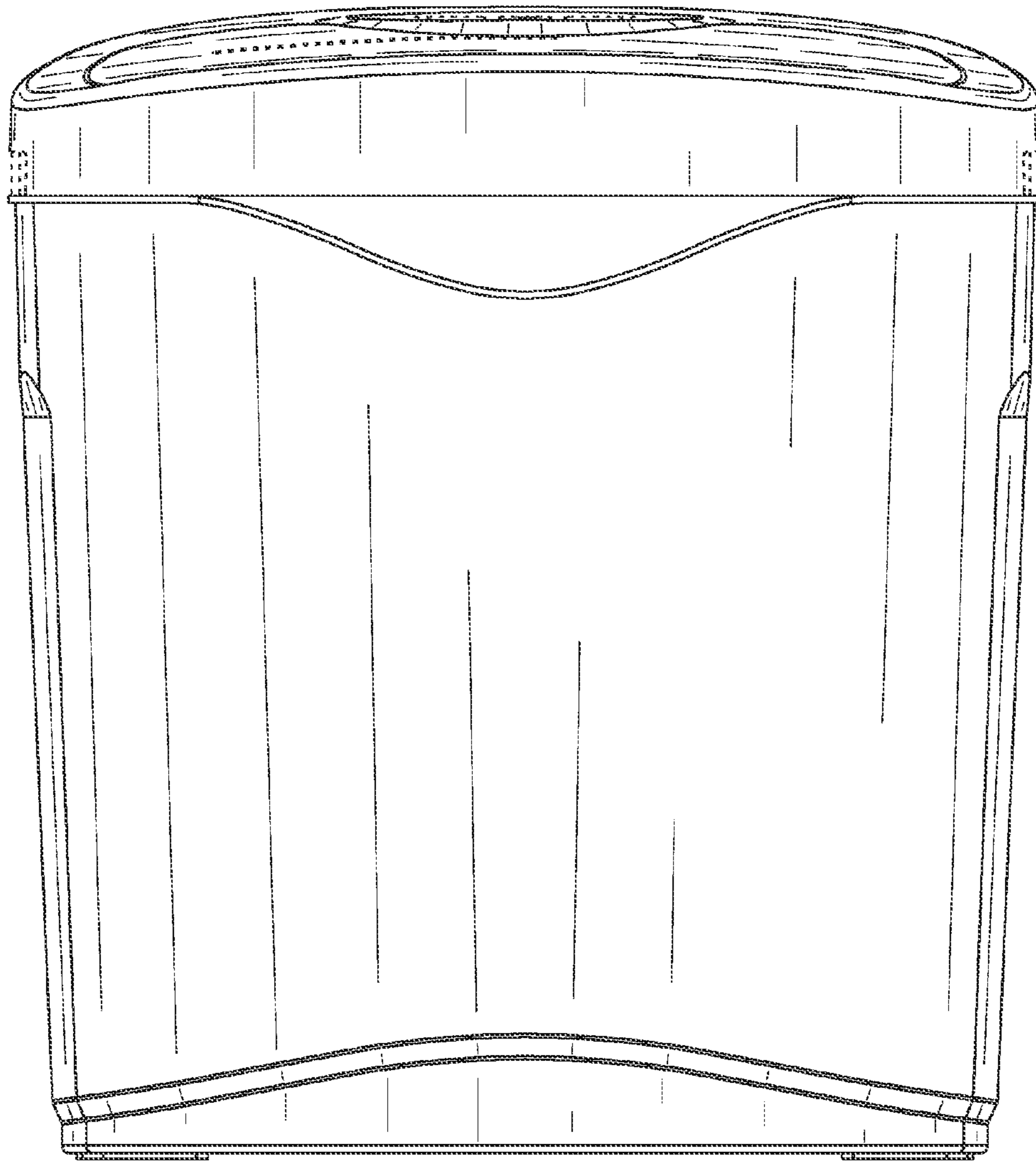

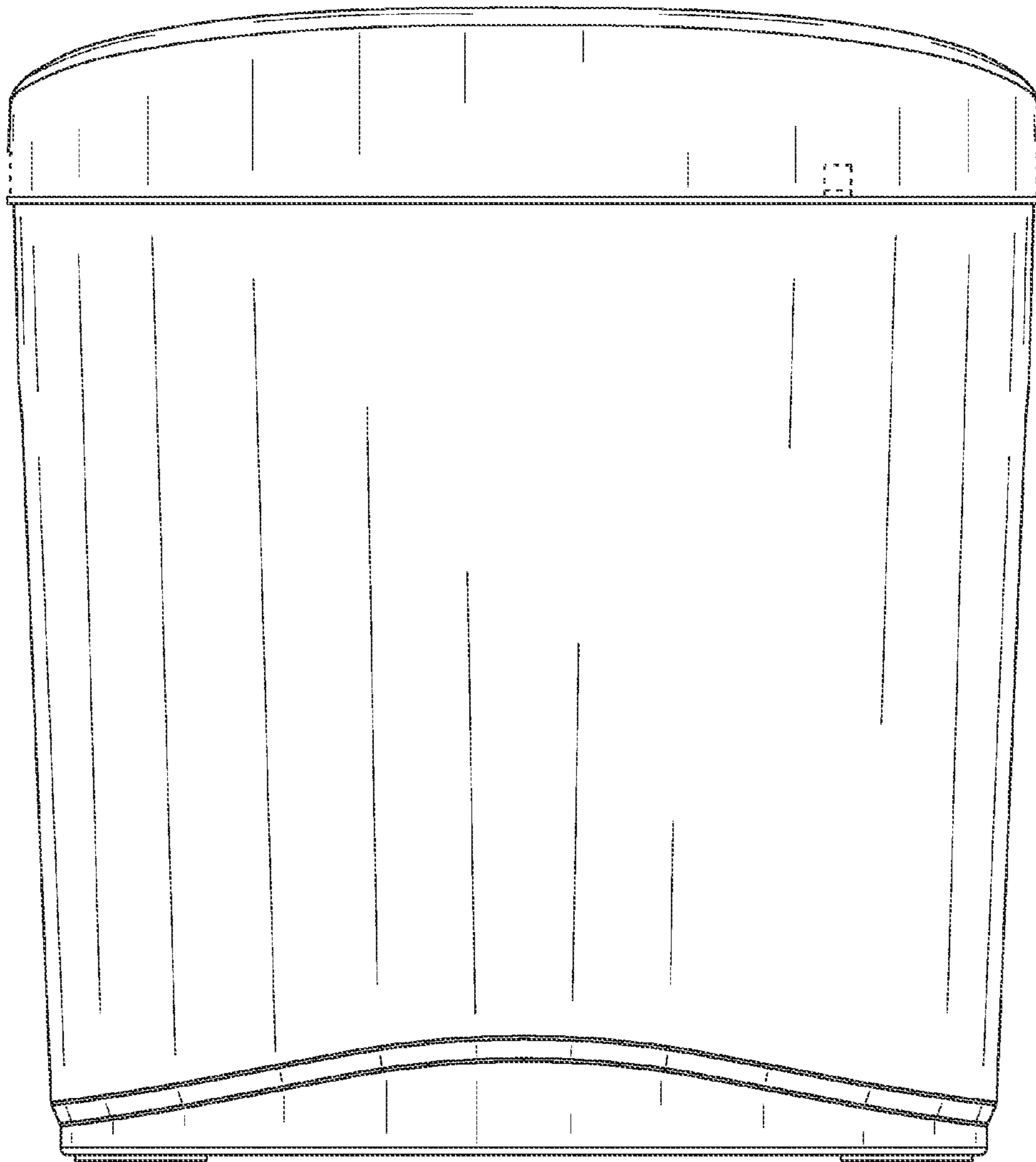

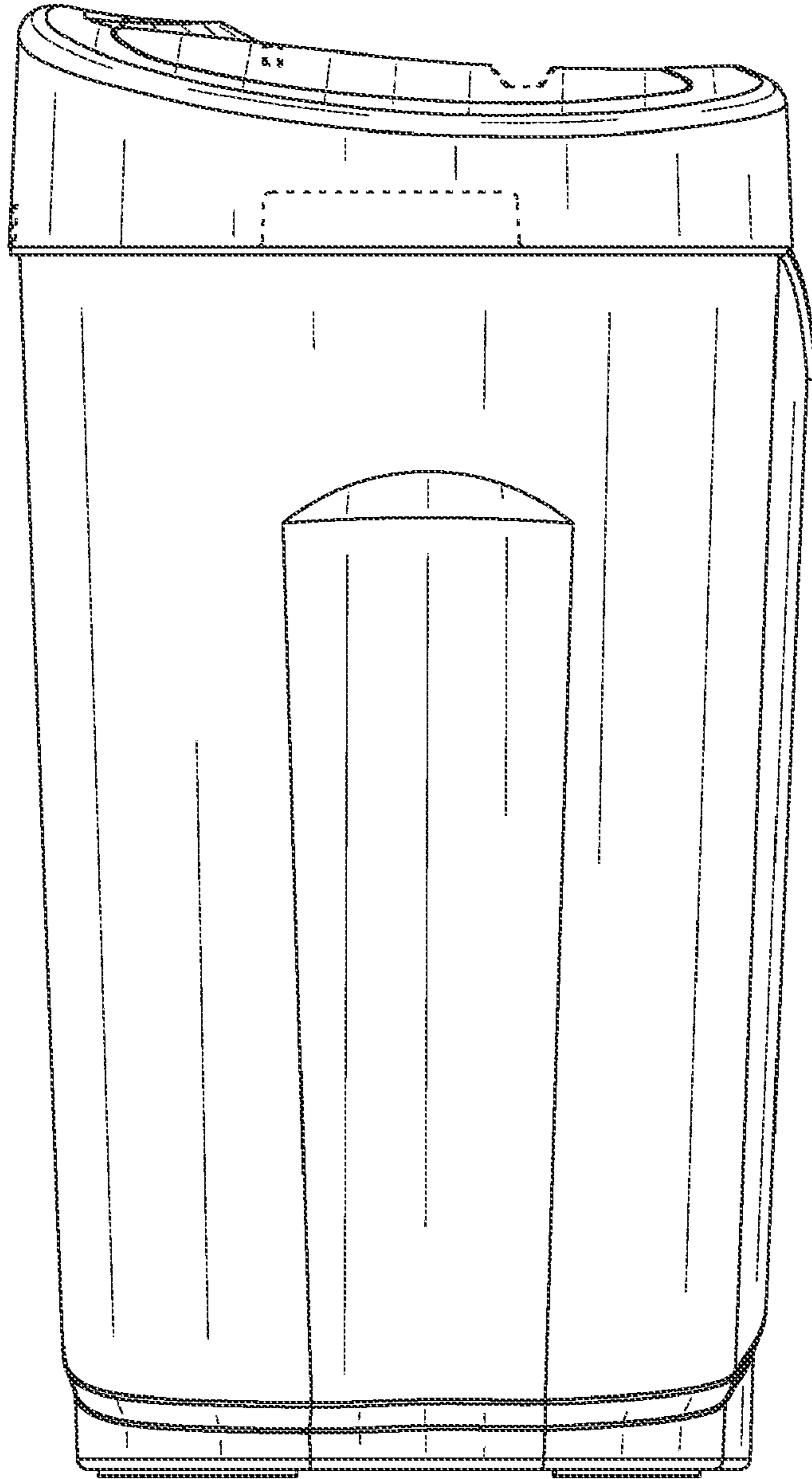

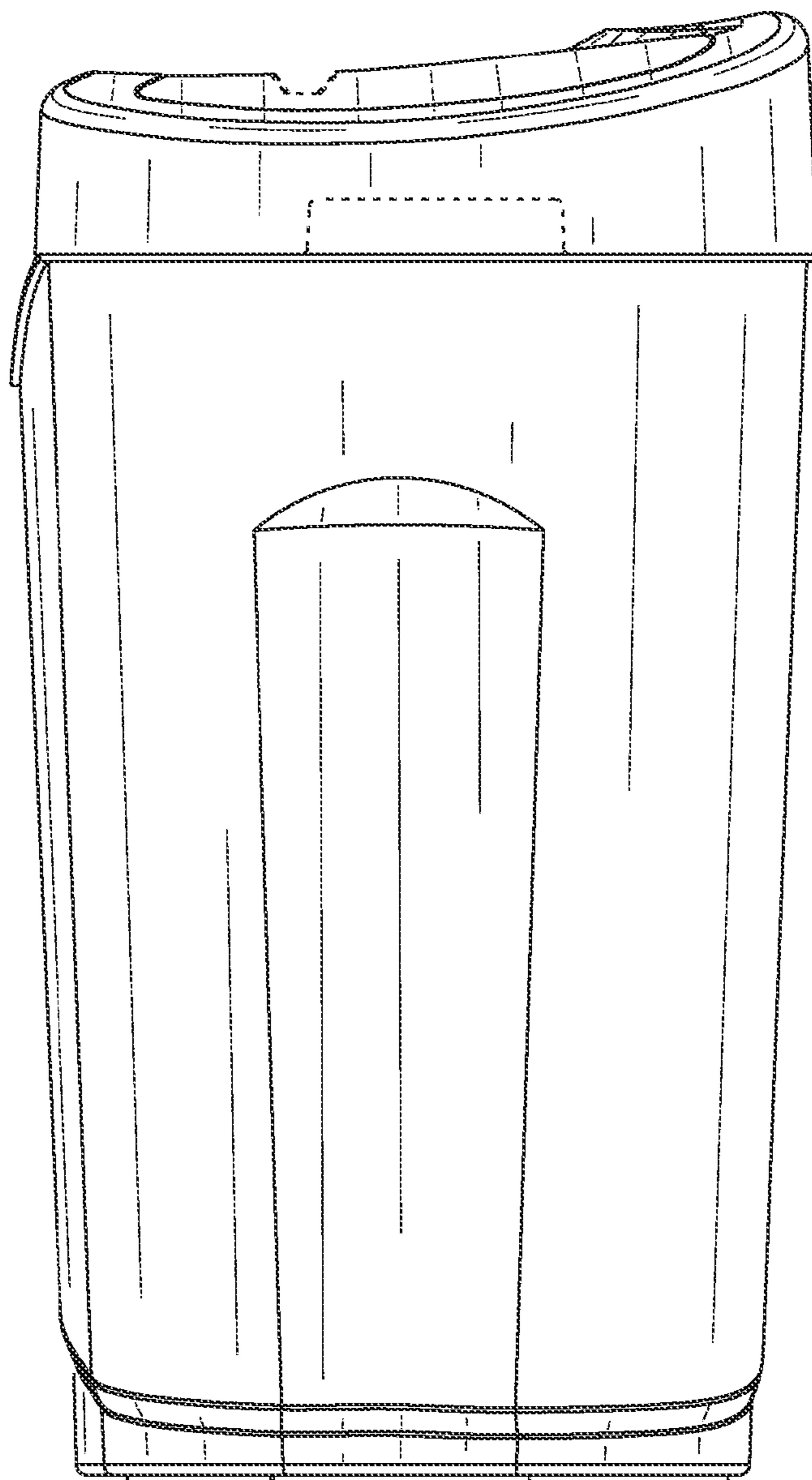

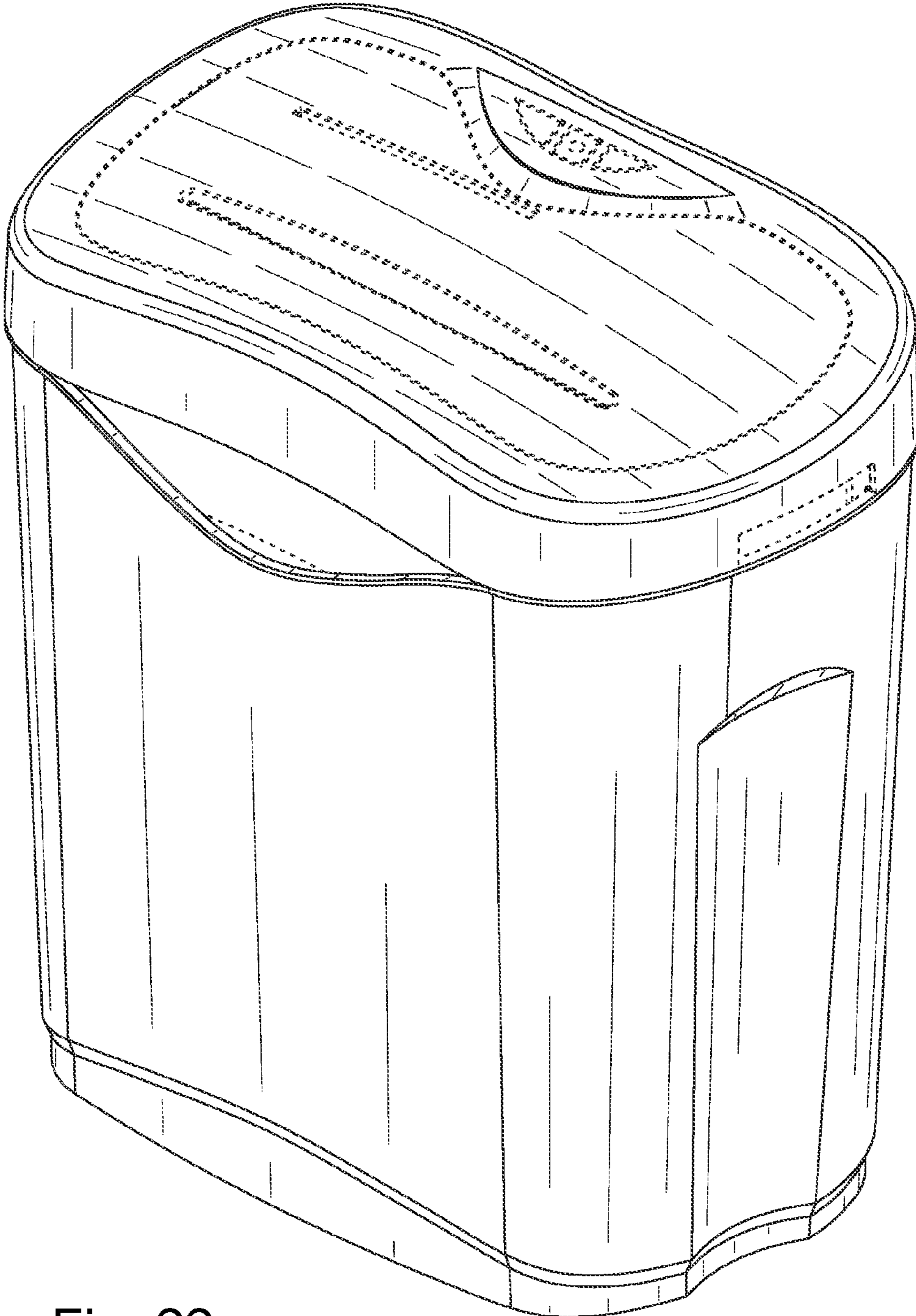

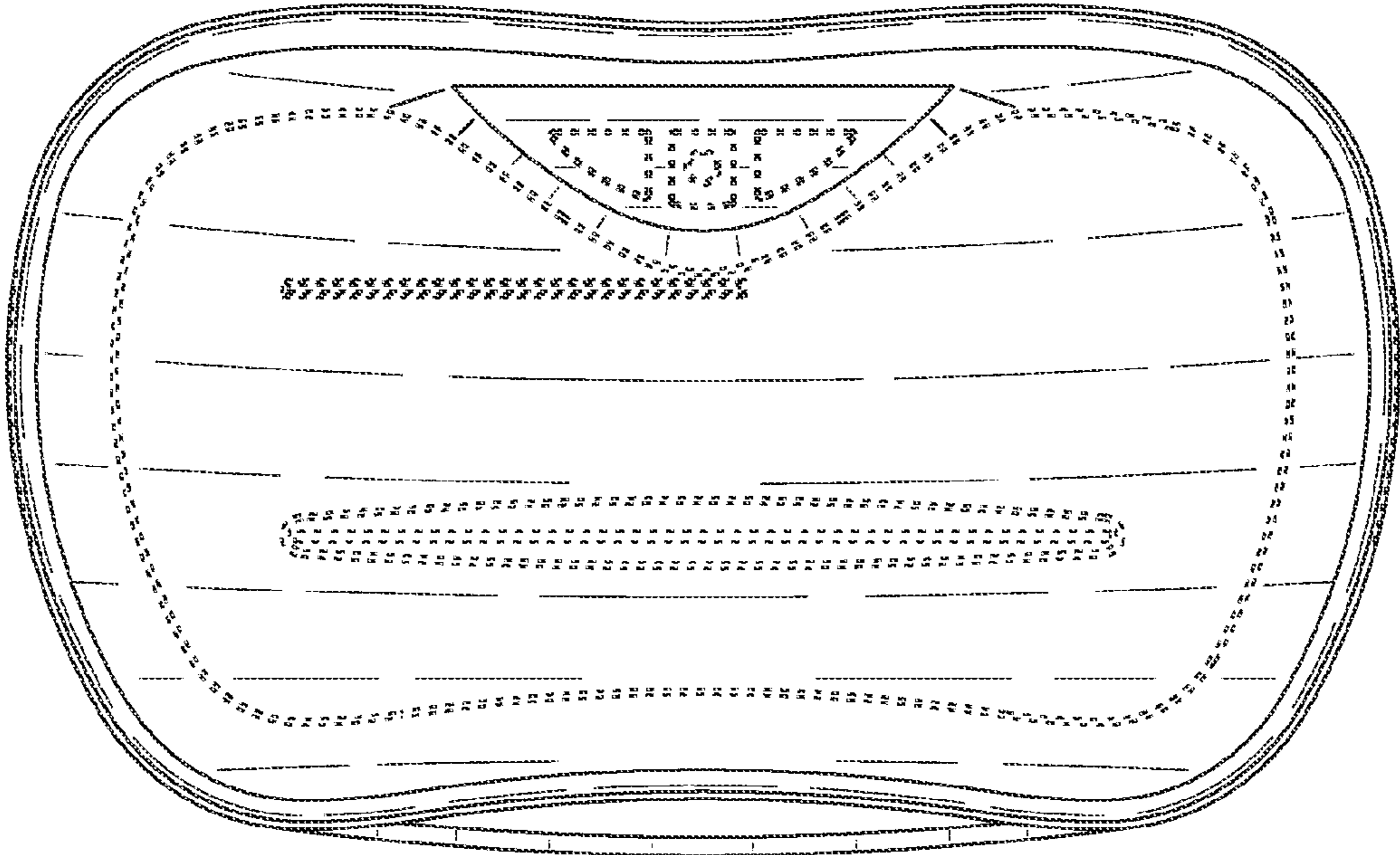

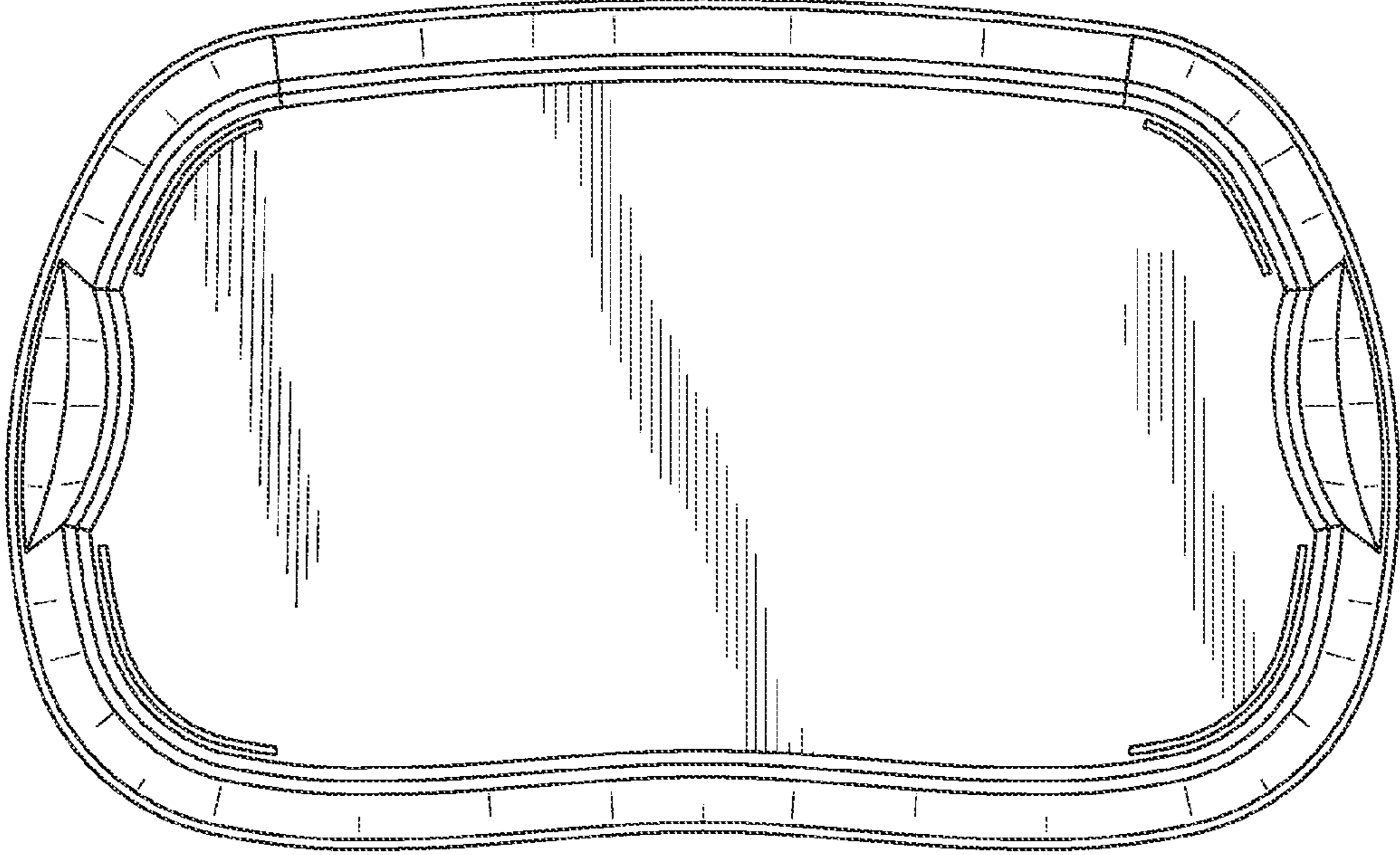

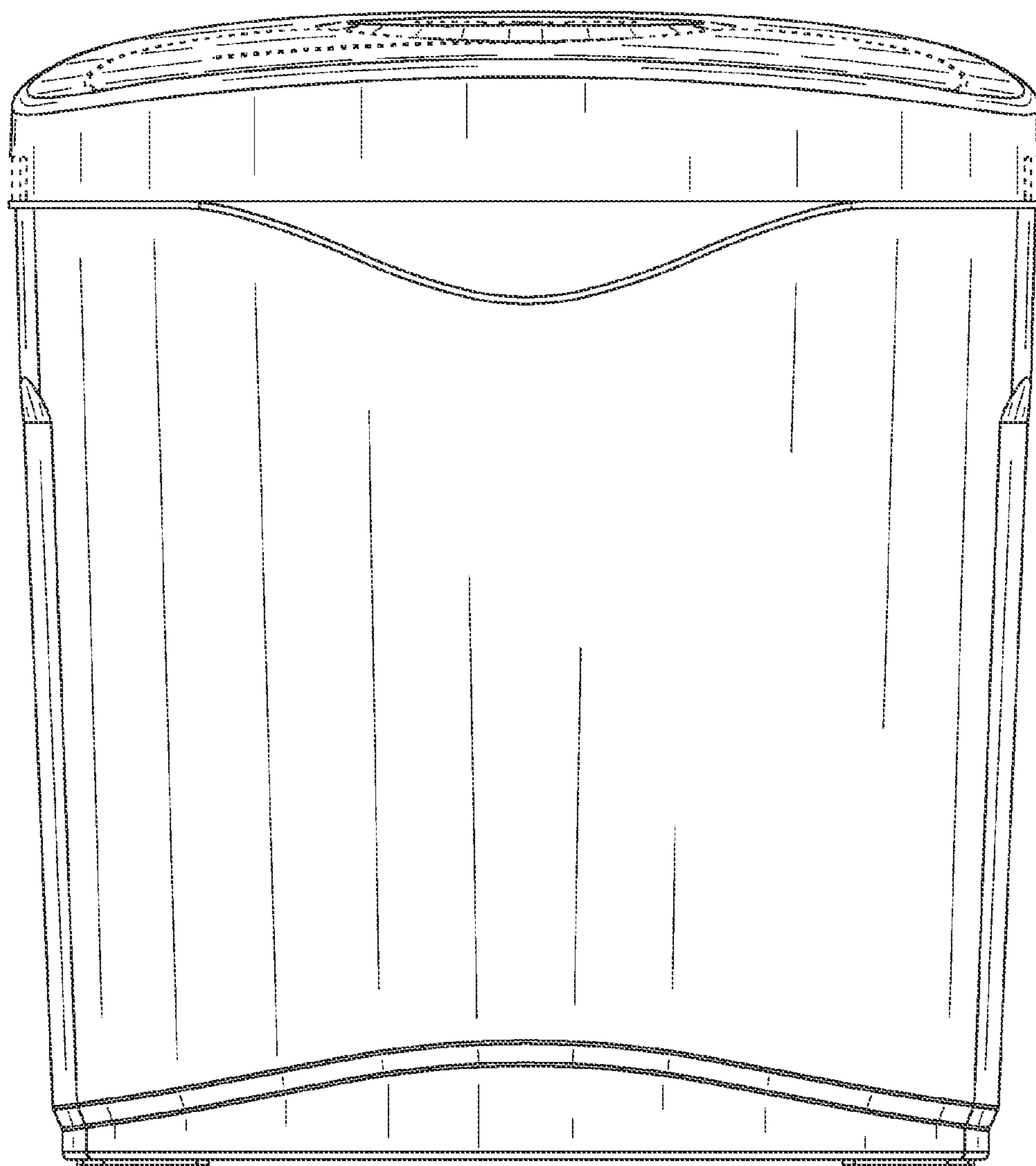

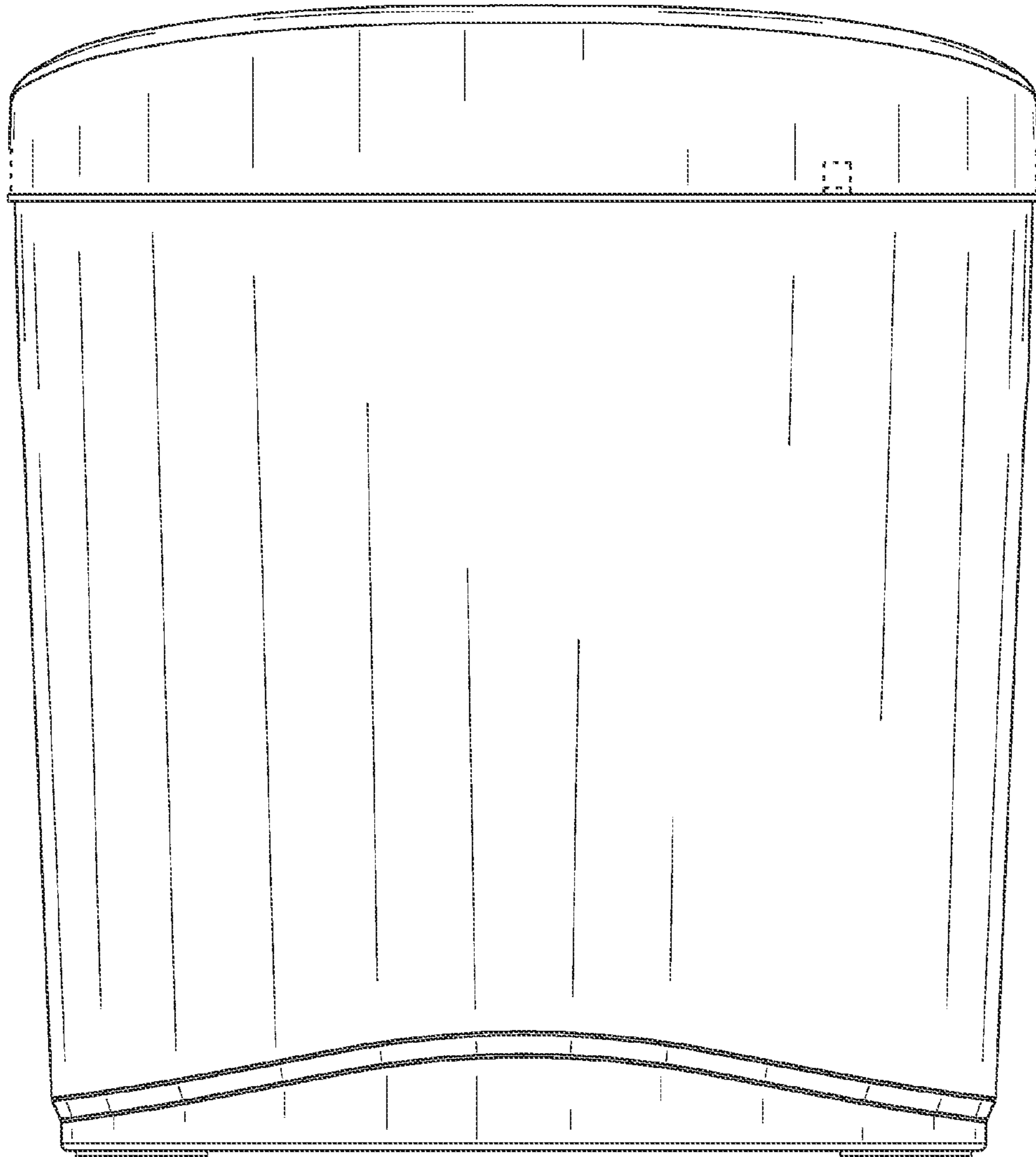

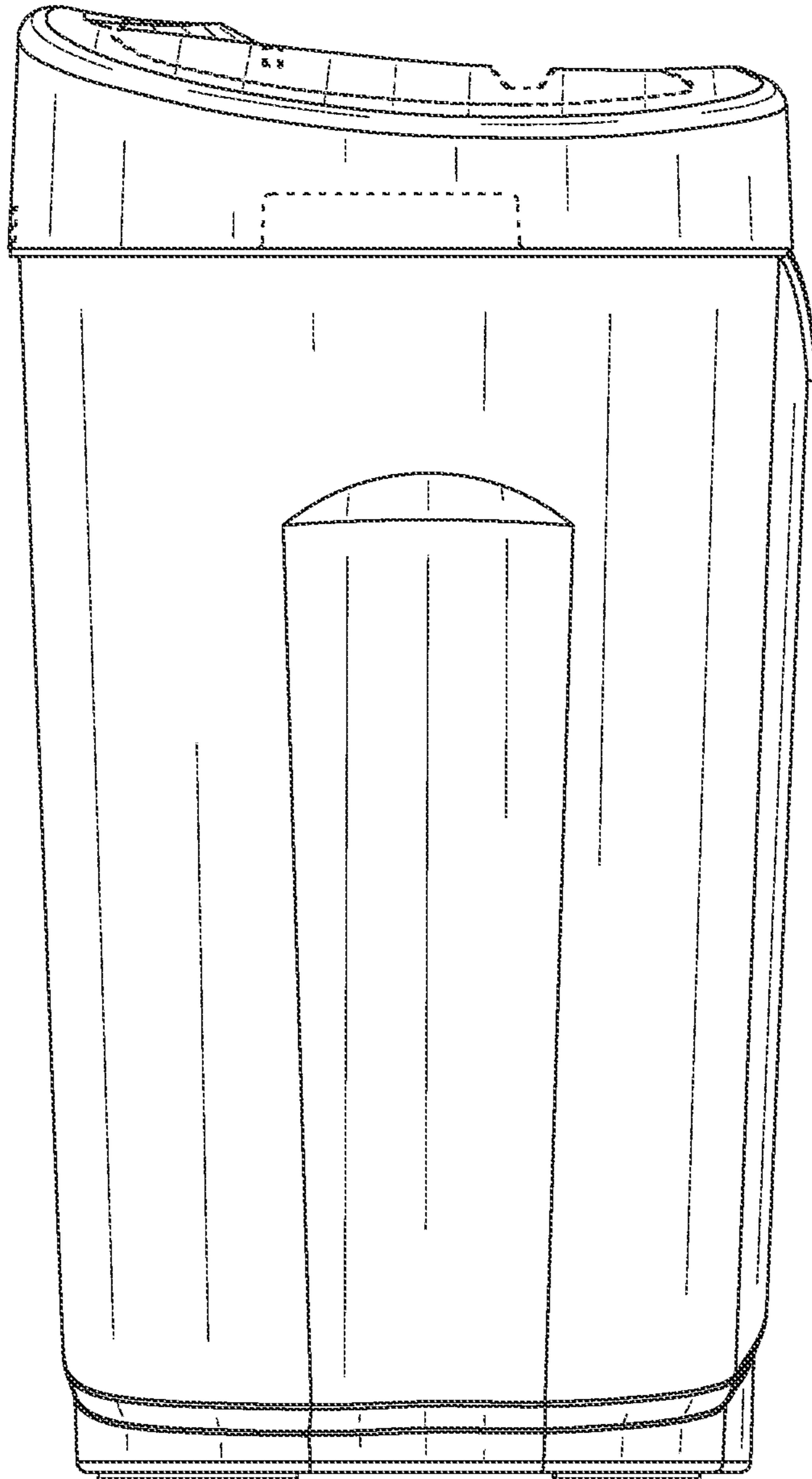

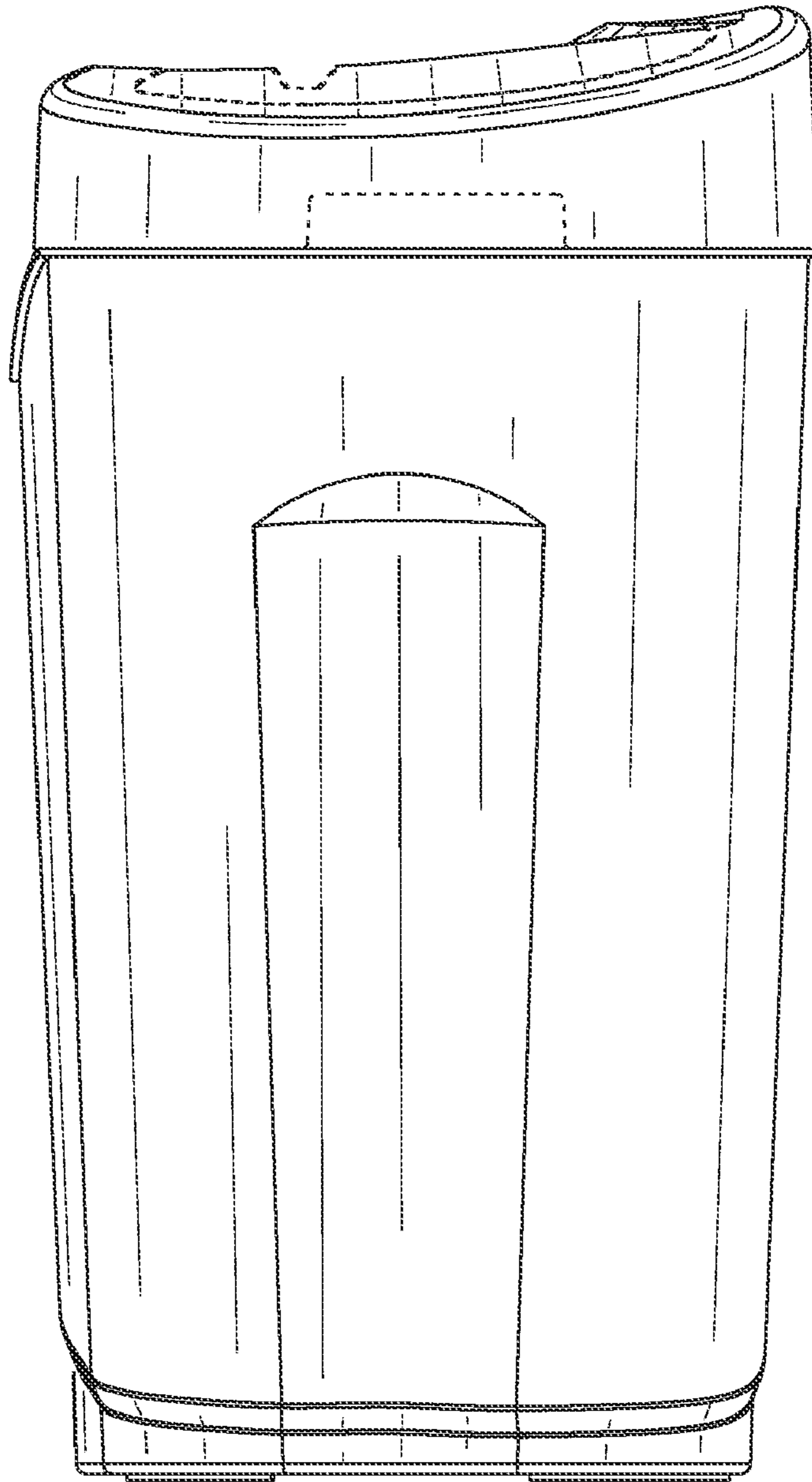
