FIG. 1 is a front elevation view of an educational card showing our new design;

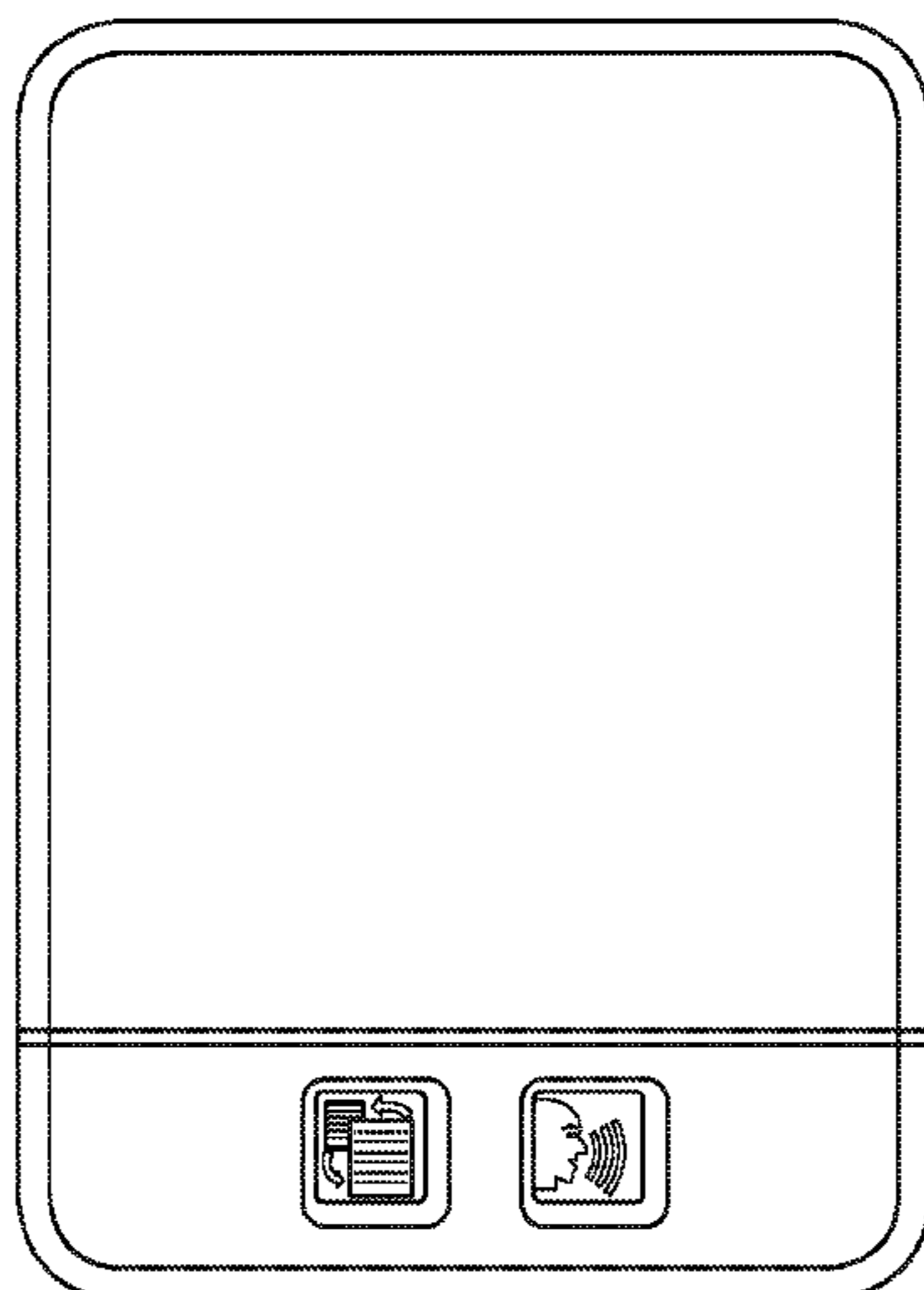
FIG. 2 is a rear elevation view thereof;

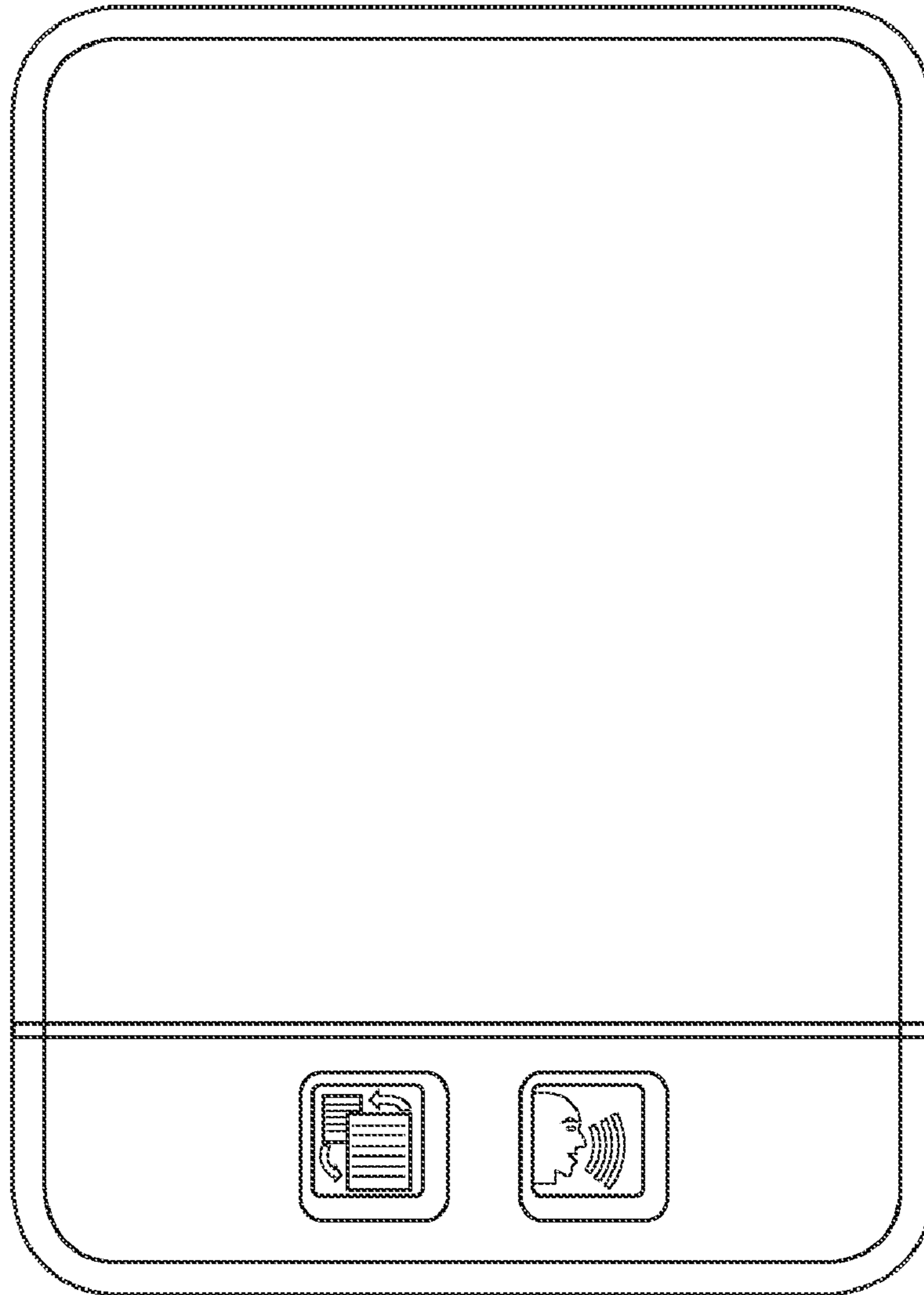

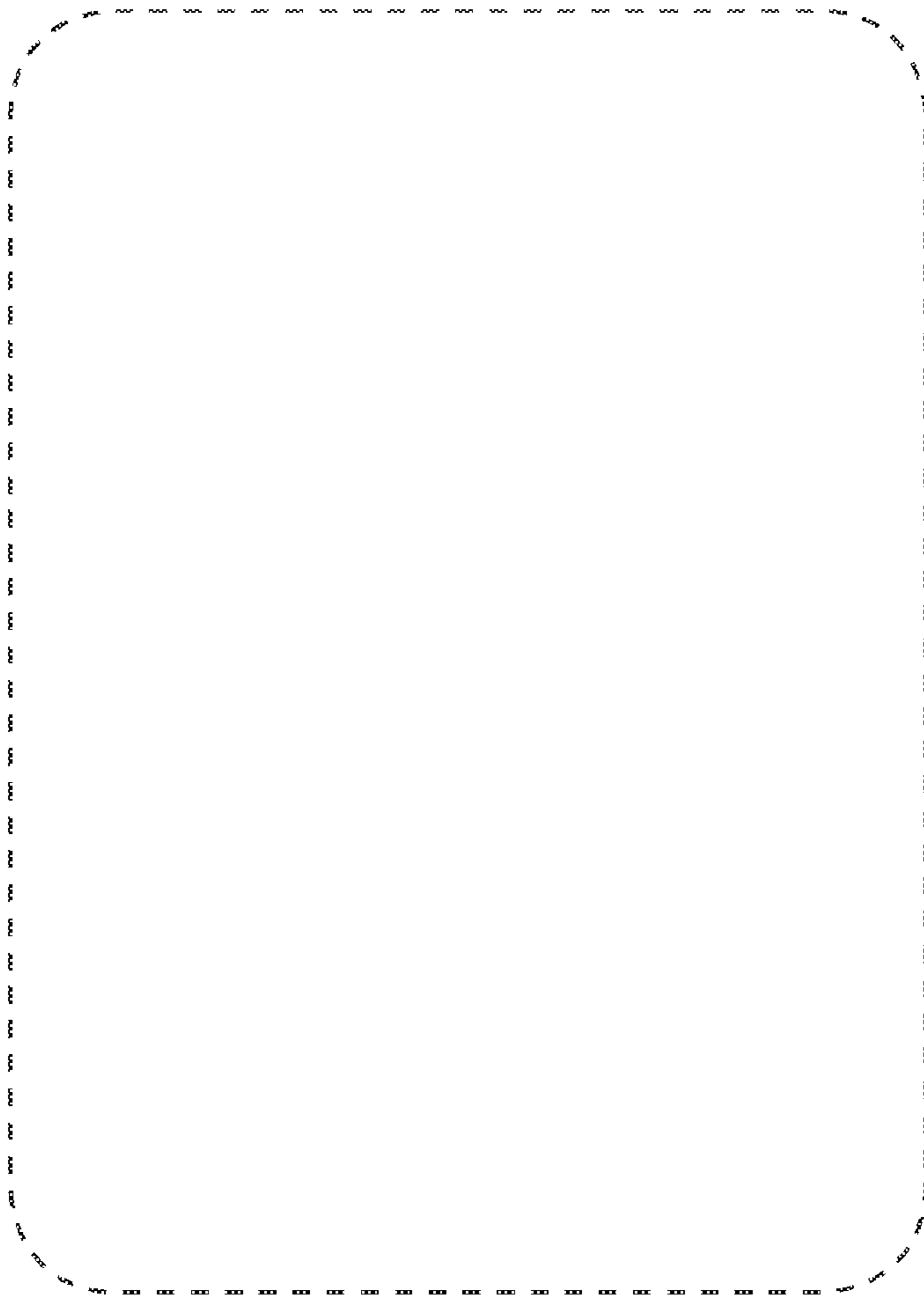
