(57) **CLAIM**

The ornamental design for a liquid storage system, as shown and described.

FIG. 1 is a perspective of a first embodiment of a liquid storage system with environmental aspects shown in broken lines.

FIG. 2 is a perspective of the liquid storage system of FIG. 1 with a portion of the broken lines removed for clarity.

FIG. 3 is a front view of the liquid storage system of FIG. 1. FIG. 4 is a right side view of the liquid storage system of FIG. 1 (the left side view being a mirror image of this view).

FIG. 5 is a rear view of the liquid storage system of FIG. 1. FIG. 6 is a top view of the liquid storage system of FIG. 1. FIG. 7 is a bottom view of the liquid storage system of FIG. 1.

FIG. 8 is a perspective of a second embodiment of a liquid storage system with environmental aspects shown in broken lines.

FIG. 9 is a front view of the liquid storage system of FIG. 8. FIG. 10 is a right side view of the liquid storage system of FIG. 8 (the left side view being a mirror image of this view).

FIG. 11 is a rear side view of the liquid storage system of FIG. 8.

FIG. 12 is a top view of the liquid storage system of FIG. 8. FIG. 13 is a bottom view of the liquid storage system of FIG. 8.

FIG. 14 is a perspective of a third embodiment of a liquid storage system with environmental aspects shown in broken lines.

FIG. 15 is a front view of the liquid storage system of FIG. 14. FIG. 16 is a right side view of the liquid storage system of FIG. 14 (the left side view being a mirror image of this view).

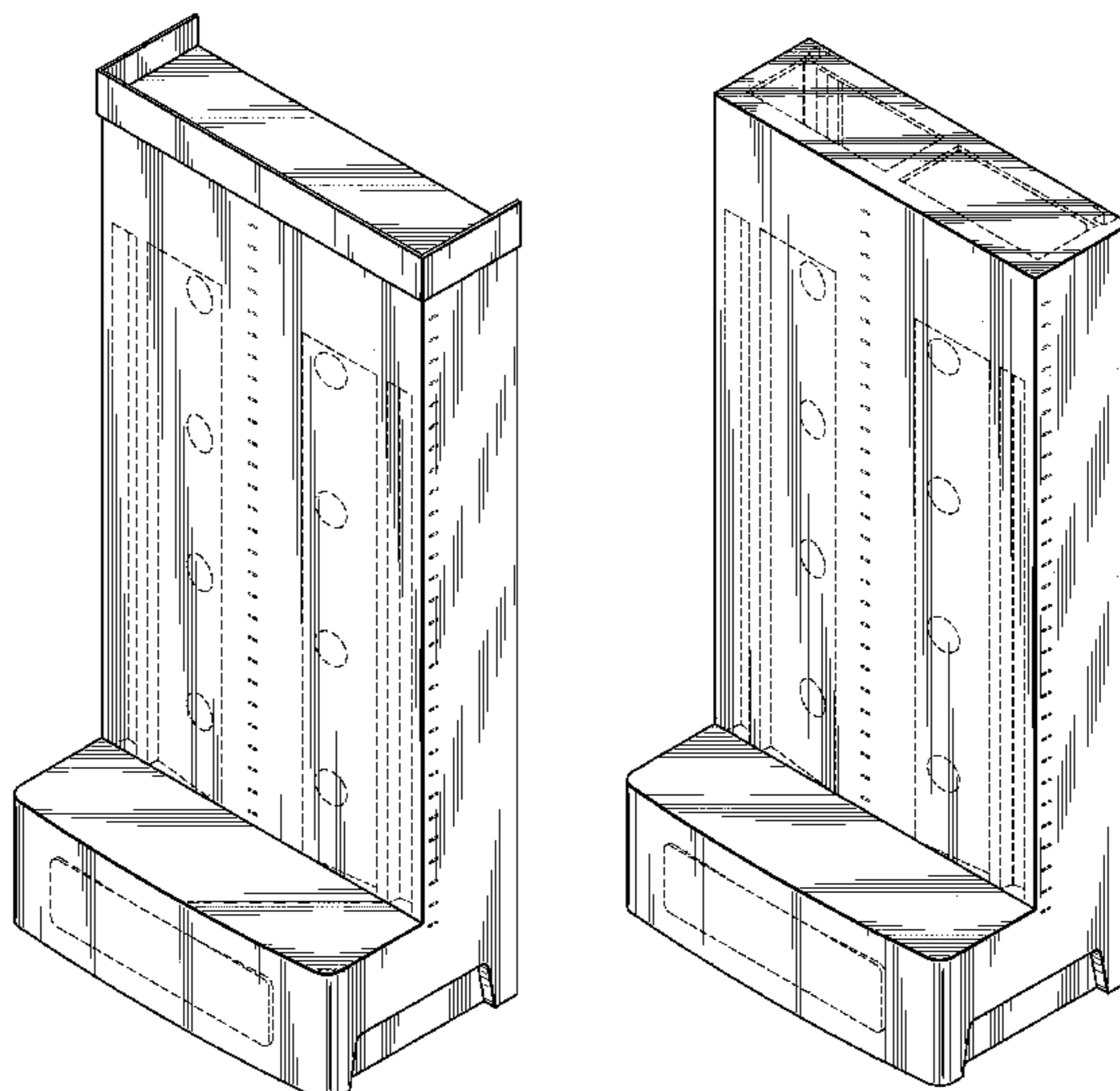
FIG. 17 is a rear side view of the liquid storage system of FIG. 14.

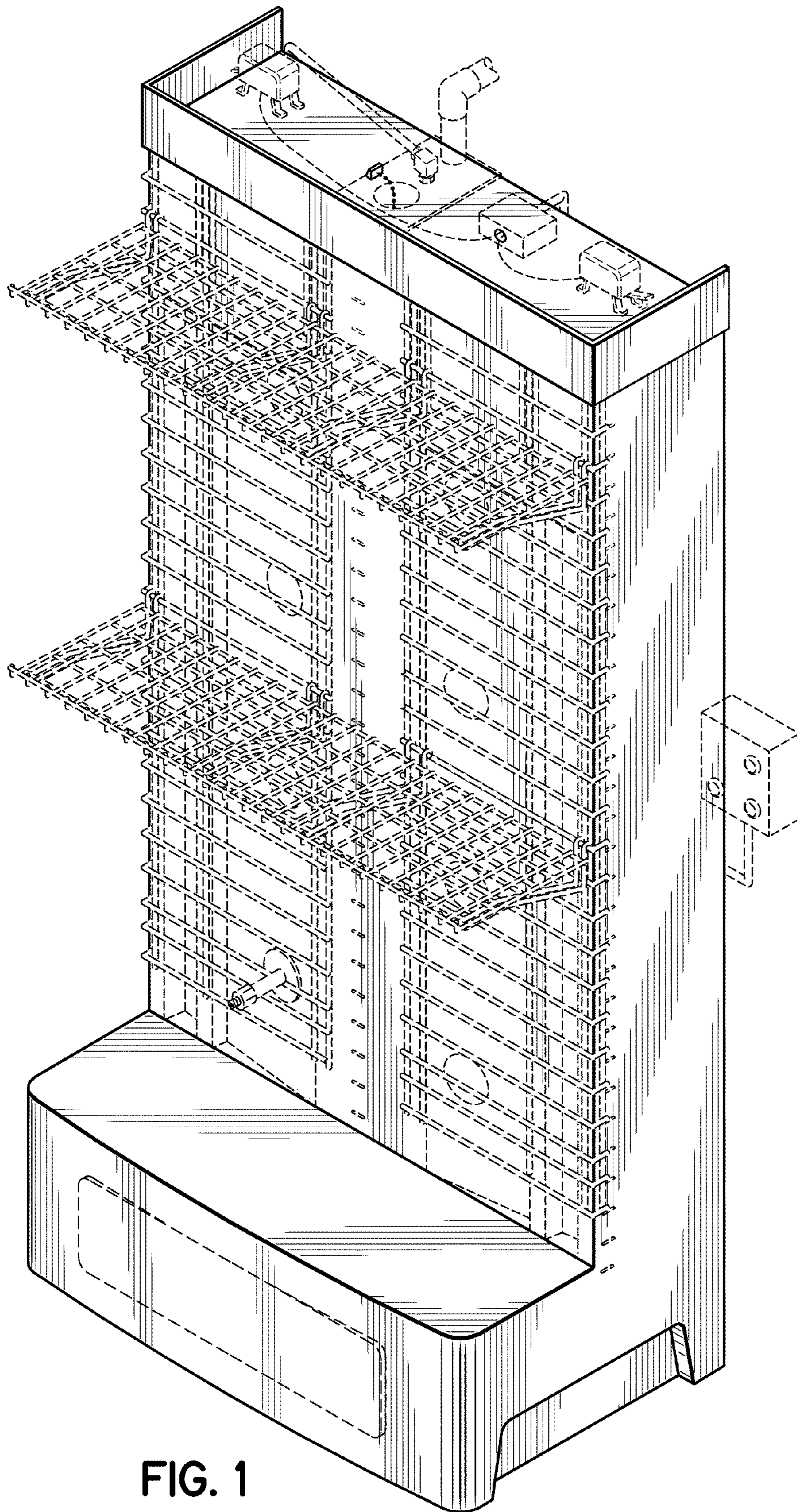

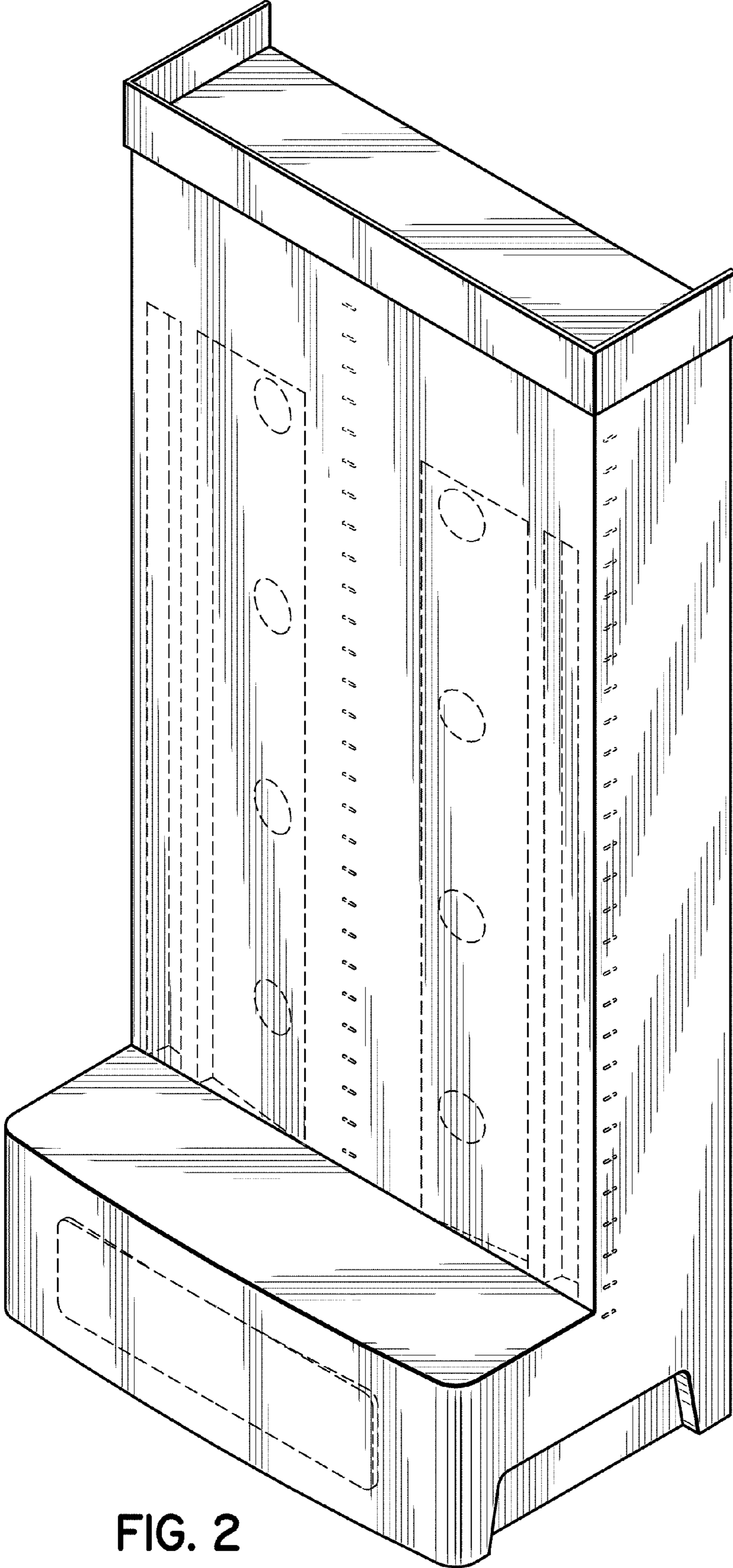

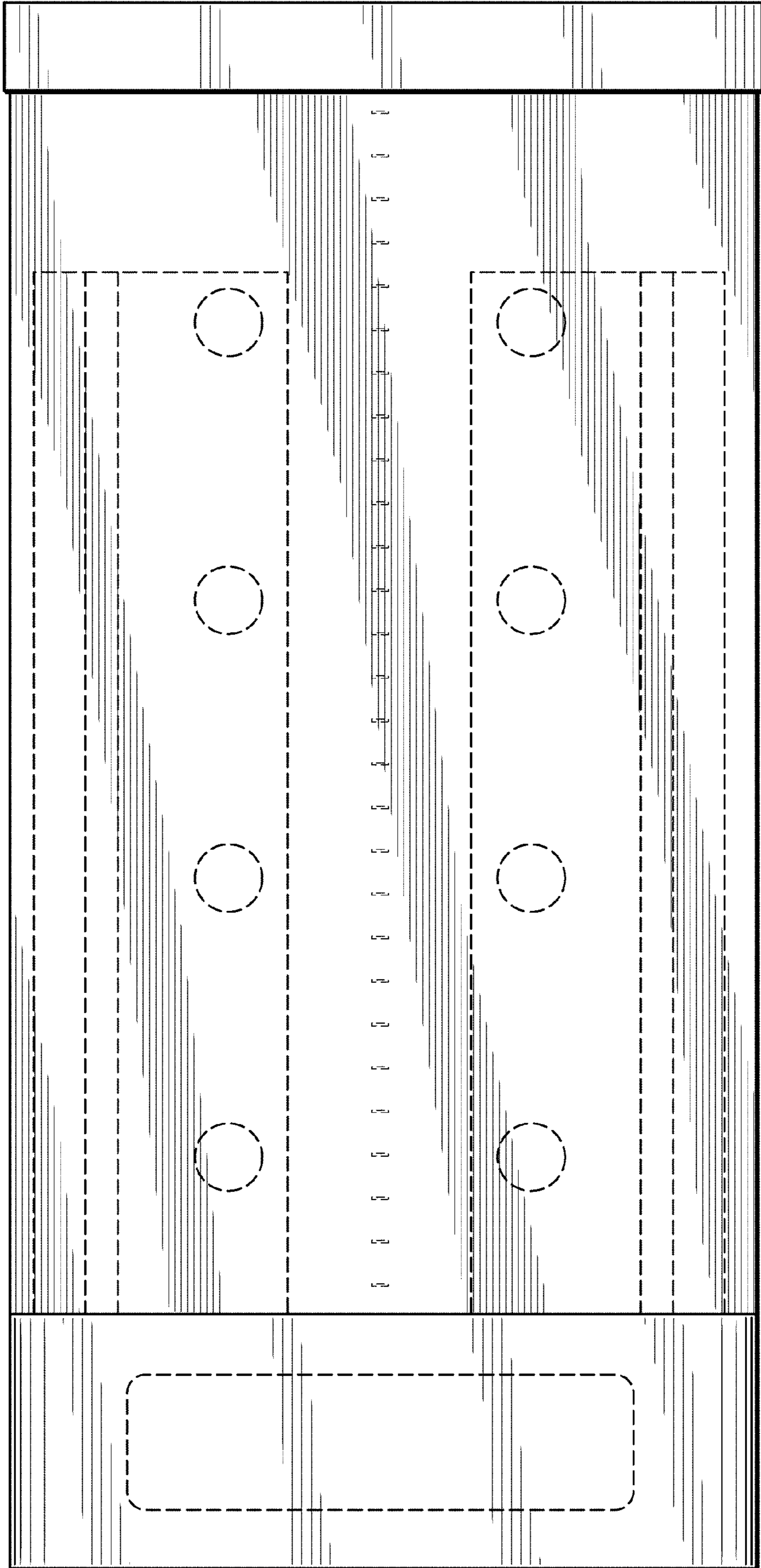

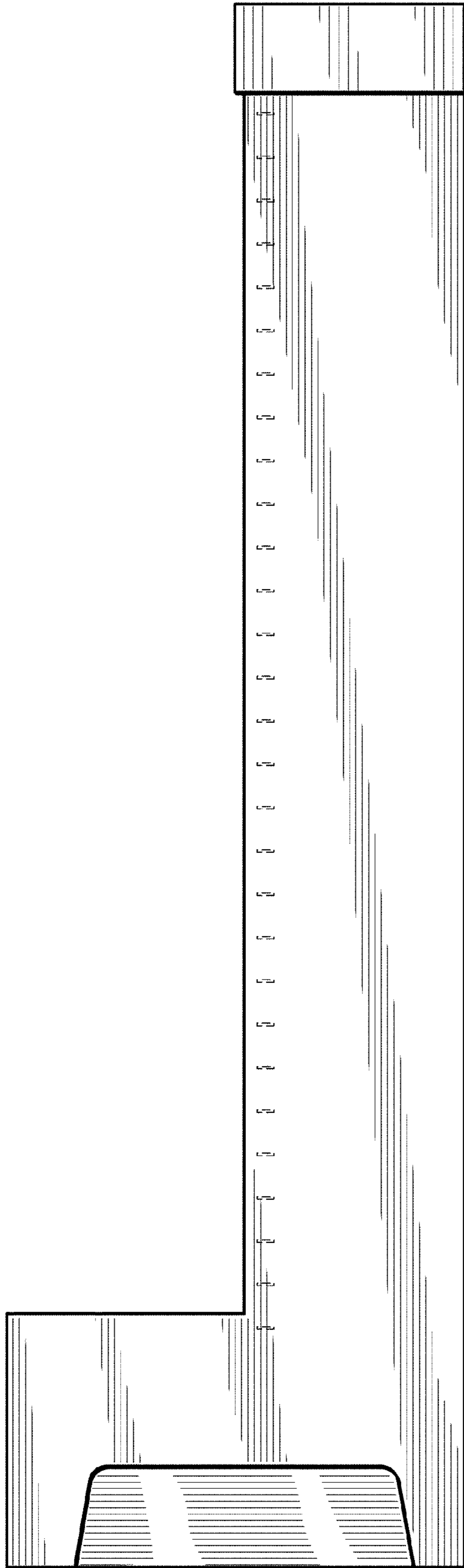

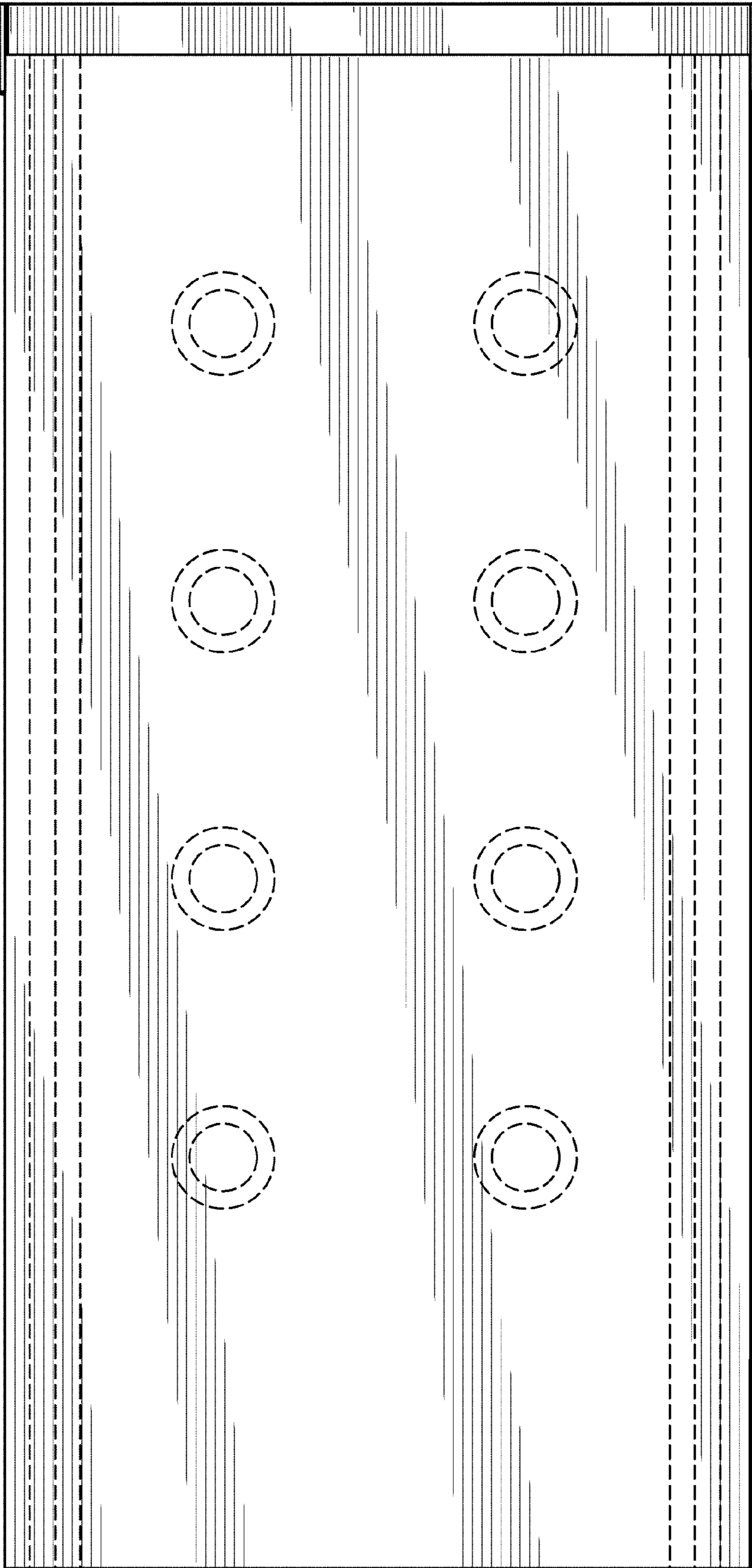

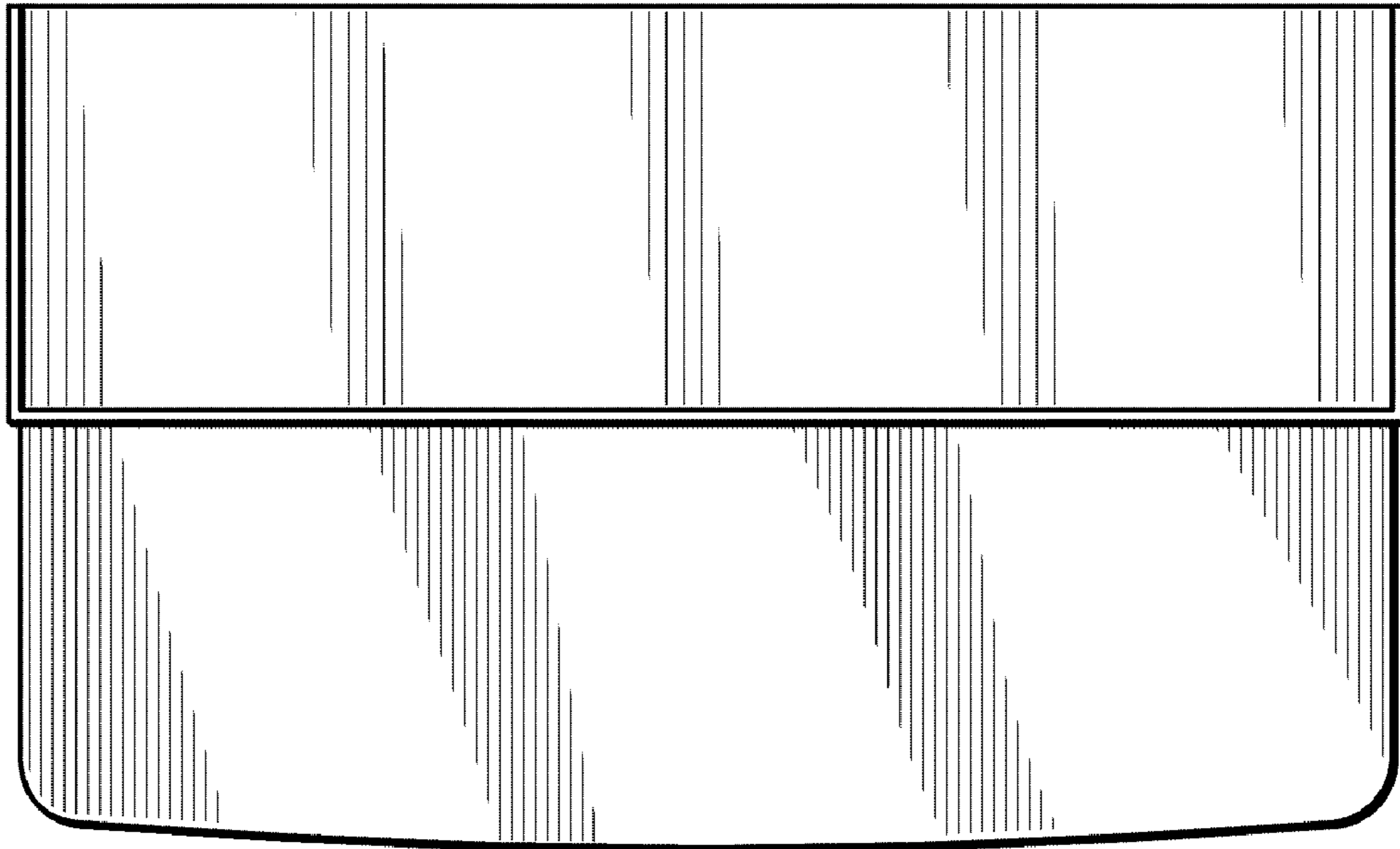

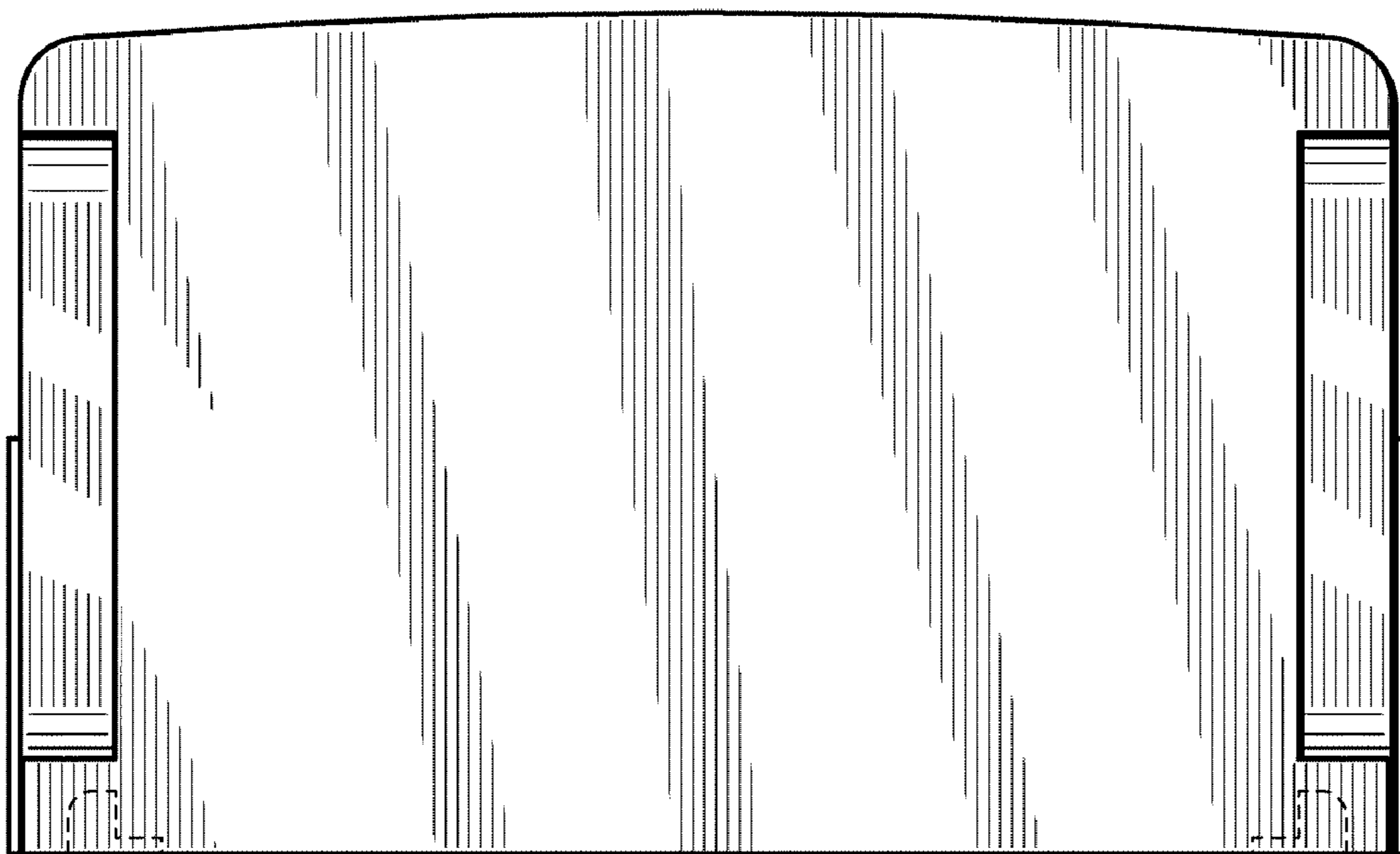

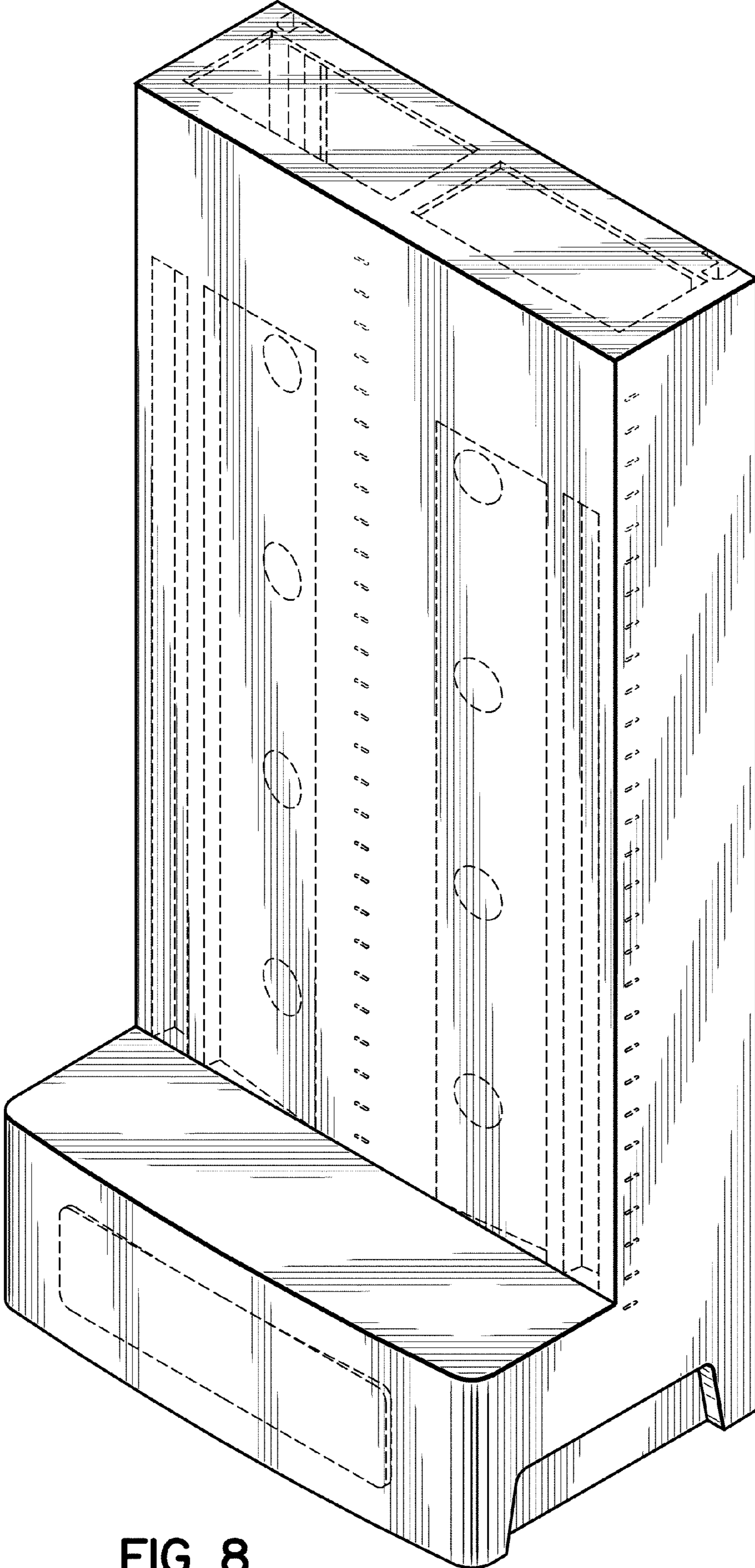

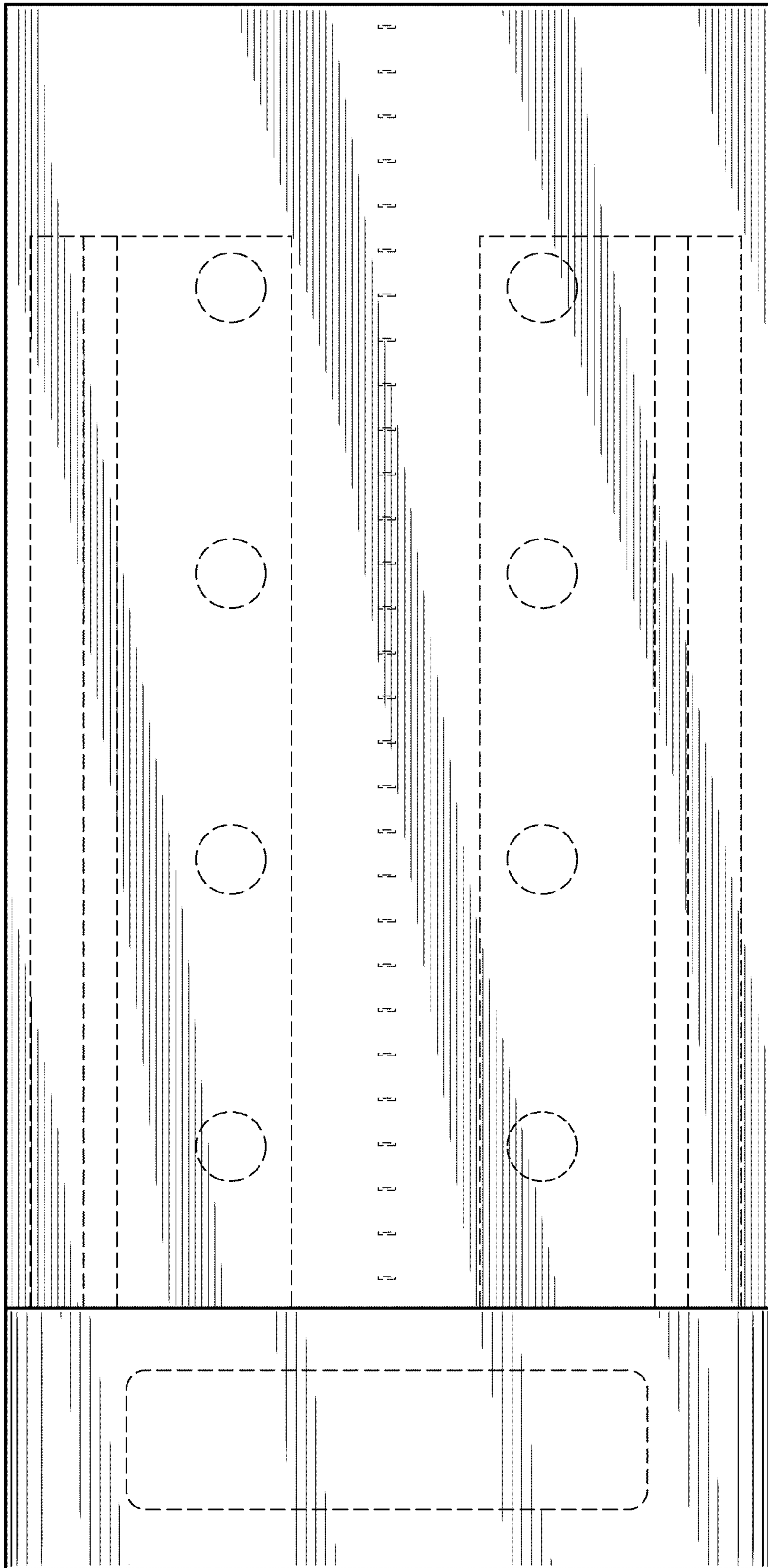

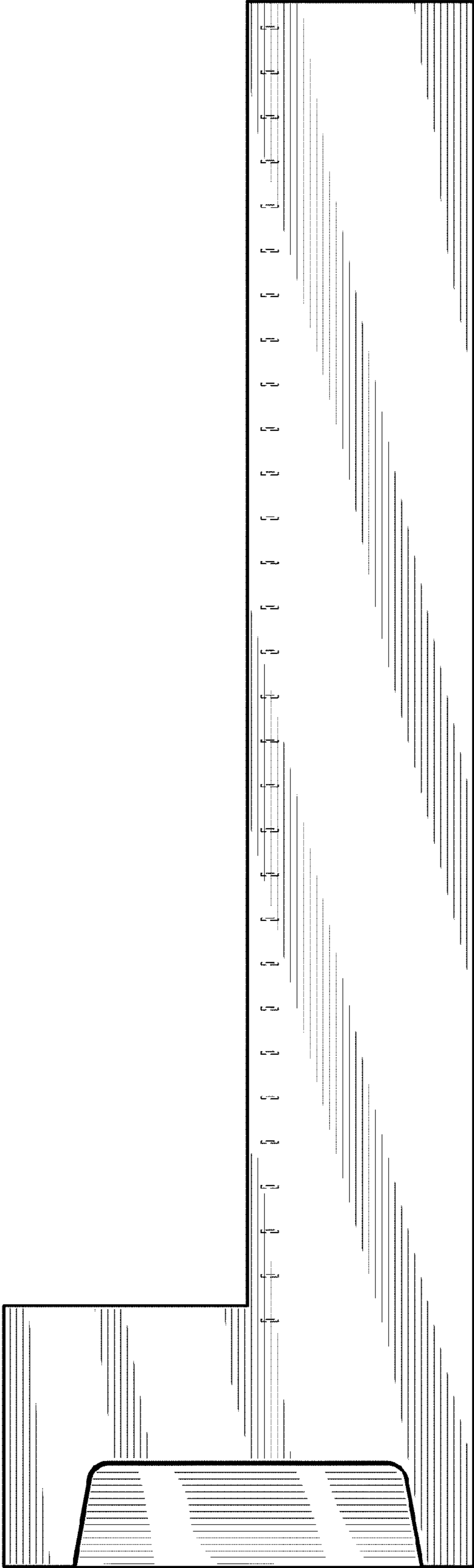

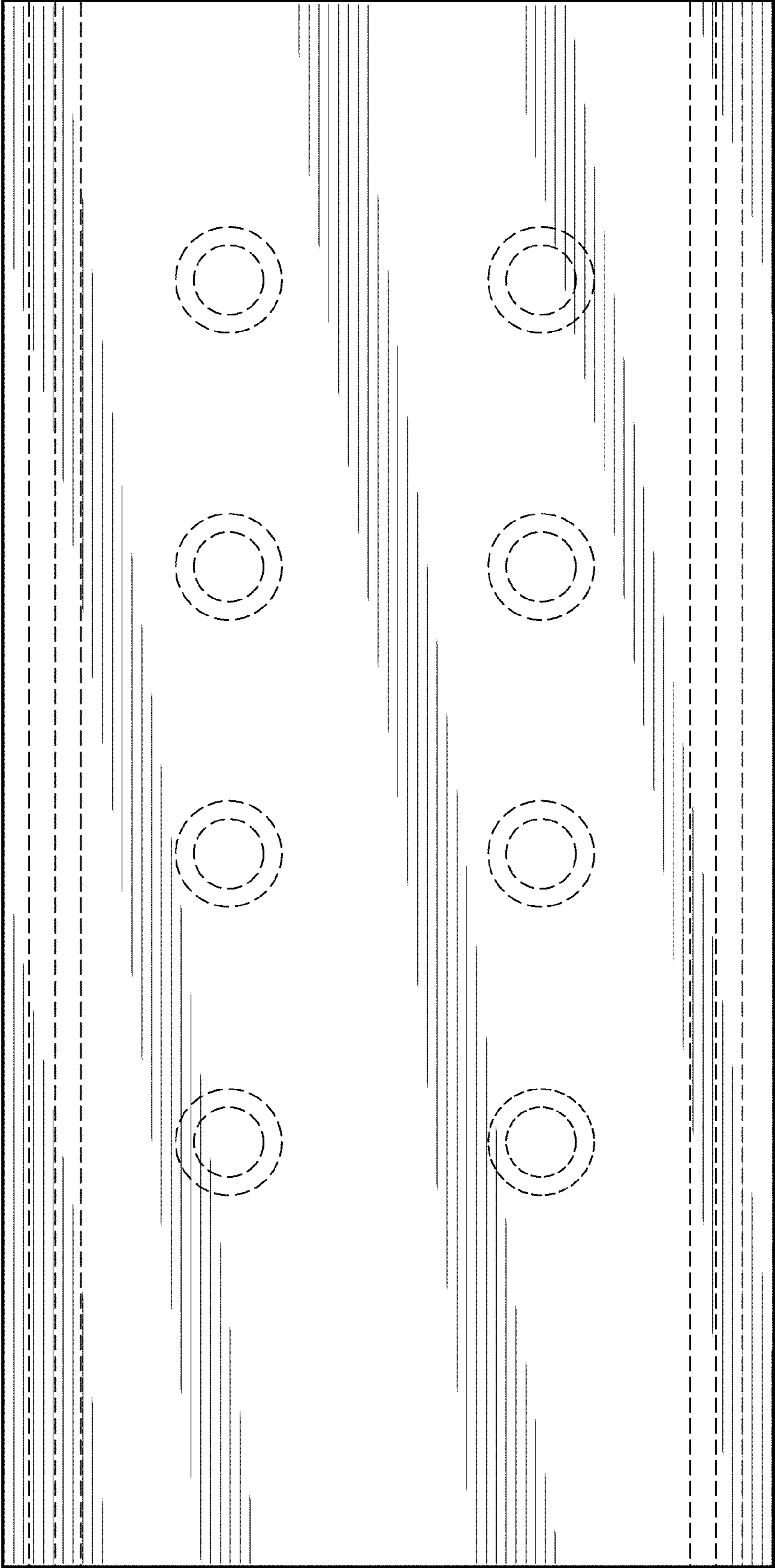

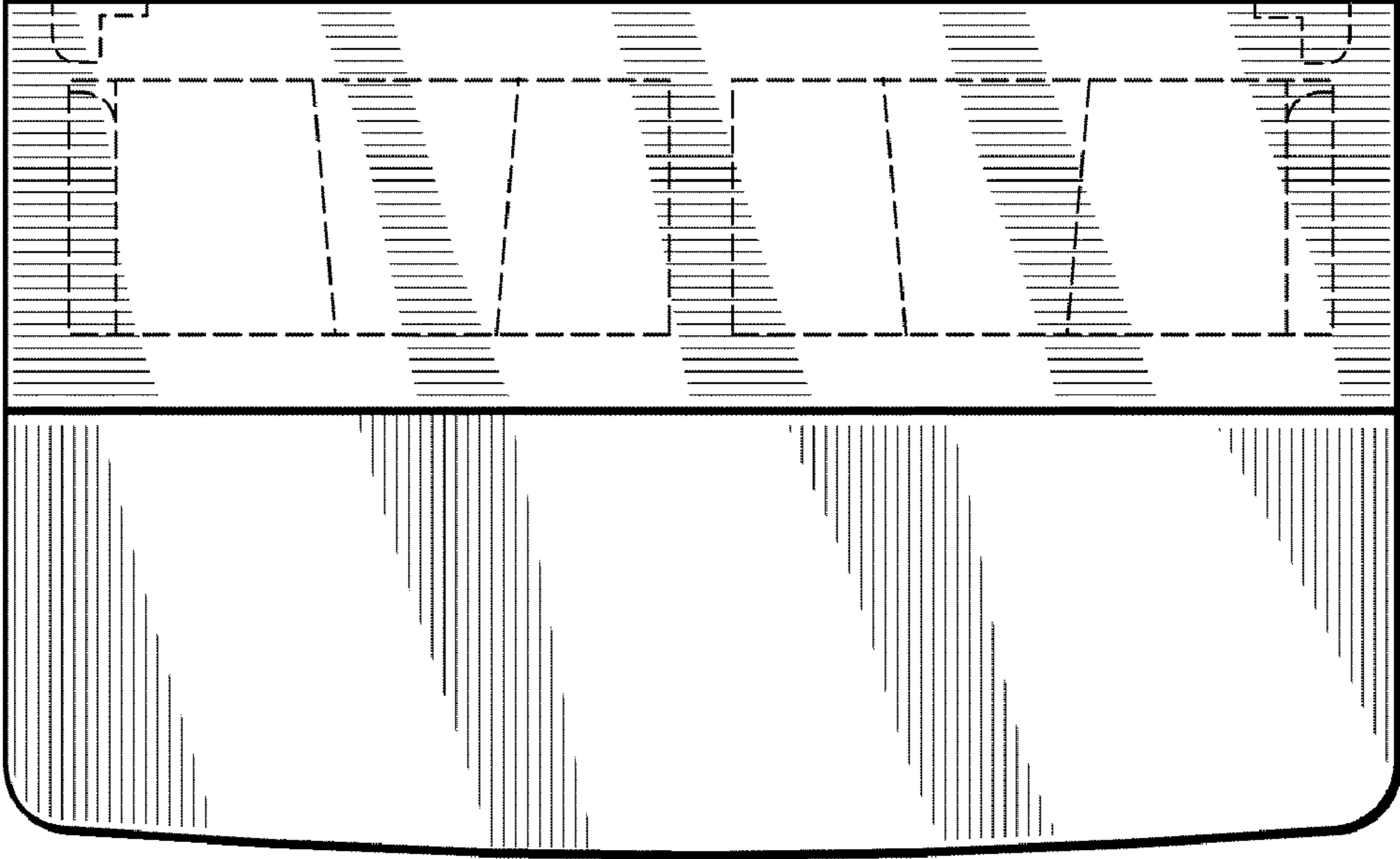

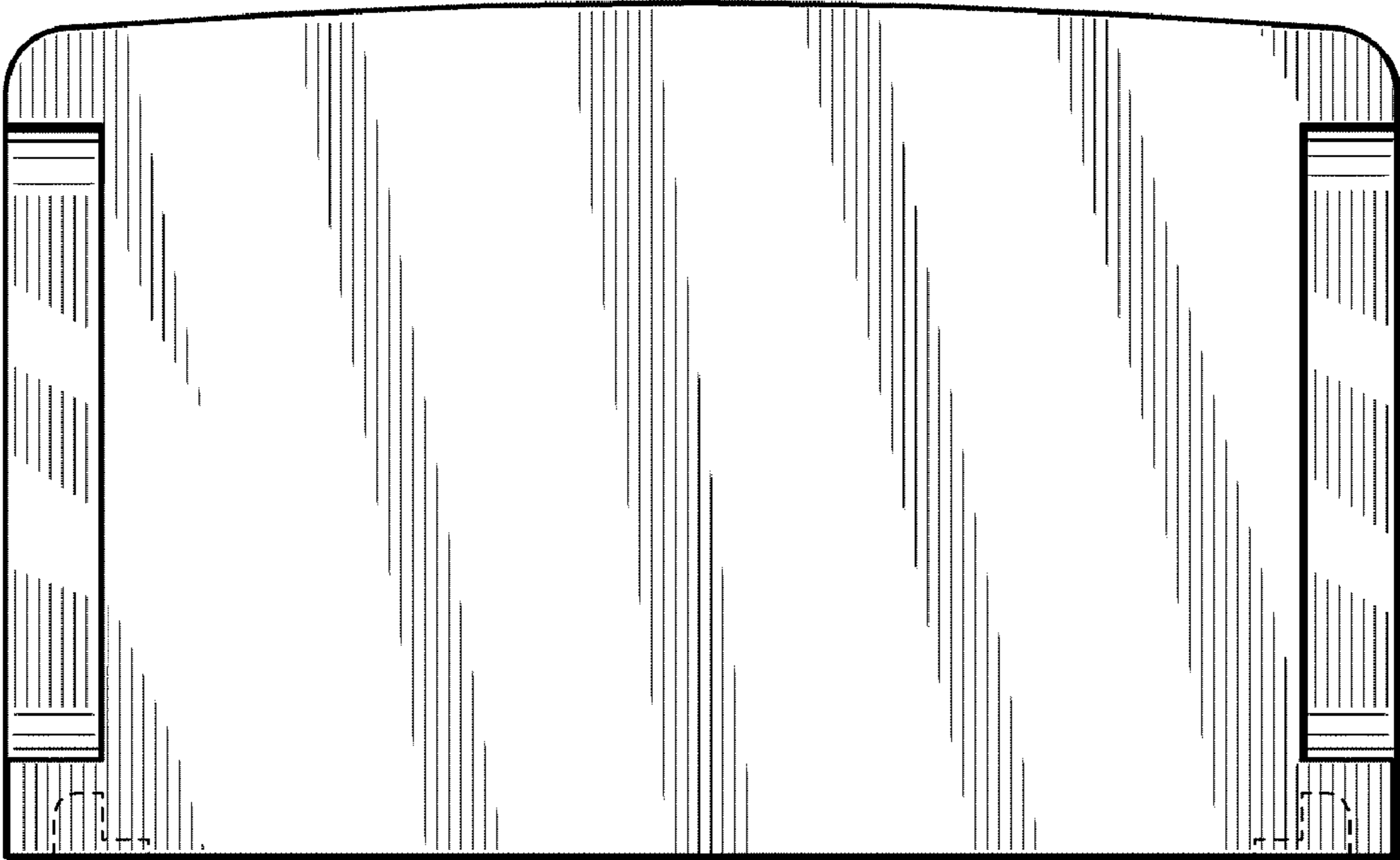

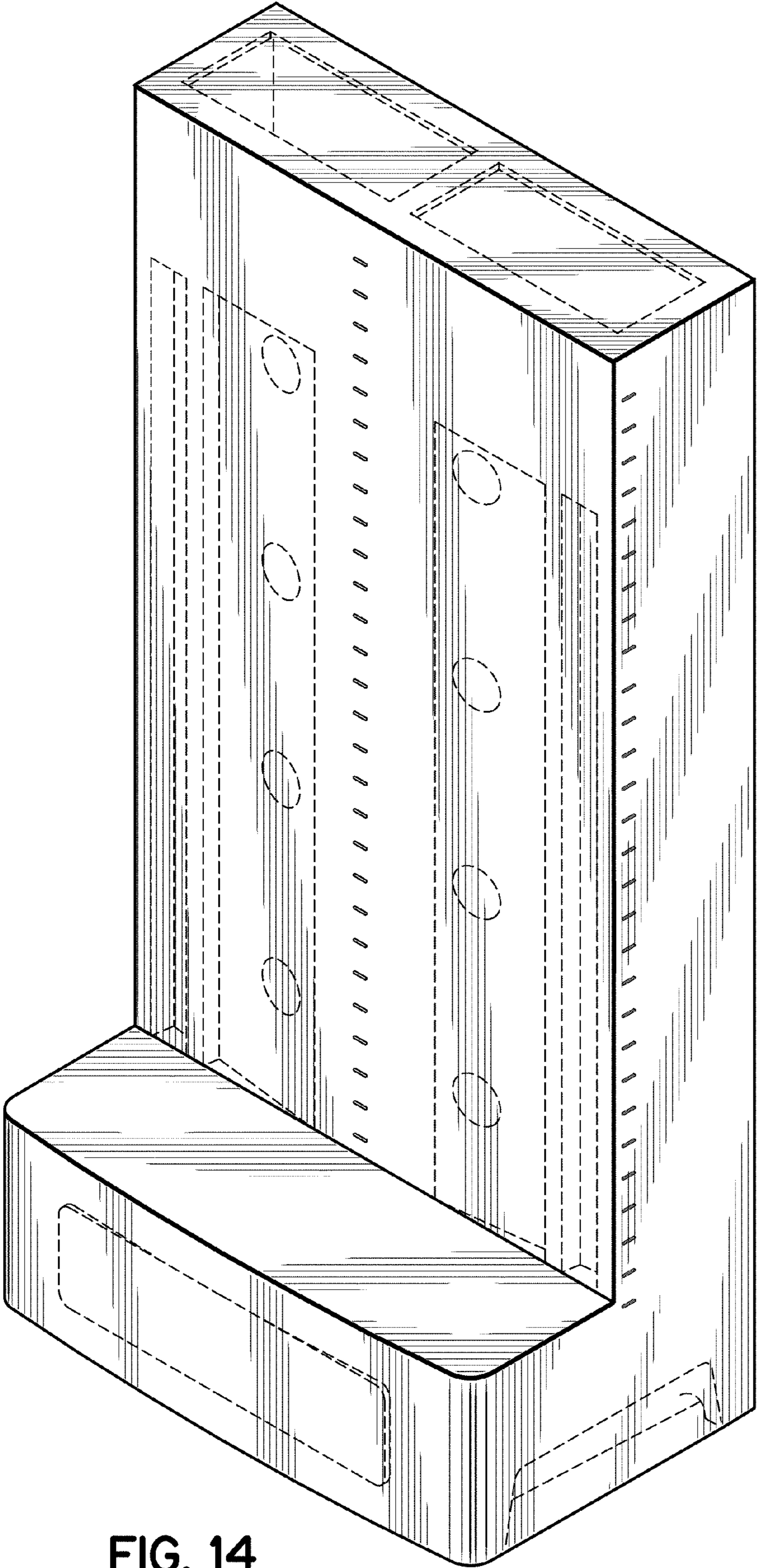

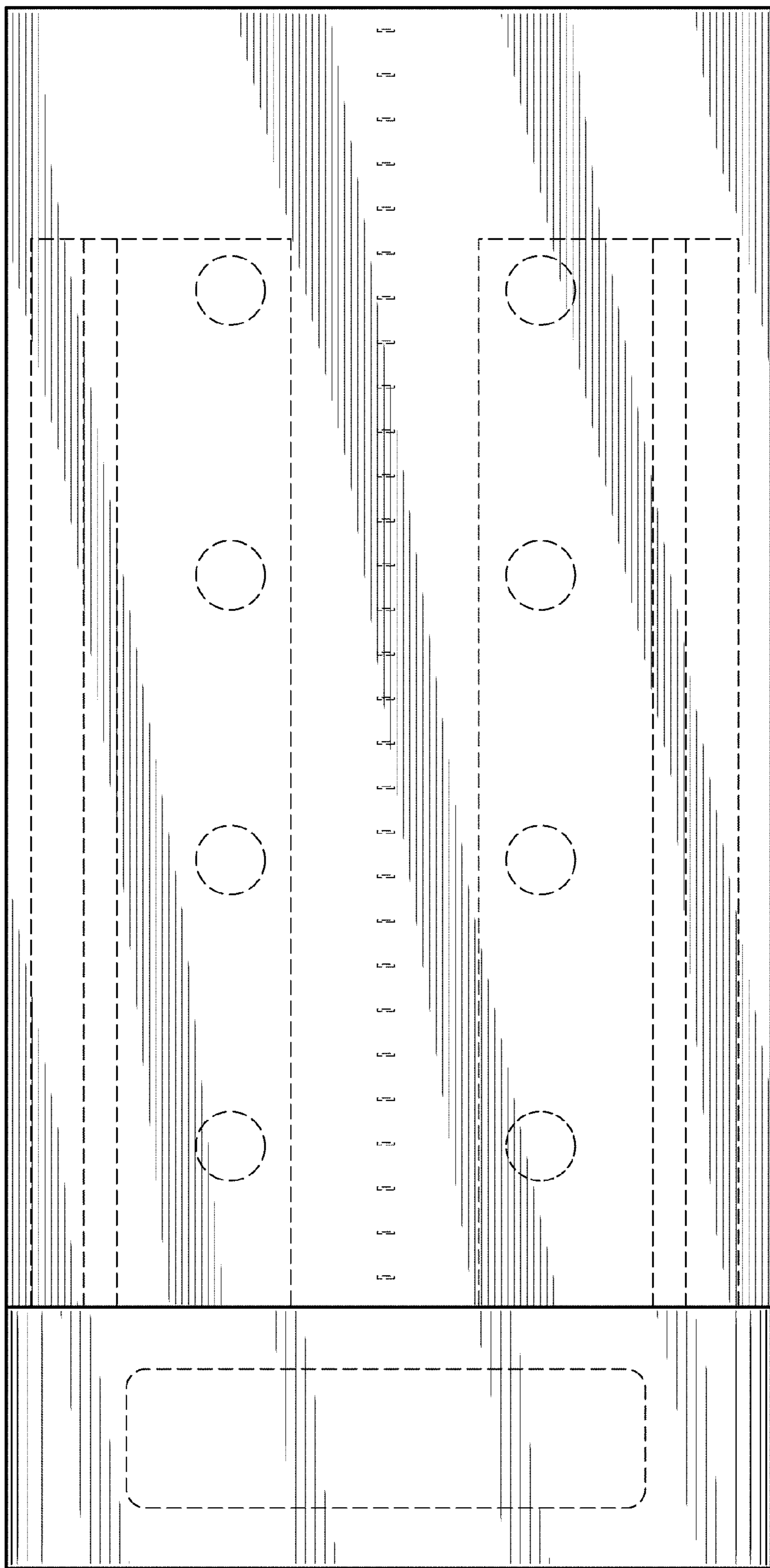

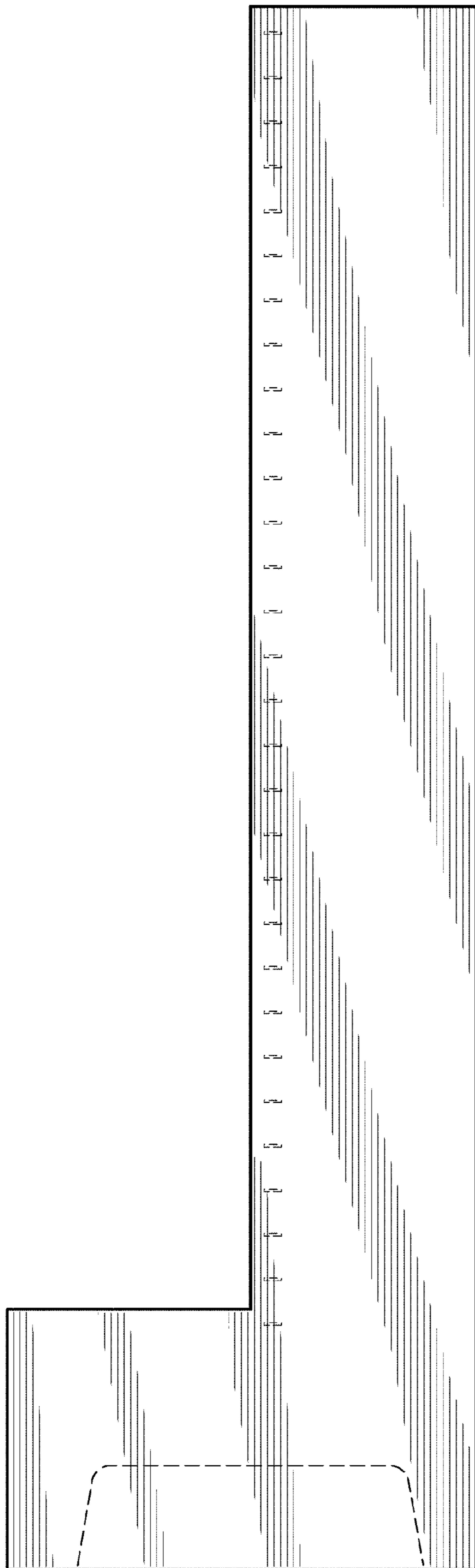

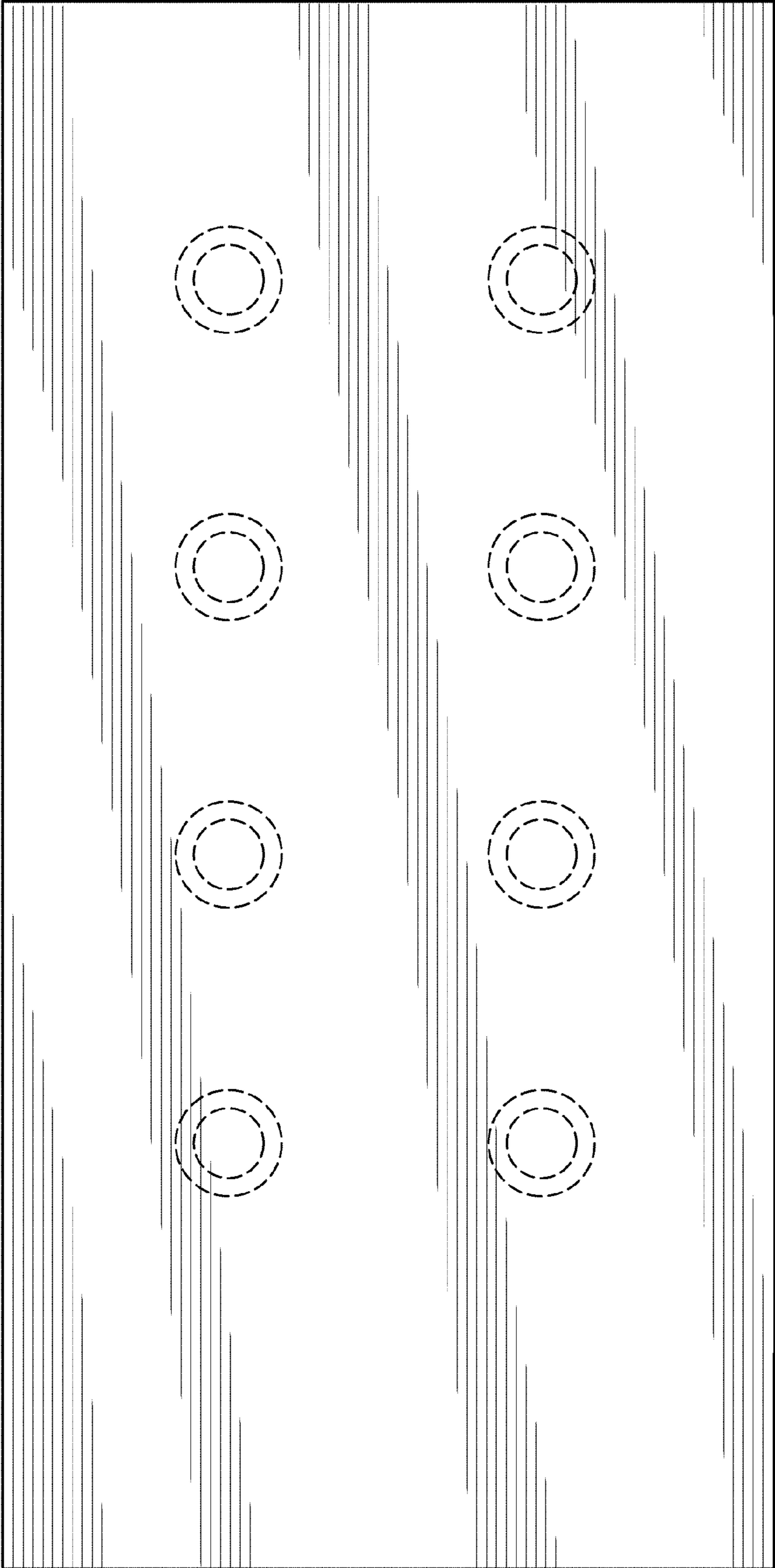

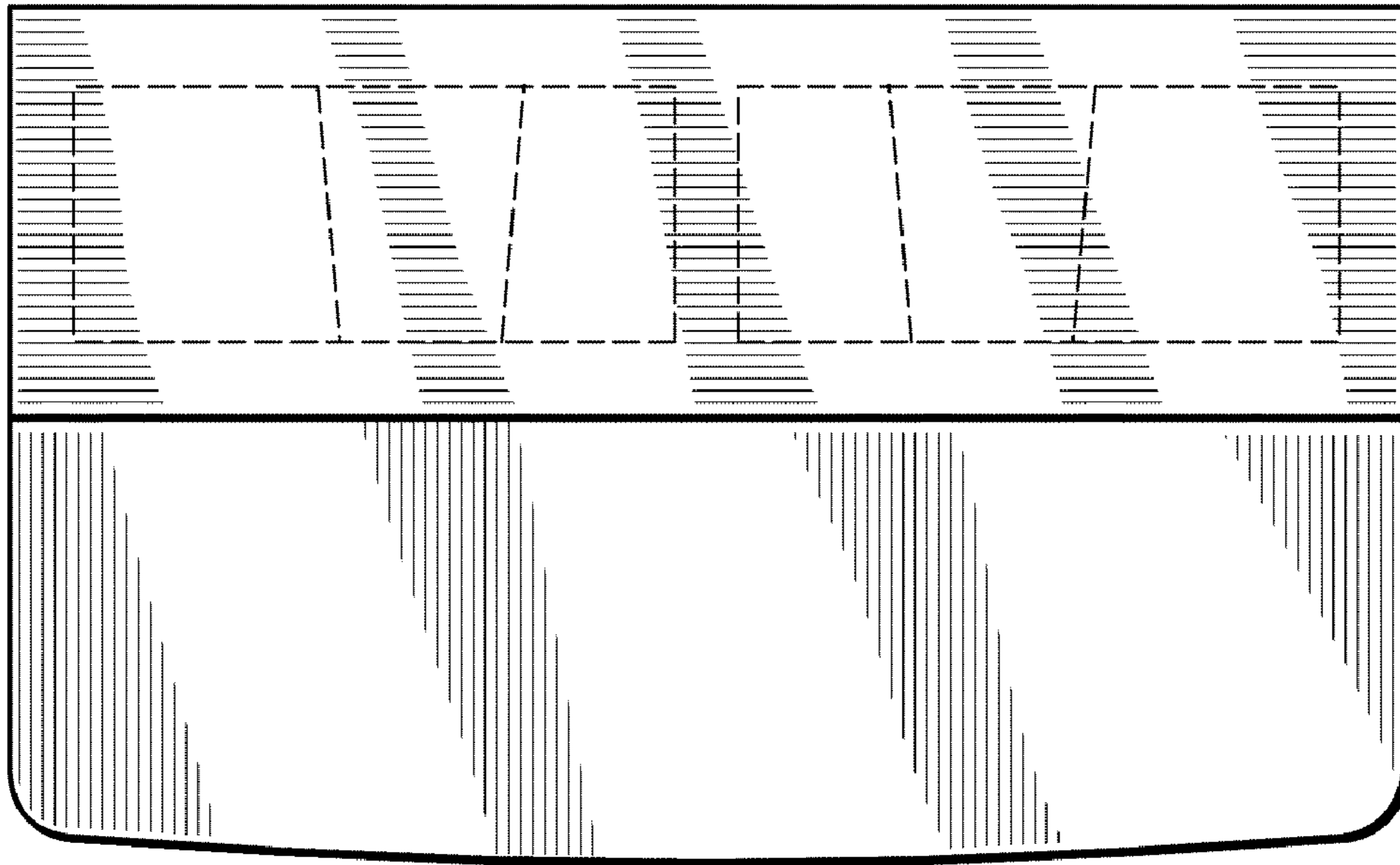

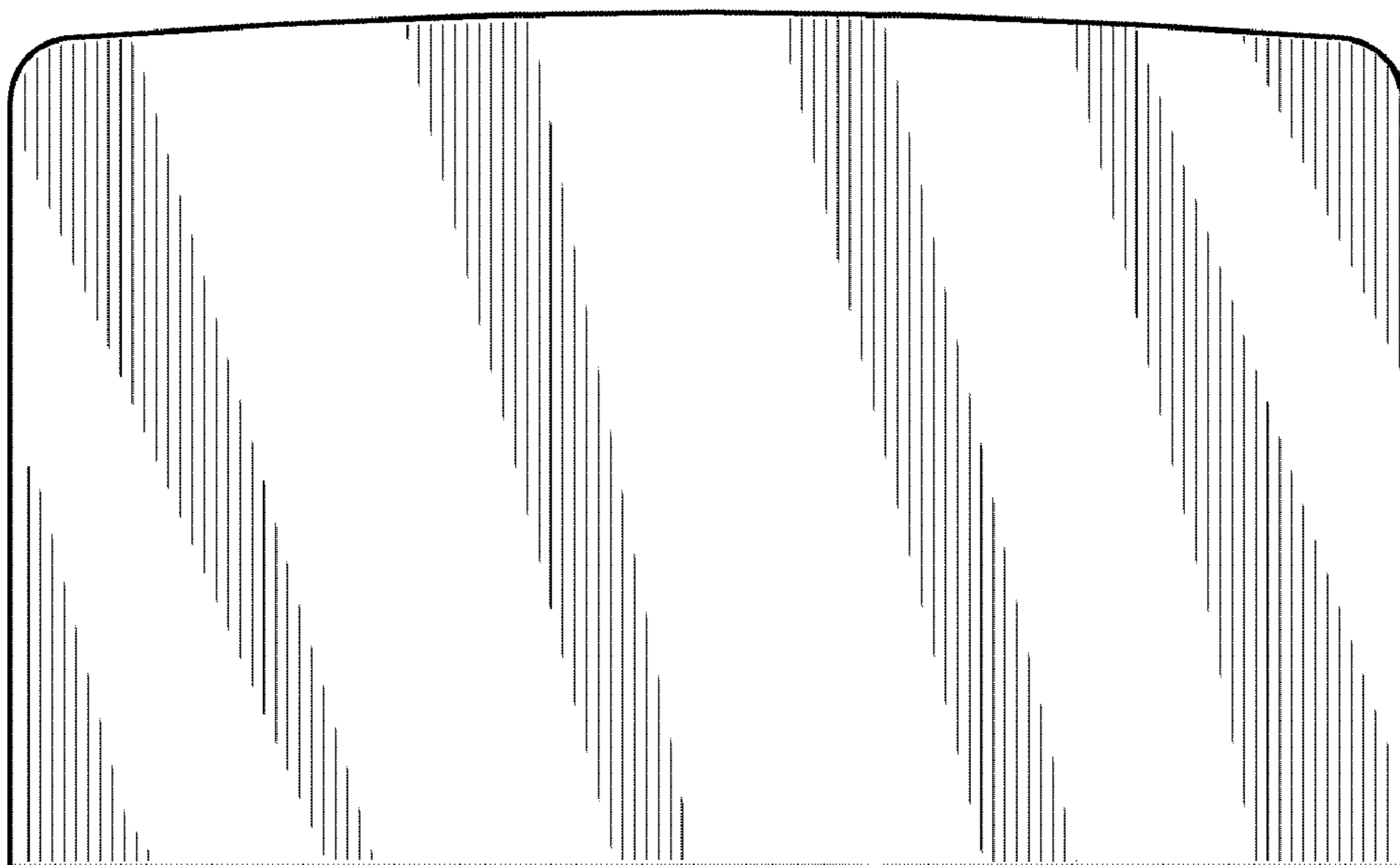
