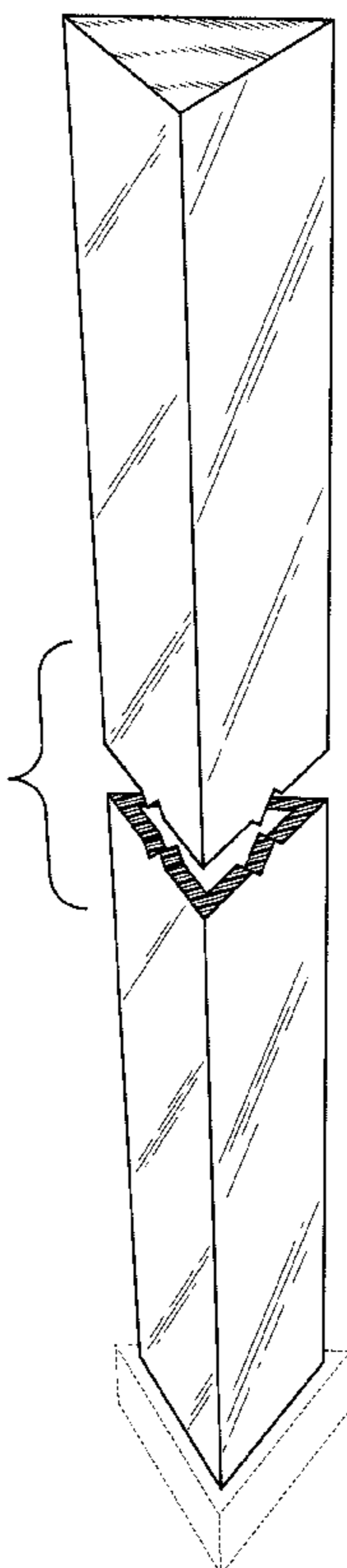
The ornamental design for a triangular light column, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a triangular light column; FIG. 2 is a top-perspective view thereof; FIG. 3 is a left elevational view thereof; FIG. 4 is a front elevational thereof; FIG. 5 is a right elevational thereof; FIG. 6 is a back elevational thereof; and, FIG. 7 is a top plan view thereof.

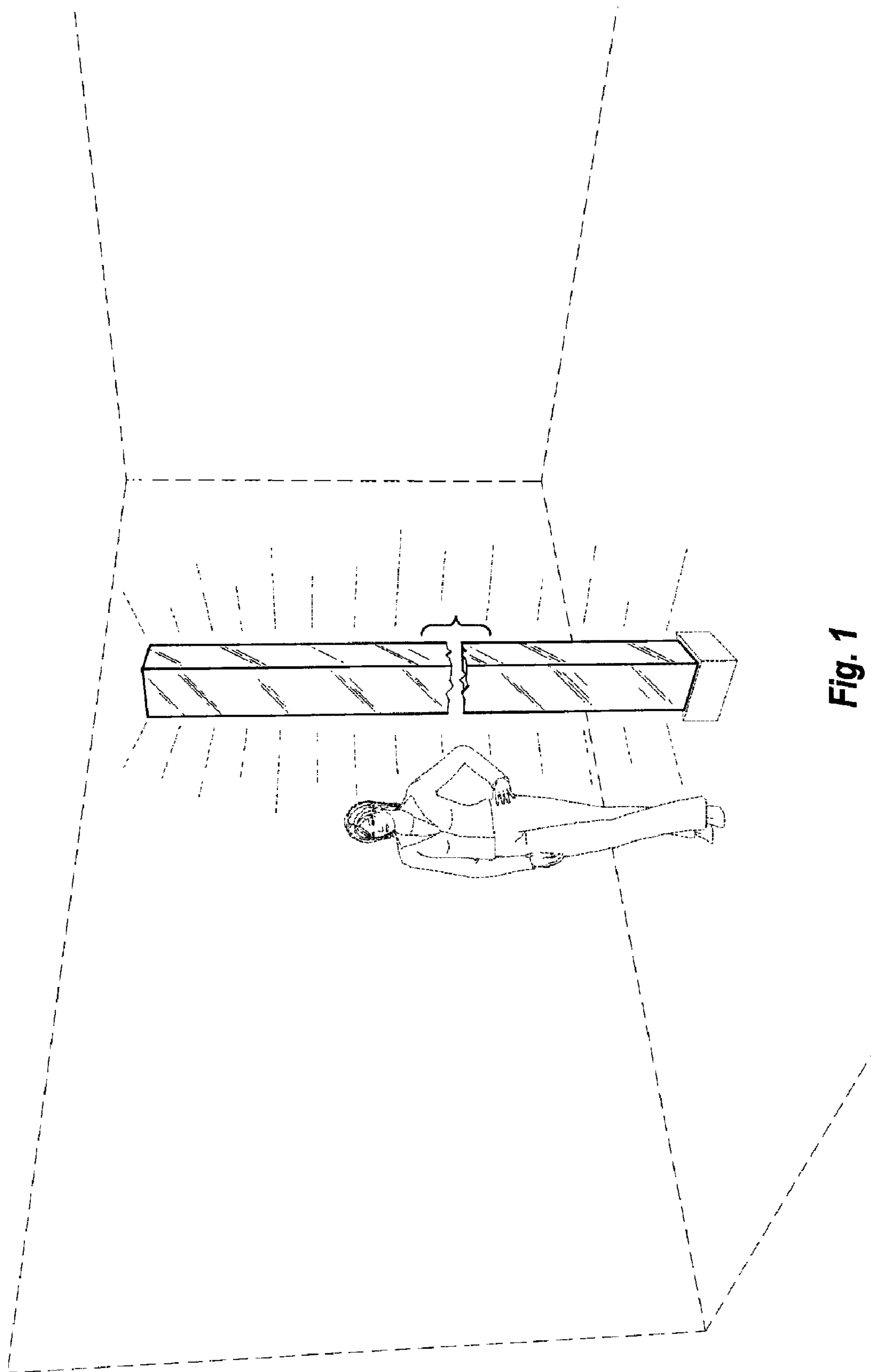

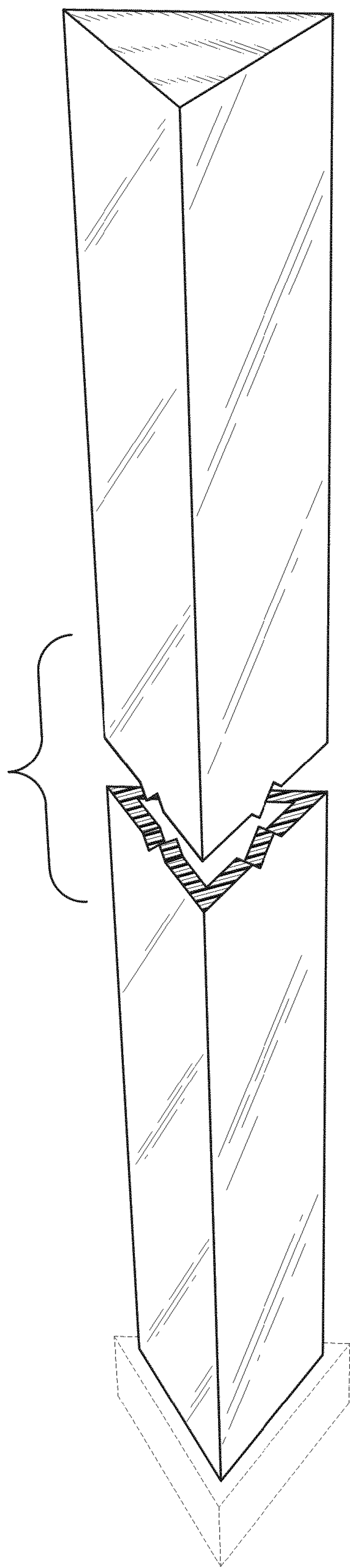

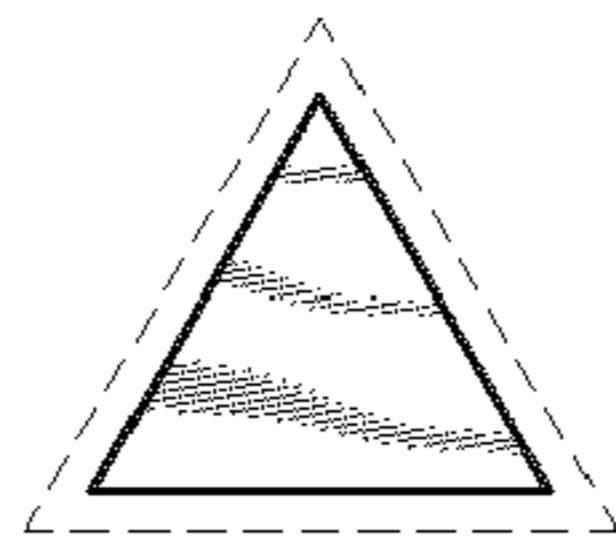

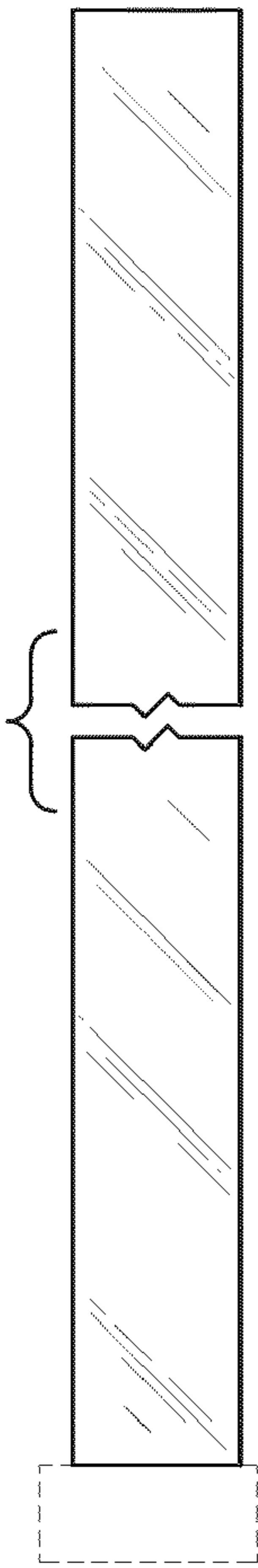

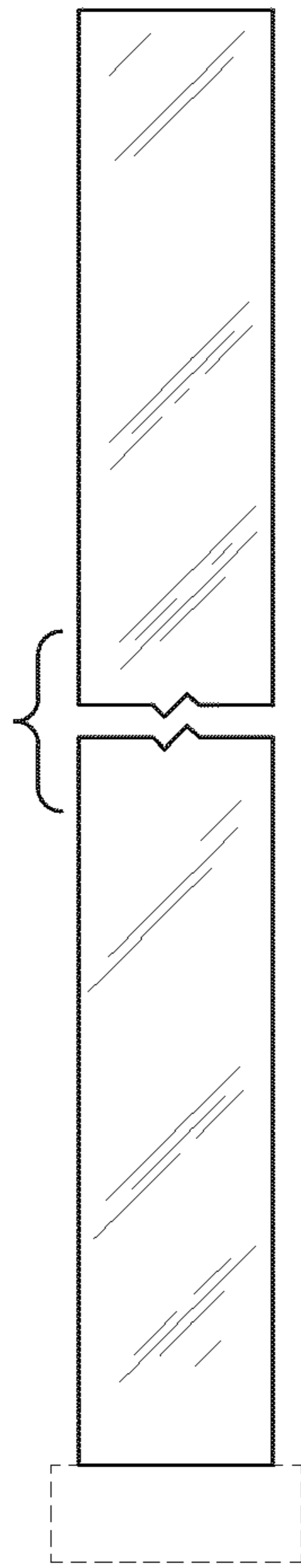

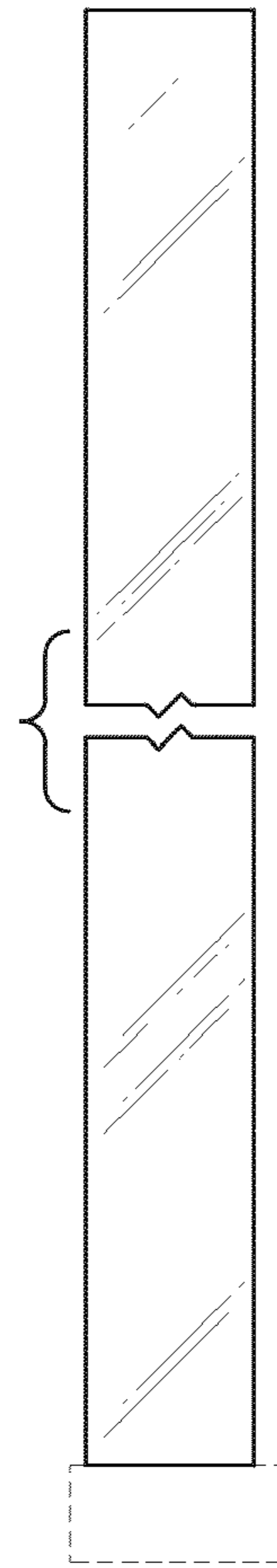

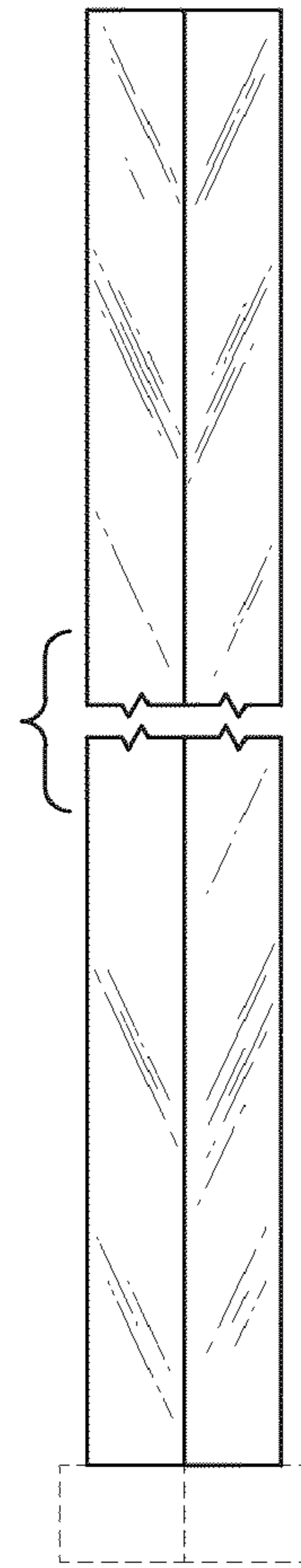
