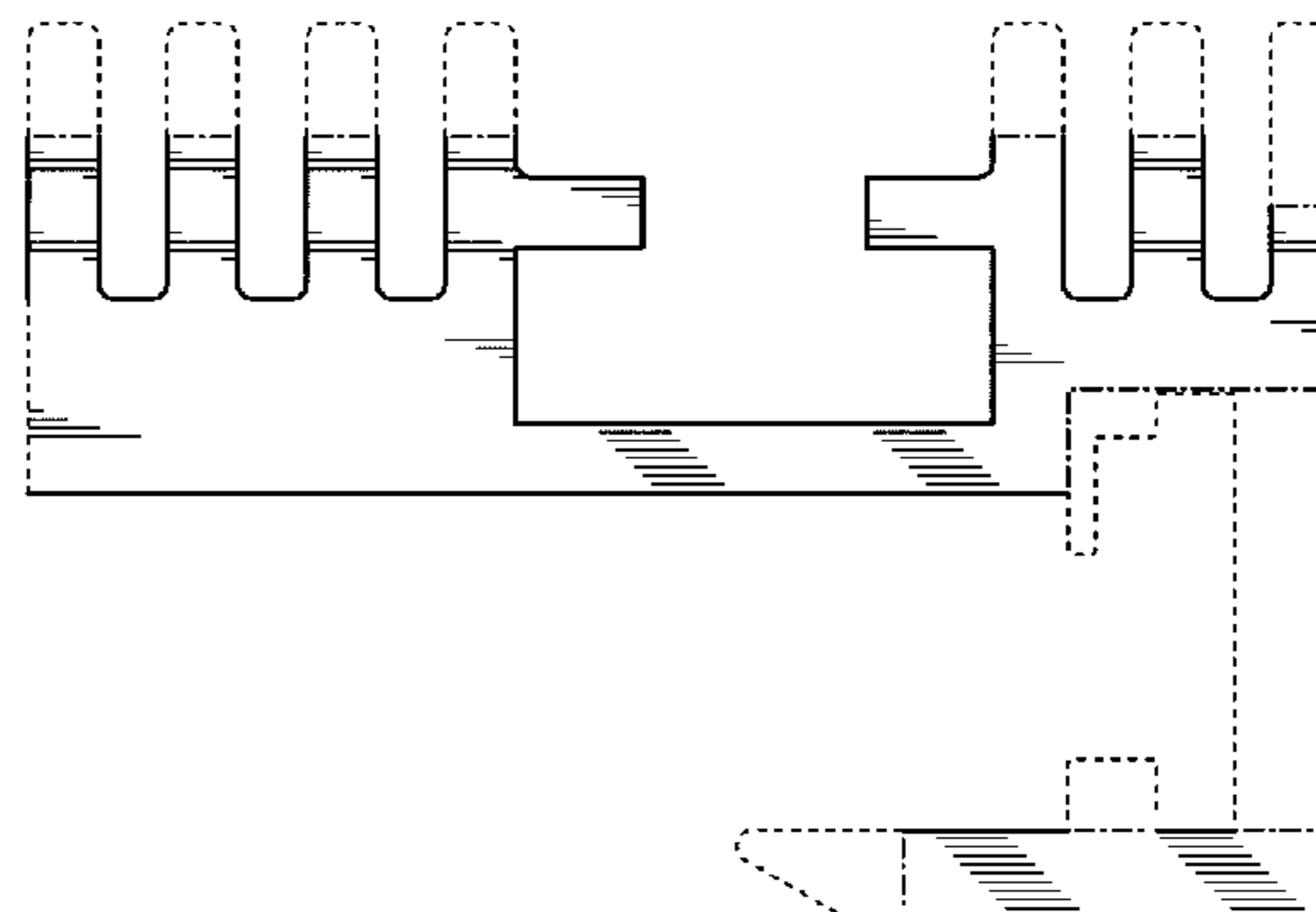
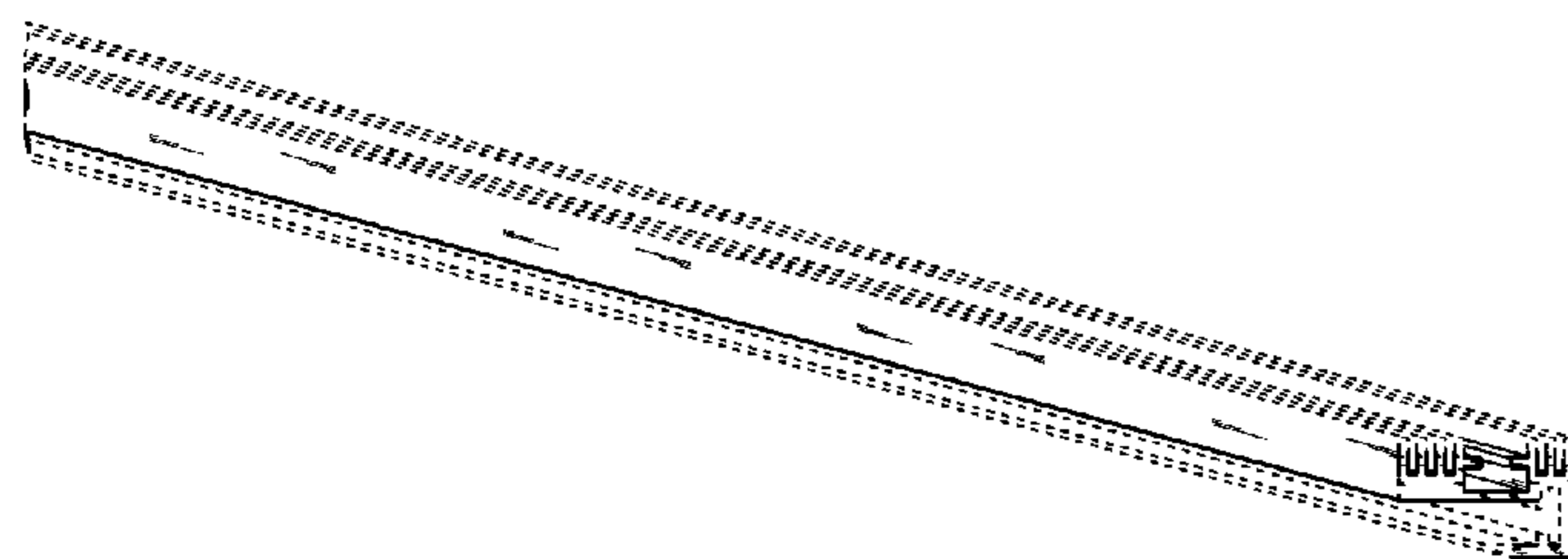
(57) **CLAIM**

The ornamental design for an extrusion for a flat panel LED  
fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a right, side perspective view of an extrusion for a flat  
panel LED fixture showing my new design; and,  
FIG. 2 is an enlarged front elevational view thereof.  
The dash-dash broken lines shown in the drawings illustrate  
unclaimed portions of the extrusion for a flat panel LED  
fixture and form no part of the claimed design. The dash-dot-  
dash broken lines in FIG. 2 define the bounds of the claimed  
design and form no part of the claimed design.

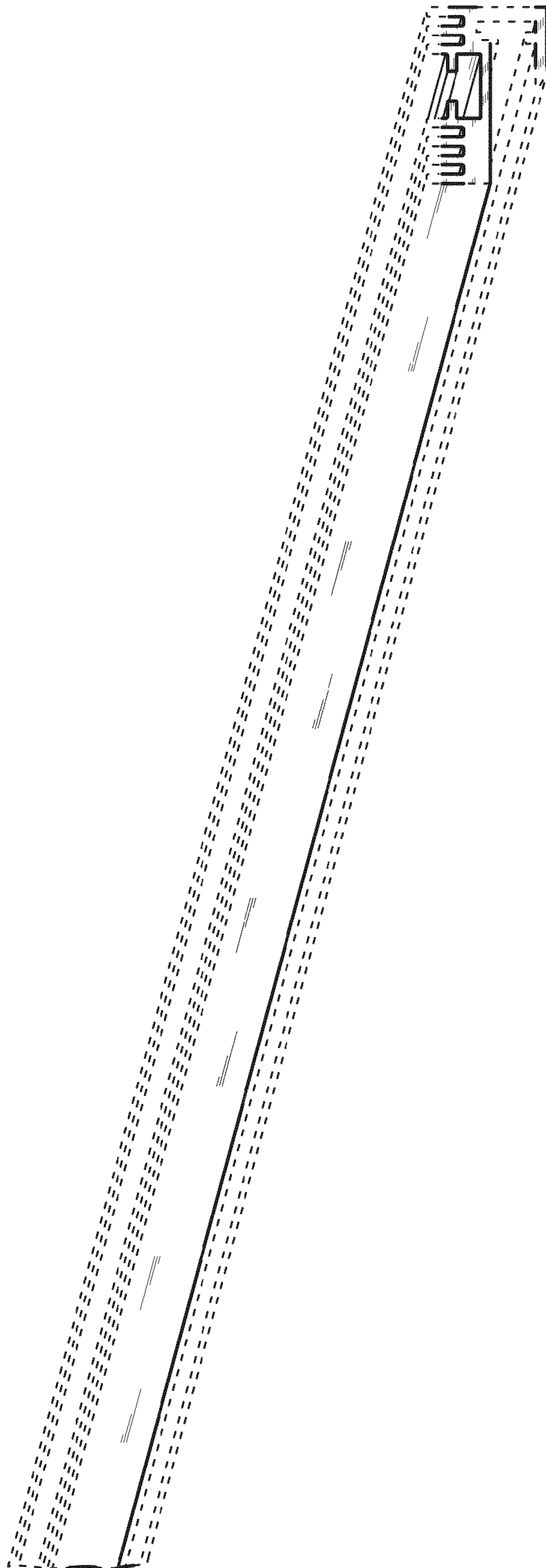

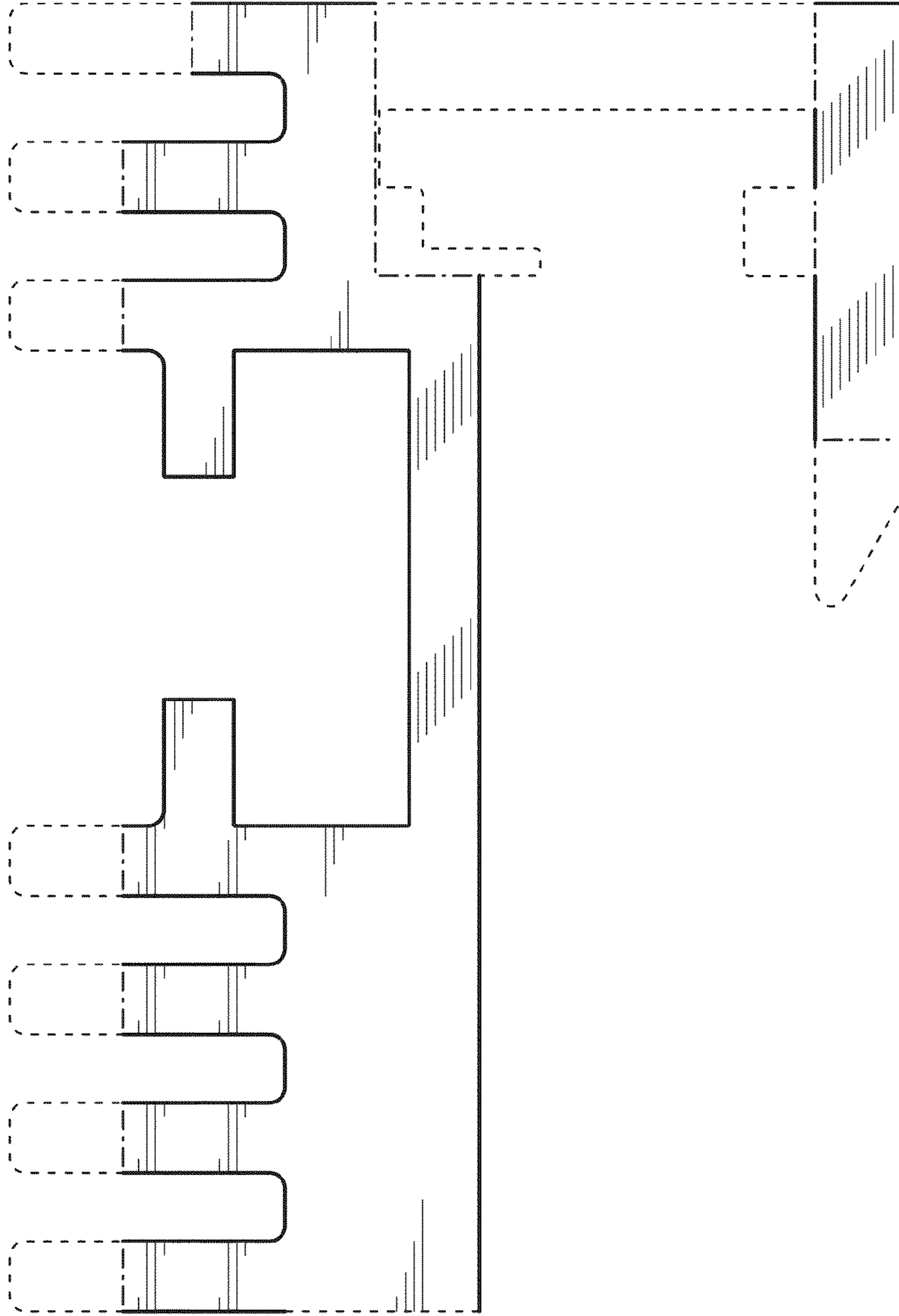
