DESCRIPTION

FIG. 1 is a front perspective view of a duster which embodies the design;

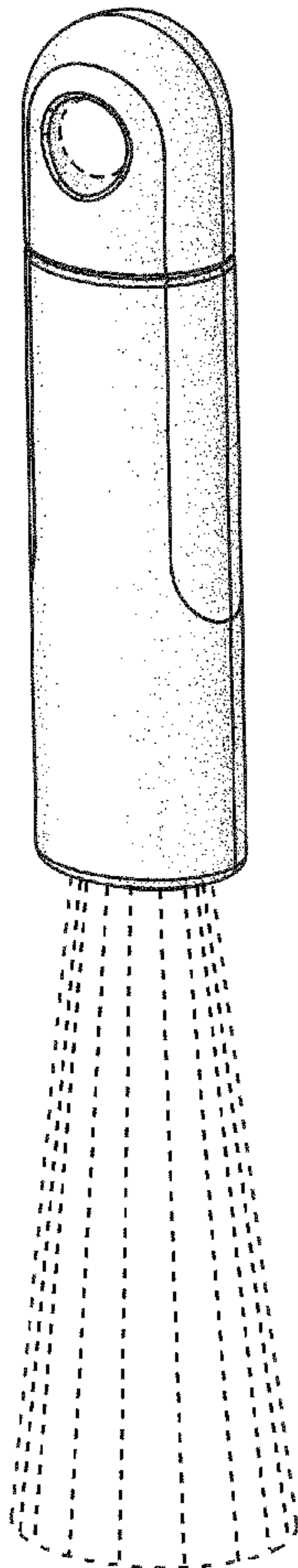
FIG. 2 is a front view thereof; the rear view thereof being a mirror image of the front view thereof;

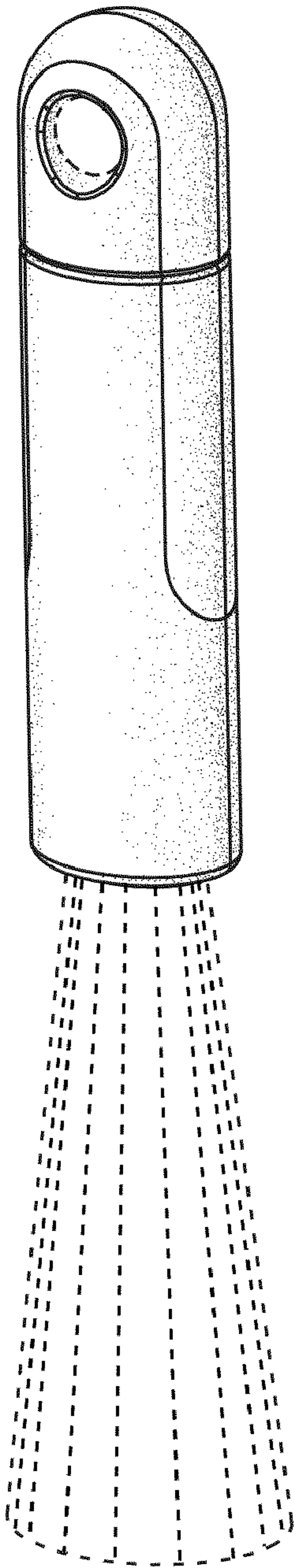

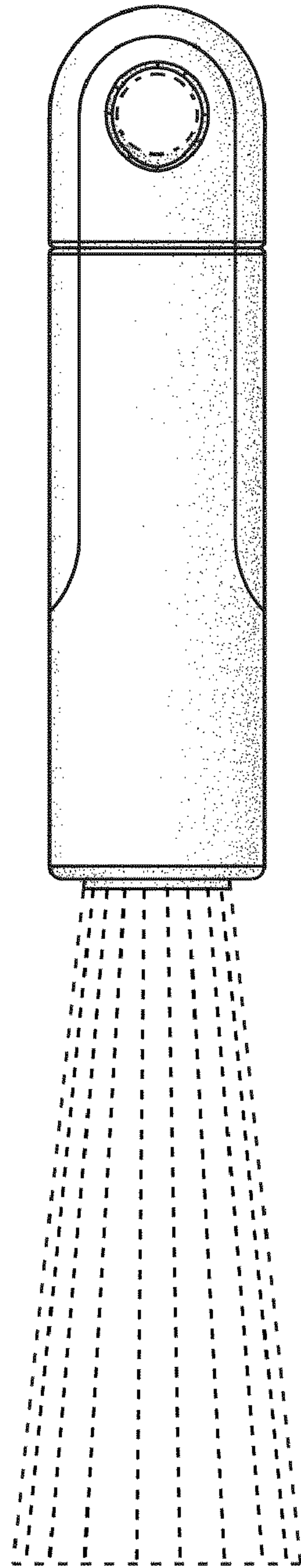

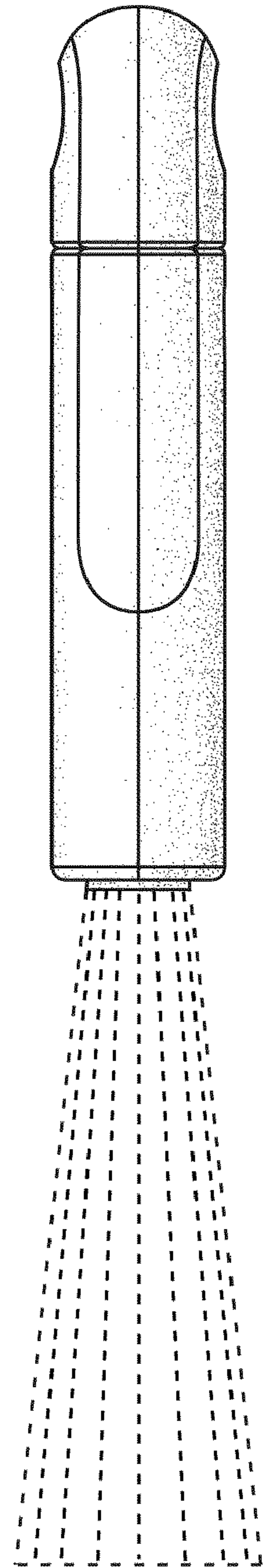
