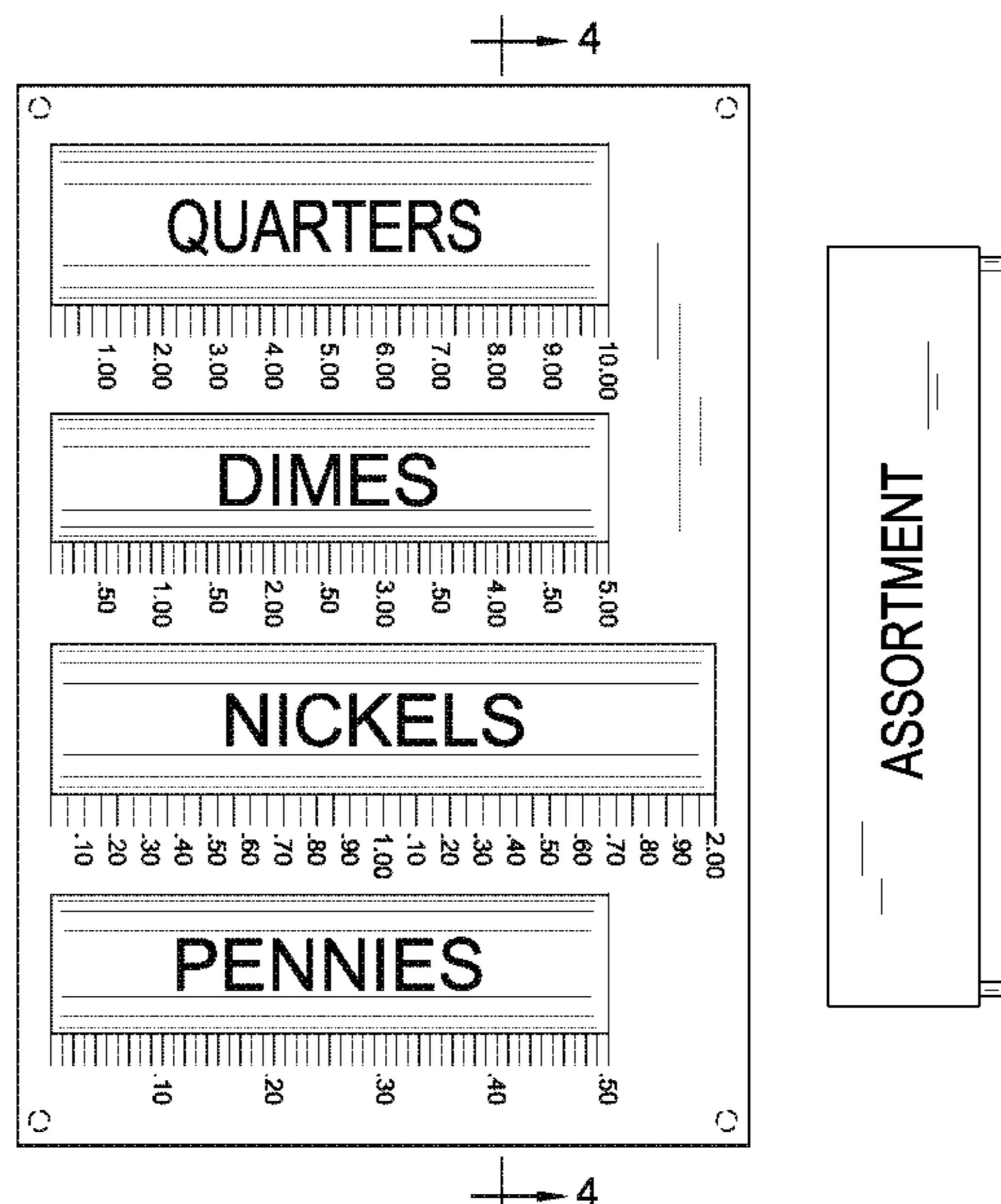
(57) **CLAIM**

The ornamental design for a coin counting and holding device, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a coin counting and holding device showing our new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a side view thereof, the opposite side view is a mirror image thereof;
FIG. 4 is a cross-sectional view taken along line 4-4 of FIG. 1
FIG. 5 is a front view thereof; and,
FIG. 6 is a back view thereof.
In the drawings, the broken lines in FIG. 1 depict portions of the design that form no part of the claim.

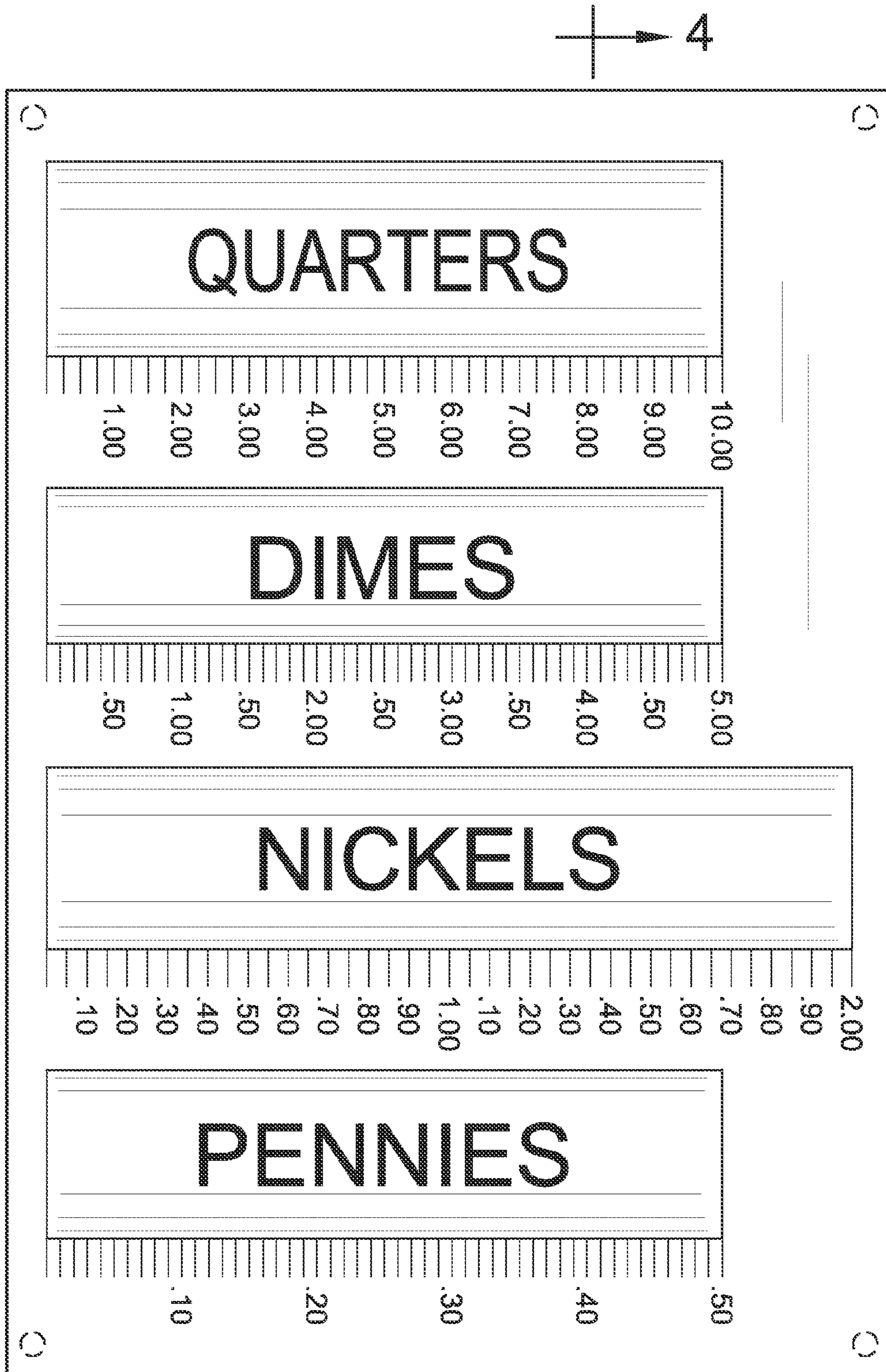

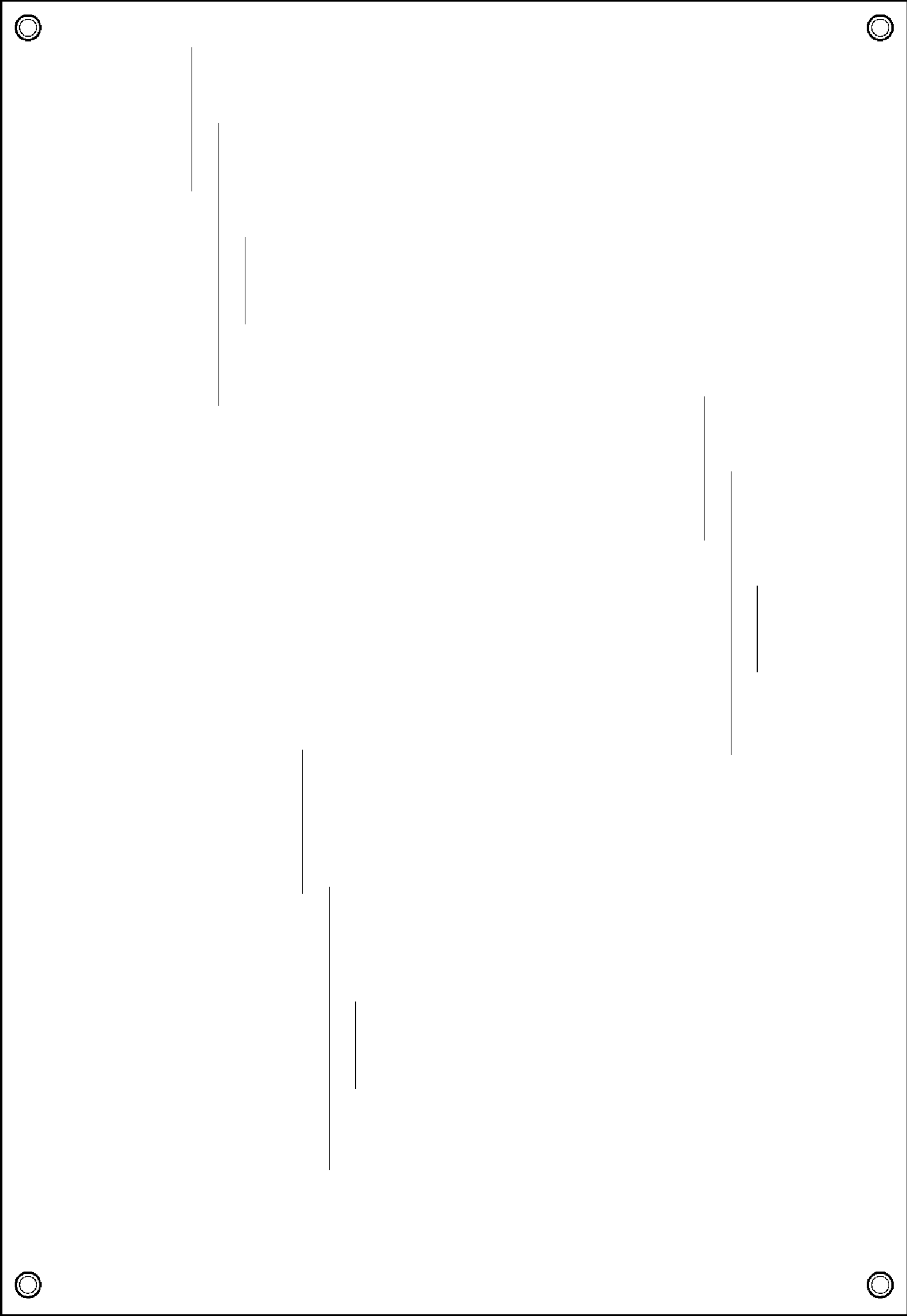

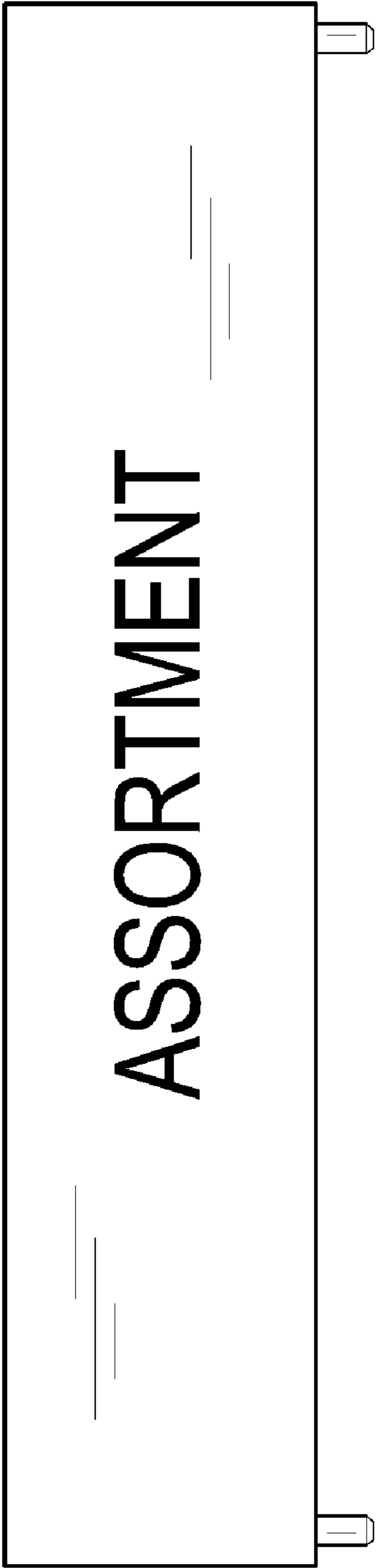

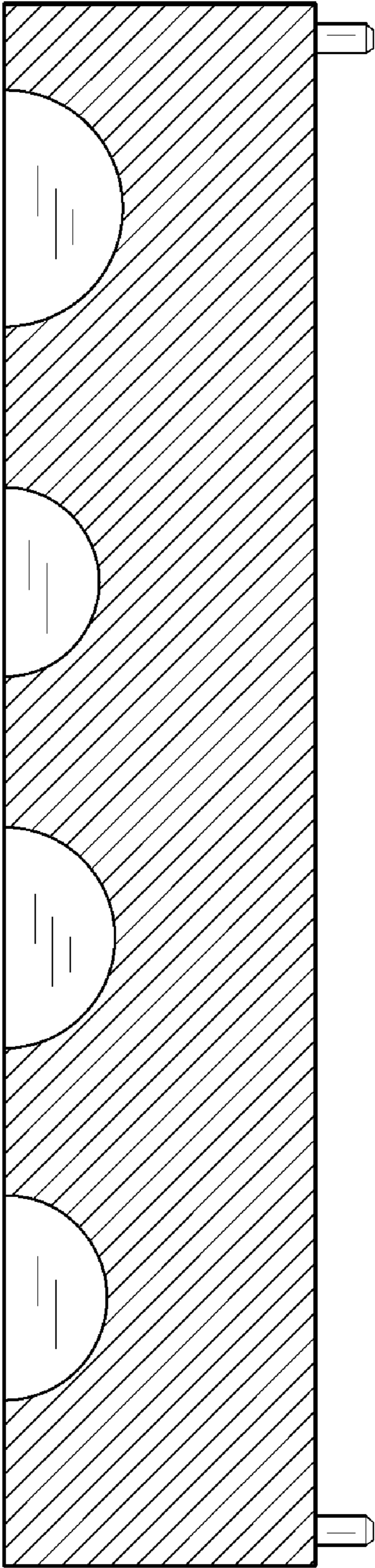

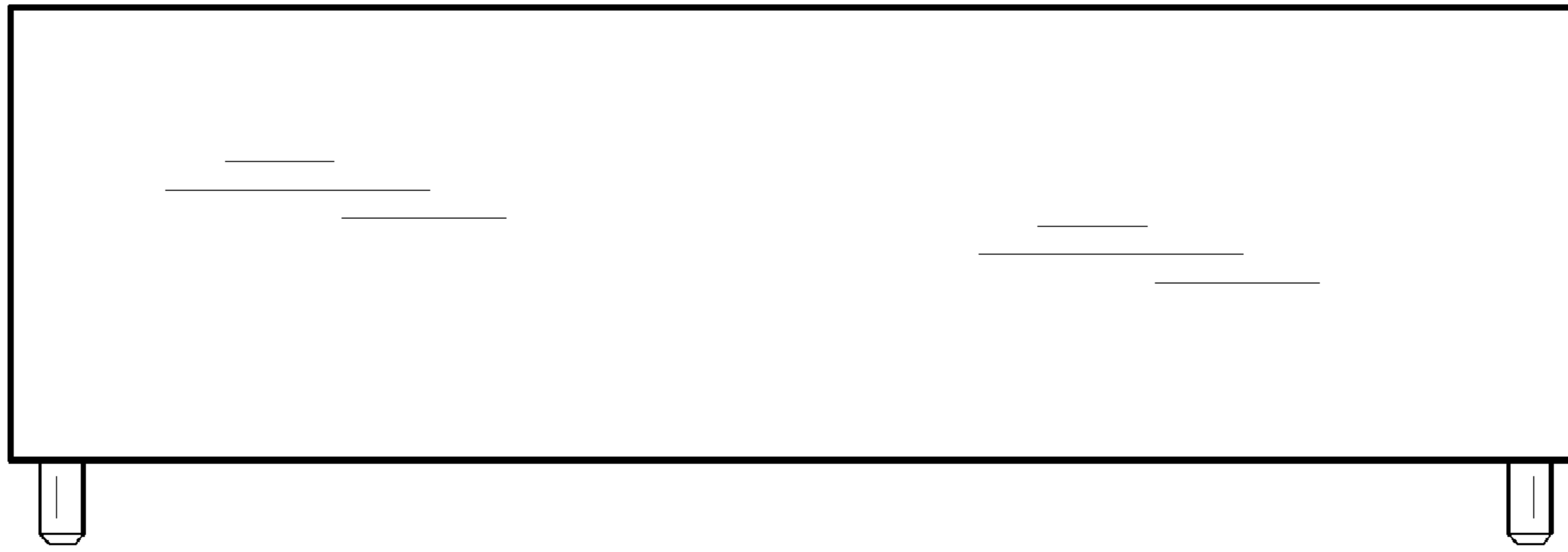
