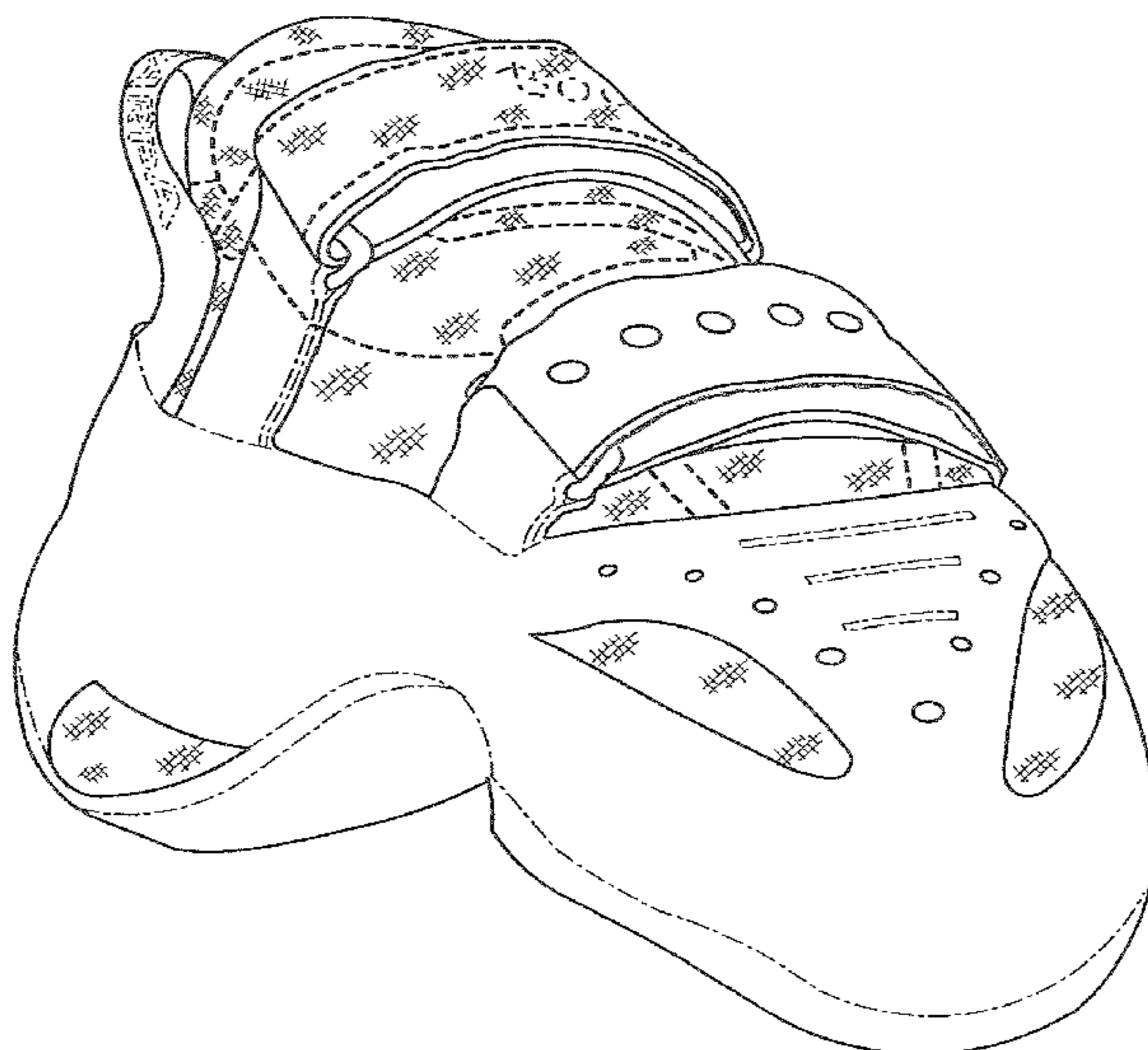
(57) **CLAIM**

I claim the ornamental design for a sports footwear, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tenth embodiment of the sports footwear showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a right elevational view thereof;
FIG. 4 is a left elevational view thereof;
FIG. 5 is a front elevational view thereof; and,
FIG. 6 is a rear elevational view thereof.
The portions of the drawings shown in broken lines form no part of the claimed design.

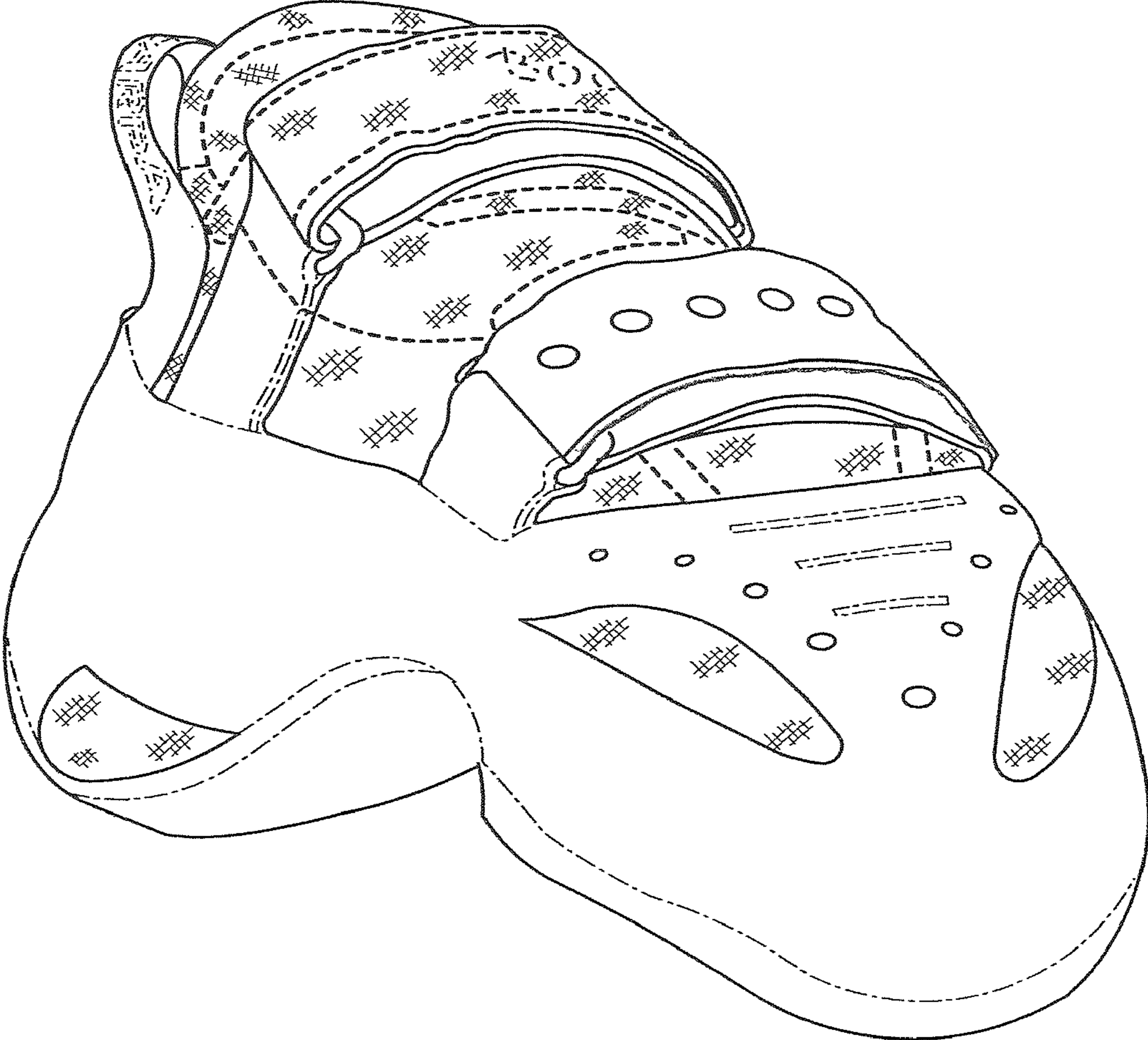

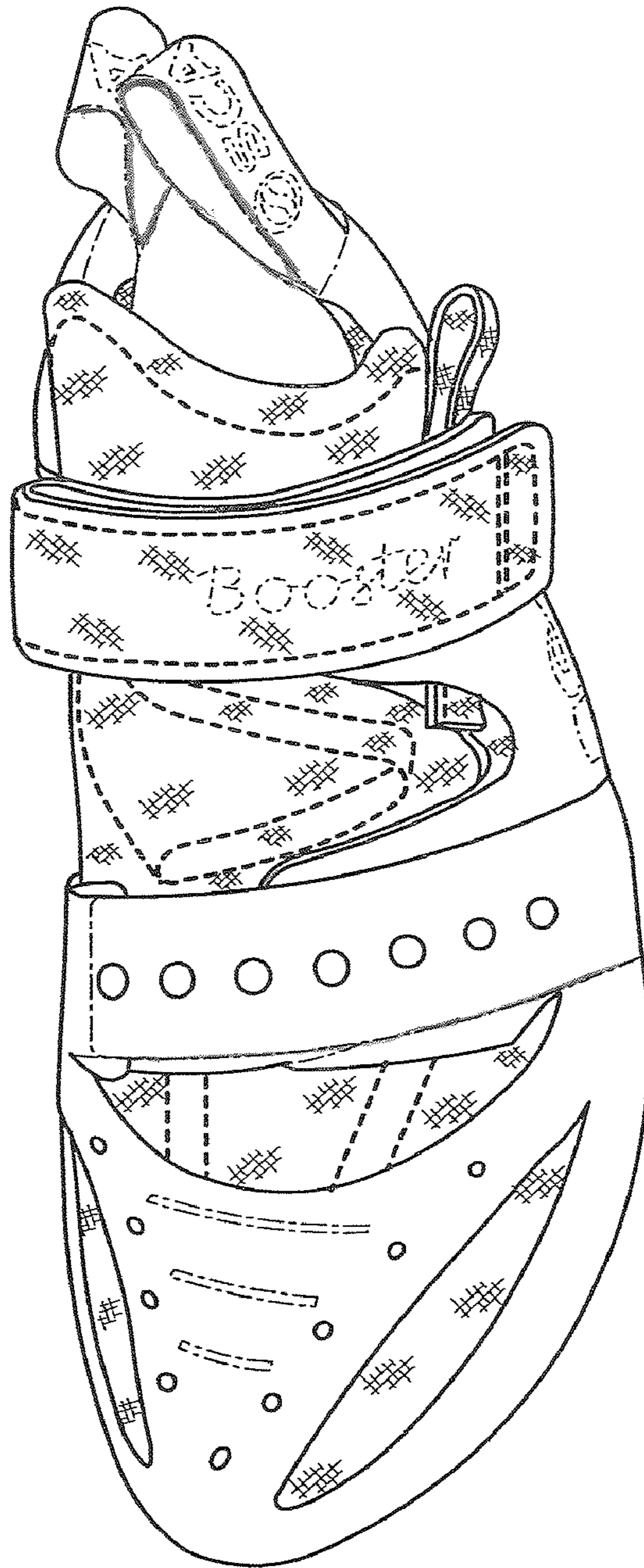

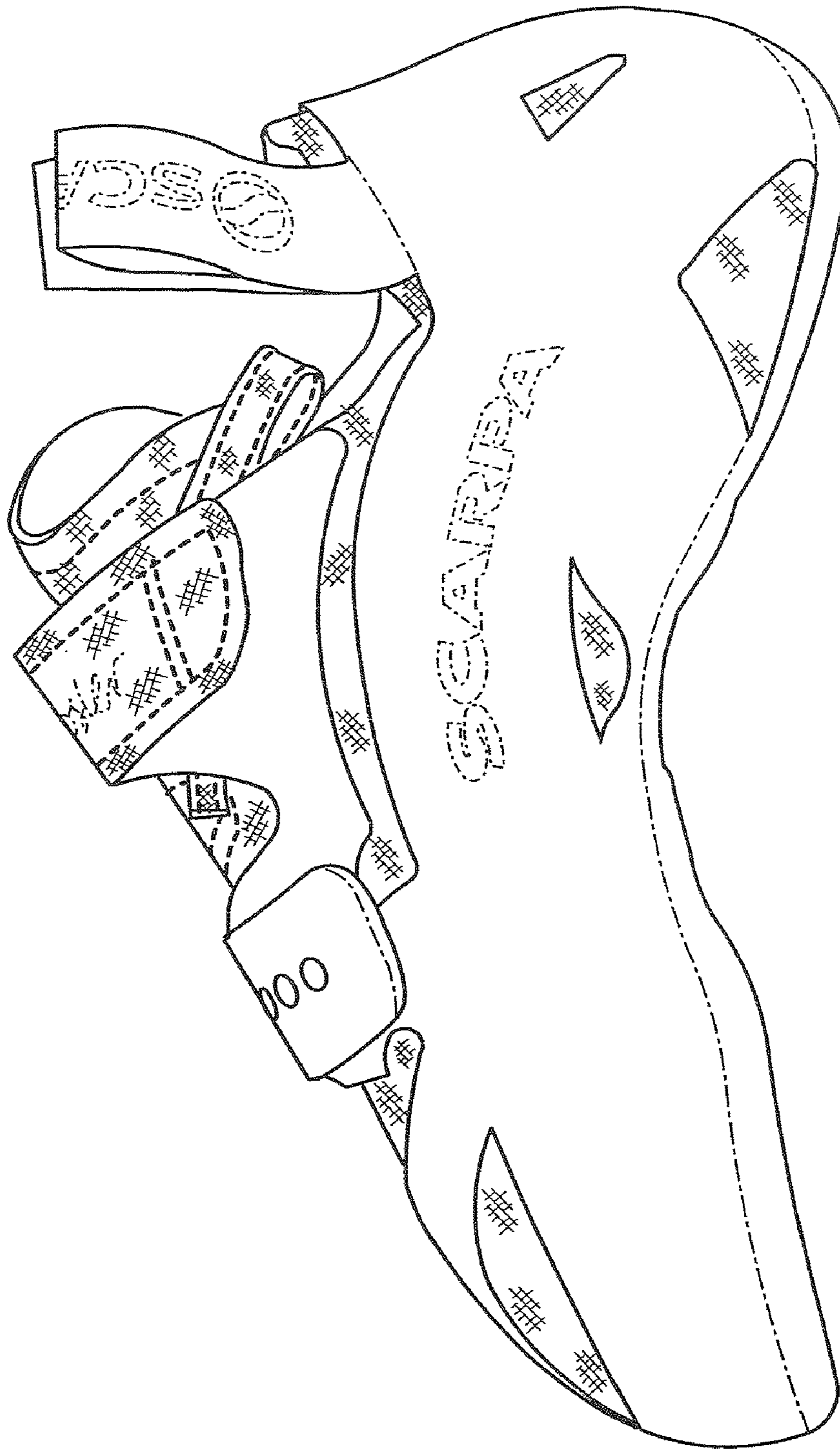

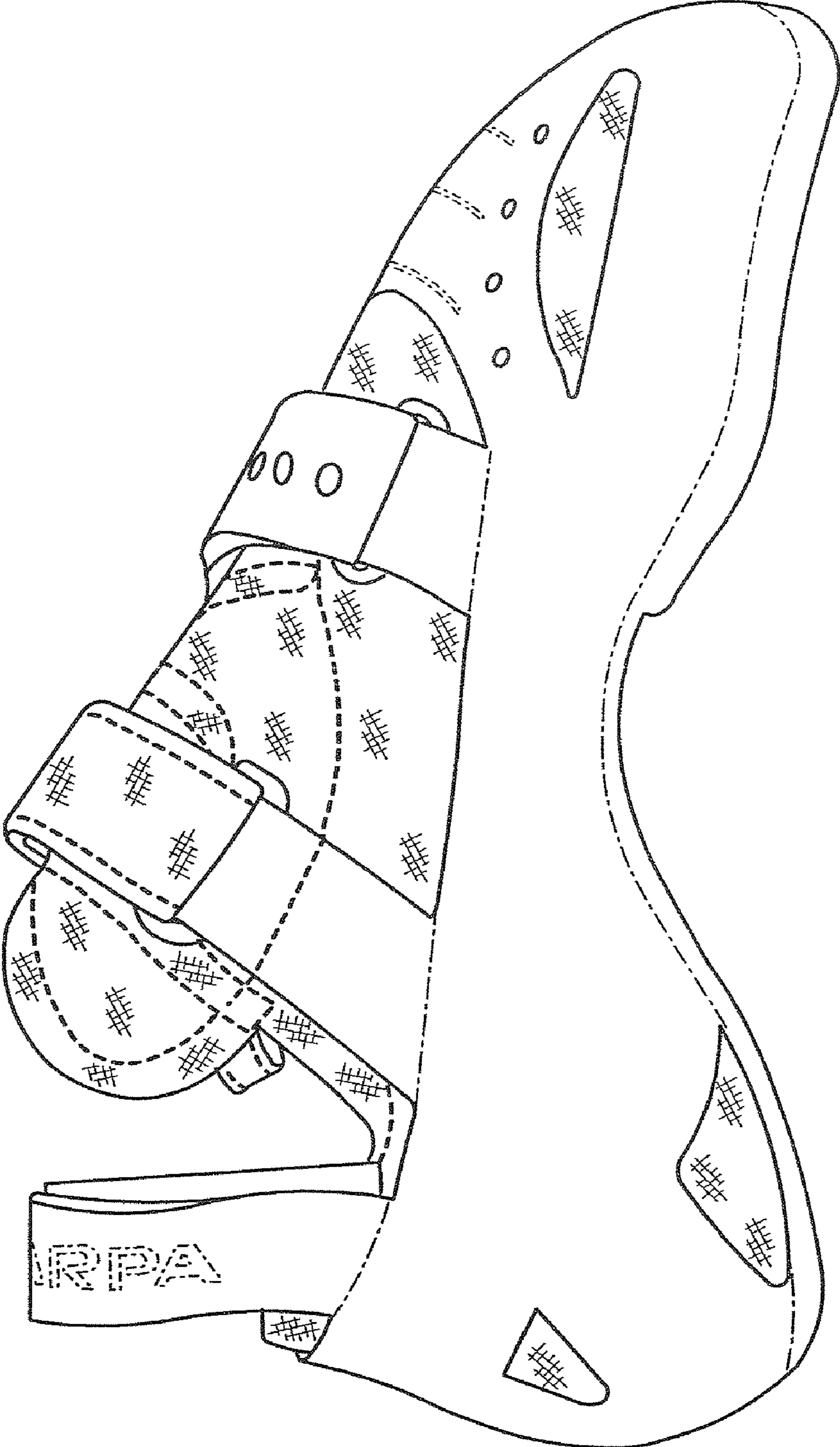

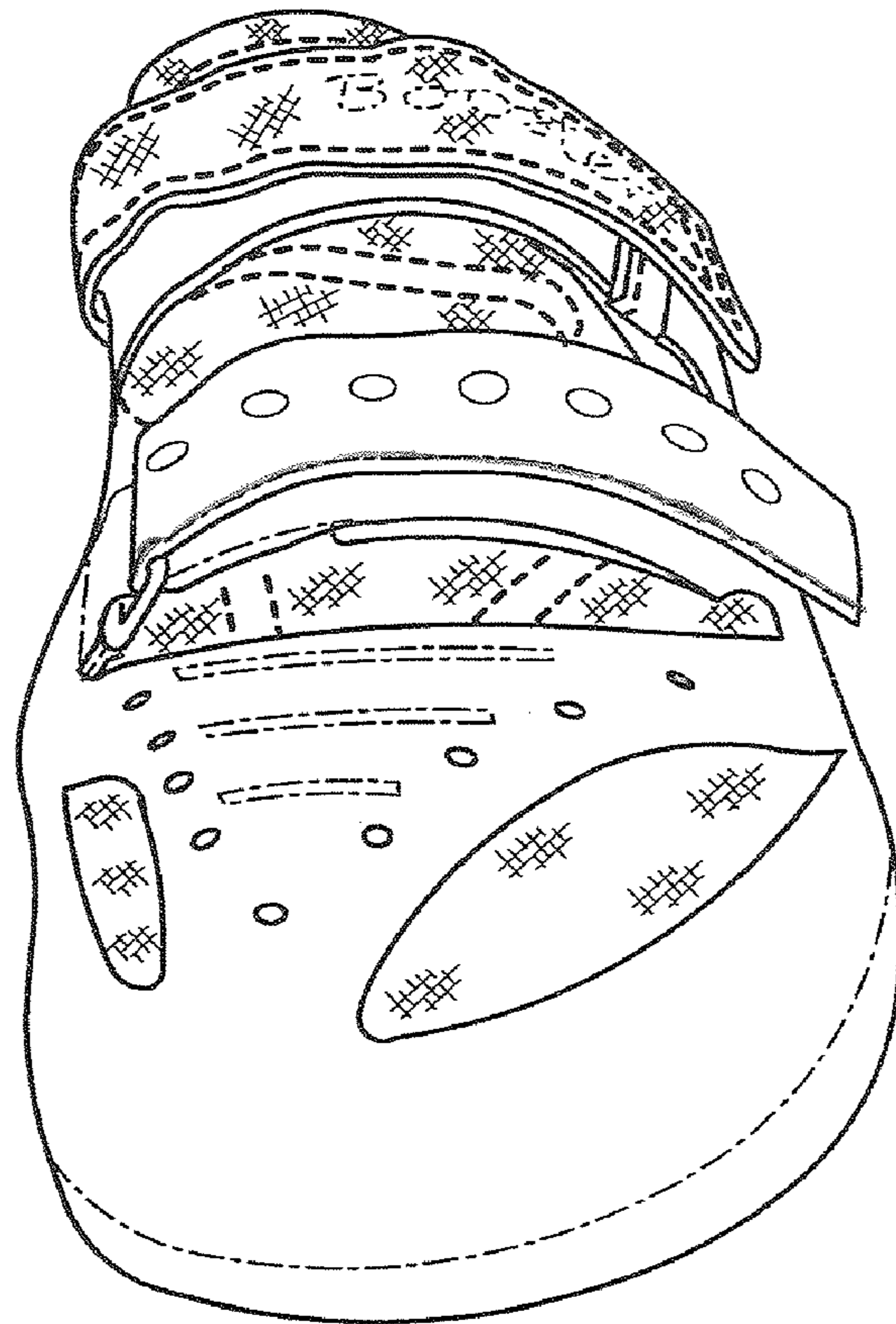

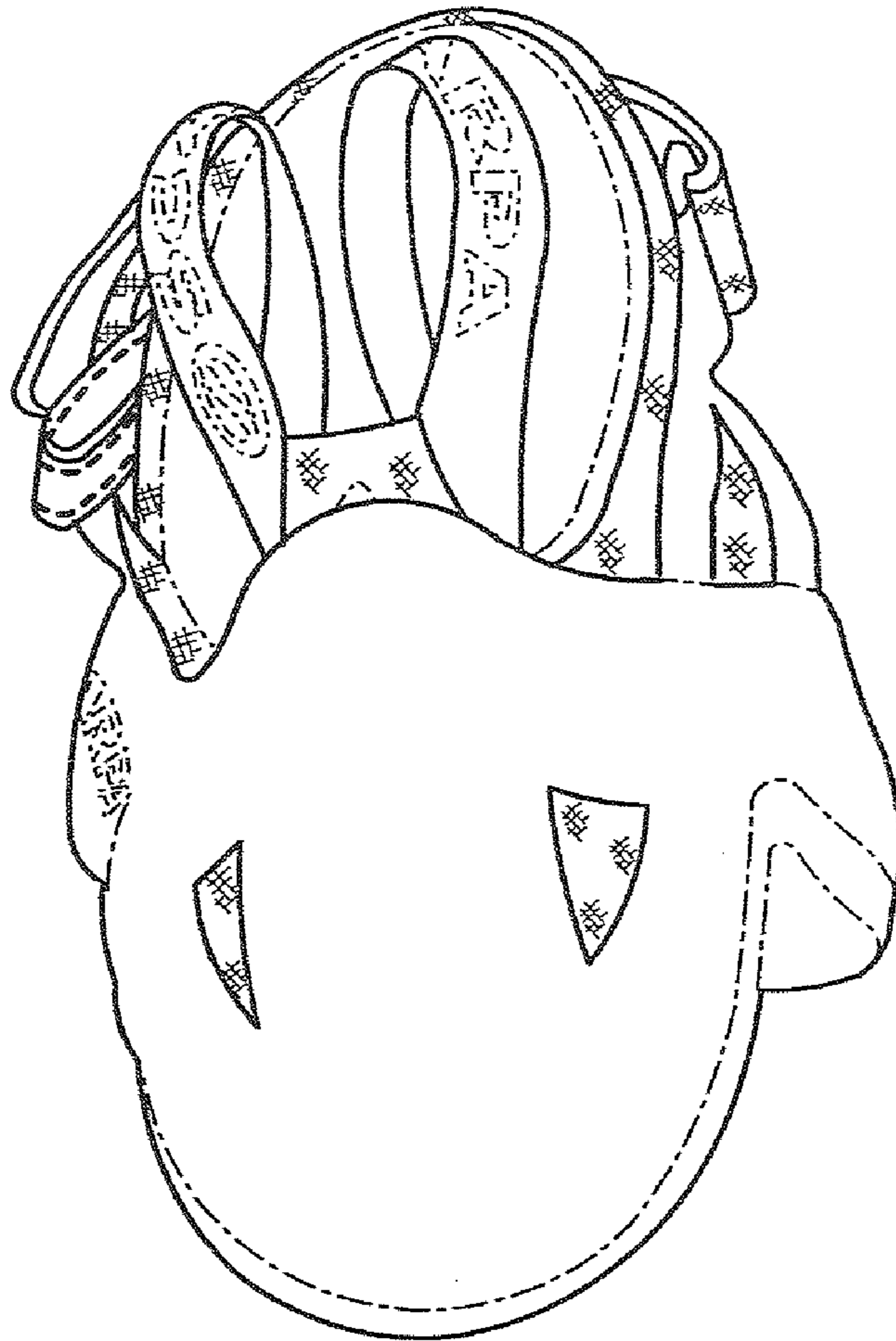
