(57) **CLAIM**

The ornamental design for a monster bag, as shown and described.

**DESCRIPTION**

FIG. 1 is perspective view of a monster bag showing our new design;

FIG. 2 is a front elevation view of the bag of FIG. 1;

FIG. 3 is a rear elevation view of the bag of FIG. 1;

FIG. 4 is a left elevation view of the bag of FIG. 1;

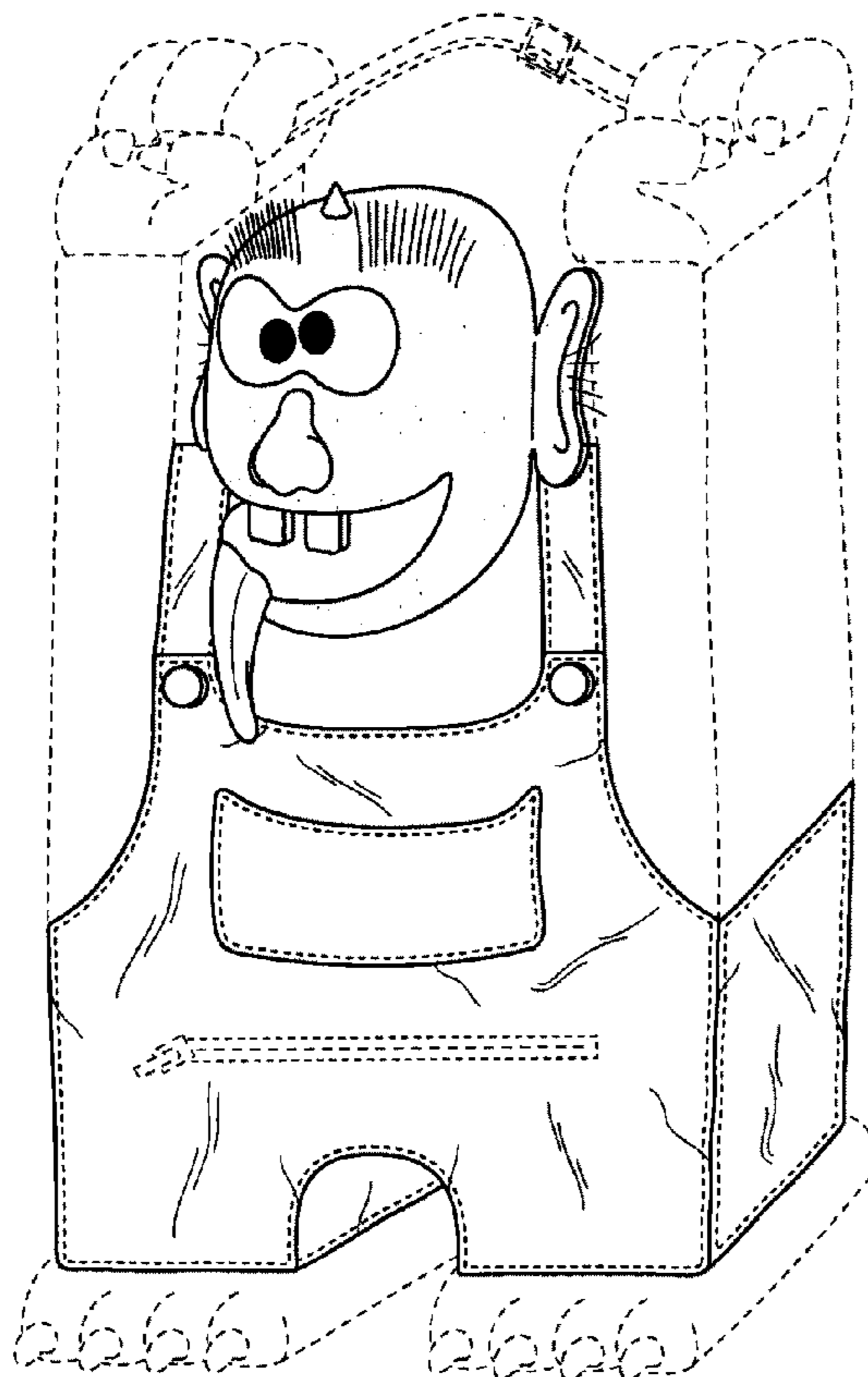
FIG. 5 is a right elevation view of the bag of FIG. 1;

FIG. 6 is a top elevation view of the bag of FIG. 1; and,

FIG. 7 is a bottom elevation view of the bag of FIG. 1.

The broken lines shown in the drawings are for the purpose of illustrating unclaimed portions of the monster bag and form no part of the claimed design. The short, heavy dashed lines along the inside edges of the overalls and on the inside of the front pocket depict stitching.

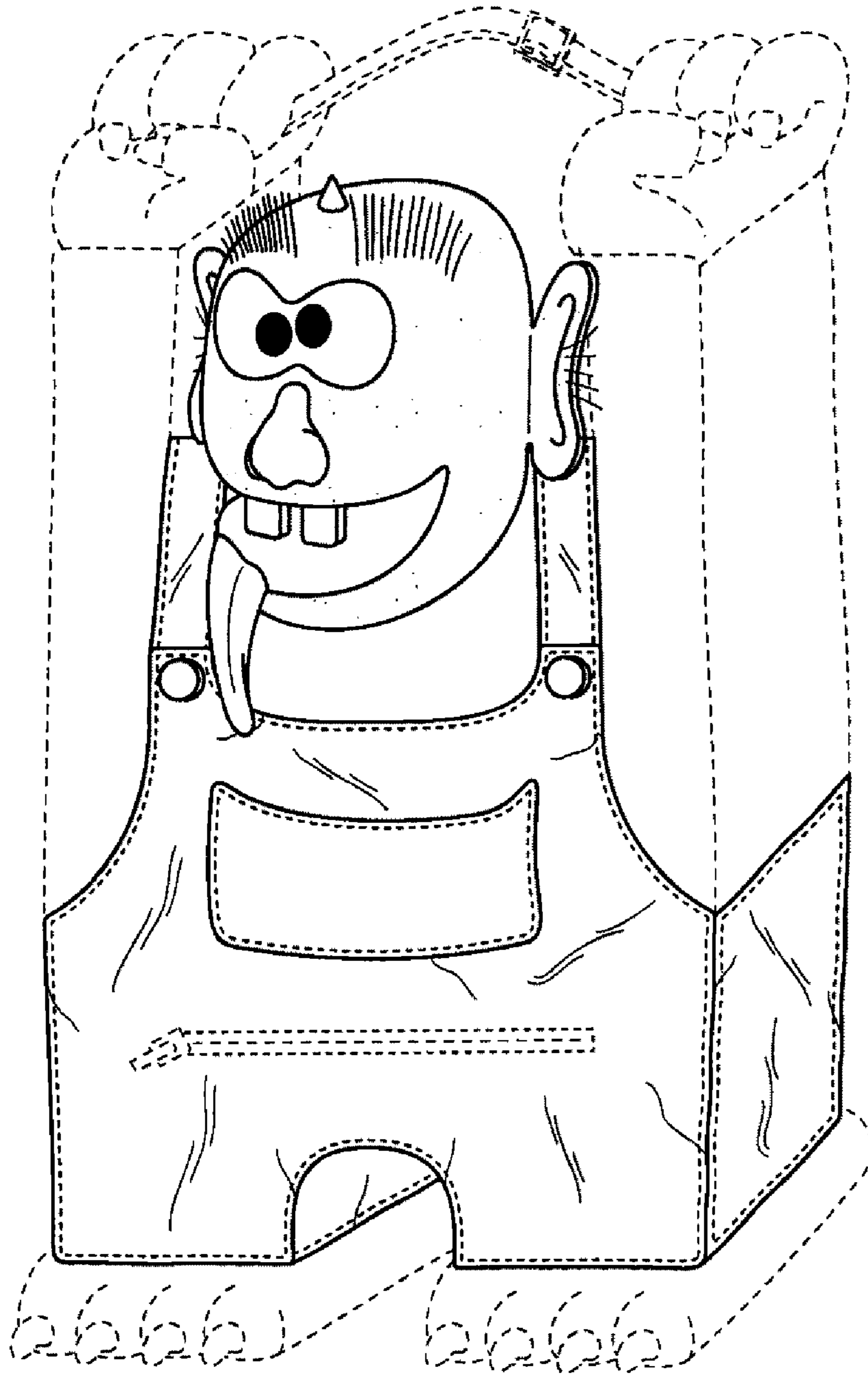

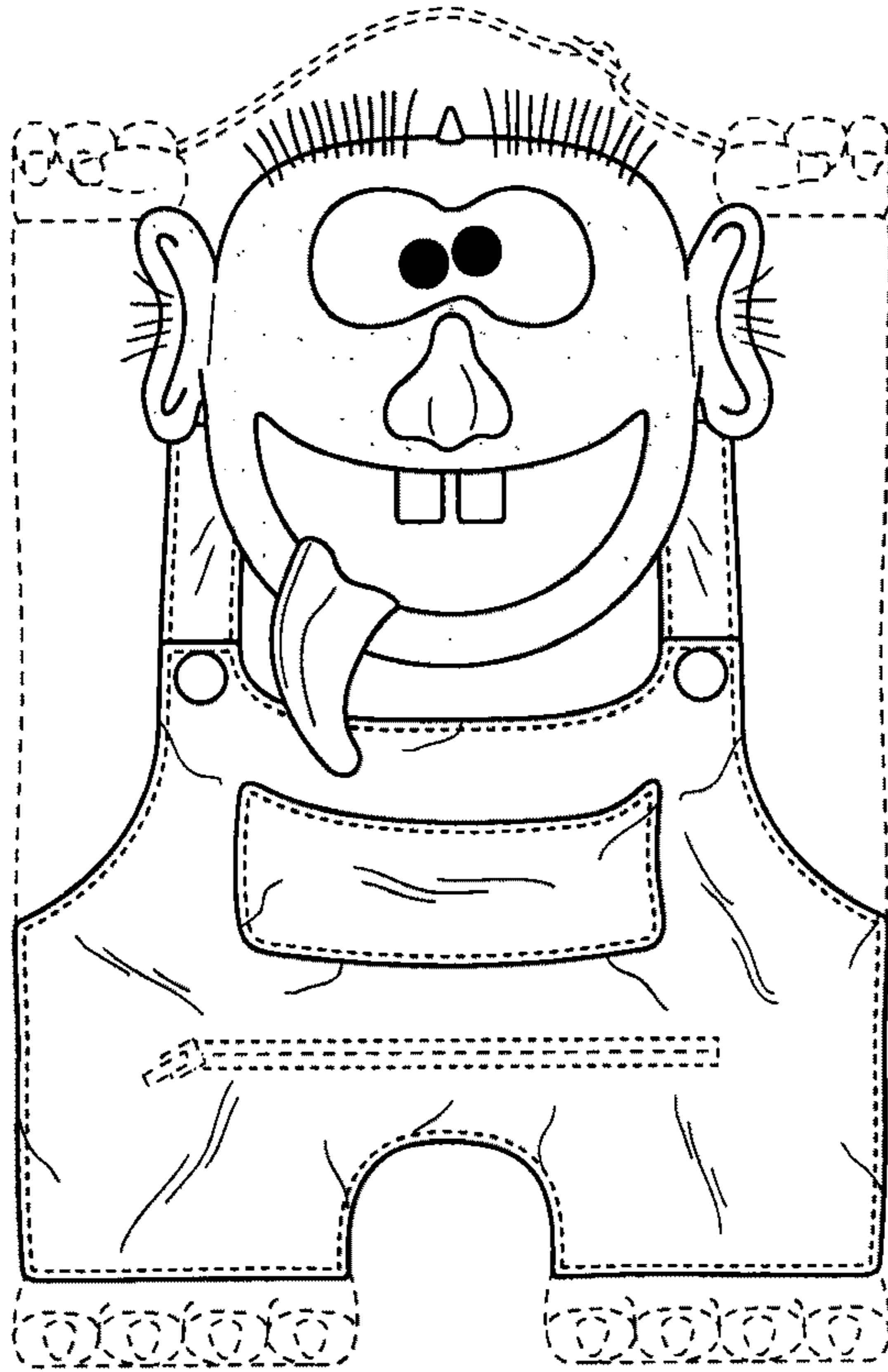

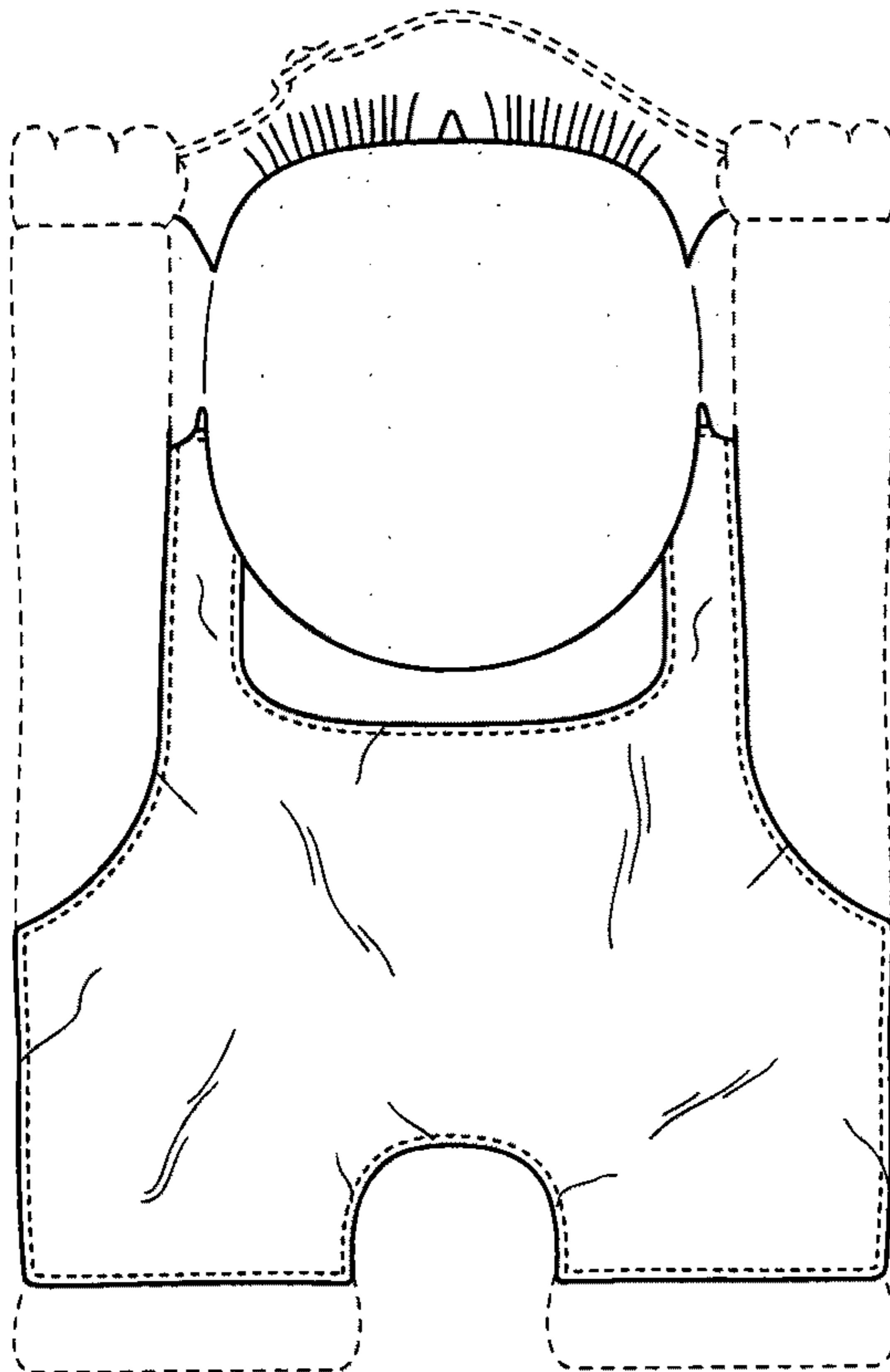

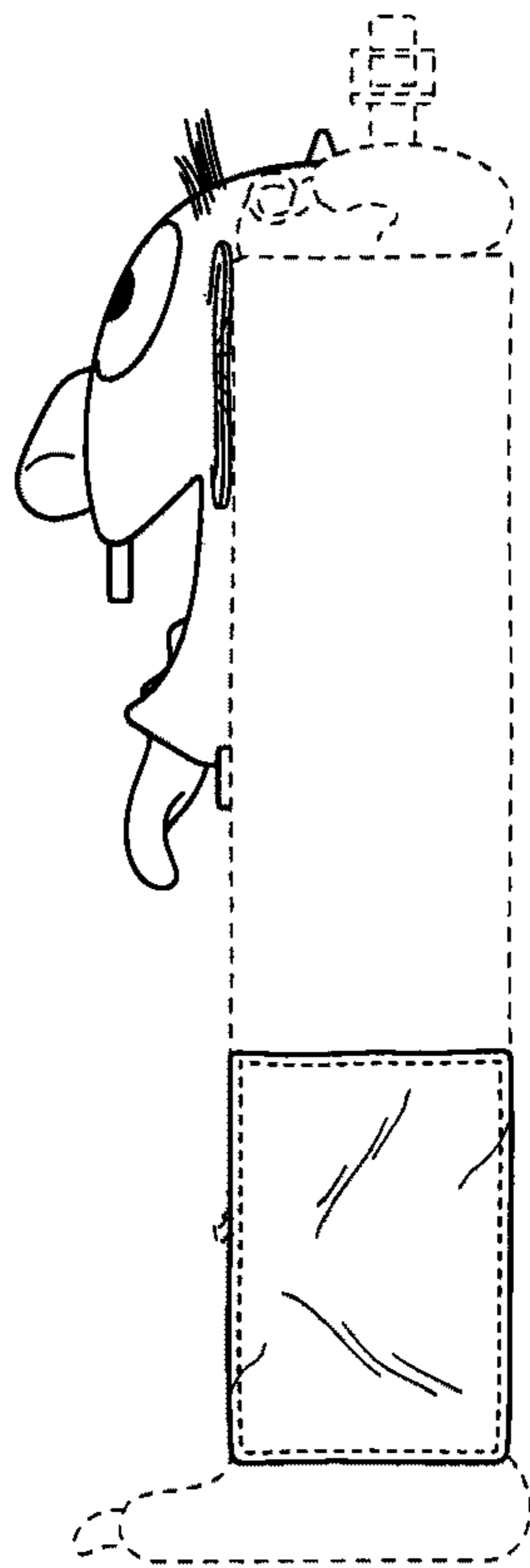

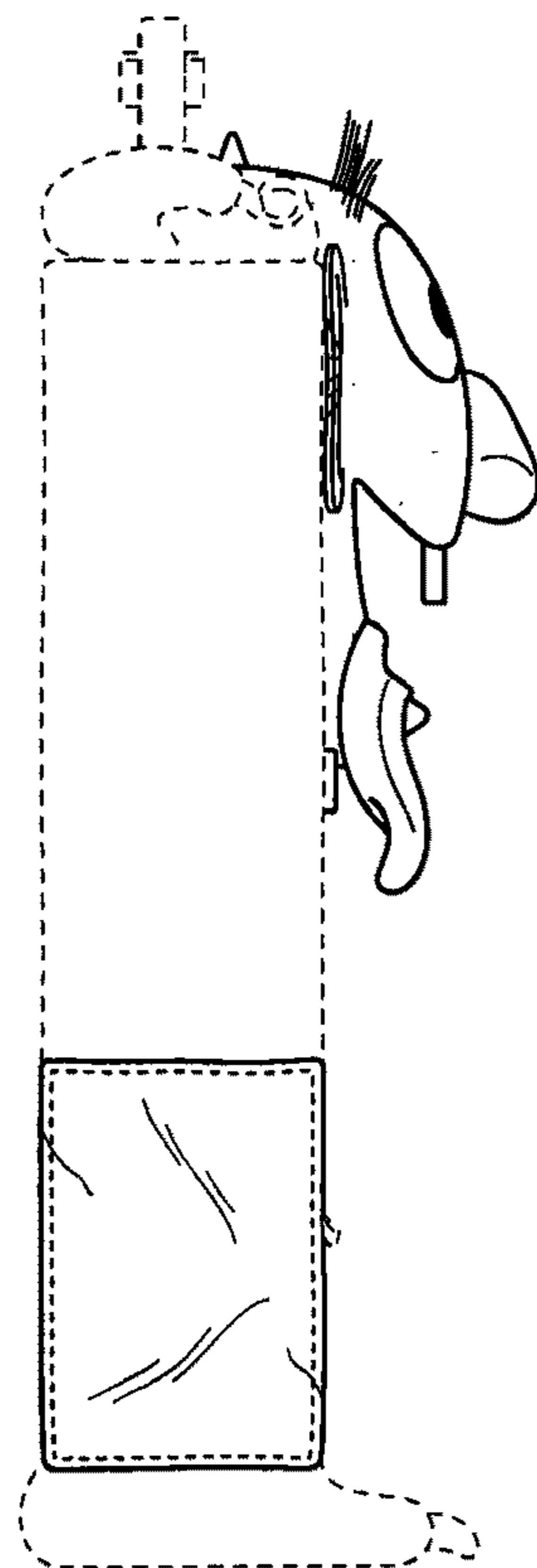
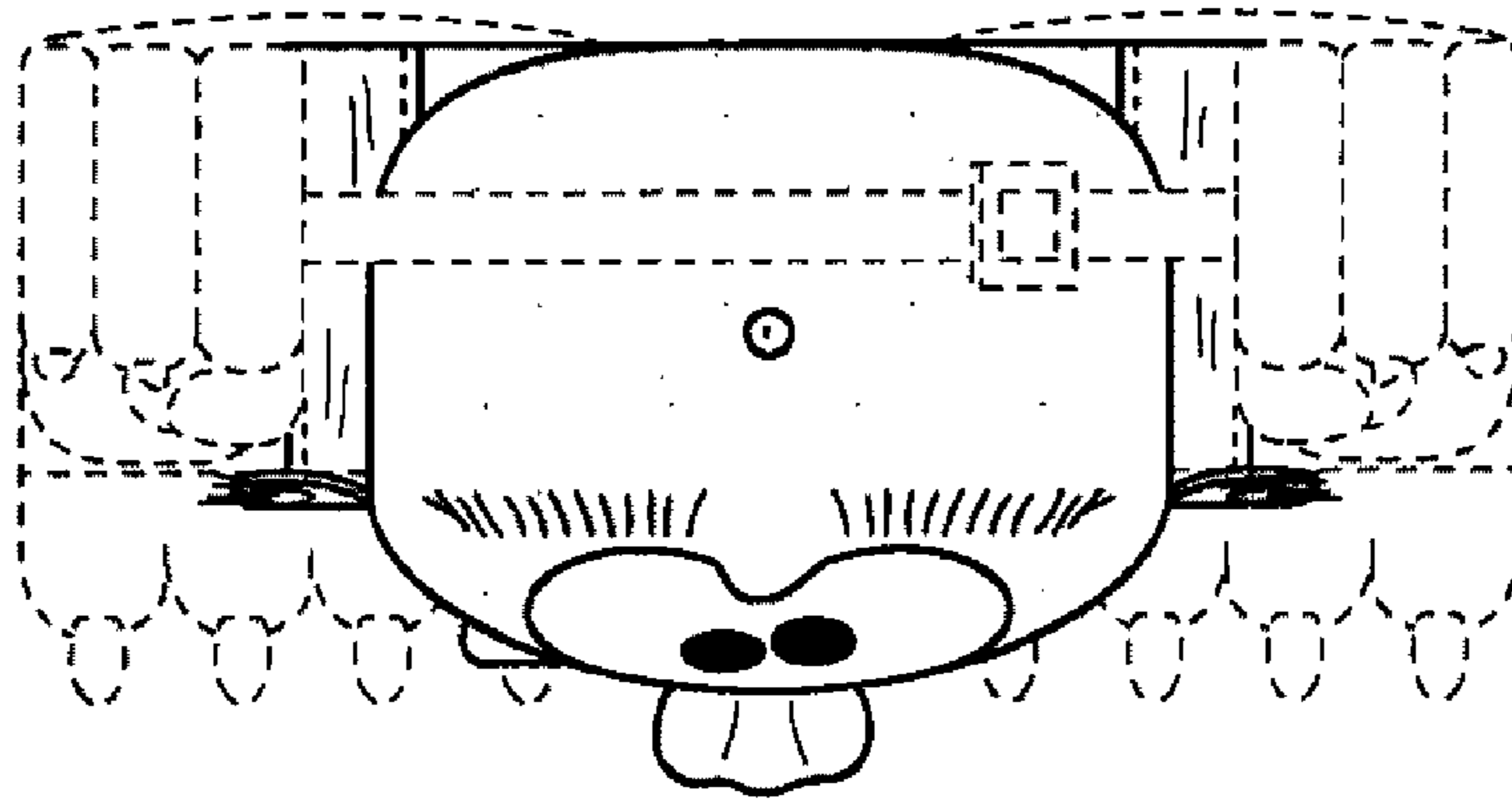
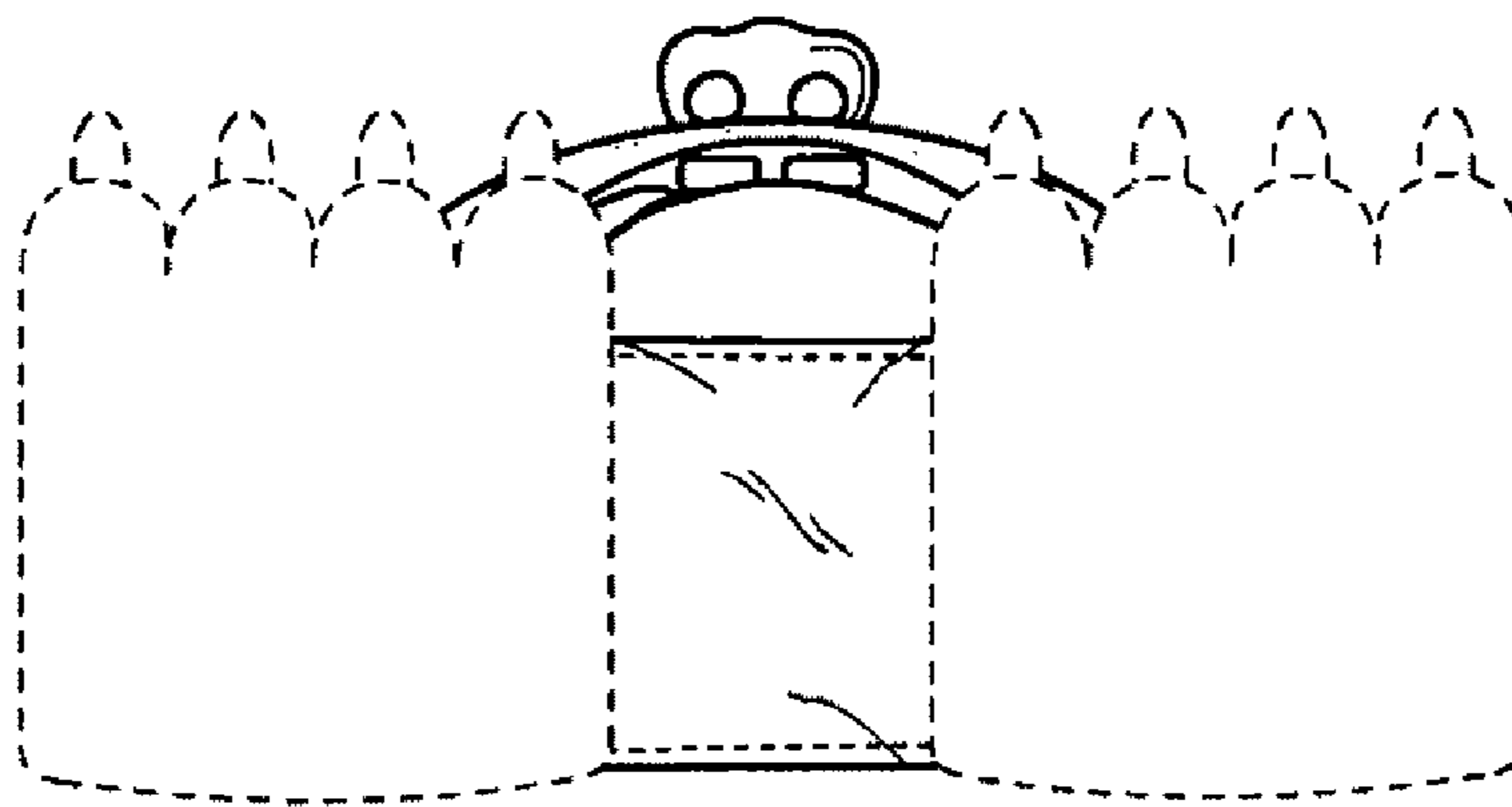
