(57) **CLAIM**

We claim an ornamental design for a stone holder, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of a stone holder, showing our
new design;

FIG. 6 is a bottom view thereof;

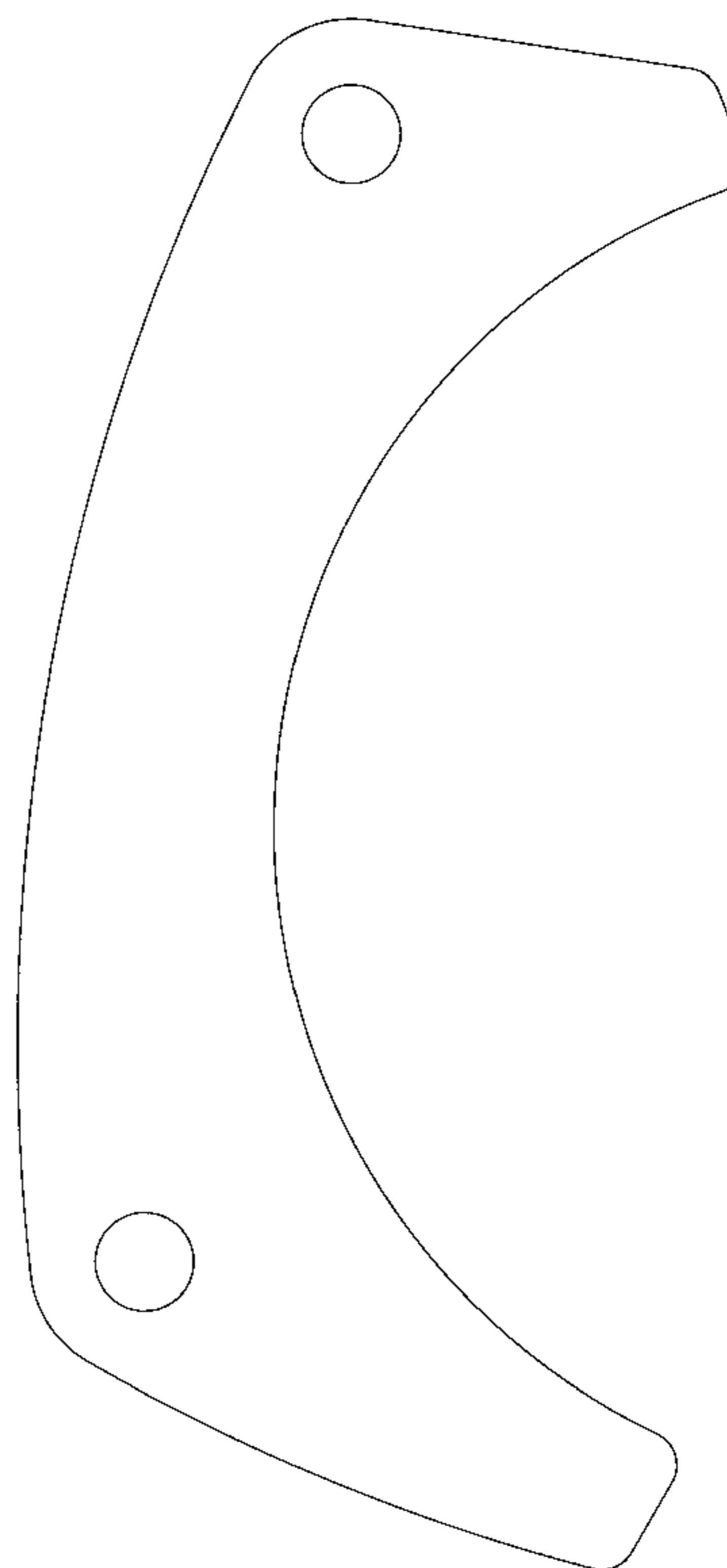
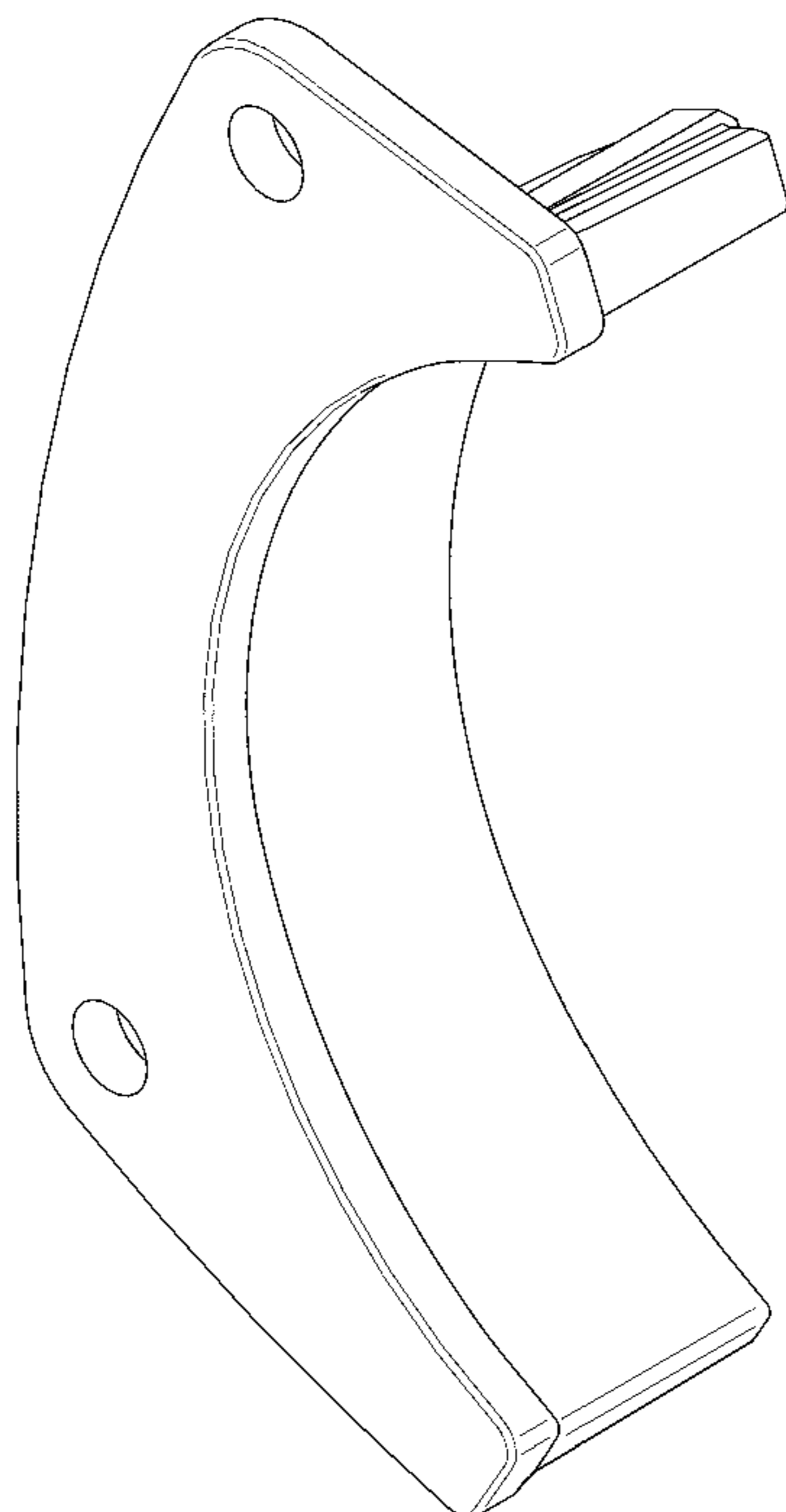
FIG. 7 is a top view thereof;

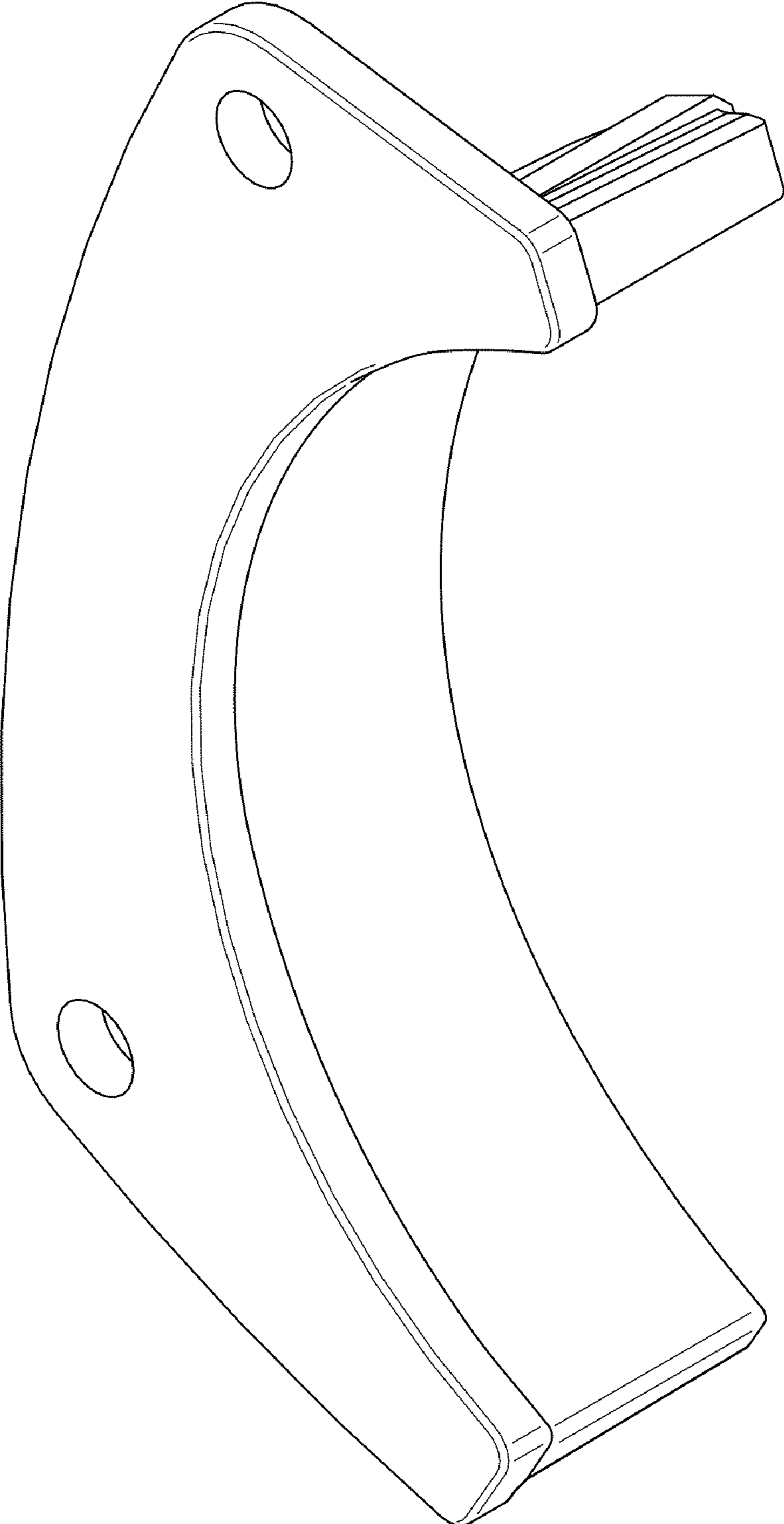

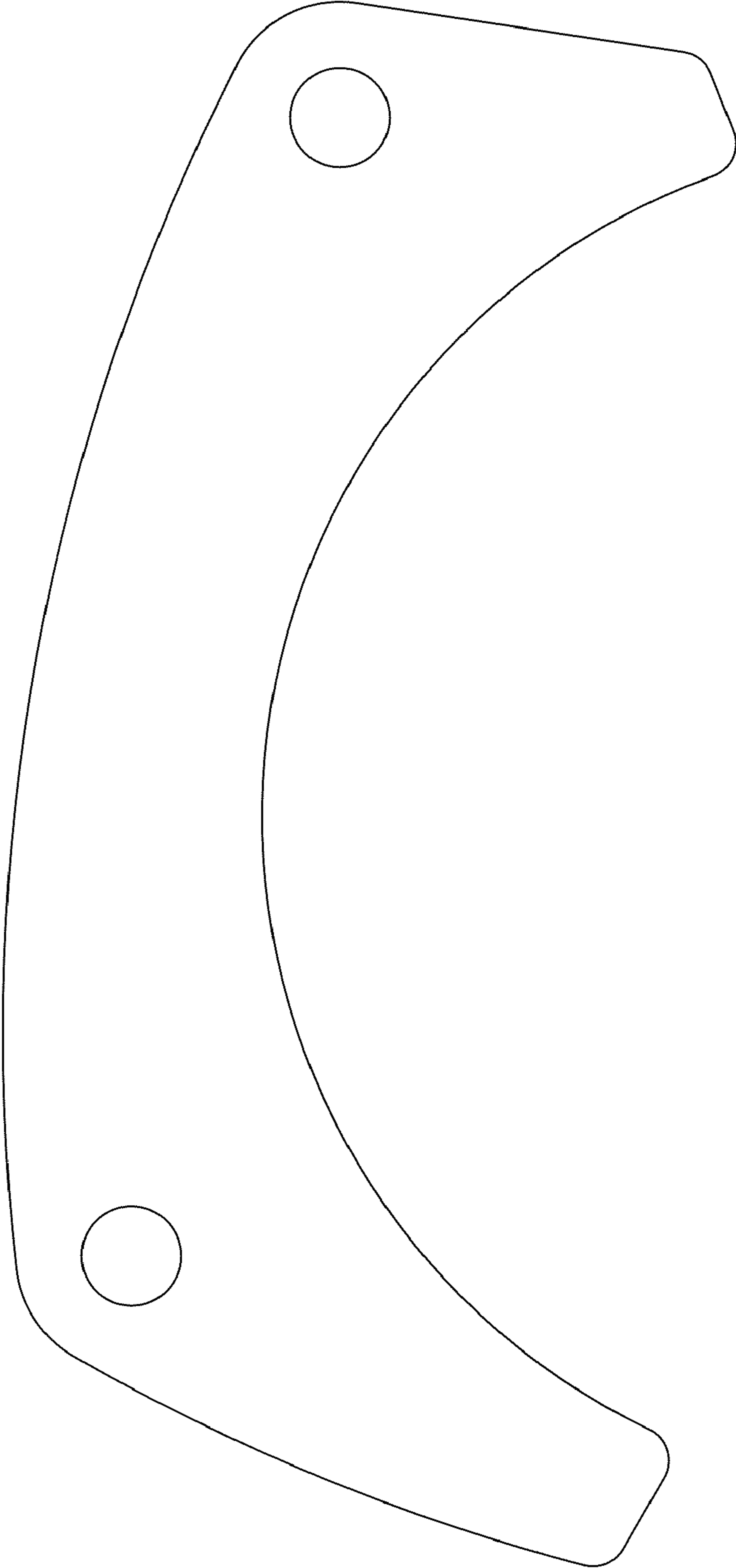

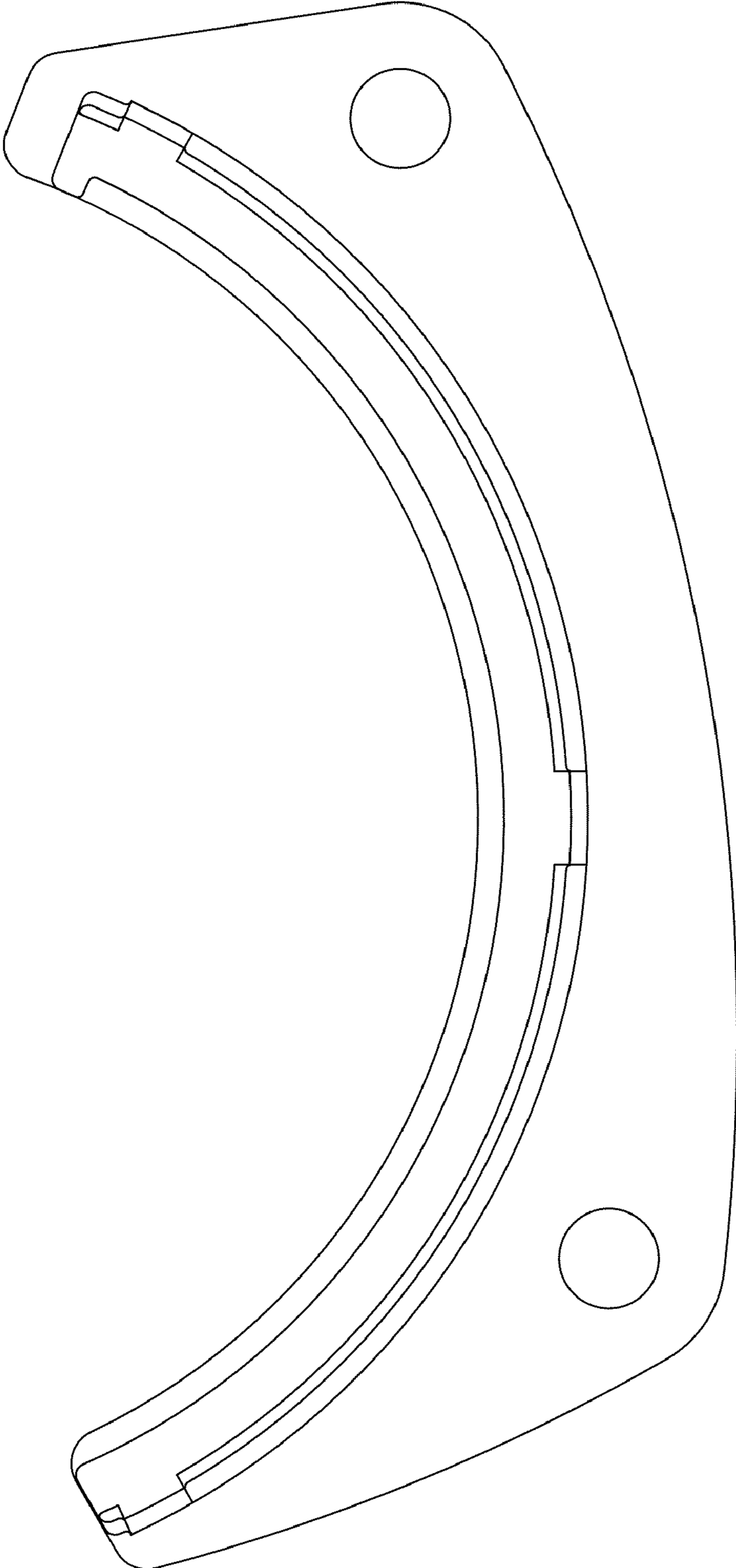

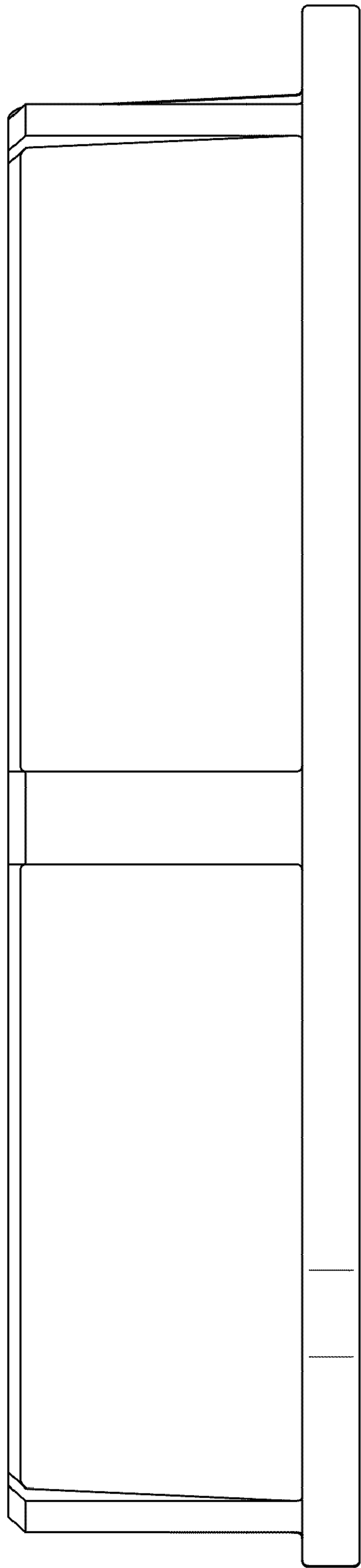

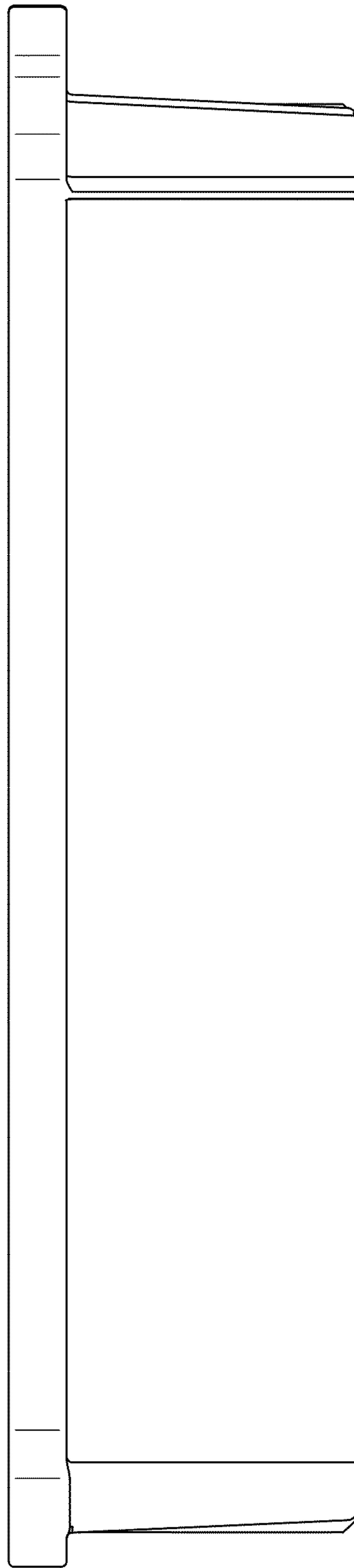

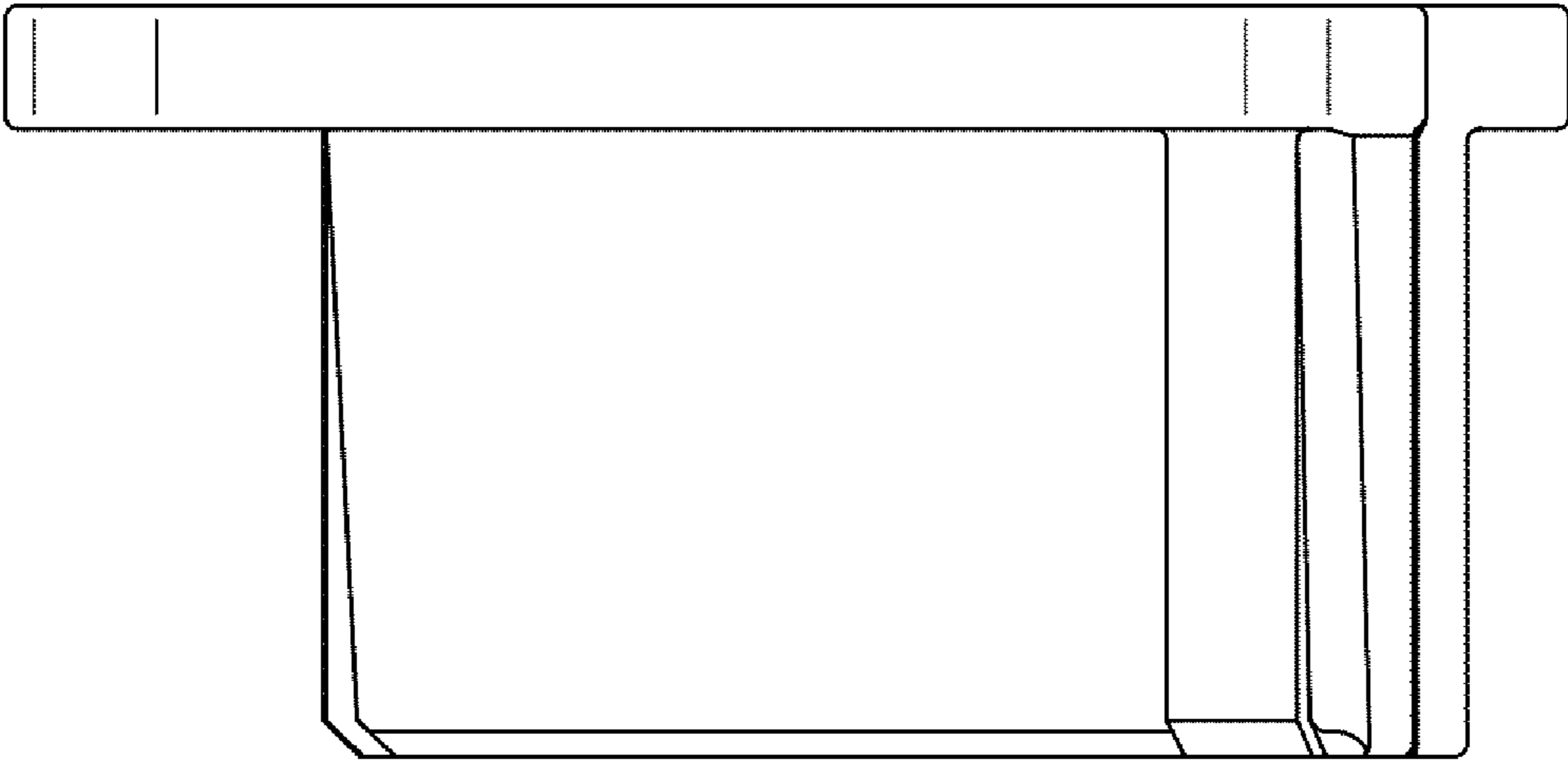

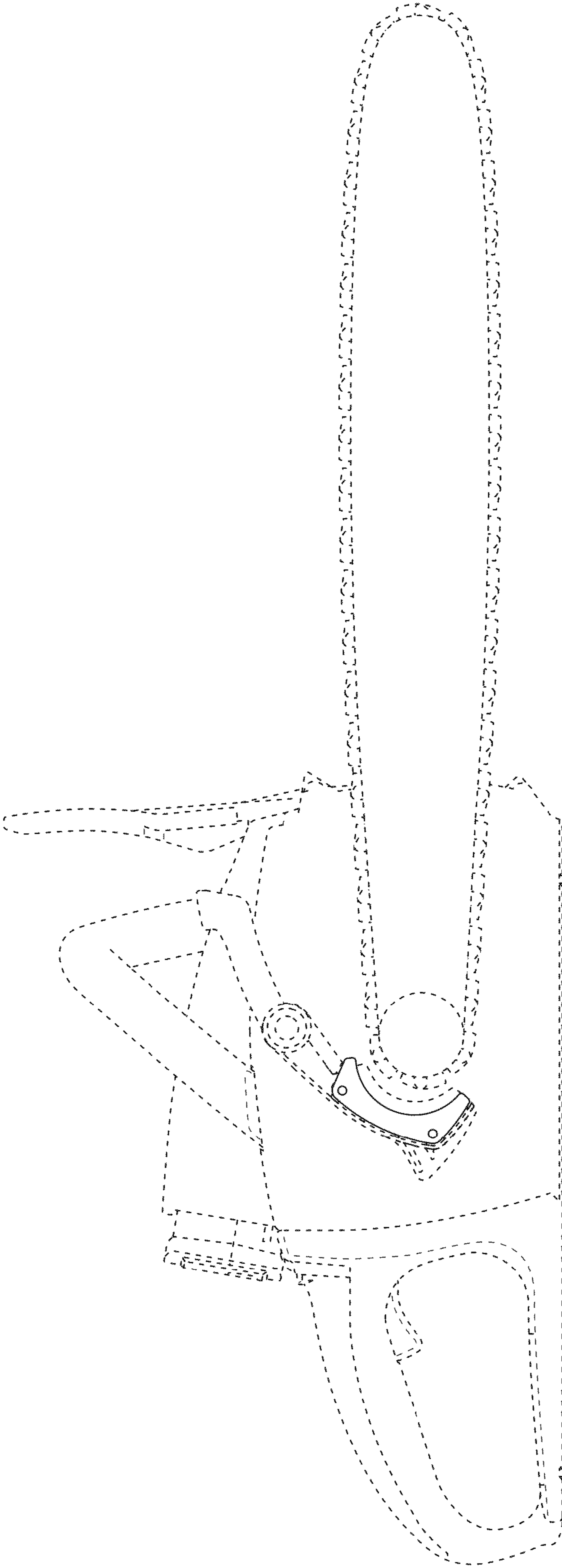

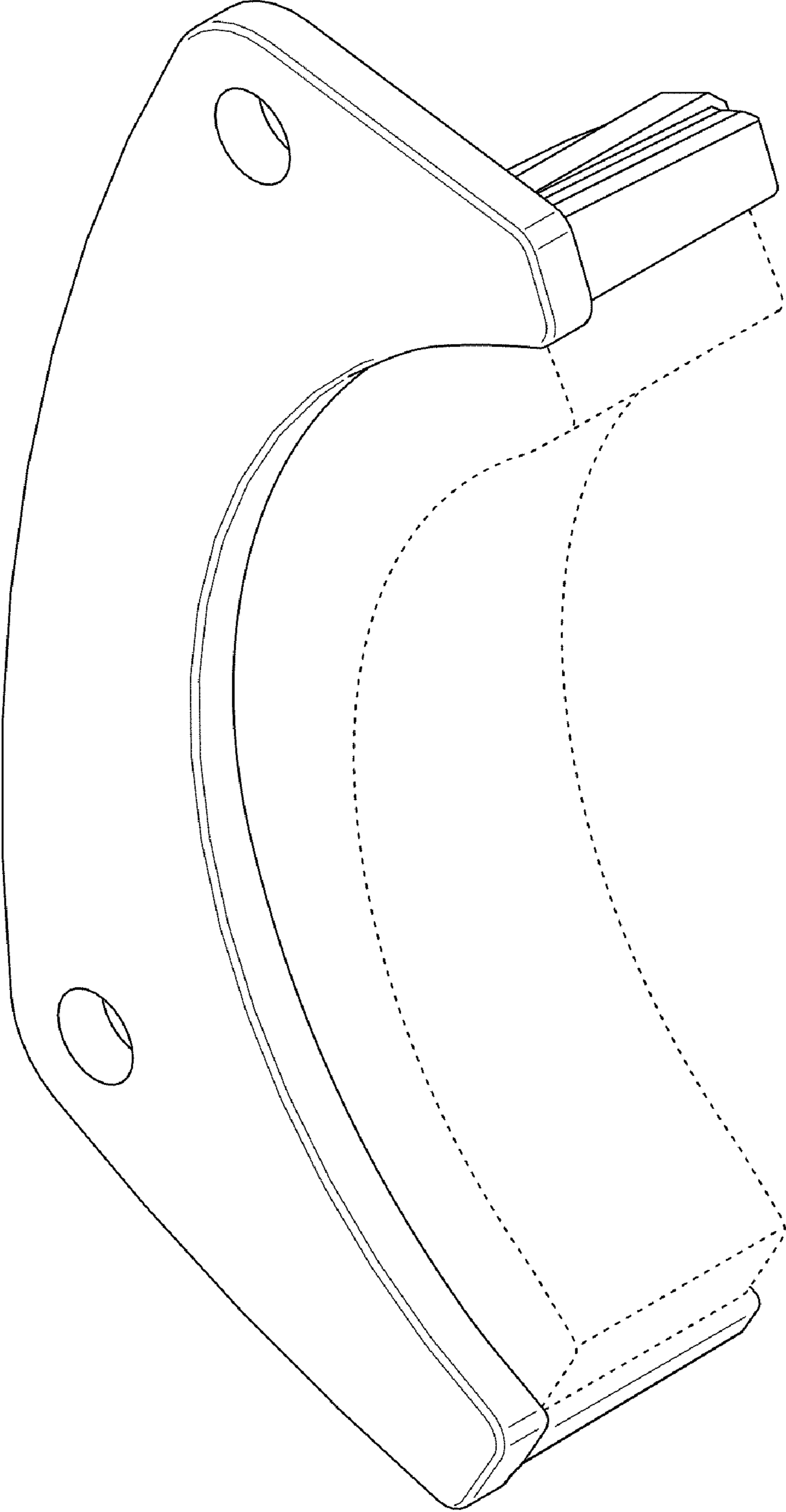
