I claim the ornamental design for a fastener, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a fastener showing my new design;

FIG. 2 is another top perspective view thereof;

FIG. 3 is a bottom perspective view thereof;

FIG. 4 is another bottom perspective view thereof;

FIG. 5 is an elevational view thereof, the opposite side view being the same;

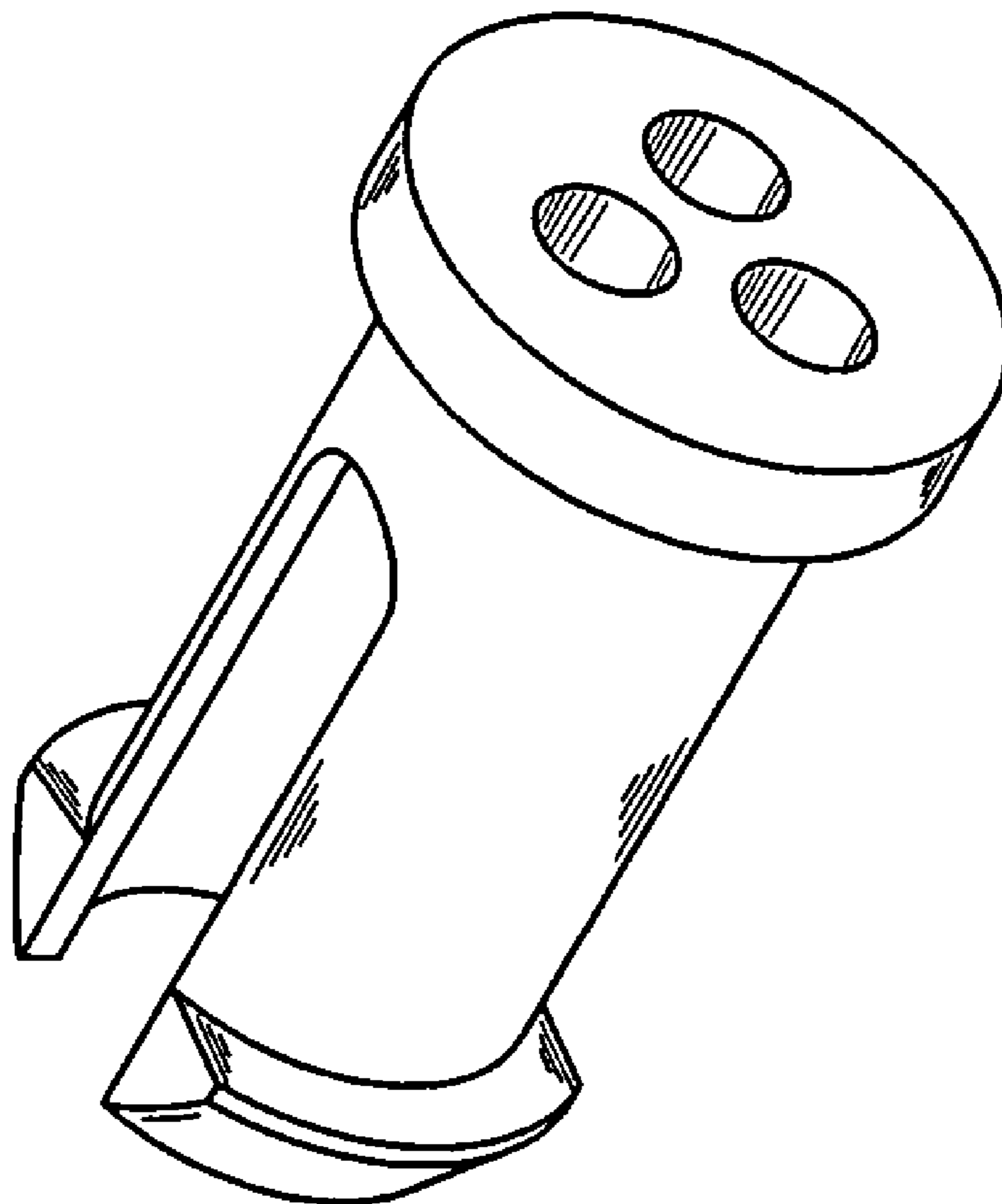
FIG. 6 is another elevational view thereof, the opposite side view being the same;

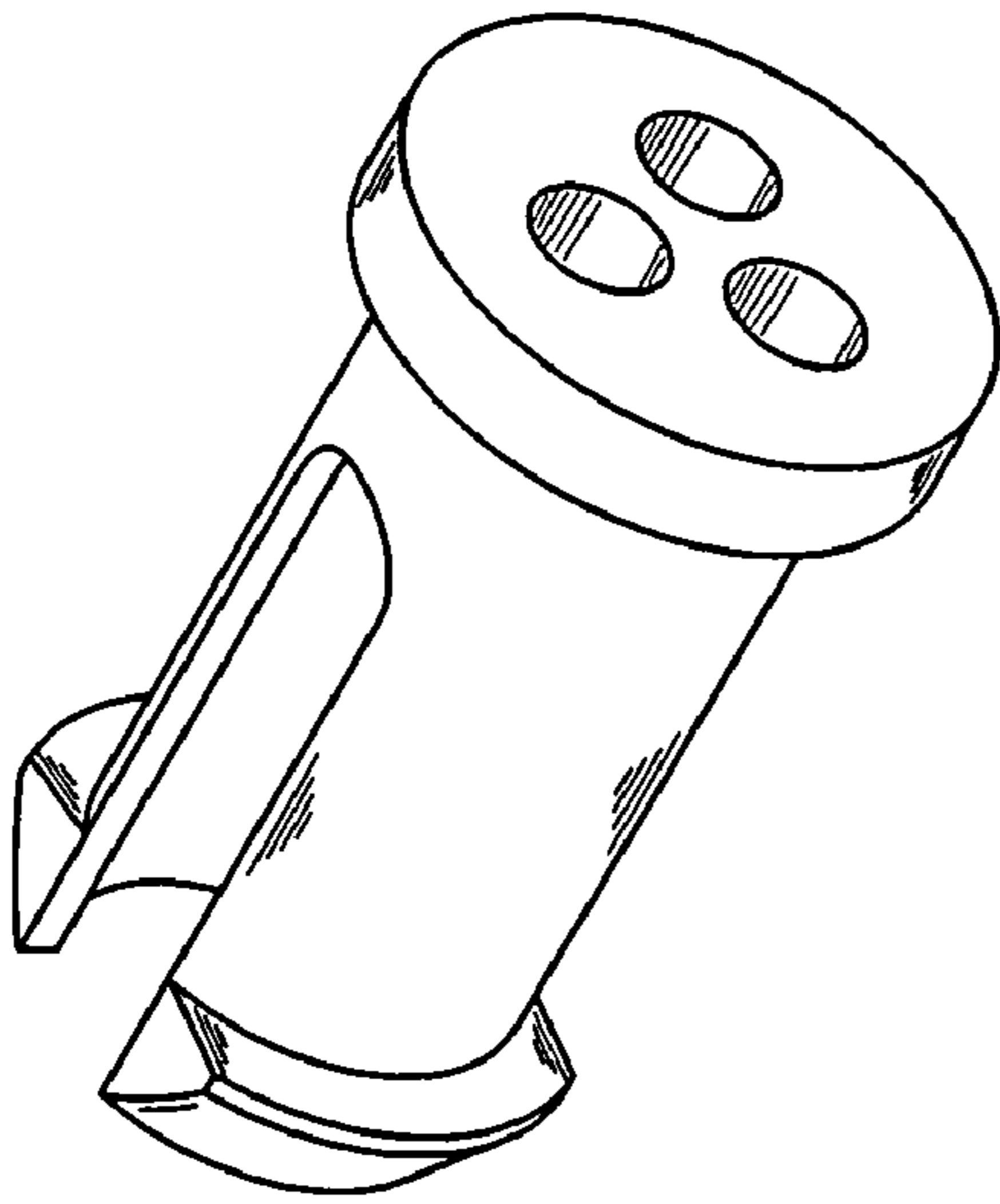

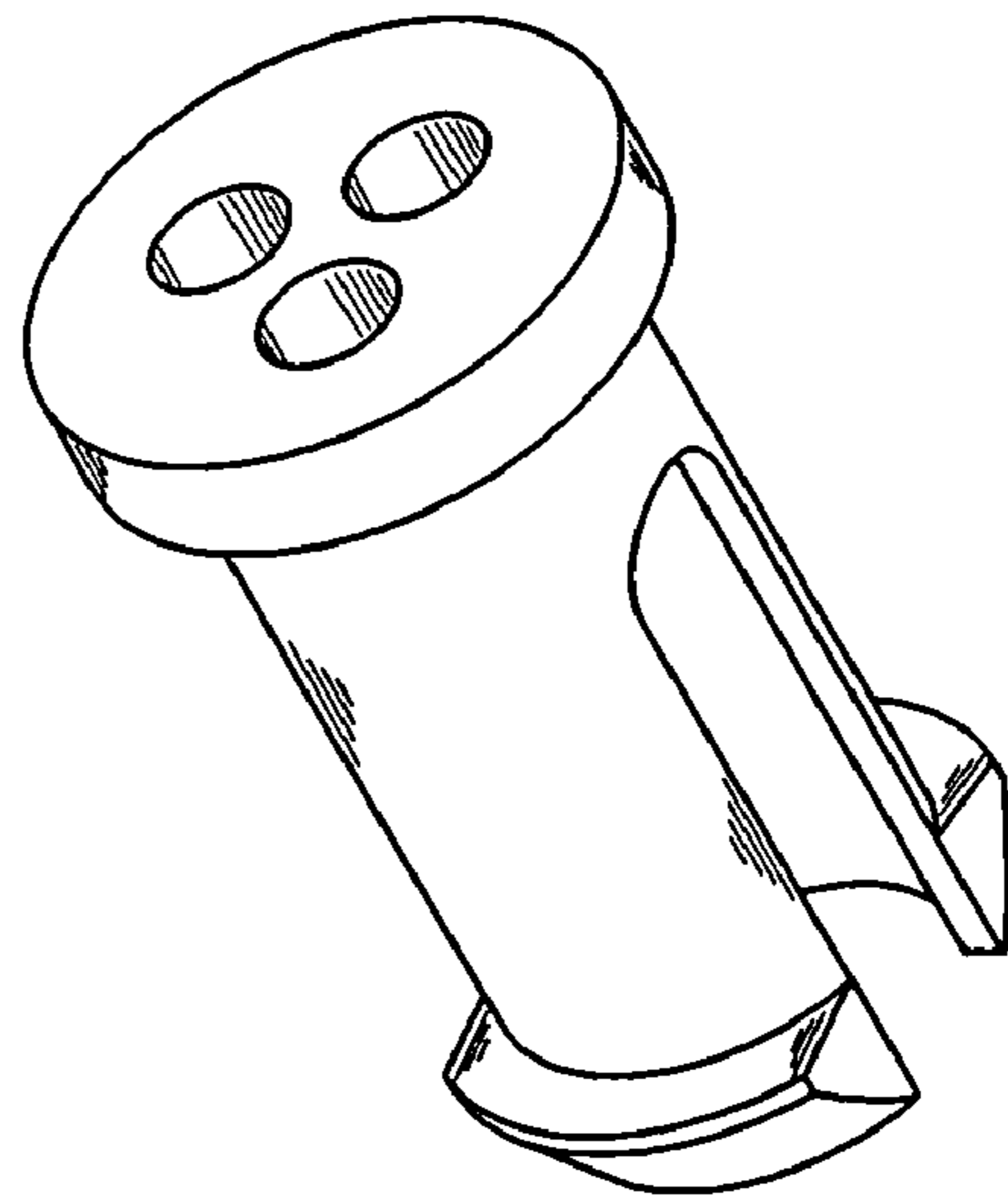

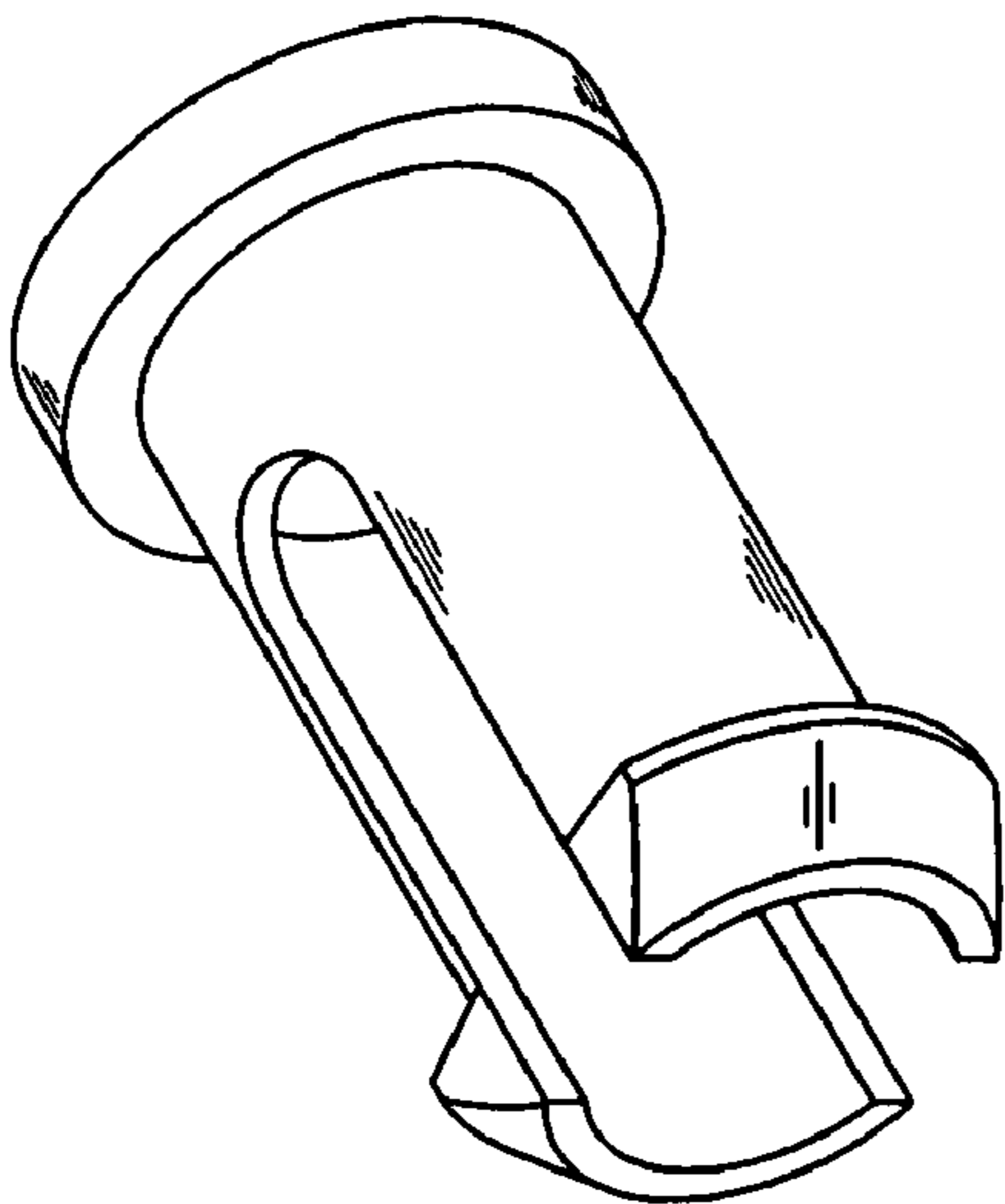

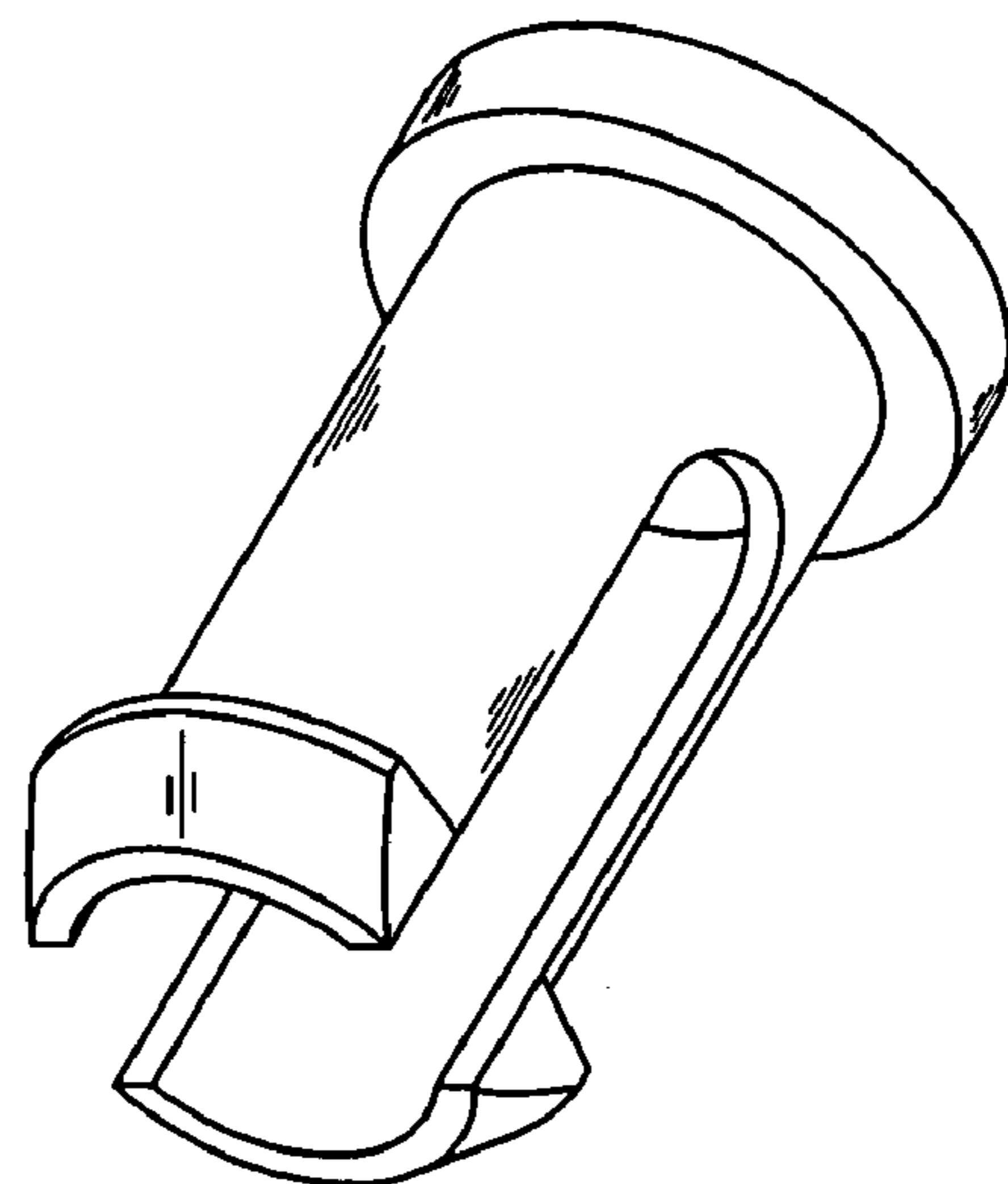

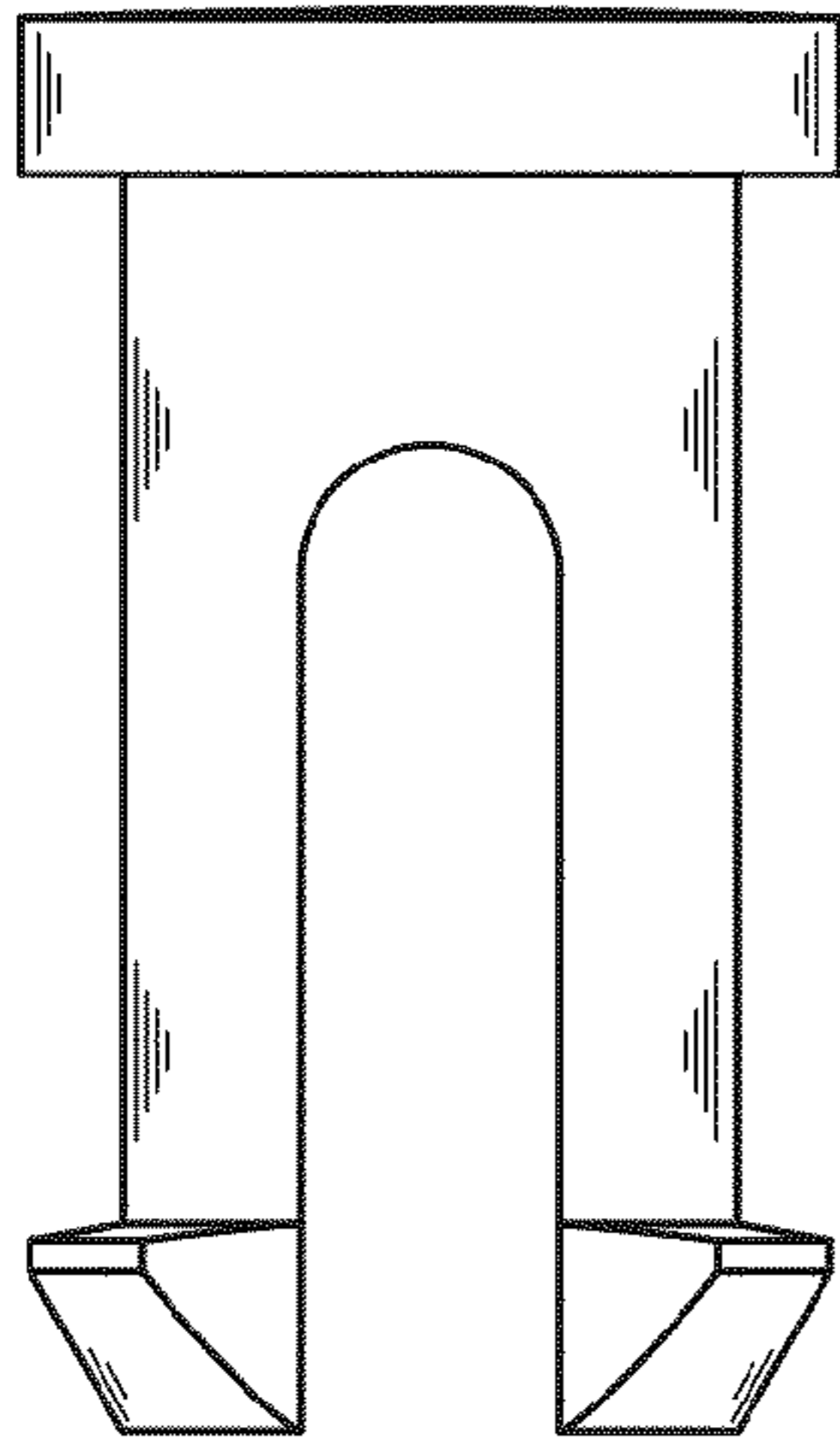

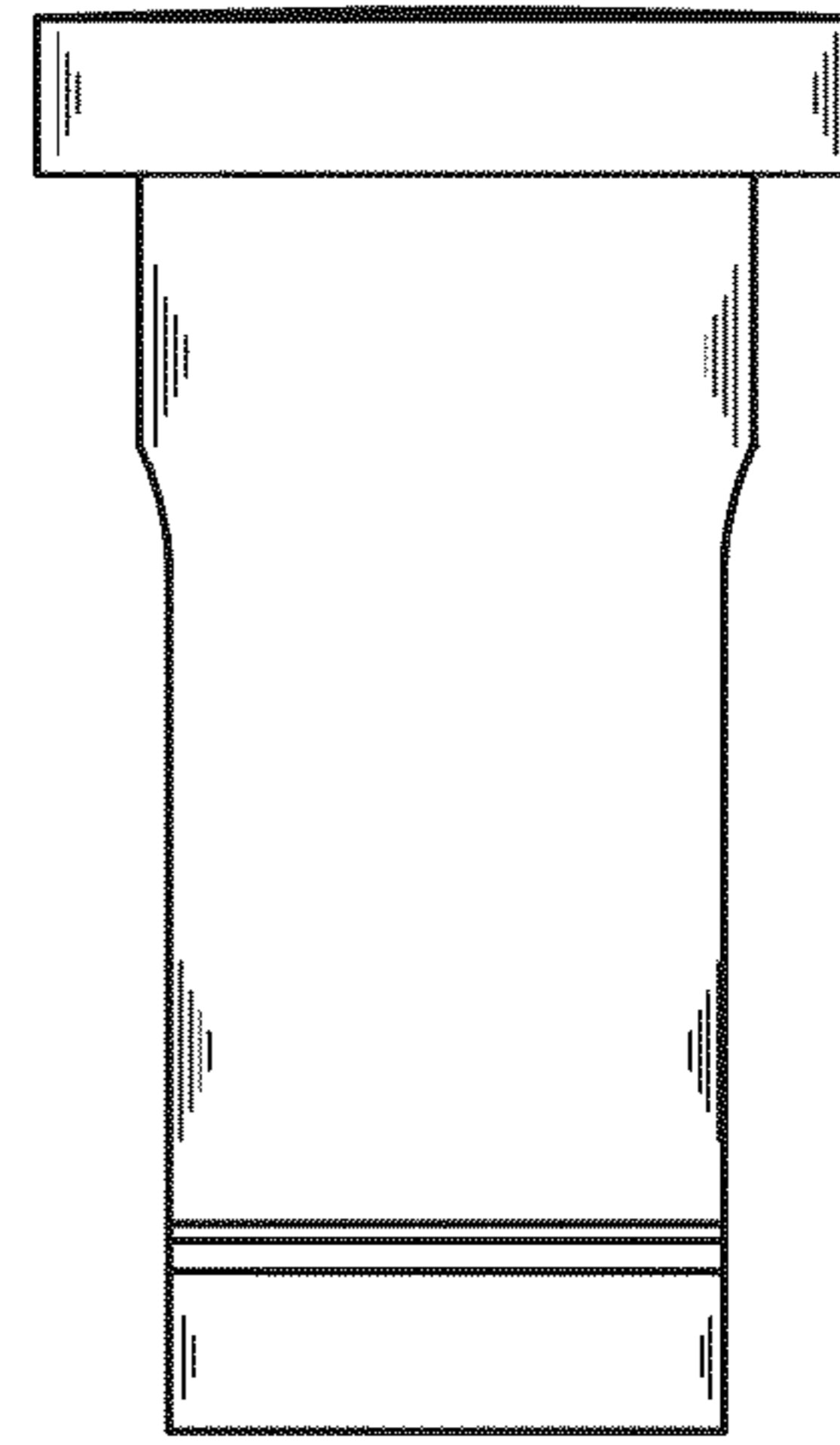

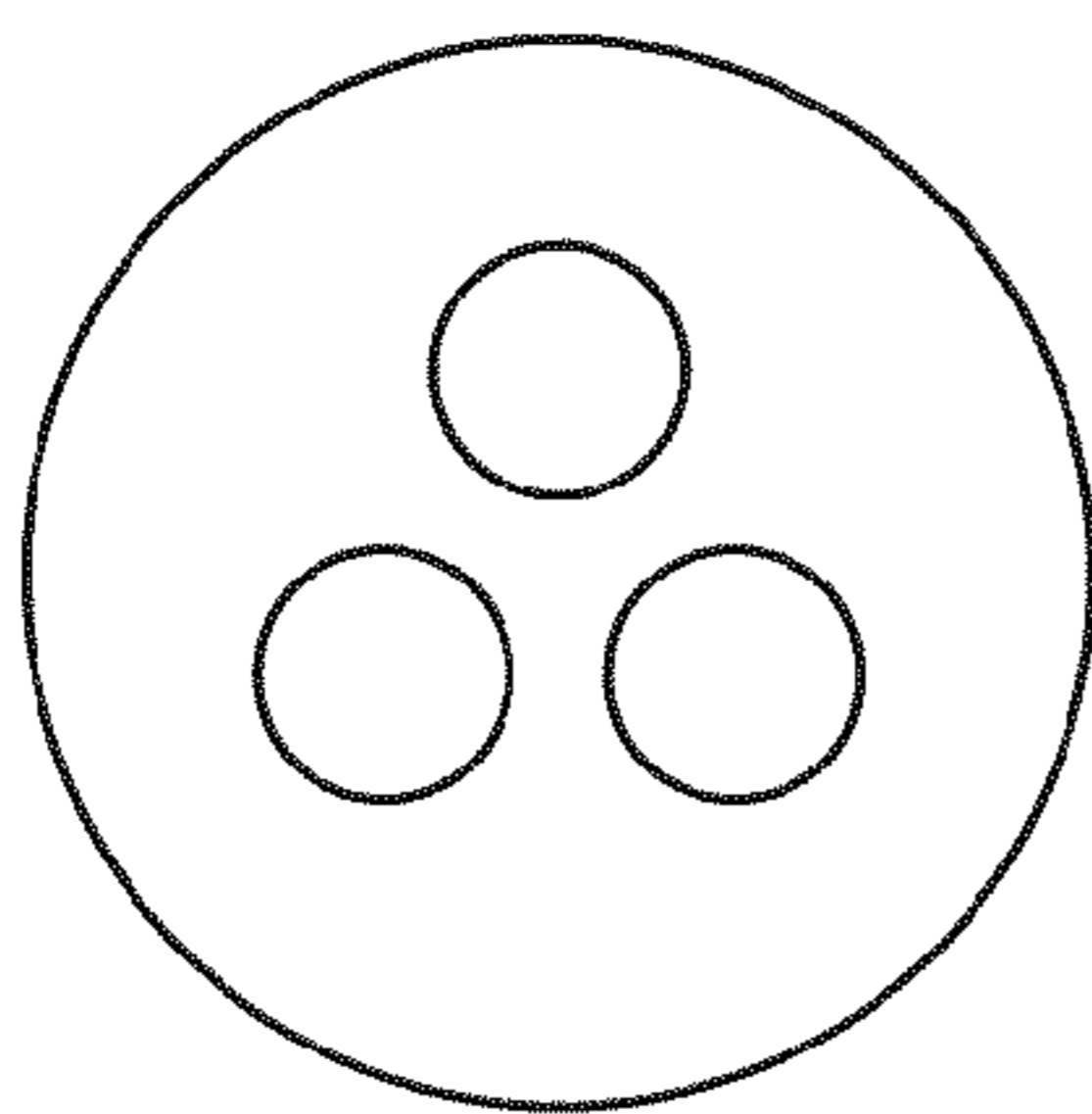

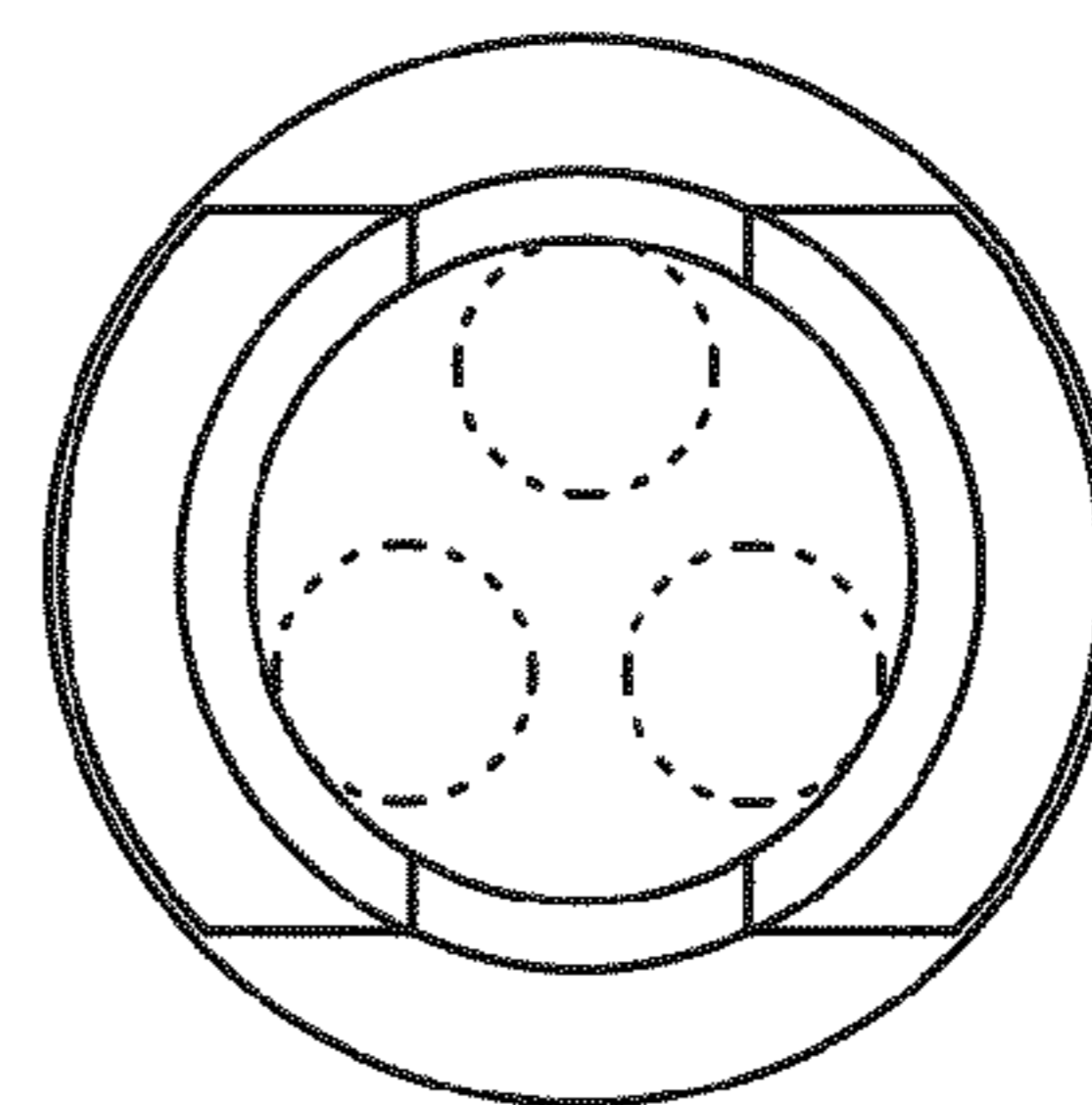
