We claim the ornamental design for a LCD television receiver, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a LCD television receiver showing our new design;

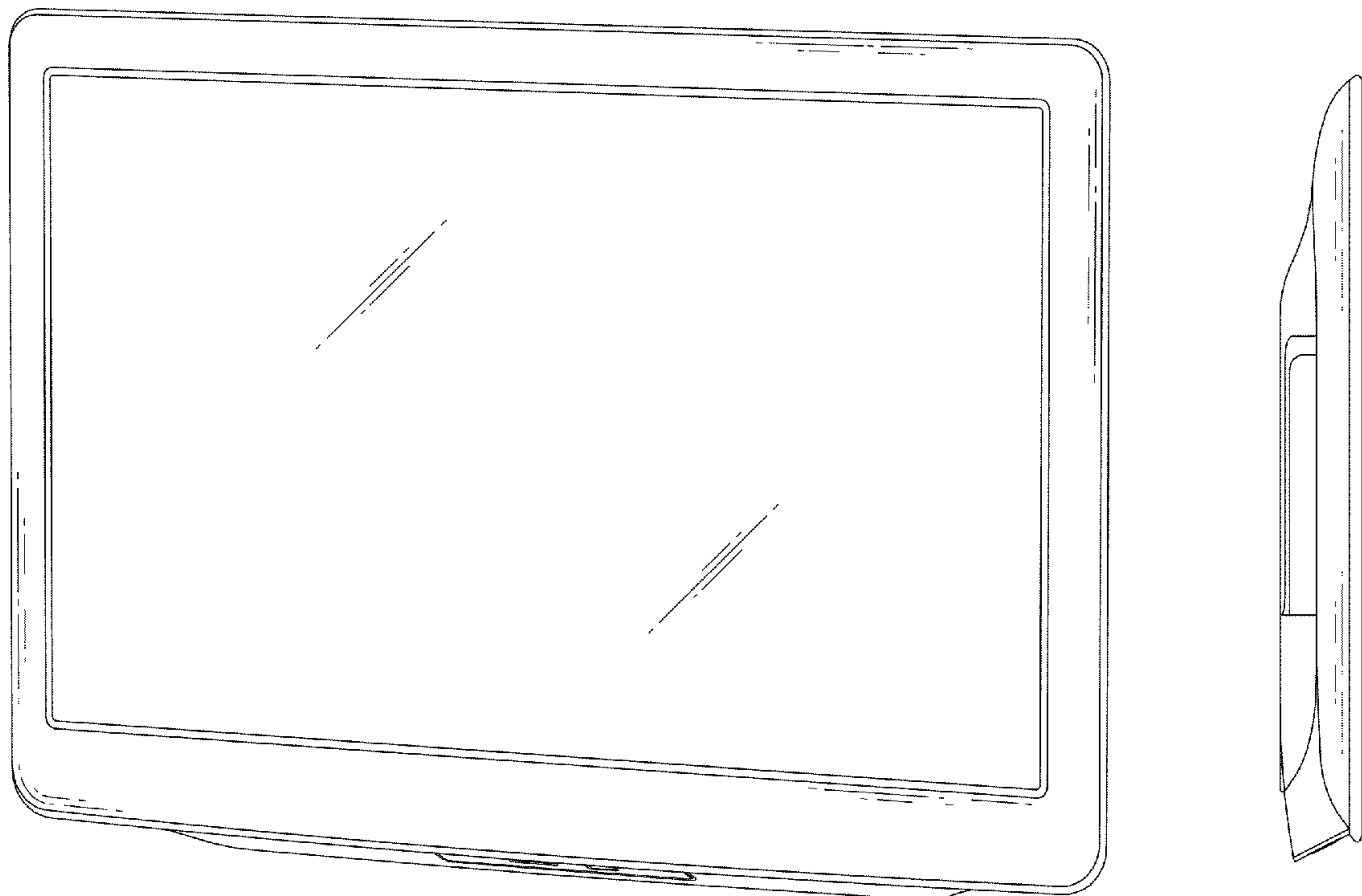

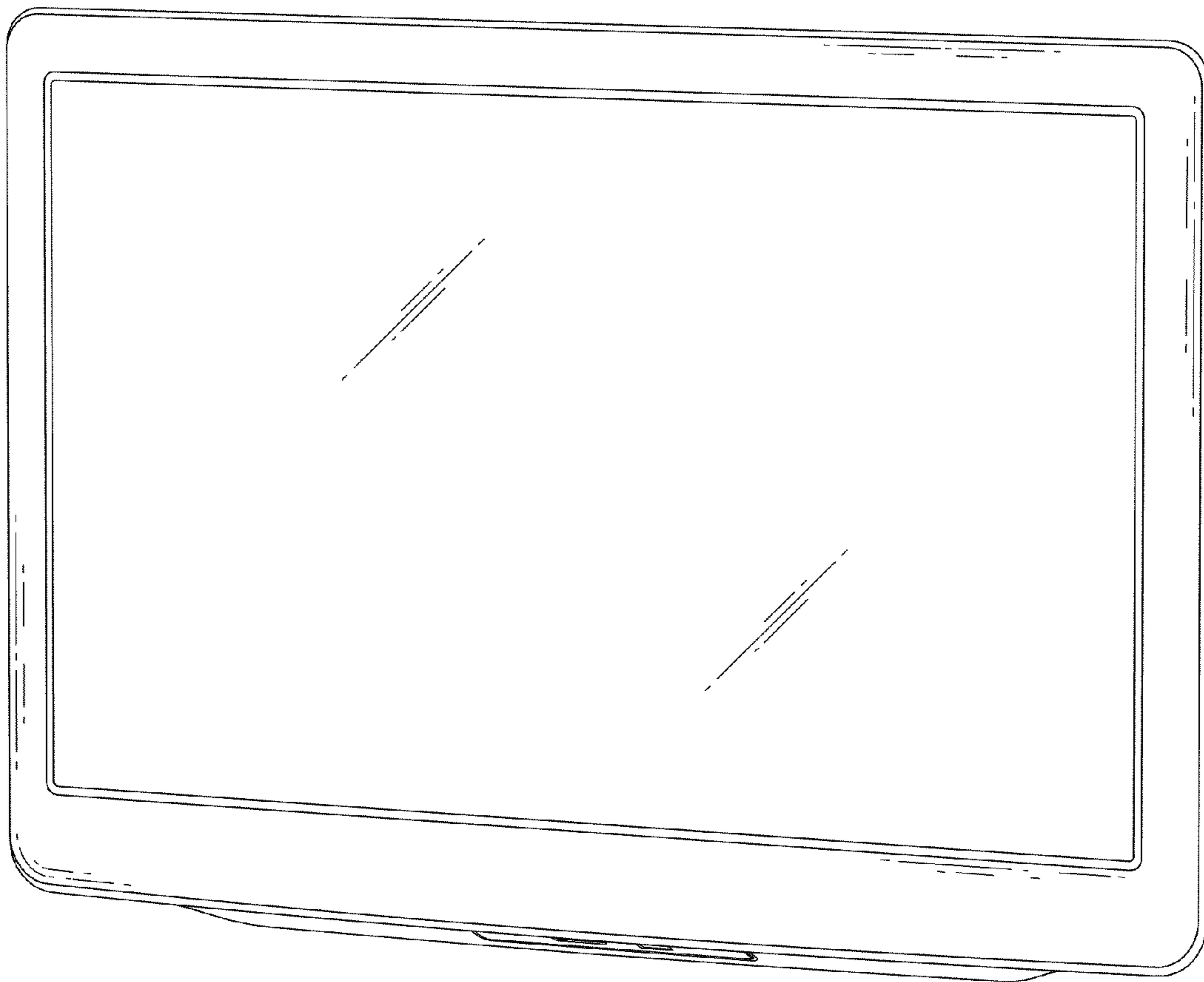

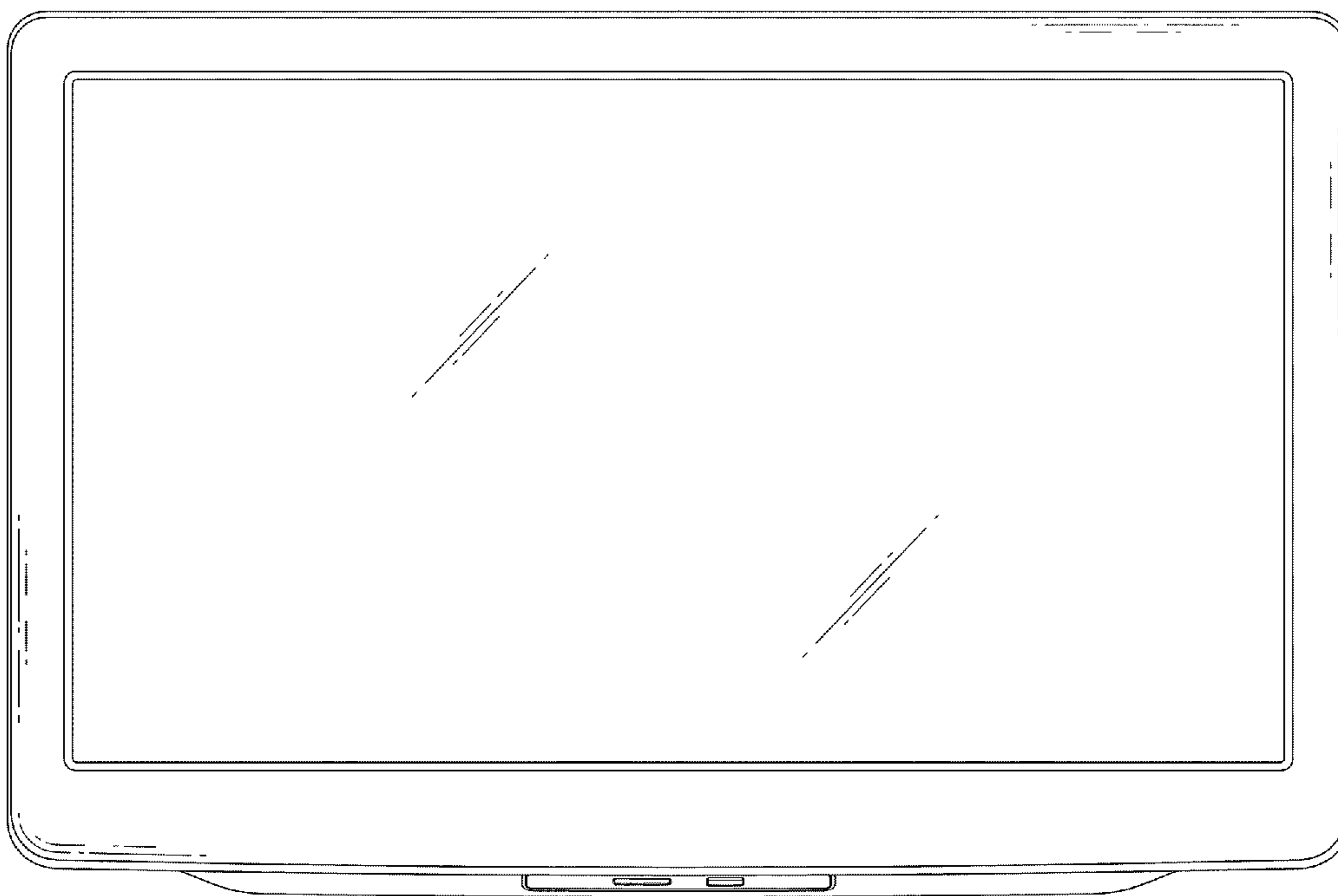

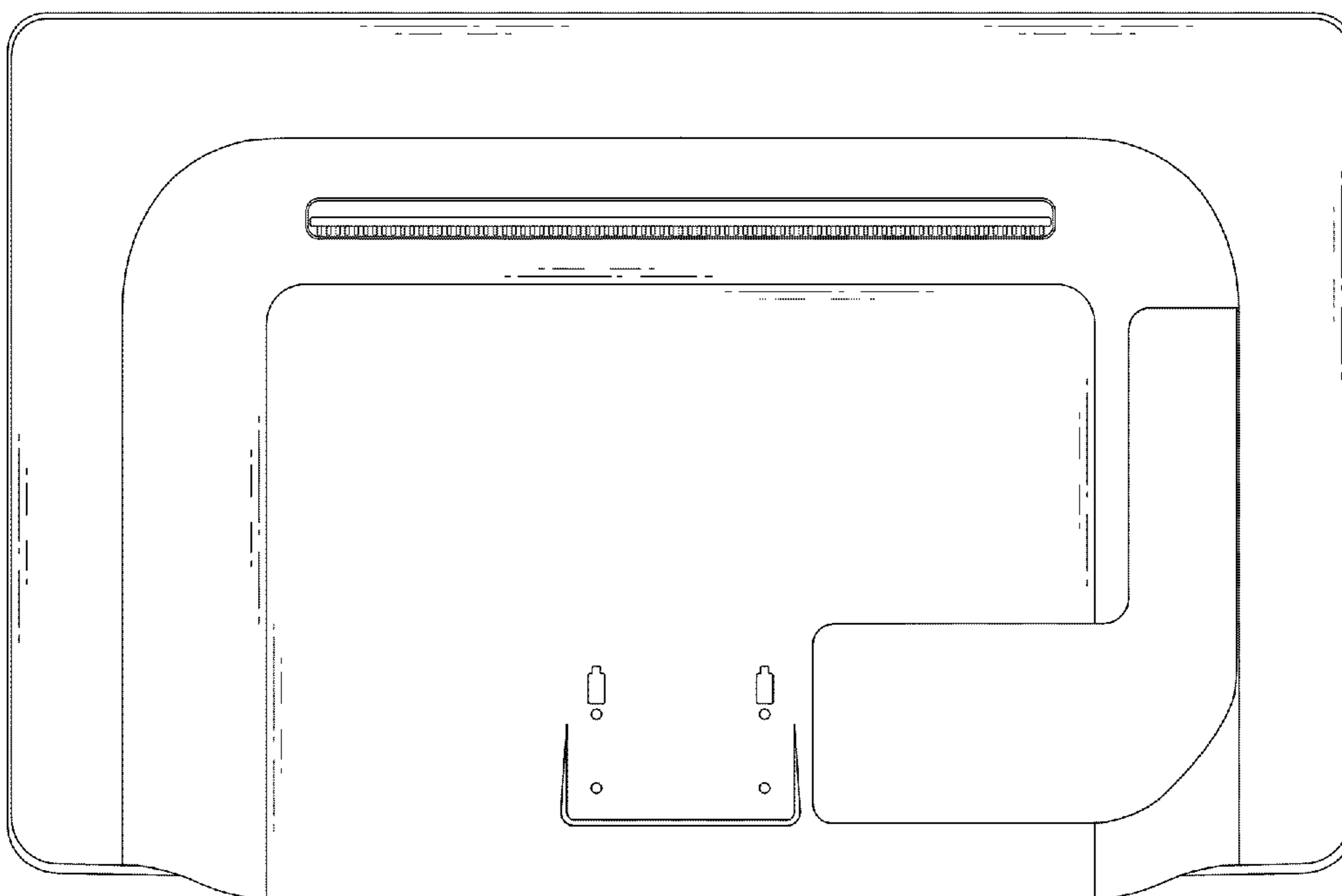

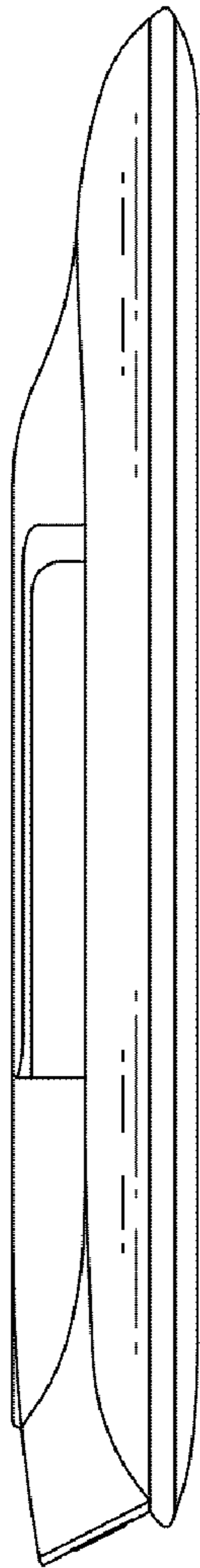

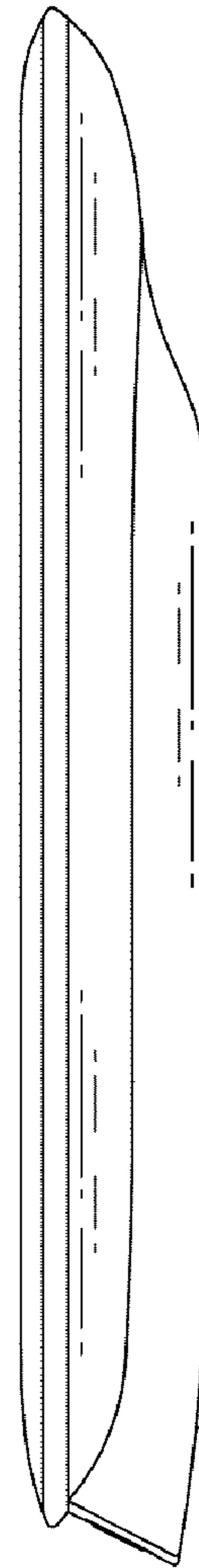

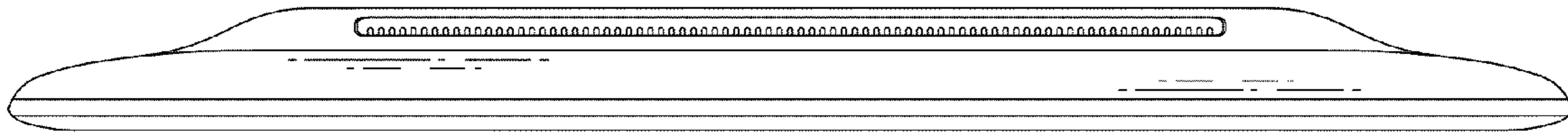
