(57) **CLAIM**

The ornamental design for a lottery ticket, as shown and described.

DESCRIPTION

FIG. 1 is a front plan view of a first embodiment of a lottery ticket having an ornamental snowflake outlined design on the front surface, the ticket being of no appreciable thickness; and,

FIG. 2 is a front plan view of a second embodiment of a lottery ticket having an ornamental snowflake outlined design on the front surface, the ticket being of no appreciable thickness.

Elements shown in phantom line in each of the Figures are for illustration only, and form no part of the present design.
