(57) **CLAIM**

The ornamental design for a weed guard with beads for a fishing lure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a weed guard for a fishing lure;

FIG. 2 is a left elevational view of the weed guard of FIG. 1;

FIG. 3 is a right elevational view of the weed guard of FIG. 1;

FIG. 4 is a front elevational view of the weed guard of FIG. 1, the front elevational view of the weed guard being a mirror image of a rear elevational view of the weed guard;

FIG. 5 is a top plan view of the weed guard of FIG. 1, the top plan view of the weed guard being a mirror image of a bottom view of the weed guard;

FIG. 6 is a second perspective view of the weed guard of FIG. 1 connected to a fishing lure, the fishing lure being illustrated in broken lines being for illustrative purposes only and forming no part of the claimed design;

FIG. 7 is a perspective view of a second embodiment of a weed guard for a fishing lure;

FIG. 8 is a left elevational view of the weed guard of FIG. 7;

FIG. 9 is a right elevational view of the weed guard of FIG. 7;

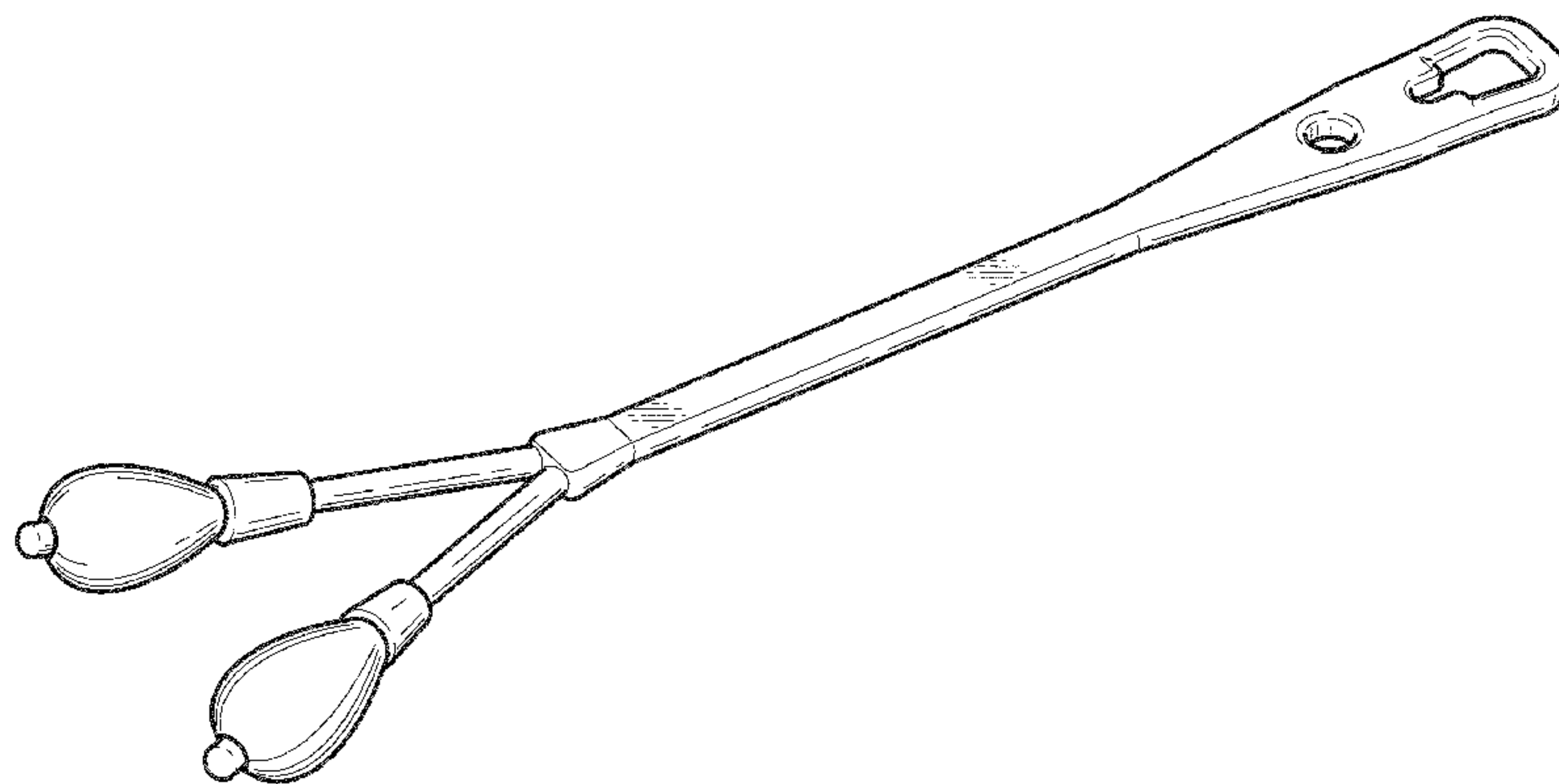
FIG. 10 is a front elevational view of the weed guard of FIG. 7, the front elevational view of the weed guard being a mirror image of a rear elevational view of the weed guard;

FIG. 11 is a top plan view of the weed guard of FIG. 7, the top plan view of the weed guard being a mirror image of a bottom view of the weed guard; and,

FIG. 12 is a second perspective view of the weed guard of FIG. 7 connected to a fishing lure, the fishing lure being illustrated in broken lines being for illustrative purposes only and forming no part of the claimed design.

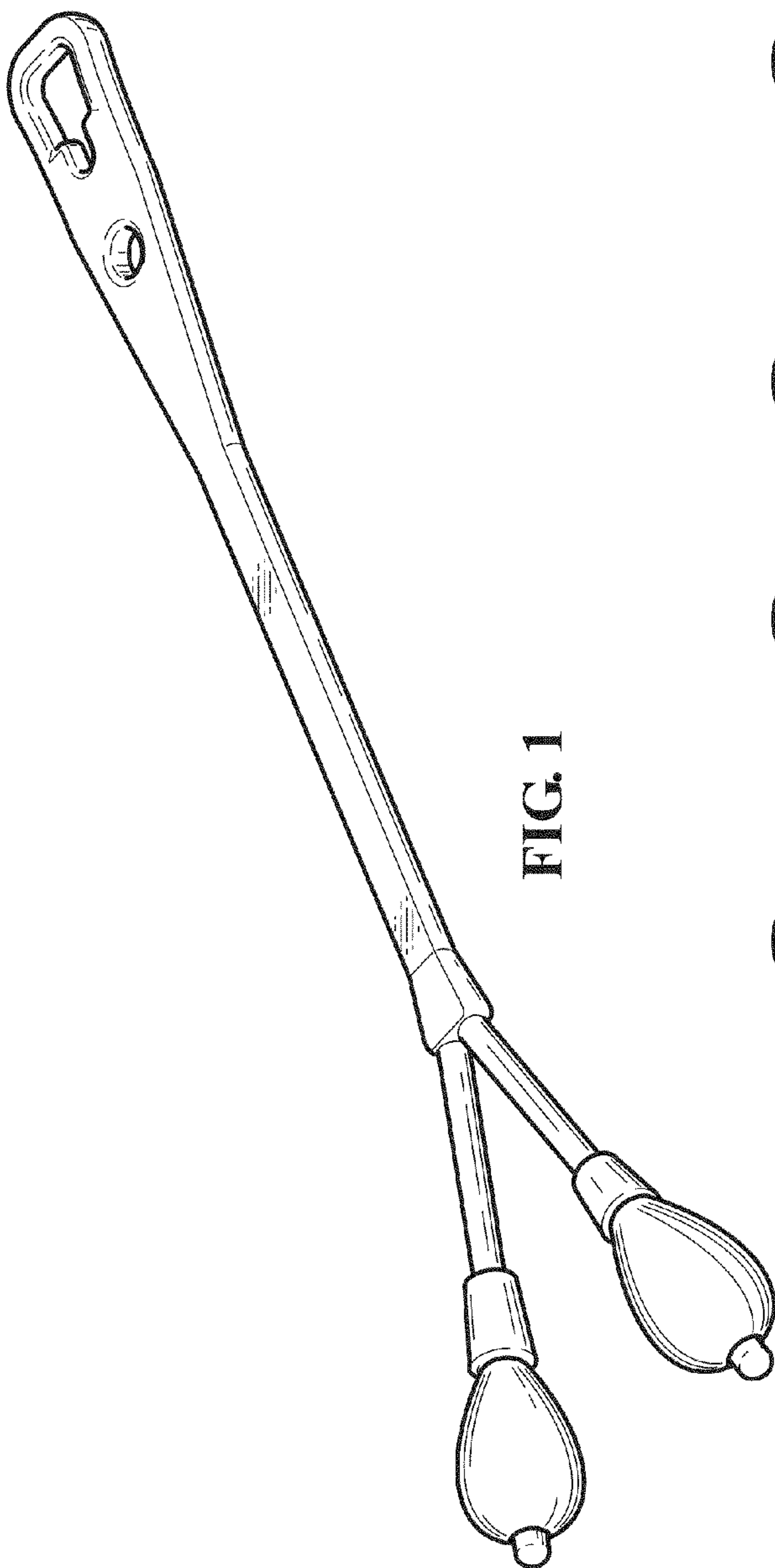

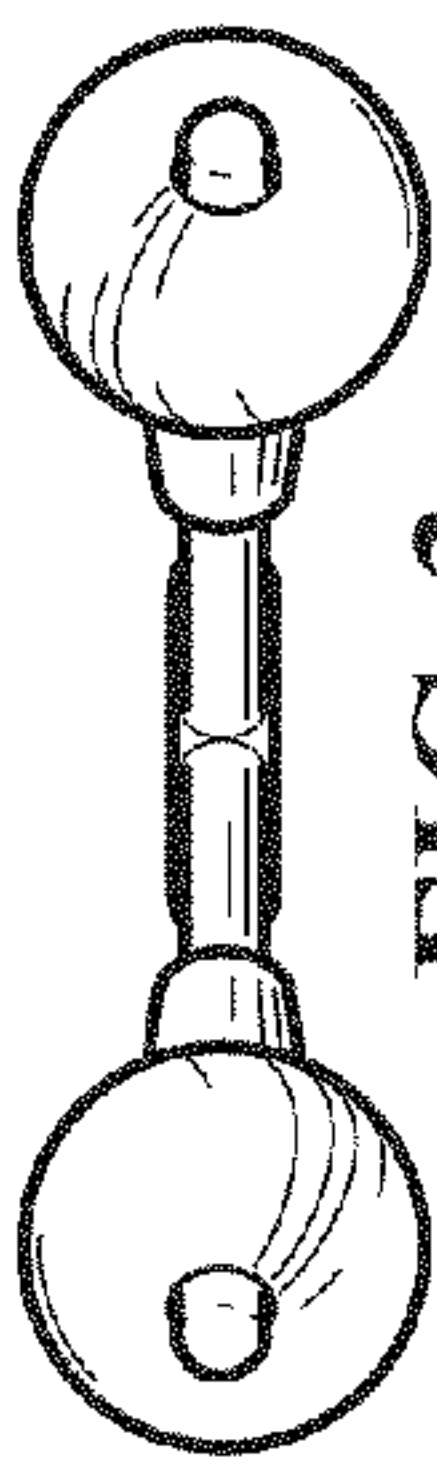

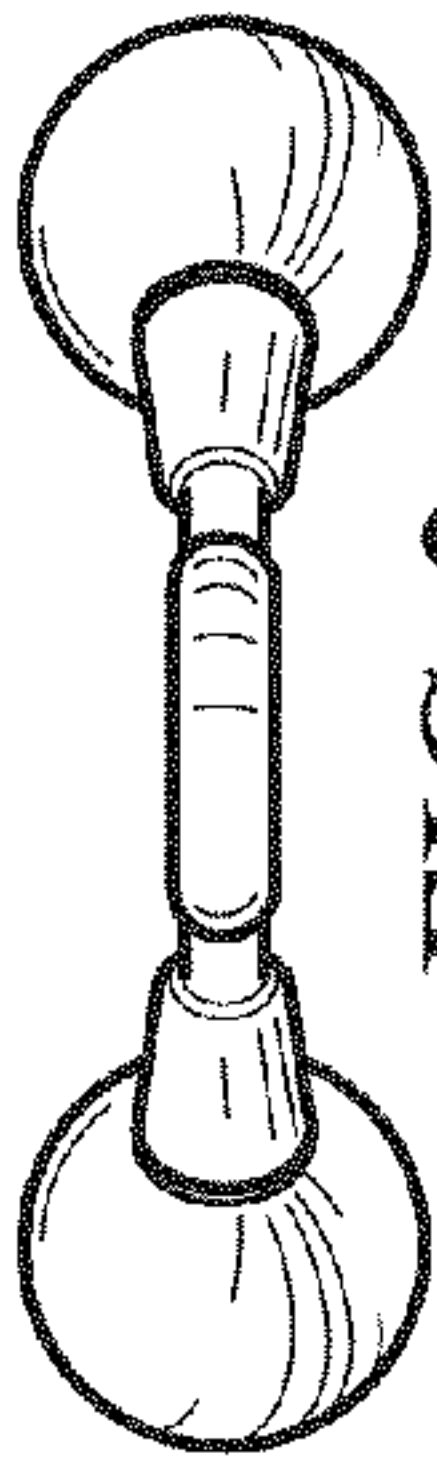
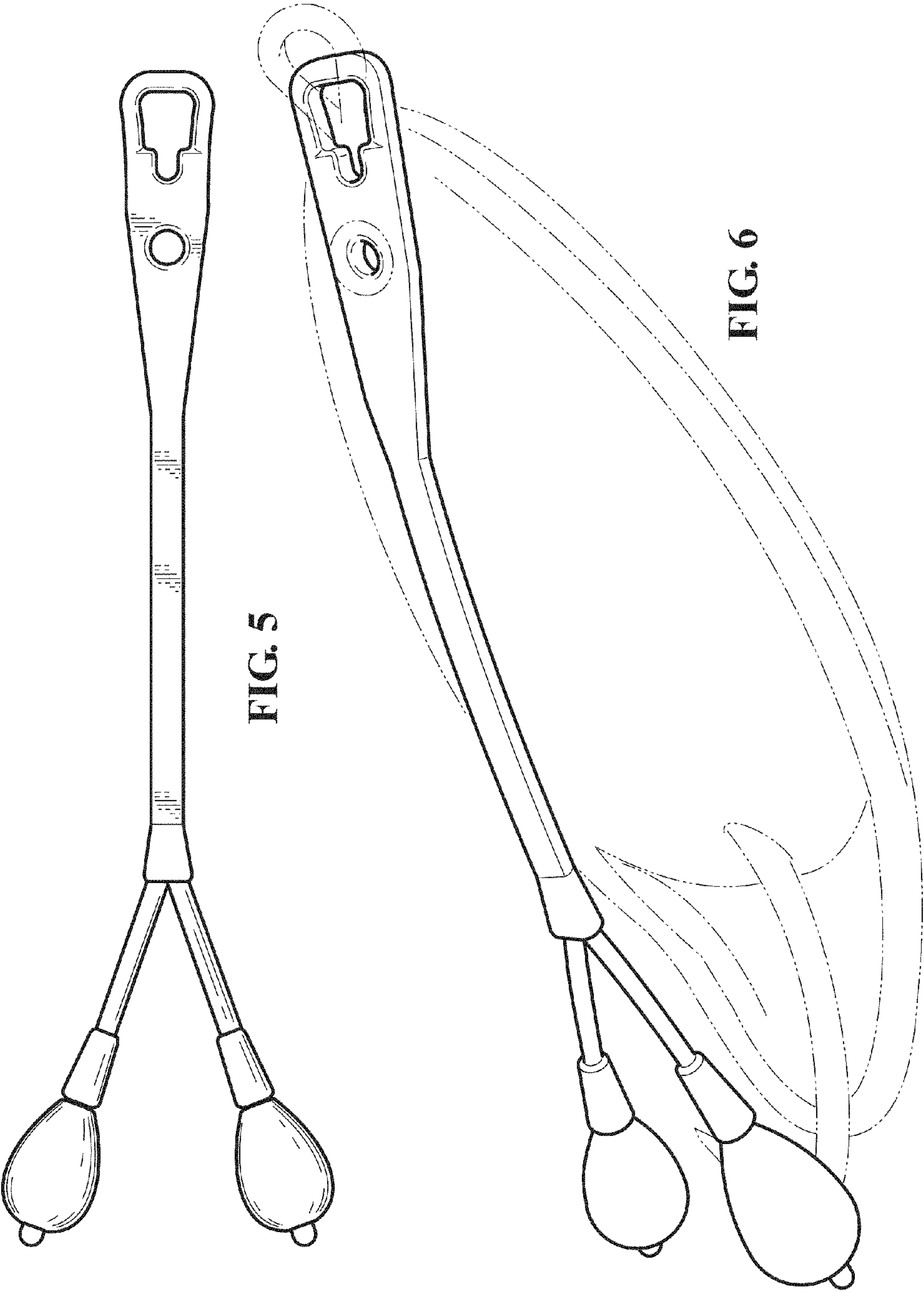

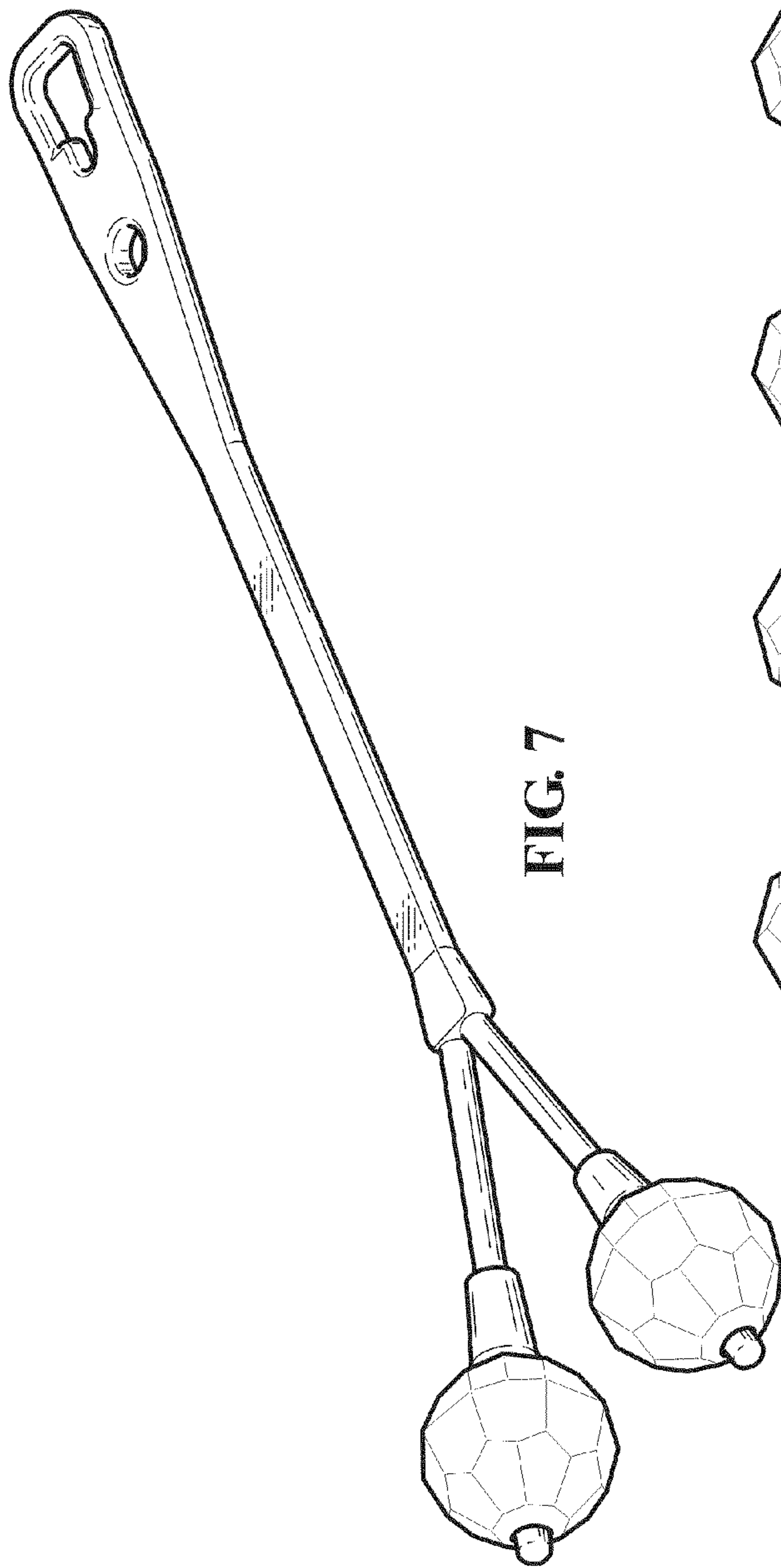

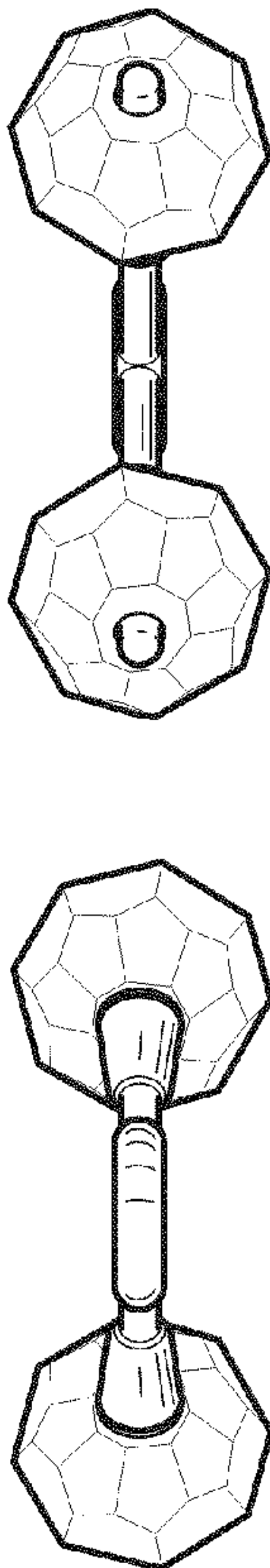

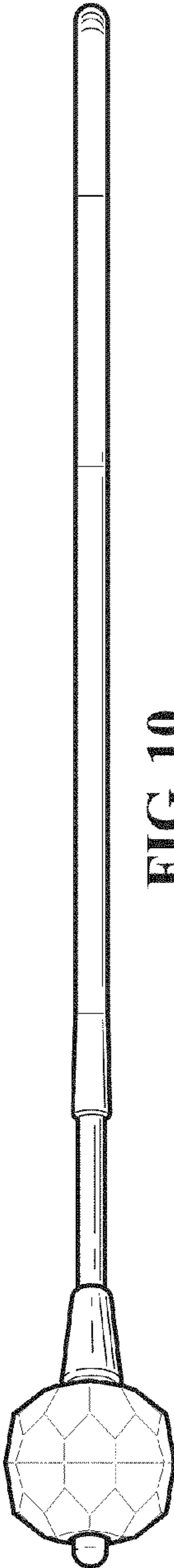
