The ornamental design for a glove, as shown and described.

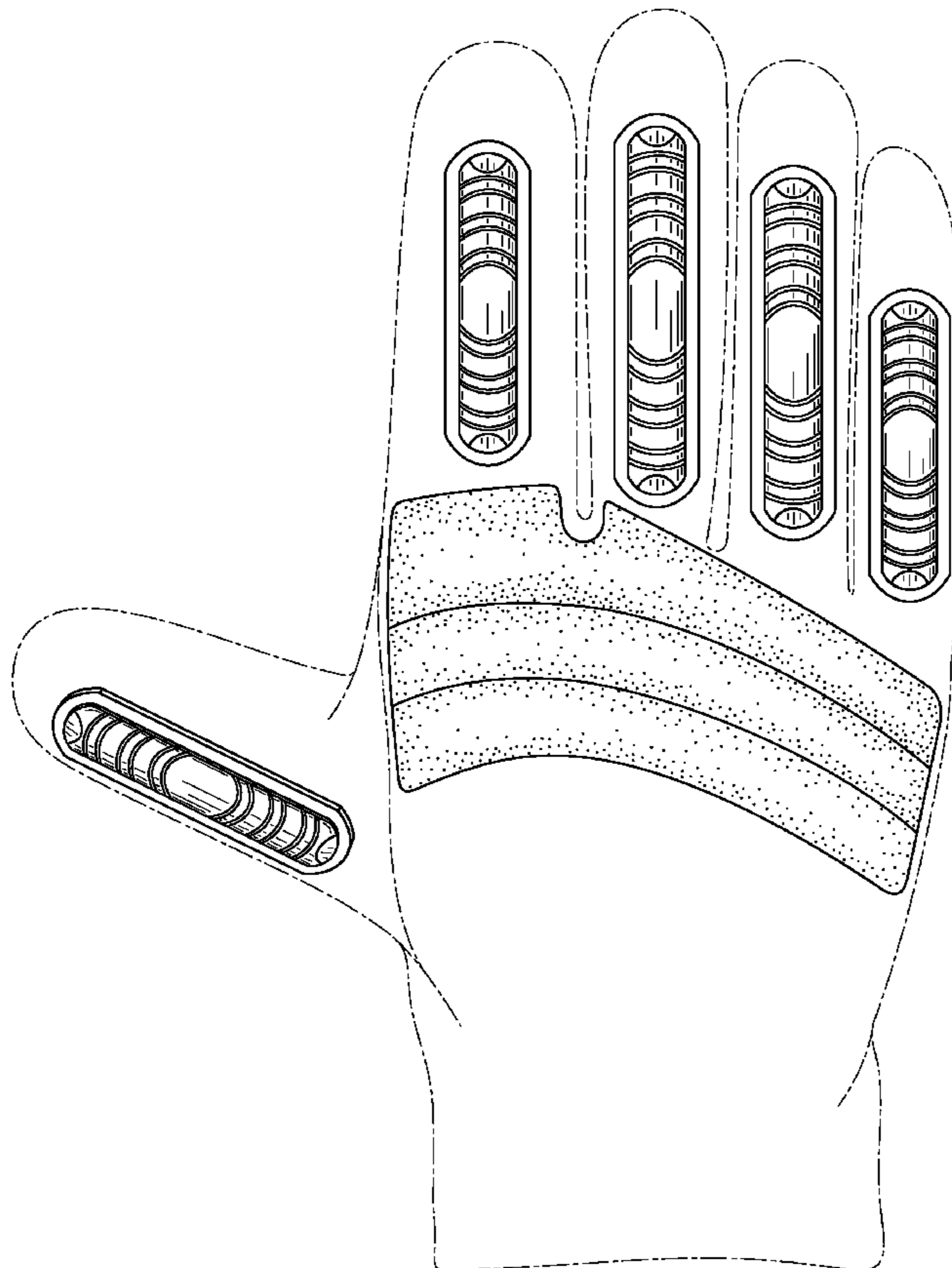
DESCRIPTION

FIG. 1 is a top view of a glove showing our new design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a left side elevational view thereof; and,
FIG. 4 is a perspective top view thereof.

The glove shown in broken lines in the drawings illustrates the article to which the design is applied, and forms no part of the claim.

The stippling in the drawings represents texture.

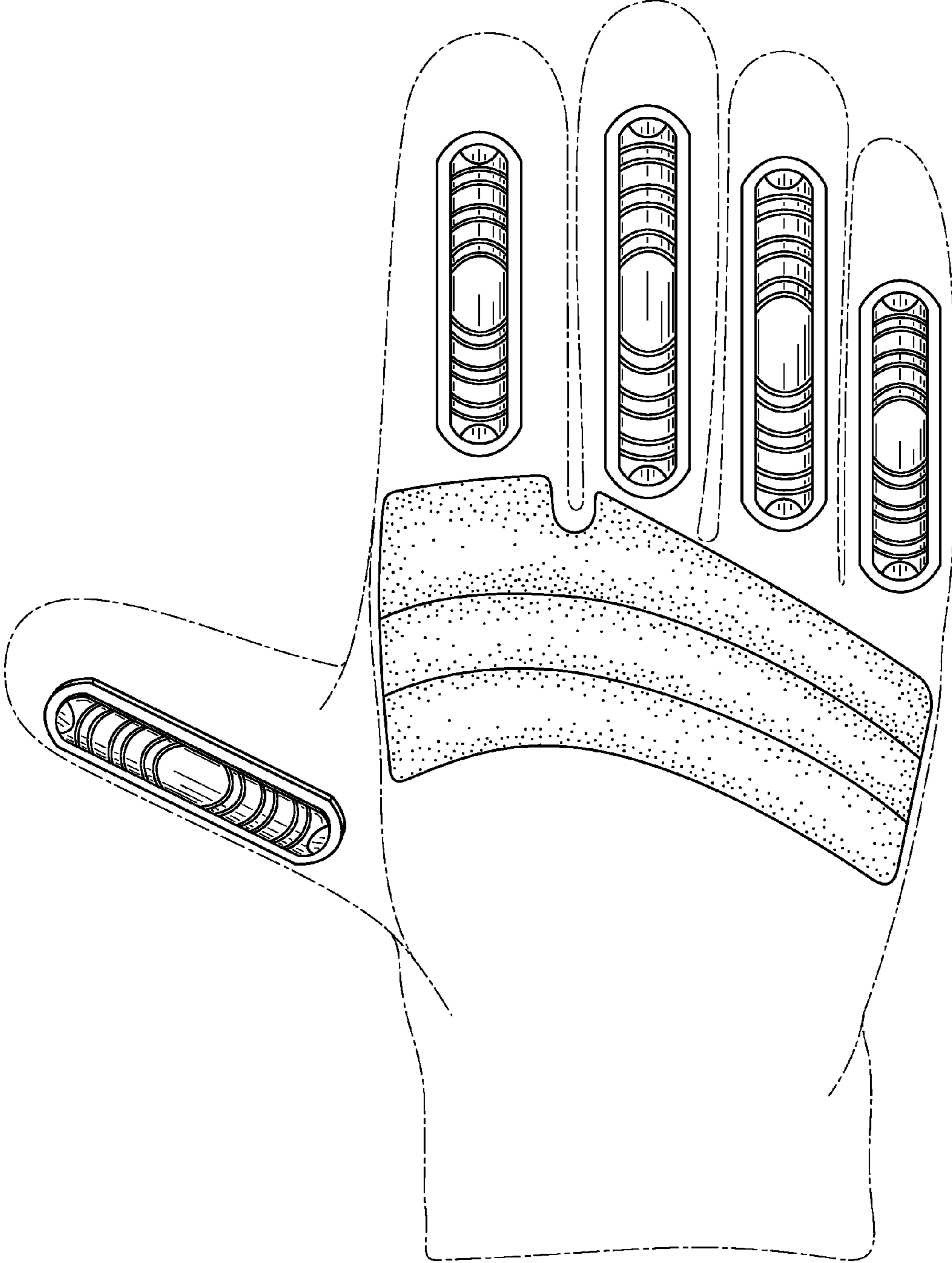

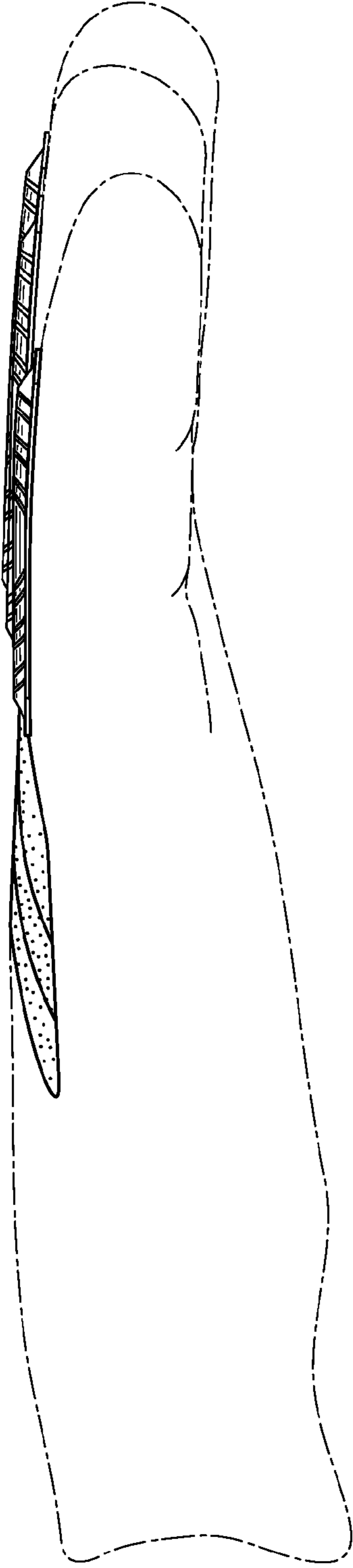

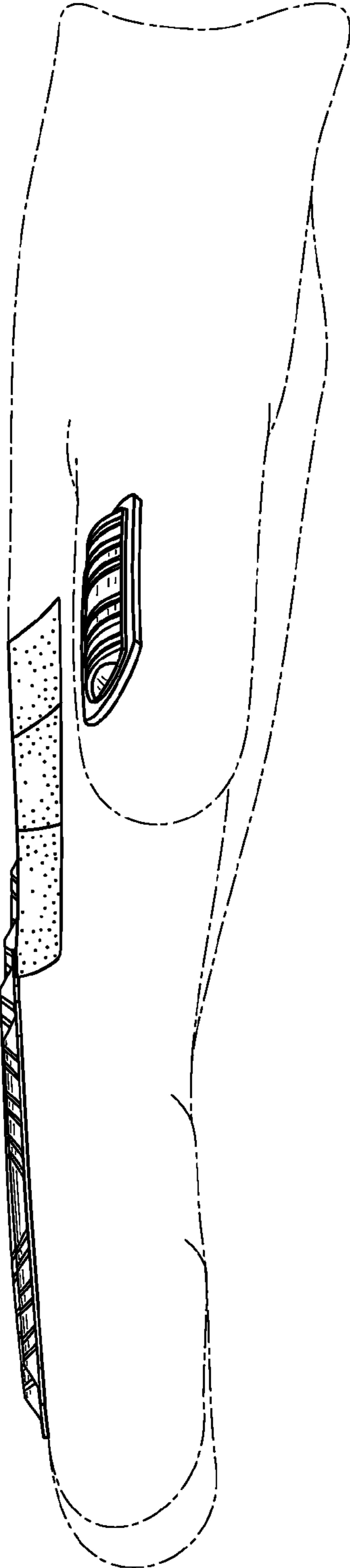

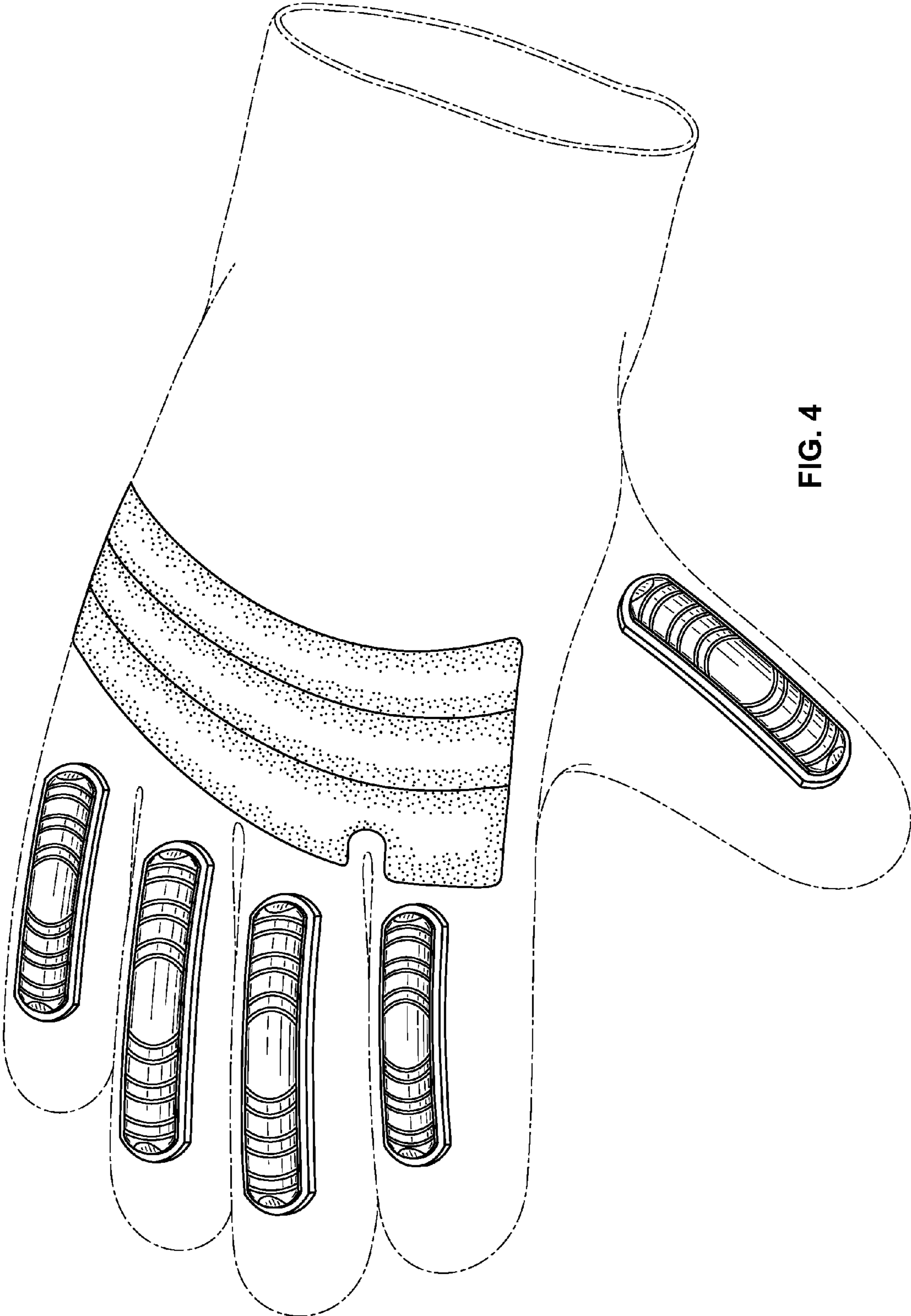
