The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a chair showing my present design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a bottom perspective view from the front thereof;

FIG. 5 is a bottom perspective view from the back thereof;

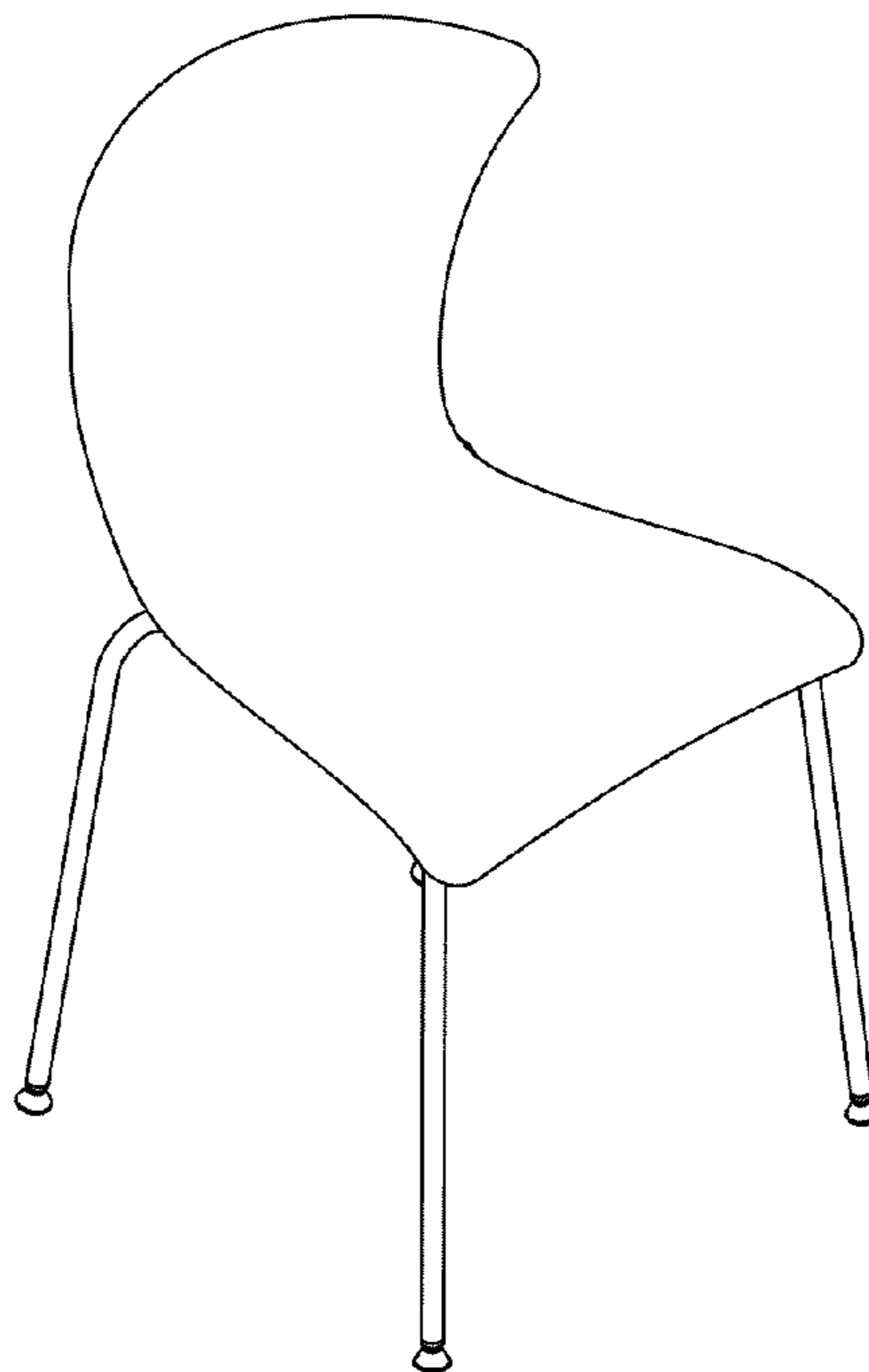

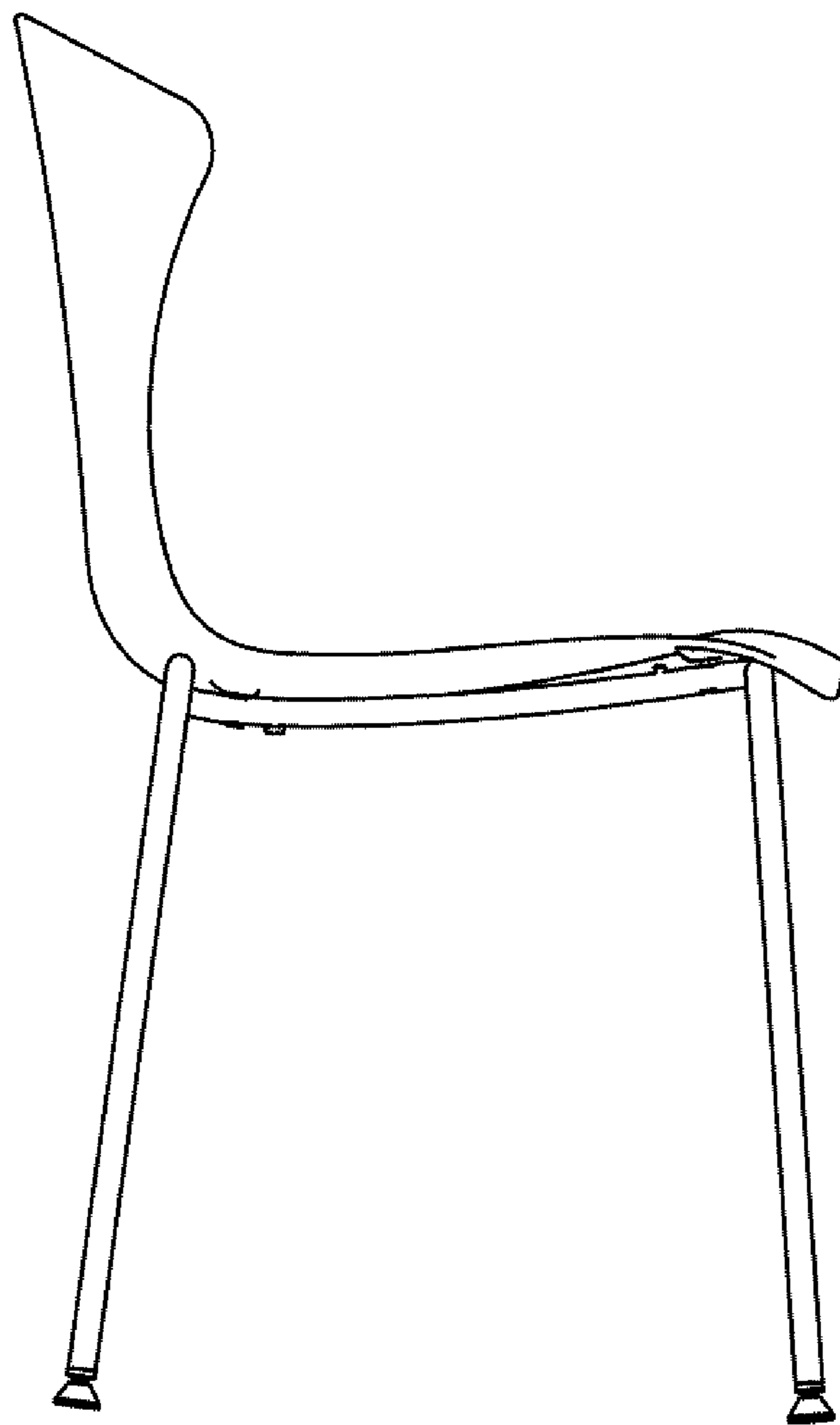

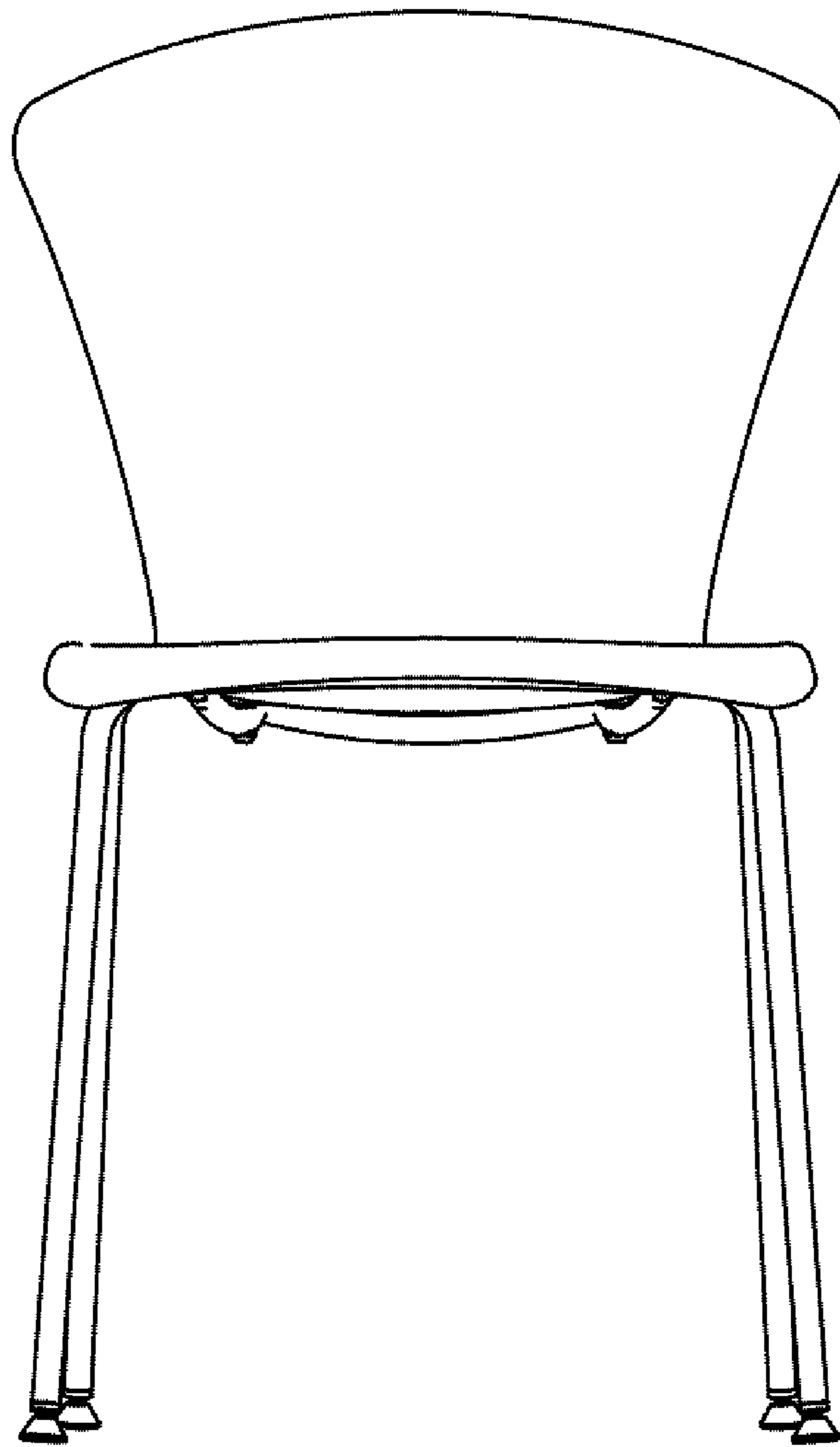

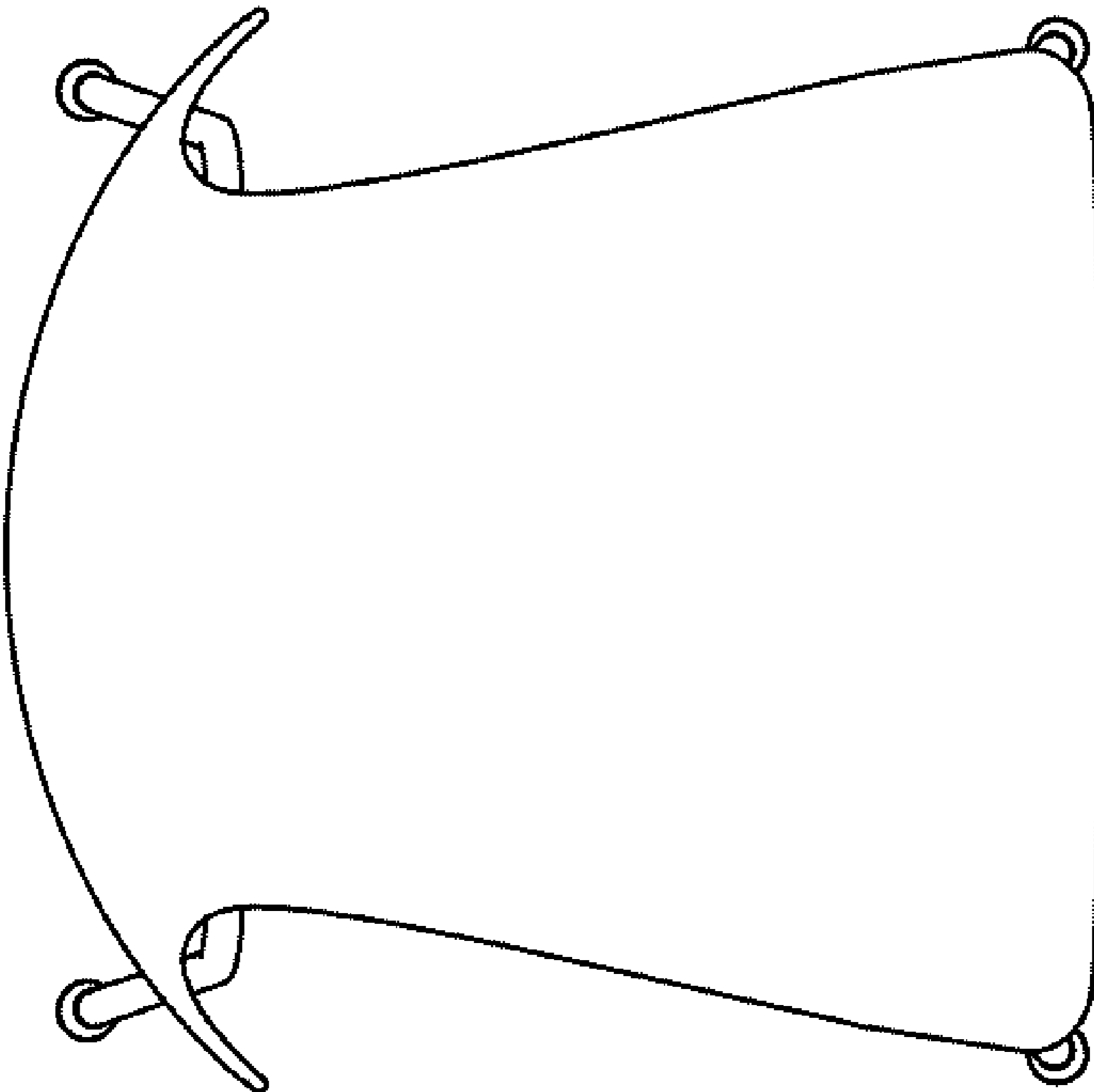

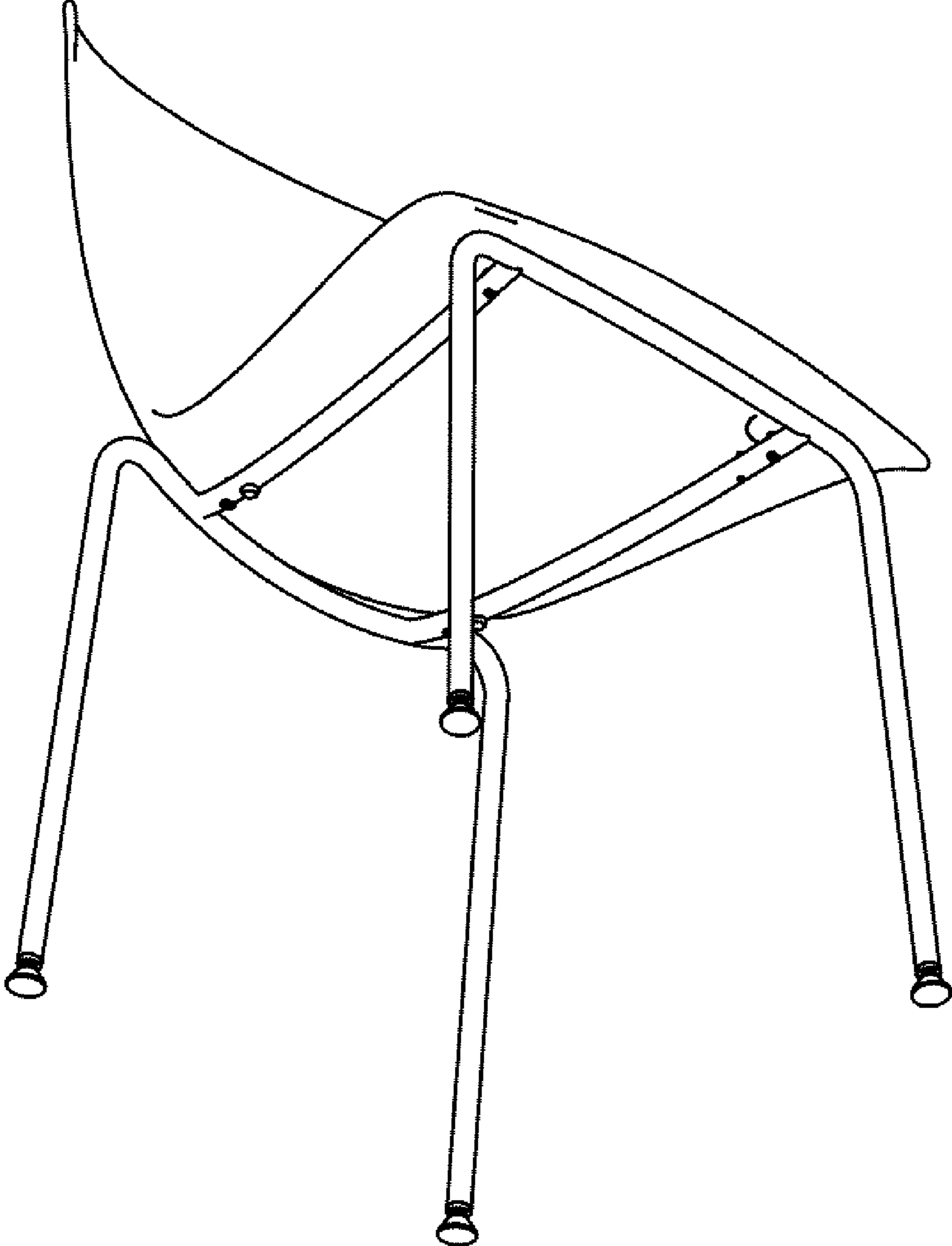

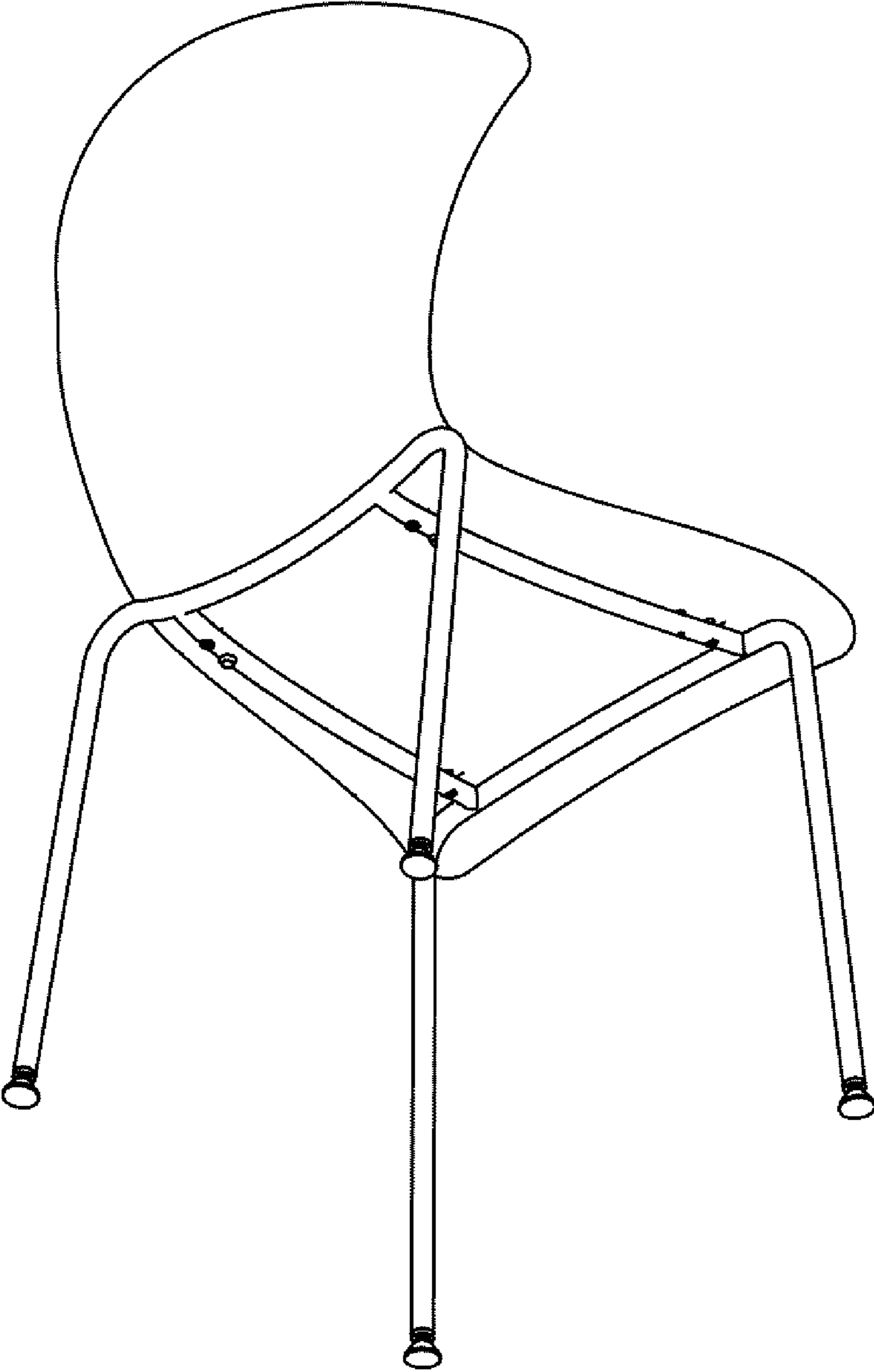

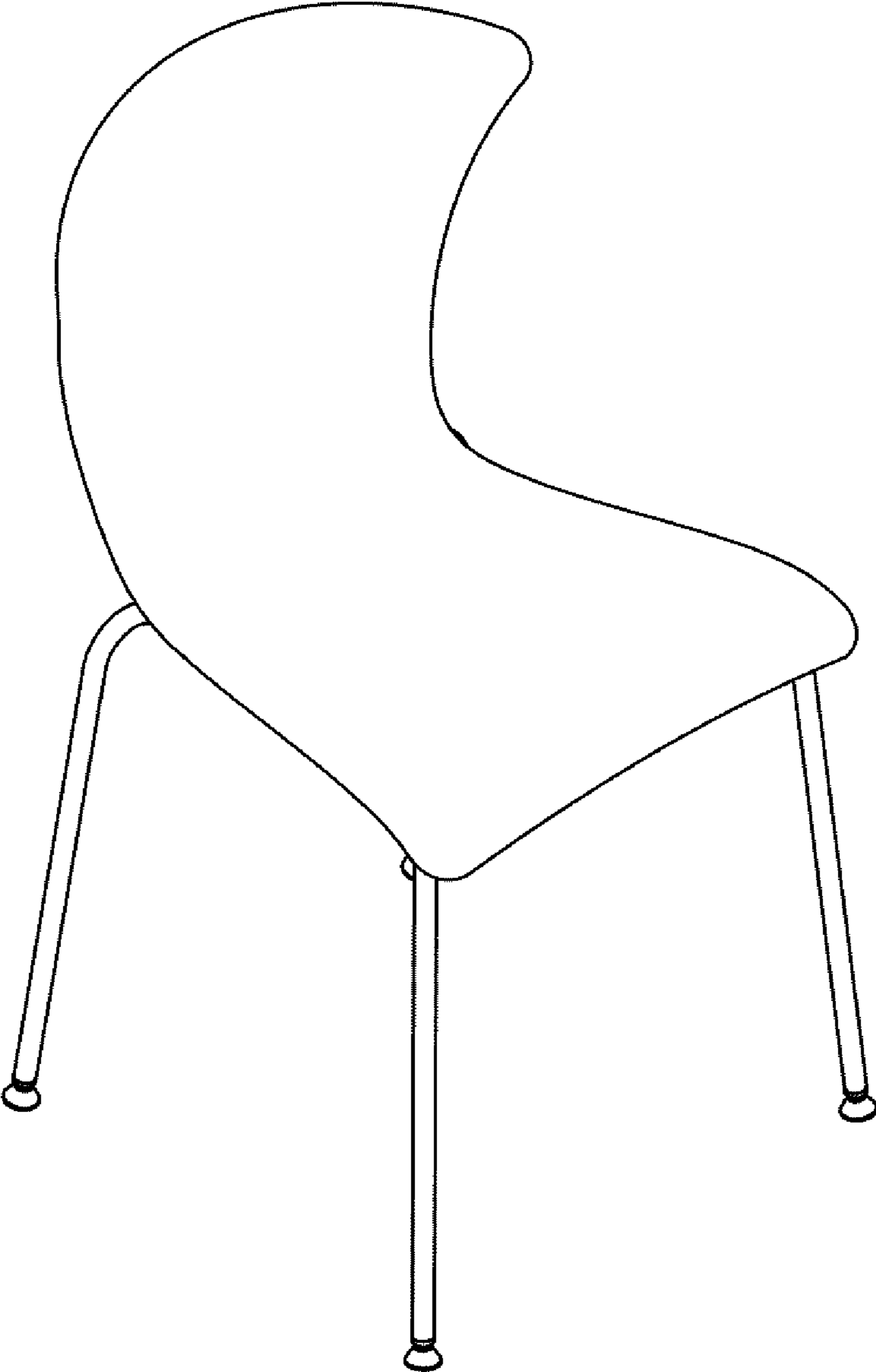

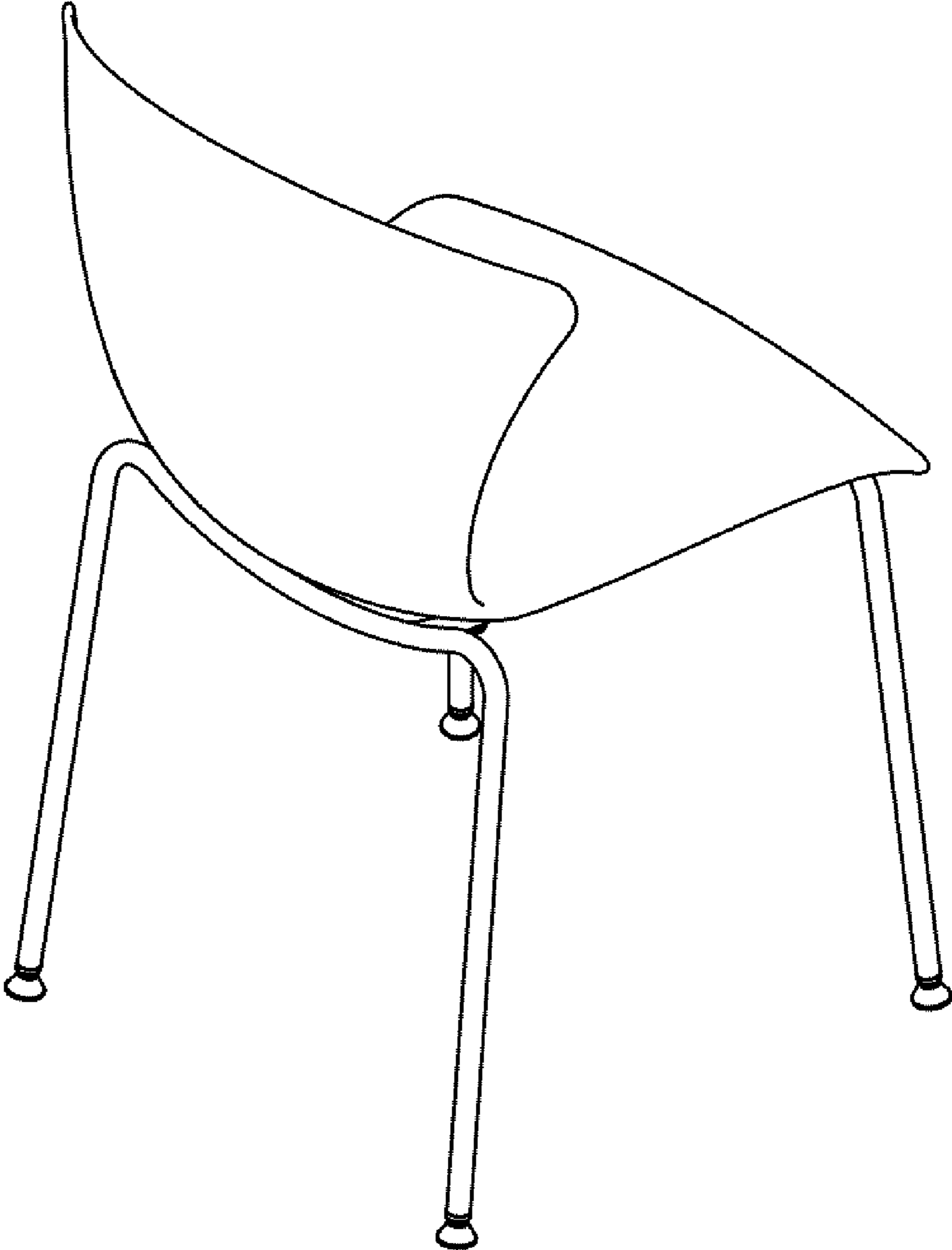

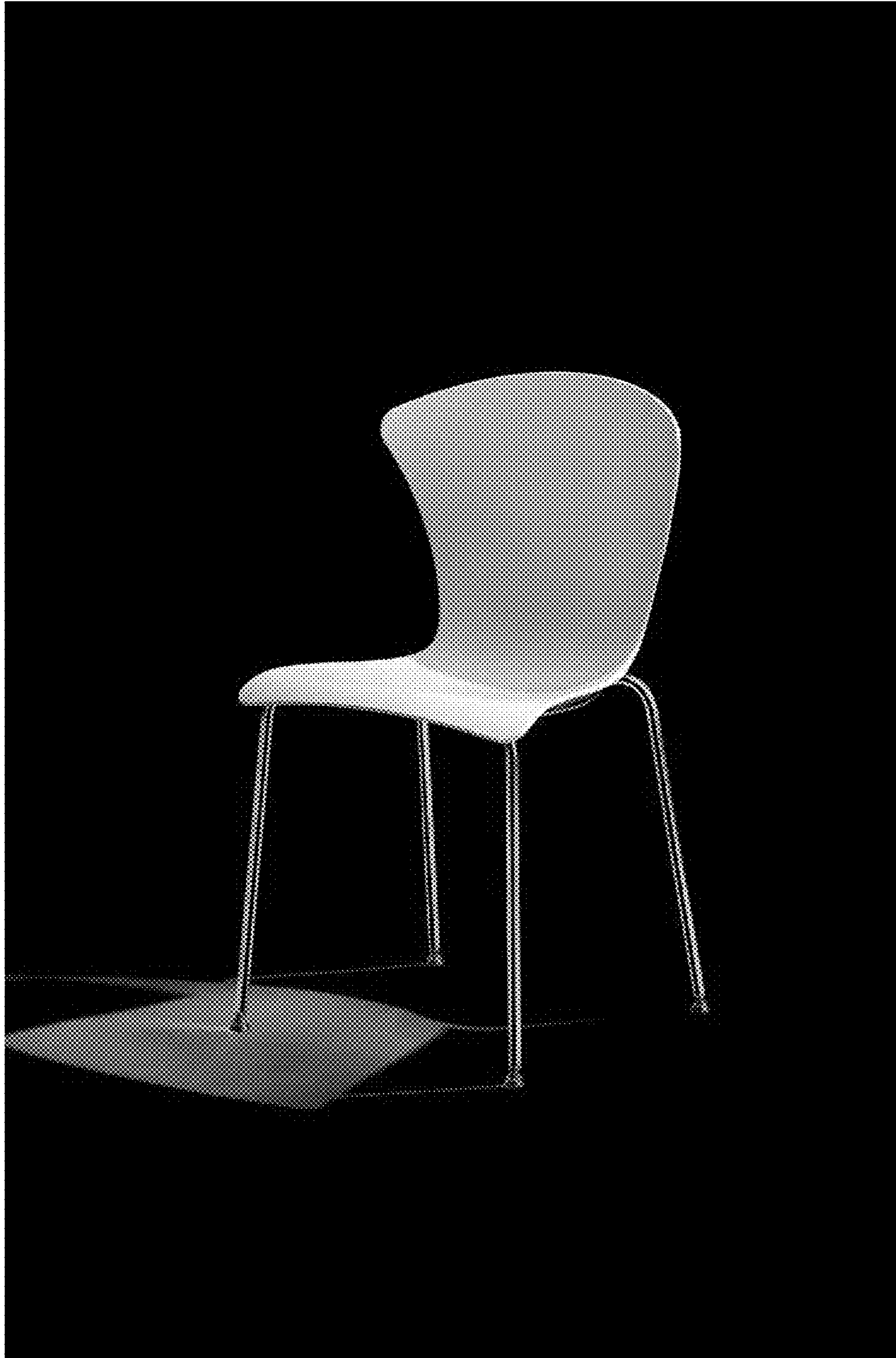
