(57) **CLAIM**

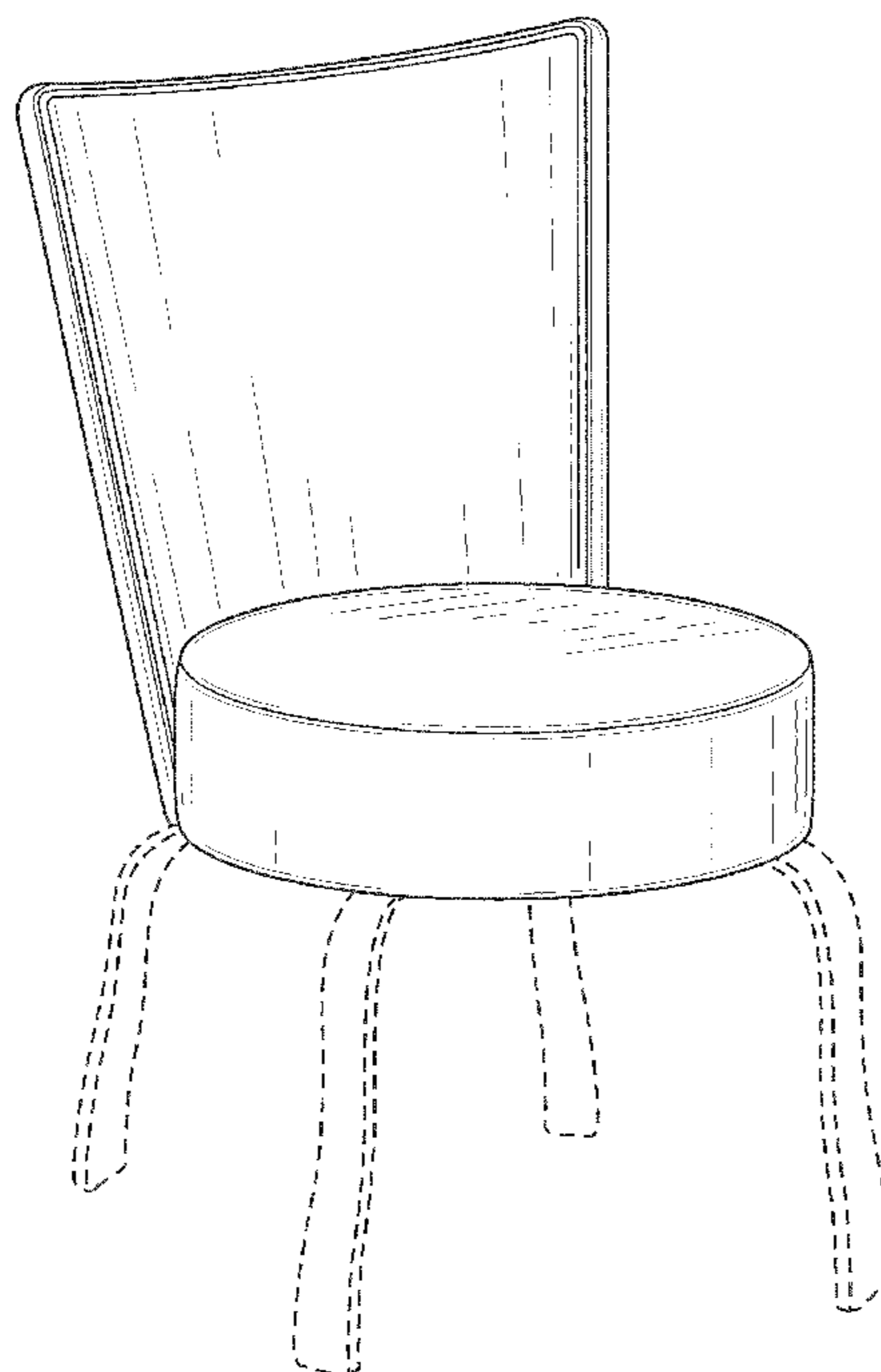
The ornamental design for a full backrest seat, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment full backrest seat, in accordance with the present invention; FIG. 2 is a front elevation view of the full backrest seat shown in FIG. 1; FIG. 3 is a back elevation view of the full backrest seat shown in FIG. 1; FIG. 4 is a left side elevation view of the full backrest seat shown in FIG. 1; FIG. 5 is a right side elevation view of the full backrest seat shown in FIG. 1; and, FIG. 6 is a top plan view of the full backrest seat as shown in FIG. 1.

The broken lines shown in the drawings are for illustrative purposes and form no part of the claimed design.

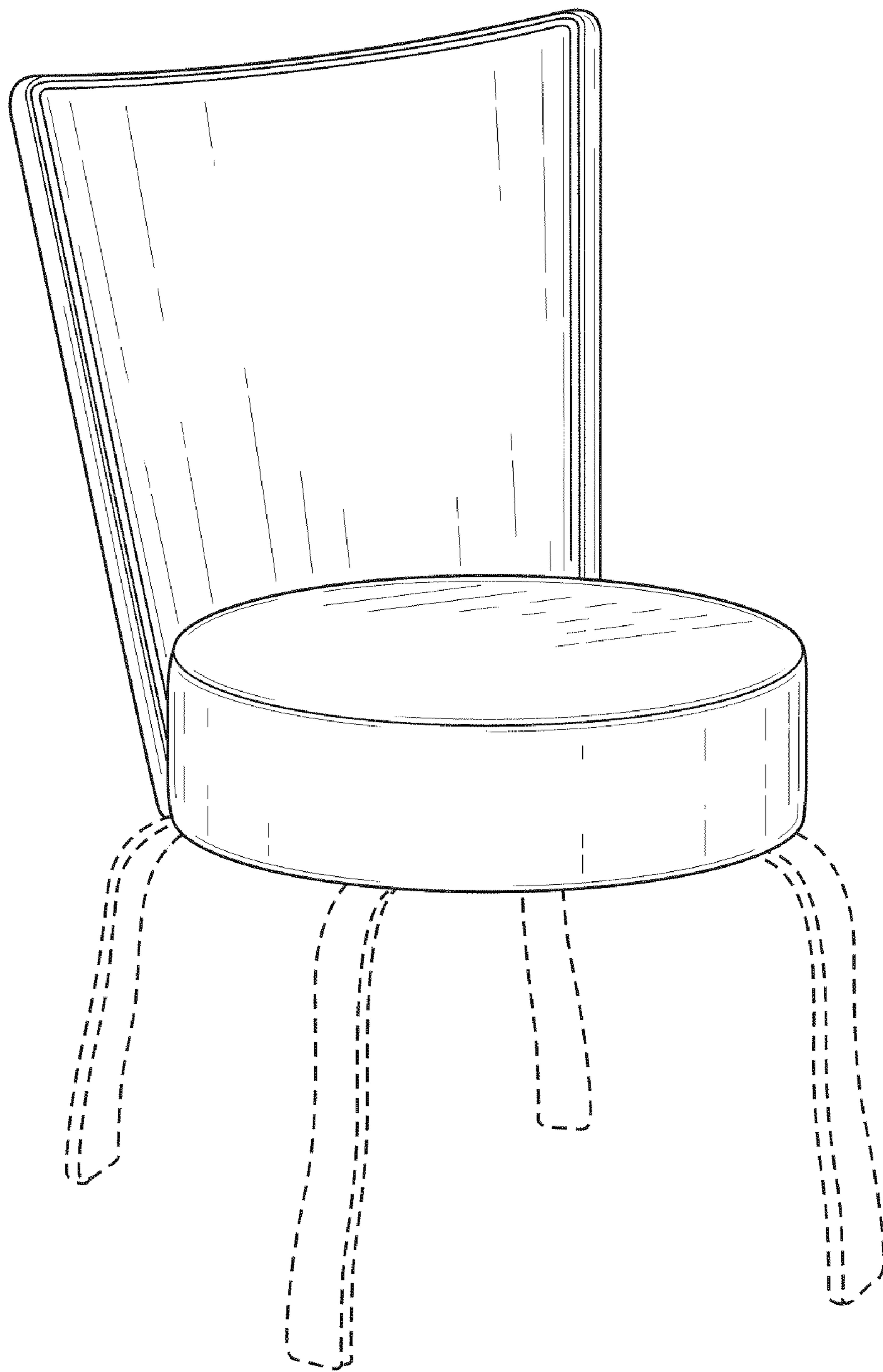

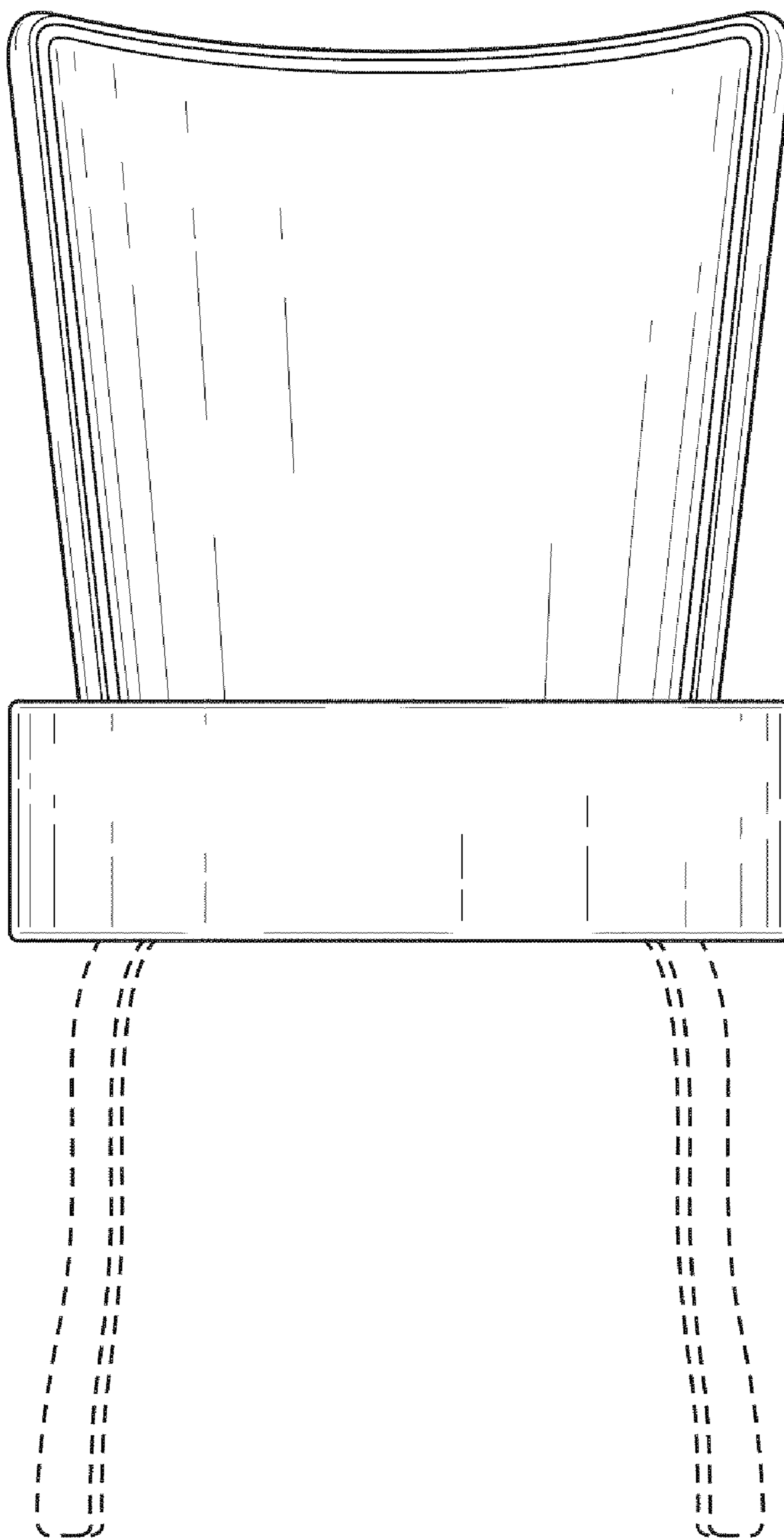

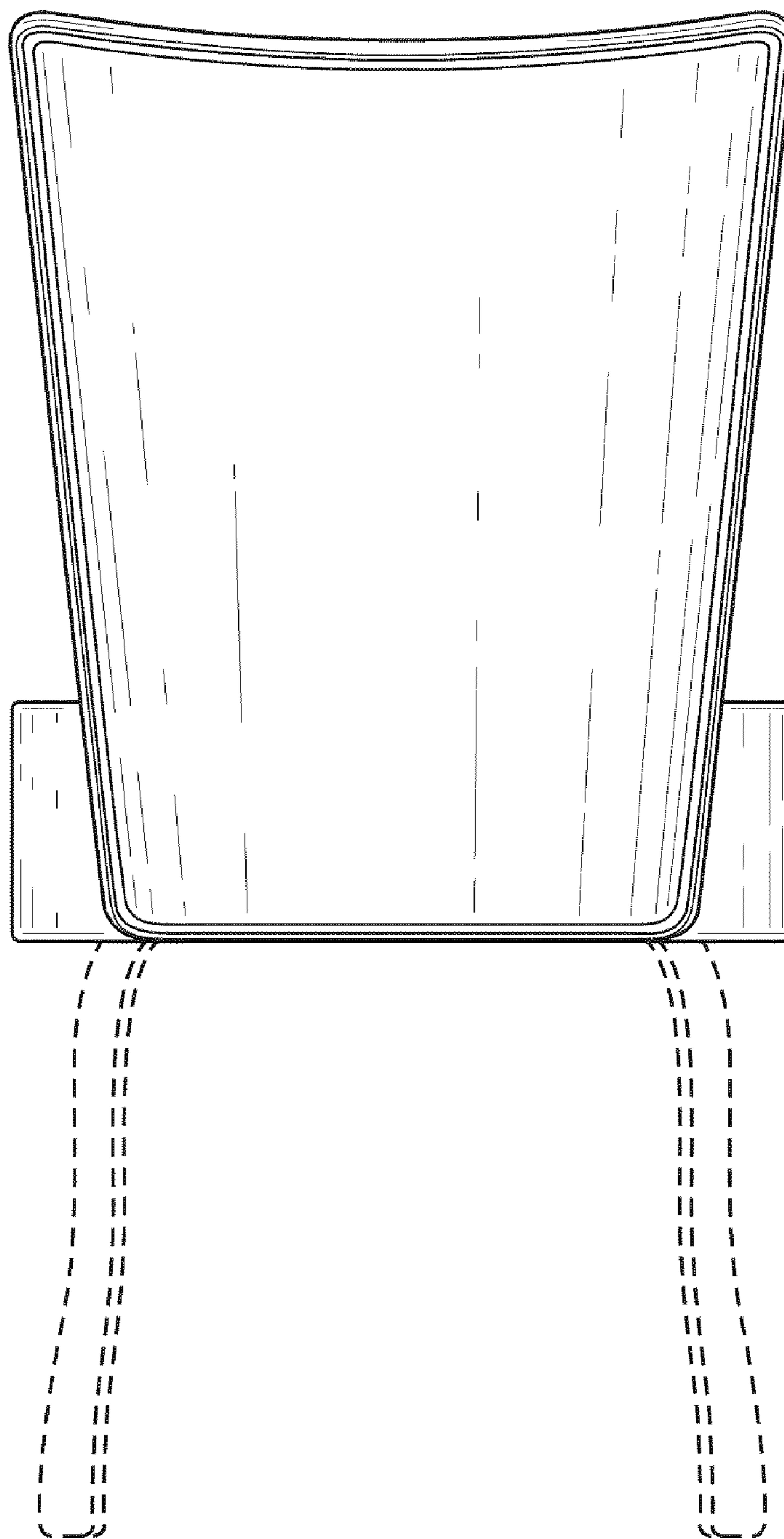

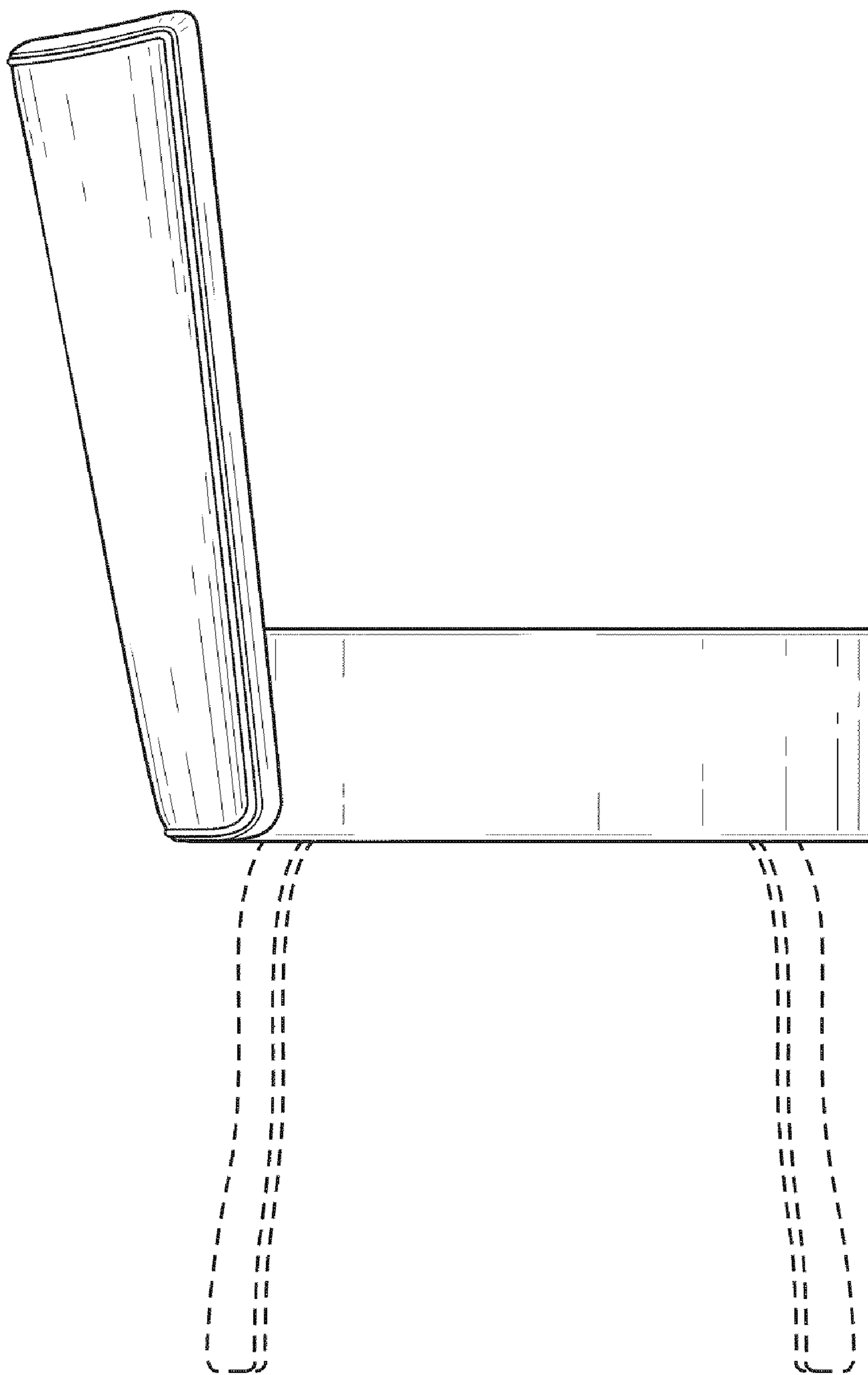

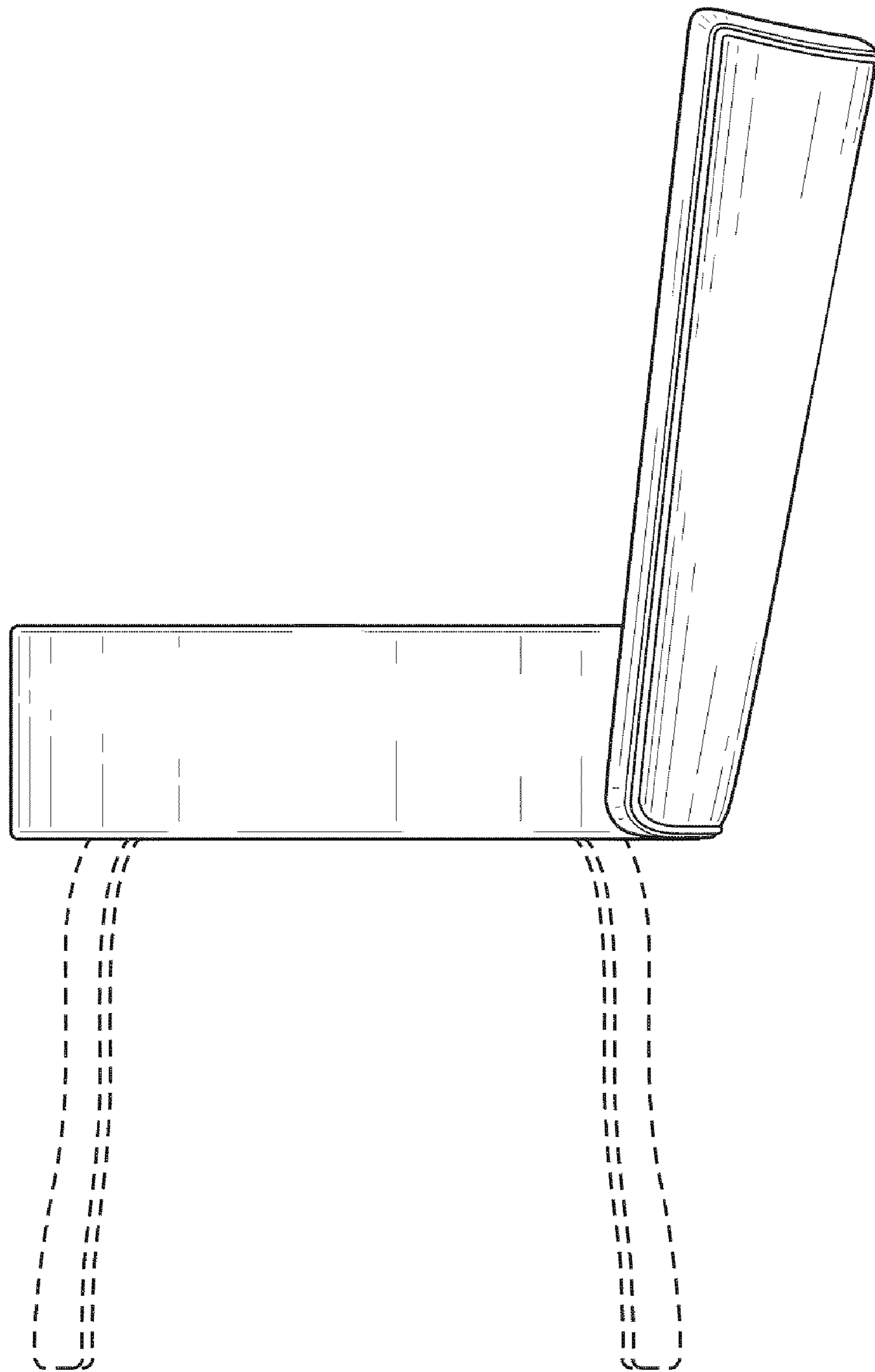

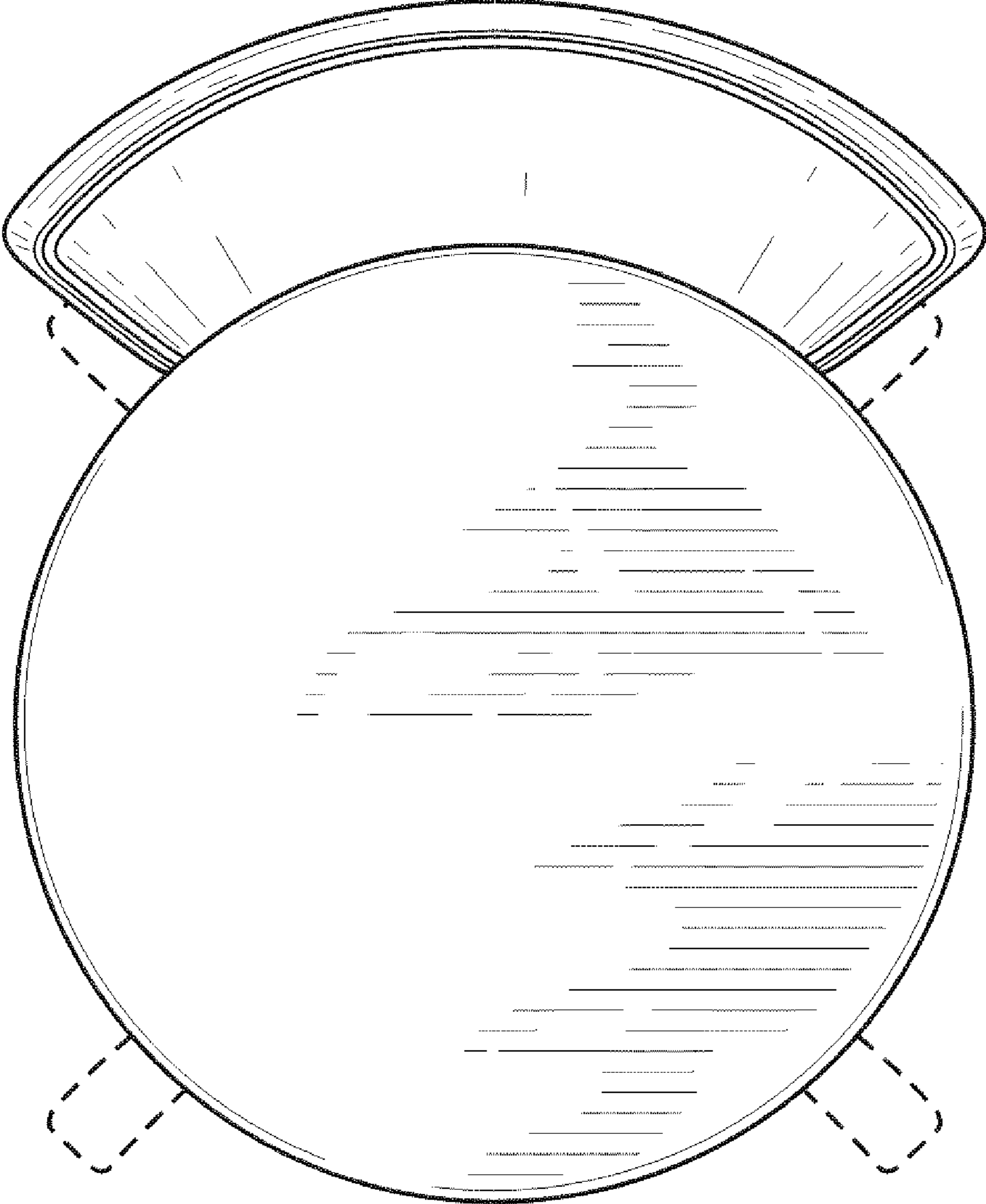
