FIG. 3 is a right side view of the dog treat waffle iron showing the design.

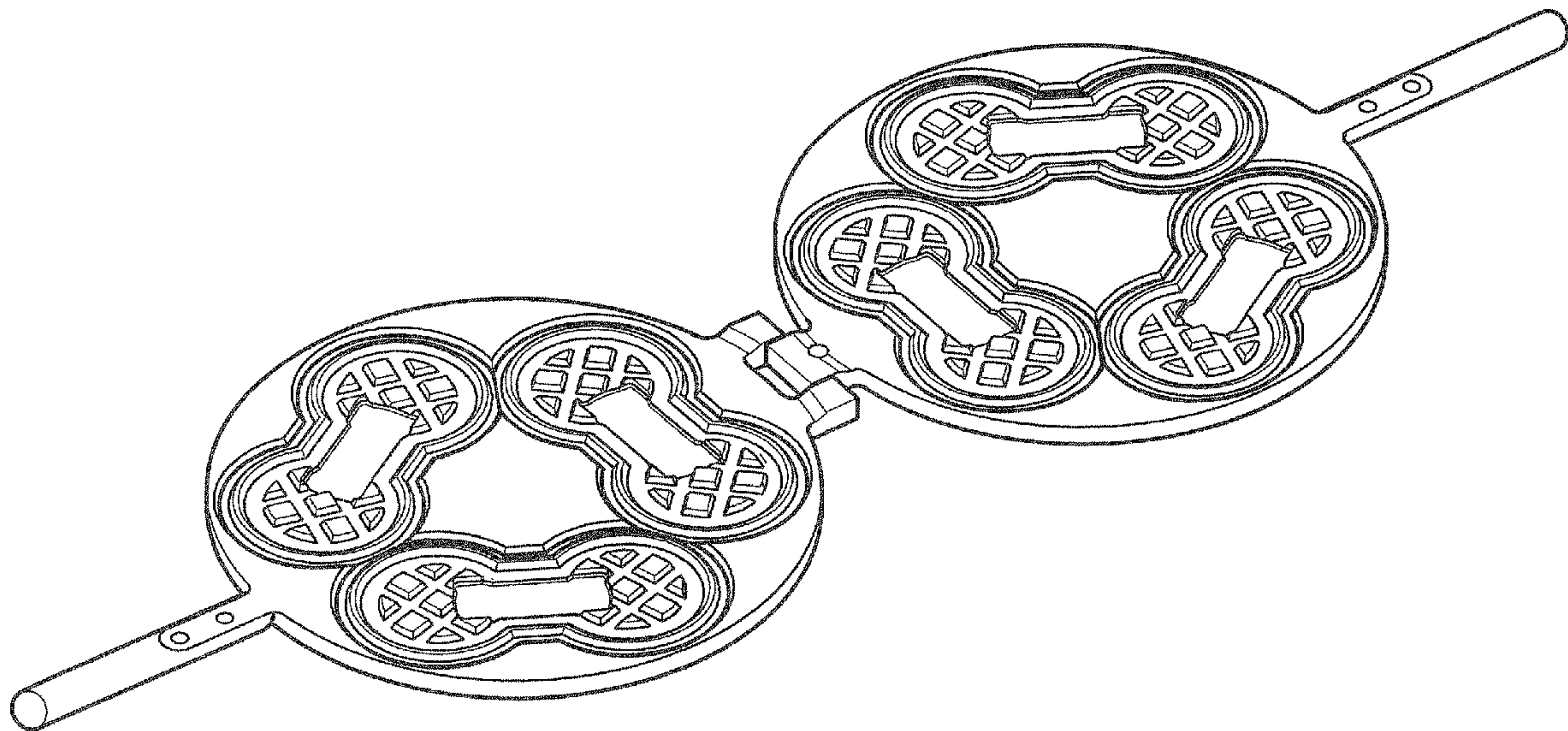
FIG. 4 is a front view of the dog treat waffle iron showing the design;

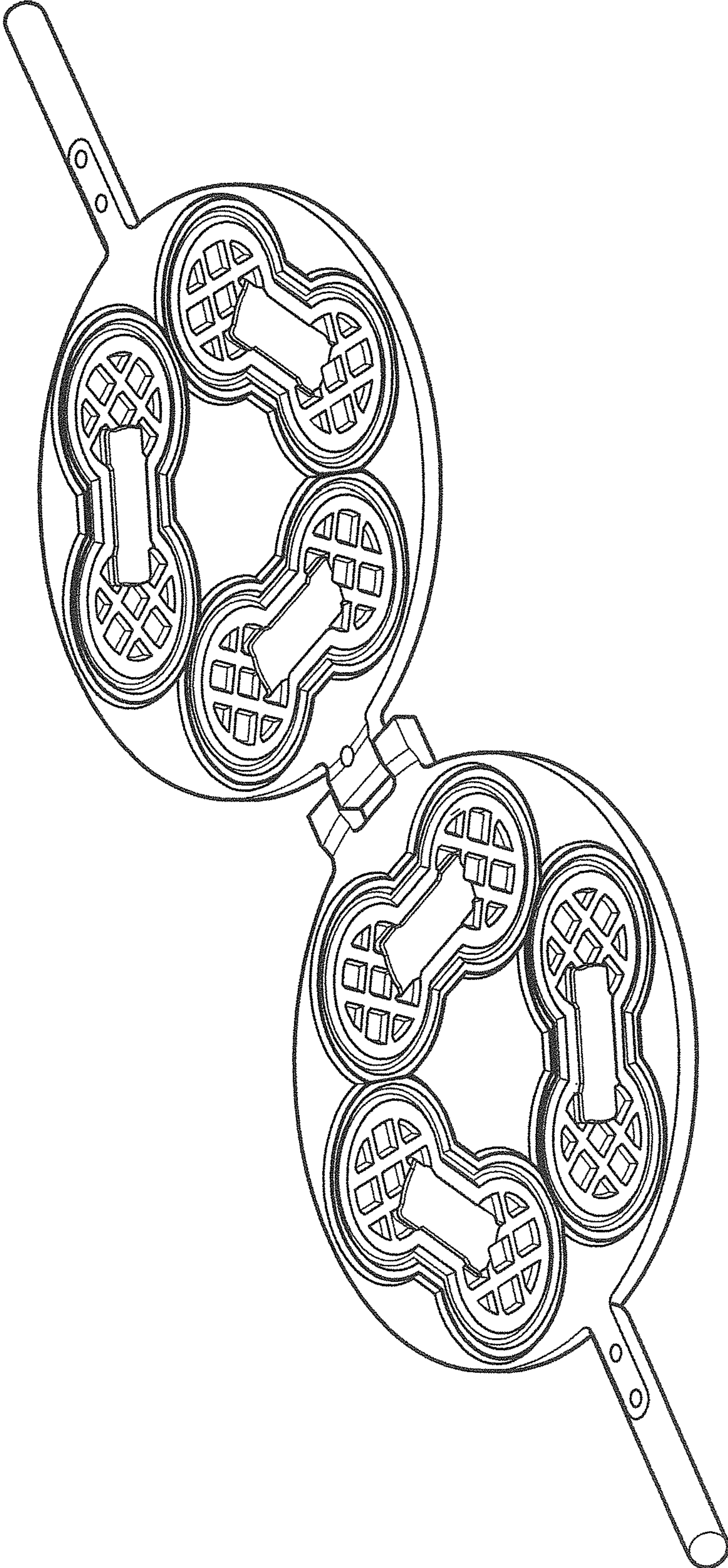

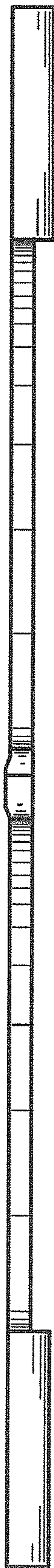

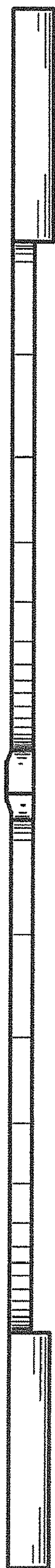

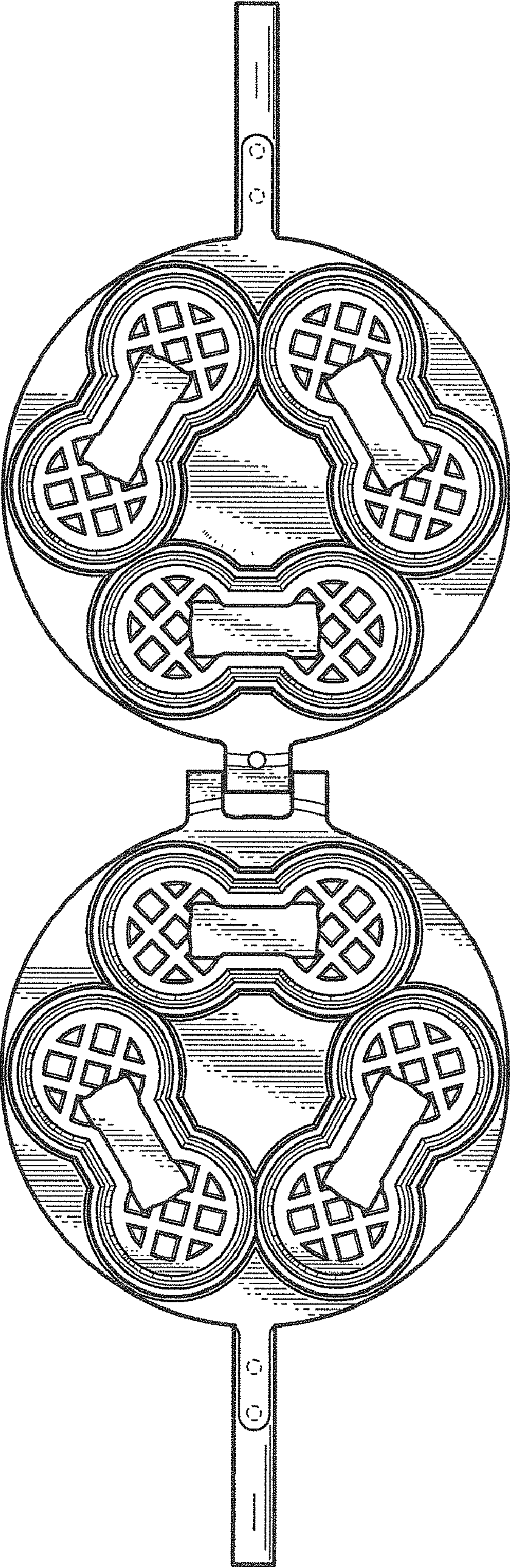

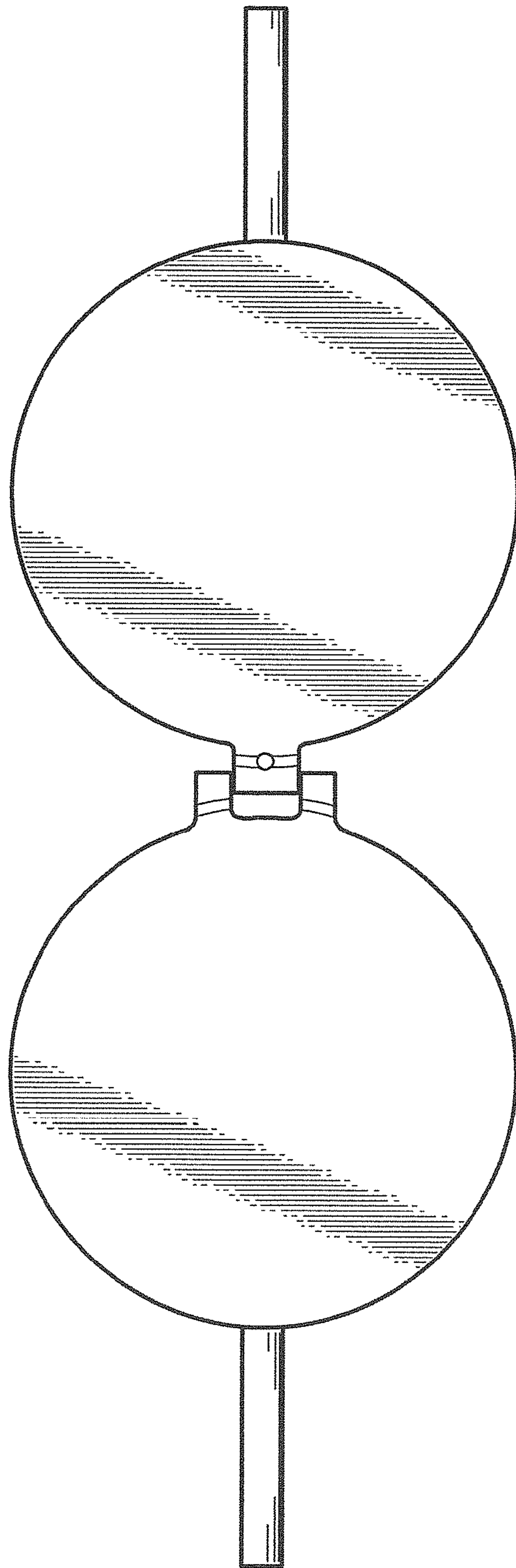
