DESCRIPTION

FIG. 1 is a front perspective view of a sandwich turner showing my new design.

FIG. 4 is a right side elevational view thereof.

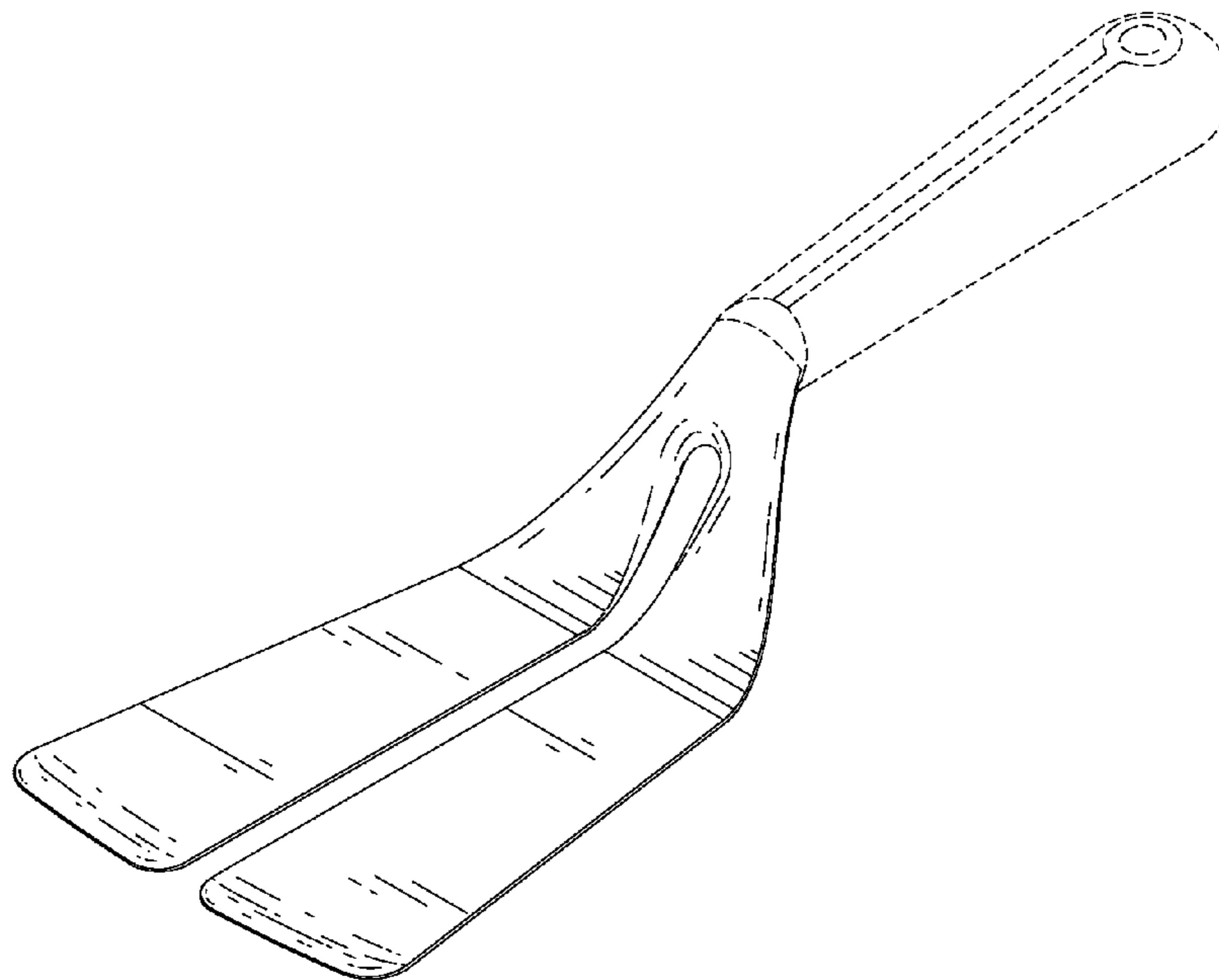
FIG. 5 is a left side elevational view thereof.

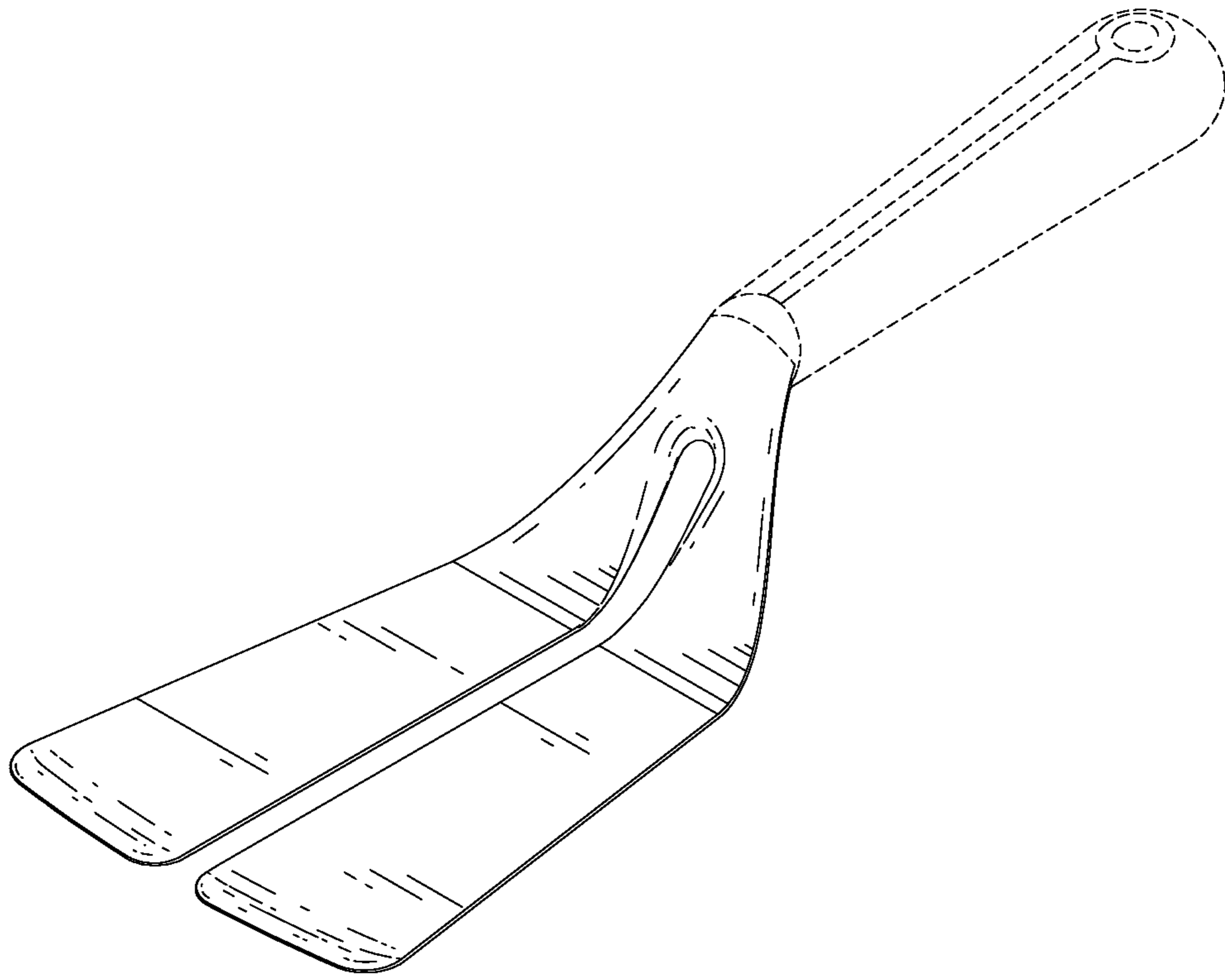

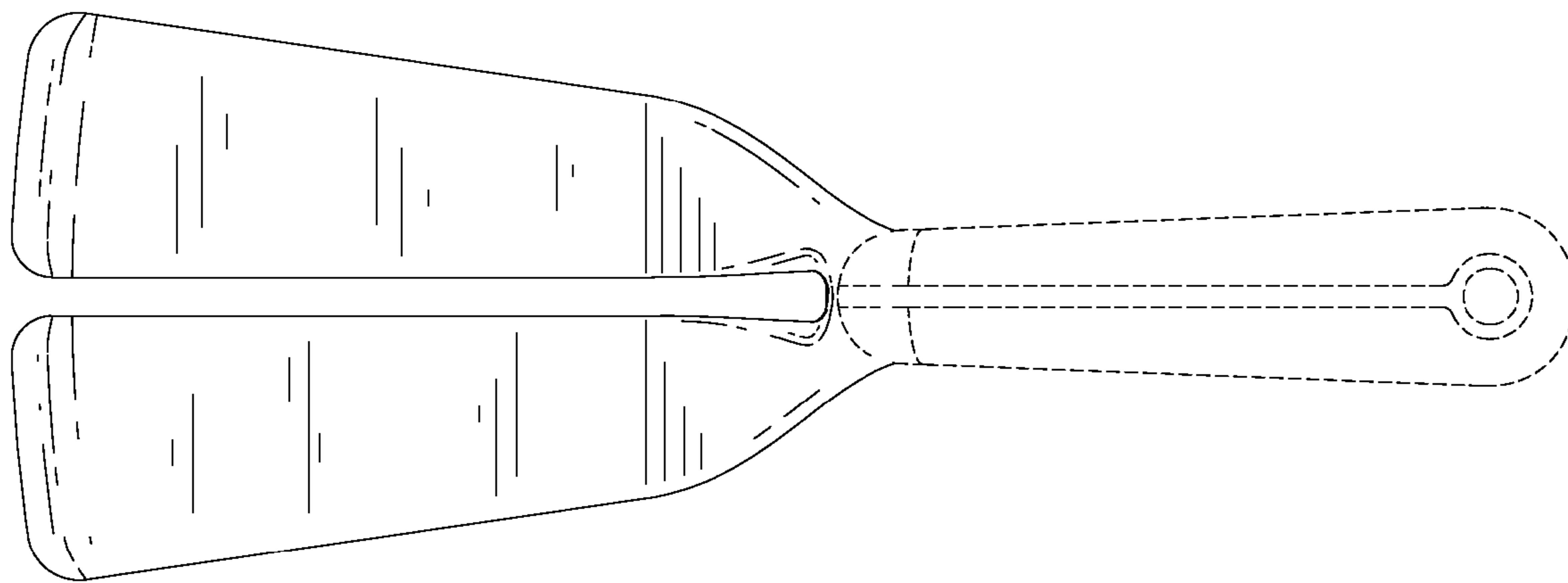

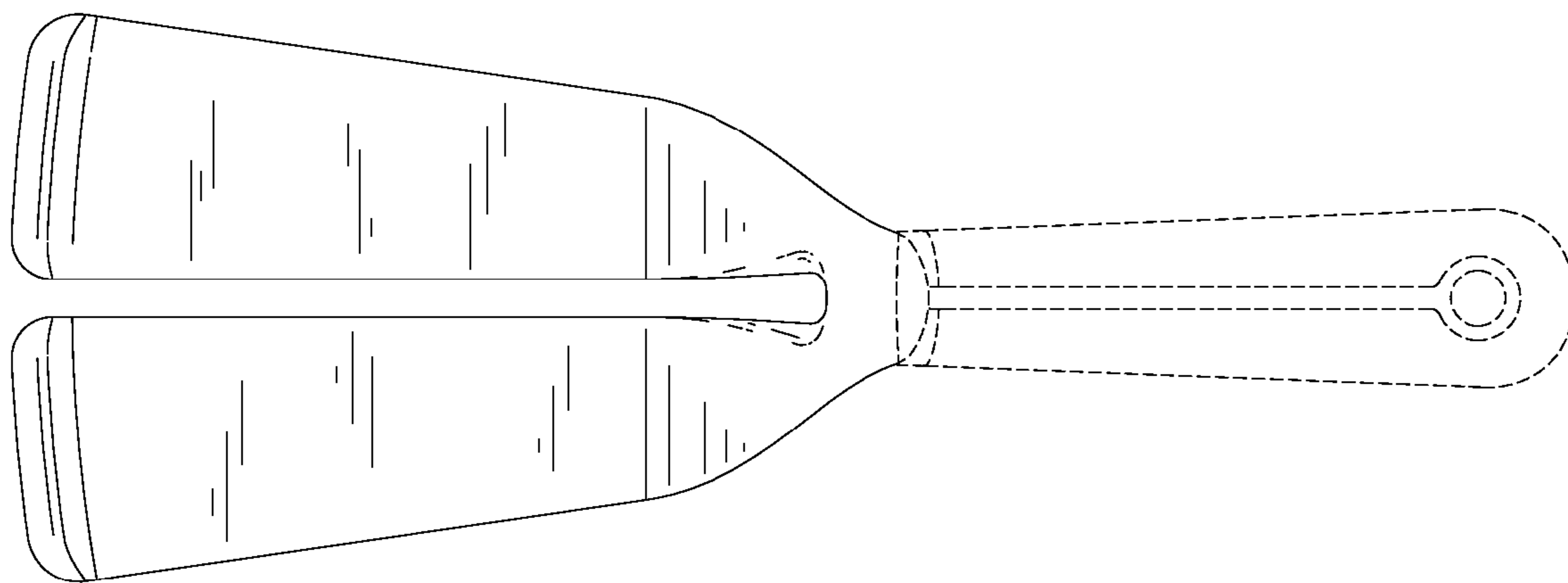

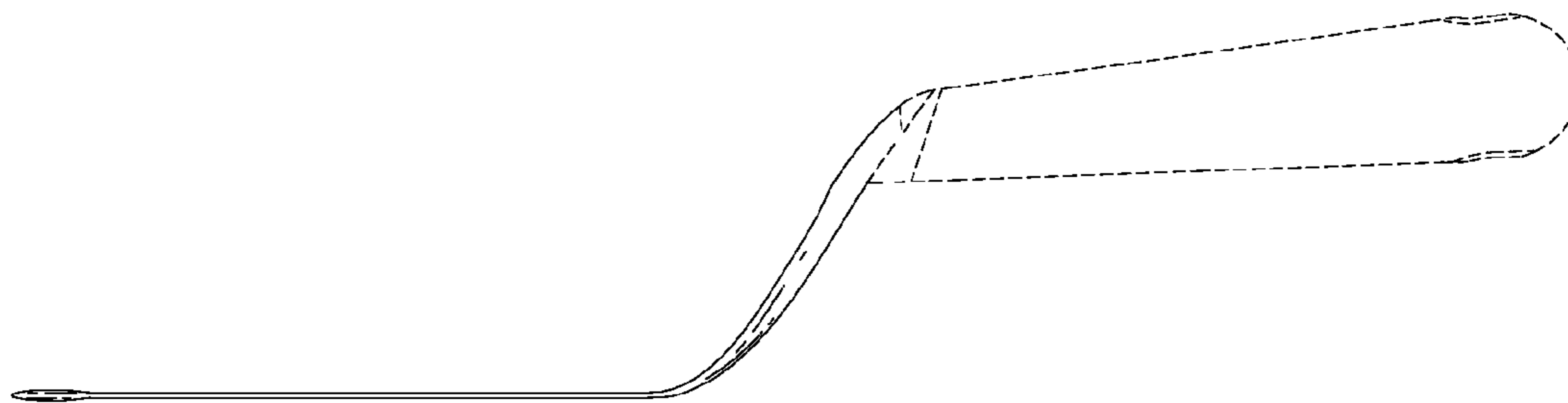

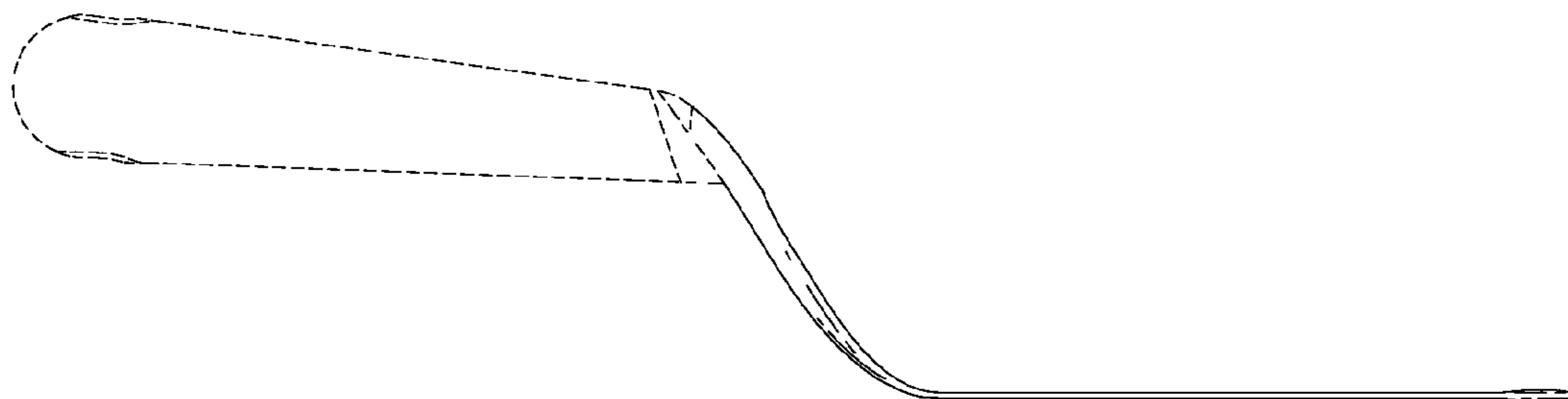

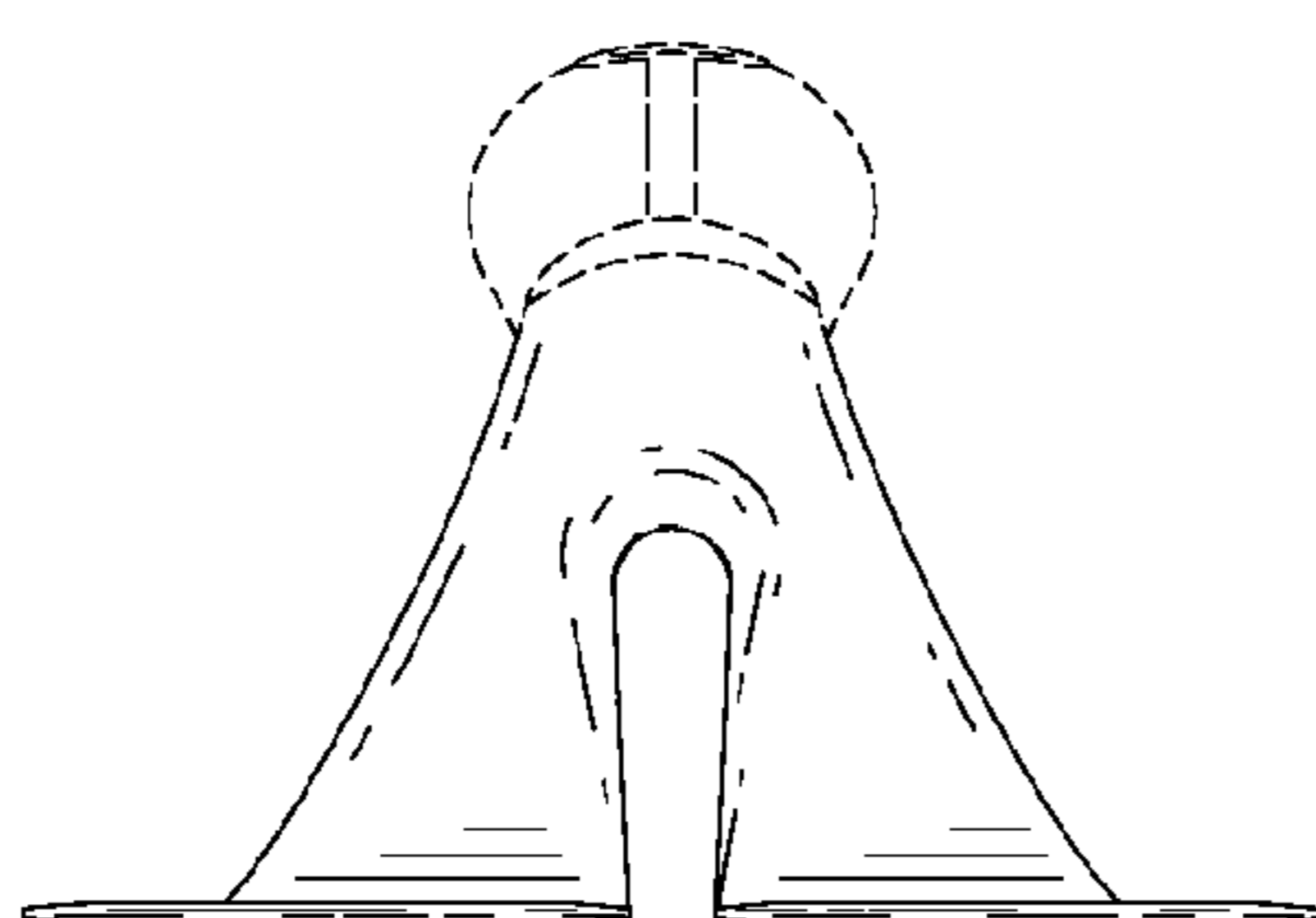

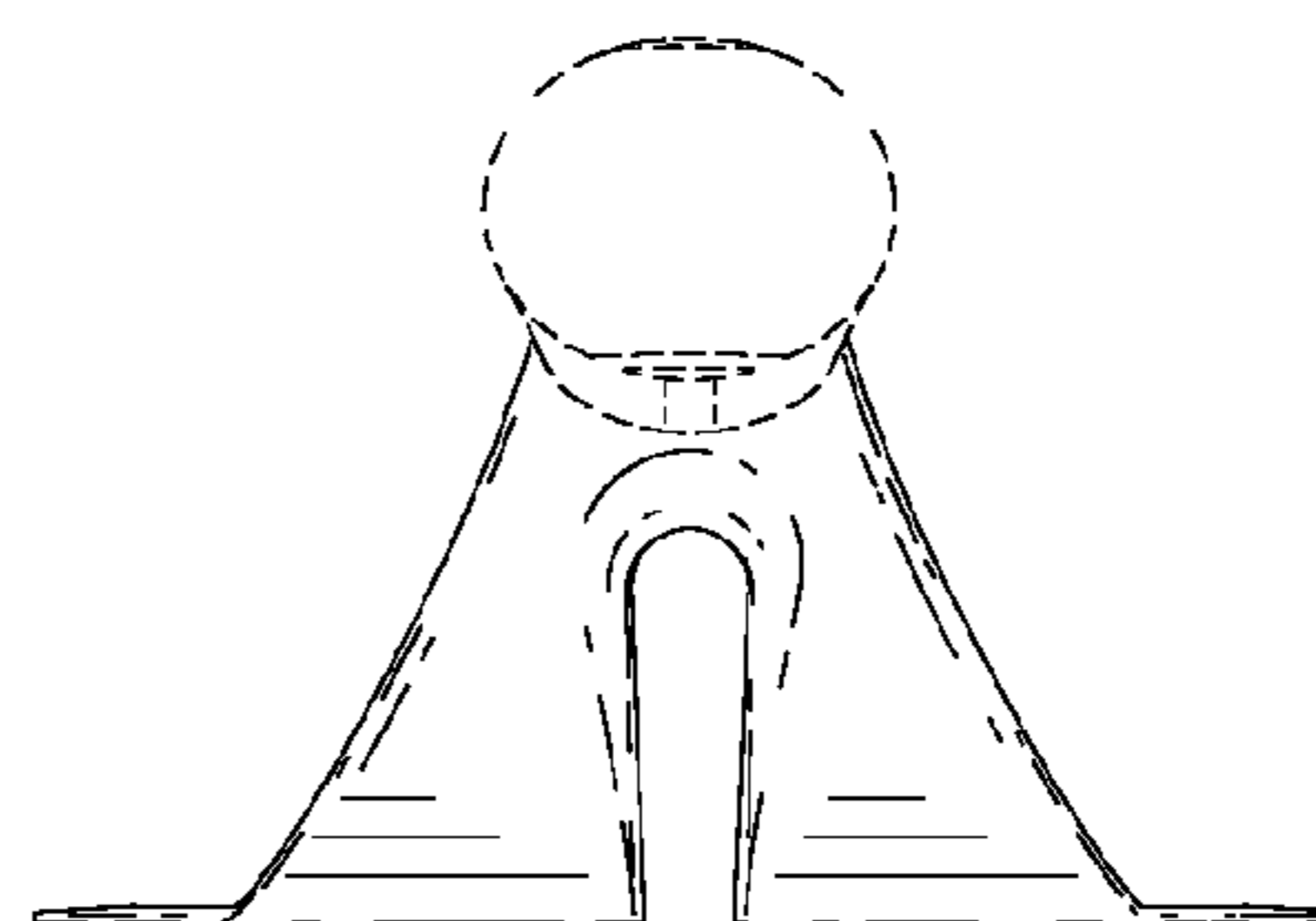
