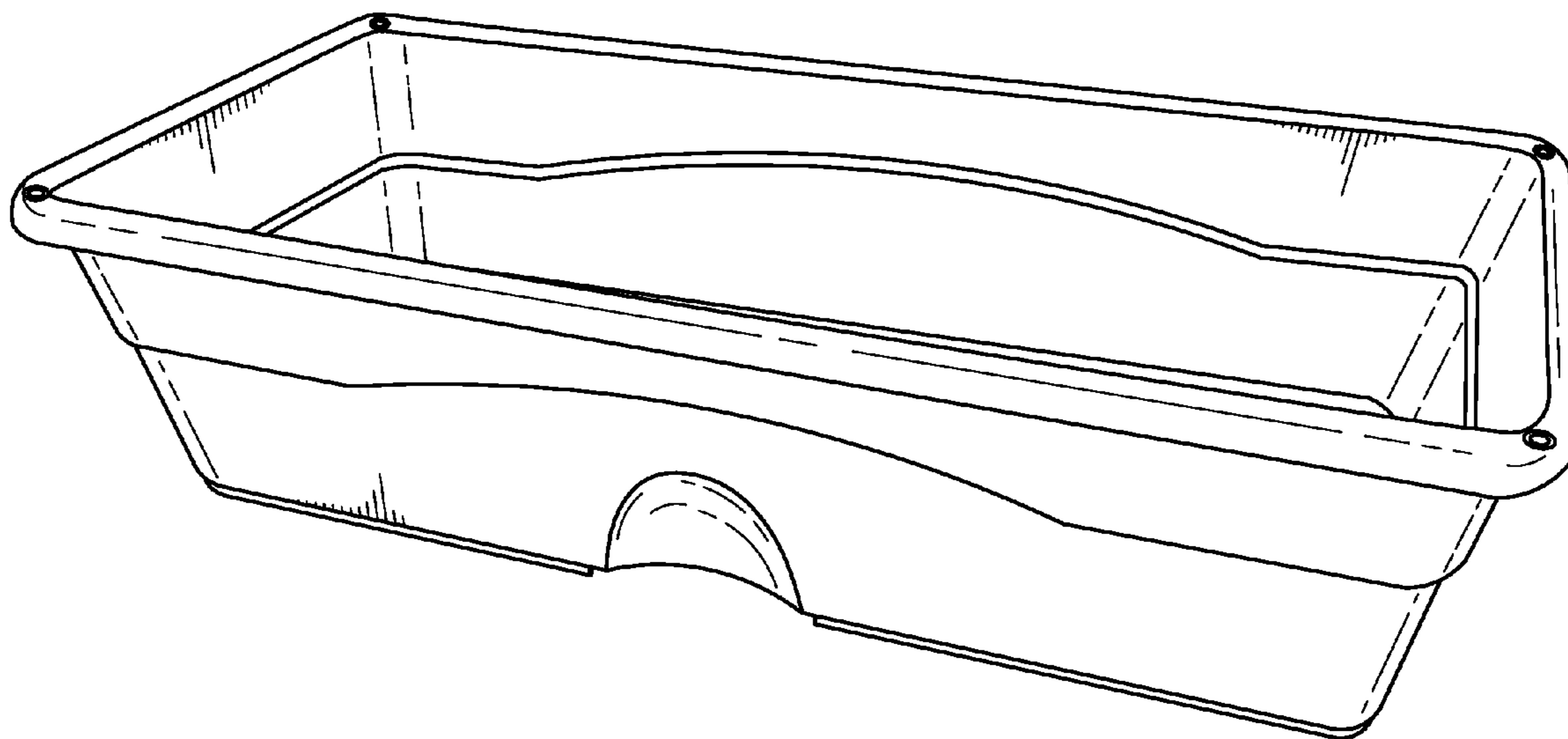
The ornamental design for a self-watering planter, as shown and described.

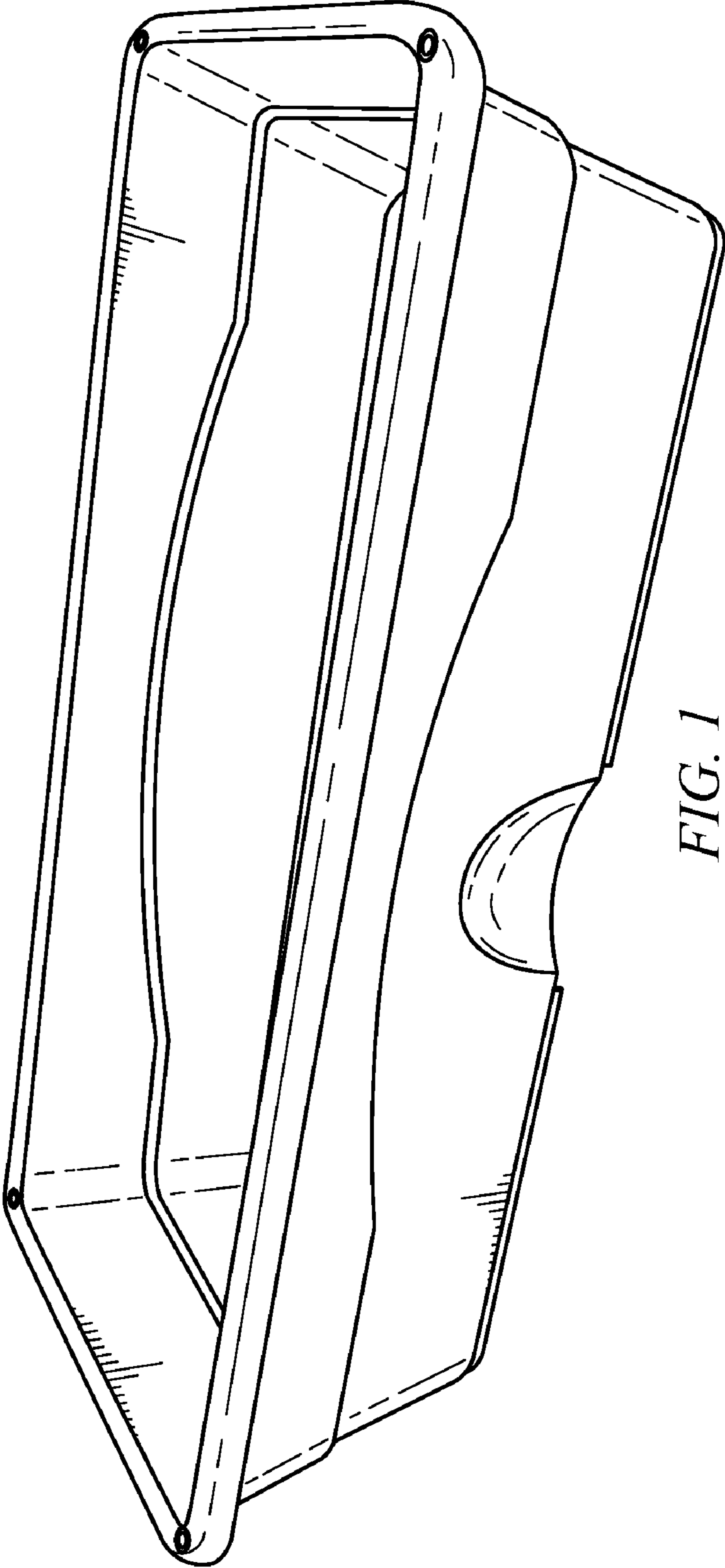

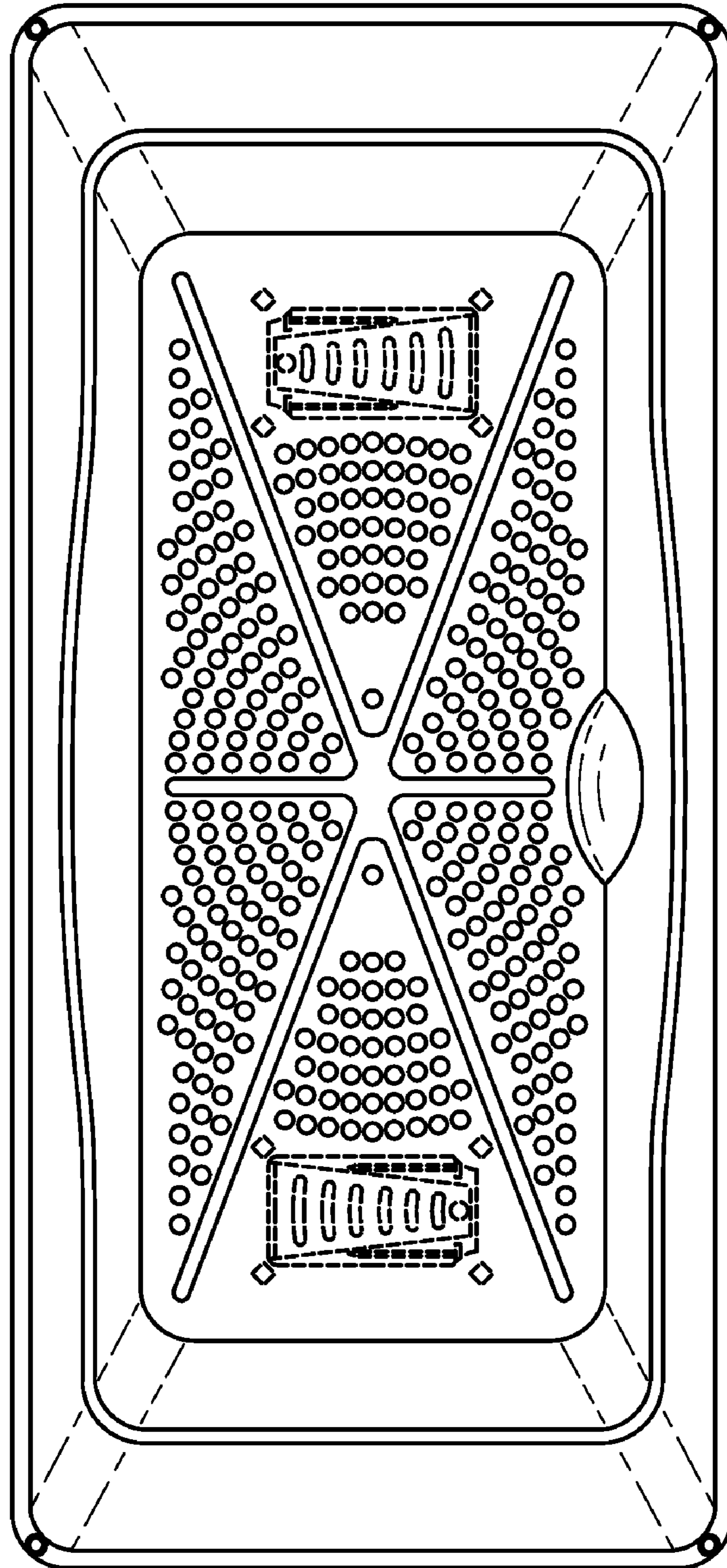

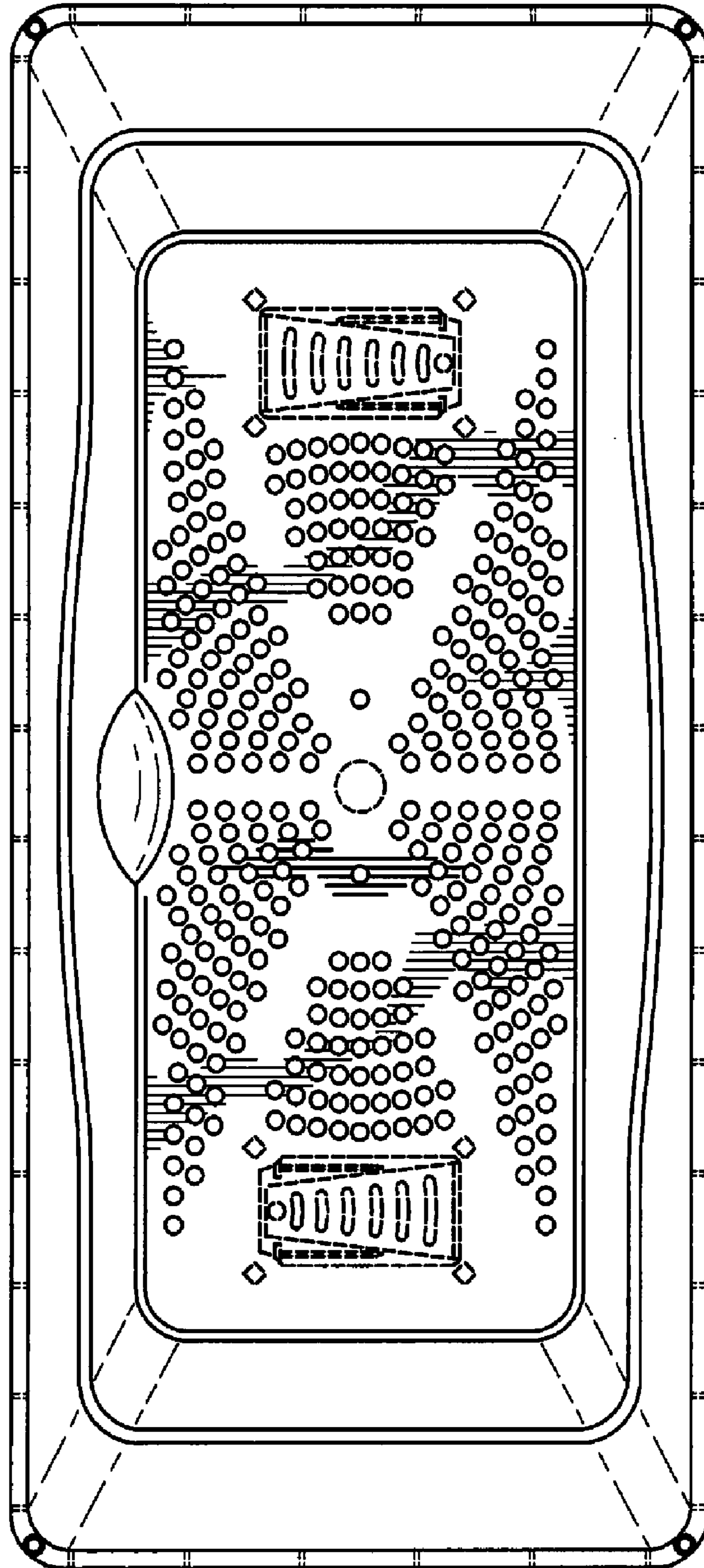

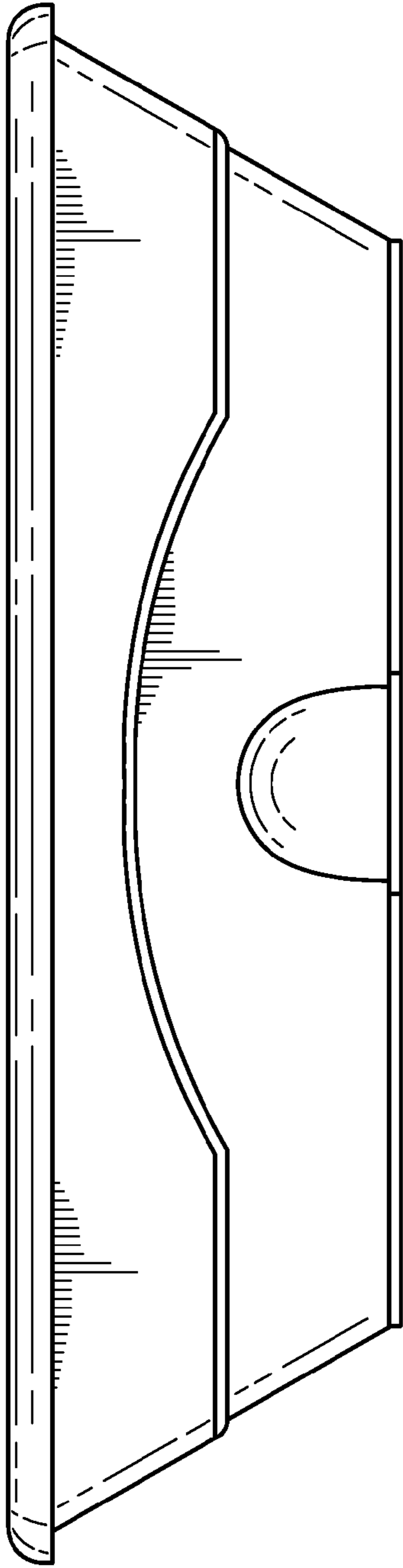

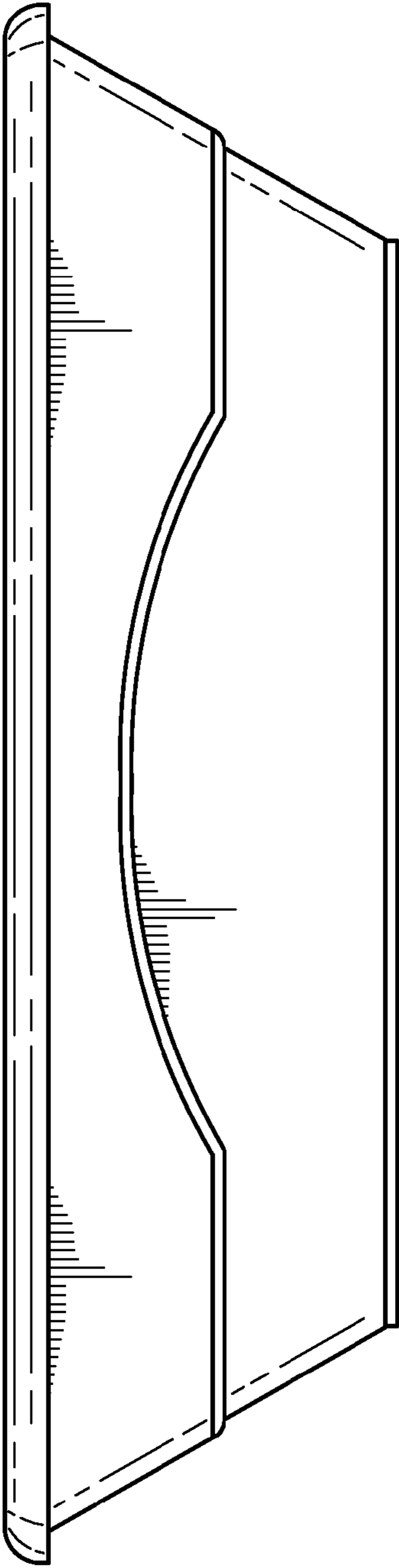

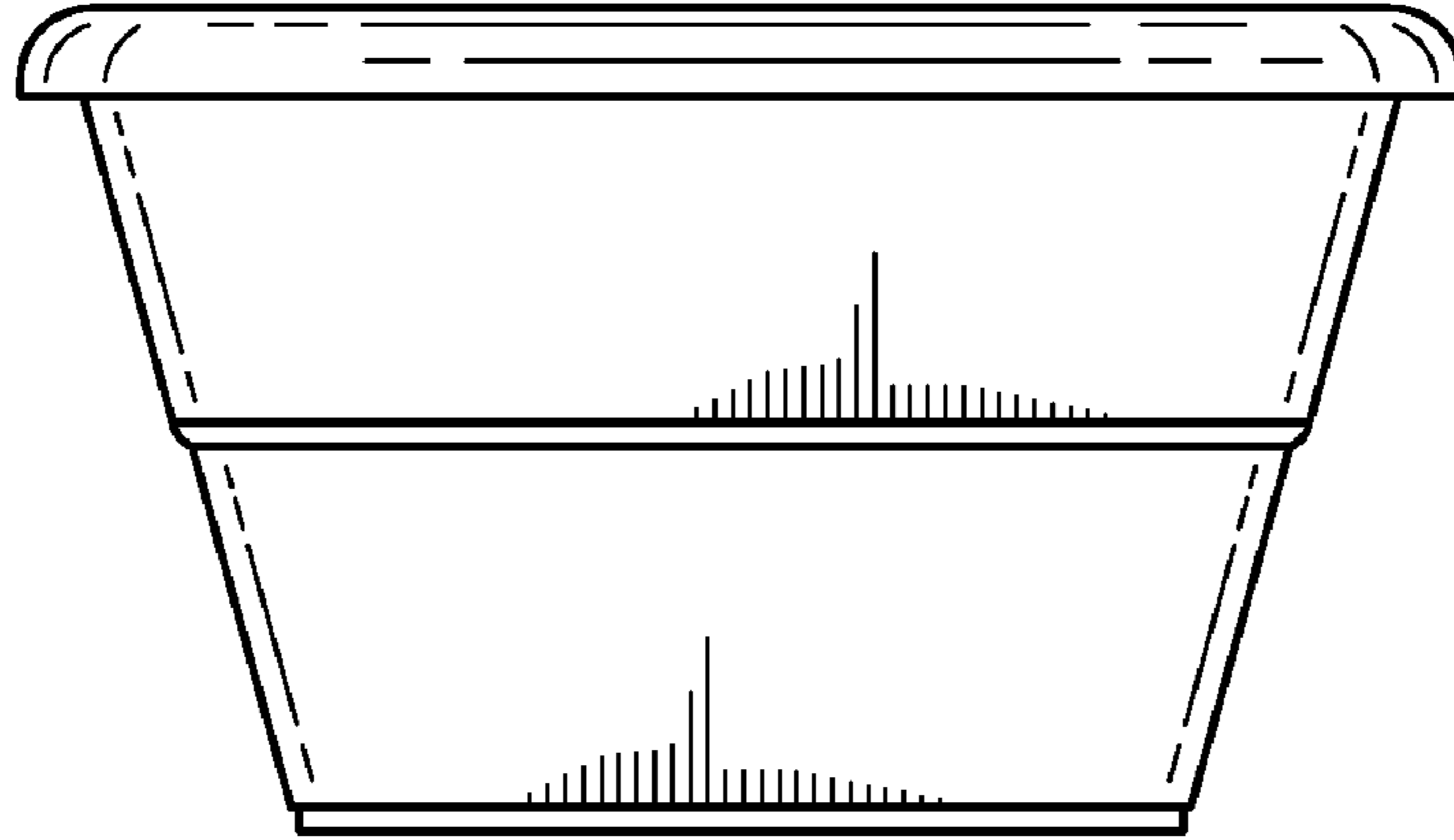

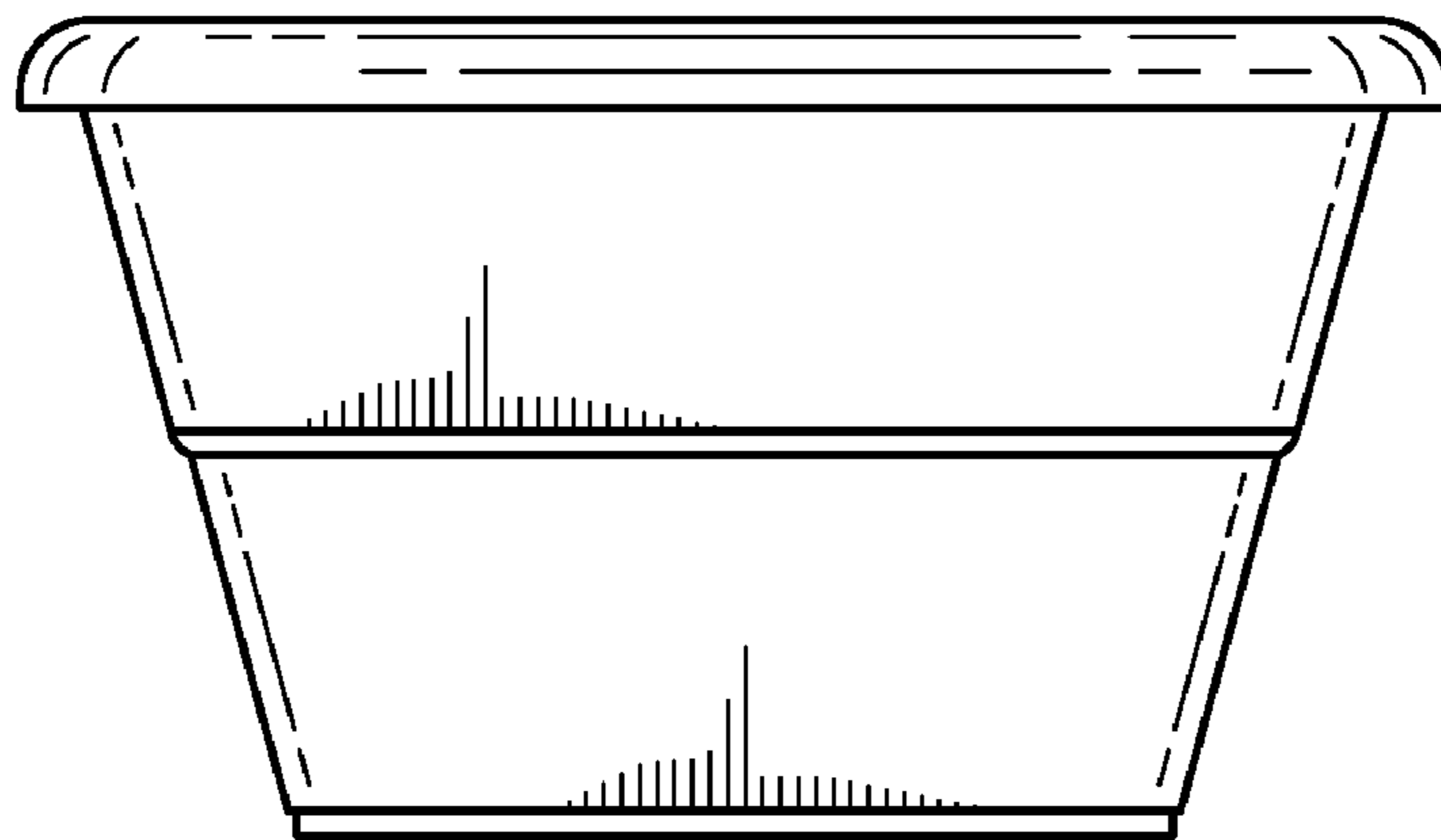
