The ornamental design for a boat ski tower with adjustable legs, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a boat ski tower with adjustable legs, showing the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

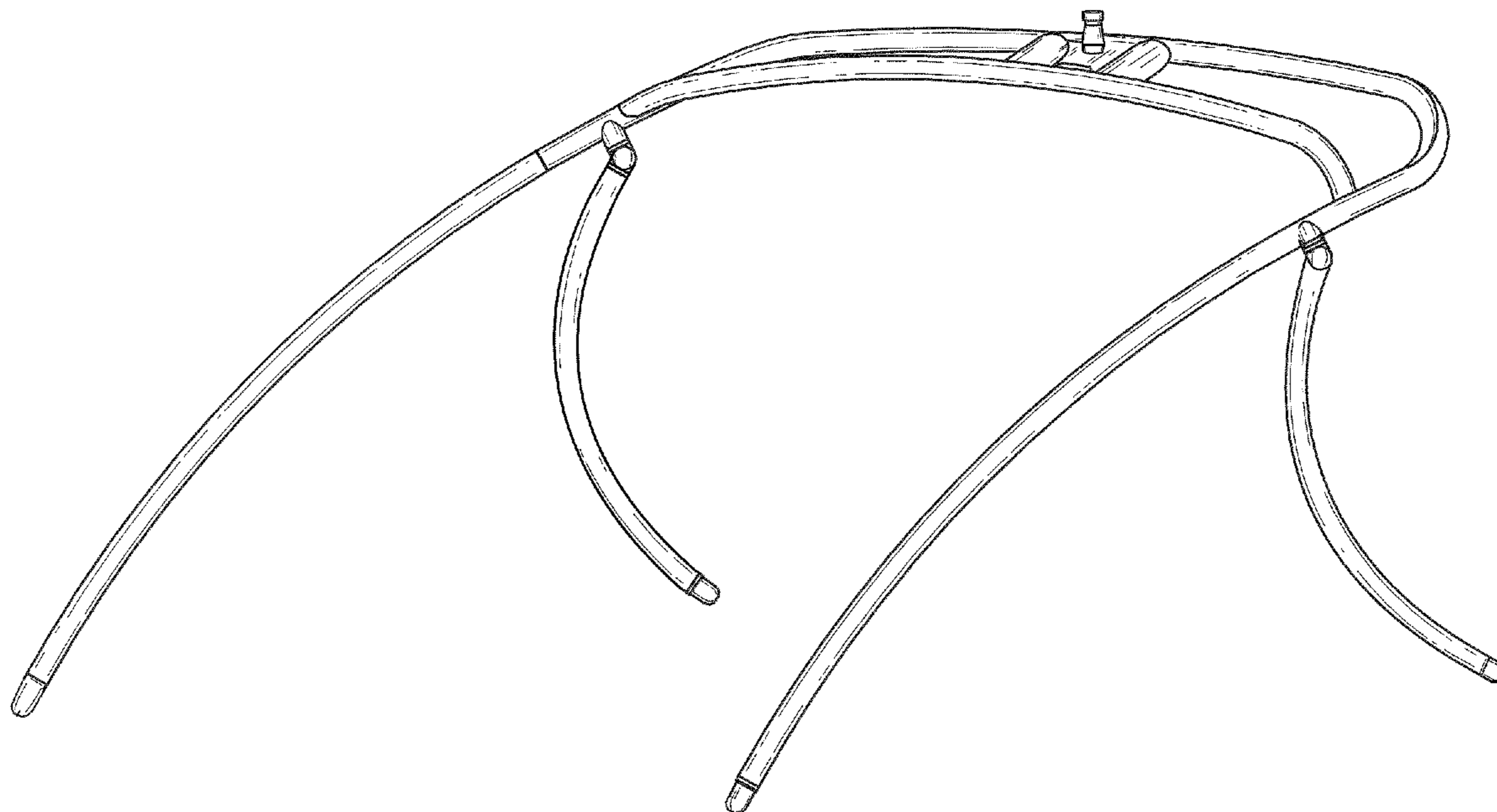
FIG. 4 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;

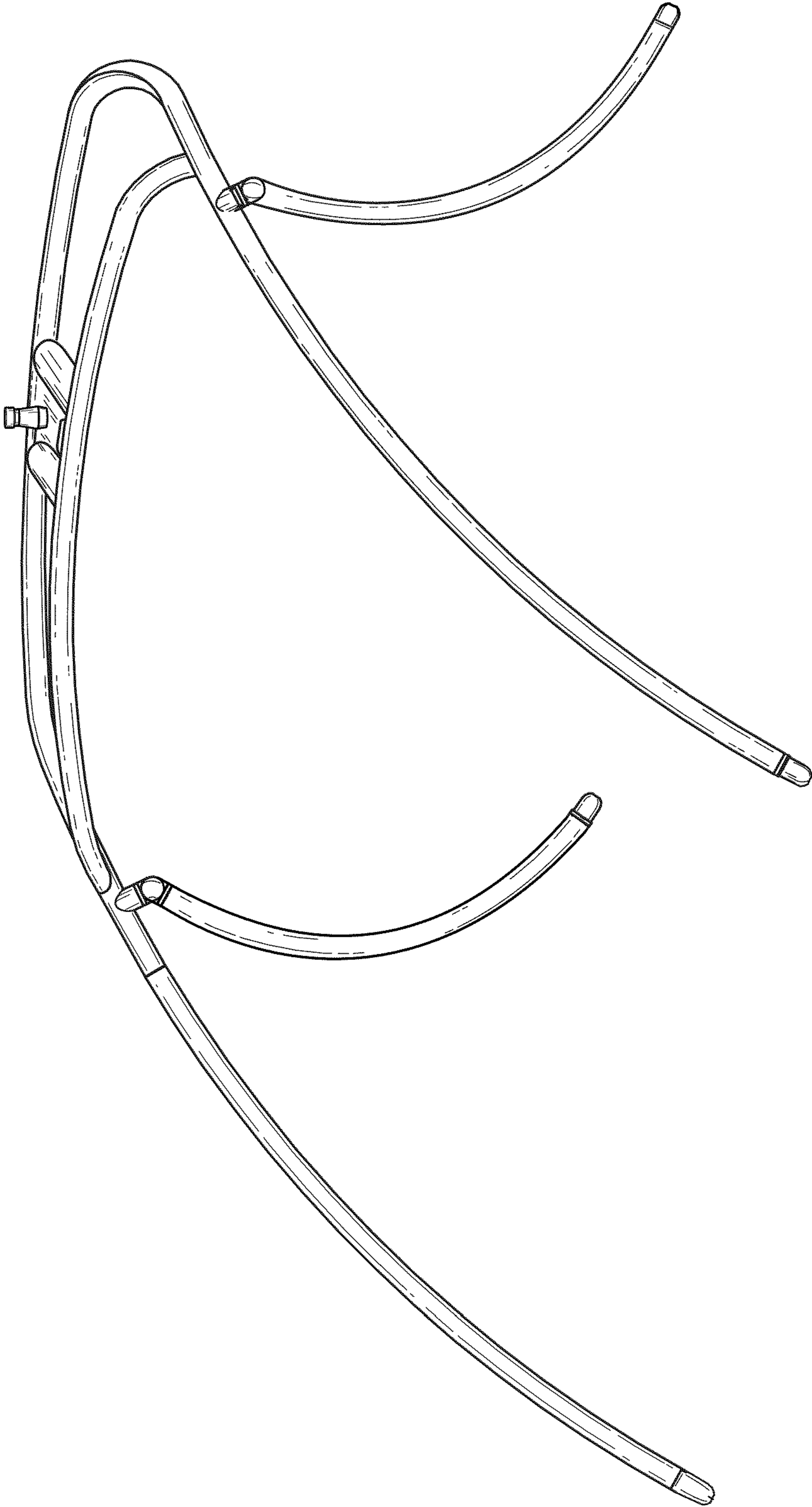

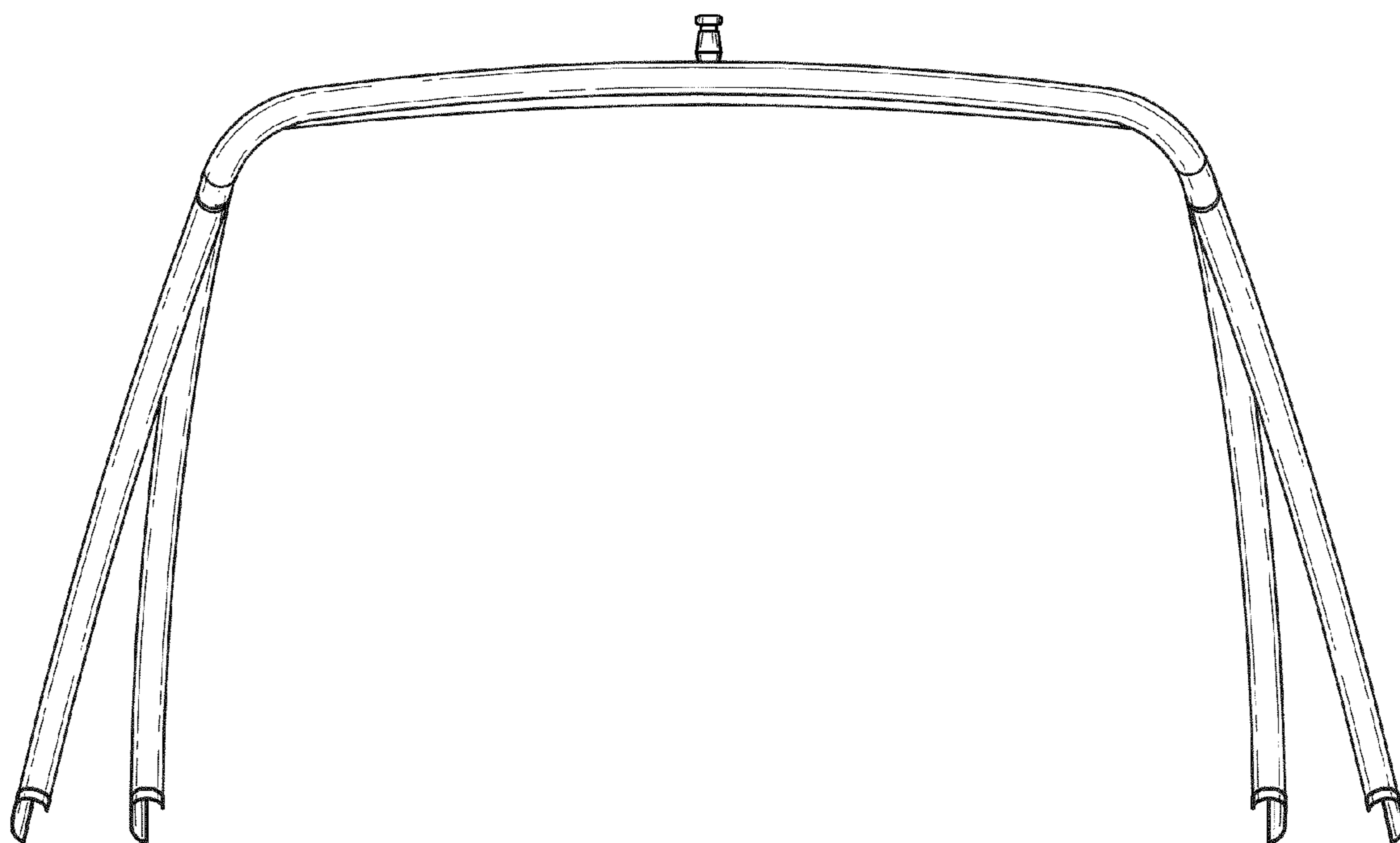

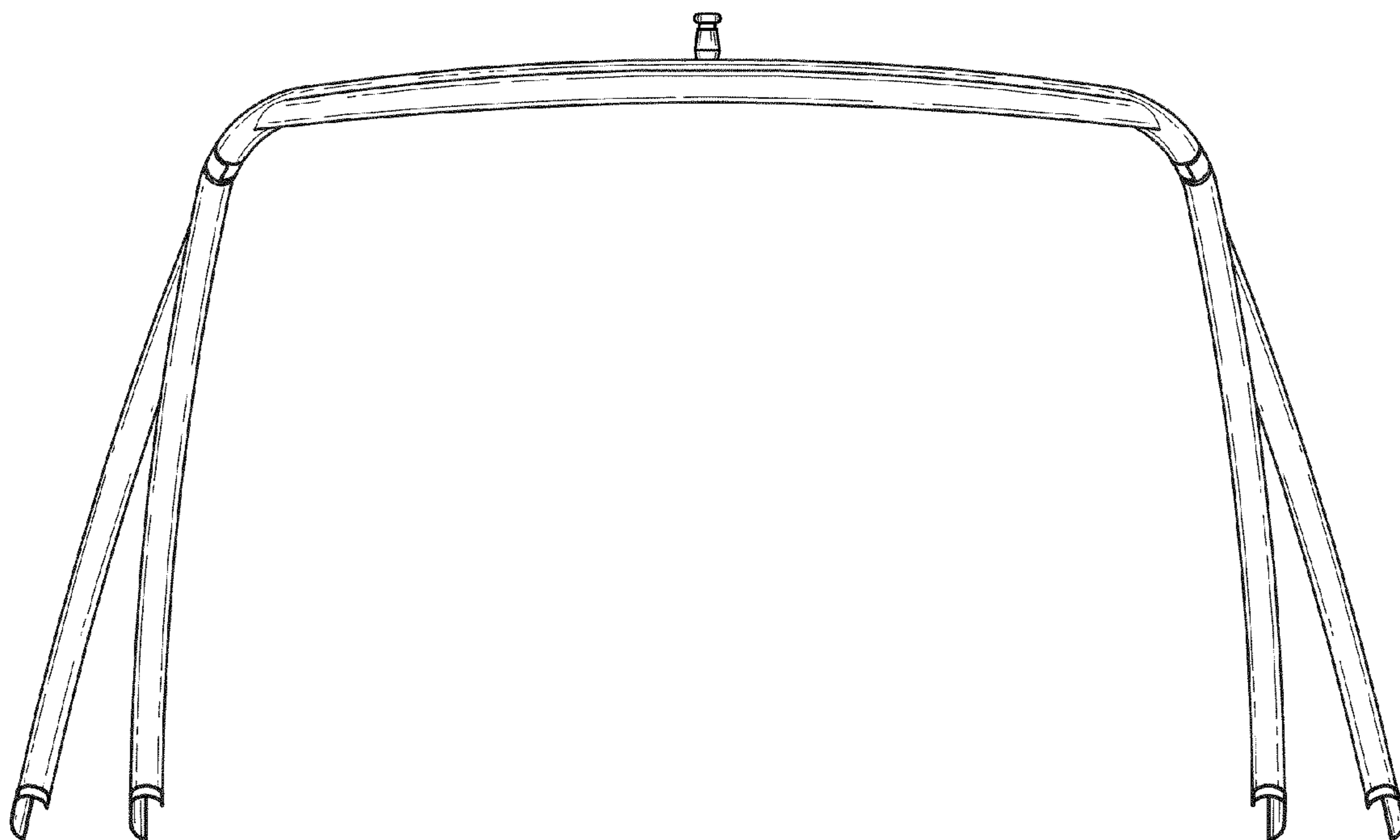

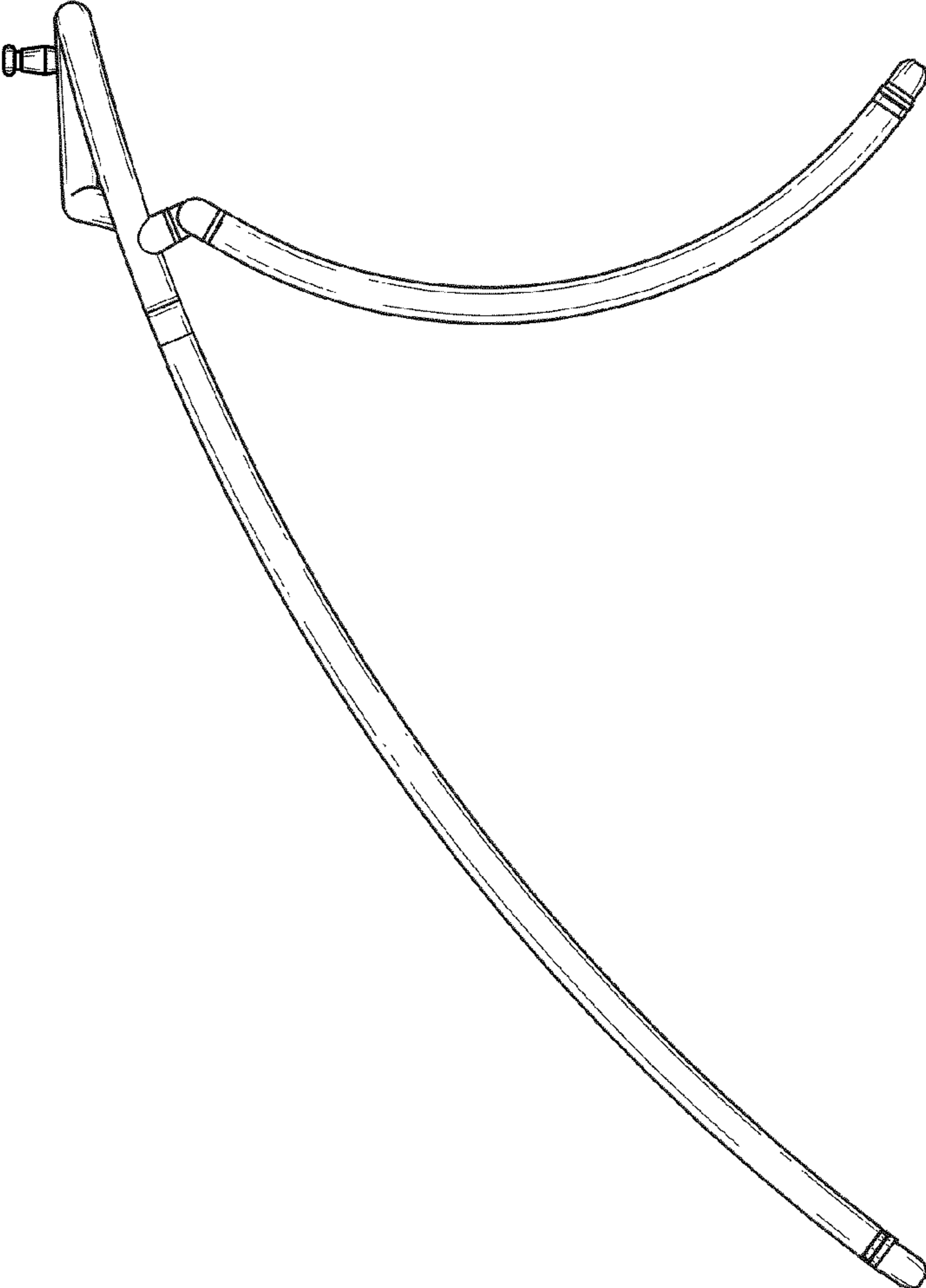

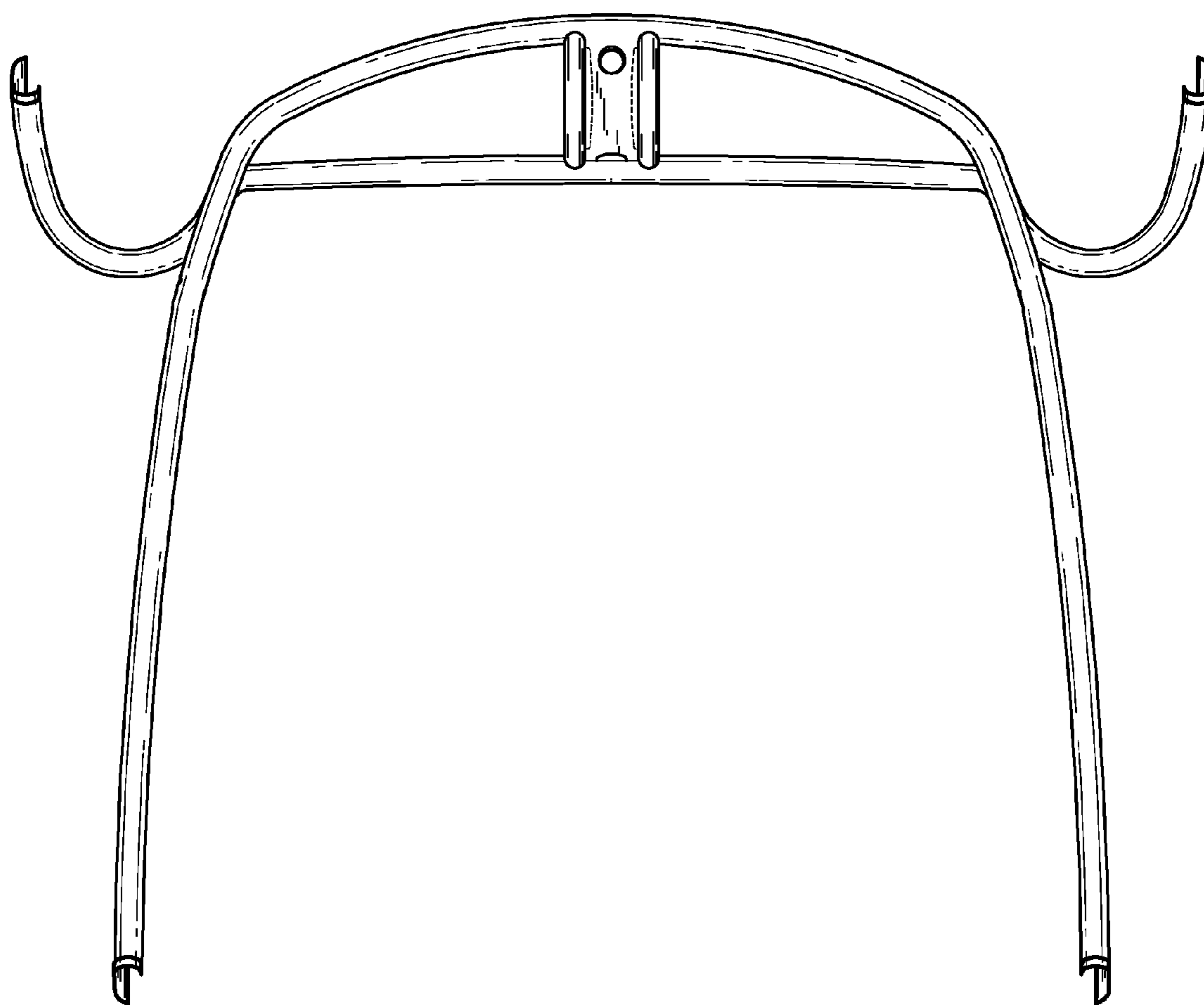

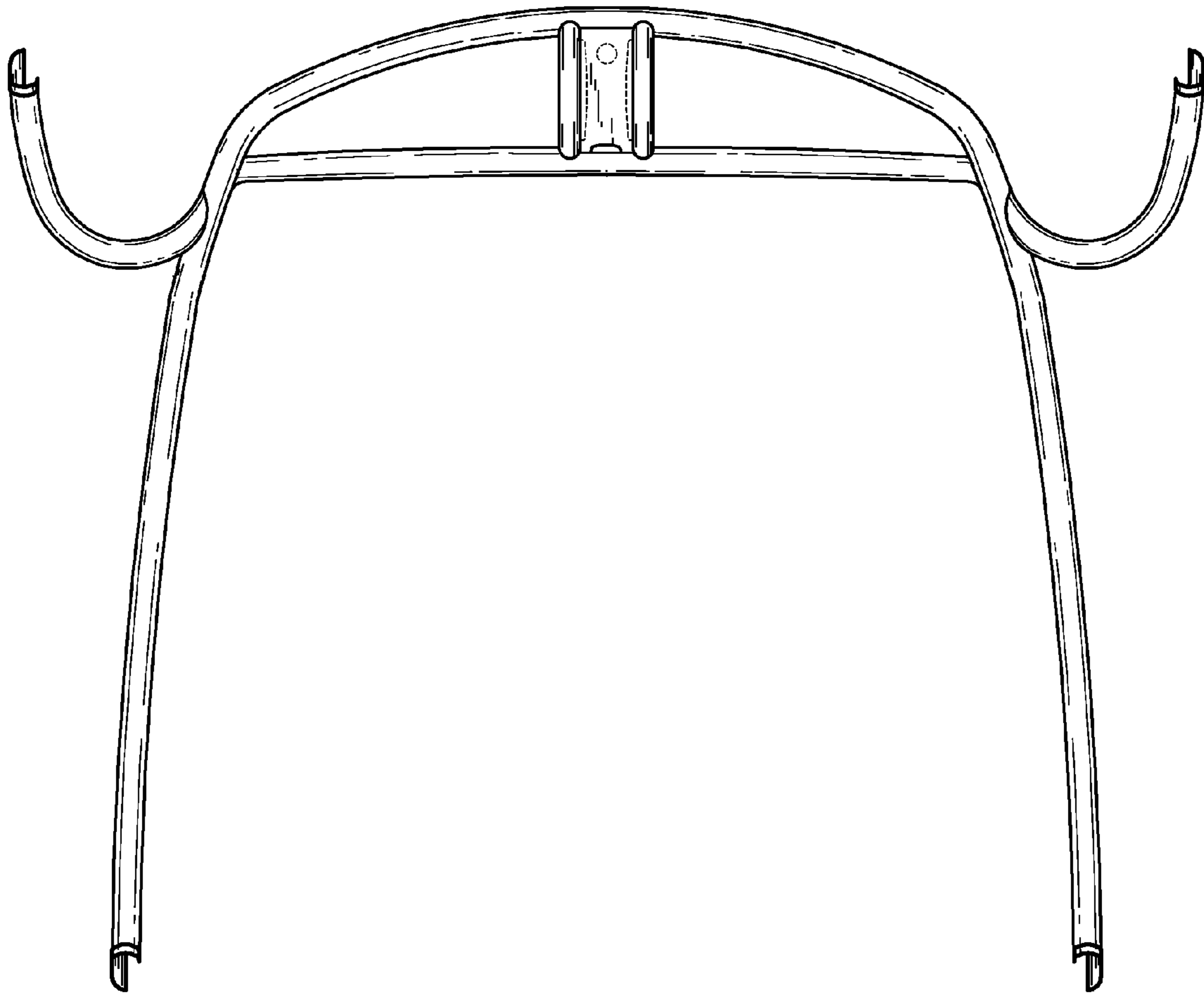
