DESCRIPTION

FIG. 1 is a perspective view of mobile phone, showing a new design;

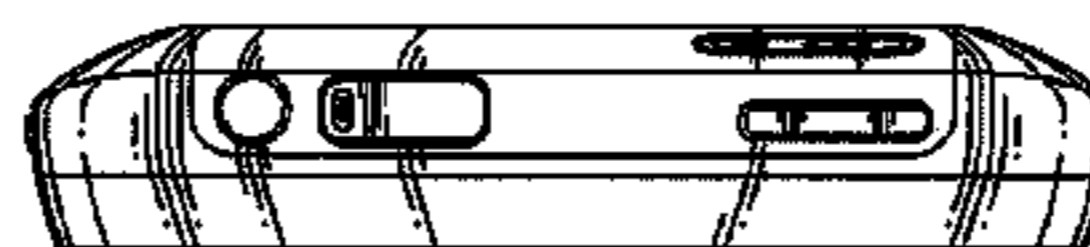
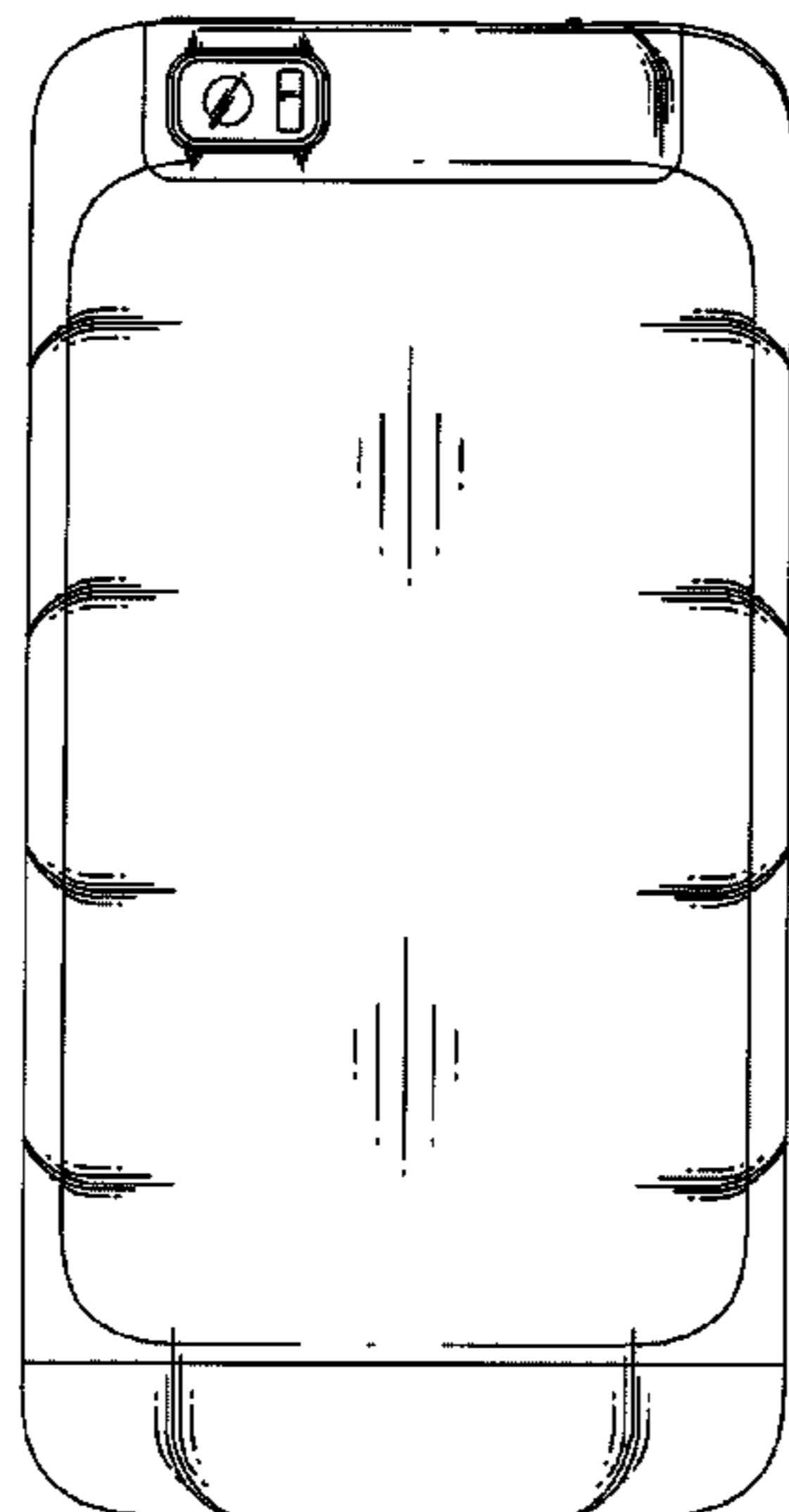

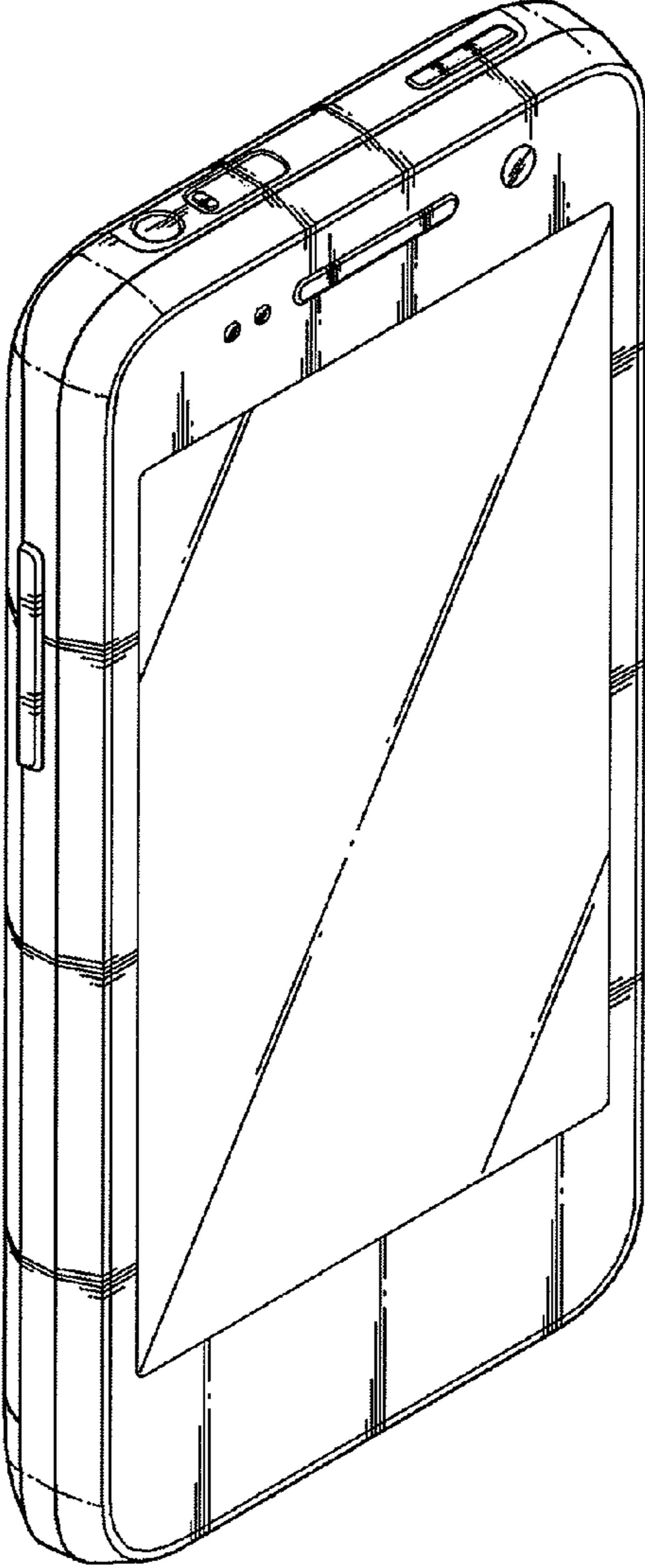

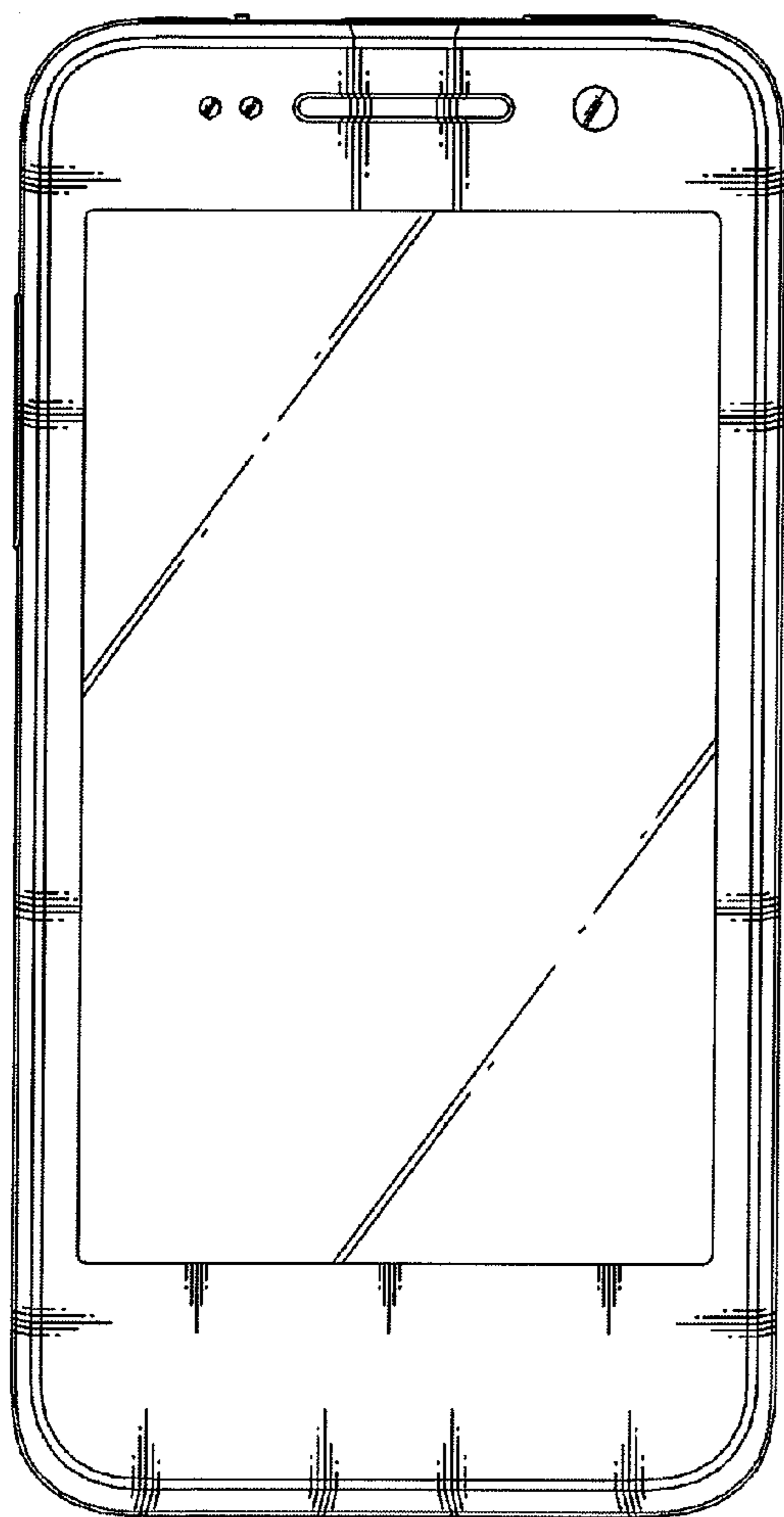

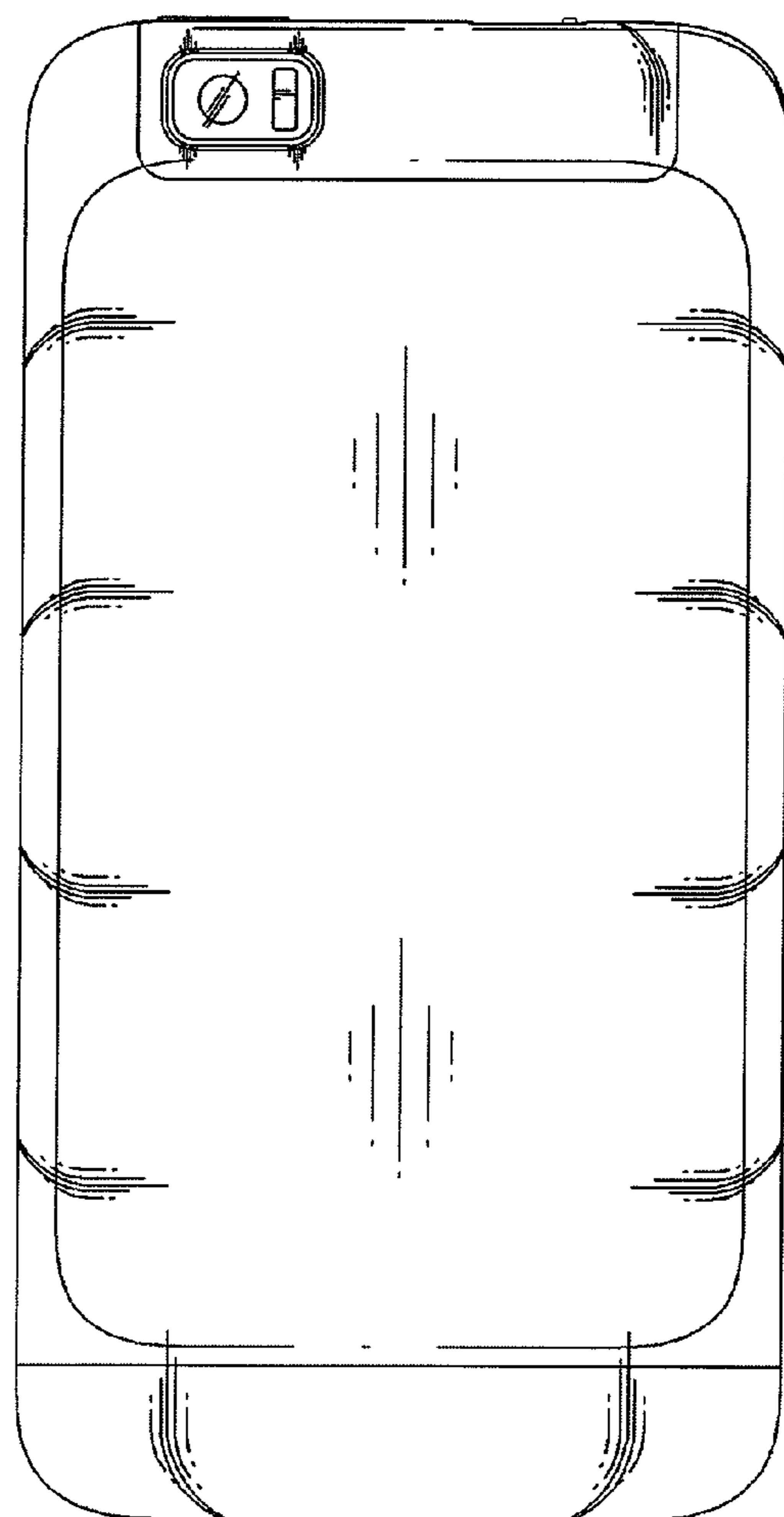

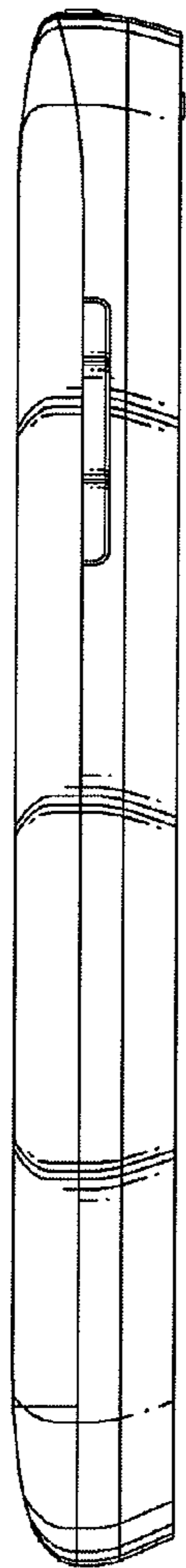

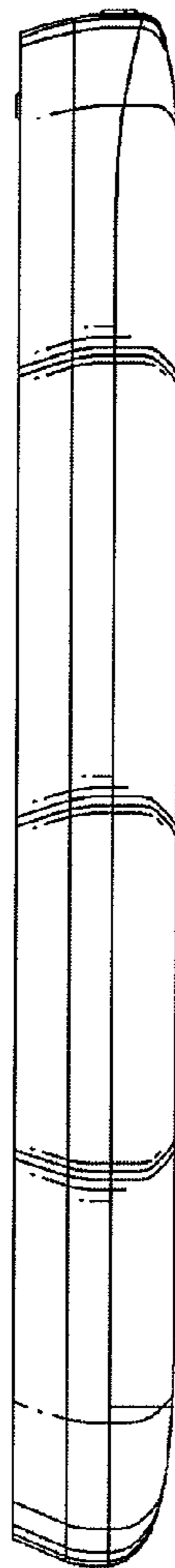

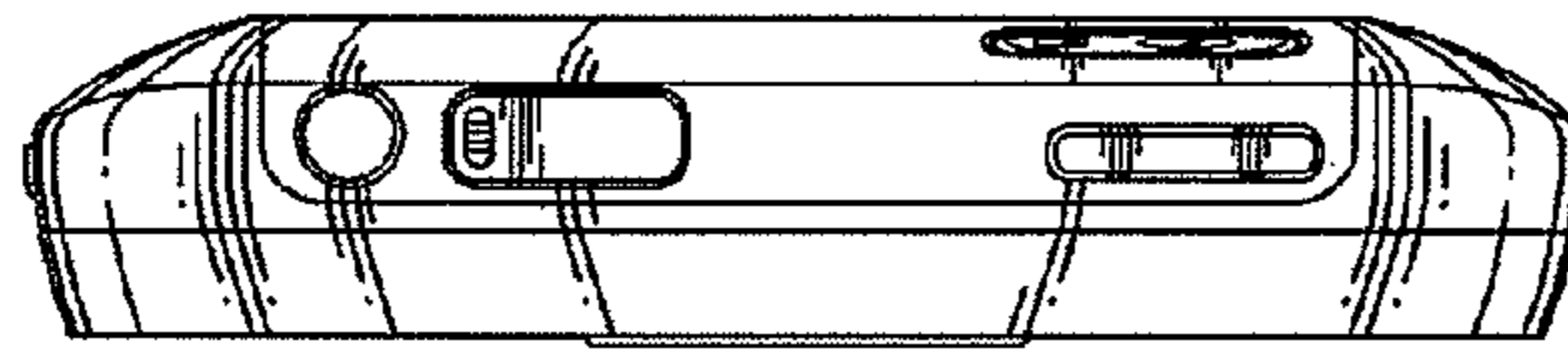

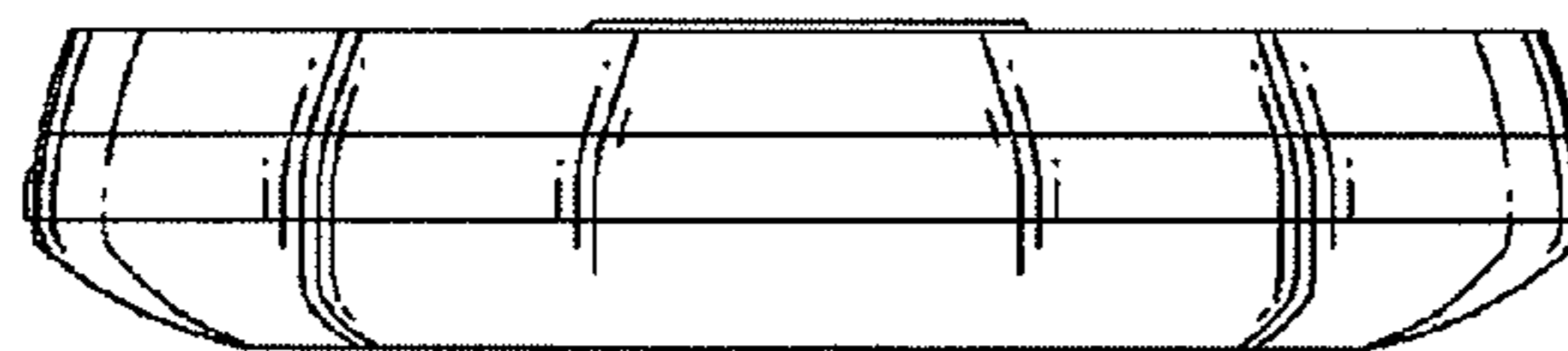
